



# **Sanctuary Cities Put on Notice**

When Jeff Sessions was selected to lead as Attorney General, I was hopeful that he would make defunding sanctuary cities a priority. I'm pleased to report that some of last week's policy discussion in Washington focused on this issue.

Sanctuary cities are municipalities that have implemented policies designed to help illegal immigrants avoid deportation. For instance, the city of San Francisco prohibits its police force from complying with U.S. Immigration and Customs Enforcement (ICE) agents by denying them access to interview incarcerated immigrants to determine legal status. ICE depends on cooperation from state and local authorities, and sanctuary city policies greatly hinder their ability to enforce our immigration laws.

Sanctuary cities are magnets for illegal immigrants, including some dangerous people with criminal records. There are more than 140 jurisdictions and six states actively obstructing enforcement of federal immigration laws with sanctuary policies. This practice puts Americans at risk, and I believe the federal government should do all it can to discourage it.

When I joined the Judiciary Committee, I made it clear that addressing our nation's illegal immigration problem is one of my top priorities. Last week, the Judiciary Committee's Subcommittee on Immigration and Border Security held a hearing on restoring immigration enforcement, and the issue of sanctuary cities was discussed at length. Witnesses ranging from a local sheriff and policy experts to a retired judge testified about the real world effects of the Obama Administration's relaxed enforcement of immigration laws. Judiciary Committee Chairman Bob Goodlatte (R-Va.) referred to it as the "systematic dismantling of immigration enforcement infrastructure," and he's right. In November 2014, as part of his executive actions on immigration,

President Obama suspended the Secure Communities program. This was a successful initiative that allowed the Department of Homeland Security and the Federal Bureau of Investigation to work together to identify and deport illegal immigrants, thus prioritizing the removal of dangerous criminals. These mistakes are being reversed. Just last week, Attorney General Jeff

Sessions announced that sanctuary cities will no longer be eligible to receive grants from the Department of Justice. This was a good move. Cities, counties, and states that refuse to cooperate with federal agencies to enforce the laws of this country should not be rewarded with taxpayer dollars intended to facilitate law and order. Our immigration system is broken and needs to be reformed, but border

security must come first. When talking about this issue, I often use the analogy of a leaky house. If a leak in your roof is filling your house with water, would you replace the carpet first? Of course not, because first you need to stop the leak. In the same way, before we consider meaningful reforms to our immigration laws, we first must halt the flood of illegal immigrants across our border.

With the full support of the White House and Congress, Attorney General Sessions is working to fix the leak. Sanctuary cities have been put on notice: the federal government will no longer tolerate their flagrant disregard for our

I look forward to working on solutions to fix our broken immigration system, and I'm excited that my new role on the Judiciary Committee gives me the opportunity to support Attorney General Jeff Sessions.

# 23andMe — WHAT THE??

We have all seen those genetic testing commercials on television. Ancestry DNA, 23 and Me to name just two. 


# What is the significance of the recent Supreme Court decision

free appropriate public education and each child under that program must have an individualized education program (IEP). Based on



prior case law the education plan for the child must enable the child to make passing marks with appropriate progress and advance from grade to grade. The language was not confined to a single test.

Endrew F. is a child with autism and was enrolled in a public school through fourth grade. When he was ready to start fifth grade his IEP resembled prior plans and the parents believed that his functional and academic progress had stalled. The parents enrolled him into a private school program that offered such specialized education and Endrew was able to make significant progress. The School District them presented the parents with another IEP and it was their belief that the new IEP was no better than the prior one.

The parents then sued the School District seeking reimbursement for monies paid to the private school; the Colorado Board of Education ruled against the plaintiffs and it was upheld by both the Federal District Court and the Tenth Circuit. While the Court ruled the child must receive more than a de minimis education the Court believed Endrew's IEP had been calculated to make some advance.

The United States Supreme Court via a Writ of Certiorari agreed to hear the case. In an 8-0 opinion it said that a child fully integrated into a regular classroom with an IEP only allows for a child with disabilities to have progress something more than a de minimis education while the same standard does not hold true for children who are not disabled.

The Court goes on to say that the Court is not in any way trying to establish what a reasonable plan is for every child and instead defers such expertise to the individual school boards. However, the Court does expect an increased ability of a child to make progress and not allow for such minimal progress when children not under an IEP are expected to achieve much more than minimal progress from grade to grade. The decision of the Tenth Circuit was vacated and the case remanded back to

the lower Court for reconsideration following the opinions of the United States

Supreme Court. This decision should be a boon to children with disabilities that require IEP's and hopefully allow such children a better opportunity to possibly be a functional and productive citizen following their education. # Dangerous Mindset

Beyond my belief that our Constitution as our nation's founding document limits by design the power and scope of the federal government for the protection of its citizens from tyrannical administrations, I also believe that it protects us from a dangerous mindset.

#### Dependency.

As a parent, one of my goals was to ensure that my son grew up with whatever opportunity I could afford him in order for him to have the skills set and ability to care for himself and his future family, completely independent of my care. That goal was never with the intent that I would ever heartlessly deny help should any hardship arise after he became an adult, but I count as my primary accomplishment as a parent that he is now able to successfully provide for his own needs as well as those of his young family.

Had I failed in my goal by consistently bailing him out of every negative situation, or in some way intentionally manipulated him so that he would be forever dependent on me, I would have denied him not only his freedom but his dignity as a human being. I have to wonder if our ready acceptance of government provision for so

much beyond the original intent of our Founders isn't an underlying cause for our moral decline. No doubt it's the reason for our escalating debt crisis which concerns our politicians during election cycles; unfortunately, once elected, any significant level of spending rarely declines but is simply circumvented to the newest pet projects. In the meantime, an alarming number of citizens continue to be manipulated

by those we elect and the mainstream media into believing that government knows best, and that it's the role of government to direct our health care choices, "educate" via public radio or government funding for the arts (with primarily a left-leaning agenda), and provide subsidies for industries deemed necessary for "the public good." The list goes on and on, and the trap for dependency is set – from the cradle to the grave – and at a financial cost that future generations can-

not possibly endure. Dare we wonder why so many in our nation lack the human dignity necessary to care for themselves? The mindset of dependency doesn't only threaten the dignity of a human, it can also fester resentment towards the source. In the analogy with my son, what parent among us hasn't experienced the trials of a child longing for independence? I certainly remember my own days of resenting my parents for what I saw then as a hindrance of my freedom, and I dare say it's the normal overwhelming desire of any teenager to make their own decisions free from parental oversight. If it's our responsibility, and joy, as parents to teach our children how to responsibly achieve independence, why are we then so willing to lose control of our own lives with an ever-expanding government? # Installing Steven 'Crash' Leath as AU's 19th President

I recently witnessed the installation ceremony of Steven 'Crash' Leath as AU's 19th President at the University Ballroom March 20th; with considerably less 'pomp & circumstance' and significantly more transparency I participated

in the election of Josh Tuttle as Chair of Alabama's LP February 25th.

AU's BoT unanimously selected Leath after a sixnational 'search' which provided little on how it was conducted. Last year our Lee County Commission Chair correctly misspoke affirming something passed 'unonimously' [sic] at a meeting where similarly all had been decided prior to putting on the show for the record and press present. Nothing like hiding behind solidarity to further conceal

the process used to brazenly install the result. Noticeably omitted at the "Ballroom Blitz" event were any microphones for question/comment from faculty, students and taxpayers. Rumours were correct Leath would start July 15th to follow President Jay Gogue's ten years as president. I guess the contract was contingent upon his 'appointment.' Note to the Board of Trustees: it might be better to NOT bring out the candidate until AFTER the sham installation is complete.

Iowa State University President Leath

appointed Auburn's 19th president.

As some readers may recall, I've mostly been a fan of Pres. Gogue's stewardship - it was easy to forecast he'd be an improvement over Ed Richardson. When Trustee John Denson was the marginal vote to get the Muse result over the Lowder gang, it signaled enough courageous souls were still at Auburn willing and able to battle the damage being done by this failed businessman and his minion 'public servants.' The Ballroom Blitz style rolling over transparency I witnessed goes a long way to removing hope and morale. It doesn't take long for a cancer of this sort to spread through any organization, even more so with public universities far too insulated from market discipline. Jay Gogue had no fear of his name being publicly known in the search that resulted in his becoming the 18th president of Auburn University. Jay Gogue had nothing to hide, it conveyed his strong desire to come back to Auburn and confidence as to how secure he was with his current position as Chancellor of the University of Houston System and University of Houston President in 2007. Far too many times many upper administrative candidates make short lists

because they initially show so well on paper but when doing a little homework, it doesn't take long to get 'the rest of the story' as Paul Harvey would say. I observed this many years ago with President Ryan Amacher at UTA [http://www.dallasobserver.com/news/fast-times-at-uta-6404568] who kept making short lists until he finally found a school which didn't do their homework. If a candidate is **NOT** secure enough in their current job to let them know others recognize their accomplishments and would like to have them in their employ, I DON'T want them. This recent way of conducting searches is nothing more than obfuscation which far too often benefits the growing minions of colluding administrators fleecing taxpayers and saddling students with increasingly more debt.

Even the faculty Senate meeting the following day addressed lack of transparency and no short list offered for public consideration. Noticeably absent was the newly appointed Leath who would've been well served to attend since Jay Gogue was committed to UVA for accreditation duties - only his third Senate meeting missed in TEN years. The Ballroom Blitz was long on thanks for this 'broadly represented' outcome rhetoric, and very short on explaining extreme confidentiality at a PUBLIC university. If allowed to question before installation, some would've asked about crashed planes, misuse of public property, odd land transactions, etc. Perhaps there are many good answers for the recent smoke rising from Iowa State, but didn't the last major Auburn hire from Iowa State, Gene Chizik if memory serves, also go up in smoke? It is not yet ripe to conclude whether Leath really is an 'Auburn man' ...if he is, then this embarrassing installation ceremony will serve as a "crash" course for Pres. Leath as to precisely what is wrong at Auburn.

Walking over to the Ballroom, a colleague forecasted it would be some time before they voted if the event was to engage in discussion and input from the 'Auburn Family.' I forecasted 20 minutes; I was wrong... it was over in less than twelve! The most notable & quotable moment followed a very loud and distinctly delayed 'AYE' from Dr. Gov. Bentley to finally make it "UNONIMOUS." Prompting Charles McCrary (President Pro Tem of the AU BoT) to proclaim, "The Voice of God." Glad I had an empty stomach for that 'special' moment, but I must note the crab balls after the Ballroom Blitz were superb. This embarrassment is not going unnoticed. KCCI News in Des Moines reported, "Last month, officials decided against filing criminal charges against Leath following an investigation into whether he broke the law with his use of school aircraft. That review began after an audit found Leath used university planes for medical appointments in Minnesota, personal flight lessons and trips home to North Carolina. He has now reimbursed the university for the flights. Auburn picked Leath after a search that didn't include an announcement of finalists.'

Gogue's presidency began July 2007. This two-time AU graduate's repute for engaging with students, supporting faculty and creating a strong university partnership with the local community has been well earned. What a difference from Richardson's reign. After stepping down as President, Gogue will remain at Auburn teaching a higher education administration course and conducting special projects. The most truthful quote of the day from McCrary was, "The contribution Jay and Susie Gogue made to Auburn is immeasurable, we're fortunate they will remain part of the Auburn community." The 12 minute Ballroom Blitz engagement would've made any Stuka pilot proud. Drop the bomb then quickly fly out without answering questions certainly is a psychological tactic to make a point. Debate shall not be tolerated at Auburn University and y'all had better know your place.

On a more pleasant note, I was able to actually participate in electing a fine young public servant to Chair the Libertarian Party of Alabama at their annual convention up in Huntsville February 25th. It was an open, transparent process with nominations, discussions, and voting. Chairman Tuttle won the office after a very close race (a one vote margin) against Baldwin County Chair Laura Lane with almost a hundred attending. Brandon Moseley (Alabama Political Reporter http://www.alreporter.com/2017/03/07/libertarians-elect-tuttlechairman/) quoted Chairman Josh Tuttle with, "I am deeply humbled to have earned the trust of the party members as Chairman of the Libertarian Party of Alabama. Our focus will be to carry the torch of liberty and contest the Old Parties in upcoming elections."

The Libertarian Party is the third largest political party in the US. In Alabama, former Republican New Mexico Governor Gary Johnson received 2.1 percent of the vote (43,869) appearing as an 'independent' because of our State's anti-competitive ballot access laws - among the most restrictive in the nation. As an aside, Judge Gorsuch has a sound record (according to Richard Winger's March 2017 Ballot Access News) on independent candidates - so maybe Gorsuch won't be part of the mainstream extremists on protecting the duopoly Parties. The Green Party is the fourth largest political party nationally, but here in Alabama the Constitution Party (CP) is gaining momentum. Lots of folks are still mad about our lame duck governor Robert Bentley naming Attorney General Luther Strange to Jeff Sessions Senate seat.

If the sitting attorney general of a state openly states that he is investigating the governor for misfeasance and then that governor appoints that attorney general to the senate seat it looks funny. It gives new meaning to the word

This brazen move has incensed legislators who have heard from their constituents back home. It has especially upset members of the House Judiciary Committee. They were asked to cease the impeachment proceedings last year in deference to Strange's request to lead an investigation of the governor's shenanigans. Needless to say they have reinstated their impeachment proceedings against old Bentley with renewed vigor.

Several legislators have taken issue with the governor's calling for the senate seat election in 2018, rather than immediately. The constitution says the election should be held forthwith. That is open to interpretation. The more prudent path is 2018, since there are elections anyway. That is traditionally the way it has been done in the state in the past. However, most seats in bygone days were vacated by the death of one of our senators and the governor usually appointed the deceased senator's widow for the remaining year or so on the term. She was considered a caretaker to the seat. There has been so much grief and acrimony to Strange's appointment that he may be a caretaker.

I have never before seen a governor treated with such disdain and irreverence by a legislature as ole Bentley. They probably will not technically impeach the ole fellow. He only has about 20 months left in his tenure and he is essentially impeached from power anyway. Most of them look at him as a buffoon or clown. He has about as much relevance in the legislative process as one of the former goats that used to graze on Goat Hill.

The ultimate fallout from Bentley's actions and unpopularity may accrue to Luther Strange in his election race in 14 months. Winning the GOP primary in this Senate race is tantamount to election in Alabama. Therefore, the race is in June of next year.

Big Luther stands a good 6'9". His height is daunting. He was actually a

college basketball player at Tulane. Luther spent the first 20 years of his career as a corporate lobbyist in Washington. Seeing the power and deference of being a U.S. Senator made an impression. He came home to run for a secondary constitutional office and get ready to run for a Senate seat vacated by either of his friends, Richard Shelby or Jeff Sessions. He chose the right stepping stone job, Attorney General.

Big Luther is basically a shy and reserved fellow. He is not a natural politician. He was on the right course when he initially said that he would not seek nor accept Bentley's appointment and that he was running for the post independent of the discredited governor's appointment. He changed his mind and met with Bentley and took the appointment.

His trusted advisors convinced him that folks have short memories and that over the next year as a sitting U.S. Senator he can raise so much Washington campaign cash that he can outspend his opposition to such an extent that it will wash away the taint of the Bentley appointment. He may be right. That may be

In the end, the IRS hit Ray for several hundred dollars of extra taxes, interest,

And that was just the beginning. Agents kept auditing Ray every year. They hit him for sums ranging from \$160 to \$1200 in extra taxes over the next five

By this time, Ray had a talk with a friend, Vietnam veteran Jeremiah Denton (Alabama's future US senator). # THE NEGATIVES OF BAITING

For the last five years or so, there's been a bill taking passes through the House and Senate in Alabama, and this year it's looking to come in with a little steam. The bill in question is House Bill 184, which would allow hunters to hunt both deer and feral hogs over bait. As it stands, the bill has passed the State House, and is looking to come up for consideration in the State Senate.

Personally, I'm not a fan of hunting over bait. We can currently use bait, as long as it's 100 yards away and out of sight. As someone who's been hunting deer for what feels like an eternity, simply dumping out some corn and shooting whatever comes to feed on it doesn't really seem like the kind of challenge I'd be looking for. It'd just be a massacre with no true fair chase. Of course, Fair Chase is a concept that doesn't get mentioned a lot, but more discussion on it couldn't hurt. Fair Chase is an expectation that a hunter won't do anything to give them an overwhelmingly unfair advantage over the game animal like baiting or fencing. It adds to the challenge of hunting while keeping a sort of honor code amongst hunters. Ultimately, it's a matter of personal interpretation, as it's generally just you and the hunt.

At any rate, QDMA's representative on this matter, Kip Adams, has a few solid points against this bill. I'll share them with you guys, in hopes that maybe some more discussion can be had on baiting and the consequences it can have.

For starters, Chronic Wasting Disease (CWD) is something that QDMA has taken great lengths to study and combat. CWD is an illness that deer can get that can absolutely ravage a deer population. With baiting, you're potentially bringing a lot of deer into one area, including those that might be infected. While CWD isn't prevalent down here in Alabama, should it ever rear its ugly head in our deer population, baiting would aid in its transmission from deer to deer.

According to various surveys, most hunters just plain don't like baiting. Similar surveys show that the non-hunting public isn't pleased with the idea either. Everyone's got their reasons to believe what they do, and in this case, it seems like the majority surveyed didn't care for baiting.

Speaking of hunters and baiting, legalization of baiting has shown to create both offensive and defensive baiting situations across property lines, resulting in potential conflict amongst hunters and property owners. Deer are considered the property of the state; not any one person's property. Concepts such as property lines don't matter much to deer, as they go where the food is, leaving hunters, who are legally bound by property lines, in an interesting position when baiting is added.

As for the deer themselves, they can dramatically change their travel and eating habits based on bait availability. Deer have a preference for feeding at night if they can help it, and if that feeder's out there belting out corn every few hours, you better believe they'll stop on by when it's safer for them. In fact, research has shown that legalizing baiting doesn't increase harvest rates.

Speaking of following the food, predators will key in on this set of changes as well. If the deer are constantly going to one place, you better believe the predators will as well. For those of you who've kept up with these articles over the years, you might remember the Predator-Pit Scenario, where a deer population can be decimated by a perfect storm of food availability and predation rates. Baiting has the potential to throw your local deer herd into that situation, wreaking havoc on your deer population.

Other states with legalized baiting have shown to have a dramatic 4-8 times increase in artificial food on the landscape. Of course, another impact baiting would have is the increase in nuisance animal populations, like feral hogs and raccoons. Hogs don't need much help with breeding and spreading, and raccoons are very opportunistic, finding food where ever they can, and troublesome, as they tend to leave a mess wherever they go. Hogs, of course, do the same, but on a much larger scale, as they can tear up large amounts of land with their rooting.

Ultimately, the decision on this bill lies with the State Senate. If you'd like to weigh in on it, feel free to contact your Senator and tell him or her what you think. Personally, I'm hoping it will not pass. I'll always welcome more discussion on the topic, as we can only benefit from trying to learn from one another, sharing our experiences on the subject. So get out there, keep your feeding and hunting legal, stay active, and go get'em!

# Moose

Moose are the largest living member of the deer family. While mostly found in northern United States and Canada, they are also found in Europe. However, in Europe the animal is known as a Eurasian elk. Standing up to seven feet at the



shoulders and weighing up to 1800 pounds, they have very few natural predators. Moose are able to run at speeds of up to 35 miles per hour and are capable of swimming up to 10 miles without stopping.

Moose range in color from light brown to a very dark brown color. Male moose, known as "bulls," tend to be darker than female moose, or "cows." The color variation is especially noticeable in the facial region. Moose have a long flap of skin beneath their throat called a bell. The definite reason for this feature is unknown, but it is thought that it most likely is used to attract a mate. The bell is more prominent in bulls than cows. Moose are very famous for their large antlers. A mature bull may grow antlers that span 6 feet and weigh up to 70 pounds. The bull's antlers take only about 5 months to fully develop, which makes them one of the fastest growing animal organs. In early December, Bull Moose will shed their antlers, and will immediately start growing new ones.

Moose are solitary animals, but during mating season moose will herd into groups for the purposes of finding mates. Cows will attract bulls with loud moans, while bulls will compete with each other by antler fighting. Breeding season for moose extends from September through October, and in late May or early June cows give birth. Moose will usually give birth to one calf, but it is not uncommon that twins will be born if food is plentiful. The calf is reddish-brown in color and weighs around 25 pounds at birth. They are capable of gaining over two pounds a day while they are nursing. The calves are weaned at five months, but their mother will rear them for up to a year. During this period the cow will defend her calf from any potential threats. Oftentimes, a cow will have to drive off her offspring after a year in order to care for a newborn calf. A bull does not become sexually mature until the age of five, while the cow is ready to breed by the age of 1 ½ years. The average life span of a Moose is about 10 to 15 years. Moose are generally docile towards humans, but may become more aggressive during the mating season of September through October. The name "moose" comes from

the Native American word "Moswa," which translates to "twig eater." The moose population in North America is estimated to be fewer than 1.5 million, with 1

million in Canada alone. Up to 200,000 are estimated to live in Alaska.

Natural predators include wolves and bear, of who mainly target the calves. A moose's long legs help it walk through snow and wade through deep water.

The nostrils of a moose are capable of

closing when the head is immersed in water. This northern species exists in the boreal

forest region across the Northern Hemisphere. Full of coniferous trees, the climate varies from -65 degrees Fahrenheit (winter months) to 86 degrees Fahrenheit (summer months). Moose do not have a problem spending their winter in the snowy region because they are adapted to it. Moose are herbivores, and eat many different types of plants, fruit, and bark. However, only eating plants and shrubs does not provide adequate amounts of sodium for the moose. Therefore, they eat a lot of aquatic foliage to add sodium in their diet. It is very common to see a moose wading in streams and marshes, with their head in the water, munching on



vegetation. Because of their long legs, moose enjoy many high grasses and shrubs, and are able to wade through deep water when feeding. Feeding habits of moose will change with the seasons. In the spring, they tend to be attracted to meadows and fields where nourishment is plentiful. In the summer, moose can be found more in marshes and lakes, filling up on aquatic vegetation. During winter, moose will forage near the edge of forests eating bark and twigs as other vegetation will have dried up. Moose must consume 9770 calories per day to maintain their body weight. A moose will eat up to 70.5 pounds of food a day.


# PASSING FOOTBALLS TO PASSING BILLS

When Crum Foshee was running through, over and around players at Red Level High School, neither he nor the citizens of Covington County realized that one day Crum would be the most powerful legislator in the Alabama Legislature. All Crum really wanted to do was help his daddy and his brother run one of the largest ginning operations in

the south. The daddy, Wheeler G. Foshee had built quite a dynasty in Covington County. He was raising cotton, processing peanuts and shipping all over the country.

Mr. Foshee had two boys about seven years apart who could carry on with the family business after he was gone. He made sure they new how to work, how to farm and how to make deals. Wheeler Foshee, Jr. was the oldest. He

helped Mr. Foshee train E. C. "Crum" Foshee in the nuances of running their business. Even though separated by a few years, the boys became very close. That relationship lasted almost 80 years. The only thing that could separate them was death. That occurred on March 18, 2017 when Crum passed away from the ravages of cancer. In order to understand Crum you had to know Wheeler, who played football

on the first Red Level football team. He was small but he could outrun the wind, which he would later have to do as a turret gunner on a B-29 in the United States Air Force. Wheeler was wounded when his B-29 was damaged on a bombing run over North Korea and crashed in Japan. By the time Wheeler got out of the service, Crum was beginning high school and playing football. Crum's biggest fan was Wheeler. He is prone to exaggerate, but I do think Crum was an outstanding football player. Obviously Coach Paul "Bear" Bryant did too. When Crum was a senior playing at Red Level he was a 5'9", 175 lb. running

back. He also played other positions, but his forte was power running. He didn't try to avoid tacklers very much. Crum was stocky and really powerful for a player his size. Coach Bryant had sent Gene Stallings to Excell, Alabama to look at a sophomore fullback and linebacker named Lee Roy Jordan. That night Crum Foshee of the Red Devel Tigers had a fantastic game and beat Lee Roy and the Excell football team. When Stallings got back to College Station, Texas, he told Coach Bryant about the short, tough running back from Red Level. Bryant looked at the report and told Stallings to sign him. Clemson also offered Crum a scholarship, so he had to make a choice. For

some reason he decided on Texas A&M. So in the fall of 1956, Wheeler drove his "little" brother to College Station. The "Aggies" won the Southwest Conference Championship the next year, but Crum was not part of the celebration. After going through fall practice, Crum decided that he didn't like football as much as Coach Bryant did. He soon pulled into Evergreen on a Trailways bus ready to go back to farming in Red Level. Who picked him up at the bus stop? Wheeler of course! His daddy and brother were delighted to have him back, but were disappointed that he did not stay in college. He did attend Auburn before he decided that politics was "his game." At this point we will skip a few years. Crum Foshee served four years in the

House of Representatives and 31 years in the Senate. He was Rules Committee Chairman for twenty years. That meant that he was responsible for "setting the calendar" for the Senate. If you wanted a bill to be considered, you had to go through Crum to get it on the calendar. He was elected nine times by the people that knew his best, the people of Covington County. Nobody in the legislature had the influence and power that ultimately Crum

Foshee had. Governor George C. Wallace may have been slightly better at "cutting a deal" but not by much. If you wanted a bill passed you needed to not have Crum Foshee against it. The short football player from Red Level had become a giant legislator in Montgomery. Most people don't know how Cliff Hare Stadium in Auburn became Jordan-

Hare Stadium. As far as I am concerned, this was one of Crum's greatest victories. Ralph "Shug" Jordan had been the head coach at Auburn for about twenty years. Coach Jordan even had more friends than Crum did. One of them was Crum's brother, Wheeler. In fact, Wheeler was a pall-bearer at Coach Jordan's funeral. I know this because I was there.

Wheeler served as Prison Commissioner and Aeronautics Commissioner under Governor Wallace over an eleven year period. Therefore, he had many occasion to be in the governors office. He and Crum considered the idea of introducing a bill to change the name of Cliff Hare Stadium to Ralph "Shug" Jordan Stadium. Well, that was no hill to climb for Crum, so he sponsored a bill to do just that. It passed naturally. The only thing left was for Governor Wallace to sign it. He had actually agreed to sign the bill. However, someone on the Auburn Board of Trustees got wind of the deal. So, the Board of Trustees requested a conference with the governor regarding this proposed name change

of the stadium. Of course Wallace agreed to have them come to Montgomery

and discuss this legislation. George Wallace loved a laugh as much as he loved

to make a speech. So, he asked Crum and Wheeler to be in the room when he met with the trustees. When they had made their presentation to Wallace as to why this would not be in the best interest of Auburn University, the governor pointed at Crum and said, "You-all need to be talking to that man over there who's got the bill in his pocket, and I am prepared to sign it." They knew that they had lost, but they wanted to cut their loss in some way. The trustees asked the governor to let

George Wallace, being the politician that he certainly was didn't want to lose votes from the Auburn people who accounted for about half of the votes in Alabama. So, he said, "Boys, we don't need to alienate any segment of the people in the great State of Alabama. Why don't we just re-

name the stadium Jordan-Hare." He looked at Crum. He looked at the trustees. Crum knew he was losing 50% of the deal and he wasn't gonna' lose the other half. Against Wheeler's objections, Crum took the deal. Now, when you go over to Auburn to a football game and see the name on the stadium, you may remember Crum Foshee.

Probably nobody knew that when the name was changed to Jordan-Hare Stadium that nowhere in the country had a stadium been named for a coach that was still coaching at their home stadium. But, that's a fact. Obviously, Coach Jordan was appreciative of the work Crum put into this. As was Jordan's custom, he never forgot. The Foshees never had much trouble getting tickets to Auburn home games as long as "Shug" was the coach.


Crum Foshee was not a saint. He had his faults like we all do. But, he must have meant something to a lot of people. There were over 2,000 signatures on the guest book at Crum's funeral on Thursday, March 23, 2017. There were more millionaires in that chapel than I have ever seen in one room. There also were folks in blue jeans and cowboy boots. Crum was not selective in picking his friends. They came from all walks of life.

It was fortunate for me to be able to see some old friends there and make new friends. John Teague, former Pro-Tem of the Alabama Senate, who I have known for over 30 years, said that Crum was a friend in the good times and when things were not going so good. He indicated that Crum was a big help when he was dealing with serious health issues. He said that a smile from Crum was better for him than the medicine he was taking. Crum did have an infectious

Jere Beasley, former Lieutenant Governor, has been a close friend and confidant since our college days in the same fraternity. He was our quarterback. I was the right end and my eventual brother-in-law Don Hall, Jr. was left end. Jere led us to the intramural championship

in 1959. He was always impressed with Crum's ability to get things done. He also said that he knew of no one who was as loyal to his friends as was Crum Foshee. He related several stories about Crum and McDowell Lee, former Secretary of the Senate. I am sorry to say that I cannot print those stories.

Seth Hammett, former Speaker of the House of Representatives reminded us of how Highway 20 became Crum Foshee Highway. He also talked about how Crum was responsible for much of the infrastructure in the state: roads, bridges, ie. He also talked about how tough it was to negotiate with Crum. It was hard to move him off his spot. Tom Coker, former lobbyist from



Lowndes County was once an adversary when I was coaching at Catholic High School. His good friend Mac Champion was the outstanding coach at Hayneville. Had I never scheduled Hayneville my record would have been considerably better. Over the years Tom has become a good friend and a lot of fun to be with. His comments concerned Crum's tenacity as a legislator. Tom was working for Howell Heflin, former United State Senator from Alabama. From his Washington office he tried to get legislation through the Alabama Senate for Heflin but Crum Foshee was there to block it. Tom made a statement that really moved me. In the end, Crum just gave out, but he never quit!

There were so many others that I talked to that were so ernest in there trust of Crum and their friendship with Crum. Former Governor, Jim Folsom, Jr. made reference to the many times that Crum had helped him in and out of office. However, the most passionate recollections of Crum Foshee were the comments of John Smith, former lobbyist. He and Crum were very close. They had breakfast together every Friday at the Cracker Barrel in Montgomery. On one occasion at the Friday morning breakfast, Crum told John that his cancer was worse than originally diagnosed, and that the doctors were not very encouraging. John, being a very sensitive person, was apparently devastated. Crum comforted John to some degree with these words, "John, I don't care what the doctors say or what

pain I must endure, when this is all over, I know where I am going." From passing footballs to passing bills, Crum was a good person. His recent passing marked the end of a political legend in the State of Alabama. It

Crum Foshee would have been 80 years old this coming December 17th.

# **April, A Presidential Month**

The month of April might well be identified as "The Month of Presidents," since many of its days are celebrated as having a presidential significance, as reported on your writer's tired old computer in "The History Place." This tally includes one Confederate president (there was only one), and a baker's dozen of Union presidents; a couple of them were mentioned twice.

On April 1, 1998, the sexual harassment case against President Bill Clinton was dismissed by a federal judge in Little Rock, Arkansas.

Eviction notice was issued by Gen. Robert E. Lee, on April 2, 1865, notifying Confederate President Jefferson Davis that he must evacuate the Confederate Capitol at Richmond, Virginia.

The third day of April in 1948, was the day that President Harry S. Truman signed the "Marshall Plan." The purpose of this endeavor was two-fold: to stop the spread of Communism in Europe, and to restore the economies of countries that had been destroyed in World War II.

On April 8, 1952, Pres. Harry S. Truman seized control of America's steel mills to prevent a strike. On the 29th, a U.S. District ruled the president's act was unconstitutional. And, the strikers received a pay raise, plus other benefits. **The 9th day of April, in 1866**, despite Pres. Andrew Johnson's veto of the Civil

Rights Bill, the measure was passed by Congress, giving blacks the rights and privileges of U.S. citizenship. On **April 11, 1968**, the Civil Rights Act was signed into law by Pres. Lyndon

B. Johnson. The act prohibited housing discrimination, and expanded the rights of certain residents of this country who have been erroneously dubbed "Native" Americans. There is no such thing as a "native American."

On April 12, 1945, Americans mourned the death of President Franklin D. Roosevelt, the only U.S. President to be elected to office four times. During his presidency the U.S. citizens endured the Great Depression and World War II.

Also on **April 12**, Alan Shepard became the first American

in space; followed a year later by Pres. John F. Kennedy's call to land a man on the moon before the decade had ended.

Back in **1743**, on April **13**, Thomas Jefferson was born in Virginia. Beside being the 3rd U.S. President, Jefferson was an author of the Declaration of Independ-

On the **14th** of the month in 1865, President Abraham Lincoln was assassi-

Moving ahead 121 years, also on **April 14, 1986**, Pres. Ronald Reagan ordered the bombing of Tripoli and Benghazi, in retaliation of a bombing of a Berlin discotheque killing 37 persons, two of whom were Americans.

Jumping back to **April 23, 1791**, James Buchanan, our 15th President, was born. He was the only bachelor to occupy the White House.

On the **26th of this month in 1944**, federal troops in Chicago seized the offices of Montgomery Ward and removed the chairman after he had refused President Roosevelt's order to recognize the CIO labor union.

On the **27th of the month, in 1791**, inventor Samuel F. B. Morse was born in

Another famous birthday that occurred on this day in April, this time it was in the year 1822; that of Gen. Ulysses S. Grant, our 18th president.

Another President who enjoyed an April birth was our 5th president, James Monroe, who was born on that day in 1758. His most significant achievement was the Monroe Doctrine, which closed the door on any nation wishing to extend its holdings or use its armed forces in North or South America.

And, finally, on the **30th of April 1789**, George Washington became America's first president. He took the presidential oath of office on the balcony of Federal Hall in New York City. Washington, DC, was yet to come.

Finally, as we watch the daily newscasts on TV we must wonder what, of any significance, will occur in March of 2018?



# The Fall Of A Great Profession

When your aging scribe first stumbled into the realm of journalism there existed a number of rigid rules to which each of us blindly adhered.

The first concerned the guide by which each reporter abided; that being an adherence to the rule of objectivity. Reporters didn't take sides. Despite one's political, religious, or whatever leanings; a news-person prepared his or her reports in an objective manner.

The second rule was one laid down in 1902 by Rudyard Kipling in his Just **So Stories**, and soon became gospel; for news reporters. Kipling wrote:

I keep six honest serving-men

(They taught me all I knew); Their names are What and Why and When

and How and Where and Who. A third rule by which all news-persons reported was anonymity: Not until

the advent of television did the pronoun I, become a part of the reportage. News reporters religiously removed themselves from the picture. It wasn't until they stepped in front of the camera did the actual existence of the chronicler become a part of the narrative. The use of the pronoun I in a newspaper narrative could bring down the wrath of the editor upon the hapless journalist. Not so today. The reporter has become an integral element in the narrative, to the extent that television reporters soon became referred to as "On air personalities." And so, journalism has sunk deeper and deeper into a mire that has swallowed

This ushered in the beginning of the end of objective news reporting. up this once proud field of news reporting and turned it into a quagmire of personality and fiction that, today, goes under the name of news reporting.

And so has news reporting sunk into a soft, muddy pool of abuses of expression; along with much of our once proud English language. We just ain't

got no couth no more. Quod erat demonstrantum.

# The Paradox of the Passion

Anyone who reads or hears the story of Easter can't help but be confronted with what Dennis Davidson called the "Paradox of the Passion." A paradox is "a statement which superficially seems to be contradictory, impossible, even absurd, yet beyond the superficial is in reality true." It is above all else inconsistent with common sense and yet is nevertheless factual. It is, as some would say, the last thing in the world you would ever expect."

Who would have ever thought God would come to live on earth with us, to be one of us in His Son? Even more striking is the thought that God would send His own innocent Son to die as a sacrifice for the sins of those least deserving? No man could have ever dreamed a more ironic plot to a story. But it isn't just a story, it's a reality.

Consider the overwhelming irony. He was labeled guilty and put to death by His own people. It wasn't done by some conquering army from afar or radical terrorist. Jewish leaders testified to His guilt. It was Jesus who was marching out of step, not them. He was a liberal, trouble making activist. Think about it, things had been happening the same way in Israel for thousands of years. What



right did this young upstart preacher have to come in and try to change things all around? He wasn't a Rabbi, he wasn't a Levite, He wasn't a scribe or a Pharisee. He was just a carpenter, He was a newcomer to Jerusalem. He was only thirty three years old and He was wrong."

"So why should they change? After all it was the Sadducees who were the lawmakers, not Jesus. He just didn't understand how things were done. How dare He call them vipers, how dare He call them fools, how dare He call them hypocrites. Who did he think He was anyway? And then He had the utter gall to claim to be the equal to Jehovah God. In their eyes he was guilty as sin."

Add to the irony of the Easter events by noting the Roman authorities. Pilate knew what he was doing. He saw trouble coming and he already had too much trouble in Jerusalem. There Jews were on the brink of revolt. He didn't need all the problems that this young Nazarene carpenter represented. To him, the problem was not whether Jesus was guilty or innocent. He simply thought the problem was best resolved by giving in to the religious leaders. After all, this was a religious problem and if they wanted this man gone, then so be it.

And wasn't it ironic that Barabbas, who had been found guilty of a capital offense, was declared innocent by the crowd and Jesus was declared guilty? Can't you just imagine it was some of the same people had sung hosanna and waved palm branches on Sunday, but then on Friday they shouted "Crucify Him, Crucify Jesus?" Can't you just see the undeniable paradox?

Lest we feel smug about our own time in history, we should observe that the paradox is not far removed from today. How many people praise his name and sing Hosanna on Sunday but on Monday live for themselves and take his name in vain? Popular opinion had proclaimed Christ a king and now it was proclaiming him a criminal. Popular opinion can sometimes be useful. But when it comes

# WHERE IS GOD?

The ancient patriarch Job felt all alone in his suffering. He said, "Oh, that I knew where I might find him! that I might come even to his seat (Job I've heard people echo Job's lament over the years. "Where is God when I

need him?" or "God doesn't hear my prayers!" or "What did I do to deserve this?" We're human and forsakenness is a common emotion in our humanity. "Nobody knows the sorrow I've seen," the old spiritual says. But we find an interesting take from the apologist C. S. Lewis. He knew pain

when his wife, Joy, died of cancer. In "A Grief Observed," he wrote about his sorrow and his questioning of God. But he came to trust God once again and wrote some tantalizing words about pain: "Pain insists upon being attended to. God whispers to us in our pleasures, speaks in our conscience, but shouts in our pain: it is His megaphone to rouse a deaf world."

The sufferings of life get our attention and make us see we're not self-sufficient. We often feel so when things are going our way--when there's health and money and all the attendant pleasures of life. But when we lose any of these things we're reminded of our humanity and vulnerability to loss. The apostle Paul knew pain as well. He called is a "thorn" in his body, but

never explained what it was. My favorite theory is the stoning he received in Lystra where he was dragged out of the city and left for dead. Without emergency medical treatment we're accustomed to, I can imagine he had internal organ damage and broken bones that never completely healed. Whatever his pain he cried out to God for its removal. It wasn't removed, but he did get something from God: the promise of God's presence and the promise of God's grace. This is why many faithful saints became so through suffering. Many of our

hymn-writers wrote from personal pain, but also about the comfort they found in partnership with God. I've known many senior saints over the years who've wrestled with pain, but who, nonetheless, have developed an unshakeable confidence in the goodness of the Lord.

Scripture asserts that no one of us is truly forsaken despite our feelings that we are. The psalm writer said, "The Lord is close to the brokenhearted and saves those who are crushed in spirit" (Psalm 34:18).

Some of our pain is inexplicable this side of heaven, and we're promised an accounting one day. Until then, we're exhorted to trust in the goodness of God and his ultimate plan of fulfillment in our lives. He is not an absentee deity. This would just be a sad story about a good man who should not have died if it was all over on Friday when his body was taken down from the cross. "Good Friday does end on a very final note. Jesus was gone, dead, buried and silenced forever. Everything that Jesus had said, everything that Jesus had taught, everything that Jesus had done was gone and would be forgotten, because Jesus was wrong. For two days by every measure that is used by the world, Jesus was wrong. Jesus clashed with all the selfish distorted values and morals of a fallen society and he died because nobody can fight a monster that big and win."

But the story doesn't end with the crucifixion, that was Friday but Sunday was a new day. The miracle of the Easter message had taken place. The tomb was empty. He died but He was now alive. "If Jesus had of remained in the ground He would have been just as wrong as Mohammed, Confucius and Buddha. If Jesus had of remained dead He would have been just another misguided prophet who thought He was right." And because Jesus of Nazareth was right on Easter day, fifty days later on the day of Pentecost those first 120 Christians were filled with the Holy Spirit and Christianity was proven right.

The paradox of His death turns into praise for the hope his resurrection offers. "There are times that it looks like Christianity is beaten but time and time again we struggle back to the surface and emerge victorious. Oh our doctrine may fail us and our leaders may disappoint us, but Christianity will not be kept down. And as we look around at the evil in this old world sometimes it appears that Satan has the upper hand, sometimes it would appear that Satan is victorious." Yet, His Word is alive bringing a message of salvation to people from every walk of life and every corner of the globe.

The message of Easter becomes personal when we realize because Jesus Christ did not lose, we will not lose. In winning the victory over death on Calvary's mount so many years ago Jesus won the victory for us. When Jesus won over death, He offered us the power to win over death.

"Jesus did not win on the cross so we could have the Easter Bunny, and Jesus did not win on the cross so we could have chocolate eggs, and Jesus did not win on the cross so we could have a long weekend in the spring."

Jesus Christ won on Calvary for one reason and one reason only, and that was to give you and me the opportunity to have eternal life. "I would suspect that if you gave Jesus a list of things He would like to have been doing over the Easter weekend that dying on a cross would have been somewhere near the bottom of the list. But Christ died on the cross so you wouldn't have to and He rose again to demonstrate that he was even in control of death." That's the paradox of the passion.

For a good many years your writer studied, wrote about, and actually became a player in the health planning process, only to come to the conclusion that government-handled health care will never come to fruition. There were too

many factions, each with its own objective, and often in fierce conflict with the other players, all of which spelled disaster. Yet they press on. And so it shall be with Obamacare. The previous president, and his minions, produced Obamacare, which never really got off the ground. It consumed

millions of dollars, held out false promises to many citizens in need of a well organized health care system, and eventually ended up like Franz Kafka's Hunger Artist, it just withered away because there was nothing that could be done to remedy his situation.

It makes for good theater, but there's really no hope for any of these proposals to succeed.

# **George Washington** The Father of Our Country

# The Building of His Character, Part One His Influence as Father of Our Country, Part Two

George Washington was born on February 22, 1732, to Augustine and Mary Ball Washington, in the family homestead of Bridges Creek, land not far from the Potomac River. George's father had been married before to Jane Butler, but only two of their three children survived, Lawrence and Augustine Jr. Their mother died in 1728, and August remarried in 1730 to Mary, the daughter of Col. Ball. They had four sons, George, Samuel, John Augustine, and Charles, as well as two daughters, Elizabeth, called Betty, and Mildred, who died in

The Washington family had emigrated in the mid-1600s. Two brothers came together, John and Andrew Washington. They settled in the Virginia colony in 1657 and purchased land between the Potomac and Rappahannock Rivers. John became a leading figure in the Colony's public service, prominent in the House of Burgesses, and as a successful plantation manager. He served as a Colonel in the Virginia Militia.

George grew up on a plantation of vast fields of tobacco, corn, and potatoes, rolling pastures, mountains, rivers, and an extended family of slaves owned by his father. These were often his companions and dear friends. There was harmony in the large Washington household. The father was serious, quiet, and in charge in the most ideal way. The mother enjoyed that security, but she had her hands full managing her domain, which was very large and commanding.


As a very young little boy, George was taught to revere his family name. He was to regularly repeat from memory the Ten Commandments, which both mother and father participated in daily. They had a book, titled <u>The Young Man's</u> <u>Companion</u>, which taught manners. His father repeatedly emphasized that the Washington Family does not lie, does not steal, does not cheat. All of George Washington's life is an example of that conduct, early learned at his parents' knee. His father expected obedience, honesty, patriotism, loyalty, and individual responsibility. His mother had the patience and resolve to see that George carried out these expectations of his father on a daily basis.

The Negroes on the farm felt a moral responsibility as well. Whether they were household servants or worked in the fields, God was very real and personal to them. While we do not endorse slavery, it was very apparent from History, that George Washington enjoyed close relationships and deep friendships with many of these slaves.

George's older brothers, Lawrence and Augustine, left home in their mid-teen years to go to England for their education. George expected to do the same, but plans changed dramatically when his father died unexpectedly when George was just 12 years old. His mother was unwilling to allow George to leave home for the schooling in England that his brothers had. While visiting the brothers in England at the Appleby Grammar School, George's father had spent long hours with the Headmaster there, and had brought back to Virginia, numerous books of curricula. He was, of course, concerned for George's education, whether it be in England or at home.

George had shown evidence of maturity, but at his father's death, he assumed more responsibility and was guided in this by his brother Lawrence. Back from England, Lawrence was assuming the headship of the family, while guiding George to lead in his own home.

While he loved to roam the meadows and the fields, he had a great love for reading. One day he discovered a book from the Appleby Grammar School that had a long list of rules of conduct befitting a gentleman. He read the book and re-read it many times, copying every single rule in his own notebook. He would



carry those rules in his heart and life, until his death. His notebook, with the

rules carefully and neatly copied, exists today in the Washington Archives.

His parents were very involved and committed to his education, but there was no schooling in the area, such as the Appleby Grammar School. The school that his brothers attended in England focused on Character for Manhood, and promoted Christian Faith and Conduct. George had expected to go there, but we have no evidence that he was disappointed when the decision was made to remain at home. For a time, George attended the village school, guided by Hobby, the Sexton of the Parish, who was not a well-educated teacher.

Later, his mother decided to send George to live with his older brother Augustine, at Bridges Creek, where there was a fine village school led by Headmaster, Mr. Williams. His manuscript notebooks still exist and are neat as well as accurate. Washington Irving and numerous other writers of the Washington biographies write of viewing his notebooks. Some of these same writers tell of viewing documents of his financial matters later in life, and that his keeping of accounts and financial transactions are near perfect.


Do we now see how young children benefit from such teaching in childhood? And through these young years, we see George as a self-disciplined young man in physical and also mental matters. He was passionate about exercise, running,

after their father died, and George spent much time with him at Mt. Vernon.

His father in law, the Honorable William Fairfax, lived at Belvoir, not far from Mt. Vernon. William Fairfax was managing large land holdings for his cousin, Lord Fairfax. George observed as a teenager that land surveying was in great demand, and he schooled himself in his teens to pursue this opportunity. The Fairfax family would enter into helping him achieve success, in his teen years of surveying, which is hard even to imagine.

One of George's great learning experiences was being asked to assist his sister Betty, with her studies. Not only did it help him learn patience, it drew him ever closer to his sister, and that closeness remained throughout their lives.

The friendship with the Fairfax family was a mutual blessing for them all. When Lord Fairfax came from England to view his vast lands, making friends with young George Washington was a delight for him. George, not yet 16 years of age, showed modesty, but frankness. Because many of His Lordship's lands had not been surveyed, George's passion for this made them look with favor in encouraging him, and later entering into contracts for the task. A few years later, George would receive the appointment of public surveyor at age 17.







ALFRA supports Senate Bill 186, sponsored by Senator Larry Stutts, which creates an equal starting point, in all child custody cases, for children and their parents. Thus, equally protecting a child's relationship with both [fit] parents and reduces placing our children at risk for suicide, juvenile incarceration, drug use, sex trafficking and teen pregnancy.

Child custody law practices is one of the most important civil and human

rights issue today. It is the role of the lawmakers to implement public policy to protect children and the family unit from unwarranted state and government interference.

The Alabama Law Institute (ALI), created in 1967, has proposed Senate

Bill 191 and House Bill 239, which do not serve the diverse families of today. The two proposed bills by ALI recklessly place children at further risk of being separated from one of their fit parents without any legal reasoning or compelling state interest. Years of complaints from both parents, children of divorce and a survey conducted by the Alabama Administrative Office of Courts indicate there is a need for Alabama legislature to implement measures to protect children and families from biased court rulings. Here is a quote from the 2016 judges' survey conducted by the Alabama Administrative Office of Courts: "I have never in ten years awarded 'true custody' or

The two bills proposed by the Alabama Law Institute (SB191 and HB239) do not remedy or change the current systemic problem. It is imper-

ative that we educate ourselves and empower our lawmakers with evidence based literature that shows Senate Bill 186, will strengthen families and our weakened society.

stand up for social equality, families and for the innocent children who do not have a voice in this matter.

# Southern Gardening Potpourri for April by Peggy Givhan

As we have heard all of our lives, "April showers bring May flowers", and hope this will ring true as I have enjoyed the low water bills from the City. If anyone tries to pull off an April Fools' Day prank, just go along with it and add that you are a fool for flowers.

The garden chores should not be mounting if we have kept weeding on a periodic schedule; however, there are some of us who just turned our backs for a few weeks, and wake up to find the soil covered with winter weeds. Luckily the dock, and others do have shallow root systems, and take very little effort to yank them out by the roots. In fact, the weeds create such a large crown or head with just the tiniest of roots. I have weeded out a huge pile while perhaps only pulling out perhaps 20 root balls. Be careful, since you will need to locate plants that have reseeded and can easily be pulled out with the drag net of weeds. So identify these before they get swept up in your weeding frenzy.

Besides the flower garden, if we have not planted lettuce, collards, turnip greens or kale, we should do this now before it gets too hot. Lettuces are especially nice, as they grow rapidly and one eats the whole plant. There is nothing better than serving a salad grown in your garden. Somehow, the salad just tastes fresher and better. If you do spray the lettuce with insecticides, remember that some "poisons" are taken up into the leaves and washing the leaves will not be enough to keep one from getting sick. There are very good organic sprays on the market which are alternatives to insecticides. For instance, one article suggested a caffeine spray for bugs. As for animals wanting to nibble some salad greens, try spraying with a mixture of garlic and another strong smelling herb. The fight to keep every bug out of your salad greens is not that daunting a task, because after six weeks, the lettuce begins to bolt and the greens have bitten the

I was reading a garden article on flowers that tolerate and thrive in alkaline soil such as we have in Montgomery also known as Gumbo Soil. What I read made me rethink on my failures of Baby's Breath, or Gypsophila, which means "lime-loving". Lime is alkaline and I have always planted Baby's breath in acid to slightly acid soil. The plant requires good drainage, needs full sun or light shade, and is perennial. They make great fillers in the garden and are great for cutting. There is a creeping variety that does tolerate acid soil. Maybe before I try a new addition to the flower garden, I should read the plant's requirements.

Ornamental grasses can be a lovely addition to the flower bed. Fountain Grass, or Pennisetum, has become very popular and is noted for its foxtail fuzzy flowers that stand above clumps of rounded fine textured foliage. These are stunning when planted in large drifts. Most re-seed year after year, so thin periodically so as not to have a massive invasion.

Now that we should not have any more hard freezes, we need to search for and plant some hardy tropicals, such as plumbago, and hibiscus. These woodystemmed plants have to be brought in during the coldest months, so I just keep them in pots and cut them back when the time comes. Just a couple of each lends an interesting texture with variety of colors from white, to pale blue to bright orange, red, yellow, peach and all colors in between.





# Southern

To decide on the subject for my column, I do a great deal of research. I search through cooking websites, magazines, recipes I developed or modified from my chef days, recipes that were given to me, newspaper clippings friends and relatives have given to me. I have used my phone to video a TV show that showed how to cook something I wanted to try, so I could then write the recipe for it. In addition, I do a lot of shopping and I like to go out to eat.

I started collecting recipes from the days when PRODIGY® was my internet portal of choice; it was almost the only portal of choice. In addition, MASTERCOOK® was my choice for collecting and categorizing all of my recipes. I found places that had combined over 15,000 recipes files in MASTERCOOK® format. There are now websites that claim to have over 150,000 recipes. Except for some websites that require you to join and some that

even require a membership, most recipes are available with a free download. If you want to cook anything edible, somewhere there is a recipe. In addition, I am sure there are recipes for many inedible items.

However, there a downside to following a recipe as is. The recipe belongs to someone else and the final product will cater to the tastes of the person who developed the recipe. My favorite reading is in old family or regional cookbooks when the person describing a recipe, says "Aunt Cora used this recipe for the people in Forsyth but in Wainscot, we added a few other ingredients." I think a recipe needs to be prepared as written the first time you try it. This is especially true if the recipe is a long and difficult recipe. After you have cooked for a while and after you have confidence and know your way around a kitchen, you will know where you can tweak a recipe by adjusting the amounts for some ingredients or adding other ingredients to suit your taste. Examples of this would be the herbs and spices called for in a recipe. Changing the spices in a recipe could change the whole character of the dish.

This comes in handy when you want to follow some cooking shows where you prep certain ingredients on Sunday and keep changing the cooking method and the herbs and spices to make different meals for the rest of the week. I like the concept if you save money, buying everything at once and in bulk. In addition, it evolves being in the kitchen and at least assembling and cooking a meal. If you have children all the better, they can be part of the meal preparation. It is always a better choice than taking some processed TV dinner-like meal out of the freezer and nuking it in the microwave.

Buying in bulk can determine your recipe selection for the week. A common vegetable that many people in bulk are onions. I have never just bought one or two onions, except maybe red onions. Since onions have a long shelf life, buying a bag is a cost saver. Check the onions closely. They may not be the same size and some will be older than others will. My favorite preparation for onions to use in a meal plan for the week is to make caramelized onions. Use the onions to top steaks, hamburgers, hot dogs or any German style sausage, or in soups or in a biscuit slider.

Every cook should have the recipe for caramelized onions in their repertoire. If you keep your heat low with a little fat and have a lot of time, and many onions, you are on your way. The best types of onion to caramelize are the basic yellow and white. A sweet yellow onion is better for short cooking times or for raw eating. About four cups of sliced onions will produce about a cup of caramelized onions. A medium sliced onion works best, you do not want the onions to get too soft and lose their shape. Rings or strips are your preference. To four cups of sliced onions, add two tablespoons of oil and two tablespoons of butter. You get the taste of the butter and the oil prevents the butter from burning. The onions will become bitter if they burn. Put onions in a large fry pan and stir every few minutes. One teaspoon of sugar added also deepens the color. I add a teaspoon per onion of Worcestershire Sauce at the end to deepen the color. Prep in advance and save in refrigerator until ready to use. Just heat and serve when needed. A more detailed and gourmet method to prepare amelized onions is as follows

# WINE-BRAISED CARMELIZED ONIONS

INGREDIENTS

About 1 small clove garlic per 2 onions Onions (cook about 3-5 at a time) Olive oil **Butter** 

One bay leaf per batch Fresh thyme sprig Salt and fresh cracked pepper White wine **Beef stock** 

#### *METHOD*

- 1. Cut the onions in half lengthwise, and then slice thinly again lengthwise.
- 2. For every one large onion, heat about one teaspoon olive oil in a large, heavy-bottom pan over medium heat.
- Add the same amount of butter, and allow the butter to melt, and then add minced garlic. Allow the garlic to soften (but not color), then add the onions.
- Stir to coat the garlic and onions in oil/butter, add a bay leaf and a small sprig of thyme, then turn down the heat to medium low (so onions don't burn).
- Continue to cook the onions until they are soft and deep golden brown, 30-40 minutes (depending on how many onions you cook).
- Add about ¼-cup white wine, and ¼ cup stock, and allow to reduce down with the onions, another 5-7 minutes. Remove from heat and set aside enough onions for grilled cheese sandwich.
- **7.** The rest, throw into a pot and make French Onion Soup.

There are other numerous ways to use the onions. Add to a salad, either a green leaf or even better in a pasta salad. A topping for a hamburger cannot be beat. Moreover, since you make your own pizza (hint) instead of buying an overly expensive frozen or a "to go" from a chain store, adding caramelized onions to your homemade pizza sauce or as a topping will enhance the flavor. While I write this article, the weather warnings are out about a hard freeze tonight. It should be the coldest day since January. However, Spring is in the air and that means we can get out and enjoy the food that has its own day or week to celebrate in April. Some foods have their own month; April is Florida Tomato Month, Fresh Celery Month, Garlic Month, Soy Foods Month, and Soft Pretzel Month. April is also National Grilled Cheese Month. Do you remember the recipe for caramelized onions? Hint!

How about a grilled cheese sandwich with the onions you just caramelized? It almost tastes like you are eating French Onion soup, hence the name, French Onion Soup Grilled Cheese. However, before you dive in and think this is just

another grilled cheese sandwich, be watchful of these items; first, the thickness of the bread, the amount of butter and the temperature of the onions. If the bread is too thick, the bread will grill and burn before the cheese has melted. Second,



I do not use butter on the outside of the sandwich. There is butter on the inside and that is plenty of butter. Thinly spread a good mayonnaise (Duke's) on the side on the bread you are going to grill. This will produce a nice brown crispy exterior. Third, heat the onions before you assemble the sandwich. Again, the cheese needs to melt before the bread gets too brown. You will build the sandwich on one slice of bread and then cap it with the other slice.

#### FRENCH ONION SOUP GRILLED CHEESE **SANDWICH**

#### **INGREDIENTS**

Duke's mayonnaise, just enough to thinly coat the outside of sandwich Two slices of bread (hard-crusted

French baguette or the like) One-tablespoon soft butter Enough gruyere cheese,

shredded, to cover both slices of bread One-half cup of your heated onions you caramelized earlier Fresh minced parsley or thyme leaves Salt and pepper

#### **METHOD**

- Start warming a frying pan on low to medium heat.
- Spread mayonnaise on one side of one slice of bread, place mayo side down on you work surface next to the other slice of bread.
- **3.** Spread butter on each slice of bread.
- Top one piece of bread with half of the cheese and then top the cheese with all of the heated onions.
- 5. Sprinkle herbs and then salt and pepper on onions.
- 6. Top the onions with the rest of the cheese.
- Cover with the other buttered piece of bread, butter down.
- Spread a thin coat of mayo on top of bread. Transfer sandwich to the heated pan.
- Watch for bread to get toasty brown and the cheese to melt. Flip over and continue until both sides have browned nicely and the cheese has melted.

There was a cheese and wine reception on the grounds. No food or wine allowed inside the house, I would think not! The cheese postponed my desire to get some more substantial food into me. To accomplish that we were off to the **SAND BAR**, on Marina Drive in Selma.

#### Restaurant Review

If you like tender cornmeal, crusted fried catfish with a moist and flaky interior then you should eat here. If you want to hang out with your friends, enjoy some drinks and fried catfish, burgers, hot dogs, seafood baskets, plates, salads, and wraps this is a place to come. If you want to hang out with lots of friends, try the Sand Bar on Saint Patrick's Day!

I am more forgiving than most about having to wait for your order. I understand what is going on in the kitchen and at the bar when there are people standing at the door waiting for a table and we were a table of six. I did not think it was an overly long wait. We did get our drinks early to keep us busy. When the food did come, it was all at once and the fish was hot. Moreover, with an order like this in a bar, I was happy to see that every order was correct and no one said anything during the meal except how good the catfish was. Everyone ordered something different, from a wrap, a platter, a basket, and a salad. Crafty me, I did not want to fill up on French fries, so I ordered the Catfish salad. For less money, I got more catfish. The salad part was just iceberg lettuce, and I think tomato and shredded cheese. There did not seem to be a choice of dressings but it came with balsamic vinaigrette. There was a listing for Cheese Curds on the menu, but it was actually cheese cubes, battered and fried. Our wait staff gave me a choice of cheddar or pepper jack. After many shakes of the hot sauce that was on the table, the pepper jack tasted like it had some peppers in it.

I would like to come back to the Sand Bar, but not next Saint Patrick's Day. The bill for my wife and I was \$27 for the food the other \$26 was for the libations. It is a bar! The most expensive item on the menu at \$16 is the seafood basket with 2 pieces of fish, four shrimp, four oysters, fries, and hushpuppies. For about \$20, you can get an appetizer, catfish basket and a big draft cup. "One of the nicest things about life is the way we must regularly stop






