

PEOPLE CONTROL

In less than a week, I’ve encountered an identical phrase from two separate sources that I believe defines the unfortunate condition of where we are as a nation.

People control.

For some reason, this simple expression has completely escaped me when trying to explain to people why I believe in the conservative message. Too many of us become so absorbed in the minutiae of each political issue in order to intelligently debate those from the liberal side of the spectrum that we fail to recognize the simplest explanation of all.

Liberals and statists love people control and an enormous centralized government is the best way to achieve it.

In considering two of the most contentious issues in our country right now, gun control and Obamacare, neither subject is really about guns or our individual health care, but rather about our government controlling the citizens of this nation through legislation that limits our freedom and economic choice.

Too many times, conservatives attempt to over-analyze complex issues but by the time we disseminate the mass quantities and excruciating details of the information we have diligently obtained, we sometimes lose the argument because we can’t condense our message to digestible sound bites that resonate with voters. Or, as related by a speaker at our recent Smart Girl Summit, Dan Bongino, former Secret Service agent

and current Congressional candidate from Maryland, if your message won’t fit on a Wheaties box, you’re explaining too much.

But if we start with expressing the premise that the left wants to control ALL of us, conservative and liberal, black and white, male and female, young and old, it isn’t difficult to point out example after example of how the current policies are designed to achieve that goal. Unfortunately, there are also far too many big government Republicans enabling the behavior which makes the battle to restore liberty even more challenging.

After contemplating Bongino’s message in the days after our Summit, I once again heard the “people control” illustration mentioned in reference to the now infamous rodeo clown episode. I, like so many others, am amazed at the uproar, especially given the fact that presidential masks as well as mockery from the opposite political side have been in vogue for decades. Not content with economic control and manipulation, the left’s “people control” in the form of political correctness surrounds us at every turn. And once I heard radio host Andrew Wilkow’s analogy of political correctness being nothing other than “people control,” I realized that this just may be the message that we need to articulate on a larger scale.

Let’s face it – the world in which we live provides far too many distractions for most Americans to stay politically engaged and adequately educated in

the issues that truly matter for extended periods of time. So if conservatives are going to be successful in communicating what we are fighting to save, perhaps we need to adopt a Wheaties’ box message that clearly expresses what we see happening. The bottom line is we’re battling an administration that is focused exclusively on economic control and manipulation. As Bongino told us at Summit, “We’re in an epic battle for the locus of control of your liberty that’s being taken from you and placed in D.C.”

It’s really not very complicated; our government is fully entrenched in “people control” and unless we share this underlying agenda with everyone we know and express the urgency for their engagement in the political process, it will only escalate in ways that we have yet to comprehend.

And as far as the rodeo clown situation, I’m having a difficult time getting the words of an old Judy Collins’ song out of my head as they sadly fit the majority of our representation in Washington: “Send in the clowns. Don’t bother, they’re here.”

I hope that everyone that reads this article will read past the first several lines to get the full story. If you have no Will, the

State of Alabama has one for you and it may not be the one that you want.

If you die without a Will, the Code of Alabama provides a method of distribution of your assets via an Administration through the Probate Court in your County. ONLY if you literally have no heirs that can be found will your assets go to the State of Alabama. That term is that your estate "escheats" to the State. Even then there are some things that must be done in order to give any potential heirs the right to take under the Administration.

The Administrator of the Estate sells the personal assets of the decedent after all debts and costs are paid. Once notice has been made, then the Administrator has one year before he pays over the sum to the Judge of Probate. For real property, there is a two year wait before the Administrator pays over to the Judge of Probate. As you see, there is a pretty good amount of time before the assets actually go to the State. The Probate Judge, after receipt of the sum of personal assets and after receipt of the sum of real property assets then must pay it to the Alabama State Treasurer.

So if you die without a spouse or children and no Will, then which persons are sought as heirs? First the assets would go to a surviving spouse if only a spouse survives (there is a provision discussed below if a parent or parents survive the decedent). If no spouse then to children, which could include adopted

children or even children out of wedlock (some exceptions apply). If all children are deceased then grandchildren or even great grandchildren can take under the Administration. If none exist then the search moves upward on the family tree to the parents. If the parents are deceased then there is a search for siblings of the decedents. If the siblings are all deceased then there is a search for nephews and nieces and maybe even great nephews and / or nieces. Finally if there is no luck there then there is a search for grandparents, siblings of the decedents parents and their children, etc. As you can see there can be a very extensive search for heirs that can take under the Administration of an estate. I think only in the case of several generations of family remaining unmarried, having no children or some catastrophic event occurring that causes the deaths of much of the family, would the estate escheat to the State. But please keep reading because I want to explain the Will that the State of Alabama has for you if you die without a Will.

If you die without a Will, someone must go forward to be the Administrator of the Estate. That person will have to be bonded which cost the estate money and an inventory of the estate will have to be submitted within 60 days following issuance of Letters of Administration by the Judge of Probate. That can be a huge pain.

So what is the Will that the State of Alabama has for you?

If you die with no Will and only a spouse then they receive everything of yours. However, if you die with only a spouse and surviving parent(s), then your spouse gets the first \$100,000.00 and half after that, the other half to your parent or parents. If you die

with a surviving spouse and children which are all children of you and your spouse then the spouse only gets \$50,000.00 plus one half of the remainder of the estate. Finally if you die and there are children of yours that are not children of your spouse then the spouse only gets one half of everything. If you die with only children surviving you then it gets evenly split between the then living children. If you want to make sure your spouse is provided for after your death or if you have individuals that you don't want to leave an equal share to or you have irresponsible children that might take through an administration of your estate then you know the answer, HAVE A LAST WILL AND TESTAMENT DONE.

If you have no attorney, ask a trusted friend or call the Alabama State Bar for the Lawyer Referral Service. If you are of little means then there are resources for free Wills and the Alabama State Bar can help direct you.

As we approach Labor Day, foremost on most Alabamians' minds is the beginning of college football season. Traditionally, Labor Day has also marked the kickoff of the political campaign season.

As we head into the Labor Day weekend of 2013, my suspicion is that more of you are excited about this Saturday's first games of the season than who is going to run for governor or more especially state auditor next year.

College football is king in Alabama. Make no mistake about it. We love college football. However, it appears the rest of the country is enamored as well. In a recent Forbes magazine article the vaunted financial periodical says, "The players might be amateurs but college football itself hauls in billions of dollars a year in television contracts, ticket sales, sponsorships and paraphernalia."

Not surprisingly, Forbes discovered that the South and more specifically the Southeastern Conference is not only the most dominant on the field, it is by far the richest. Forbes' study revealed that seven of the ten most lucrative college football franchises are in the SEC.

The report lists these SEC schools and their team values if they were in the NFL. At number four was LSU with a team value of \$102 million. Georgia was number five at \$99 million. Alabama was number six at \$96 million. Florida came in seventh at \$93 million. Auburn was ninth at \$85 million and Arkansas was tenth

at \$83 million. Therefore, the SEC held places four through ten in the Forbes rankings of richest franchises. Seven out of ten is not bad.

Texas was number one. Michigan was number two and Notre Dame was third.

For the most part there is a correlation to how well a team does on the field and their dollar value at the bank. That is not precise though. For example, in the last six years Alabama has emerged as the premier college football program in America, while Texas has suffered through some lackluster seasons. A lot of Texas' financial success stems from its unique, exclusive television arrangement. Notre Dame also has a novel national television contract and following.

However, the SEC recently entered into a lucrative extensive television contract that will air our dominant teams nationwide and insure that our top teams remain in the top ten financially for years to come.

By the way, according to Forbes the average salary of the ten highest paid football coaches in the country is \$4.2 million. Nine of the ten are state employees. Alabama's Nick Saban remains number one and deservingly so.

Labor Day generally marks the end of the summer vacation season with many of you slipping in a final trek to the beach. For those of you who like to frequent our own Alabama gulf coast, you will have a new luxury resort hotel to accommodate you soon and it will be owned partially by the state. Gov. Bentley

made a convention center hotel on our own Alabama coast a lynchpin of his accomplishments during his first term in office. He repeatedly said, I am tired of going to conferences of Alabama associations that are being held at Sandestin on Florida's gulf coast.

Bentley spearheaded the efforts to make our own Gulf State Park a luxury convention destination. Legislation was passed in this year's Regular Session to make it a reality. Six governors prior to Bentley have floated the idea. The legislation allows the state to partner with a private developer to build a hotel and conference center at our Gulf State Park. The hotel will actually be built on the stretch of beach where the old Gulf State Park was located prior to it being decimated by Hurricane Ivan in 2004.

The state will use \$80 million it received from the 2010 BP gulf oil spill to pay for the project. Therefore, the state will own the land and facility.

You could see Bentley's pride when he signed the bill creating the new luxury state owned hotel. He had the bill signing on the site of the new venture. It was a beautiful clear May day on the Gulf of Mexico with blue skies and seagulls surrounding the Governor and Gulf Coast dignitaries. Bentley beamed as he set the project in motion.

It should be a crown jewel for our gulf coast that generations to come can enjoy and from which the state will reap the profits.

LET SOCIAL SECURITY HELP GUIDE YOU TO WORK...

September is National Guide Dog Month.

The celebration of the work that guide dogs do each day was inspired by actor Dick Van Patten, who wanted to raise awareness and money to help guide dog schools.

Many people who depend on guide dogs also depend on disability benefits. People who receive Social Security or Supplemental Security Income (SSI) due to a disability suffer from severe ailments that make them unable to work and provide for themselves. However, sometimes it is possible — with a little help — for people with disabilities to become self-sufficient through work.

If you are getting disability benefits, we understand how difficult the prospect of trying to work can be. We also understand that the possibility of having medical and financial benefits cut off can be frightening. But rest assured, Social Security has some great work incentives in place that allow people with disabilities to “test the waters” and prove that they can work before any benefits are stopped. That makes it inviting to try. Even if things don’t work out, the benefits will still be there for you.

These work incentives include continued cash benefits for a period of time while you work, continued Medicare or Medicaid while you work, and help with education, training, and rehabilitation to start a new line of work. The rules vary depending on whether you receive Social Security or SSI.

Although the ultimate goal of work incentives is to help bridge the gap between a dependence on monthly benefits and self-sufficiency, we cast a large safety net to make sure you do not find yourself in dangerous waters. You may continue to receive benefits while working, and medical benefits can sometimes continue to provide coverage for years.

When a person who receives Social Security or SSI disability benefits works, there are certain impairment-related work expenses that we deduct from your countable income, making it possible to earn more and remain eligible to receive benefits. For SSI, these excluded expenses can allow you to receive a higher benefit payment. Examples of these impairment-related work expenses include wheelchairs, certain

transportation costs, and specialized work-related equipment. Blind work expenses can include guide dog expenses, meals consumed during work hours, and income used to pay income taxes.

You can learn all about the different rules for both Social Security and SSI by reading our publication, *Working While Disabled — How We Can Help*, available to read or listen to at www.socialsecurity.gov/pubs.

From that page, type the title in the box at the left side of the page. The online booklet will tell you about the work incentives you may be able to use.

You also can put the word “work” in the publications search box to find out more about how Social Security’s work incentives can help you. Pay special attention to the publications entitled *Incentives To Help You Return To Work* and *Your Ticket To Work*. These publications, which you can read or listen to, will guide you as you consider your options.

OBAMA ASSERTS "SNOWDEN SHOULD'VE USED THE COURTS"

In his August 9th press event, President Obama's said his decision not to attend the G-20 summit in Moscow next month wasn't solely related to Russia's decision to grant asylum to Snowden. In further discussion on the Snowden matter, Mr. Obama asserted Snowden should've used our federal courts to address his Fourth Amendment concerns. Since that Friday press conference, many said they thought of what we (me and my bride) endured in our 13 year and hundreds of thousands of dollars Fourth (Third and esp. Fifth) Amendment civil rights fight. Even after winning unanimously in the 2005 SCotUS (8-0, Justice Roberts was not yet installed) thanks to some heavy lifting by lawyers like Jeffrey Bennett and excellent Judges like Michael Nix, Jacob Walker (Lee County) and Susan Walker (Middle District of Alabama) who understand as well as defend our civil rights; the case was returned to Myron Thompson who again ruled against our civil rights. The second time up to the 2010 SCotUS under Roberts' stewardship, the case was not forwarded to the full court (it seems by Justice Kagan or Sotomayor) where it was likely to win again, albeit not unanimously given the new mix of justices and their (mis) understanding of civil rights.

This is how (even more so with poor jurists like Dubina, Kagan, Roberts, Sotomayor, Thompson) federal courts work to overturn sound decisions and summary judgments in defense of our civil rights. Although Thompson's most (in)famous 'Ten Commandments Monument' decision declaring himself arbiter of the interior décor of our court buildings is what comes to mind for most folks, I recall the Johnny Reynolds case (ongoing since 1985) to illustrate how incompetent the federal courts are with respect to quickly and definitively addressing civil rights violations. Johnny Reynolds died before he ever saw a decision; I suspect Mr. Obama would prefer Snowden die before he ever saw the light of a courtroom. It was clear in our case (esp. when we wouldn't succumb to threats of \$10,000/day fines, threats of financial ruin via Rule 11, etc.) the bullies wanted us to die and go away; they certainly didn't think most folks could survive being made homeless, pay a mortgage/taxes on their house as others lived there, pay to reside elsewhere AND pay legal expenses... Those refusing handsome settlement offers to go away are denied the ability to reduce further victimization of others when a corrupt judge is willing to pluck the case from competent, honest jurists. The Honorable Susan Russ Walker's capable hand (unanimously affirmed by the 2005 SCotUS) had to be denied to continue quashing these fundamental civil rights.

I suspect Mr. Obama's rhetoric admonishing Snowden for not using our federal courts will be effective; most do not know how they work in fact. If Snowden is indeed correct about Fourth Amendment civil rights violations, our courts are not an option. More than enough judges are comfortably corrupt and clearly undisciplined by the Roberts Court (unlike the 2005 SCotUS which showed some promise of restoring our civil rights) to deny Snowden the light of a courtroom. This has become the 'new normal.' Even after many favorable summary judgments, affirmed by a unanimous Supreme Court to be granted one's day in court, cases are recycled back to the corrupt and incompetent judges to deny justice. Despots quashing our civil rights know to keep grinding away in our courts to where the case finally dies as victims run out of money/resources, plaintiffs die or it simply is not forwarded by a Kagan/Sotomayor type. This is how politburo bullies operate.

Does anyone (including Mr. Obama) sincerely think a young man like Snowden could endure what we did? It breaks my heart to see Snowden's father come to terms with what a despotic institution his son has taken on. I wish our parents had not witnessed the fraction of what we endured. Few know the courage it took my beautiful bride (of good spirit and the strongest sense of righteousness) to suffer the bullying and verbal abuse of 'public servants' like Terri Sewell (now in Congress) who continues to show such reckless disregard for our civil rights. In the end, if they were so confident to engage in 13 years of litigation expense, bullying tactics and threats - why deny a plaintiff's day in court to justly lose? Does Mr. Obama, who knows exactly how the system works in fact, really think

Snowden would've (or ever will have if he returns) been allowed his day in court on the 4th Amendment issue?

Instead of arguing if Snowden is an attention seeker, fraud, hero, patriot, traitor, etc., I prefer to find a lesson in recent events. US Army Private Bradley Manning held soldier status (was in uniform at the time of his offense) and recently sentenced to 35 years. If we operated under a Constitutionally correct system, this is a reasonable/just result. Mr. Edward Snowden was NOT a soldier. He worked as civilian for a federal govt. agency which has no sound Constitutional authorization to exist. The Constitution (for sound reasons) placed a two year appropriations limit on the Army. The founders rationally feared what may result from large standing federal armies in times of peace. The Navy on the other hand (given the purpose of securing the blessings of liberty by providing stable currency [coin money] to keep commerce regular between member States and other Nations trading [defend shipping/deter piracy] with member States in the coalition, provide the common defense [with the well regulated/provisioned militias] to promote the general welfare/domestic tranquility) did NOT have a similar appropriation limitation. Costs of providing a functioning market to keep trade of this sort regular are ongoing.

The full faith and credit clause was to allow borrowing for 'durables' like arsenals, coin money, custom houses, dockyards, frigates, port construction, etc. which are consumed over time. Those who wish to devote a long time (in excess of two years) to public service in defense can enlist in the Navy; as an aviator, seaman, etc. and if they prefer infantry/land artillery, etc. the Marines. It all operates under the same JAG corps and every two years Congress must decide to expand brigades, fleets, etc.; keep current levels; or if they will contract by BRAC, RIF, attrition or some other manner (hopefully more rational than 'sequestration') they deem apropos. The best of aviation/artillery/infantry may go to West Point on renewable two year contracts after long term Navy/Marine service where they've acquired knowledge of the most recent tactics and technology. The best of the two year Army enlistments can apply to Navy/Marines if they wish to be considered for a longer term/career contract.

How does this apply to Pvt. Manning? ...he should never had been contracted/paid longer than two years and clearly did NOT show the commitment (nor the maturity/stability) to be in any position where sensitive intelligence was at his disposal - esp. in 'peacetime.' Of course, the notion of a Congress which actually did their job and declared war (defined objectives) would also remove a bunch of nonsense like Guantanamo and other issues designed to be dealt with via wartime military tribunals. Nonetheless, Manning was in Army uniform at the time of his offense, so while his duties shouldn't exist (in peacetime) at his station/position - the sentence is just.

How does this apply to Snowden? ...no civilian should be in a position to deal with sensitive defense information/intelligence (esp. in peacetime) not in a long term Navy/Marine enlistment. International military intelligence (with non-US citizens) is the responsibility of ONI (Office of Naval Intelligence) by those in uniform who tend to care/have more camaraderie/empathy for others in uniform. Let's be clear that non-US citizens do NOT have civil rights under our Constitution. Once it is determined a US citizen is involved (where civil rights DO apply) then the federal Marshal office must pick up the lead and concern for civil right violations apply.

I suspect those who've managed to read this far are either upset or confused, since most do not think the Constitution a document which provides sound guidance on this civil/military dilemma. This includes the naive who believe without our provocative actions (which triggered the 'blowback' these past decades) we'd not require federal Marshal/ONI surveillance; even more so the redundant bureaucrats, brass and others who

privately benefit from and/or believe the current extremist result makes us safer.

Let's make this painfully clear; it is time to do away with our redundant, unconstitutional, unnecessary federal defense/security agencies, civilian and military. Air Force - the Army Air Corps was supposed to down-size in two year cycles after WWII; not become yet another brass laden DoD branch in 1947. They no longer show interest in supporting ground troops which should be Marine/Navy aviation - esp. in peacetime. FBI shouldn't exist, we were doing fine before this redundant agency came along about a century ago proffering despicable like J. Edgar Hoover. If federal Marshals require more resources for their investigative division, go to Congress and justify increased appropriations for investigations.

land in Alabama for a month now. Confusion still seems to be the theme of this law. Lawyers of all different positions, private and public, have difficulty interpreting this law. Some of the confusion seems to come from individuals who want to do what they feel like doing and try to push the limits of the law. For example, this law may allow open carry, but there are restrictions. You cannot open carry on property not your own. If a person does not want you on his property with a gun, you must leave. You cannot open carry in a vehicle without a license to carry a pistol. If you do not have a license to carry a pistol you must unload your pistol, lock it separately from the ammo in a secure container that is not in reach of anyone in the car. This usually means in the trunk of a car or locked in a toolbox in a pickup truck.

I do not like the part of the law that requires Sheriffs to issue permits to people between 18 and 21 years old but it is the law and now an eighteen year old can obtain a permit. In my opinion most 18 year olds are not mature and do not fully understand the implications that carrying a pistol implies. They need to understand the ramifications of shooting the weapon and how they are legally and civilly liable for their actions. Using a weapon can sometimes be a life changing event and they need to understand this. There have also been problems with people under 21 attempting to buy a weapon and they think that they can buy a gun because they can obtain a pistol license. This is not the law. The truth of the matter is that federal law requires them to be 21.

The new Alabama gun law has been the law of the



zone, so this idea does not fly in my opinion. Try to get onto Maxwell or Gunter with a weapon and see what happens. I promise that you will not like the results.

Just get a permit and you will eliminate most of the problems you encounter by refusing to do so. Speaking of permits, we now require new applicants as well as renewals to fill out an application. The law says that we need to run a thorough background check and we are required to retain the applications for 6 years.

The application needs to be filled out COMPLETELY and TRUTHFULLY. Lately it seems that many people are not truthfully filling out their pistol permit application, mostly lying about past arrest. These applications are being denied and I am planning on prosecuting people who are not truthful in the near future. 13A-11-81 of the Code of Alabama says that no person shall, in purchasing or otherwise securing delivery of a pistol or in applying for a license to carry the same, give false information or offer false evidence of his identity. The penalty for violation of this law is a felony punishable by imprisonment for not more than FIVE years.

I also hear the story that 18 year olds can serve in the military and carry guns in combat. That is true but we are not in a war here at home. Even in the military people have rules to go by. You don't see people walking around a military installation wearing a firearm. There are rules that require them to turn in the weapons when they are not in a combat

We are here to assist every law abiding citizen in obtaining a license to carry a pistol and will do what we can to see to it that you are legally carry a concealed pistol on your person or in your vehicle.

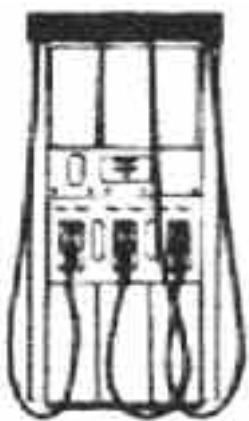

DOVE FIELD PLANTING GUIDELINES ESTABLISHED BY THE ALABAMA COOPERATIVE EXTENSION SYSTEM

September has finally arrived. This month signals the beginning of college football, cooler weather, improved fishing and most of all, hunting season. Dove hunters will hit the fields on the 7th for the opening day of the season. This month, we will look at some tactics that will improve your odds of harvesting these speedsters, as well as tips to help you select the best spot to set up on a dove field. If you are lucky, a dove breast barbecue may be right around the corner.

First of all, hunters need to be aware of the new dove field planting guidelines that have been established by the Alabama Cooperative Extension System. They are as follows:

1. **Winter wheat can be top-sown from August 1 - November 30 statewide. This planting practice requires a well-prepared seedbed. A well-prepared seedbed involves adequate tilling of the soil so when the seeds are planted there will be good soil-to-seed contact and the soil will not be excessively hard (i.e., it can easily be penetrated by the developing root of the germinating seed).**
2. **Up to 200 pounds of wheat can be top-sown per acre.**
3. **Doves can be hunted over top-sown wheat when planted for a wildlife food plot, a cover crop, an agricultural crop or as supplemental livestock grazing.**

In this part of the state, most counties fall into the North Zone of mourning dove season. This zone has a split season, actually 3 seasons, in which you can hunt dove. The first season runs from September 7 to October 6, the second from October 19 to November 2 and the third from December 7 to December 31. Shooting hours are from one-half hour before sunrise until sunset except for opening day, when you can't start hunting until 12 o'clock noon. If you shoot a repeating shotgun, it must have an internal plug limiting it to only holding three shells. Remember too, that all licensed hunters who hunt dove are required by Federal Law to obtain a HIP permit prior to hunting. HIP permits are free and are available at www.outdooralabama.com and all hunting license vendors.

Too often hunters show up at a dove field and simply sit in the first patch of shade they find. They give little or no thought to a number of factors that could ensure the time is occupied with more shooting than waiting. It's happened to most dove hunters at one time or another. There you are, through poor choice or luck

of the draw, at the wrong place on the field. Frustrated, you watch other shooters enjoy fast and furious action as you sit there, lamenting your fate and praying that one or two birds may unwittingly blunder close enough to afford a shot before the end of feeding time or legal shooting hours.

So make your own luck! When it comes to having action on a dove field, there are many factors to consider. First, it pays great dividends if you have done your "homework" and familiarized yourself with the specific nuances of the field. This is the only reliable tactic that can tell you such vital things as where the birds are coming from, when they start arriving, and where they concentrate their on-the-field activities. Why waste time sitting in spots where doves aren't flying? They are creatures of habit, so a little scouting goes a long way in patterning doves. Birds frequently fly along tree lines and field edges as well as across the middle of fields, where terrain features help them navigate.

Also keep in mind that doves like to be able to see, and feel protected at the same time. Once you've identified their "flyways," look for spots that satisfy their need for security, and your need to get off a shot. Key on gaps in a tree line, a saddle on a hill, converging crop fields, a dead tree, windrows and even a high spot, such as a lone dirt mound in a field.

Often hunters are invited to a first-come/first-served shoot on the field. In such instances, the trick is to be prepared to recognize certain strategic set-ups on the dove field that can work to your advantage. If it's permissible, get there early. When picking a set-up spot on a dove field in this situation, take several factors into consideration. Let the sun and its relationship to where you are setting up be high on your list. Keep the sun to your back whenever possible. Doves are tough enough to hit under ideal circumstances. Don't handicap yourself by having to stare into the glare of a blinding morning or afternoon sun. And, as mentioned earlier, look for features like gaps in a tree line, a dead tree, a power line, anything that may act as a attractant for dove

entering the field.

When it comes to being hid, the best camouflage pattern in the world is generally worthless if the person wearing it can't keep still. Breaking your outline is very important, but sitting still should definitely be your main concern. A smart dove hunter remains perfectly motionless until the very moment he decides to stand and shoot. And carry all the supplies you need when you first leave your vehicle. Don't be running back and forth to the truck during a hunt.

You can hedge your bet even more by putting a few dove decoys on fence wires, bare limbs or anywhere

else they can be seen by flights of birds coming into the feeding area. Over the past few seasons, dove hunters have added another tool to their hunting arsenal. The spinning-wing decoy is, just as the name implies, a dove decoy with a battery-powered motor that causes the wings of the decoy to spin, thus imitating a flying dove. Place it on a raised stand, and its spinning wings can be seen from quite a distance. This motion captures the attention of the doves and



lures them near to the decoy. While the birds' eyes are fixed on the decoy, the chances of them spotting the hunter are diminished.

You'll find most successful dove hunters are not necessarily the greatest shooters in the world. Rather, they are the ones who show up the day of the shoot having done enough studying beforehand. They have learned – often the hard way – that the right tactics and preparation go a long way toward compensating for those occasional missed shots. Shooting inaccuracy notwithstanding, these are the hunters who still leave a field with a respectable number of birds in their game bags.

Next month, archery season takes center stage. Early October is also the best time to plant your food plots. He was also a great option quarterback on one of Troy's national championship teams before Troy went to Division 1A. Huntingdon will get a late start on the season as they travel to Mississippi College on September 14. This could be the toughest test for the Hawks. For a team that didn't even have a football on campus seven years ago, Coach Turk has developed quite a following. Be sure to catch Huntingdon's second game with Louisiana College on the campus at Sanford Stadium on Charles Lee Field.

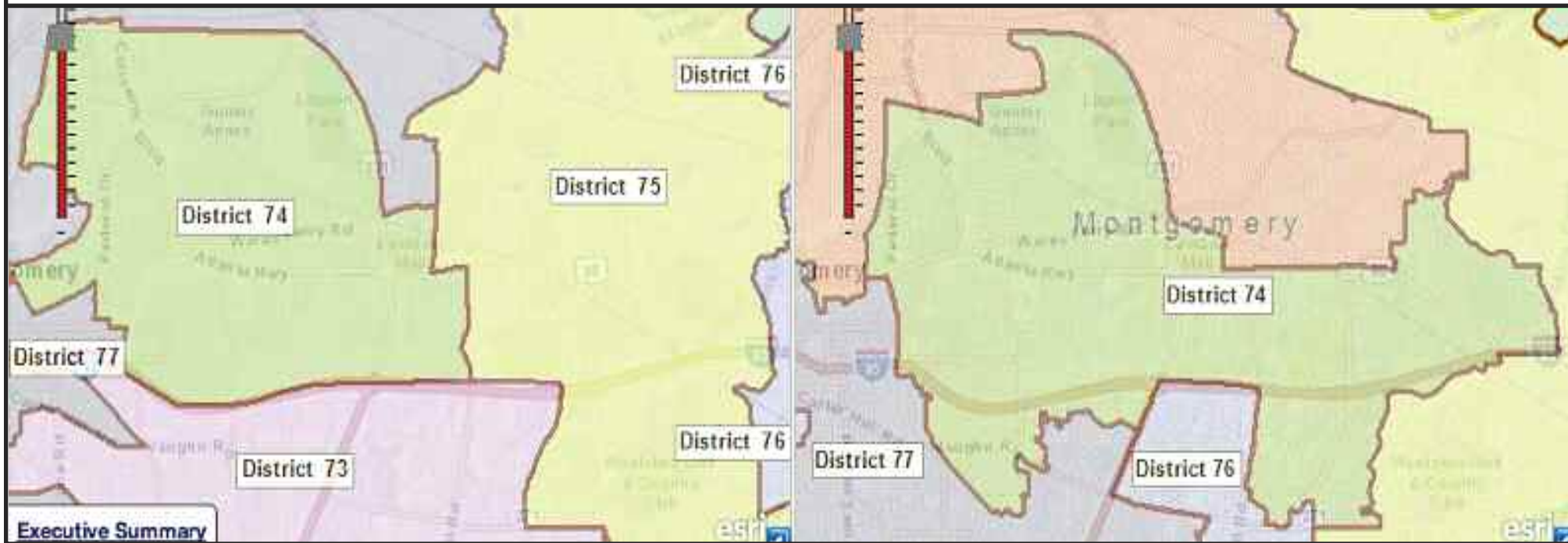

This has been a strange year. I have been around 60 years and I've never seen a summer as wet as this one. I believe it's rained every day and it didn't just sprinkle, it poured.

In addition in all of the years that I have been following politics I have never seen as many resignations from office by political figures.

These folks that quit were not insignificant figures. They were high profile players. Jo Bonner quit his Congressional seat to take a position with the University of Alabama. Beth Chapman quit as Secretary of State to do consulting work for the Alabama Farmers Federation. Representatives Jim Barton of Mobile and Jay Love of Montgomery left their House seats to lobby.

The most important vacancy for those of us in the River Region is the House seat of Jay Love. The Governor has called a special election for October 8. There are three candidates. All three are running in the Republican Primary on that date. All three are good, well-qualified candidates.

It is very difficult to predict a winner. Why? Because special elections are a special political animal or show if you will.

Generally speaking a legislative race is driven by money and name identification. Money buys name identification. Therefore you can safely say that a legislative race hinges on who spends the most money.

This axiom is not necessarily true in a special election. In this race the name of the game is organization, organization, organization. It takes a certain amount of money to run an organized attack but it is not the determining factor to victory. You have to target who is going to vote and get your voters to the polls. It is analogous to hunting with a rifle rather than with a shotgun.

In a general primary or election you will have a 60-70% turnout in a Republican House District. In this contest 20% will be high.

Television is probably a waste of time as is radio. These are good for general elections because you reach the masses and they are going to the polls. In this election you need to use the phone, the mail, the internet, and good old fashion shoe leather. I would keep good notes on who said they were going to vote for me and then I would call them ten times before October 8 and 10 more on October 8.

The classic example of what I am talking about occurred in a special legislative election for a republican seat in Mobile earlier this year. State Senator Ben Brooks resigned his Senate Seat to take an open Circuit Judgeship in Mobile.

The aforementioned state representative Jim Barton became the odds on favorite because he garnered all of the Goat Hill special interest money. Get this folks, Barton raised \$500,000 and bought TV ads galore on every Mobile station. His opponent spent \$50,000 and won. In fact despite being outspent 10-to-1 he beat Barton 60-to-40. I'm sure Barton probably had a lot of folks who live in Pensacola that watch Mobile TV that wanted to vote for him, but he did not do his homework at home where it counted. There is a tried and true maxim in politics. All politics is local. This race calls for a rifle not a shotgun.

If you want to get an idea, on who the favorite is in this special election look at if and who they hired as a get out the vote campaign strategist. It is the best bang for the buck in this special election. The best campaign consultants in the state are right here in Montgomery.

There are two other certainties in this scenario. First whoever wins the district loses. Jay Love was Chairman of the House Ways and Means Budget Committee. The next representative will be a first term back bencher.

Secondly they will have to turn around and run again immediately. They will probably be challenged in the June Republican Primary and they may very well have a Democratic challenger

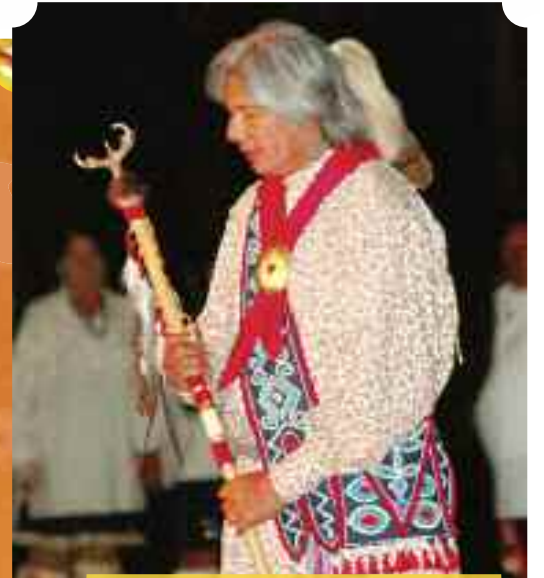

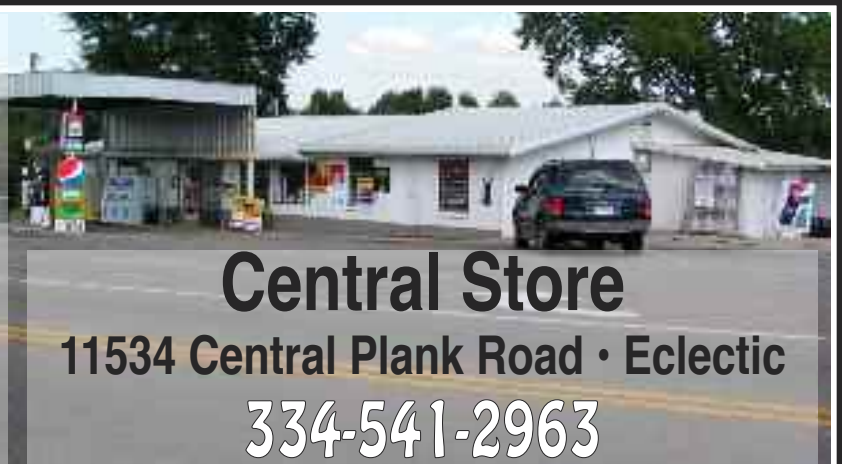

IT'S 2013 AND ALABAMA STILL STRUGGLES WITH THE PRINCIPLES OF EQUALITY!

Do you ever wondered how changed occurred? How the 19th Amendment to the Constitution was finally ratified, enfranchising all America women and declaring for the first time that they, like men, deserve all the rights and responsibilities of citizenship? It took time and dedicated individuals and the campaign was not easy. It has not been so long ago since the Civil Rights Movement happened in the 50s and 60s, and many of those major events took place in Alabama. It is unclear how this customary and accepted discrimination against children of divorced or never married parents has gained such widespread legal acceptance other than the financial gain by the divorce industry.

Despite Alabama being currently ranked 4th in the country regarding divorces; 44th among the 50 states in overall child-wellbeing, based on measures in four categories – health, education, economic well-being, and family and community; we are still seeing tremendous resistance from those who are profiting from the risk our

children are being exposed to when a discriminatory system takes one of their fit parents from them without any legal reasoning, other than "this is how we have been doing it".

The Education Station...

CHRISTIANITY, EDUCATION, AND THE GROWING POWER OF THE STATE

A great theologian educator, J. Gresham Machen, said long ago, "if you give the bureaucrats the children, you may as well give them everything else as well." He was speaking of the moral and intellectual decline as the federal government continued to reach for more and more control of American Education. Let's look at the moral and intellectual decline in the culture, and the attack on the minds and hearts of American children through a thoroughly secular school system. Let's look at the grave injustice to children, parents, and the future of our liberty. By facing the truth, perhaps people will wake up to the dangers of today.

FAITH and CULTURE

In early America, at the time of the American Revolution, the literacy rate was astoundingly high, probably higher than any place on the planet. Labor was honored, and liberty was treasured. Community groups banded together for community schools, primarily in churches or neighborhood school houses erected for that purpose. Schools in churches were common in every colony. In New England, in Pilgrim and Puritan communities, the wiser and older women, often widows, who had been successful in their own families, were chosen to lead the "Dame" schools. The culture across all the colonies embraced the Genesis Account, faith in one God, the Jehovah God of the Old and New Testaments, who had spoken through His Word. And not only spoken, but had sent His Son to redeem His fallen humanity.

Education began with a focus on this One God, who brought all things into being, the Creator God, being the source of all things, was foundational. Children were taught that they were dependent on Him, accountable to Him, loved by Him, and made in His image. No wonder there were no "self-esteem" problems in New England.

About 150 years ago, all the teachings of Origins went through a dramatic change because of Charles Darwin's book, *The Origin of the Species*. Evolution teaching soon impacted not only the teaching of Biology and all of the Life Sciences, it has destroyed the teaching of Biblical Creation in all public schools. Sadly, it has been taught as true Science to unsuspecting children.

This teaching has also done the most astounding damage to the theory of Government, as the politicians now view all levels of government as EVOLVING as well. This led to the current view of a "living constitution." Today, the concept of law is not "fixed" as it was historically understood by the framers of the Constitution, and for a hundred years afterwards. Now the checks and balances which the Constitution so carefully has crafted into the document is ignored by all three branches of our national government, and by the state governments as well. The States have accepted total dependency on the national government for their 30 pieces of silver.

It is encouraging to see an awakening by many people today to problems that are so evident, and yet, many of these citizens have never read the Constitution and have no idea how to solve the onslaught of Socialism and Atheism. Who will be elected with the conviction

and stamina to reverse the violations to the Constitution? Who will have the courage to take on the battle? True American History has not been the focus of public schools since the late 1920's and early 1930's. I was there, and I was in one of those schools. John Dewey, with the help of other atheists, developed the methodology for the early teaching of Humanism, and trained the teachers and school superintendents in Columbia Teachers College. This attack upon the fundamental principles of civil and religious liberty has taken place for centuries, but never has it been so swift and sophisticated as in the post modern world today. A monopolistic system of education controlled by the State is more efficient in crushing the rights of parents, and of crushing Liberty, than an enemy's sword. The John Deweys and the NEA leaders do not speak for every teacher in every classroom of America. They never have. Not every member of the AEA approves the agenda. Tyranny has never received the popular vote. It sneaks up from behind until too powerful to combat. It is not that powerful today in America.

Most articles on Education are necessarily short and seems to be peering through a small window, displaying only bits and pieces, which is helpful and informative, but never revealing the panorama of the vastness of the demise in the culture. In addition to the teaching of Evolution, another dramatic change took place with the attacks on religion by the secular philosophers: Immanuel Kant, Soren Kierkegaard, Friedrich Schleiermacher, Friedrich Nietzsche, Karl Marx, and the Romantic Movement. In our new century, add these: the pragmatists, the existentialists, the positivists, the neo-orthodox, and the just plain liberals. This anti-intellectualism brought about the mediocrity in modern education in America, but also the demise of Western Civilization in Europe.

The deadly achievement of these pagan philosophers was to separate faith and knowledge in public education, from state supported elementary and secondary schools through the state supported colleges and universities. On modern campuses, the Christian faith and practice is ridiculed. The anti-intellectual climate reminds one of Pilate's question, "what is truth.?" The ridiculous pedagogic theories of the modern university would make a column by itself. Let it be said that the Liberal Arts of Western Civilization have vanished from most American university campuses.

For close to two centuries, on classroom walls hung the Declaration of Independence, U.S. Constitution, and The Ten Commandments. There was very little conflict between Christianity and culture, between knowledge and piety. It was accepted that the foundation for true knowledge must have the foundation of absolutes, found in the Bible.

The government bureaucrats in education circles, attempted to teach "character education" without reference to God's moral law. To attempt to train the mind without the moral law is to educate for a moral collapse in our country. The teaching of Creation and the teaching of Evolution are mutually exclusive world views regarding Origins. These are dramatic conflicting views on how our children view themselves, their pur-

pose in life, the reality of eternal life. Now a government has the power of removing TRUTH from the curriculum, and replacing it with moral relativism. There is no Scientific evidence that can prove any facet of Evolution. It is not Science. True Science does not contradict the Bible. The anti-intellectualism of the age is blind, willfully blind. The Institute for Creation Research and Answers-in-Genesis provide freely true Scientific documentation that upholds Scripture.

It is not only the Executive Branch of government that has overreached, but the Congress and United States Supreme Court go grievously beyond Constitutional action. Just one court case involving Alabama, is the Prayer Case of 1982-1983 in Mobile. The United States Supreme Court dealt a deadly blow to the First Amendment. Some readers may recall the landmark case in Mobile County where Ishmael Jaffree filed against the schools to forbid simple prayer in school: simple prayer such as, "God is great, God is good, let us thank Him for our food." Judge Brevard Hand made a Constitutional ruling in line with the First Amendment religious rights, but the United States Supreme Court overturned his ruling and built its own Wall of Separation theory for the new interpretation of the First Amendment. The Supreme Court has been rendering many of these new interpretations of the "living" constitution, as they proclaim it. The Supreme Court has taken jurisdiction over church-state matters at will, it seems to this writer. Will the States be strong enough to band together to amend the Constitution to place term limits on these justices? Or on Congress?

Senator Jesse Helms summarized unconstitutional actions by the Supreme Court as falling into two categories.

1. It invades the prerogatives of the legislative branch by amending federal statutes. (see the Bob Jones Case)
2. It alters the Constitution without a constitutional amendment.

Today American liberty is being destroyed. The love of liberty was taught so diligently to my mind, that the love of liberty lives in my heart. My husband and I dedicated ourselves to pass on that love of liberty to our children. We understood that liberty is not preserved by ink on a page, but by that love written on the heart. We may be called on to pay the price that the Scottish Covenanters paid in the 1600's where they, at great sacrifice, preserved religious liberty for the faithful.

There can be a revolt against the tyranny that is upon us, such as the French Revolution. That would be a tragedy. There is another way, and that is for every person in the nation who embraces the God of Truth, to become involved in taking back Christian self-government, and in doing so, restoring the Constitution.

Christianity is a world view, but it is also a system of government that worked for us for a long time, and can be restored. Only in this manner will Truth prevail.

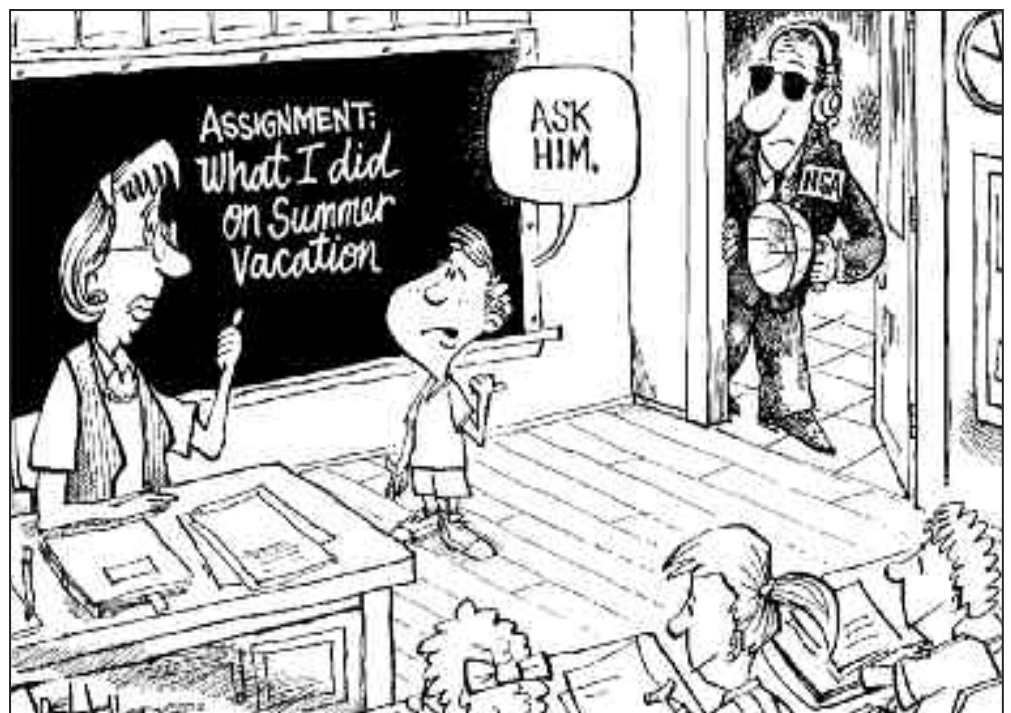

DATA-MINING YOUR KIDS

Parents and Privacy Advocates are outraged at the reports of compiling unprecedented data on students. Monitoring and tracking of students appears to be part of the administration's "education reforms" attempt. Some government agencies are directly collecting the data, and some private organizations with government assistance.

One of the data collection programs titled, "in Bloom," has received attention, as it is already in progress in at least nine states and funded by Bill Gates and the Carnegie Foundation at a reported \$100 million dollars.

In conjunction with "in-Bloom," similar programs are being funded and directed by the government itself.

Attorney Michael Farris, President of Parental Rights.org, pointed out that the United Nations Convention on the Rights of the Child committee pressured governments to create national data-bases on children years ago.

Reporter, Alex Newman, writing for the August 19th, 2013, New American magazine, reports how

widely this accumulation of data systems on students is growing. As of 2009, the latest year for which figures are available on the Department of Education website, show that 41 states and Washington, D.C. had been awarded SLDS (Statewide Longitudinal Data Systems) grants to expand their data systems on students.

Congress passed the "Family Educational Rights and Privacy Act" (FERPA) to protect both student privacy and parental rights with the backing of strong law. This collection of personal and family data no doubt flies in the face of this law. What will Congress do about it?

In the Alex Newman lengthy and well crafted article for his readers, he warns that the data suggested for inclusion would be "political affiliations or beliefs of the student of parents; mental or psychological problems of the student or the student's family, sex behavior or attitudes; illegal, anti-social, self-incriminating and demeaning behavior; religious practices, affiliations, or beliefs of the student or the student's parent, or income." The loophole appears to be that while federal law forbids this kind of data

collection, bureaucrats argue that state laws do not forbid it. Information from all levels of government appears to find its way into a national data bank today. As technology advances the Dept of Labor, the Dept. of Education, and all of "Big Brother" will be able to create linkages and share information at will. The Newman article referred to reminds one of the Orwellian Nightmare, as the collection biometric data is accelerating.

The article states, "Despite fierce opposition, the trend toward using biometric data to identify and track students while collecting unimaginable amounts of information is accelerating. The federal government is helping lead the way toward abolishing any vestige of privacy, and aside from the NSA spying on virtually everyone, students seem to be among the primary targets."

Let's be honest, some heat and sunlight would be a welcomed relief to this summer's monsoons. Forget all the tomatoes, squash, and all other plant material that has rotted from too much moisture. I just want everything to dry out so I can know what type of plants to replace in the fall. I am looking at the weather prognosticators for this information so I can use marigolds, and Obedient Plant for the soggy areas of the garden. Also Cardinal flowers loves damp feet. Perhaps by the time the September chores are completed as described in another part of this article, I can move forward for the fall garden.

As the end of the summer is upon us, we can always depend upon fall perennials for fill-ins and also to get bigger and better for next year. The selections we are offered through garden centers and other plant outlets have increased in variety and quality over the years. A few of the fall perennials we should look at in our area should include Salvia leucantha, which is a clumping salvia with burgundy colored spires. It is hardy, and the cut flowers are superb for indoor arrangements. Other choices include Asters, Chrysanthemums, the Obedient Plant (*Physostegia virginiana*), Goldenrod (*Solidago*

and perennial *Ageratum*. These should round out an interesting mix for the Autumn garden.

Now just a little about the above flowers. The Obedient Plant is surely a misnomer as it is anything but obedient in any way except when you bend the bloom head, it remains in that position. This is a great attribute for flower arrangements. But in the garden setting, this plant can easily get away from you and be invasive. So stay on top of it and uproot unwanted colonies. No wonder it tends to spread rapidly since it is a member of the mint family and propagates through rhizomes and seed. But when you see these flower spikes in snapdragon like blooms, you will come to the conclusion that it worth a little pulling out. Also, this squared stemmed plant does not mind soggy feet and adds height of over 2 1/2 feet to the beds. A variety named 'Miss Manners' is truly obedient, and a variety 'Summer Snow' has beautiful white blooms.

Garden chores may be more onerous due to all the rain Montgomery has experienced throughout the summer. However, we must bite the bullet and clean out and refresh the beds by removing dead plants, weeds and other debris. One way I recommend is to hand weed within 2 feet of a stand of flowers we intend on keeping, cover the plants with a garbage bag and then spray with round up or it equivalent. This precaution is passed along

since I have been careful to not spray on a windy day, but even the slightest zephyr of breeze can blow the spray onto the plant, with disastrous results.

PLANT OF THE MONTH -- STONECAPS

A common name for the family of Sedums which are succulents and scientifically known as hylotelephium. The most popular and probably the easiest to acquire is 'Autumn Joy' and also known as 'Indian Chief'. It thrives just about anywhere and is especially easy to root. Standing over a foot high and a foot wide, they bloom in late summer with a pale pink flower, but by October they have morphed into a bright rusty red, then fading to a burnt orange brown. Another good variety is 'Autumn Fire' which has a sturdier stem and longer lasting flowers. I have enjoyed this long lived perennial for years, just leaving it to do its thing in a corner of the bed. It thrives in partial shade and is very much at home in rock gardens. Sedums mix well with ferns, hostas, and other low light plants. Other great varieties are 'Chocolate Drop', and 'Thunder Cloud' which has a serrated leaf and hundreds of white blooms. And I can not leave out 'Neon' which has such electric bright pink blooms that it glows. It is a real eye-catcher with its unique flowers.

2013 MASTER GARDENERS Class Application Deadline

For those River Region gardeners who've been planning to become a Master Gardener, the September 13th deadline for applications for the 2013 class with the Central Alabama Master Gardeners' Association (CAMGA) in Wetumpka is fast approaching.

Applications may be picked up at the Elmore County Extension Service office at 340 Queen Ann Road, just off Hwy 14 on the west side of Wetumpka or online at: <http://www.aces.edu/pubs/docs/ANR-115/ANR-1155.pdf>

Completed applications must be received no later than Friday, September 13th, 2013.

Once the application has been approved, the Master Gardener students will attend classes for 10 consecutive Thursdays beginning October 3 and ending December 12, 2013 from 9am-2pm. The registration fee of \$125 is due before the classes begin and includes lunch on each class day.

Subjects to be studied will include Basic Landscape Design and Plant Selection; Plant Propagation; Soils and Plant Nutrition; Hummingbirds; Vegetable Gardening and many more. Class instructors will include Alabama Cooperative Extension Service (ACES) County Agents, experts from Auburn University and experienced Master Gardeners.

Upon completing the class work, Apprentice Master Gardeners will be expected to contribute 50 hours of volunteer activities CAMGA projects in the next year. These hours will include assisting on the Master Gardener Help line that provides a source of information for area gardeners; participating in developing and maintaining the expanding Learning Gardens at the ACES facility or aiding other volunteers in landscape development and maintenance work at various public facilities in the River Region, primarily in Elmore County. Volunteer opportunities are plentiful with the 2012 class of 15 Apprentice Master Gardeners (Interns) having contributed nearly 1,500 hours.

CAMGA has members primarily from Elmore, Autauga and Montgomery Counties.

Space in the 2013 class is limited and the deadline for applications very close.

ALABAMA'S 2013 PEANUT CROP

MONTGOMERY, AL - According to the USDA's August Crop Production Report this year acres planted in peanuts are down 90,000 acres in comparison to 2012. Overall peanut production is projected to be down 55%. With record rainfall recorded throughout many areas of Alabama, several acres of peanuts will be lost as a result of standing water in the fields. Farmers are also facing an increase of weeds and disease because spraying was delayed by the excessive rainfall. Despite the

complications brought on by significant rain totals farmers are cautiously optimistic and hoping for at least an average 2013 peanut crop on well drained fields.

Commissioner of Agriculture & Industries John McMillan stated, "This has been one of the wettest summer's I can remember and because of that we were afraid

the peanut crop could be a total loss. I'm encouraged by what I've seen in the fields and heard from several of our Alabama peanut growers."

As you can see in the provided photo some peanuts are completely mature and there are several well on their way. Peanut harvest is expected to begin around September 15th in South Alabama.

Approximately half of the peanuts grown in the United States are grown within a 100-mile radius of Dothan, Alabama. The peanut Industry contributes over \$211 million to our state's economy and provides over 2,000 jobs.

Interesting Facts about Peanuts (Provided by the Alabama Peanut Producers Association)
Nearly half of the United States peanut crop is used to make peanut butter and Americans eat 3 pounds of peanut butter per person every year. That's about 700 million pounds, or enough to coat the floor of the Grand Canyon. Nutrition studies show peanuts and peanut butter are good for you! There are many health benefits from eating peanuts, peanut butter and using peanut oil. In fact, studies show that when eaten in small amounts daily, peanuts reduce the risk of a number of chronic diseases.

In 1997, movie theaters were packed with folks who came to watch Leonardo DiCaprio and Kate Winslet go down with the ship in a fictional re-enactment of the actual 1912 disaster: the sinking of the RMS Titanic.

In the year 2013, the world is watching as the USS America, having crashed into a fiscal iceberg, is rapidly sinking into the sea of debt and scandal as the ship's captain, played by Barack Obama, tries desperately to ignore the fact that his ship has struck an iceberg and is slowly sinking into a sea of debt, incompetence, chicanery, and insolvency.

Even in the U.S. there's a tendency to look at it as an affliction that needs to be attended to in some way or another. At the same time, little or no effort is made to accommodate people who are left handed.

Add to that, there are some people who go both ways and are referred to in professional circles as "cross dominant."

It was your humble scribe's lot once, as a student of education, to take an education course in which the problem of cross dominance was studied. Not only studied, but viewed as a mental disability; and various efforts to cure the affliction were studied.

And here's your humble scribe, after 50 years of blissful existence on this planet, suddenly discovering that he has such a mental problem and it is presumed to be a physical disability.

Rubbish, yours truly must say.

One may wonder—or one may not—what the reaction of most southpaws was last month, when, on August 13, the world celebrated International Left Handers Day.

Left handers should have invited others, who have not been blessed with this unusual ability; to share with them this opportunity to inform the world that everyone is out of step but them. And there's a lot of them—about 10 percent of the total population is left-handed--and they're proud of it.

Quit Worrying Start Living

There are just two days in every week which we should not worry about, two days which should be kept free of fear and apprehension. Do you know what they are?

One of these days is yesterday. Yesterday had its aches and pains or maybe it's good times. But it is gone forever, beyond our control. Yet there are people who live in yesterdays. One friend of mine called them "postmortem people." They are always digging up the past. "Why did we have to move?" "Why did I take that job?" "Why did I marry that person?" Or they are looking at the sorrow of yesterday. It's just not possible to find happiness with the future constantly questioning every decision of the past.

I knew a family who had a baby die in the first year of his life. Not only did they suffer grief as would be expected. Years later they had not changed one thing in that child's room. Almost every conversation with either of the parents of more than a minute or two the subject of their child's death was brought up. They just could not bury the sorrow of yesterday and let God heal the wound.

Sorrow is a kind of wound. It does cut deeply and it is painful. We know from our bodies if a wound is clean it will usually heal itself. The same is true emotionally. But if we keep agitating a wound and adding things to it a serious infection may take place. Sometimes it can poison the whole body. The Great Physician, our Lord, can heal the wounds of sorrow if we turn it over to Him. He is the one who can take the bad things of life and bring good out of them.

Some people also live in the yesterday of their sin. Sin has cast a dark shadow over their life, especially their inner being and sense of conscience. Over and over their inner spirit is being beaten up by the reminder of their sin. Guilt rides their soul as they keep living in the sins of yesterday.

I remember a conversation with a young man who said I do not know if I believe in God or not. I pray and don't seem to get an answer. If He is out there, I am sure He is not listening to my prayers. As we talked I discovered that this young man once had faith in God. The problem was that there was a sin back there in his life which he had not felt was forgiven. It hung over him but he had never really confessed it to the Lord and found forgiveness. His sin was a barrier between Him and God. It was not God that had moved away from the young man, but that he had allowed a wall to be so high he could not feel or sense God.

One of the most important lessons of the faith life is this. You cannot find happiness with God and hold onto your sin. God has no desire for us to live carrying the burden of yesterday's sorrow or sin. There is a wonderful verse in the Bible which is so helpful to all of us. "If we confess our sins, He is faithful and just to forgive our sin and to cleanse us from all unrighteousness." The Bible promises that God wants to remove our sin from us as far as the east is from the west.

It is like a friend who when walking through his yard from front to back stopped to close the gate behind him which separated the two sides. He said, "I have always made it a practice to close the gate behind me. That is a good motto for

all of us about our yesterdays. Learn to close the gate behind us as we pass from one day to the next. It is a lot easier if we could just whisper a prayer in the morning which goes like this, "Lord, forgive me for what I may have done wrong yesterday and help me to forgive anyone who did me wrong. Help me to forget yesterday's disappointments and failures as I seek to live today for you."

There is a second day we should stop worrying about. That is tomorrow with all its possible adversaries, burdens, and potential problems. Tomorrow is really beyond our control. Tomorrow's sun will either rise in splendor or it will be covered by clouds. But it will rise.

I know a lot of people who are trying to live in their tomorrow. They live in the tomorrow of procrastination. Tomorrow I will quit smoking. Tomorrow I will go back to school. Tomorrow I will set a better example for my children, work on my marriage, get help for my problems. Tomorrow I will get my life right with the Lord. Probably you've heard or said some of the same things. Procrastination about what we know we ought to do is a sin, not one of immorality, but a sin none the less.

Jesus told the story of a wealthy farmer who looked out at all his crops and wealth. He bragged "tomorrow I will tear down my barns and build bigger ones. Then I can sit back and take my ease." Jesus condemned the man saying, "You fool, for tonight your soul will be demanded of you." What Jesus meant was this. None of us has the absolute promise of tomorrow. We ought to do today what we know we ought to do. If there is an "ought" connected to a decision in your life which you can do something about and you do not, then consider that a sin.

There is also the tomorrow of worry and anxiety. I would not pretend that there are not reasons of concern in our world. All one has to do is to look at the destruction of many things we hold dear in our nation, to the international problems both militarily and economically and to the challenges to the future for our children and grandchildren. Yes, these hold great issues of concern which we can not change or solve alone.

But have you considered that we are not born natural worriers. It is not a natural characteristic of human nature. You have to learn to worry. Some people practice it so much they get really good at it. It is a learned habit as much as a musician or athlete gets good at their chosen task.

I heard a silly story but one which makes a good point. It is about a grandfather clock which had been sitting in the hallway for years in that family, keeping time, tick tock, tick tock. One day the clock had a nervous breakdown. The clock went to a clock psychiatrist. He came in shattered. The doctor asked what was wrong. "I've just got too much on me," said the clock, "I can't stand it any longer. I sit in the hall and go tick tock, tick tock on and on. I have to make two ticks a second, 120 ticks a minute, 7,200 ticks an hour, 172,800 ticks a day. Do you know I have to make more than 62 million ticks a year. I just can't take that strain any longer!"

The clock psychiatrist asked, "Now how many ticks do you have to make at a time." "Oh, I just have to make one at a time." "So why don't you just make one tick at a time and forget about all those you have to make later?" And so the old clock went back and began just ticking one tick at a

time. That was twenty years ago and he is just fine.

Out of this little story maybe we need to learn a lesson. We can't live 30 or 365 days at a time. We really can live only one day at a time.

Someone said, "85 % of the things we worry about never happen. If you really want an eye-opening lesson just write down everything you think you need to worry about. Keep a catalog or journal of them. See how many really happen in the way you've worried about or get solved in some other way.

On my grandparents farm when I was a little boy I would sometimes walk out to the barn at night. But I was scared because it was dark. All they had was a lantern to walk with. But it did not light the whole path. My grandparents always said, "Just walk in the light and you will be fine." That is a good lesson for all of us. Just learn to walk in the light of faith you have and God will lead you the rest of the way. So if there are two days of the week we should never worry about, two days we should be free from fear and apprehension, there is just one day left. That is today.

If freed from the burdens of yesterday and the fears of tomorrow, most of us can muster the strength to fight the battles of today. Most folks break down over the other two, not the matters of the moment. It is not the experiences of today that drive most people over the cliff; it is the remorse or bitterness of something which happened yesterday or that dread of tomorrow. The happiest people are those who learn to live one day at a time.

Jesus said, "Seek first the Kingdom of God and His righteousness and all these things - maybe all those things we worry about - will find their place. I think He was saying get your life in order. Put the first things first. Put God's will and plan for your life first. It is amazing how the rest finds a place, a resource for help, a solution you never imagined and a peace which makes life bearable.

As a Pastor who has walked through the gamut of sadness and struggles which can surround people, I have seen over and over again the amazing power of priorities. Learning to live one day at a time focused on God makes the difference. It is learning to live either in the desperation of self-sufficiency or the dependence on God. Certainly God expects us to help ourselves in areas we can. But there is no substitute for the strength faith and hope can give.

Some years ago a dear friend was diagnosed with cancer. It was a difficult diagnosis and not one she wanted to hear. She was given about six months to live. Her words went something like this, "I have been a Christian for years, but my faith had not really gotten hold of me until just these days, these months. When I found I only had six months to live, suddenly, every day became important. I began to live as though it were the last day of my life. I have lived it at its best and it's fullest. As a result I want everyone to know that while I am dying, these have been the happiest days of my life."

Let me paraphrase what I think the Psalmist said, "This is the day the Lord has made, let me live in it, rejoice in it, serve Him in it, and make your life count for Him in it if you want to find happiness."

Live today. Step into the light. Don't forget, "one tick at a time." Stop worrying. Start living!

LORD OF OUR TONGUES

I've met a few of the Jimmy Carter family over the years through the Carter Political Items Collectors group. Two years ago we had Sybil Carter as banquet speaker who was wife of the late first-brother Billy. She spoke about her work with drug and alcohol dependents since her husband's death in 1988.

I never met the Carter matriarch, "Miss Lillian," however. She was an amazing lady who spent two years working as a nurse in India in the Peace Corps, as well as serving as a dorm mother at Auburn University. She became famous for dispensing wisdom at the Plains train depot in 1976.

One of the great stories from those days is an interview Miss Lillian had with Barbara Walters. Gov. Carter made the promise during his presidential campaign that he'd never lie to the American people.

"Has your son never told a lie?" Walters asked.

"Well, he's probably told a few little white lies," Carter replied.

"What's a little white lie?" Walters asked.

"Well, Barbara," Miss Lillian continued, "you remember when you came here a few minutes ago and I told you how pretty you looked and how glad I was to see you? That was one!"

The apostle Paul offered a serious word to Christians: "let no corrupt communication proceed out of your mouth, but what is good for . . . edification, that it may impart grace to the hearers" (Ephesians 4:29). That is, Christians must speak the truth and be committed to words that build up and don't tear down.

One example of destructive speech is profanity.

According to a recent story in "USA Today," the "run on cussing" in movies and television is due to our becoming "increasingly desensitized" to this kind of language. A generation ago parents taught children that profanity demonstrated ignorance and a lack of proper education. Today, however, we hear disrespectful words on every hand. The "O, my God" phrase so casually tossed around today would've been unthinkable years ago as a sign of disrespect toward God.

Jesus said "Let your yes be yes and your no be no. Anything more is sin" (Matthew 5:37).

Another example is the thoughtless words we speak to those we love.

Psychologists speak of "displaced anger." This means we get upset at work where anger is under "social control," so we keep it in check until coming home. Then we speak words to family we later regret.

The poet, Lord Byron, born with a clubfoot, said his father pushed him aside one day and shouted, "Get out of my way, you lame brat." Byron said he grew up feeling worthless.

Every believer should pray that Christ be lord of our tongues.

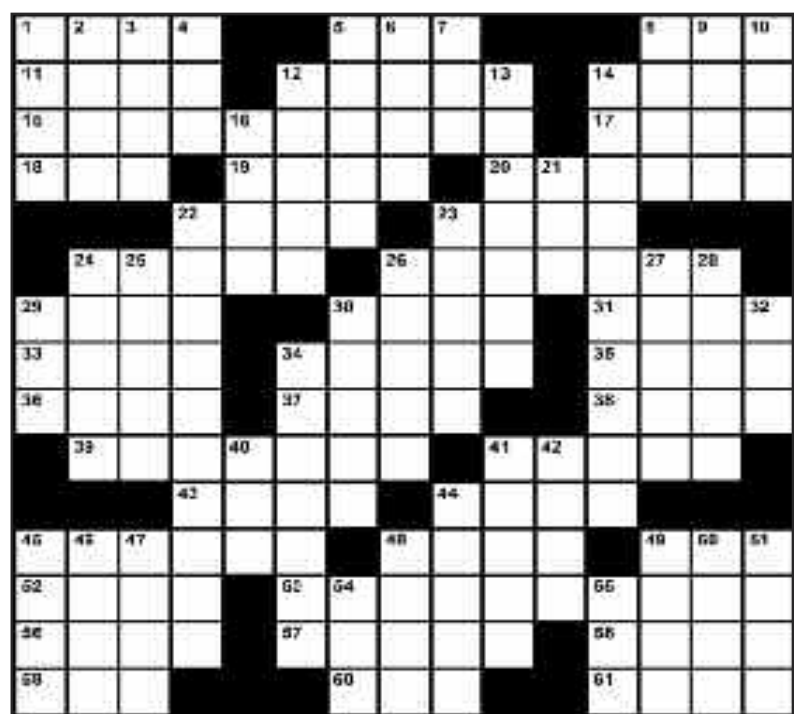
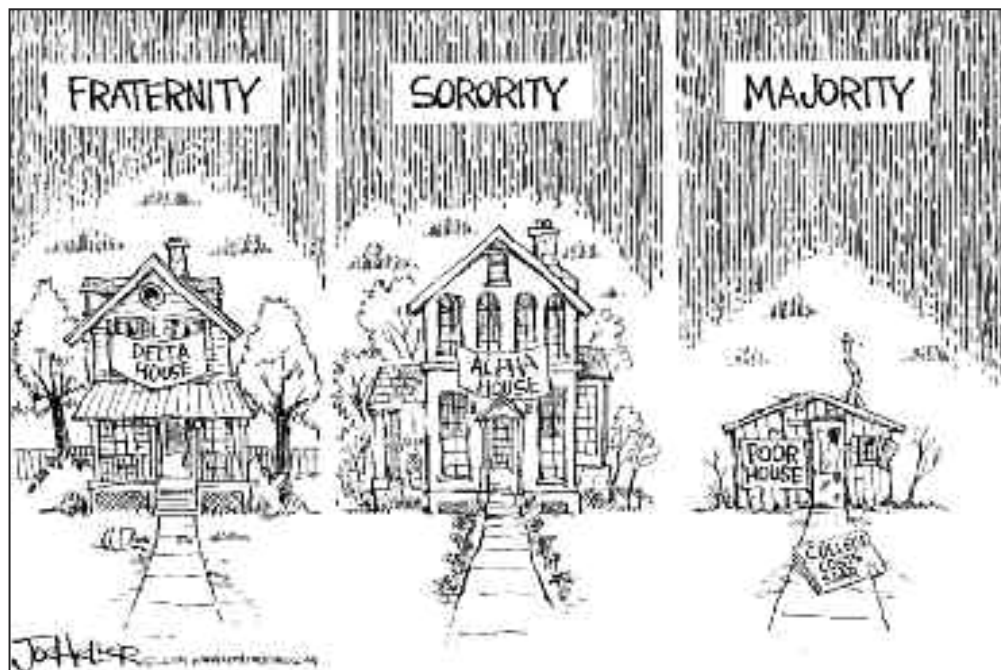


