# A Face to the War on Ukraine A Father Flees with his Family PRAY FOR PEACE Gustavo and his son. Source: Facebook

On February 27, 2022, a citizen of Ukraine posted that he was safely at home in Odesa with his family, about 15 kilometers outside of the city, which is a seaport and the third most populated city in Ukraine.

### This was three days after Russia invaded Ukraine.

That beautiful Sunday morning, he was fairly relaxed in his Facebook video, stating he felt that Odesa was still reasonably safe. Although a curfew was in place from 8 p.m until 6 a.m, the men in his apartment building and those in the area had formed the equivalent of neighborhood watches. This was simply a precaution to make rounds and watch for any people loitering or any other suspicious activity.

Most of the essential businesses were open – something that was a temporary norm during the height of Covid – including government offices. Despite what might have been relayed in the media, pricing had not significantly changed and the supply change had not been interrupted. The banks did shut down, but only for a day. When they reopened, limits were placed on the amounts people could spend each week as many people were withdrawing monies and preparing to flee.

### Three days later, everything changed

During this time, many of those attempting to cross the borders of Poland and Romania became stuck there. Others abandoned their vehicles in order to walk across the border. The roads were becoming congested and dangerous as civilians, understandably on edge, began reacting to the situation and preparing to protect themselves and their families from the Russian forces.

These proclamations celebrate the contributions women have made to the United States and recognize the specific achievements women have made over the course of American history in a variety of fields.

# UKRAINE: Historical Background and Current Bloodshed

As of presstime, March 3, 2022, it has been reported that Russian troops have taken control of an area around the Zaporizhzhia plant in the southeartern Ukraine, the second biggest in Europe, containing six of the country's 15 nuclear reactors.

Recent history of Ukraine can be traced to the mid-1650s when Poland and Lithuania entered into a shaky peace agreement with the Cossacks, Christians from Eastern Europe, seeking a democratic, self-governing community in the-then sparsely populated part of Eastern Europe.

In the Treaty of Perpetual Peace, 1686, Poland divested ownership of what is now

Ukraine to the Russians, but not without almost perpetual disputes. The formal treaty was not ratified until 1710. After further partitions, between 1772-1795, Russia and Austria controlled and claimed all of the territories of what is now Ukraine for over 100 years.

After the Russian Revolution of 1917, Ukraine had a short-lived moment of revolutionary independence but the Russians again took control in 1919. At first, the Ukraine population retained its language and culture. However, by the mid-1930s the now named United Socialist Soviet Republic (USSR) had completed its Russification. When the famine (Holodomor) hit this region historians estimate 8-10 million people starved to death across the USSR, with 4-6 million being from Ukraine. The eventual leader of the USSR, Nikita Khrushchev came from Ukraine.

During WWI, Ukraine fought for and won its independence, though subsequently most of the repressive policies of the USSR were still present. The Ukraine became a charter member of the United Nations in 1945 which meant among other things that if one nation in the UN was attacked, all the members would come to its aid, including NATO's military force.

The 1990s and 2000s proved harsh economic times for the Ukraine. After declining to participate in the European Union, mass protest broke out and a Revolution of Dignity was declared. The president was impeached, which lead to the first Russian-Ukrainian War in 2014. It concluded with an uneasy peace and Ukraine ceding Crimea to the Russians. Then President Obama and VP Biden watched Putin take the Crimea and used the same ineffective sanction approach toward Russia with the same results

Now they are at war again. But look back to 1991 when Ukraine held the third largest stockpile of nuclear weapons. President George H.W. Bush negotiated with other nuclear powers to dismantle these weapons for the cause of peace. Ukraine was given assurance from the West (1994), that should any harm come to them the West would come to their aid. (See: Strategic Arms Reduction Treaty, aka START and The Budapest Memorandum).

Per the agreements, Ukraine transferred its last nuclear warhead to Russia in 1996 and dismantled its last strategic nuclear delivery vehicle in 2001. While not defenseless, its ability to defend itself from surrounding powers was substantially and irrevocably degraded.

Over the last dozen or so years, President Vladimir Putin has flaunted the signatories of the above agreements, first with Crimea and now with the Ukraine. In the pre-dawn hours of February 27, 2022, Putin sent a chilling message that eviscerated all diplomatic attempts to stop Putin. Embargo, negations, and threats were of no use. He declared the Russians were under a constant threat from the modern Ukraine (slavic word for borderland, referencing Poland circa 1150 A.D.).

With the whole world looking on. Putin amassed 150,000 plus troops at strategic border points during this run up without any meaningful response from NATO nations, except from Germany, which tacitly and tersely sent 5,000 helmets to the Ukrainians on the same day as Putin's announcement to attack.

The Terrors of Justice

Eighty years ago this month, with the stroke of a pen, President Franklin Roosevelt in Executive Order 9066 effectively relegated 120,000 Japanese Americans to internment camps. Many of these American citizens were afforded no rights to object to their removal, and

there was no procedure to prove loyalty to the United States. These citizens were interned solely because of their ancestry, nothing else.

In the aftermath of Pearl Harbor, there was widespread fear that the Empire of Japan might invade the West Coast. No doubt people were scared and on high alert, and, certainly, there was anxiety that turned rational people into frenzied xenophobes. But rather than deal with the reality of the situation, political leaders galvanized the country into transferring all these concerns into a government campaign to round up almost the entire population of Japanese Americans and relocate them.

Granted, they were not sent to concentration camps organized along the German or Soviet models. There was no plan to cleanse America of Japanese influence by premeditated death through forced labor. Nevertheless, these citizens were forced to leave their homes, abandon their businesses, and take their entire families to detention centers surrounded by barbed wire, guards and dogs.

And all of this was accomplished through legal and judicial means. Congress had passed an act giving the President broad and sweeping emergency powers to organize the country for total war. These wartime powers had precedent as Abraham Lincoln also used similar powers to suspend the writ of habeas corpus and incarcerate pro-secessionists. Ironically enough, Chief Justice Roger Taney, who authored the Dred Scott decision, warned Lincoln that such actions potentially violated his oath of office and could mean that citizens were no longer living under a government respecting the rule of law.

War, like other national emergencies, set in motion a series of restrictions subjugating the rights of individuals to the needs of the state. Fighting a war and making the decisions necessary to win cannot be done by consensus, but must be determined by leaders who have both national support and critical judgment to implement a plan for victory. Roosevelt's almost dictatorial power was derived from legislative mandate, not usurpation. The hindsight of history clearly shows that he, like Churchill, was the man for the times.

But the internment of loyal American was perhaps an excessive use of presidential authority and a blot on American values. The need to systematically detain these citizens was no doubt a knee-jerk reaction to Pearl Harbor. But leadership is more than succumbing to situational whims and should be based on evidence or some proof that a threat existed. In fact, the exact opposite was true.

Military intelligence and the FBI found no disloyalty among the Japanese Americans. They uncovered no organized network of spies or saboteurs ready to support an invasion. The only reason for the detention was a suspicion based upon fear and a complete misunderstanding of Japanese American culture.

With no basis in fact, an assumption was made that anyone of Japanese ancestry would remain loyal to the Emperor. Like all foundations of racism, there is an assumption that people of similar backgrounds and appearance must share other, monolithic traits attributed to them by imaginary, irrational views. Political and military leaders simply agreed that these citizens would be disloyal, were probably spies, and posed a threat even though no evidence existed to support these assumptions. Thus, the President who told his country that "all we had to fear is fear itself" incorporated a racist fear into his policies that detained 120,000 Americans.

Despite the fact that this incident was humiliating and demeaning, almost 35,000 Japanese American men and women demonstrated their loyalty as United States citizens by serving in the military during World War II. In some cases, sons and daughters fighting for Roosevelt's four freedoms had relatives detained by the same Uncle Sam. Units comprising these Japanese American troops were sent to the European Theater and distinguished themselves in battle. If there can be any humor to both the internment and the war, there was a story that Germans fighting in Italy were captured by one of these units and thought that the Japanese had changed sides and joined with the Americans to defeat the Third Reich.

Perhaps one of the most interesting aspects of deporting people based on race was the number of prominent liberals who blindly went along with the procedure. It is easy to see that military commanders on the West Coast truly believing that an invasion was imminent would want to evacuate civilians from a potential war zone. But it is difficult to understand how leaders normally inclined to support the rights of minorities, expand civil liberties and limit the powers of government would so easily embrace wholesale deportation without a hint of due process.

California Attorney General Earl Warren supported and encouraged this action. In the Korematsu case, Alabama's own Justice Hugo Black wrote that "the military urgency of the situation demanded that all citizens of Japanese ancestry be segregated from the West Coast." Justice Felix Frankfurter provided cover to the administration by writing that the possibility of espionage and sabotage, not race, supported the government's actions. Justice Robert Jackson disagreed, and in a vehement dissent argued that the government's actions legalized racism in a manner no different than the "abhorrent and despicable treatment of minority groups by the dictatorial tyrannies which this nation is now pledged to destroy."

Executive power is potent and requires conscientious leadership to assess and organize the needs of a nation to prepare a unified response to an existential threat. But even good leaders can succumb to fear and misunderstanding and attribute suspicions without substantial foundations.

In America, executive power is not absolute, and our rule of law requires that even emergency actions be reviewed and, if necessary, checked so that a looming or perceived threat is not used as a cover to suspend or deny rights based on political misperceptions.

Now therefore, I, Abraham Lincoln . . . as a fit and necessary war measure designate as the States and parts of States wherein the people thereof respectively, are this day in rebellion against the United States, the following to wit: Arkansas,

Texas, Louisiana (except the parishes of St. Bernard, Plaquemines, Jefferson, St. John, St. Charles, St. James Ascension, Assumption, Terrebonne, Lafourche, St. Mary, St. Martin, and Orleans, including the City of New Orleans), Mississippi, Alabama, Florida, Georgia, South Carolina, North Carolina, and Virginia (except the forty-eight counties designated as West Virginia, and also the counties of Berkley, Accomac, Northampton, Elizabeth City, York, Princess Anne, and Norfolk, including the cities of Norfolk and Portsmouth), and which excepted parts, are for the present, left precisely as if this proclamation were not issued.

On June 20, 1863, six months after the Emancipation Proclamation took effect, West Virginia was admitted to the Union as a slave holding state.

Slavery in the Union did not end until ratification of the 13th Amendment on December 6, 1865.

Teaching of Critical Race Theory has no Place in Alabama Education

For many decades, our elected officials have relentlessly usurped our cherished constitution and fundamental civil rights more times than we could ever hope to count. Many of these violations are imposing severe restrictions on our right to travel and to buy, sell, own, and drive affordable vehicles to exercise that right.

Beginning in the late 1960's, "Uncle Sam" began to impose mandates on auto manufacturers to "reduce emis-

sions" and impose more "safety." Every year, these mandates became more and more extreme, jacking up car prices and maintenance from double to over four times what people could be paying if we had a free market—where the manufacturers and the customers, not the government, made the decisions on what to buy and drive.

Today's new cars cost from a low of about \$20,000 up to and well beyond \$40,000—a huge jump from 50 years ago (1972), when one could buy a new car for as little as \$2000. If we had a market as free as it was back then, a new car could start at under \$5000 and average less than about \$10,000. With today's technology, it could very likely be less.

Reducing emissions has lately been one big headache. Initially, cutting them by about <sup>3</sup>/<sub>4</sub> has not been particularly difficult. But when pushing the limit much more, the law of diminishing returns rapidly kicks in, and getting the last smidgen pushes costs and prices many times beyond anything practical. But the insane government regulators are never satisfied.

We also have outrageous safety mandates—going crazier every year. It started with little things like seat belts, but at least they are inexpensive and actually save lives. Later came more expensive air bags, beginning with just one for the front passenger seat. Now some cars have six, if not more. Why can't we buy a new car without air bags? I fasten my seat belt. I don't need them.

With each year, cars and trucks are becoming flimsier and flimsier. In the 1970's, nearly all new cars were equipped with hydraulic bumpers that could withstand a 5 mph impact against a solid abutment with NO damage. In fact, it was a government mandate to help mitigate insurance claims for repeated bumps in parking lots (one of the VERY RARE mandates I could actually support). But beginning in the 1980's, that practical feature was replaced by an opposite mandate that a car's entire front end had to be crushable, and thus destroyed. One very light tap meant \$1000 or more in damage. A 5 mph bump would likely total the car. Why aren't the insurance companies, and the people, complaining about that?

To make cars more fuel efficient, manufacturers struggled to minimize weight. Therefore, they made everything as thin as possible and replaced much of the steel with plastic. Not only are they fragile, they are also highly flammable.

The best way to reduce weight is to eliminate the items we are better off without. Make air bags strictly optional. Increase fuel efficiency by eliminating mandates that retard it. And REPEAL that outrageous law that whacked Volkswagen for its tiny bit of emission "cheating" to enhance fuel economy.

"Big Brother" has also imposed limits on practical vehicles imported from other nations. There are numerous cars and trucks in other parts of the world that Americans would love to buy and drive, except for one caveat—our government won't allow them. They either emit a bit too much NOx or more likely lack some of the mandated safety devices that many of us would much rather do without.

What could we get if we had a free market? You could legally drive a Mahindra Roxor—a clone of a Jeep CJ/Wrangler 4×4 that COSTS HALF AS MUCH as a new Wrangler over here. But our government, for whatever crazy reasons, claims it is not safe enough. (image below)

It's not actually "unsafe." It's just not flimsy enough to pass the latest governmentmandated crash tests. And it doesn't have a back up camera and mandated other 'equipment."

Have a look at the Zhengtu, a truck made by Wuling, a Chinese

subsidiary of General Motors. It costs only \$9000. It also has some cool features like hinged, outward folding-flat bed walls that allow you to transport bulky items. But "Uncle Sam" will not allow it in this country, even though it's made by an American company. (image above)

The \$25,200 Chevy Colorado is the least expensive new truck GM sells in the United States. And its bed is not as wide.

The Zhengtu features a reliable manual transmission and averages 33 miles per gallon. A four cylinder Chevy Colorado struggles to reach 25 MPG on the highway with its mandated automatic transmission and its expensive electronics, should they fail, could cost more than the entire truck is worth.

What about electric cars? Surely our government would not object to any of these. After all, our rulers have been hyping them up since the beginning of this century.

Nope! Not all of them. Not the ones that low and middle income people can afford to buy. Most people are unable to shell out \$50,000 for a Tesla, \$27,400 for a Leaf or even \$17,990 for a Volt. But in China, people can buy a variety of electric cars for well under \$10,000.

They can even buy them for less than half of that—the \$4,500 Wuling Hongguang Mini. It is the best-selling EV, in China. Practically anybody in the USA could afford one, even some high school students. It's small and light—just under 1,500 pounds (slightly less than a 1960's Volkswagen Beetle). It has a 17.4 horsepower electric motor powered by a 9.2-13.8 kilowatt-hour battery pack that weighs only 250 pounds, a fourth of a Tesla's half ton behemoth. It can go 106 miles at 62 mph on a charge, adequate speed and range for many Americans. And being much lighter, it gets far greater kilowatt efficiency than an overpriced Tesla.

Yes, it's made by the same GM subsidiary that makes the Zhengtu pickup truck—Wuling. BUT, also like the Zhengtu, you can't buy or drive it in this country. (image below)



You would think our government "masters" would welcome people buying cars like these. After all, they are dead set on eliminating internal combustion engines. So why are they usurping their own proposed mandate by prohibiting the American people from buying the very practical, ffordable EVs that will meet that objective? These cars create NO emissions. In fact, because they are

lighter and more kilowatt-hour efficient, they emit LESS emissions at the power plants that charge them up than their overweight brethren in this country.

We MUST put an end to this government insanity. Think about that when you vote this year.

# Discrimination via Poor Representation

Once upon a time, I've been told, students were taught 'taxation without representation' as a trigger in our first war for independence. Sadly, it wasn't something stressed in my government school approved education. Thankfully enough true teachers remained to direct me toward some of the more important clauses of our

**Declaration** and **Constitution**. Some classmates may also cite old textbooks stored in the back of a high-school classroom where I'd try to hide (bored in

trig class, desperate for reading) likely played a bigger role in my education. Much ink has been spilled these past weeks about Alabama's redistricting maps which are indeed an abomination to the most elementary math class and any Constitutionally correct basic civics class -i.e., NOT politically correct as taught today. Long time column readers have suffered my lone voice in the wilderness many times these past dozen plus years w.r.t. our Constitutional [Art. 1, Sec. 2] design for the HoR. Disheartening to observe how far we've 'progressed' since the 435 limit was imposed (1929) by DC oligarchs from the one representative for every 30,000 (round-up) rule well argued in the Constitutional convention. As population increased this past century, we now have one representative for about 800,000. debate. Presidential and congressional elections all the way down to my corrupt Lee County commission Districts and Auburn City Council exhibit this growing discrimination via poor representation results from flawed redistricting. The Lee County arithmetic is as follows. Our last increase in District seats to the current

five member result was set circa 1970 at 61,268 population – *i.e.*, approximately one commissioner for every 12,000. County population had tripled from 1870 to 1970. Population has now almost tripled **again** this past half-century since 1970. With "current population at 166,314

century since 1970. With "current population at 166,314 and **no** change in number of districts, real representation has decayed to one commissioner for every 33,000 with **much** more to address than those few things States authorized to the federal government enumerated in Art. 1, Sec. 8. Sadly, the incompetent Lee County judge doing the redistricting droned on about how wonderful he was getting each District within a few person difference, instead of doing the hard work of keeping areas intact as directed with +/- 5% tolerance allowed. Perhaps when this incompetent is aged out, a more thinking

judge will replace the political hacking we've observed these past decades.

The number of Lee County Commission Districts shall not exceed one for every Twenty-five Thousand to be adjusted every decade after each federal census determination of Lee County population.

The threshold is worthy of serious contemplation, one for 30,000 would retain the five district result until 180,000 county population. One for 25,000 threshold currently requires one more district – *i.e.*, total of six. Even numbers make tied votes more likely (maybe not with our current lock-step commissioners) but the existing rule is the chair [Probate Judge] casts the deciding vote as the US Vice President does over the 100 member US Senate. To think we will ever see one for 12,000 representation again (would be about 13 commissioners) is 'swinging for the fences' in my humble opinion since most are uneducated on how political power has concentrated in DC, Montgomery and Opelika.

#### Article 1, Section 2 of the United States Constitution:

The house of Representatives shall be composed of Members chosen every second Year by the Beople of the several States, and the €lectors in each State shall have the Qualifications requisite for €lectors of the most numerous Branch of the State Legislature.

No Person shall be a Representative who shall not have attained to the Age of twenty five Years, and been seven Years a Citizen of the United States, and who shall not, when elected, be an Inhabitant of that State in which he shall be chosen.

Representatives and derect Taxes shall be apportioned among the several states which may be included within this Union, according to their respective Mumbers, which shall be Setermined by adding to the whole Mumber of free Persons, including those bound to Bervice for a Term of Years, and excluding indians not taxed, three fifths of all other Persons. The actual Enumeration shall be made within every subsequent Term of ten Years, in such Manner as they shall by Law direct. The Mumber of Representatives shall not exceed one for every thirty Thousand, but each State shall have at Least one Representative; and until such enumeration shall be made, the State of New Bamushire shall be entitled to chuse three, Massachusetts eight, Rhode-Island and Drowdence Plantations one, Connecticut five, New York six, New Jersey four, Pennsylvania eight, Delaware one, Maryland six, Dirginia ten, Morth Carolina five, South Carolina five, and Coorda three.

When vacancies happen in the Representation from any State, the Executive Authority thereof shall issue Writs of Election to fill such Vacancies.

The Bouse of Representatives shall chuse their Speaker and other Officers; and shall have the sole Power of Impeachment.

Auburn City discrimination via poor representation outcome is just another iteration of the same abomination. 43% population growth with no increase in number of seats for voters to elect. Lee County *NAACP* Branch 5038 did a splendid job. The *LDF*'s attorney using a 'barbell' illustration from a past case of two populations connected by a hyper-gerrymandered sliver of a highway to connect them was perfect! Of course this was being done because the letter and Spirit of representation is dead... these two population centers would be two distinct voting districts with different candidates to elect in each race. At 59,999 still one Rep. At 60,000; two Representatives. State population at 89,999; still two Reps. At 90,000; three Reps. Y'all get the idea... because we do not follow Art. 1, Sec. 2 of the US Constitution we have US House members representing over 800,000! This also distorts the Electoral College (Art. 2, Sec. 1) driving the Bush ν. Gore result, etc. The reason so many 3 electoral vote States are observed is because the number of Senators is more than their one House member which has not been allowed to increase as per the Constitution – i.e., a House which is NOT very representative.

### My husband is beginning to show signs of dementia, maybe even Alzheimer's. What type things should I do to prepare us should he become incapacitated?

I think that you are doing the hardest thing and the best thing for your husband and yourself by facing this right now. When our loved ones are faced with such devastating diseases it's easier to not face it and believe they will improve. Being proactive will have you prepared.

First I will advise that you visit an attorney that can assist you with estate planning. The three basic documents that your husband will need (and you) are a Last Will and Testament, Durable Power of Attorney (health and Financial) and an Advance Directive. Even if he has these documents, if they were prepared more than 3-5 years ago or there have been other significant changes in your lives (family, health or financial), then I would advise that you both

If your husband is in early stages as you state and still has times of clarity, then he should be able to state his wishes for a Will, The capacity requirement for a Will is lower than that required to have a Power of Attorney and Advance Directive prepared. As I have said so often, if you don't have a Will, the State of Alabama has one for you via the rules of intestacy. As an example, the share for the spouse is stated in the following manner:

### § 43-8-41. Share of the spouse

The intestate share of the surviving spouse is as follows:

- (1) If there is no surviving issue or parent of the decedent, the entire
- (2) If there is no surviving issue but the decedent is survived by a parent or parents, the first \$100,000.00 in value, plus one-half of the balance of the intestate estate;
- (3) If there are surviving issue all of whom are issue of the surviving spouse also, the first \$50,000.00 in value, plus one-half of the balance of the intestate estate;
- (4) If there are surviving issue one or more of whom are not issue of the surviving spouse, one-half of the intestate estate

Without a Will you can see that you might end up with significantly less than what you thought. Additionally, the Administrator (Personal Representative) must be bonded and an inventory is required of the assets of the decedent. A Will usually states there will be no requirement of a bond or inventory.

The next document is a **Durable Power of Attorney** (DPOA). While there are different types there are two popular types of a financial DPOA. The Durable Power of Attorney is probably the most popular and must contain a statement that the POA is effective even in your incapacity to make it durable. The other is a "springing" POA in which a certain event must occur to have it "spring" into action. Such an event is usually your incapacity, which would have to be established by a physician. It can make the effectiveness a bit subjective. One of my attorney friends has compared the two documents by asking, "If you are going to trust someone under your POA when you are incapacitated, why not trust them now?" Alabama has adopted a Uniform Power of Attorney Act, which became effective 1 January 2012. There is a statutory form, but most attorneys seem to prefer to work the statutory form into their own tried and true document. The new form does NOT invalidate prior POA's that meet the legal definition of an effective Alabama POA.

While I have been told that the proxy selection discussed below in the Advance Directive for Health Care can be used in general health settings, I prefer to prepare a health care power of attorney which better delineates the available powers and desires of the principal.

The capacity requirement to name someone to act under your POA is roughly the required capacity to enter into a contract. As an example could your husband enter into a contract to buy an automobile?

The final document is the **Advance Directive**. It consists of the *Living Will* and Health Care Proxy. It allows you to make decisions about life support measures and artificially provided food and hydration should you be in such a condition that you will die in the near future and are unable to communicate your wishes about your health care.

Additionally, you will want to consider future care. Are you and your family willing and able to provide care for your husband at home? Alzheimer's patients can become violent at times and family members have been hurt badly by loved ones because they allowed the affected family member to get between them and an escape route (out of a room). Will you want to hire sitters? What about Assisted Living? Assisted living can only keep Alzheimer's patients for a certain portion of their illness. After that it is necessary to go to a SCALF (Specialty Care Assisted Living Facility) or to a skilled long term care facility (nursing home). If your husband is a veteran he may be eligible for VA care if necessary. You also have to consider how to pay for the more advanced care. If very wealthy you can pay for it or if poor you can have Medicaid cover it in the case of being impoverished. For those in between there may very limited Medicare coverage, selling assets to cover the cost, a viatical settlement of an insurance policy, a reverse mortgage (I am not fond of these in most cases as they require payoff within six months after the last person dies or leaves the home permanently) for in home care or the very best is a long term care insurance policy. If your husband is having symptoms of dementia, has other major health issues or is elderly he may well not be eligible to purchase such insurance. I think long term care insurance is the best hedge against the potential for long term care, but it is always a gamble as with many insurances as you may never need it, just as you may never need homeowner's or car insurance.

Also consider what you might do if you have to take the car keys away from your husband. This will probably need a family pow wow and a visit to the doctor. The doctor can make an assessment with a promise of a future assessment if your husband needs to give up driving. This may give your husband something to look forward to and a reason to be more compliant if he believes he may get his driving privileges back.

Taking these steps will hopefully by pass most reasons to seek a conservatorship or guardianship through the Court in the future.

I hope that you will talk to your attorney or an elder law attorney about these things in the near future. The Alabama State Bar also has a referral service if needed.

It is said to begin with the January 6, 2020, event that some call a riot and some call an "insurrection"—a so-called insurrection with no weapons, individuals walking around taking pictures and chatting with Capitol personnel, and a few mysterious instigators with seemingly nefarious intentions, e.g., Utah's John Sullivan (connected to CNN) and Ray Epps. In similar fashion,

competing views of the War Between the States exist but we typically only hear the "Yankee" version.

Anyone who has studied primary source documents should understand the propaganda that has been (and still is) used against the South for over 150 years. Much of the agitprop coincided with the creation of the mythical Abraham Lincoln. Lincoln's bodyguard, Ward Hill Lamon, witnessed it at the outset: "The ceremony of Mr. Lincoln's apotheosis was planned and executed by men who were unfriendly to him while he lived..." One of those planners, Union Secretary of War Edwin Stanton, often called Lincoln "the original gorilla." After Lincoln's death, Stanton gloriously proclaimed, "Now he belongs to the ages." Naturally Stanton, Thaddeus Stevens, Charles Sumner and other Radical Republicans were going to offer glowing praise—Lincoln spearheaded the treasonous invasion of sovereign States and denied their right of selfgovernment—these men were part of it.

The Lincoln's Dilemma promo references a metamorphosis of Lincoln transitioning from being mildly anti-slavery to being a staunch advocate for its abolition. This phenomenon is supposedly from a man who supported the Original 13th Amendment (the Corwin Amendment), which would have perpetually removed the institution from federal interference. Doris Kearns Goodwin believes Lincoln wrote the Corwin Amendment. He also initially sanctioned the Fugitive Slave Act, including the most draconian element concerning runaways

We have been led to believe the Republican Party was adamantly against slavery and/or its spread. While many members were anti-slavery, they consistently leave out a key piece of their reasoning, i.e., their goal was to keep Blacks confined to the Southern and Border States. Lincoln wholeheartedly agreed with this position. Union Secretary of State William Seward explained—the Republican Party's opposition to "the extension of slavery had always really been concern for the welfare of the white man, and not an unnatural sympathy for the Negro." New York Tribune Editor Horace Greeley concurred, stating the "unoccupied territory...shall be preserved for the benefit of the White Caucasian race—a thing which cannot be except by the exclusion of slavery." Greeley and

Lincoln corresponded affirmatively on this topic. On September 18, 1858, Lincoln proclaimed: "I will say, then, that I am

not, nor ever have been, in favor of bringing about in any way the social and

political equality of the white and black races..." On August 14, 1862, Lincoln said, "Your race suffers very greatly, many of them, by living among us, while ours suffers from your presence...But even when you cease to be slaves, you are yet far removed from being placed on an equality with the white race." Relative to his treatment of the slave controversy, in an August 22, 1862, letter to Greeley, Lincoln stated: "What I do about slavery, and the colored race, I do because I believe it helps to save the Union..." The Emancipation Proclamation supposedly freed slaves out of Lincoln's reach and kept enslaved those within his reach. England's Lord Palmerston scoffed at this hypocritical stratagem; Lincoln called the proclamation what it was: a "war measure." New England historian Edward Channing said: "Of course, it did not abolish slavery as an institution anywhere." Another angle identified by fellow Alabama Gazette columnist John Sophocleus is Lincoln's timing of the proclamation (January 1, 1863) based on the anticipation of a broken blockade (January 31, 1863). The "war against slavery ruse" thus created an impediment of perception to deter British and French intervention.

Most Southerners were not anxious to go to war. Confederate General Richard Taylor (son of President Zachary Taylor) was alarmed at Southerners who naively thought the North would allow the South to govern itself. Having been educated at Harvard and Yale, Taylor knew the mercenary nature of the power brokers in the North. Three meetings between Lincoln and Southern representatives (who tried to talk Lincoln out war) in April 1861 failed to produce a peaceful resolution as Lincoln told them all the low duty tariffs through Southern ports would put the North out of business and "he might as well shut up housekeeping at once."

In Colonization after Emancipation, Phillip Magness and Sebastian Page uncovered documentation in British Archives that Lincoln was still attempting to deport Blacks from these United States virtually up to the day he died. I have a gut feeling that this (and everything else in this piece) will not be mentioned in Lincoln's Dilemma.

### Did Slavery Make America Rich?

The New York Times' 1619 Project examines the impact of slavery on America. One essay contends that our economic system was built on slavery. Was America's ascension as an economic powerhouse due to

Slavery was a repugnant and evil institution. Its abolition is a sign of humanity's moral progress. Slavery

taints America's founding and was incompatible with "all men are created equal." Yet Emancipation took ninety years and a terrible civil war, plus another 100 years to extend the promise of freedom to all Americans.

Journalist Nikole Hannah-Jones curated the series of essays. Princeton University's Matthew Desmond authored the essay linking American capitalism to slavery, drawing heavily on the scholarly research of the "New History of Capitalism" (NHC). I will focus on Desmond's claim that, "Slavery was undeniably a font of incredible wealth."

Economic historians have extensively studied slavery, including Nobel Prize winner Robert Fogel. Economic theory and econometrics have illuminated the institution's operation. Economic historian Phillip Magness draws on this plus his own research in his *The 1619 Project: A Critique*, which I rely on here.

A plausible connection exists between slavery and prosperity during the first half of the 1800s. Textiles produced using cotton largely from the southern U.S. were an enormous part of the Industrial Revolution.

Before examining economic details, let's consider the big picture. Slavery existed throughout human history. If slavery really could produce "incredible wealth," presumably humanity would have prospered before 1776 or 1619.

How important was cotton to the American economy? NHC Historian Edward Baptist claims that cotton accounted for nearly half of U.S. economic activity in the 1830s, a statistic cited supporting reparations for slavery. As Dr. Magness describes, Baptist erred; he "proceeded to double and triple count intermediate transactions involved in cotton production," namely things like tools, land, and transportation. Yet GDP includes only final goods and services to avoid double counting. As Magness continues, "Baptist's numbers are not only wrong – they represent a basic unfamiliarity with the meaning and definition of GDP."



Professor Desmond, again following NHC historians, attributes the 400 percent increase in cotton productivity between 1800 and 1860 to American slavery's brutal efficiency. But economists Alan Olmstead and Paul Rhode, who established the productivity increase, attributed it to improvements in cotton seeds.

Another Desmond claim was the necessity of slavery to produce cotton in sufficient quantities. This turns on a technical question, returns to scale in cotton production. If economies of scale existed, only large plantations using slaves might have been able to capture these economies. Yet economic historians found no important returns to scale; Stanford's Gavin Wright concludes that cotton, "could be cultivated efficiently at any scale."

Furthermore, if slavery was necessary to produce cotton, supply should have collapsed following Emancipation. Yet the price of cotton returned to pre-war levels by the end of the 1870s.

Economists have documented an enormous increase in standards of living beginning around 1800. A plot of world per capita GDP over time shows a true hockey stick shaped takeoff then. Economic historian Deirdre McCloskey calls this the Great Enrichment. Humanity prospered as slavery was abolished.

People long believed that commanding and enslaving others was the key prosperity. This was incorrect. Professor McCloskey argues that thousands and thousands of improvements, discovered through the imagination and intelligence of ordinary people, produced the Great Enrichment. Prosperity results when freedom unleashes everyone's full potential.

A society organized on commands and whips requires obedience, which in turn requires keeping the underlings from fully recognizing their humanity. Once Harriet Tubman recognized her value as a human being, she was never going to be anyone's slave. Slaves repeat the tasks they are commanded to perform as opposed to discovering how to perform these tasks more efficiently.

The political philosophy of liberalism, founded on the moral equality of all people, gave birth to capitalism. Liberalism implies both that government must serve the citizens and that no human being should be a slave. That capitalism produced modern prosperity and ended slavery is no accident.

The American Public Power Association pays tribute to Black American leaders who, over a half-century ago, established the Utilities Board of Tuskegee

#### Tuskegee, Alabama Public Power Utility Formed

The Tuskegee City Council unanimously adopted a resolution on January 27, 1970 to incorporate a public corporation responsible for utility services. The effort was spearheaded by Booker T. Conley, Edward Reid, and William Allen, who are widely recognized as "the fathers of the Utilities Board of the City of Tuskegee." Their goal was to incorporate a public utility to operate an electric system, a water works system, and a sewage system.



### **Booker T. Conley (1923-2019)**

Booker Conley embodied the best of his family's virtues: he was humble, intelligent, brave, and adventurous. He would be proud of the legacy he left for public power today. Conley greatly admired his older brother, Coleman, and would follow him to Tuskegee University, where he had enrolled in the very first

class of Tuskegee Airmen. That first class of just 13 U.S. Army Air Corps cadets graduated from Tuskegee Army Air Field on March 7, 1942.

Booker Conley studied architecture at Tuskegee University, and later drafted the plans to build the airplane hangars that housed Tuskegee's famous "Red Tail" fighter planes. When his older brother was tragically killed in a combat exercise, Booker took his place and joined the civil pilot training program at Tuskegee in 1940.

Upon graduating from Army ROTC, he went

right) / Photos Courtesy of UBT on to serve with the 92nd "Buffalo Soldiers" infantry division in Italy during World War II, flying P-51 Mustang fighter planes. The Buffalo Soldiers Division was the only Black infantry division that participated in WWII combat, serving in Italy from 1944 to the war's end. Booker Conley flew missions over Italy and Northern Africa. He and Coleman Conley are the first known brothers to be documented amongst the 996 Tuskegee Airmen pilots. Conley returned to Alabama after World War II and lived near Tuskegee University where he helped advance the formation of UBT to improve services in his hometown.

#### **UBT Today**

The Utilities Board of Tuskegee (UBT) continues to thrive today and operates with 72 employees. The 103-square mile service area includes the City of Tuskegee, the towns of Franklin and Shorter, and much of Macon County, Alabama. The utility has approximately 6,714 electric customers – 88% are residential customers. The utility is overseen by a five-member board of directors. All five members are Black men, with Black men and women comprising the predominant majority of UBT's leadership team.

### Gerald B. Long

UBT General Manager

Gerald Long, CPA, CGMA, graduated from the University of Alabama, Birmingham in 1983. He joined the Alabama Public Service Commission in 1988 and was later promoted to director of the telecommunications division. In 2008, Long became the Chief Financial Officer of UBT and, later, its General Manager. UBT was awarded a Mutual Aid Commendation certificate in August 2020 for supporting power restoration efforts in Louisiana after the local utility was hit hard by

Hurricane Laura. "I love working for UBT because we provide indispensable services to the community," Long said. "And, through the provision of those services, we are able to plot a future for our community that will lead to economic growth and prosperity," he said.

### Taxes Are Due AGAIN?!

Tax Deadlines, who can appreciate them? There it is circled on your calendar, April 18, 2022, taxes in the mail or online. Did you know there are more tax documents than ever before? If you qualified for the Child Tax Credit, the IRS has sent you a Letter 6419, however; if you changed banks or moved during this past December, you need to get the most up to date figures on your Child Tax Credit before filing. You can go to your IRS online taxpayer account to get the information.

The Alabama Legislature passed a bill recently that will help the families who used the Child Tax Credit. The law will not count against the federal deduction. The new Alabama law will do what the U.S. Congress intended it to do. The earned income tax credit and dependent care tax credit won't count against the federal deduction. Governor Kay Ivey supports the law and plans to sign the law.

Another issue for many taxpayers is the **Stimulus Payment Letter**, which gives a significant effect to a great deal of Americans. The IRS gave out millions in economic impact payments in 2021 which means you may have received a summary of the payments given to you in Letter 6475. This letter was mailed in late January, you will need to use this letter to accurately report your economic income payments

Many do not realize that the IRS may have assigned you an Identity Protections Pin. Why do you need this? For your protection, an IP PIN is a six-digit number that keeps anyone else from filing a tax return using your Social Security number or Individual Taxpayer ID Number. The IP PIN is known only to you and the IRS. An error could be discovered by you or your tax preparer on your tax form. If

this happens a corrected version must be mailed to both the taxpayer and the IRS. Some of the forms that may have been corrected are: Form W-2 from your employer that shows corrected wages, salary and taxes

- Form 1099-INT or Form 1099-DIV from your investment broker that shows a revision in interest and dividend income
- Form 1099-NEC from a client to whom you provide services
- Form 1098 that shows how much mortgage or student loan interest you paid

If a correct tax form does show up in your mailbox (or inbox), don't throw away the old one. Save it along with the old form for future reference. The ease of filing your tax return is dependent on having the correct information.

### **Tips for the Home-Based Business**

Home-based businesses have become more financially rewarding and can provide some flexibility with day-to-day schedules, but you must take time to keep your records accurate. Keep these tips in mind.

ACCOUNTS RECEIVABLE MUST BE A TOP PRIORITY. 



# Southern Gardening

GARDEN CHORES FOR MARCH

When I think of the month of March, I see kite

flying with colorful tails dancing in the wind, I see bright yellow daffodils bobbing their heads, and tulips bursting into bloom. I see the harbingers of spring. And what a sight to see. There are also so many wonderful scents such as the old fashion French hyacinths which return year after year at the farm planted years ago in gumbo soil. The

daffodils which multiply and come back year after year are: Mount Hood, Ice Follies, and Carlton. If you are in our area and see these for sale, buy as many as you can. You will really get your money's worth over the years.

If you have not made a garden scheme or plan, or you are just plain bored with what you have used over the past few years, then change it up. Sometimes you must rethink the plan because suddenly there is too much shade with the only solution is to cut back or cut down a tree. Even taking steps to prune low lying limbs

may help. And I hate to declare the death penalty for the tree, but a plan that includes more shade loving flowers is a great alternative. You may even have to have shade tolerant plants in the back of the bed and sun loving in the front of the bed. Also, we do have some flowers that thrive in both sun and shade. The color range in both types of plants have vastly grown over the years. In other words, you may duplicate the color scheme you want and still use shade loving plants. Sun exposure is tricky, but a little trial

1. Weeding. A never ending task this time of year, but these annual late winter weeds are so simple to pull out. For instance, dock is wide spreading but has a small root system which means you can accumulate a large pile with very little effort. These are the type of weeds which will be killed off with a lot of warmth, so once they are gone, they are gone for good, or until this time next year.

**2.** *Planting.* Now is the time to fill in some of the areas of the beds that have not been planted with winter annuals or perennials such of lambs ears, dusty miller, dianthus and pansies. Geraniums, begonias, canna lilies, elephant ears, come to mind. I would not plant impatiens until closer to the end of March. These are mostly fillers and will carry the beds through most of the summer.

Potpourri for March

3. Fertilizing. Purchase a good all round fertilizer with 8-8-8 or 10-10-10 and work into the soil. You can also spread Osmocote now that the temps get above 45%, but Osmocote much more expensive and can be used in summer when the commercial grade fertilizers may burn the

Source: begoniafields.blogspot.com foliage. Spraying with a liquid fertilizer is also a good idea. Just buy a hose end spraying, add the correct amount of a water soluble, fertilizer,

then add water to the proper dilution rate, and spray away. 4. Stop to smell the roses and take in all the joyous sights of the flowering trees such as Red Bud, Japanese Magnolia; and shrubs, such as Loropetalum, Forsythia, and quince.

### **Technical Sergeant Christopher Laneaux (89)**

Technical Sergeant (TSgt) Christopher Laneaux served 21 years in the U. S. Air Force with four separate periods of voluntary service. His Air Force Specialty Code (AFSC) was Supply/Logistics. TSgt Laneaux's service included deployments to Germany, Italy, Thailand, Turkey and an assignment in Alaska. SSGT Laneaux distinguished himself by meritorious service as a Noncommissioned Officer in Charge of Material Control Branch while assigned to the 7307th Support Squadron, and 7499th Support Group (USAFE) from January 27, 1967 through September 1968 resulting in his receiving the Air Force Commendation Medal with One Oak Leaf Cluster. He received other decorations, medals, commendations, citations and campaign ribbons: National Defense Service Medal with One Bronze Star, Vietnam Service Medal with Three Bronze Stars, Air Force Longevity Service Award with Three Oak Leaf Clusters, Small Arms Expert Marksmanship Ribbon and Air Force Good Conduct Medal with Two Oak Leaf Clusters.

TSgt Laneaux was born July 24, 1932 in Kiln. MS, to his mother, Wilhelmenia Williams. He was reared in Bay St. Louis, MS, and graduated from Saint Rose de Lima High School in 1953. He volunteered for

military service and enlisted in the U.S. Air Force June 12, 1950. TSgt Laneaux completed Basic Training at Sheppard Air Force Base

(A.F.B.) and completed the Supply System Management Course at Lowry A.F.B., CO. During the Korean War for two years, he was stationed at Eielson Air Force Base, AK, where the Air Defense Command deployed interceptors which were used to monitor Soviet air power during the Cold War. His next assignment was at Suffolk County A.F.B., Long Island, N.Y. where he left military service June 11, 1954. He then reenlisted in the U.S. Air Force at Mitchell Air Force Base, Long Island, N.Y. He was next deployed to Naples, Italy, for four years, and then he served for one year at Sheppard A.F.B., TX with a missile training unit for operation of the Jupiter Missile, the first nuclear armed medium range ballistic missile. He returned to Italy to serve at the Italian Gloia del Colle Air Base where the U.S. Air Force's 36th Strategic Interdiction Air Brigade trained the Italian Air Force in missile operations. He then transferred to Turkey near Izmir where the Turks were trained in operation of the Jupiter Missile. He returned to Sheppard A.F.B, TX, to Hurlbert Field, an Air Force installation in FL, to Eglin A.F.B., FL, and then to Brookley A.F.B., in Mobile, AL, followed by deployment in December 1965 to Ubon Royal Air Force Base in Thailand during the Vietnam War for one year and then deployment to Rhein Main Air Base in Germany in 1967-1969 for three years. TSgt Laneaux's final assignment was at Maxwell A.F.B. where he retired from military service August 23, 1970.

After his military retirement, TSgt Laneaux worked 21 years for the State of Alabama in three departments. First, he worked as a salesman in the AL Beverage Control. Next, the served as a counselor with the AL Department of Youth Services at the Mount Megs Campus. He then worked with the AL Department of Corrections as a supply officer of equipment for each of Alabama's prisons. Using the G.I. Bill while employed by the State of AL, he received a B.S. Degree in Sociology and Psychology and a Master's Degree in Criminal Justice from Troy State University. TSgt Laneaux retired from all employment in 1990.

TSgt Laneaux and his wife, Janice Wesley Laneaux, have been married for 56 years. They met in Mobile when he was stationed at Brookley A.F.B., and they were married in Mobile in November 1965. He has three sons, one daughter, six grandchildren and four great-grandchildren. He is an active member of the City of St. Jude Catholic Church in Montgomery, AL. For four years, he served as a van driver for the Church providing transportation to services for people who otherwise would not have had transportation. He has been a member of the Knights of Peter Claver, the largest African American Catholic organization in the United States whose purpose is to render service to God and His Holy Church, render aid and assistance to the sick and disabled, and promote social and intellectual association among its members. He has held the positions of Deputy Grand Knight and Financial Secretary within this organization. He also drove and delivered Meals on Wheels for elderly with the Montgomery Council on Aging for two years. He enjoys fishing and rooting for the athletic teams of the University of Alabama.

TSgt Laneaux s' reflections on his military service are, "Being in the military in the military service gave me opportunities to see places that I would not have able to see or even to imagine. Each country that I went to gave me knowledge of that particular country's culture and people. I enjoyed it. I enjoyed each station, and I never had any bad experience. I am grateful for those opportunities. It gave me an education, and it gave me pride that I was able to serve my country."

### **Sergeant First Class Patrick Louis Campbell (84)**

Sergeant First Class (SFC) Patrick Louis Campbell served in the United States Army for 21 years. His Military Occupational Specialty (MOS) was Explosion Ordinance Specialist. While serving in Vietnam, he received the following medals, awards and decorations: Soldier's Medal, Bronze Star Medal with V Device and Oak Leaf Cluster, Purple Heart, Army Commendation Medal with V Device, Good Conduct Medal (1st-5th Award), National Defense Service Medal, Vietnam Service Medal, Vietnam Campaign Medal, EOD Specialist Badge, Senior EOD Badge, Vietnam Gallantry Cross Unit Citation with Palm and Meritorious Unit Citation.

SFC Campbell was born August 17, 1937 to his parents, Gordon and Elsie Campbell, in St. Charles, MO. His father worked as a migrant laborer, and the family moved to many states including CA, CO, AR, TN etc. His two brothers served in the U.S. Marine Corps retiring after successful military careers. At age 17 before finishing school, SFC Campbell enlisted in the U. S. Army in November 1954. He completed eight weeks of Basic Training and eight weeks of Infantry training at Ft. Jackson, SC, for service in the Infantry. SFC Campbell was deployed to





peacetime forces in Korea with the 24th Infantry Division for 18 months. After that deployment, he was transferred to Ft. Riley, KS, for completion of his three years of enlistment in December 1957. He then reenlisted for six years, and for 13 weeks, he retrained to work in Explosive Ordinance at the U. S. Navy Propellant Factory and E.O.D. School at Indianhead, MD. He then served at Granite City Engineering Depot, Ill. He also served at Okinawa, Red River Army Depot, TX, Korea and Sandia Base, NM. SFC Campbell was deployed to Vietnam serving from April 1967 to June 1969 where he was wounded and

SFC Campbell continued his military career by serving at White Sands Missile Range, NM. SFC Campbell retired from military service at the Redstone Arsenal, AL, December 1975 at the rank of E7.

After his military retirement, SFC Campbell entered civil service and worked as a logistics specialist at Tinker Air Force Base, OK, and then he became a government contract specialist at Maxwell Air Force Base Gunter Annex retiring in 1995 at GS11. He has membership in the Vietnam Veterans of America, Disabled American Veterans and Veterans of Foreign Wars.

SFC Campbell and his wife, Marion Mercer, were married 16 years before she passed away, and they had two adopted children, two granddaughters and six great-grandchildren. He and his wife, Mary Hollis, were married 22 years until she passed. He and his wife Brenda have been married almost two years, and they are active members of Frazer Methodist Church.

SFC Campbell is grateful for the education that he was able to receive during his military service. He received a GED while serving in Korea, a B.S. Degree in Business Administration from William Carey College in 1956 and a Master of Business Administration from Oklahoma City University in 1981. While reiterating that he felt safe at the time, this Ukrainian recognized that many other areas of his country were being hit hard. Again, he stressed that the City of Odesa was reasonably safe. Not a Ukrainian citizen by birth, Odesa was home to him. He had established a family there and made many friends. He had enough food and supplies for a month, and a car full of gas. At the time, still not comprehending that he might have to flee Ukraine.

Who is this man giving a first-hand report from overseas in a country invaded by Russia on Thursday, February 24, 2002? He is known as Gustavo – a well-known musician on the high seas and beloved by many. His profession is that of a piano bar entertainer in the cruise industry. He is just one face and one account of what is happening to the citizens of Ukraine. He is just one person in a city of more than a million and in a country of 41 million. But Gustavo is a real person. He is not media hype or a fictitious character. He is a man in fear of his life and that of his family.

On that beautiful Sunday morning, the piano man ended the video with hopes of peace talks, but he wasn't naive and he was prepared.

Having that esprit de corps brought out so much in me that I never missed family. I had something of which I was a part. When I went beyond my emotional needs, I looked at what we were doing for society. We were contributing by being model citizens, living a good, clean, healthy life, working out and being an ambassador to other people who were less fortunate. I was strengthened by being in the military. I was so overwhelmed by everything that I received, the training, the strategies, the operations, that now that I look at myself, all I want to do is to give back. I think that having a family helped me to balance and focus on the mission because of my family's notes and e-mails encouraging me on down days especially during deployments and travel."

### **OBSERVATIONS:**

Putin served in KGB for 16 years. He has ordered opponents to be imprisoned or murdered. He is not crazy; he is cunning. He also seeks the glory that was once held by former Soviet dictators and wants to be in the pantheon of the Communist Soviet leaders.

Ukraine was one of the founding countries of the USSR. It has rich and complimentary mineral resources that can directly help the Russian economy.

Surprisingly, Russia's GDP (\$1.4 trillion) is roughly equivalent to that of the state of Florida (\$1.3 trillion). War is often an excuse leaders use when the economy is doing poorly. Half of Russia's GDP is tied to oil exports.

Russia controls the flow of oil to most the European countries. Interestingly, the current embargos do not include stopping Russian oil.

The U.S. imports over 200,000 barrels a day. The Biden sanctions do not include any disruption as of the time of this writing.

China is sitting on the sidelines, but only in appearance. It has been strongly suggested that it will provide as much funding as Russia needs in turn for its opportunity to attack and control Taiwan in the coming months if not weeks.

Banks around the world have ceased all transactions with Russia and the U.S., and others have seized Russian assets in affiliated banks. These actions seem to strengthen a tie between not only between Russia and China, but also Iran. China abstained from condemning Russia's attacks in a UN resolution.

Oil prices have surged to over \$110 a barrel at the time of this writing. Reports out of Ukraine indicate war deaths of over 20,000 Ukraine soldiers and 5,000 civilians thus far, with predicted loss of life to be much higher. Some estimate in the hundreds of thousands, with those injured exceeding 100,000. Bombings continue across the country including key seaports. It is reported that between one and two million refugees will flood into neighboring countries.

Kyiv (pronounced Ki-ev not Keiv) is currently under siege with a 40-mile Russian convoy heading toward the capital city, approximately 20 miles from the city center.

The Ukraine has no air assault to speak of and none of the NATO forces have volunteered to attack this convoy or other key spots. The U.S. has deployed about 10,000 troops thus far, and has also given the Ukraine military Javelin missile weapon systems made in Troy, AL by Lockheed Martin.

One of the key criticisms of Putin was that the Ukraine was attempting to join the U.N. Security Council.

Germany and other countries are now beginning to attempt to send more

sophisticated weapons, but not enough to stop the onslaught.— Staff Reporter



# WOMEN'S HISTORY MONTH and Social Security

Each March, we celebrate Women's History Month.

It is a time to reflect on the achievements of women. Social Security has served a vital role in the lives of women for more than 85 years.

Women have longer average life expectancies than men, which means they live more years in retirement and have a greater chance of exhausting other sources of income. It's important for women to plan early and wisely for retirement.



Our retirement pages at *www.ssa.gov/retirement* provide detailed information about how life events can affect a woman's Social Security retirement benefits. These events may include marriage, widowhood, divorce, self-employment, government service, and other life or career changes.

Your earnings history will determine your future benefits, so we encourage you to verify that the information we have is correct. You can create your personal *my Social Security* account at *www.ssa.gov/myaccount* and review your earnings history. If you find an error in your earnings record, it is important to get it corrected so you receive the benefits you earned when you retire. Our publication, *How to Correct Your Social Security Earnings Record* at *www.ssa.gov/pubs/EN-05-10081.pdf*, provides you with details on how to make a correction. You also can view your Social Security Statement on your *my Social Security* account, for estimates of future benefits and other important planning information.

### Guard Your Card: Protect What's Important to You



We encourage you not to carry your Social Security card with you every day. The best way to "Guard Your Card" is to keep it in a safe place and share it only when required. In fact, in most cases, just knowing the Social Security number should be enough. In 49 states and the District of Columbia, a Social Security card isn't required to request a Real ID. Only Pennsylvania requires it.

Please be careful about sharing your number when asked for it. You should always ask why your number is needed, how it will be used, and what will happen if you refuse. Also, you shouldn't carry documents that display your number.

If you need a replacement Social Security card, we make it easy. You may be able to use a personal my Social Security account to request a replacement on our website. If you live in one of 46 participating states or the District of Columbia, and are requesting a replacement card with no changes, like a name change, you can use our free online service at www.ssa.gov/myaccount/replacement-card.html.

# Workers in Your Home and Social Security Taxes

Do you plan to pay a cleaning person, cook, gardener, babysitter, or other household worker at least \$2,400 in 2022? If you will pay at least \$2,400 to one person during the year, which may include transportation, meals, and housing, you have additional financial responsibilities to consider.

When you pay at least \$2,400 in wages to a household worker, you must do all of the following:

- Deduct Social Security and Medicare taxes from those wages.
- Pay these taxes to the Internal Revenue Service.
- Report the wages to Social Security.

Accurate reporting is important as employees earn credits toward Social Security benefits and Medicare coverage. You can currently earn Social Security or Medicare credit for every \$1,510 in wages that are reported. Generally, people need 10 years of work to qualify for:

- Retirement benefits (as early as age 62).
- Disability benefits for the worker and the worker's dependents.
- Survivors benefits for the worker's family.
- Medicare benefits.



# How to be Social Without the Social Media

The United States surgeon general has issued a report stating the negative effects social media platforms are having on mental health, especially in teens and young adults. The platforms generate feelings of loneliness and erode self-esteem.

Social media has proven to offer the opposite of what the name states, allowing users to isolate while constantly comparing themselves to others. This has been exacerbated further by the pandemic. There has been a rise in suicide attempts, depression, stress, and anxiety.

It is a problem made worse by a lack of access to quality care for mental health issues. It often takes years from the onset of symptoms before a child receives treatment.

The report expressed the immediate need for prevention programs, and the need for a better understanding of the impact technology and social media can have on young people.

Those of us who grew up before social media can remember what is was like to be social without an app. It was a different time. People would go out. And out could be anywhere.

I had the opportunity to be young in two places. I lived in Thomasville until I was 16, then lived in Clanton – where I graduated from high school – until I was 18.

In Thomasville, on Friday and Saturday nights the place to be social was

the Hardee's parking lot. The Hardee's parking lot may not sound like a very exciting place, but at the time it was the most exciting place in Thomasville to young people.

Girl's would dress up and fix their hair just to go sit in the Hardee's parking lot. Guy's would wash their trucks and put on fresh button-down collared shirts. It wasn't always Hardee's. My parents lived in Thomasville when they were

young too and they would pretty much do the same except they would gang up at the Dairy Queen.

Clanton, was a little different, but most towns had similar routines. In Clan-

ton come the weekend, the thing to do socially was fit as many of your friends in your car or your mama's car as you could, and then drive to the Pizza Hut. It was there on the main street through town. Everybody in town who could go, would. So many it was a traffic issue every weekend.

Nobody much went into the Pizza Hut to eat. We just circled it, driving

slow, looking at who else was out driving around. We would wave at one another. Not everybody waved, but most people waved. That was part of the socializing. Some people tried to act stuck-up, or mad, or sometimes somebody might be too drunk to recognize anybody to wave at, but for the most part people were friendly. That was the whole point.

What we would do then would be drive from the Pizza Hut up the street to Jack's, and then we would drive around Jack's, still looking and waving and hollering out the window at one another. Then we would drive back down to Pizza Hut. It was fun. We would do it for hours.

Sometimes there would be a swapping up of passengers from car to car. Most people knew a few back roads. Knew where the peach orchards were, and the gravel pit. Back then people liked to feel on one another. They didn't have screens to touch. That was how a lot of families started. But mostly, kids just drove back and forth...being social. And then one day we had to grow up and be adults.

Before long young people today will probably learn they have to do the same. Life is much better living it than watching it from the sideline.

### What's in Your Live Well?

The bass fishing tournaments are getting ready to start with a vengeance. Once they begin, each weekend will offer another opportunity to fish for money. All bass tournaments have pretty much the same rules. Two fishermen, one boat, and the five biggest fish by weight,

win. Some men will literally come to blows in pursuing first prize. And first prize can be worth lots of money, even in the smaller tournaments. As I have said before, these types of events touch both the competitive and outdoorsy side of men. It's enough fun to fish but add in beating somebody in the process and winning cash to do it, makes it an addictive potion. Most of the time, each team will spend the first few hours on the water just trying to catch any size fish. The immediate goal is to get five fish in the boat. # Southern Cuisine

The recipes chosen for this issue were determined by the weather and age.. Last night was the coldest for the year. It is only February, so colder days could come back at anytime. Besides the weather, I wanted to continue

with my theme of finding older recipes that I have ignored or how to prepare them has been lost. With all of the premade meals you can find in grocery stores and with the partial opening of restaurants, it is very easy to have a meal and not have to prepare it. And just the freedom from governmentmandated restrictions on where you can eat and socialize has made it easier to leave your home and go out and enjoy life.

I have commented before on the savings you will have by preparing your own meals at home. Yes, it is nice to get out and try new tastes at the new restaurants that have opened but I actually had sticker shock when I looked at the price of a meal at a restaurant. There are valid reasons for the sticker shock. Restaurants have had a hard time the past couple of years. Mandates have limited the number of patrons they can seat. Inflation and cost of labor has increased. People have been scared to go out on the town.

If you have not dined at some of the new restaurants that have opened, you have missed out.

I have eaten at four new restaurants and I have not been disappointed. Yes the meals were more expensive than what I was use to, but the meals themselves were different from what they were before.

So even though I do and will go out to eat many times in the future I am changing what I originally was going to write about. I found two ways to cook a dish that has always been a favorite of mine. Living in Texas for a number of years, Chili has been a go to meal when my refrigerator was full of leftovers from meals past. Each recipe can be called a chili recipe, but there are more renditions of chili recipes as there are renditions of tuna salad sandwiches, hamburgers and vodka drinks. So here are two renditions of chili. One is a cream base and is thick warm and filling. The other is a broth base and is good with a jalapeno cheese cornbread. Either recipe can be tweaked to spice them up. Just add your favorite hot sauce to make it as spicy as you can stand. Also add some Hatch green chilies. Or the next time you stop at BUC-EES on your way to the coast, pick up a bottle of their wide selections of hot sauces they carry. When I shop in Montgomery, I always try to stop at the Capitol Market on the southern bypass and pick up a jar of INCA'S FOOD Aji Amarillo yellow paste.

The first recipe is from LANA'S COOKING website with a few tweaks.

### Creamy White Chicken Chili

A rich, creamy white chili packed with tender pieces of chicken and white beans. Servings: 10

### **INGREDIENTS:**

- 9 chicken thighs, cooked, bones removed & chopped, skin on
- ½ cup butter divided 2 large onions chopped
- 1/4 cup all-purpose flour
- 3/4 cup chicken broth
- 2 cups half and half
- 1 tsp Tabasco
- 1½ tsp chili powder 1tsp ground cumin
- 2 tsp salt ½ tsp pepper
- 16 oz canned white beans
- (great northern or cannellini), drained
- 8 oz canned, chopped mild green chilies drained
- 1½ cups grated Monterey Jack cheese
- 1 cup milk
- ½ cup sour cream

### **METHOD:**

- 1. Cook thighs and remove bones. Cut into medium chunks.
- In a large pot or Dutch oven, cook the onion in half of the butter until softened. Remove from the pot and set aside.
- In the same pot, melt remaining 6 Tbsp of butter over moderately low heat and whisk in the flour.
- Cook, whisking constantly, for about three minutes.
- Stir in the onion.
- Gradually add the broth then the half and half, whisking the whole time.
- Bring the mixture to a boil, reduce the heat and simmer, stirring occasionally, 5 minutes, or until thickened. (It will be nicely and obviously thick.)
- Stir in all other ingredients.
- Cook over moderately low heat, stirring occasionally for 20 minutes.
- 10. Add sour cream.
- 11. Serve with the usual chili garnishes cilantro, cheese, jalapenos, etc.

My wife, Anne, made up this recipe. It is a broth type chili. There is no dairy in the recipe if you substitute the butter in the recipe for oil or margarine.

### ANNE'S Chicken Chili

### **INGREDIENTS:**

- 9 cooked chicken thighs with the bones removed & then chopped into medium chunks
- 4 cups chicken stock
- 2 15-oz cans white beans (cannellini or great northern, drained &
- 2 4.5-oz cans diced green chilis 3 cloves garlic chopped saute before
- 1 medium onion chopped saute
- before adding 2 tsp cumin
- 14-oz can yellow corn, drained
- ½ tsp salt
- 1/4 tsp cayenne pepper



### **METHOD:**

- 1. Put all ingredients in a slow cooker or pot on stove.
- 2. Cook until hot for serving.

Garnish: small bunch fresh cilantro for garnish & fresh lime cut in wedges

Serve with the same cornbread as with the previous recipe, or with my favorite, saltine crackers.

With all the spice in the chili recipes, a sweet dessert works well. This recipe was first published in 2001, I not sure it was first published in Southern Living, but I found this recipe in the magazine in 2021. It is a sheet cake recipe and takes some effort to mix it altogether. And you can use any frosting you seem fit. Sprinkle the remaining pecans on top.

### Fresh Apple Cake

### **INGREDIENTS:**

1½ cups chopped pecans, divided

- 1 stick butter, melted 2 cups sugar
- 2 eggs
- 1 tsp vanilla extract 2 cups flour
- 2 tsp cinnamon
- 1 tsp baking soda
- 1 tsp salt
- 4 large Granny Smith apples, peeled & cut into wedges **Cream Cheese Frosting**

### **METHOD:**

- 1. Preheat oven to 350°.
- Bake pecans in a single layer in a shallow pan 5 to 7 minutes or until lightly toasted and fragrant, stirring halfway through.
- Combine butter, sugar, eggs, and vanilla extract in a large bowl until
- Combine flour, salt, cinnamon, baking soda and butter mixture, stirring until blended.
- Stir in apples and 1 cup pecans.
- Spread thick batter into a lightly greased 13- x 9-inch pan.
- Bake at 350° for 45 minutes.
- Remove from oven when a wooden pick inserted in center comes out
- Cool completely in pan on a wire rack for 30-45 minutes.
- 10. Spread frosting (your choice) on cake and sprinkle with remaining pecans.
