

Mr. and Mrs. Ames founded Perry County Christian School in 1965, where Mrs. Ames taught and was the school administrator. She pursued graduate work in Library Science and a Masters Degree in School Administration.

Over the years, Bobbie was active in Republican political circles, having served as President of the Federation of Republican Women at the county and state levels, and as Republican National Committeewoman from Alabama, from 1968-1972.

Mrs. Ames built a library at Emerald Mountain Christian School to preserve and to assure vital and pure research with over 45,000 volumes in the collection. This valuable research source has enabled her to write for an area newspaper, *The Alabama Gazette*, for the last six years writing on issues of education and history from the Biblical worldview.

Today Emerald Mountain Christian School's mission has expanded into an outreach and research division called "*The Hoffman Education Center for the Family*." Son **David Ames** is the headmaster of the school with the very able help of **Joanna**, his wife.



It is Christmas time, and since Alabama is one of the most charitable states in the nation, I would expect that many of us are in the giving mood and plan to help many worthy causes across our great state. Unfortunately, it appears that some recent rulings by the Alabama Ethics Commission are going to make it more difficult for charities across the state to raise the funds that they need to serve our communities.

Many charities in Alabama are concerned that an unintended consequence of recent Commission interpretations of the ethics law is that it could restrict the ability of public officials and employees and their family members to be involved in fundraising for charities and other organizations that they support, including public schools and universities.

You may not be aware, but there are over 300,000 public officials and employees at the state and local level who are covered by Alabama's ethics law. Many of these individuals are leaders in their communities, who are appointed to positions of public responsibility such as school boards and water boards. Not surprisingly, these same individuals are often also involved in supporting a number of worthy causes and charities by helping with their fundraising and serving on their boards.

The problem is, over the past year or so, in an effort to implement what they seem to believe the law requires, the Ethics Commission has issued guidance that places restrictions on the ability of public officials and employees to help charities by seeking donations from various individuals, businesses, and organizations.

While their intentions are no doubt good, the broad language of these rulings has caused major issues for charities across the state. This is because a number of those charities rely on individuals, who happen to be part-time members of public boards who are covered by these ethics laws. As a result, charities are asking anyone involved in a public body not to fundraise for them no matter how much they have done so in the past. I do not expect that anyone was thinking about these

situations when they amended the ethics laws back in 2010, but it appears that this is another one of those unintended consequences of a well-intentioned law.

To make matters worse, under the Commission's interpretations of these laws, the restrictions on charity fundraising also seem to apply to the family members of these 300,000 public servants who are raising money for a charity. This means that these rulings affect the ability of many more Alabamians. There are probably close to one million folks who help raise money for the charities that they support.

Hopefully, the Commission will clear up this confusion. However, if they do not, I expect that the outcry will be so great that the Legislature will take action.

Remember that this is not the first time we have had problems with broad interpretations of the ethics laws at Christmastime.

Back in December 2011, you may recall, the Ethics Commission issued rulings that raised a lot of questions and concerns about the ability of public school teachers to accept Christmas gifts from students under these same ethics laws. The concerns arose then because of some of the changes to the law that had gone into effect earlier in 2011.

The Commission's rulings in 2011 did not, in the end, clear things up very much for students and their teachers in time for Christmas. However, in the following legislative session in 2012, the Legislature amended the ethics law to make it easier for students to give Christmas gifts to public school teachers and coaches. The legislative fix was needed to address an unintended consequence of the law.

I think we are all hoping this current problem for charitable fundraising is resolved by the Ethics Commission in time for Christmas. We do not need our charities and other worthy causes to suffer an unintended consequence of a well-intentioned law.

A Personal Experience: Health Law, Health Care and Me

In September I had began to feel pretty rough, so bad that I actually went to the doctor. It was determined that I had a gallstone pancreatitis caused by a gallbladder with stones (of course) and my gallbladder needed to come out. Having had no prior abdominal surgery my surgeon was happy that I had a "virgin belly", a pretty funny term.

I know that my health insurance went up signifi-

cantly last year and significantly again this year. Thank you President Obama for a real piece of work. Insurance now seems to rely on age rather than experience as previously done and I'm afraid that my rates now greatly exceed my age many, many times over. I understand that some families are paying in the \$1500 to \$2000 range per month. Those are medium to higher range plans but the deductibles and copays for lower range plans can be very significant; I have seen as much as a \$10,000.00 deductible.

I am in the process of trying to sort out my bills and making sure that my providers have considered my gap insurance. I received a bill from the hospital, one for my CT, one for the emergency room doctor who I don't think I really needed to see because I was told to go to the ER to be admitted; we already knew what was going on. I received a bill from the surgeon, one from the anesthesiologist and last but not least the hospitalist. The deductibles added up to a few thousand dollars but they had not considered the gap insurance so I will see what happens. I have had to become my own advocate to make sure that these entities stay on top of my insurances. Do you remember when your doctor admitted you and came to see you in the hospital? Now the hospitalist drives the process and they don't know anything about you until they walk in your room and flip open your chart. The first one that I saw I got to tell him I was having surgery in a few hours and he charged me for that! When my surgery was over the surgeon came by and said I could go home that afternoon but the hospitalist who didn't come by again that day did not discharge me so I stayed an extra night and another hospitalist came by the next morning and released me. The hospitalist drives the system. I don't question the abilities of the hospitalist but they don't know me and in a follow up visit my surgeon told me the hospitalist allowed me to go back to work sooner than he would have allowed. With all of the new regulations on health care providers no wonder the cost has gone up. This wonderful technology has greatly improved health care delivery but it obviously has a price. New Medicare payment models for certain sections of the health care industry are now in a trial phase. Basically those that are more efficient in the delivery of health care will be paid more. While efficiency includes fewer hospital returns for treatment of an already treated condition I'm guessing there is also pressure to further decrease the length of stay; my experience shows that conflicts with using hospitalists. Health care is becoming a balancing act with the survival of independent clinics that provide top-notch specialty services and trying to not be absorbed by large hospital systems that look at the bottom line rather than the services that have been provided to the community.

It has become evident with the number of health insurance companies dropping out of the marketplace that the goal of the Obama administration was to become a one-payer system, i.e. the government. Remember the phrase, "I'm from the government and I'm here to help you"? I don't know where Blue Cross, Humana, Viva and the others will fit into this unless it's as a secondary insurance, gap insurance and a Medicare supplement. The goal of progressives is to follow a European style government that we figured out two hundred and forty years ago does not work well for Americans. When my wife and I were in the Republic of Ireland ten years ago and listening to Sky News the rage that day was over a twenty something year old woman that died while waiting on some type of scan that was scheduled six months away under her socialized medicine program. Those that can afford it do a private pay in the afternoons after doctors have completed their government obligations. We can only pray that a Trump administration will really get a grip on what Obama's administration has complicated.

The heroes of my health care were the employees that I know have suffered from literally little or no raises and increasing health insurance premiums. I think about the nurse in the ER that got me a food tray after I had missed lunch and been there for hours. I think about the nurse in the holding area after I left the ER while waiting on a room. I laid on a small stretcher that my feet hung off for a few hours but the nurse did everything she could to make me comfortable. I think about the nursing assistant that took me to my room telling me about a gentleman that she spoke to and how he worked two shifts at different places to care for his family. The nurses that cared for me on the floor were equally great and made sure I had everything that I needed. I think about the very nice young man that rolled me to surgery and though very busy respectfully and reverently waited while one of my pastors prayed with my wife and me. These employees of the local hospital were great and I really appreciated them. I hope that the hospital values these employees as I did. I pray that each of you have a blessed Hanukkah or Christmas and for Christians to think about a loving God that sent His Son to earth in the form of a baby to grow and teach us about our loving God and to finally give over his life as a sacrifice for those that will call on the name of Jesus for salvation.

No doubt my most read text from years of writing for the *Alabama Gazette* is "Ten Years After" (Jan. 2011 column) explaining how Texas Gov. George W. Bush became the 43rd US president although VP Al Gore received more votes in the general election. Some readers have asked for similar analysis on the recent result where Mr. Trump won the Electoral College with a much greater electoral vote margin yet STILL lost the popular vote by 668,483 (according to **AP** reports) or even more according to other sources.

"W" was the third US president to win the Electoral College (50.5%/49.5%) without winning the popular vote 50,456,002 to 50,999,897; the 271-266 result fell one short of 538 because a DC elector abstained. In 1876, Rutherford B. Hayes squeaked by Samuel J. Tilden in the Electoral College 185-184, despite losing the popular vote 4,284,020 to 4,036,572. In 1888, Benjamin Harrison won the Electoral College (58%/42%) over Grover Cleveland by a 233-168 margin, while losing the popular vote 5,537,857 - 5,447,129. Cleveland came back to beat Harrison in 1892 as the first and only president thus far to serve two **non**consecutive terms.

The response by a number of Gore supporters (including then NY Senator-elect Hillary Clinton and another big govt. champion Donald Trump) to this inconsistency between the Electoral College and popular vote was to do away with the Electoral College. This debate is nothing new, the only difference for those like Trump is this time the 'rigged system' proffered his desired duopoly result. Abolishing electors will not likely happen given the majorities required for an Amendment, unless this simply becomes another Constitutional provision ignored by extremists who've 'progressed' our Nation toward the mess we're in today - more on DC electors distortion later.

Widespread ignorance from the pop press explaining why this occurred adds to the 'fuzzy picture' which results under the current House of Representatives (HoR) result. States with small populations have a more-than-proportionate influence in the electoral college. It seems unlikely the small States which benefit from the current (unconstitutional) size of Congress, would support a Constitutional amendment to eliminate the electoral college. In fact, Ms. Clinton's position put her publicly at odds with the Senate minority leader at that time (Tom Daschle of South Dakota) from one of the States which benefit the most from the current Electoral College. A State like Alabama (23rd largest State last I checked) wouldn't see a huge gain/loss relative to other States, but would benefit from a more representative HoR in general.

Trump's past and Clinton's now shriller cry for ending the Electoral College is ill-founded to anyone familiar with the structure of the Constitution. The genesis of the inconsistency between the Electoral College result and the popular vote lies not in any fundamental problem with the Electoral College, but specifically the corrupt actions of Congress. A brief overview (Art. 2, Sect. 1) of the makeup of the Electoral College sheds some light on the ever increasing likelihood of more Bush v. Gore outcomes - esp. when the margin of victory is close in some key "battleground" States and "blowouts" in other States. Electors for each State equals the number of U.S. Senators (two) plus the number of individuals serving in the HoR which varies by State population. Since each State is guaranteed a minimum of one representative, the lowest possible number of electors from each State (now including the District of Columbia) in the electoral college is three. The result from the electoral college almost always mirrors the popular vote - esp. if Art. 1, Sect. 2 (30,000 rule) is also followed. Of course if the Electoral College were eliminated (dissolving one of the last vestiges of State sovereignty in our now forced coalition of states) campaigns would be ran/targeted differently. Once it is clear a State (e.g., Alabama or Wyoming for Trump; California or New York for Clinton) will go to one of the duopoly candidates, there's no incentive to campaign and many voters simply do not show or do not vote in the presidential race. While it is interesting to speculate, we do not know how the popular vote would change and campaigns/voters respond to the structural change. How many more Trump voters would've shown in CA - how many more Clinton voters in Wyoming -- who knows?

IF the House of Representatives lives up to its name (i.e., being truly represen-

McKinley/Bryan, 1896; Cleveland/Harrison, 1892; Cleveland/Blaine, 1884; Garfield/Hancock, 1880) the more representative, constitutionally correct electoral college mirrors the popular vote for president.

Its simple arithmetic - occasional inconsistencies between the popular vote and the Electoral College vote in presidential elections is not caused by any deep flaw in the Electoral College. It is driven more by congressional circumvention of our Constitution along with campaigns and voters responding to our current unrepresentative duopoly result. Irate politicians like Mrs. Clinton over the Bush v. Gore result who are eager to fix perceived wrongs associated with our presidential elections would advance their cause more effectively by filing suit to force Congress to live by the law of the land rather than once again trying to amend it. Don't hold your breath expecting one of our modern extremist (Republocrat) candidates to bring a case of this sort. Mr. Gore had a documentable violation of the Constitution which caused him demonstrable harm - he lost a job. The Bush, Clinton, Dole, Gore, et al types want the status quo result even when it means they must take the back seat for an election cycle or two - representative government is their worst nightmare.

This would move our nation forward to what we were envisioned to become - a more perfect voluntary union to promote the GENERAL welfare over specific interests. To be painfully clear, Congress pulled off a "union" of another sort in 1929, agreeing to cap the number members to 435 so they could raise the price of political favours. Think of then [2000] Congressman Riley taking money from pharmaceutical giant Pfizer to extend patents which apply specifically to them; or more locally, felon Hubbard taking campaign contributions from Farmers to make auto insurance mandatory in our State. I did NOT and still don't care which extremist won. I don't think our nation would be in any better shape if Gore had been president rather than W nor better with Trump instead of Clinton - will some parasites fare better under Trump's corporate welfare and debt increase than Clinton's social welfare parasites? Yes, but the ever shrinking number of middle class producers will find little difference in being sucked dry these next several years by red tics as we've been drained by the blue tics in DC these past years.

I've long advocated moving forward to a part-time, constitutionally correct Congress whose members each represent just over 30,000 people with no more staff than a general secretary who serves several members at the same time. No big paychecks (say median income so they may know/care what it is?) nor separate retirements to avoid the SSA Ponzi scheme they've created, no skirting the government health insurance they mandate, etc. I'm certain a ten thousand member HoR will have extremists babbling. Feel free to join them as long as you don't mind an increasingly 'fuzzier picture' as James Hines would say. More importantly, this will make campaign money much less of an issue as individuals and specific groups will not be willing to pay much to HoR candidates for wealth transfers in their favour as each member will have such a small net impact (as originally designed) when voting on legislation. Furthermore, it would get a more diverse group into national politics which may provide better candidates than the Bush, Clinton, Dole, Kerry, McCain, Obama, Romney, et al types most voters feel compelled to vote for.

Would a HoR which adjusts to population in this fashion mean little would 'get done' in DC? YOU BET! What few bills which would make it through this body for the Executive to consider would indeed be representative of the people - again this is the worst nightmare of the extremists who've so long benefitted from the unrepresentative results. The median, productive citizen would be amazed at how much their lives (i.e., general welfare) would improve if the federal government moved forward to only do those few things enumerated really well and left the rest to more competitive State and local governments to accomplish. Hard to imagine a worse group in our nation than the current, unrepresentative body put in power via gerrymandering absurdly large Congressional Districts, with restrictive ballot access laws, and campaign finance laws designed to protect incumbents deciding our future, which is likely to make this era another great contraction in our nation's economic history if they do not change course. More of the same is not the answer. My point back in 2011 at the ten year anniversary of an electoral college win over the popular vote we observed upheld by the SCotUS was a sound milestone/ reminder to consider making our HoR representative once again - likely to offer better choices than the two politicians of such poor character and integrity offered in 2000. I don't think any rational person sincerely believes the swamp rats returning to DC will really drain the swamp, but we can dilute the power of the most deleterious rats plaguing us. Onto the recent Trump 306-232 Electoral College (57%/43%) result over Clinton's 62,972,226 to 62,277,750 popular vote win. It is only the SECOND time a Constitutionally correct HoR does not mirror the popular vote as in 1888 when Harrison won the Electoral College (58%/42%) over Cleveland by a 233-168 margin but lost the popular vote 5,537,857 - 5,447,129. Clinton sycophants, hypocritically silent (as is Trump this time about the Electoral College) on 'Super-delegates' boxing out Bernie for the Democratic Party nomination, are again crying foul and havoc with a result they don't like. With what appears to be the worst turnout in 20 years by most accounts, I get a tickle out of those who assert Trump somehow has a mandate with such low approval ratings riding the wave of 'flyover country' backlash to win without the popular vote under the current distorted result. Let's be honest, Clinton lost because the union/blue collar vote didn't show - some say because the pollsters all said she'd win and they didn't want to show support for one who'd clearly forgotten and didn't represent them... remember the Howard Dean scream media trashing, now a cautionary tale for the Dems? Most illustrative, Hillary's pop vote result couldn't even beat Romney. The number of voters who cast a vote in Senate races and didn't vote in the presidential election was in the hundreds of thousands. Millennials didn't show as expected for Clinton - esp. those slighted by how Mr. Sanders was treated by the 'rigged system' and many voted for someone other than these two deeply flawed duopoly candidates. So what happened?

tative) inconsistencies between popular and electoral results are less likely. However, this is not the case. On June 18, 1929, Congress capped the size of the House of Representatives to 435 - - in violation of Art. 1, Sect. 2. As population grows, real representation decreases - or as my friend James Hines explains, "produces a fuzzier picture with fewer pixels." The Constitution specifies, "*The number of Representatives shall not exceed one per thirty thousand, but each State shall have at Least one Representative; ...*" In any given State, there must be one representative for the first 59,999 people. At 60,000 people, the State is apportioned a second representative (two representatives for 59,999 would violate the constitutional provision cited above), and so forth. However, this illegal action only formalized the Congress' de facto violation of the Constitution, as the 30,000 ratio has been exceeded throughout the 19th and 20th centuries. At the time of the tight Bush v. Gore Electoral College result we were at about 600,000 to 1. It may be hard for some readers to believe that our esteemed, ethical members of Congress would do anything unconstitutional, but, in fact, it happens on a regular basis.

Federalist (Numbers 55-58) explains the founding fathers were concerned with having too many/too few representatives. Since our United States were intended to be a representative republic, NOT a democracy, the act of capping the size of the HoR reduces the relative political influence of States which are gaining population faster than others. The reason? Even though seats are reapportioned after every Census, 'small' States always have a minimum of three electors. Some States (like Wyoming) had not yet reached the 600,000 threshold in the 2000 election, but still get an elector for their one representative, while the most populous State, California, had 54 electors. In effect, California had 18 times as much weight in the Electoral College as Wyoming, which has three votes. This is NOT constitutionally correct representation and gives Wyoming and other 'small' States relatively more weight in the Electoral College than they'd have under the constitutional constraint. In 1999, the population of California was 33,145,121, while the population of Wyoming was 479,602. In terms of population California was 69 times larger than Wyoming. Under the 30,000 rule for determining the HoR California would've had 1,120 members in its delegation; Wyoming only 15. In the Electoral College California is 1,122 electors; Wyoming would have 17... don't forget the two senators which our framers understood would become insignificant in generating elector totals as population increased. In this case, California's relative influence in the Electoral College would much more closely match relative differences in State population (66 to 1) in close elections.

To demonstrate this abridgement of representation creates the inconsistency between the popular vote and the electoral college (not any fundamental problem with the electoral college itself) Professor David Laband calculated the composition of the electoral college as if representation adhered to the 30,000 to 1 stricture spelled out in Art. 1, Sect. 2. When doing so, Mr. Gore also wins the 'Constitutionally correct' electoral vote 4,632 to 4,615. Going back into history and recalculating electoral college results for the 1876 election, Laband found Sam Tilden would have won the electoral college vote by 686-646, leaving the 1888 election as the only anomaly of the first three -- Grover Cleveland wins the popular vote but still falls short in the electoral college or the popular vote (Carter/Ford, 1976; Nixon/Humphrey, 1968; Kennedy/Nixon, 1960; Truman/Dewey, 1948; Wilson/Hughes, 1916;

Clinton was 38 Electoral votes short. The four States which made the difference are as follows:

FLORIDA's 29 electors were lost by 119, 770 votes, the only **non**-duopoly candidate on all 50 State ballots (Gov. Johnson) earned 206,007 votes. Most polling found the Johnson ticket (the most qualified in terms of actual executive experience) was taking votes from Hillary 2 to 1, prompting the national press to finally cover the only other viable candidate - a.k.a. they "Aleppoed" him. Those who assert Johnson voters would still show to vote duopoly party and more would've gone Clinton, most of her 38 elector deficit is covered and only one of the three remaining battleground States listed below changes the result. Nothing new for "Florida, Florida, Florida," - on average recent presidential results have been determined by just over 10,000 votes in this large Electoral College State on par with New York, only exceeded by California and Texas.

MICHIGAN's 16 electors were lost by only 11,837 votes, the **non**-duopoly party candidate earned 173,021 votes. Again, if the Johnson voters still showed **and** disproportionately voted Clinton, these two small margin of victory States change the result.

PENNSYLVANIA 20 electors were lost by 68, 236 votes, the **non**-duopoly candidate earned 143, 653; another marginal State where Johnson voters can change the result if they still showed and disproportionately vote Clinton. I want to be very

Under the current circumstances if Clinton and Trump were the only choices forced upon Alabama, I wouldn't have participated. WISCONSIN's 10 electors were lost by 27,257 votes and the **non**-duopoly party candidate on all 50 State ballots earned 106, 442. Another small margin of victory State that along with Florida changes the result.

So what's the bottom line with the difference? Just like the unconstitutional 435 limit on the HoR [1929] impacts the observed electoral v. popular vote results, the 23rd Amendment [1961] giving DC electors distorts the outcome from the structure our framers designed. The ten mile square to make DC is federal installation, it wasn't supposed to have residents just as many folks who work and live on other federal installations have voting residencies in their respective/declared States. The biggest margin of victory for a candidate this Nov. was Clinton's 93% in DC running up the popular vote difference 248, 670 for that separate block (tied to the smallest State since DC also has no reason for Senators) of 3 electors on Clinton's side. DEER 101-QDMA

This week, I want to talk about how to anticipate tracking a deer after it's been stuck with an arrow. There are some tell-tale signs to keep an eye out for when the arrow hits that can give you a good idea of where you hit it and how long you need to wait before tracking it. Of course, I can right out tell you that shots to the head and neck aren't really what you want. Sure, they're pretty vital, but with all the bone, skin, muscle, and fur in the way, you're more likely than not just going to give that buck the shave of a lifetime and not a spot on the wall. Your main target is just behind the shoulder, where the heart is. A true shot through the heart will typically have that deer give a mule-kick, followed by a rather short meeting with the ground. In the rare case that the deer scampers off, and you're not sure where you tagged it, if the blood is a bright, almost pinkish color with some slight bubbling, you can bet that whitetail isn't too far off. The bubbling, for the curious, is from the arrow clipping the lungs, as it's pretty hard to shoot the heart without getting a bit of a lung shot.

Now, if you've ever been out there hunting deer, you know as well as I do that those animals rarely ever give you a good, clean, broadsided shot. Typically, you'll make do with the best shot you can get, so it pays to note what the deer does when it's hit, as well as what kind of blood trail you're looking at. Let's say you tag that buck in the spine. Odds are, with the thick bones and everything else, your arrow is going to break. However, a spine shot means that buck isn't going anywhere, but you'll need another shot to deliver that buck from its misery. Don't wait.

If you tag it in the gut, you're in for a long night. That sucker will take a few short steps, arch its back, tuck its tail right in tight, and slowly walk or trot out of the field before bedding down somewhere nearby. You want to take your time before trailing this deer, as a gut shot will normally be fatal but not quick. If you push after that deer too quick and too soon, it'll get up and run off before bedding down again, making locating it far, far more difficult. Your arrow will have flecks of brown and green on it as well as blood, and you'll definitely know if it's a gut shot from the smell. Try to avoid this one as much as possible!

If you tag it in the liver, that deer is done for. However, like a gut shot, it will take some time before you'll safely be able to approach; 3-5 hours is probably a good rule to follow. Your arrow will be covered in a very, very dark red blood, with a good start to the trail as it slowly fades out. Liver shot deer can go anywhere from 200 yards to a quarter mile before bedding down. As for the initial hit, just like a lung shot, the deer will more than likely trot off a little bit, or maybe just walk. Unlike the lung hit, where the deer will shortly fall over, a liver shot deer will take time to find a good place to rest. Just be patient and be ready.

Of course, while aiming for the heart is optimal in all situations, if you pull too far over, you'll smack that arrow against the foreleg of the deer, right into the scapula, which, unfortunately for you, is designed to protect the deer's vitals. If you pull back towards the heart and vitals, you'll have meat in the freezer for sure, so hope, pray, and aim well that your shot goes away from the bone. If you think the shot was high, up into the shoulder and bone, don't wait. Get down there and get ready to finish the job. If you're sure you nailed the vitals, then the wait is just a few minutes; a wounded animal is always dangerous to approach, so please be careful when approaching.

All that being said, we're gearing up for some gun hunting, so let's talk about deer roaming habits. As most of you know, the big old bucks don't get that way by being dumb, and every researcher worth his or her salt knows it too. Naturally,

they're working hard to get to the bottom of those big bad bucks' mysteries, and our wildlife biologists and researchers have turned to the latest in gadgets and tech to help reveal just where that trophy's been hiding. Of course, I'm talking about GPS collars.

After tagging a buck with a collar, biologists can check up on their subjects through the Eye in the Sky, letting us know just what a buck does with his day. As it turns out, from multiple studies performed across the United States, they do a whole lot of waiting. Most bucks seem to stay right smack in whatever area they can find that's chock full of cover and food. Clearcuts with plenty of browse are a favorite, and they will stay in them all day, every day. Most studies have shown bucks will only leave well after hunting hours are over; we're talking 3 in the morning! Now, as the weather cools off, browse gets sparse, and the rut starts cranking up, those big boys will start to wander out of their comfort zone a bit more often. If you're a bowhunter, early season, you'll want to find a good thickgrowth area with lots of protection, and try your darnedest to sneak up alongside it without getting caught. You might find yourself with a good story and a better trophy.

As gun season rolls around, stay patient; the big boys don't head out of their homes without good reason, so finding a buck in broad daylight is more or less like hitting the lottery. Be patient and resist the urge to leave the stand early. After the rut kicks in, all bets are off, as those lover boys aren't as concerned about safety as they are about those does.

Another thing to remember is that pressure will push deer off of their daily routine faster than anything else. GPS collars have shown that deer will adjust the same day they sense a hunter moving into an area, in as little as 12 hours. The average time for them to head back to an area with pressure is about 3 days, it seems. Keep your presence minimal and your impact light, or you might not get what you came for!

All in all, there's a whole lot more to go over, but we're already here at the start of the season. I hope all of you have prepared well and scouted out ahead of time, and I also hope all of you bow hunters managed to get a good story, if not a great trophy. So get out there, grab your camo and your ammo, get your Game Check ready, and go get'em!



Does a animal have the same pains, do they have PTSDs when a coon hunter chases them through the woods at night to try and kill them for sport. Do they have PTSDs when they almost get hit by a car or hit and survive? These are my


questions because I suffer from wounds and PTSDs, and I finally found the secret that makes living with this not a burden.

I spent 27 years as a military man and not once in those years was I able to

sleep a complete night, I never got more than a hours worth of sleep, my wife used to wake up finding me in a corner or under the bed, I found gun shots, cars back firing and popping balloons would make me drop grabbing my air weapon. But now its better I can sleep at least three hours and my pain doesn't hurt as bad now. These raccoons with special needs help me as much as I do them, or maybe just

This august group had Auburn in the top 15 going into the Alabama game and had talked about Auburn being a long shot to make the playoffs, that is until they lost to Georgia. Playing a quarterback with a severly injured throwing shoulder in Athens was the low point of Auburn's season. That is how afraid the offensive staff was to play one of the back-up quarterbacks.

this Auburn team was going to be, there were some misconceptions. Coach

Kevin Steele came over from LSU to run the defense. He has exceeded all

expectations. The offense was still being run by the coach that I labeled

"Malzahn the Magician" after the 2013 season. At every stop on Gus Malzahn's

college journey he has had great success with his quarterbacks and with his

offenses; Arkansas, Tulsa, Auburn, Arkansas State and the first year at Auburn

as head coach. I admit that he had a bit of luck in 2013 when he took Auburn to the National Championship Game. But, since that time he has had relatively bad

Now, an 8 - 4 season is no disgrace. In fact the Tigers could be in the Sugar Bowl on January 2nd. We will know on December 4th when the CFP Committee releases its top 4 teams. I reluctantly picked Auburn to go 9 - 3 in my pre-season poll in August. Here is a breakdown of the Auburn 2016 football season. Auburn

won three games over teams that had a winning season; Arkansas State who is in the Sun Belt Conference with Troy and South Alabama. They have at this writing a 6 - 5 record. LSU could not beat Florida, who has as bad an offense as Auburn's. They wound up with a fired coach and a hired coach and a 7 - 4 record. Arkansas is the pretender in the conference. They create all kinds of noise every year only to fold somewhere in the season and become ordinary. Arkansas finished 7 - 5. Those three teams compiled a record of 20 - 14.

Jalen Hurts, true freshman quarterback

In the Iron Bowl, Auburn's defense kept the Tigers in the game in the first half. They caused four fumbles, all covered by Alabama. True freshman defensive back from Robert E. Lee High School in Montgomery, Daniel Thomas, intercepted two of Jalen Hurts' passes which turned into six points. Hurts also fumbled three times but all were recovered by Alabama. All of his freshman miss-steps occurred in the first half. In the second half Jalen Hurts looked like the Heisman candidate that he is. For the game he completed 28 passes for 298 yards as Alabama pulled away for the big win. Alabama now plays Florida for the SEC Championship and for an almost certain play-off spot.

Early in the game, junior defensive back Stephen Roberts returned a punt 58 yards to set up Daniel Carlson's first field goal. With Auburn's three and out offense, the Auburn defense was on the field most of the second half but still only gave up a field goal and two touchdowns to the best team in America. **Coach Kevin Steele** has done a magnificent job in his first year as the defensive

coordinator at Auburn. It is yet to be determined how to judge the offensive staff. It appears that the offensive staff cannot come up with any kind of plan to beat a team that is better than Auburn. Obviously, the roulette wheel is not the answer. Every team in America has a first string quarterback and a back-up quarterback that is capable of running the team's offense. Not Auburn. They are afraid of the second team quarterback, Jeremy Johnson, so they limit his use of the total offense. They are even more afraid of John Franklin, the third team quarterback. He has


Well, lets be realistic. Regardless of the pre-season discussion as to how good



Pushing Back The Darkness

As we make our journey through the Advent Season, one symbol is preeminent-LIGHT! Tree lights, candle lights, houses, buildings, and malls are all decorated with lights. Perhaps it's a parable of our times that we are rarely without some form of light. I suppose we ought to thank Edison for that. It is said that after thousands of experiments, when he finally achieved this monumental breakthrough that would affect all of human history, Edison heard the shrill voice of his wife cry out, "For goodness sake, Tom, would you turn off that light and come to bed!"

We rarely experience total darkness because we have so much artificial light. Perhaps this is a parable of the inner darkness and emptiness of modern humanity. The writers of the Bible understood the significance of darkness and light.

In one of the prophecies about Christ, Isaiah beckoned his hearers to walk in the light of the Lord. "The people walking in darkness have seen a great light; on those living in the land of the shadow of death a light has dawned." (Isaiah 9:2) When Paul challenges us to cast off the works of darkness and put on the armor of light, the imagery is sharp and vivid. Without God there is nothing but confusion, dread, darkness and death. In Him is light and life.

The first recorded word that God spoke was, "Let there be light!" John, in his first epistle says, "Walk in the light as he is in the light." That's the basic message of the entire Bible. God can light up the entire universe with galaxies of indescribable dimensions, but there is one little corner of creation that with all His power and might He cannot reach without our help-the darkness within the human heart.

Many of you who are parents can appreciate God's dilemma. The world's greatest scientist or philosopher with an I.Q. at the top of the scale-with money and power may not be able to get through to a wayward son or daughter. Even the most devout Christian parent may watch helplessly as his offspring chooses the low road.

Imagine the agony of God as He surveys the darkness of life on our planet: hatred, murder, rape, and war. Imagine His despair as He beholds how we are bent on self-destruction. He offers us a better way, a way of abundant living and yet we waste our lives in the frivolous pursuit of status, pleasure, wealth, and power.

Let me offer three observations which help us draw a sharp contrast between the world of darkness and the full light of God's love we celebrate in this Christmas season.

First, God's light shines on us in the midst of our darkness. In the Bible, the coming of the light into the world is seen as an act of judgment. When we come into the light we are seen with all of our flaws, all of our misdeeds, and all of our weaknesses.

Of course, the irony is that we delude ourselves when we think that we can hide anything from God. You may be familiar with the story of a man who discovered his little daughter praying for him out loud. When she was finished, he said to her, "Honey, I appreciate you praying for me, but did you have to tell God that I have a hangover?"

Then there is the little girl who cut off a large section of her hair. When her mother realized it, she was very upset. The girl asked, "But how did you know, Mommy? I hid the hair very carefully. How did you know?"

We must look just as foolish as that little girl standing before God trying to hide our flaws from the One who knows us better than we know ourselves. He knows us and loves us and accepts us just as we are. That is the Gospel!

I think we often misunderstand the function of God's judgment. His judgment comes not as retribution but as redemption. He wants to save us from ourselves. As a physician seeks to remove a deadly spot from the body, so God wants to remove the dark spot from our soul, not for His sake but for ours.

Some of the same characteristics of darkness are still with us today as much as in those days gone by. Among these are idolatry, bondage, foolishness, confusion, superstition and spiritual blindness. Only the light of the Gospel reveals the true emptiness of such living.

took his little grandson for a walk in the woods. As they were walking along they stopped for a moment the grandfather asked, "Do you know where we are?" The little boy said, "No." The grandfather asked, "Do you know where we're going?" And the little boy again said, "No." The grandfather chuckled and said, "Well, I guess you're lost then." The boy looked up at his grandfather and said, "No, I'm not lost. I'm with you."

No matter what may happen to us in the world or where we find ourselves, the Lord is with us. And when Jesus is with us we are never lost. The Bible says, "He is our light and our salvation, of whom should we be afraid?"

If you want GOD'S light to shine in you, there are places and attitudes where changes have to be made. Some of us are so caught up in habits, practices and our possessions that there is not room for the Lord in our lives. We are more controlled by what we have and possess. The light also reveals "the pointed finger." It is so much easier to justify ourselves while judging others. Having just gone through a difficult political season in our country, how much more urgent it is that we pay attention to our attitudes in light of the Christmas message.

Third, the point of the Christmas message is not simply that light came into the world or that it has shone into our lives, but rather, that God wants His light to shine through us. One day in a sermon the Pastor asked, "what is a saint?" A little boy looked up at the stained glass windows of the apostles and blurted out, "People who let the light shine through!"

John the apostle said, "In Him was life, and that life was the light of men. The light shines in the darkness, but the darkness has not understood it." (John 1:4) Just as in that day, not everyone today will recognize Christ as Savior. Our job is not to force the Gospel on anyone, but to give witness of the light in our lives. What people do with Christ is up to them. One of the certain characteristics of all who have the light of Christ in their heart is to wish it for others.

In this season we should be especially prayerful for people of the world who have never heard of Christ or of the God who loved them so much He sent His only Son to die on the cross for their sins. They do live in a world of darkness without eternal hope. My prayer is that the light of Christ might be reflected from us into our culture and to the extremes of the earth so that no one will ever miss the opportunity to know the One who is the Light of the World.

One day Jesus Christ will pull back the curtain of time and space, then the light of His presence, the glow of His glory and the brilliance of His splendor will radiate forth as He breaks the fabric of the eastern sky to reveal His eternal victory and claim His reward, His Church. Then we too will shine forth in the beauty of His holiness. I hope this coming transformation of His true church will include you also.

I WAS IN PRISON

I traveled to a Tennessee prison last weekend to visit a cousin. My sister engineered our trip, and we picked up our cousin's brother en route and had a nice day, despite the major purpose of our excursion. I

learned that other family members had been reluctant to go through the process of approval and to visit.

I remembered once hearing a radio host fielding a call from a lady who'd distanced herself from relatives who had a family member in jail.

"I don't want to be around them and I don't want my children around them," she said.

Surprisingly the host agreed.

"This inmate made a bad choice and you have to shield yourself from the family," she said. "I agree with you."

I was flabbergasted at this exchange, and honestly felt the host was out-ofline.

I was a regular Bible teacher at Bibb County Correctional Facility in Brent for a number of years when a long-time friend was named chaplain. I met Bob Hall in Brent; he was director of the New Orleans Baptist Theological Seminary's Birmingham extension. Bob recommended me to the North Georgia extension that sponsors a program in the Phillips Prison in Buford, Georgia, and I've taught two classes there in recent years.

All of that to say that most of the men I meet in prison are remorseful. They've missed so much in life that can never be replaced. One inmate told me he was incarcerated when his son was 10, and his son had recently come to visit him on the boy's 18th birthday. Stanley was in tears when he said his foolishness made his son grow up without a father.

We mustn't forget that Jesus said, "I was in prison and you came to visit me" (Matthew 25:36). It's striking that for believers, serving those in prison is serving Christ.

One mark of Christian grace is not only showing kindness to people in prison, but also showing kindness to former inmates. Jesus taught us to welcome those who messed up. In the story of the Prodigal Son the father received the disobedient son with joy, while the elder brother received him with disdain. I think we'd want to be more like the father than the brother.

Some inmates will live with state-imposed restrictions the rest of their lives. Churches must respect these restrictions and sometimes put safeguards in place depending on the offense, but other than this, every church ought to be a place where prodigals can come and worship and feel safe.





Restoring Civil Debate

to who yells the loudest or who has the best narrative or best meme or some other nonsense."

On a recent October evening, Supreme Court Justice Clarence Thomas spoke at The Heritage Foundation's Joseph Story Distinguished Lecture, just three days after the 25th anniversary of his swearing-in as an associate justice on the Court. Described as a "fearless originalist" regarding his defense of the Constitution, conservatives anxiously wait to see if the new Trump administration fulfills its campaign promise of appointing justices who will join Justice Thomas in upholding the principles as intended of that founding document.

As I listened to Justice Thomas comment on numerous topics, and specifically his reflections on the brokenness of Washington, DC, I wondered if he had any idea just how prophetic his words were in the aftermath of this election, except that the brokenness he spoke of isn't confined to our nation's capital. Our brokenness is reflected in the eroding of civil debate and each election cycle sadly demonstrates just how lacking we are in our ability to consider issues and policy without personal attack, or in the words of Justice Thomas, "we'll just simply annihilate the person who disagrees with me."* Further, as we're witnessing after this election, far too many believe that rioting in the streets and harassing the daily lives of other citizens with demands and threats regarding the Electoral College votes is justified behavior in protesting results they do not like.

Because many of our citizens lack for a proper understanding of the purpose and brilliance of the Electoral College in protecting all of us from the dangers of "mob rule" in a pure democracy, the frustration and anger we are now seeing on the left is easily manipulated by forces that care little for the preservation of our constitutional representative republic.

While I am of the belief that the majority of the anger towards our system of government by progressives is enabled and encouraged by the left-leaning direction of our education system, those of us on the conservative side aren't without our own unhealthy resentment of what we view wrong in our nation that can also discourage healthy debate. While those on the right aren't prone to street rioting, I see an abundance of social media shares of misleading or false information easily debunked if only we take the time to research the source, and sharing only serves to discredit us.

Our lack of civil debate leads to what Justice Thomas describes as "destroying our institutions" and in his opinion, "I don't think that's going to change in this city until we get back to sort of a notion that we argue, that we debate, that we decide things based on logic and facts and reason as opposed

I'll add that there is nothing in our current manner of electing representation that even closely resembles debate. Whether presidential or congressional, our "debates" are increasingly only sound-bite forums in which candidates take more personal shots at each other than having significant discussion on the issues. But how responsible is the electorate for these "debates?" We are willing to spend more time, effort, and money on our various forms of entertainment than we are on studying the serious issues we face as a nation, and as long as the sound-bite campaigns satisfy the masses, it's what we will continue to receive.

Our political divisions are hardly new as they have existed since the founding of this nation, only seemingly more intense and destructive with the introduction of social media, and I find myself wondering if our culture has reached a point where civil debate is beyond restoration. If so, the continuing escalation of the anger, name-calling, and division from both sides of the political aisle without civil discourse will likely destroy us from within.

The next four years with total Republican control of Congress and the office of President will be challenging at best given the level of anger from the left. and though tempting as it may be for those on the right frustrated by the past eight years of the Obama administration, it is crucial that we not return fire with fire. The next four years can offer conservatives an amazing opportunity, one truly of divine intervention proportions if we embrace it, to engage those who disagree with our conservative principles in respectful debate and persuasion regarding the policies that will be enacted. In leading by example, which will be a difficult task as the personal attacks will undoubtedly continue, we can hopefully begin to return to a more civil discussion of our differences.

As we celebrate the birth of our Savior, the Truth of God's Word revealed in human form, and praise Him for providing His divine mercy on our nation. let's take time to reflect on just what we can do individually and within our various associations with others to repair our institutions that have long survived in this great experiment known as America, as our freedom deserves nothing less than our absolute best effort of preservation for the generations to come.

The Good Old Days

The term "good old days" has been around for many years. Older people have and still do like to sometimes reflect on how much better their lives were at various times in the past than they are now.

The subjects are varied. They range from how much less things cost back then to how much less crime we had. For the most part, these things are true, but most of these people have not been able to comprehend the fundamental reason why few things have turned to the better and most have gone the other way.

One of the best decades of the 20th century began about 1952 (when the Korean War ended) and lasted until 1964 (when LBJ initiated devastating social programs and escalated the Vietnam War). Times were very good. America was the manufacturing giant of the world. Nearly

everything in the stores was made in the USA and was of excellent quality and reasonably priced. Most people held well-paying jobs. People had ample time for vacations and recreation. Crime was low. Welfare programs were minimal, so few people became addicted to them and decayed into deadbeats. Teenage and out of wedlock births were few, even among blacks, and when they did happen, they were severely frowned upon. The vast majority of children had both a mother and a father. Public education was of a much higher caliber than it is today, but its cost was much, much less.

Taxes back then were far lower than they are today. In Montgomery, the sales tax totaled only 3% - 2% state and 1% city. Today we shell out 10\%. State income taxes were much lower because the tax brackets were about the same as they are today, but a dollar then was worth about ten of today's dollars. A man who lived near Prattville had a 110 acre farm with a fine house, a barn, and other buildings—a property now worth over a million dollars. In the mid 1950's, he said to his wife, "It's time to pay our property taxes. Let's pick up some of our pecans and sell them." In about 30 minutes or less, they finished, took them to town, and sold them for enough money to pay the taxes—about \$10 or so. And yet, the quality of public services back then was superior to what we have now—in other words, keeping the roads in good shape, protecting us from criminals, and otherwise leaving us alone to pursue our happiness, unmolested.

Traffic fines were also much less: Running a stop sign was \$2, a red light \$5, speeding \$10, and reckless driving \$25. The top fine was \$100 for "drunk driving" (what we now call DUI). Multiply these figures by 10 to allow for inflation and compare them to today's fines.

There are a few things in life today that have greatly improved. Almost all of them are the result of developments in technology-communication and weather satellites, high definition television, digital photography, LED lighting, advances in medicine and health care, and perhaps the foremost modern asset of them all, the internet-the greatest educational tool that has ever been devised.

But with the exception of technology, however, life in America and most other parts of the world has gone downhill. The claimed reasons are manywar, hunger, overcrowding, depletion of resources, crime, terrorism, etc.

So what were the factors that caused this severe decline in the quality of life? People blame all kinds of things, but there is one root cause-government. Government is the villain that has spawned the aforementioned war, hunger, overcrowding, depletion of resources, crime, terrorism, etc.

In these earlier days, government at all levels made a much smaller impact onto our lives. The multitudes of oppressive, unconstitutional agencies and programs did not exist in anywhere near the quantities we have today. Health care was 100% private, but it was far more affordable than it is now. Public education was limited to the local communities and therefore far easier for parents to monitor. Draconian regulatory agencies did not exist. Businesses could hire the people they chose without being subjected to mandates to hire certain percentages of "minorities" or meet ridiculous safety regulations. People could live on and use their private property with no fears of goons stepping in and declaring that it was "unsafe" or a "nuisance."

Most of the government we had then was service oriented. Today it is mostly enforcement oriented, and more and more of that enforcement is for matters that should be left strictly alone. In earlier times, law enforcement targeted criminals-people who actually violated other people. Today it largely targets consensual "crimes" that have no victims and sometimes turns real criminals loose because the jails are full. And finally, American government meddling has spread to other parts of the world and has stirred up a hornets' nest of unspeakable horror.

Leaving things alone is a thing that all levels of government must learn. Meddling with a "problem"—real or imagined—almost always results in either making the problem worse or making a problem out of something that never was one.


And of course, we see one more reason we must never consent to more taxes. Instead, priority one should be cutting out the parts of government we are better off without.



If you mark out every passing day on your calendar, you will notice there is not much left to mark out. The year 2016 is coming to a close and what a year this has been. In the culinary world, Sous Vide cooking is becoming mainstream and affordable for home preparation. Southern Cuisine is still popular and has the attention of the up and coming chefs trying to put their mark in the restaurant world. Putting attention on making dishes healthier and using locally source products. This is my third December to write the article Southern Cuisine for the Alabama Gazette. Hopefully, I have had a positive influence in your cooking, menu choices and shopping habits. Oh, there was an election! Comments about the outcome and influence this election will have on the country have been about everything except how it is going to change the eating habits of Americans!

Since this is not a political op-ed article, I'll stick with the culinary topics. Even though I majored in Political Science, I get more satisfaction using my skills from my Chef's training and working for hotels with large banquet kitchens then I do watching a bunch of talking heads on TV talking over each other. I look forward to the food commercials!

It seems the topics of the commercials, cooking magazines, TV cooking channels and specialty cooking programs now showing are what to do with the leftovers from Thanksgiving, what to prepare for Christmas dinner and how to feed all the friends and relatives that are in your home between those two meals. My first reaction is to feed everyone the leftovers from Thanksgiving, but that won't make it all the way to Christmas. If it does, you made too much food in the first place also the leftovers would not be fit to eat if they were in the refrigerator for that long.

There is some enjoyment waiting for the leftover meals, for most people! I know friends and relatives that refuse to eat leftovers. My first reaction is "Alright, more for everyone else" But then, I think they are already bored eating the same food again. So maybe if we could "re-purpose" the food. I'm not sure if this is using the word correctly, but if the food was originally made for dinner, re-purpose it for breakfast. Not just cutting up and adding turkey to your eggs in the morning or making tacos, my favorite, out of all the leftovers. An example I have made and received good reviews is turning dressing into waffles. Waffles can be breakfast, brunch or even dinner and if you still get resistance about serving "dressing" again, freeze the waffles for another day.

The waffles won't be the "Belgium" waffle type with lots of syrup and whipped cream and fruit. These will be savory and the waffles could replace the English muffins in Eggs Benedict and replace the toast in a Texas Breakfast Sandwich or replace the biscuits for a Sausage Gravy Waffle. If you froze the waffles for later use, they would be perfect for Chicken and Waffles.


The original recipe I used came from *justataste.com*. The waffle is crispy and moist and tender. The original recipe is named Leftover Stuffing Waffles, but we don't serve stuffing below the Mason-Dixon Line.

LEFTOVER DRESSING EGG BENEDICT WAFFLES

INGREDIENTS

4+ cups crumbled leftover dressing

Notes: works best with a basic dressing, with no large chunks of vegetables or sausage, remove large pieces before cooking. And it will take longer to cook than regular waffles 2 large eggs for mix Chicken stock as needed 4 poached eggs 4 slices of leftover ham, heated Hollandaise Sauce as needed





in my bowl of oatmeal. And why ruin a bowl of cut up fresh fruit by putting whipped cream on it. Why can't I have a peanut butter, mayonnaise, cheese, lettuce, dill pickle, tomato, and mustard and jalapeno sandwich? I guess that is why I can mix foods that normally would not be served together.

And why can't I have leftover Thanksgiving Sweet Potatoes for breakfast?

SWEET POTATO BREAKFAST BOWL

INGREDIENTS

As much leftover Thanksgiving sweet potatoes you want. 1/2 banana

Preparation: 5 minutes Cook time: 1-2 minutes Serving: 1

METHOD

Dash cinnamon Toppings of your choice

1/4 cup milk



- **1.** Take leftover sweet potato and mash it up in a microwavable bowl. If you have mashed sweet potato leftovers skip the mashing.
- **2.** Heat for 1 to 2 minutes depending on amount and power of your microwave oven.
- **3.** In your serving bowl, mash up banana and add enough milk to make it extra mushy.
- 4. Add heated sweet potato and mix.
- **5.** Top with nuts, peanut butter, berries, coconut flakes, granola, syrup or any combination and amount you want.

Other ways to use up sweet potatoes is to whip them up into a pancake batter. Of course there is the sandwich. A way to eat pretty much anything you want all at once. In a sandwich I can eat my least favorite part of the turkey, the breast. The breast to me needs lots of help to eat as a leftover. You really have to think outside the box.

There is no wrong way to make a sandwich, so you can take these ingredients and put them between two slices of sourdough bread anyway you want to. I do it this way:

Spread a thin coat of Italian salad dressing on a slice of bread. Add slices of turkey breast. Make a mixture of half grape jelly and half steak sauce and spread on top of turkey. Add slices of Swiss cheese and then a layer of potato chips. Then top with the other slice of bread.

One thing that is leftover and usually thrown away but can be utilized for future meals is the turkey carcass itself. Put the carcass, some thyme and a little garlic, and half an onion in a big pot add some water and bring to a boil and then turn to a simmer for as long as you want to reduce the liquid and concentrate the flavor. Let cool and put in zip lock bags and lay flat in freezer to use next time you need a stock for a soup or sauce.

To show you are not trying to pass off nothing but leftovers and you want to introduce something new, try our favorite, Lemon Pie in a Jar! Besides the friends and family that love this, my colleagues at work are hooked! Simple to make, no baking, just the right size and easily transported.

There are many recipes for pie in a jar, some you bake, some you pre-cook the ingredients. This recipe is mix, make and chill.

ANNE'S MASON JAR LEMON PIE INGREDIENTS

8 ounce package cream cheese

much lemon flavor do you want)

Cook time: about 5 minutes

Yield: 4 waffles (I used a square 4 waffle iron)

METHOD

- 1. Preheat waffle iron and coat with cooking spray.
- 2. In a large bowl mix room temperature dressing, eggs and 1/3 cup stock.
- **3.** Keep mixing and adding stock until you end up with well-moistened mix that you should be able to spread over waffle iron in an even and thin layer.

The mixture will not spread out like a batter.

- 4. Close lid and bake until golden brown and crispy.
- 5. Break waffle into four pieces and place on 4 plates.
- 6. Top the waffle with warmed ham, then a poached egg and top with Hollandaise.

I have a recipe for Hollandaise Sauce in the December 2015 issue of the Alabama Gazette, from <u>The Pioneer Woman</u>.

When I was growing up, the family would sit down for dinner and we ate what our mother fixed. Even if the meal was "must go", everything in the refrigerator must go! There was no," I don't like this, will you fix me something else?" There was no option that I could eat mac and cheese every meal.

My extent of complaining about meals was limited to things like; there wasn't any meat in my mac and cheese, or "Vanilla ice cream again, if Baskin Robbins can have 37 flavors why can't I?" I do eat vanilla ice cream but only after I add chocolate syrup, nuts, jam, powered coffee, molasses, peanut butter or anything else I could find in the refrigerator or cupboard and then mix it all up until the ice cream has melted. And why can't I put those same ingredients





- Can sweetened condensed milk 3 egg yolks
- Teaspoon vanilla
- 1/3 to 1/2 cup lemon juice (how


Box Graham Cracker Crumbs Brown sugar One stick melted butter Cool-Whip

METHOD

- 1. Clean seven ½ pint mason jars and lids.
- 2. In a mixing bowl combine two tablespoons brown sugar to 2 cups Graham Cracker Crumbs.
- 3. Add melted butter (one stick) and mix well.
- 4. Place ¹/₄ cup of the mixed crumbs at bottom of each jar and tamp down to make smooth bottom crust.
- 5. In a separate mixing bowl, place cream cheese and beat until smooth.
- 6. Add condensed milk and continue until well mixed.
- 7. Add egg yolks and continue mixing.
- 8. Add vanilla and lemon juice and mix until smooth.
- 9. Then add about $\frac{1}{2}$ cup of lemon mix over the crumb bottom of each jar.
- **10.** Fill about to the bottom rind at neck.
- 11. Top the jars with Cool-Whip and place lid and ring on jars
- 12. Refrigerate at least 5 hours to set lemon filling.
- Serve cold

This is an easy dessert to make and can be altered many ways. Instead of the lemon filling, try pre-made canned cherry pie filling with the Cool-Whip topped with granola.


Yet, the very first Christmas seemed to do without any of these things. The very first Christmas somehow



Southern Gardening Potpourri for December by Peggy Givhan

The magazines shout that Christmas is near with colorful photos of tables groaning with turkeys, hams, casseroles, and fabulous desserts. Holidays in America and in the South do revolve around food and drink. And speaking of food, these make great gifts to neighbors, friends, and family. One such food gift would be Pesto which can be put in jars and the

tops wrapped in gold foil with ribbons to match The recipe is simple, adding about 2 cups of fresh basil and blended in the blender with a good extra virgin olive oil. There are many recipes on the Internet which include different salts, peppers, even butter.

There is no one that I know of who does not absolutely love the Christmas season. With a nip in the air, and maybe a slight freeze, we can bring a garden of blooms

We can force indoors. narcissus bulbs into bloom by putting them in bowls or vases with a layer of small stones of all descriptions placed in the bottom and covered with water. Also Amaryllis bulbs, which are on the market everywhere, is another bulb which is easy to force into bloom. If one desires tulips for the garden, they must be refrigerated for 6-8 weeks in the crisper of the refrigerator prior to planting. If planted without refrigeration, the blooms come right out of the ground with little or no stem. Weird looking. So if you want tulips, get the bulbs immediately, and plant them mid to late January. Inspect the bulbs before making the purchase as they are not cheap, many times about \$1.00 per

bulb. Mildew, mealy bugs, or rust spots on the bulbs could prove disastrous for the plant. And we would not want to introduce soil born organisms which play havoc with other flowers planted in the same area.

December temperatures are not usually much below freezing, but when the gauge indicates below 20 degrees, that is when we could have problems with cold damage to the roots of Azaleas. Not only Azaleas, but the cold problem can be

the same with other southern zone 8 flowering trees and shrubs. To be prepared, December is a great time to mulch with about 2 -3 inches Pine straw, pine bark of: mulch, and even leaves, piled up around the feet of these plants. So when we blow or rake up the fall leaves, spread them around under trees and shrubs and you will be ahead of the game.

For those of you who have talents that include flower arranging, here is an idea that I spotted in a fall magazine that really is stunningly beautiful and easy to produce. The asymmetrical flower arrangement included pine cones, Asian lilies, Cyclamen, Eucalyptus, and variegated ivy. Secure a footed dish about 10 inches high with floral clay and cover it will

different size pine cones. Then place the lilies, ivy, Eucalyptus and Cyclamen amongst the cones. Dried Poppy Seed heads, or other seed pods also add to the diverse, yet very pleasing design.
