

DRONES BRING NEW TERROR ATTACK FEARS

On July 16, 2024 a would-be presidential assassin grazed former President Donald J. Trump with a shot fired from a long rifle. Sadly, there is a long history of guns being used in political violence and terrorism. The new element was that the shooter scouted the whole scene hours earlier with a drone to analyze defenses, the terrain, and pick his location. What if he had used an armed drone to launch his attack? In the war in Ukraine both sides are using drones to kill people, trucks, artillery pieces, bunkers, aircraft, naval vessels, and even tanks. This developing technology brings new fears of what drones could potentially do in the wrong hands.

Drones have the ability to enable terrorists to conduct multiple attacks nearly simultaneously and the attacker does not have to ever be present at the scene of the attack so a terror attack would not necessarily be suicidal. Drones provide a terrorist with standoff capability and present a new challenge for law enforcement.

Since the early 2000s, the use of airborne drones by private individuals in a variety of fields has become commonplace.

Al-Qaeda has already attempted an attack in Pakistan using multiple drones but that was stopped by local law enforcement and ISIS used drones in its military operations in Iraq and Syria. Two Russian military bases in Syria were attacked by drone swarms in 2018 and Houthi rebels in Yemen have used Iranian made drones earlier this year to attack international shipping in the Red Sea and has even used them in attacks on the U.S. Navy.

A terror attack using drones on a political rally, an inauguration, or a civilian mass casualty event like an NFL stadium is a growing real concern for Homeland Security and law enforcement.

Alabama Politics has been affected by Presidential Assassination Attempts

America has a long

history of presidential assassinations and assassination attempts. The two most notable, as well as history changing,

were the assassination of Abraham Lincoln, our 16th President, and John F. Kennedy, our 35th President.

I remember vividly the sad and poignant saga of John F. Kennedy's assassination. It was a tragic event. The scenes are indelibly planted into the memories of those of us who are old enough to remember. A short time later his brother, Robert F. Kennedy, was assassinated while running for president. The 1960's was a tumultuous decade.

In recent decades, President Ronald Reagan was shot and recovered without any complications. Presidents Gerald Ford and George H.W. Bush were attacked. Closer to home, our own Governor George C. Wallace was mortally shot during a presidential foray, but remarkably survived, although he was left paralyzed.

Governor Wallace was in the middle of his third term as Governor of our state. He was known as the most ardent segregationist in the nation. He had parlayed this notoriety into becoming a national presidential candidate. He was garnering large and fervent fiery crowds on the campaign trail. He was speaking at a rally in a parking lot in Laurel, Maryland, in May of 1972, when a crazed gunman named Arthur Bremer shot him several times and pierced numerous vital organs. Most people would not have survived. He was hospitalized in Maryland for over a month with it being touch and go as to whether he would live or die. He barely survived, but it left him a paraplegic. He was confined to a wheelchair and in constant pain for the rest of his life.

This year's July 13th assassination attempt on former President Donald Trump, and the assassination attempt on George Wallace were very similar. They both were helped immensely, politically, by the bullets. Trump was leading in the polls due to the obvious cognitive decline of Joe Biden. However, Trump's resilience and quick defiant response was iconic. It has made him a martyr among Republicans.

The assassination attempt on Wallace also saved his political life and politics was his life. Wallace was not going to become the Democratic nominee in 1972, much less win the presidency. He was on a Don Quixote endeavor. However, being Governor of Alabama was his life and the bullets that riddled his body saved his political life.

Wallace had been elected Governor for his first term in 1962. He had ridden the race issue to his lifelong dream. He had won with the race issue. Big Jim Folsom was soft on the race issue and would not demagogue or race bait. Wallace was at the height of his popularity in 1966 and wanted a second term. However, the Alabama Constitution prohibited him from succeeding himself, so he ran his wife, Lurleen, in his stead. She won overwhelmingly. Wallace was actually Governor. Lurleen succumbed to cancer in 1968, and Lt. Governor Albert Brewer ascended to Governor for two years.

Wallace and Brewer clashed in the most titanic and bitter governor's race in Alabama political history in 1970. In that race, Brewer led Wallace in the first primary, largely due to a gigantic Black voter turnout. Black Alabamians had just been given the right to vote by the 1965 Voting Rights Act and they were taking advantage of that right.

Wallace came back with the most overt, racist campaign ads in American history, and edged Brewer out and captured the Governor's office for a third time. Wallace had been bitten by the presidential bug and ran in 1968. He was constantly out of state and not tending to being Governor. Brewer had wounded him with a slogan, "Alabama needs a full-time Governor." Wallace had pleaded with Alabamians in the 1970 runoff. He went to every city and hamlet in the state and swore that, "if you elect me Governor, I will never again leave the state and will stay home and be a full-time Governor." After his razor thin, come-from-behind, race baiting, "Full-time Governor" promising win, the next day he was on a plane to Wisconsin running for President.

Alabamians did not like this overt demagogic lie. He was not going to win the Governor's race in 1974. Brewer and newcomers, Attorney General Bill Baxley and Lt. Governor Jere Beasley, were all planning to run in 1974. One of them would have beaten Wallace. However, after the bullet wounds in Maryland, sympathy for Wallace was too great. The three Bs had to wait until 1978. The assassin's bullets severely ruined and limited Wallace's life, but saved his political life.

My point. I think it is time for the law makers in this country to consider rape as a capital offense. Sorry, but I believe this. At a minimum, punishment should be life with no chance of parole. It doesn't matter if the victim is a girl or boy, man or woman. You rape someone, you have forfeited your life. Until we as a nation decide that this crime is as horrific as it is, rapes will continue. They will. I cannot understand why we take such a light hearted view of rape. I will not.

Do I understand that Alabama Medicaid now attempts to recover from decedent estates?

Yes, that is correct. It is however conditioned on certain criteria and in my view will cause some changes in estate planning and in debt collection by creditors.

Whenever an estate is opened in an Alabama probate court, the named personal representative whether appointed for a testate (having a Will), intestate (no Will) estate or the person initiating the settlement of a Small

Ronald A. Holtsford Estate (with or without a Will where the probate assets are limited by law), must file a specific document with Alabama Medicaid and file an affidavit of notice along with a copy of the Medicaid document with the Probate Court. This document must be filed regardless of whether the deceased person did or did not use Alabama Medicaid. Alabama Medicaid has thirty days in which to respond.

And it's not just confined to Alabama Medicaid in general. The criteria is that the deceased must have received Medicaid at or after age fifty-five (55) and/or that the Medicaid assistance was in long term or nursing home care and/ or while receiving Medicaid assistance a special needs trust was used. The age constraint means that even though someone may require Alabama Medicaid for instance in a nursing home prior to age fifty-five (55), it's only the Medicaid usage from age fifty-five and later (if used for that long) that is countable towards recovery.

If Alabama Medicaid finds the deceased in their files, then they will determine how much Medicaid paid for services at or after age 55. Medicaid waiver programs are not countable. It will be interesting as this fleshes out since it only became effective a few years ago for estates filed after September 1st, 2019. For starters a Medicaid recipient can have no more than two thousand dollars in assets. However, at application and throughout the assistance there are exempt items such as an automobile and rented land worth no more than six thousand dollars. Certainly after death there is no need for those items and I would think they would be eligible assets that would have to be sold for recovery. When an institutionalized spouse leaves a spouse living in the marital home, it is an exempt asset as long as that spouse remains in the home. There is a cap on the value of the home of over a half million dollars. I would guess that after both spouses have died, assuming the last to die is in the marital home then half of the home value is probably available for recovery. A self settled special needs trust already has the requirement that Alabama Medicaid have a payback provision up to the amount expended on the person, but a third party settled special needs trust for the Medicaid recipient should not have a payback provision and instead has contingent

beneficiaries. I have to wonder if there is any push to try and access those assets. There are some unknowns and Alabama State Bar members affected by this are working now to understand the exact implications of this program.

Though there are differing camps on estate planning, I generally favor a Will over a Trust because of the Trust cost to the client, the fact that assets such as vehicles, bank accounts, investments and the home must be placed in the Trust and that a Pour Over Will is done in case there are assets that need a legal transfer and are not a part of the Trust for some reason. The use of Trusts or other instruments that circumvent probate, may become more important. Though I have not yet noted it, a certain segment of my estate planning clientele will need further discussion on what to do.

This law also places Alabama Medicaid, sixth in the line of things that must be paid before creditors are paid. Some of the items that precede Medicaid recovery include the cost of burial, estate administration, taxes of employees, etc. The thing to consider is that some 75-80% of Alabama nursing home residents are on Medicaid with an average stay of about two years. The cost rises each year, with Alabama Medicaid paying a part of the more than \$6,000 per month per resident. With Medicaid recovering whatever may be left, I would assume that creditors generally have little recourse for those individuals since one assumes that whatever part of the estate may be available for debts (remember that family members have no personal responsibility for debts of a decedent) may be completely "taken" by Medicaid. This is not derogatory towards Medicaid and I understand that the program must be run as a tight ship and I also understand that individuals must bear personal responsibility in their care during life. I have no details but I wonder if creditors have tightened up credit limits or become more selective on whom they extend credit to if they feel there is a lesser chance of repayment.

The case was settled, or so I-Ship's CEO thought. Twenty three months later, he received a notice from his insurance company that it had been slammed with a \$350,000 lawsuit—for WHAT?

Somehow, the UPS driver had decided he could cash in his little fender bender for a quick fortune. He had called Georgia's Queen of Torts, Glenda Mitchell, a female version of ambulance-chaser Alexander Shunnarah, to file a frivolous lawsuit for, as yet unidentified "damages." What damages? Did he suffer a \$350,000 hospital bill from a 3 mph impact on a fiberglass hood?

Apparently, I-Ship's insurance had paid the \$350,000 without any contest. WHY? It was obviously frivolous. WHO made the judgment, and for what? WHO decided on \$350.000? WHY was there NO contest? Col John Eidsmoe

Well, maybe that's an exaggeration. I learned a lot teaching and practicing law, but my law student experience consisted mostly of left-wing theories I've had to unlearn.

But way back in the early 1950s, in Whittier Elementary School of Sioux City, Iowa, I sat in fourth grade under Miss Mildred Terhune, the strictest and best teacher I ever endured.

When she wasn't disciplining me for whatever mischief I could concoct, she taught me the Bible (this was before Abington Township v. Schempp of 1963, not that she would have cared). She taught me American history. And she taught me the Constitution.

The Constitution, she said, establishes three branches of government. One branch (Congress) passes laws. Another branch (the President) enforces laws. And the third branch (the Court) interprets laws. When I wasn't off daydreaming in Eidsmoeland, I listened, and sometimes I understood.

When a similar lesson came up in the schools of Pennsylvania and Delaware, Joe Biden must have been playing hooky. So was Kamala Harris – or maybe she had been sent to the principal's office for excessive cackling. They seem not to have learned that administrative agencies under the Executive Branch of Article II are not to engage in legislation. They may with strict limitations adopt regulations for applying laws, but they may not pass laws; that is the responsibility of Congress.

Biden/Harris (and I use both names because Kamala Harris cannot evade responsibility for the Biden record, much as she would like to) and their Radical Left allies have, as of July 2, 2024, signed 139 executive orders, 190 presidential memoranda, 629 proclamations, and 129 notices. While the number of executive orders is fewer than those signed by President Trump, many of Biden's orders expand federal power while Trump's orders deregulated the economy and limited federal power. Furthermore, many of Biden's presidential memoranda are really executive orders under the guise of memoranda, issued as memoranda so the Administration does not have to meet the legal requirements for adoption of an executive order, such as pre-publication and public comment. In so doing, these regulations violate the basic constitutional principle of separation of powers.

On no less than five occasions, the U.S. Supreme Court has struck down the Biden/Harris Administration's regulations as usurping the authority of Congress:

(1) National Federation of Independent Business v. OSHA (2022). Biden and Harris wanted to force all Americans to undergo COVID-19 vaccination whether they wanted it or not and whether they needed it or not. It is questionable whether Congress has the authority to impose vaccination, but in any event, Congress chose not to do so. So Biden/Harris ordered the Secretary of Labor to adopt a regulation through the Occupational Health and Safety Administration (OSHA) requiring all employers with 100 or more employees "to ensure their workforces are fully vaccinated or show a negative test at least once a week." This would have affected about 84,500,000 employees. The National Federation of Independent Business challenged this regulation in court.

The Supreme Court ruled that OSHA had been created by a 1970 Act of Congress, and therefore OSHA had only the powers delegated to that agency by Congress. Congress had delegated to OSHA the power to regulate "work-related dangers," but COVID was not a danger specifically related to work. Therefore Biden/Harris and OSHA exceeded their authority by adopting this regulation. The Court therefore held that the mandatory vaccination rule was invalid. Note: This issue in this case is not whether COVID vaccination is good or bad, effective or ineffective. The issue is whether an unelected administrative agency may force vaccination. The Court held that it may not.

(2) Next, in West Virginia v. Environmental Protection Agency (2022), the Supreme Court struck down portions of the EPA "Clean Power Plan" (adopted by the Obama Administration but defended by the Biden/Harris Administration) that mandated emissions reduction technology and, in some instances, shifting to solar and wind power. West Virginia and other States challenged this regulation in court, and the Supreme Court held that Congress had not delegated power to the EPA to promulgate or enforce regulations that impose such sweeping changes in power production. Because the EPA had exceeded the authority delegated to it by Congress, those regulations were held to be invalid.

Note again: The issue is not whether emissions controls or shifts to solar and wind power are good or bad. The issue, rather, is who has constitutional authority to mandate such changes. If any branch of government has this authority, it is Congress, and Congress has not delegated this authority to the EPA.

(3) The following year, the Court again slapped the hands of Biden/Harris in Biden v. Nebraska (2023). In a brazen attempt to buy votes, Biden/Harris adopted

a student loan forgiveness plan. But once again, the Supreme Court invalidated the plan, noting that Congress had created the student loan program and had not authorized the Department of Education to forgive or modify loans except as provided in the Act. Because the Biden/Harris loan forgiveness program exceeded authority delegated to the executive branch by Congress, the program was held to be invalid.

Again: The issue is not whether student loan forgiveness is a good or bad idea. Many complained about the unfairness of requiring the taxpayers as a whole, many of whom could not afford to go to college and others of whom had already repaid their loans, should be required to subsidize these privileged few by paying their loans for them. The issue, rather, is who has authority to adopt a student loan forgiveness program — Congress, or the Biden/Harris Administration? Again, that is the authority of Congress.

However, Biden defied the Supreme Court with a slightly modified plan that will cost the taxpayers at least \$870 billion. That plan, too, has recently been struck down by the Eighth Circuit, but the same day the Circuit made its decision, Biden/Harris announced another loan forgiveness program. We'll see where that goes.

(4). In Loper Bright Enterprises v. Raimondo (2024), the Court dealt another blow to the Biden/Harris Administration, holding that courts rather than administrative agencies must interpret federal laws. Over the past century, administrative law has grown exponentially, with OSHA courts, tax courts, and other "courts" established by administrative agencies that operate under the Executive Branch rather than under the Judicial Branch. In its 1984 Chevron U.S.A., Inc. v. Natural Resources Defense Council, Inc. the Supreme Court boosted the power of administrative agencies, holding that courts must give deference to an administrative agency's interpretation of an ambiguity in the law. This means that when an individual or a business challenges an administrative agency in court, the agency usually wins. But in Loper the Court overruled the Chevron deference doctrine and held that administrative agencies are no longer entitled to such deference. Rather, courts must give more consideration to arguments raised by those challenging administrative interpretations.

Again: The issue is, who interprets the law – administrative agencies, or courts? The Constitution, Article III Sec. 2, says that is the duty of the courts. The Supreme Court agrees.

(5) Most recently, in the companion cases Department of Education v. Louisiana and Cardona v. Tennessee (2024), the Court has once again ruled that Congress, not the President or his agencies, has the authority to adopt laws. In 1972 Congress enacted Title IX, an education statute that prohibits sex discrimination in schools that receive federal funds. But the Biden Administration has adopted administrative regulations that essentially rewrite Title IX. The new rule redefines sex discrimination to include discrimination based on sexual orientation and sexual identification. This means public schools must allow biological males to dress and undress and shower in girls' facilities, and much more.

Several states challenged this rule, saying it misinterprets Title IX which forbade sex discrimination relating to biological males and females, not those who self-identify with a different gender. Five federal district court judges ruled in favor of the states and enjoined enforcement of the Biden/Harris rule. And now, the Supreme Court has upheld their injunctions, saying Biden/Harris have failed to demonstrate that they have authority to change a law adopted by Congress. *Note: Congress, not the President, makes laws. President Biden and Vice-President Harris, what part of Article I do you not understand?*


I'm not just splitting hairs. The separation of powers into legislative, executive, and judicial branches is essential to maintaining our constitutional system of limited government. Once one branch succeeds in usurping authority granted to a different branch, we are well on the path toward dictatorship. Biden/Harris, not Trump/Vance, are the real threats to democracy.

Back home in Sioux City, Whittier Elementary School closed a few years ago, and the old building is now used for apartments. Miss Terhune, God bless her, has gone home to be with the Lord. But the principles of government she taught us remain, because they are enshrined in the United States Constitution. There are three branches of government. Congress passes laws. The President does not. Nor does the Court.

Thankfully, the majority on the Supreme Court seem to understand that – at least for now. But who will appoint and confirm the next Supreme Court Justices?

Joy to the World or Joy to the Left Kamala's Economic Nonsense Unveiled!


Remember that old Three Dog Night hit, "Joy to the World"? You know, the one

Rigged Elections: Primary Coups & General Racketeering

Last month's column closed with 'money mill parasites' driving our political outcomes. When the Republican Party told Trump they wouldn't pay his mounting legal bills (remember, DJT is a big government modern Democrat, currently 'donning' the Red jersey who donated to fellow soviets like Kamala Harris) he made overtures to the Libertarian Party. Money mill parasites don't care how donations are spent, or the outcome as long as they get their cut. Donations with the Biden crime family

at the top of the ticket dropped sharply. Dramatics to re-prime the money mill and keep political Kabuki Theatre in full shriek is the usual formula... staging a close duopoly race until this election cycle's racketeering ends Tuesday, November 5th.

The 'primary coup' is complete with Harris, Trump, et al political masters calling the shots. Alabama taxpayer money, voters' time and effort were all for naught seeing the process and decision cast aside as money mill parasites directed. Some readers recalled https://www.alabamagazette.com/story/2024/03/01/opinion/trump-ballots-primary-corruption-and-general-collusion/2801.html explaining no shortage of disagreement on what constitutes a 'coup' or 'insurrection' in State cases w.r.t. ballot access for Mr. Trump. State provided primary ballots subsidizing Alabama's soviet parties is nothing new in strongly duopolized Alabama.

Some reports touted recent Trump ballot access decisions historic. Maine's Secretary of State [Shenna Bellows] was the first to remove a presidential candidate from their State's ballot 'unilaterally' (12/29/23 Denver AP report) as a top election official (mis)using the 14th Amendment's Section 3 insurrection clause. Even more vulgar, Maine is one of those States unconstitutionally splitting electoral votes - i.e., just one of Maine's 4 electoral votes may make a difference in razor close Electoral College outcomes. The AP report also noted Maine's "unusual process in which a secretary of state is required to hold a public hearing on challenges to politicians' spots on the ballot and then issue a ruling. Multiple groups of Maine voters, including a bipartisan clutch of former state lawmakers, filed such a challenge, triggering Bellows' decision."

Most Trump ballot access lawsuits were dismissed by courts asserting no authority over party primaries. True in States which do not subsidize party primaries, but Alabama taxpayers provide our primary elections. Effectively 'fund-raisers' for Democrat/Republican Parties, candidates pay their duopolist (usu. a function of the office's salary) for ballot access. Alabamians are not obliged to provide PRIMARY elections as is true with GENERAL elections to satisfy Article 4, Section 4 requirements of the US Constitution guaranteeing our representative republic. Candidate payments to duopoly parties are not remitted to our Alabama Dept. of Treasury to offset expenses of primary elections using government resources; these collections are KEPT by our Blue/Red soviet parties. This anti-competitive wealth transfer is difficult to defeat, write-ins often aren't allowed on primary ballots where any candidate(s) could 'sneak by' and access general election ballots without paying 'protection money' to our political gangs.

While our Secretary of State had no trouble eliminating a general election to install Felon Hubbard's desired replacement, he failed to eliminate clearly ineligible candidates in other races. If our State was not paying for primaries, parties may submit any candidate, legal or illegal; there's no Secretary of State 'oversight' role. The Secretary's office would later remove those determined ineligible on the general election ballot our State is obliged to provide. Voters still may write-in someone ineligible by State law who shall be removed after general elections proffer ineligible winners. Sadly, Secretary Merrill seemed exasperated at times with our corrupt ethics commission who did little to discipline duopoly candidate/party malfeasance.


General election racketeering in our State, with some of the most restrictive ballot access laws in the nation further aids and abets our uncompetitive, unrepresentative results. Will Trump be removed if installed again? - the next rigged, unconstitutional result will certainly install another duopoly thug as the general election winner. Extremely unlikely our State (or any other State) will make a racketeering case upon installing Harris on their general elections ballots by improper process. Rules do not (or selectively) apply to duopoly party thugs. Other readers recalled the September 2022 column on the next step in stealing elections in Alabama via closed primaries [https://www.alabamagazette.com/story/2022/09/01/opinion/stealing-elections-in-alabama-next-step-close-primaries/2414.html] being championed by our Blue and Red soviet parties.

If Democrats/Republicans want to determine their general election candidates submitted via convention, election, pin the tail on the Donkey/Elephant, smoke filled room... you get the idea, as a PRIVATE entity on their own purse - great! Pay for your own convention facility, use your own voting machines or rent our public ones at documented cost, buy your own Donkey/Elephant board... then the party as a private entity can decide (degree of open/closed) participation however they please. Once a party takes taxpayer money to purchase the facility, voting machine, smoke blower, etc. then citizens have the right to access/vote in every primary determination they're subsidizing. The set deadline for ALL candidates to be placed on our general election was August 23, 2024. In an unsubsidized election, each candidate must submit uniform payment to be listed on the actual/general election ballot; an amount determined by the marginal expense(s) of placing another candidate printed/counted on ballots in excess of the fixed cost taxpayers are obliged to pay. This would eliminate the waste of candidates collecting and voters signing petitions which bureaucrats must then also waste their resources and time verifying. No doubt our soviet parties will despise disempowering their duopoly and losing this protection of their hyper-gerrymandered political gang turf.





Foundations for Freedom

"Experience must be our only guide. Reason might mislead us." So said John Dickinson at the Constitutional Convention in 1787, some 237 years ago this month.

As we celebrate the birth of the United States Constitu-

tion, Dickinson's admonition is critical to understanding our Founding Fathers' thoughts that served as the basis for our constitutional government.

Our Constitution, revered my many, detested by some and imitated worldwide, has stood the test of time. Even with disputes about its meaning and debates about its interpretation, its framework for government still works.

This document was not the product of political scientists or academicians with surveys and samples of how to form a government. Rather, the Constitution was an expression of the colonial experience based on the British structure of government which had enabled the American colonies to develop. Indeed, the constitutional framework was a distillation of the best of the British view of society, rule of law and government, stripped of the dross of monarchy, parliamentary overreach and the elitism of a ruling class.

Our founding fathers had been educated in English schools permeated by practical views of liberty, constitutional government and the common law. From the framework of how the colonies were governed and how colonial society was ordered, there was little innovation; the colonies mirrored the best practices of British society.

Most of the colonists would have been content to remain loyal subjects had Parliament not aggressively attempted to regulate colonial life and enforce impractical legislation on commerce and trade. The mercantile system, for all its economic faults, benefited the mother country by transferring great wealth, but as the cost of maintaining an empire grew, Britain was not content to reap the benefits of trade and sought to impose direct taxation.

The result was to unite what had been 13 separate and distinct colonies, challenge them to consider self-government and foment a revolution that resulted in

independence. And, while achieving independence was celebrated wildly, cooler heads realized that with military victory, the easy part was over and now began the hard part of governing.

From the end of the Revolution until the enactment of the Constitution, great debates resounded throughout the colonies to determine how the states might act in concert, what their inter- relationship would be and how they would trade with other countries.

During all these debates, discussions and decisions, no one proposed a new or innovative system of governance. Rather, they harkened back to the tried and true of the colonial experience and used that as the basis for their Government.

One overriding concern was to clearly define how any new government would work. If there was one problem that stood out, it was that the English Constitution was not written down. Even today, students of government are shocked to learn that the English Constitution is not expressed in words on a page, but it is comprised of various traditions, court rulings and legislation from tensions between Parliament and the Monarchy.

Not having a written constitution was a liability when the colonists argued about their "rights" in the dialogue that created the various misunderstandings with Parliament. What rights did they have? The colonies were formed from separate charters granted by the reigning monarch, but the charters weren't documents that created or defined rights. From the colonist's viewpoint, Parliament was a nuisance, but at several thousand miles away, it could do little. And what it could do, the colonists ignored, until they sent troops!

But once the states were in charge, defining government took the English traditions and attempted to express them in a minimal sense as a framework going forward. Initially, most of the constitutional work took place on the state level with each state working to reduce to writing how their government would be organized. This was much easier since the states and their various communities of interest had existed before the Revolution and their institutions of government were already expressed in some form.

The unique challenge was how to create a national government. The Continental Congress had some authority, but Washington's victory was achieved

despite that body. Articles of Confederation were tried, but these failed miserably to create a cohesive government to produce stability and foster economic growth. The states initially prospered, but having 13 separate taxes, trade restrictions and currency retarded interstate growth, and with no organized national defense and no comprehensive foreign policy, the division of states' power would limit progress and ultimately liberty.

So, in creating a national government, any number of issues had to be addressed. Resolving disputes between the various states and deciding questions about power in government required an exemplar; an appeal to something to support an idea. The delegates had two choices. They could base their new government on their previous experience and use these patterns and practices to develop a national government, or they could appeal to philosophy and the enlightenment theories of government, rights and liberty.

Dickinson's expression conveyed his belief that government based on any theoretical notion was unsound. Rather, he suggested that the new government must be based on practical ideas that worked and resolved problems. He did not view the Constitution as a lab experiment in combining various theories to achieve a result; rather, he wanted a form of government to provide a foundation for the states and the people of each state to produce a framework of limited government, expansive liberty and economic prosperity. In short, he did not see the Constitution as giving rights, but as defining rights already enjoyed and which the colonists had previously experienced.

If there was anything unique in our Constitution, it was creating three co- equal branches that would intentionally limit the power of government. The national government was designed to respect rights that already existed, not create ill-defined rights that could never be enforced.

Dickinson's admonition rings true today. Rather than be guided by theories, academic speculation or international reports, responsible government should look to past experiences and benefit from the tried and true.

Dixie's Football Pride



In 2022, an invented controversy arose concerning the word Dixie. Individuals supposedly associated with the University of Alabama felt the word did not belong in the UA Fight Song. Dixie, the traditional name for the South, appeared to be fine in the typically raucous Dixieland Delight.

As I referenced in a previous article (August 2020), the word Dixie is generally thought to have originated from the French word "dix," which referenced a \$10 bank note. It morphed into the land of Dixies. For example, the old TV Show, The Adventures of Jim Bowie, has several episodes where financial transactions are made using Dixies.

After the unsuccessful War for Southern Independence, Southern States were occupied and held under martial law for about a dozen years—the South was severely punished for seeking independence. One version of history contends the Southern States agreed to support Rutherford B. Hayes in return for his removal of the occupation troops. Military subjugation of the South was a catalyst for the Posse Comitatus Act of 1877, which disallowed federal troops from being involved in domestic affairs.

As the South tried to rebuild within Lincoln's new involuntary union, economic and political abuse continued. Nonetheless, the region was disproportionately represented in the military. Southern soldiers were suitable for the wars instigated by the corporations and bankers but they dare not believe in a voluntary union. Despite the boot heel paced on the South, many strides were made. One was that of perception and sports became a rallying point.

The University of Alabama (UA) has a long legacy of championship football. Beginning with their first team in 1892, UA has taken great pride in athletic endeavors. The stream of good to great coaches includes Xen Scott, Wallace Wade, Frank Thomas, Red Drew, Bear Bryant, Gene Stallings, and Nick Saban. Within that group one of Coach Wade's teams made a significant impact on Alabama football and Southern football in general.

In the 1920s Southern football was generally considered inferior to other regions of the country. Although it sounds odd today, early powerhouses included Harvard, Yale, Princeton, Army, Navy, as well as traditional powers such as Notre Dame and Southern Cal. Coach Wade's 1925 Alabama Crimson Tide went 9-0 during a dominating regular season and was chosen to face the powerhouse Washington Huskies in the 1926 Rose Bowl in Pasadena.

The Alabama team was given almost no chance of winning—the cynical Will Rogers labeled the Alabama football team as "Tusca-losers." Despite the cynicism, support for the team was incredible. On the train ride from Tuscaloosa to the West Coast, fans cheered the team from Southern State to Southern State. As noted by Ted Miller, Alabama, like other Southern teams, was "subjected to regional elitism and snobbery" and "many from the South chose to view the game as a re-enactment of the Civil War, with the team from Seattle representing the

Yankees and Northern aggression -- historical and geographical accuracy be damned."

Alabama's Johnny Mack Brown, "the Dothan Antelope," pondered how "a bunch of farmers" could compete. The heavily favored Huskies took a 12-0 lead into halftime with their star, George "Wildcat" Wilson, aka the "Purple Tornado," leading the way. His use of excessive force while tackling Alabama's Brown (later a movie star) brought on retaliation from Tide players and Wilson was temporarily knocked out of the game.

At halftime, Wallace Wade lamented "and they told me Southern boys would fight." Accepting the challenge, Alabama dominated the third quarter and came back to take a 20-12 lead with Pooley Hubert scoring the last touchdown. Wilson returned to action and led his Washington team to within a point of Alabama. The "pluck and grit" of the Alabama team swung most of the Pasadena crowd to shift allegiances to the underdog Tide. A game saving tackle by Brown on a Wilson breakaway and a couple of late interceptions sealed Alabama's 20-19 victory, considered a stunning upset.

Brown remarked Alabama "won the Rose Bowl for the whole South." At every stop on the train ride back to Tuscaloosa, the team was celebrated with crowds, bands, and congratulatory speeches. Birmingham News sportswriter Clyde Bolton described the results: "The 1926 Rose Bowl was without a doubt the most important game before or since in Southern football history."

Auburn's Fight Song references "Power of Dixieland" and mentions Dixie in the alma mater. Georgia's Fight Song includes "Hail to Georgia, down in Dixie!" Ole Miss' Fight song references Dixie's synonym with "the Southland's pride."

To this day "most" (certainly not all) SEC fans cheer for their sister schools when playing outside opponents. This goes back to the regional identity of native Southerners, who, by and large, are similar people of a unique culture whether they live in Virginia, Texas or any point in-between.

WHY IT'S IMPORTANT TO TELL US ABOUT CHANGES WHEN YOU GET SOCIAL SECURITY BENEFITS

If you receive Social Security, you can help to make sure we pay you the right benefit each month. You can do that by telling us about relationship or other life changes that could affect your eligibility for retirement, survivors, or disability benefits – or the benefit amount.



Master Sergeant James L. Berdeaux: Age 74



Master Sergeant (MSgt) James L. Berdeaux served 24 years in the U.S, Air Force. His Air Force Service Code (AFSC) included Security Police and Aircraft Control and Early Warning Radar. His medals, badges citations and campaign ribbons included: Air Force Unit Award, AF Good Conduct Medal with three oak leaf clusters, Air Reserve Forces Service Medal with three oak leaf clusters, National Defense Service Medal with two bronze stars, Vietnam Service Medal, Air Force Overseas Ribbon Long Tour, Air Force Overseas Ribbon Long Tour, Air Force Longevity Service with five oak leaf clusters, Armed Forces Reserve Medal with bronze hourglass and with one bronze "M" device, USAF NCO Professional Military

Education graduate ribbon, Small Arms Expert Marksmanship ribbon, AF Training Ribbon and Republic of Vietnam Campaign Medal.

MSgt Berdeaux was born June 26,1950 in Montgomery, AL, to his parents, James E. and Betty J. Berdeaux. Although his family moved often until he reached junior high school, he was educated at Alabama Christian Academy at Montgomery, AL, graduating in May 1968.

MSgt Berdeaux volunteered for military service, and his service began July 17, 1968. He reported to Lackland Air Force Base (AFB), TX, where he completed 12 weeks of Boot Camp. He then completed eight weeks of training at the Security Police School at Lackland. His first duty station was at Minot AFB, North Dakota, where he worked in security for three months. Next, he transferred to Keflavik Naval Air Station, Iceland, for one year. This was followed by a tour at Ellsworth AFB, South Dakota, for three months. He then volunteered for service in Vietnam, and he served for 12 months in Southeast Asia. Upon his return from Thailand, he was assigned to MacDill AFB, FL, for five months. He was discharged from military service in May 1972 and then reenlisted January 29, 1973. Using the G.I. Bill, he earned a B.S. Degree in Criminal justice from Troy University in Montgomery, AL in 1976. Upon reentry into the military, he completed seven weeks of training at the Aircraft Control and Early Warning School at Kessler AFB, MS. He then served at Myrtle Beach AFB, SC, for five months as a radar technician. Next, he served at Wheeler AFB, HI, where he identified all aircraft inbound to the islands for

three years. This was followed by service at Eglin AFB, FL, while assigned duties in the Armament Development Test Center. He was discharged in June 1977. In January 1990, MSgt Berdeaux joined the Air Force Reserve in his former AFSC which was Security. He was recalled to active duty in November 2001. Upon reentry into the military, he completed seven weeks of training at the Aircraft Control and Early Warning Radar School at Keesler AFV, MS. He then served at Myrtle Beach, AFB, S.C., for five months as a radar technician. His AFSC changed back to Security, and he served the remainder of his military service at Maxwell AFB, AL, until he retired from all military service September 29, 2002



Following his miliary service, MSgt Berdeaux was employed as a territorial sales representative with Weaver Paper Company calling on the printing trade and office supply stores. Since 2010, he has been the owner of Berdeaux Sauces. He inherited the recipes from his grandfather, Rufus White, the chef at the Pickwick FBQ Café in downtown Montgomery, AL, during 1900-1949 and owner of three restaurants in Prattville, AL, during the 1940's. MSgt Berdeaux had a taste for the sauce business long before he started selling it. The former Air Force Master Sergeant grew up in the River Region eating barbecue with a homemade sauce cooked up by his grandfather. When he died, he handed down the recipe to his family. MSgt Berdeaux had spent years giving the sauce away in Mason jars to friends old and new. After retiring, he decided to bottle that sauce, and then he used it as a base to create more flavors for different types of food — Vintage Revenge steak sauce, Simply Creole barbecue sauce and Sweet Island cocktail sauce that are chemical free with no preservatives.

MSgt Berdeaux and his wife, Gloria, have been married 46 years, and they have four children. He is a member of the Vietnam Veterans of America Chapter 607 and the VFW Smith-Wayne Pose 96.

MSgt Berdeaux's conclusions about his military service are: "Serving in the military instilled a spirit of patriotism that nothing else could match."



Sergeant Robert Clifton Fell: Age 48





Sergeant (Sgt) Robert Clifton Fell served four years in the U.S. Marine Corps. His Military Occupational Specialty (MOS) was Helicopter Power Plant Mechanic. He received the following medals, awards, decorations and citations: Rifle Expert, Good Conduct Medal, NATO Medal, Armed Forces Service Medal, National Defense Service Medal, Sea Service Deployment Ribbon with one star and Letter of Commendation and Meritorious Mast which is given for personal performance that is considered noteworthy or commendable beyond the usual requirements of duty.

Sgt Robert Clifton Fell was born September 4, 1975 in Rocky Mt., North Carolina, to his parents George and Sandy Fell. He was reared there for nine years and then in Fraser, CO, which is best known for thrilled filled sledding and snow-tubing at

Fraser, CO, which is best known for thrilled filled sledding and snow-tubing at the Fraser Snow Trail and Colorado Adventure Park. He enjoyed those sports as well as skiing at Winter Park Ski Area and playing basketball. He signed up in the delayed entry program early in his senior year and graduated from Middle Park High School in May 1994. His family has a long history of serving in the military with an uncle and a cousin serving in the US Navy, an uncle serving and retiring in the US Airforce, and one cousin serving in the US Army. His father is a decorated Marine veteran who served in Vietnam.

Sgt Fell enlisted in the U.S. Marine Corps in Denver, CO, and on September 11, 1994, he stood on those yellow footprints at the Marine Corps Recruit Depot San Diego, CA. He was assigned to the 1st Battalion, Platoon 1050 where he completed 13 weeks of the legendary Marine Corps Boot Camp. There he experienced the physical, mental and moral toughness which are prerequisites to fight among the Marine Corps ranks. He and the other recruits acquired the knowledge, discipline, teamwork and fitness level required of a Marine through physical training, classroom instruction and development of combat skills. The difficulties that this process presents to every recruit are as deliberate as they are legendary, as physical, mental and moral toughness are prerequisites. It is not enough to simply endure. The Marine must prevail.

After graduating from Boot Camp on January 6, 1995, Pvt. Fell was assigned to the 2nd Battalion Hotel Company, 2nd Platoon at Marine Corps Base Camp Pendleton, CA, for combat training. It was there he was meritoriously promoted to Private First Class (PFC) on February 2nd 1995 and learned that his MOS would be 6124, helicopter power plants mechanic. After graduating from combat training at the end of February 1995, he was transferred to the Naval Air Technical Training Center, Millington, TN where he completed his Aviation Machinist's Mate Course. Next, he was transferred to the Naval Air Maintenance Training Group in Mayport, FL, where he trained in maintenance of the T-700-GE-401C, which is the powerplant for the AH-1W Super Cobra engine. There he was awarded a letter of commendation for achieving the highest GPA in his class. He then trained at Marine Base Camp, in the powerplant maintenance of the Pratt & WhitneyT-400 turbo twin pack which the engine for the UH/IV Huey. After graduating in August of 1995, he was stationed at the Marine Corps Air Station New River, N.C., with MALS-26 (Marine Aviation Logistics Squadron). During his time there, he was deployed twice on U.S. Navy ships to the Mediterranean Sea. He served with the 24th MEU on the USS Saipan LHA 2 which is a Tarawa class amphibious assault ship from June 1996 to December 1996. During that deployment he also served as an aerial observer on the UH-1N Huey and was promoted to Corporal. While docked in Haifa, Israel, Corporal Fell was victorious in his boxing match during the Battalion Landing Team 2/8 "Smoker" on November 24th. On November 1st 1997, he was promoted to Sergeant. He served from January 1998 until June 1998 with the 26th MEU on the USS LHD-1, a United States Navy multipurpose amphibious assault ship and the lead

ship of her class at the time. During this deployment, the 26th MEU served as the Headquarters for the Strategic Reserve Force (SRF) during Exercise Dynamic Response in Bosnia. The SRF was a multinational force made up of forces from the Netherlands, Spain, Italy, Romania, Poland and the United States. He also served on the USS Trenton LPD-14 during this deployment in the Black Sea. Sgt. Fell completed his military service September 11,1998.

After his military service, Sgt Fell used the G.I. Bill and received a Certificate of International Business and a Bachelors of Science Degree in Business Economics from the University of Arizona in 2003. His employment after his military service began in leadership working as group manager with Jeld-Wen Windows & Doors in Vista, CA, for several years. He then moved to Georgia to build a house with his father for the next year. From that experience, he chose to work in the construction industry. He was employed by Ryland Homes in Ft. Myers, Florida, as a construction superintendent. Construction was booming during this time, and so were the subprime mortgages.



Unwarranted risk-taking and the greed of the financial institutions ultimately led to the housing bubble burst and the Great Recession. He was laid off in October of 2007 but was able to adapt and find work at a small SERVPRO franchise, a cleanup and restoration service. He operated as the estimator and organized the crews to serve homeowners in need. During that time, he led a crew to Birmingham, Alabama in 2011 to assist in cleanup efforts after an EF4 tornado caused massive damage to the western and northern parts of Birmingham. In 2012, he was hired as a assistant manager at Hyundai Motor Manufacturing Alabama in Montgomery, AL. From 2012 to 2019, he led teams of 50–120 team members and management in the quality production of Hyundai vehicles. In 2019, he was selected for promotion to manager and was moved to the paint shop. There he led 134 team members and five members of management to produce 500 quality cars per shift.

In 2018, he and his wife had their youngest daughter Isabella who was born with Down Syndrome. This motivated Robert to learn about the fundamental financial management and investing principals so that he could provide for her future. He led a Financial Peace University class at his church and was excited to lead people to a strong financial foundation. This led him to search for an opportunity to do this as a career. He joined Edward Jones in January 2024 and passed his Securities Industry Essentials exam, Series 7. Series 66, and Alabama Insurance exam. Edward Jones bestowed the title of Financial Advisor upon Robert where he builds relationships with his clients and leads them to a strong financial foundation based upon their needs. Sgt. Fell and his wife, Cecilia, have been married nine years, and they have three daughters. His elderly parents live next door and make it their job to spoil his children. They are members of the First Baptist Church of Prattville, Down Syndrome Alabama and Townsend Detachment 920 Marine Corps League. He enjoys spending time in his barn and raising chickens, horses and vegetables on the 10 acres of his home.

Sgt Fell's conclusions about his military service in the U.S. Marine Corps are: "It provided me with a foundation outside of my parents raising me and allowed me to mature. It exposed me to other cultures, not just overseas, but within these great United States. It broadened my horizons more than any college classroom could. I knew if I set my mind to it, then I could do it, and that is what I have done." He would like people to remember him as follower of Christ, a solid friend, a good father, husband and fun to be around.

Sergeant (Sgt) Seth Edward Maggard served six years in the U.S. Marine Corps. His Military Occupational Specialty (MOS) was Combat Photographer. He received the following medals, awards, ribbons and commendations: Navy and Marine Corps Achievement Medal, Combat Action Ribbon, Joint Service Commendation Medal, Marine Corps Good Conduct Medal (two), Marine Corps Expeditionary Medal, National Defense Medal, Iraq Campaign Medal, Global War on Terrorism Service Medal, National Defense Service Medal, Sea Service Deployment Ribbon (three awards), Certificate of Commendation and Meritorious Mast which is given for personal performance that is considered noteworthy or

commendable beyond the usual requirements of duty.

Sgt Maggard was born June 18, 1986 in Montgomery, AL, to his parents, Edward and Tracey Maggard. He was reared in Prattville, AL, and he graduated from Prattville High School in May 2005. Sgt Maggard voluntarily signed up to join the U.S. Marine Corps in 2004, and immediately after graduation from high school, he reported for active duty at the Marine Corps Recruit Depot Parrish Island, S. C. where he completed the rigorous 13 weeks of the Marine Corps Boot Camp, and this was followed by 59 days of Combat Training at Camp Geiger, a base camp within the larger Marine Corps Base Camp LeJeune, N.C. Upon completion of Boot Camp and Combat Training, he was selected to serve as a photographer and videographer, and he completed this specialized training at the Defense Information School at Ft. Meade, MD, during December 2005 through May 2006. This training included training in public affairs writing, photography, photojournalism, tv and radio broadcasting, lithographing, broadcast equipment maintenance and various forms of visual information. He was then stationed at Marine Corps Base Camp Pendleton, CA, with the 1stMarine Division from May 2006 until February 2008 where he worked with the newspaper at the base. He was then deployed to Al-Asad Air Base, Iraq, for 15 months where he served in combat as a photographer and videographer. He then returned to Camp Pendleton during March 2009 through August 2009, and while there, he was selected as the Military Photographer of the Year in 2009 for all branches of the U.S. military which was a significant honor. His final assignment was as instructor of the next generation of photographers, videographers and journalists at the Defense Information School at Ft. Meade, MD, from August 2009-Juy 1, 2011 when he was honorably discharged from military service and became a government civilian with Defense Media Activity. Sgt Maggard has more than 300 published

photos and news articles in mainstream media including the New York Times, L.A. Times, BBC, Al Jazeera, Fox News, Forbes, CNN, RT and several other publications.

After discharge, Sgt Maggard returned to Montgomery, AL, and used the G. I. Bill graduating with a B.S. Degree in Interdisciplinary Studies & Psychology from Auburn University at Montgomery in 2023. He worked as a defense communication specialist with Booze Allen Hamilton, a defense contractor, from 2016-2023, he co-created a virtual reality training from scratch and traveled to 42 countries. Culture and Language Virtual Reality (CLVR) teaches servicemembers how to interact with other cultures. During this time, he went to Israel, and using his knowledge of artificial intelligence, he created an



algorithm, a process or set of rules to be followed in calculations or other problem-solving operations especially by a computer for identifying fake news. He also created a Dashboard, an arts agency that connects artists with space to reimagine experience through human-centered design and experiential events. The office of the Supreme Allied Command used it. While in Europe, he became interested in theater, and his family started acting with the Amelia Earhart Theater Playhouse in Weisbaden, Germany. When he returned to the U.S.A., he continued to participate in theatrical productions in Millbrook and Wetumpka, AL.

He then worked one year with the AL Governor's press office with the AL Department of Revenue during 2024. He has enrolled at Auburn University to obtain a provisional teaching certificate in preparation for earning a degree in Secondary Education to teach English and language arts.

Sgt Maggard and his wife, Merideth, have been married 18 years, and they have three children: Gabe, McKenzie Grace and Walter. They are members of Cains Chapel in Deatsville, AL, where he is involved directing children's drama and singing. He is a member of the Townsend Detachment #920 Marine Corps League and writes its newsletter.

Sgt Maggard's reflections on what serving his country in the U.S. Marines means to him saying: "It is my life and my foundation. It defines who I am. I would not trade it for anything, including combat. I always have the Marine Corps to remind me who I am." He would like people to remember him as someone who is not afraid to be outside the box, to be a good father and to be someone with strong Christian values.





SOUTHERN GARDENING Potpourri for EPTEMBER

This summer's heat was simply brutal for any type of gardening. Hopefully we have turned the corner and the temperatures will cool down. Of course cooling would mean no higher than 90 degrees. September brings Labor Day and the commencement of football season. which most people in the south have a passion for. Whether it

is Alabama, Auburn, Alabama State, Troy or Huntingdon College, let's cheer our favorite teams on to victory.

There is one job that is a constant for gardening, and that is weed control. I have made it a habit over the years to cut back all dead blossoms or weed blooms before they go to seed. As far as the flowers, I cut them back to save the seed and not to allow the seeds to just sow randomly throughout the beds. And the pesky weeds, the ones which have slipped by my watchful eye, taken out. The old saying goes, "Do not let the weeds go to seed--1 year of seed will be 7 years of weeds." In making observations in the garden, I have noticed that certain plants actually defy encroachment of weeds. These will stop weeds in their tracks. Dianthus forms a thick mat of small flowers and once the plants grow together--no more weeding. Mexican Heather, which can grow in sun or shade, falls in this category. Hosta, a shade loving plant, also has this attribute. The bottom line is: if you have only these plants in your beds, no more weeding for you.

PLANT OF THE MONTH-- BAPTISIA

Baptisia, also known as False indigo, or wild indigo, is a wonderful perennial which grows into shrub-like proportions. Their colorful pea shaped flower spikes of yellow, blue, cream and white are simply spectacular. The flowers resemble those of lupines and Baptisia can be a substitute for lupines since they struggle in zone 8 because of the heat. These plants are tough, long-lived and low maintenance plants, definitely my kind of plant. They require moist and well drained soil in full sun or part shade. Once established, all species are drought tolerant. However, they are not quite totally trouble free. In the early spring as they are emerging they may need staking. Best propagation would be by seed which usually germinates

within 2 weeks. Perhaps it was 40 years ago when I grew Baptisia which came back over a 2--3 years period, and then just forgot about them. Baptisia will be high on my list for next season.

If you want to take a road trip through Alabama, consider visiting the Botanical Gardens of Huntsville, Birmingham and Montgomery, Mobile and Dothan. All will impress you with their beauty and serenity. Although an entrance fee of \$20.00 is charged at the Huntsville Botanical Gardens, a \$5.00 fee in Dothan and an \$8.00 fee in Mobile, Birmingham and Montgomery are free. September is a great time of year to get out and commune with nature.
