We Now Have a Very Youthful Federal Judiciary in Alabama

Our senior senator, Richard Shelby, has left an indelible legacy and imprint on our state. Every corner of the state has been the recipient of his prowess at bringing home the bacon to the Heart of Dixie. Every university has enjoyed a largesse of federal dollars. He has made the Huntsville Redstone Arsenal one of the most renowned high technology regions in the nation, not to mention placing the FBI's second home in Huntsville.

Shelby's accomplishments for Alabama would take a book to enumerate. However, what is not universally known is that Senator Richard Shelby has transformed the federal judiciary in Alabama for years to come.

During the entire eight-year presidency of Barack Obama, by nature we had some attrition in our federal judiciary in all three regions, Northern, Middle and Southern Districts. Even though President Obama sought to appoint Democratic judges throughout the state, Senator Shelby and Senator Jeff Sessions thwarted all Democratic appointees and held these cherished and powerful judgeships vacant.

Shelby and Sessions were hopeful that one day there would be a Republican president coupled with a Republican senate majority and they would be able to appoint Republican jurists to the federal bench in Alabama. That happened when Trump became president. Senator Sessions had parted with his senate seat to become attorney general, so that left Senator Shelby to select and get confirmed a host of new, young federal judges in Alabama.

Shelby assigned his loyal and brilliant Chief of Staff, Katie Boyd Britt, the job of vetting potential federal judgeships. She and Shelby chose an outstanding cadre of young, well-educated, extremely qualified, moderately conservative men and women to sit on the federal bench in Alabama. This group is stellar and will be the majority of federal judges for the next 25 to 30 years. This coup of appointing young, conservative, extremely capable judges to the federal bench in Alabama may be one of Senator Richard Shelby's greatest legacies.

Shelby had Andrew Brasher first appointed to the Middle District of Alabama. However, soon thereafter an opening occurred on the Eleventh Circuit and so Shelby had President Trump appoint Brasher to the higher appeals court. Prior to Brasher's appointment to the Middle District, he practiced law with Bradley Arant in Birmingham. He was solicitor general and a law clerk for Judge Bill Pryor. Judge Brasher is a graduate of Samford University and Harvard Law School. Senator Shelby had President Trump appoint Anna Manasco as a federal judge in the Northern District of Alabama. Judge Manasco, like Judge Brasher, practiced law in Birmingham with Bradley Arant prior to her federal appointment. She graduated with honors from Emory University, prior to earning her law degree from Yale Law School.

Shelby aligned with President Trump to appoint Corey Maze for a seat on the federal bench in the Northern District. Judge Maze was a prosecutor for the State of Alabama Attorney General's office. He is a summa cum laude graduate of Auburn University and a graduate of Georgetown Law.

Senator Shelby had President Trump appoint Liles Burke to a federal judgeship in the Northern District. Burke was an Associate Judge of the Alabama Court of Criminal Appeals prior to his federal appointment. He obtained his undergraduate and law degree from the University of Alabama.

Annemarie Axon is another Trump and Shelby anointed appointee for the Northern District of Alabama. Judge Axon practiced law in Birmingham prior to her appointment. She, like all of the other Northern District appointees, is extremely well qualified. Axon also obtained her undergraduate and law degree from the University of Alabama.

Austin Huffaker, Jr. of Montgomery was chosen by Shelby and Trump for a federal judgeship in the Middle District. He practiced law in Montgomery prior to his appointment. He has an engineering degree from Vanderbilt and earned his law degree from the University of Alabama School of Law.

Also appointed by Shelby and Trump to the Middle District is Emily Marks of Montgomery. Judge Marks practiced law in Montgomery prior to her appointment. She is a graduate of Spring Hill College in Mobile and the University of Alabama School of Law.

Jeffrey Beaverstock was appointed to a federal judgeship in the Southern District. He practiced law in Mobile and is a graduate of the Citadel and the University of Alabama School of Law.

Terry Moorer was appointed by President Trump and confirmed by the senate for the Southern District. He was previously an assistant U.S. Attorney and is a graduate of Huntington College and the University of Alabama School of Law.

This host of federal jurists in Alabama will be one of Senator Richard Shelby's lasting legacies.

What is the Constitutionality President Biden's, Covid-19 vaccination requirement among certain people residing in the United States?

That's a tough question and prone to a rambling answer. Before looking at several points we will pretty much first agree that there may be legitimate, provable exemptions that may be medical or religious. In looking at case law there are numerous Covid-19 related cases that generally deal with a compassionate release from prison where multiple

cases of Covid have occurred in prisons. There is a case of a cruise liner requiring proof of vaccination for a very high percentage of its employees and passengers to meet certain regulatory guidelines only to be frustrated by Florida law which went against what the cruise line was trying to follow so as to not lose another year of cruising. The cruise line was successful in gaining injunctive relief.

First to look at an argument for required immunization of certain groups. Consider the required immunization of school children to attend public school. Public school of course is an extension of a governmental entity and accepts payment from governmental agencies. The required immunization of school aged children is not a part of Biden mandates but this is purely an example of required immunization to protect those inoculated and those that come in contact. Under Biden's mandates consider then companies of more than 100 employees that receive governmental payment because of government contracts (though governmental payment is not a requirement). While I don't think we are at war with anyone right now, private companies that manufacture the machinery of war are expected to remain healthy and to be able to have adequate staff to produce what is expected and paid for by the government. Those companies under the mandate have both the ability to require vaccination or routine testing requirements. Another part of Biden's mandates includes the complete vaccination of healthcare providers that receive Medicare and Medicaid. It does not include a provision of routine testing to skirt a vaccination requirement.

The 1905 United States Supreme Court case of Jacobsen v Massachusetts allowed local health authorities to require that all adults receive the smallpox vaccination. This occurred in Cambridge, Massachusetts. Henning Jacobsen was fined \$5.00 for refusing a free but required smallpox vaccination. According to an inflation calculator, \$5.00 is the approximate equivalent in 2021 of just over \$155.00. Justice John Marshall Harlan wrote in the majority opinion, "It is for the legislature, and not for the courts, to determine in the first instance whether vaccination is or is not the best mode for the prevention of smallpox and the protection of the public health." General police powers given to the states is there to require such things to protect the public.

With over 675,000 deaths in the United States alone there is a compelling public interest to take reasonable steps to protect the citizenry, especially the more vulnerable. Aside from the deaths there are mental health effects, higher health care costs, strains on funeral homes, economic impact from the illnesses, time away from work and the deaths of workers. It has caused some children to have only one parent or to become orphans.

On the flip side, individuals argue that it is their body and that they should be able to refuse such a personal and physical invasion. Some argue Constitutionally that the refusal is protected under the First Amendment as a freedom of expression.

Some states are requiring a vaccine passport. In response to Biden's mandates, Gov. Kay Ivey said the following, "Once again, President Biden has missed the mark. His outrageous, overreaching mandates will no doubt be challenged in the courts. Placing more burdens on both employers and employees during a pandemic with the rising inflation rates and lingering labor shortages is totally unacceptable."

"Alabamians have stepped up by rolling up their sleeves to get the covid-19 vaccine, increasing our doses administered significantly in recent weeks. We have done so without mandates from Washington D.C. or Montgomery. I've made it abundantly clear: I support the science and encourage folks taking the vaccine. However, I am absolutely against a government mandate on the vaccine, which is why I signed the vaccine passport ban into law here in Alabama. This is not the role of the government."

In 1922, a Texas case, Zucht v King, was also related to smallpox but in that it was required that school children have the smallpox vaccination. It was challenged by Rosalyn Zucht who said it violated her 14th Amendment due process rights. Again the United States Supreme Court stated that police powers of the state are available to protect the public.

A couple of universities that have mandated vaccines have been challenged or are in the process of being challenged. Thus far courts have ruled that Constitutional rights were not violated and have upheld the rules of the universities. Finally, a couple of other things that may be used by the Federal government is to use its spending power to "encourage through reward" states to mandate vaccinations or even to use the interstate commerce clause since people travel between states. The commerce clause was used in the famous 1960's Ollie's BBQ case where Federal segregation was challenged by the McClung owners from Birmingham but lost at the United States Supreme Court because products used in the restaurant were subject to moving between states to get there and it was ruled that the Federal government therefore had power over such places.

We will see what happens in the courts.

Nation Building Done Right.

Some things succeed while other things fail; observ-

ing the reasons for success should help draft a blueprint for planning the future. It may be vogue to regard the past as nothing more than a sentimental embrace of the

pre-modern world, but the laboratory of human conflict yields tangible results that can be examined, quantified and reviewed to consider best practices.

What can we learn when the autocrat's autocrat allows a form of pluralism that is against type?

That Louis XIV, King of France and in his mind, King of the World, would shed ruthless conquest for negotiated peace is not something many monarchs embraced 340 years ago. But, against his own pattern for subjugating other provinces to his iron will, Louis allowed the Protestant city of Strasbourg to stay virtually intact with limited oversight of superintending the city's government.

This was not the normal behavior for the 17th Century: conquest led to subjugation, which, in turn, led to exploitation. In the short term, this policy created wealth to the conqueror but also seething resentment in the populace seeking an opportunity to throw off the yoke and regain independence.

Strasbourg spoke mostly German and was overwhelmingly Lutheran. But rather than join its neighbors and engage in devastating sectarian conflict, it wisely choose to pursue a policy deferring to commerce more than religion.

The leaders of Strasbourg realized that religious war benefitted only arms dealers and morticians; they understood that communities lose when trade is stifled by conflict. Ahead of its time, Strasbourg understood that religious conviction that led to armed conflict was not true religion at all. It thus refused to embrace the fervor of religious belief other provinces co-opted into a misguided rage that demanded acceptance on the pain of death.

It would be neither the first nor last time that religious zeal would be compromised by politicians anxious for territorial expansion and selfaggrandizement. Many city-states and provinces weaponized the religious fervor of the reformation and counter-reformation to gain territory and political advantage. But, in the wake of such cynicism of faith, the result was widespread devastation, carnage, and poverty.

Strasbourg stood in stark contrast to this political science. Situated strategically on the Rhine, the city was at a crossroad of trade and economic expansion. It was a free imperial city with a thriving middle class engaged in crafts, trade, and, with its own mint, banking.

As a free city, it had a defensive system adequate to protect against limited conflict, but not strong enough to repel the military juggernaut of Louis XIV. From its structure of government, the city openly encouraged the participation of all faiths and even had a power-sharing arrangement between the Lutherans and Catholics.

While it is true that Calvinists and Jews were not a part of this political structure, it is also true that unlike other locales, they were tolerated and allowed to generally participate in the business of the city under the protection of its laws. Another mitigating factor against sectarian violence was that Martin Bucer,

proclaimed by some to be the father of ecumenism, had been an influential cleric there. Bucer was the consummate "big tent" protestant, looking for common ground with all faiths and advocating forbearance in a sea of bigotry.

The stability of Strasbourg economically, politically, and culturally created great prosperity for its citizens. It was a thriving medieval community, which made it the crown jewel of the area and an object of conquest for the French king. The value of the city located at the confluence of the Rhine and Ill rivers made it ideal for an outpost on the eastern border of France to serve as an early warning system against invasion.

For years, Louis and his generals coveted the city as an addition to the expanding empire of the Sun King. But rather than pursue siege and armed conflict, Louis wisely engaged in deft diplomacy effectively charming the city but with the threat of force implicit in his affections.

Annexing Strasbourg by negotiation would not only provide an economic benefit but would also serve as an example to other surrounding cities that Louis' ruthless reputation was undeserved, and he was a reasonable despot. This diplomatic approach gave Louis a sphere of influence to neutralize otherwise hostile cities and encourage acceptance, if not allegiance, to his cause.

So, in September 1681, Louis occupied Strasbourg without a shot fired in anger and incorporated the city into his realm. Reaching an acceptable accommodation with the various centers of power in the city was easily accomplished when it was clear that French occupation would not change the law of the land.

Louis did require that the Cathedral of Our Lady be returned to exclusive Catholic worship. Previously, several churches were used by various faiths to worship at alternating times on Sunday. But, while Louis favored his Catholic faith, unlike his other conquests where all other sects were banned and members exiled, he allowed Strasbourg to continue to follow its longstanding tradition of religious toleration.

Strasbourg thus remained faithful to Louis and to the French. While its initial language was primarily German, over time this changed as the city embraced a distinctive French culture. However, from 1871 it was caught between the imperial aims of Germany and France in three wars, changing boundaries by conquest and negotiated settlement until finally after World War II it was re-incorporated into France.

Thanks in large part to Louis' largess, Strasbourg remained a thriving commercial center and also a center for religious tolerance. This tolerance was an unintentional consequence of understanding the importance of commercial interest and the prosperity occasioned by stability in all aspects of city life.

Nation builders, newlyweds and community organizers would do well to follow Louis' example and moderate changes of local customs to advocate acceptance, toleration and freedom of conscience. It is no wonder that when Europe sought a location for its Court of Human Rights, Strasbourg was a logical choice.

The Prospects for Economic Freedom

The 2021 Economic Freedom of the World (EFW) rankings from Canada's Fraser Institute show freedom essentially unchanged in the United States. But some important changes in the rankings will be coming soon.

Economic freedom is based on "the concept of

The 2021 EFW rankings use data from 2019 due to lags in compiling statistics and surveys. The rankings consequently are always somewhat backward looking. Two ongoing events will soon shake up the ratings.

The first involves China's crackdown on Hong Kong. Hong Kong has always been rated separately from China (currently 116th), initially because it was a British colony and then because of its Special Administrative Region status. Yet China is now reneging on this deal. Hong Kong's Legal System score should decline precipitously producing a new #1 for the first time in EFW history.

self-ownership." We should have "a right to choose – to decide how to use [our] time and talents to shape [our]

lives." What does economic freedom mean in practice? "Individuals are economically free when they are permitted to choose for themselves and engage in voluntary transactions as long as they do not harm the person or property of others." With a high degree of economic freedom "the choices of individuals will decide what and how goods and services are produced."

The EFW index turns this concept into a measure now applied to 165 countries. The index features five component areas: Size of Government (the levels of taxing and spending); Legal System and Property Rights; Sound Money; Freedom to Trade Internationally; and Regulation, which includes credit and labor markets as well as general business restrictions. Each element is scored from 0 to 10 (10 being more freedom) and the five area scores are averaged to generate a nation's score.

The United States ranks 6th in 2021 (as in 2020) with a score of 8.24 which is a mere 0.02 points lower than last year. Hong Kong and Singapore take the top two spots, with scores of 8.91 and 8.81, with New Zealand, Switzerland, and the Republic of Georgia rounding out the top five. The bottom five nations are Zimbabwe, Algeria, Libya, Sudan and Venezuela in last. Socialist Venezuela is not necessarily the most consistent practitioners of Marxism today as a lack of date keep Cuba and North Korea from being rated.

Looking across the five areas of the index, the U.S. ranks 6th in regulation, 15th in Sound Money, 19th in Property Rights, 52nd in Size of Government, and 64th in International Trade. The Size of Government scores deserve comment. Many European nations have high taxes and spending but otherwise a lot of freedom. For example, Denmark ranks 10th overall despite ranking 150th in size of government. On the other hand, many weak governments tax and spend little while failing to protect property rights; Sudan ranks 7th in the size of government but next to last in overall freedom.

The current report also does not reflect policy responses to the pandemic. To me the freedom to trade internationally is most vulnerable. The pandemic has initiated what some are calling deglobalization. COVID-19 has made international travel and trade seem dangerous in a way it was not before.

Over the past 18 months the international shipment of goods has been disrupted but rarely strictly prohibited. Travel has been more restricted. Quarantine rules and potential travel suspensions raise the cost of visiting suppliers in Malaysia or China. The relevant economic question is whether businesses can maintain global operations without frequent face-to-face interaction.

This likely depends on the oft-predicted "death of distance," where technology eliminates the need for face-to-face interactions. Yet proponents have been predicting distance's demise for two decades. The adequacy of distance communications probably depends more on psychology than economics.

Economist Adam Smith identified how the division of labor increases productivity with a bigger market allowing greater division of labor. A global market allows the greatest division possible, to our benefit. Our standard of living depends on the survival of international trade with diminished international travel.

Tough "Roe" to Hoe

I suspect most *Alabama Gazette* readers share my distain for (non-defensive) abortion as much as any other premeditated murder. Those who endure my lengthy

columns know where I stand on the issue as a legal matter. Apropos to open this 22nd Anniversary issue column with thanks for the honour to be included in this wonderful paper which allows such dissenting views on 'long standing' precedents. Problems of this sort persist aided and abetted by jurists (like Chief Justice Roberts installed by big-govt. Republicans) who care more for adhering to precedents instead of fidelity to the letter and Spirit of our Constitution. Wise rulings are driven by logic and reason applied to the originalists' (to shamelessly evoke Justice Scalia's nomenclature) text, not the zeitgeist and desired wealth transfers of the moment. This permits deleterious law to persist and generate greater harm - in this case making Roe a much longer, tougher, bloody precedent to hoe...

Roe v. Wade is one of DC's more tangible assaults on State sovereignty. I'm a pragmatist on the issue. If the people of a State want to allow murder in Massachusetts and not in Mississippi, it is NOT a federal offense. The definition and enforcement of murder isn't authorised to the federal government. I'm not foolish enough to think banning murder will end all the killing (even less so the immediate and tangible murder of a defenseless child inside or just outside a womb posing no threat to the mother) we've observed, but I want the freedom to possibly live in a State which doesn't subsidize murdering one's own child. If you kill your own child, do it on your own purse. It is not a lot to ask federal judges to ban taking my treasure to subsidize killings I and many others find reprehensible. This is an integral part of securing blessings of liberty for ourselves and our posterity – born and unborn.



US District Court Judge Myron Thompson is no stranger to reinserting the federal govt. into the abortion business. A more recent and notable of Thompson's opinings was his 2015 Planned Parenthood ruling further assaulting civil rights of citizens who do not wish to subsidize those committing infanticide of their children. Reason Staff Editor Elizabeth Nolan Brown [10/28/15] wrote, "Alabama must restore the contract with Planned Parenthood as a Medicaid provider, at least for now, because Alabama offered no reason whatsoever for the sudden defunding, the state was likely in violation of federal Medicaid law, which requires letting patients see any provider that accepts Medicaid unless the state establishes that they're not qualified. Providers, of course, are not generally obligated to take Medicaid patients, and many don't because of low reimbursement rates. But under federal law, Medicaid patients have 'freedom of choice' among qualified Medicaid providers."

Many still ask why the Hyde amendment (prohibiting use of federal funds for abortion except cases where the mother's life is in danger or pregnancy results from incest/rape) doesn't apply to this ruling. Hyde addressed a symptom; the source of the problem is unconstitutional federal programs/policies like Medicare/Medicaid imposed by extremists decades ago. In a world of 'fungiblity' Hyde doesn't matter. Alabama Medicaid Agency records show \$4,351 (Thompson's 2015 order stated \$5,600) paid for services to patients at Planned Parenthood's Alabama clinics over the last two years in Mike Cason's Al.com report; payments were mostly for contraceptive services and did not include abortions. Some assert Thompson reinforced Jane Doe's right to seek family planning services at qualified providers of choice - which is absurd. Nothing has been done to deny Jane's right - she (or any private donor who wishes to subsidize Jane) may purchase whatever service and/or provider however they see fit. Thompson's poor training/understanding of the letter and Spirit of the Constitution fails to protect the civil rights of US citizens in general NOT to subsidize Jane. States as the sovereign unit (who may also authorize local governments to act) may fund/subsidize abortions, fetal tissue, etc. but Alabama

does not. Private expenditure of time and effort may also occur, some follow their conscience to take those who choose killing their child to locales which will perform

this service; others follow their conscience to discourage killing and promote adoption, financial help in raising children of mothers often young, inexperienced and of meager means for the task. This 'freedom of choice' to devote one's time, money and effort to the manner of assistance they prefer has been usurped for the modern 'choice' movement more interested in imposing their preferred result and have others pay for their desired end. Recent changes in Texas legislation could be more wisely handled under 'accessory to murder' statutes; those who find the empowering of private citizens problematic to enforce this matter were noticeably silent when Mondale Act 6th Amendment violations destroyed many lives in trumped-up claims of child abuse/assault without the ability to face one's accuser.

I'd like to observe those who abhor stealing/taking the property right to one's body also disapprove murdering squatters or ones refusing rightful eviction from their property. I pray most would also find 'hired guns' abhorrent who do it for those too weak or squeamish to commit the murder themselves. It seems those screaming the loudest for rent forgiveness worried about their lives are the same ones screaming to evict 'squatters' from their property. Isn't it just as wrong to force owners of a building to host a squatter without their consent (as the 3rd Amendment asserts) or compensation as forcing a mother to host an unwanted squatter? We have courts, laws, etc. to decide and accomplish this less unilaterally; at one time the church and other private entities played a huge role in reducing abortions and burden of getting unplanned/unwanted lives from others' body/property humanely. Those who have no problem mandating unwanted injections may be OK with a woman being forced to endure the unwanted injection from a rapist; some find BOTH despicable. Nonetheless, if a govt. mandates an individual(s) suffering either of these forced results, they are obliged to compensate for the consequences...

Myron Thompson has already shown great disregard for individuals' civil right to property, removing homeowners from property they held legal title to so others could live in their home - i.e., don't expect any rational relief there. Lt. Woodward Durham Lamar served as a pilot in the U.S. Navy for four years of active duty during WWII and served seven years in the Navy Reserve.

Lt. Lamar was born October 31, 1922 in Montgomery, AL, to his parents, Robert Jones Lamar and Mary Yougene Lamar. Lt. Lamar's four brothers also served during WWII, and one brother was killed in combat when he was flying a B-25. Lt. Lamar was reared in Montgomery and graduated from Lanier High School in 1940. He worked for one year at the AA Seed Company, a fertilizer company, and as a shoe salesman in Montgomery followed by working at a boys' camp in Fountain, North Carolina. Next, he attended the University of AL for one year.

While working at a defense plant in Detroit, MI, Lt. Lamar joined the U. S. Navy in August 1942 and became a Navy pilot. His flight prep school was in Columbia, S.C., soloed at Rocky Mt., N.C., completed preflight in Athens, GA, and graduated from flight school at the Naval Air Station at Pensacola, FL, receiving his pilot's wings. One of his instructors at Bronson Field, a Naval Auxilliary Air Station near Pensacola, was Ted Williams, a Marine Corps fighter-pilot who was a famous professional baseball player. He began flying the Stearman PT-17, a two-seater,

single engine aircraft for the instructor and the student-pilot. He next flew the SNJ, a single engine advanced trainer aircraft. He then completed training at the torpedo-bomber school and flew the TBF Avenger aircraft. He completed operational training in Miami, FL, followed by training to be catapulted and to land on Naval aircraft carriers in Lake Michigan at the Glenview Naval Air Station in Glenview, IL. After completion of all training to fly with instruments during the day and the night, Lt. Lamar was assigned to Torpedo Squadron Seven at Seaside, Oregon, where training was done in preparation for an invasion of Japan. Lt. Lamar recalls that his pilot training was thorough.

The Japanese surrendered August 15, 1945, and Lt. Lamar never got to fly in combat before WWII ended in the Pacific Theater. He was then sent to Hawaii where he flew the cargo plane, C-47, delivering supplies throughout the Hawaiian Islands for nine months. He was discharged from active military service in 1946 at San Francisco, CA, riding a train back to his hometown of Montgomery, AL, followed by serving in the Naval Reserve.

Using the G.I. Bill, Lt. Lamar graduated from the University of AL with a B.S. and a B.A. Degee in Pre-Med in 1948, and he graduated from the University of AL School of Dentistry in the University of AL in Birmingham, AL in 1952. Dr. Lamar practiced dentistry for 40 years in Montgomery, AL. He ended his service in the Navy Reserve when he finished dental school.

Dr. Lamar and his wife, May Rush, were married 48 years before she passed away, and they had four children, nine grandchildren and seven greatgrandchildren. After receiving a degree in early childhood education, May started







David L. McFarland served 27 years in the United States Air Force. His Air Force Specialty Code was Navigator-Bombardier.

David L. McFarland was born to Evan McFarland and Sarah McFarland in Louisville, KY in May 1941. His father was a landscape gardener at the time with a thriving business based out of Crestwood, a small village, in rural Oldham County near Louisville. After a contentious divorce, his father was granted custody of David at age five, an older sister and a brother. Evan McFarland then moved his small family to Scott County, Ky. Numerous McFarland families who trace their history back to Scotland settled in the county in the 1700s.

McFarland began his schooling at Newtown School, and he attended several elementary schools until moving to Fayette County where he completed junior high and then graduated sixth out of a class of over 300 at Lafayette Senior High School in 1958. He then enrolled in the University of Kentucky (UK) in Lexington and worked to earn money for each semester's tuition and books which was then about \$200. His father provided a home and an old car to help him. He graduated from UK in May 1962, and since the school was a land grant school, he enrolled in the mandatory Reserve Officer Training Corps. Luck led him into the Air Force ROTC program and a commission as a 2nd Lieutenant with a Bachelor of Arts in Aerospace Science. He entered active service on July 27, 1962 to train as a navigator (Air Force Service Code 1525Z) at James Connally AFB, Waco, TX. With a high standing in the class, he was able to select his assignment to become a navigator/bombardier at Mather AFB, Sacramento, CA. Finishing the school as second in the class of 20, he requested an assignment to Tactical Air Command. He got his wish and was assigned to Shaw AFB, SC near Sumter, SC. The assignment was to RB-66 aircraft. The aircraft was never used as a bomber, but it served in weather, signals intelligence and photo reconnaissance roles. Although McFarland, known as "Spanky," flew in each of the roles, he settled into his flying life in the photo reconnaissance version, the RB-66B.

Photographic reconnaissance was perfect for him because of his love of maps. His father was sent to Beaumont, TX to relandscape the Texas home of Pansy Yount, a mountain girl who carried water to the oil drillers. She married Frank Yount, who brought in a free-flowing oil well on the Spindletop salt dome. Yount would become one of the richest oilmen in USA and when he died, his wife became the richest woman in the country. On the way to Texas, McFarland, collected highway maps at every gas station. He found that he could easily relate maps to the places they covered. This skill would be ideal for a photo recce navigator. Years later in the air, he developed an ability to match topographical maps to the earth's surface. As a 1st lieutenant, he was offered a job as mission planner

the kindergarten programs at the Montgomery Y.M.C.A.'s. One son, Woodward Lamar, served as a pilot in the AL National Guard flying the F4 Phantom and the F-16 Viper reaching the rank of Colonel. Another son, Claude Lamar, graduated from the U.S. Naval Academy serving five years on active duty with the Navy followed by practicing as a pediatrician for 25 years. A daughter, Melissa Lamar, has worked as a social worker in Oregon and Washington. A daughter, May, has been a reporter and is a free-lance writer in Montgomery. Dr. Lamar has served as a deacon of First Baptist Church of Montgomery and as President of the AL Dental Association. He and his wife enjoyed playing golf and often won trophies in mixed doubles in golf tournaments. They even played golf in other countries including Ireland, Scotland and New Zealand. They also fished together often on the coast of the Gulf of Mexico catching pompano. He caught a 550 pound marlin one time that took almost three hours to reel in the huge fish.

Lt. Lamar's conclusions about his military service are, "We got attacked, and we had to retaliate. I did not feel all that patriotic. It was just something that we had to do. That was all there was to it. I am proud of my service."

for the secret U-2 and SR-71 then flying over Russia. The job was normally done by a lieutenant colonel, but he turned it down because he wanted to fly.

After six weeks at Maxwell's Squadron Officer School, he returned to James Connally AFB to become Flight Check Navigator for the RF-4C Phantom, a new twin engine recce aircraft the USAF developed just in time for the ramping up of the war in SEA. On his first RF-4 mission in the USA, he flew with David "Dutch" Holland who been lured by false radio signals into East Germany flying an RB-66B along with two crew members. They were traded for a communist spy after two weeks. The MiG 19 Soviet Pilot, V.G. Zinoviev visited Holland in hospital and gave him a pack of Marlboro cigarettes.

In April 1964, four RB-66B aircraft and five three-man crews (pilot, navigator and infrared set operator) were sent to Tan Son Nhut AB, on the western edge of Saigon. McFarland's first operational war mission was in RB-66B, number 418, as was his third over jungle roads to detect heat from North Vietnamese cooking fires and truck engines used along the Ho Chi Minh trail in central Laos. Three days later, he flew the aircraft again on his birthday. Out of over 100 missions over the Vietnams, Laos, and Cambodia, he flew RB-66B number 418 twenty-three times at low level, both day and night during a three-month TDY and a tour in late 1965 followed by six weeks and four at Takhli AB, Thailand in the RB-66C. The missions were to gather electronic intel on enemy Surface-to-Air Missiles in the Hanoi area.

In July of 1966, the war-tested navigator got the news that he was to be in the first class of Weapons Systems Officers (WSO) to fly the RF-4C and train for assignment to Bergstrom AFB, Austin, TX. Because of his war experience, he immediately became a standardization/evaluation officer at the wing level. McFarland established all the low-level training routes covering Texas used both day and night by pilot and WSO students headed to SEA for combat. In late 1969, many crews were alerted for reassignment to Misawa AB. Japan. When he was not called for this new base, he volunteered to go.

The wing was a fighter-bomber unit with two F-4C squadrons and one RF-4C reconnaissance squadron that came from duty in SEA. McFarland again became a wing standardization/evaluation officer for the reconnaissance WSO's. The tour at Misawa was short. After just six months, punctuated by a 10 ft snow fall, the squadrons left in February 1970. McFarland returned to train reconnaissance crews at Shaw AFB once again. In 1973, Major McFarland was selected to attend Air Command and Staff College (ASFC) as a student for a year. While there, he wrote a paper about the ongoing war in Oman against Yemeni irregulars attempting to take Dhofar province. Iranian RF crews trained at Bergstrom AFB, TX, and flew Phantoms for the Omanis. In the paper, then Major McFarland predicted that US aircrews would fly from Oman in a future war. They did fly during the war when Iraq attacked Kuwait and Saudi Arabia and again in the war to oust Saddam Hussein.

After ASFC in 1974, Major McFarland returned to Shaw AFB and joined the 9th Air Force Inspector General (IG) team. As an inspector, he inspected Air National Guard and Reserve units that in event of mobilization would be assigned to regular USAF operations. He often flew the RF-4C Phantom "recce" aircraft with Captain Randy Wortmann. McFarland had known him since 1968 when

1st Class Seaman Frederick D. Roberts Sr. served three years in the U. S. Navy during WWII. His Military Occupational Specialty (MOS) was Guard at the Commander's Office at Naval Station Treasure Island, a major Navy departure and receiving point for sailors in the Pacific aboard surface ships and submarines at San Francisco, CA. He served there for one year and four months followed by service in Oahu, Hawaii, where he unloaded wounded military personnel and in the Philippine Islands working in the mess halls until WWII ended.

Roberts was born October 16, 1925 to his parents, Oscar and Mary Roberts in Frisco City, AL. Although he did not graduate from high school, he later received his GED. Roberts was drafted and enlisted in the U.S. Navy completing Basic Training at the Great Lakes Naval Station, IL.

After discharge from military service in 1946 in TN, Roberts worked for Monsanto Industries, an American agrochemical and agricultural biotechnology company, for 28 years and retired in 1985. He and his wife, Geraldine Taylor, were married 64 years, and they had five children, eight grandchildren, nine great-grandchildren and one great-greatgrandchild. Roberts has served as a Deacon at the Shiloh Baptist Church for over 50 years. He has enjoyed farming and making wine. He also enjoys his family and reading the Bible. He counts himself blessed. He mostly enjoyed taking care of his mother and wife during their illnesses. He has been a Master in the Masonic Order of the Eastern Star.

Roberts did not see combat duty during WWII; however he was ready to serve while serving and waiting to be deployed in the Navy at Treasure Island before WWII ended. He states the following about his military service, "It meant a "heap", a lot, to serve and to go on adventures." His conclusions about what he would like future generations to remember about him are, "Put God first. Always respect others. Get a good education. My granddad prayed for better days, and it is here. My children, my grandchildren and my great-grandchildren are hardworking just as I prayed for them to be."

Randy was one of the first four second lieutenants picked to pilot the Phantom. Originally, this would be a two-year assignment, but it stretched to six, and he would become Chief of IG Operations at 9th and a Lieutenant Colonel.

Assigned to ACSC as a seminar leader, Lt Col McFarland recognized that the college had no program to teach history of the Air Force. He proposed to bring distinguished people in the United Kingdom, Argentina, Israel, Pakistan, Germany and France, and even the United States and Russia! Lt Col McFarland retired in 1989, but he continued to organize the gathering as a non-paid advisor to select students chosen to coordinate the week-long event as their required thesis.

The war in Kosovo brought a new chapter in the now retired officer's life. On April 14, 1999, during the war over the Balkans, he saw photos of a convoy of refugees in Kosovo escaping the rampaging Serbian army. The refugees were driven from their homes by a Kosovar Serb, an auxiliary policeman. His name was Milutin Prascevic. One week later, Pascevic was killed by a young Kosovo Liberation Army soldier near Meja village just a mile from where NATO F-16 accidently bombed a convoy that appeared to be military vehicles. The F-16 pilots were not allowed to fly below 15,000 flight altitude. After lengthy communications with intelligence operators at NATO ground bases, the NATO pilots were cleared to drop bombs. The Serb vehicles had left the convoy and hid in the woods and barns. Sadly, the convoy was now composed of farmers and families on tractors and horse-drawn wagons. Two bombs struck the convoy and a farmhouse wrongly thought to be a Serb command center. That day, war photographer, Goran Tomasevic, an ethnic Serb, featured a young blond Kosovar boy who was totally traumatized and in tears.

After his retirement in August 1989, McFarland saw the photo on a BBC website, and began a search to find the boy. With the help of the UN mission in Kosovo and Voice of America, he located the boy in the tiny village of Pacaj, Kosovo. McFarland made other connections and headed to Kosovo in September 2001 to finally meet the boy. Flying from New York to Germany on September 9th, he drove to visit a friend, who was now a Czech fighter wing commander at Caslov AB. There on TV, he saw the 9/11 attack on the World Trade Center. From there, McFarland drove to Slovenia, and then flew to Kosovo. With help from a contact there, he made the trip over a very rough dirt road to Pacaj village. There he fulfilled the mission to meet the boy that he called "The Boy in the Yellow Shirt." Muharrem "Rrem" Alija was then 16 years old. Rrem's older sister, Filoreta, was one of 33 people killed in the accidental bombing. His two younger sisters and three younger brothers, plus his mother and father survived the attack. Their home was hardly more than a shack and all of the children needed clothes and dental care. McFarland helped all to solve these needs and encouraged Rrem to restart school in the 7th grade. All went on to complete high school in Kosovo. Rrem was an outstanding leader in his class. He helped McFarland to survive treatment for pancreatic cancer during 2008/2009. Their friendship continues to this day...Muharrem Alija is now a US citizen and lives in Georgia. He owns a big-rig truck and trailer and is married, with two small girls. His brothers, sisters and mother all have good lives in Germany, Italy and Kosovo ... Their story continues!

Sgt Harold Woodman: Age 90





Sergeant Harold Woodman served two years in the Naval Reserve and three years in the United States Air Force. His Air Force Specialty Code was Correspondent Clerk. His medals, awards and decorations included the National Defense Service Medal, Good Conduct Medal and Occupational Medal Germany. He served veterans for 30 years assisting them through rehabilitative counseling.

Sgt Woodman was born April 9, 1931 in Montgomery, AL, to his parents, "Sandy" Harold Woodman and Margaret Woodman. He was reared in Montgomery and attended schools there graduating from Sidney Lanier High School in

graduating from Sidney Lanier High School in May 1950. While he was in high school, he participated in the Naval Reserve. He worked as a tree trimmer with the AL Power Company for six months, and then he joined the U. S. Air Force February 6, 1951. Sgt Woodman served in Frankfort, Germany, in the intelligence service interviewing German prisoners of war coming from Russia dealing with ascertaining the activities in the cities of Russia during the Cold War. He was discharged from military service September 4, 1954. Sgt Woodman used the G.I. Bill and graduated with a B.S. Degree in Marketing in 1957 from the University of Alabama.

After graduating, he worked for a brief time with City Florist in Montgomery followed by working as a salesman with General Mills throughout Alabama.

Sgt Woodman returned to the University of AL, and in 1966 he graduated with a M.S. Degree in Rehabilitative Counseling, which prepared him to work as a Rehabilitative Counselor. He worked two years with the State of AL and assisted disabled people who had limitations to get the necessary treatments and training for employment. Then for 28 years, he worked for the Veterans Administration in counseling psychology assisting disabled veterans and children of veterans, looking at the veterans' limitations and placing them in jobs. He administered a variety of tests to determine their aptitudes and interests and helped them in obtaining financial assistance through the Disabled G. I. Bill. Sgt Woodman recalls that he looked forward to going to work each day as most of the veterans had suffered injuries from combat. He retired from all employment in June 1996.

Sgt Woodman who likes to be called "Woody" and his wife Freda have been married 63 years, and they have four children, 11 grandchildren and three greatgrandchildren. Since 1966, both Woody and Freda have been active members of the St. James United Methodist Church of Montgomery. Freda has served in many areas including singing in the choir, teaching Sunday School, making prayer shawls for ill or home bound church members or for active duty deployed service men, making baby blankets and also leading a weekly Bible study in their home. Woody has served as a deacon, Superintendent of Education, Sunday School teacher, President of a Sunday School Class and a leader of ushers. Woody has been an avid tennis player for many years playing doubles with the Early Birds at O'Conner Tennis Center, and he has cultivated a vegetable garden also for many years.

Sgt Woodman's conclusions about what serving in the U. S. Military has meant to him saying, "At that time, we felt like it was an obligation. I fulfilled that obligation. Everybody was expected to go into the service. While serving with an intelligence outfit, I wanted to get to know the German people and their life style."

Robert E. Lee: American Patriot

IT'S A "RIGHT" – BEWARE!!!

I will begin this article with a simple question: Is Public Education a Right?

The moral and economic decline of these united States is obvious. In many ways, this country has become unrecognizable. Part of the deterioration can be

traced to the inferior quality of officials elected to key positions at all levels of government, combined with their support of radical and often immoral issues. The dearth of ethical individuals in public life may now be worse than at any other time in the life of the republic.

As a student of American history, I am unaware of any American who surpasses the integrity of Robert Edward Lee. It seems Lee inherited the best qualities of his Saxon, Norman, and Celtic ancestors. Unfortunately, in our era, Lee's integrity and character have become lightning rods of criticism initiated by individuals of antithetical moral character.

Lee was born January 19, 1807, in Stratford Hall, Virginia, and died October 12, 1870, in Lexington, Virginia. The legendary Lee family includes Lee's father, Henry 'Lighthorse Harry' Lee, a famous Revolutionary War general, his cousins, Francis Lightfoot Lee and Richard Henry Lee (both signers of the Declaration of Independence), and Alexander Spotswood, Lt. Governor of Virginia. Going even further back, through his mother's family (the Carters), Lee was descended from Robert the Bruce, King of Scotland.

In 1829, Lee graduated second in his class at West Point. He then served loyally for twenty-six years in the U.S. Army. Though an opponent of secession, once Virginia voted to leave the Union he was duty-bound to follow. As peculiar as it may sound in our era, most Southerners thought of their State as their country. They understood the Sovereign States formed the country under compact and created the federal government to handle only specific enumerated duties. The Articles of Confederation spelled out State sovereignty whereas, its replacement, the U.S. Constitution, was ratified with the understanding of this fact.

Although asked by Abe Lincoln and Winfield Scott to command the U.S. Army, Lee could not accept. Lincoln's request for 75,000 troops from each State to invade the seven seceded States was considered a violation of Article III, Section 3 (Treason) of the U.S. Constitution. No governor or legislature of a seceded State asked for help (Article IV, Section 4, U.S. Constitution). Since the seceding States were simply exercising their right of self-government, there was no valid reason to invade them. Lincoln, a master of sophistry, claimed the seceded States did not literally leave the Union but were merely in "rebellion." His troop request led Virginia, North Carolina, Tennessee, and Arkansas to

secede from the voluntary compact. Maryland may have seceded as well if she had not been invaded and occupied.

Lee's Christianity (Episcopalian) was well known. His Godly beliefs are manifest in perhaps his most famous quote: "Do your duty in all things. You cannot do more; you should never wish to do less." Even those in the North understood Lee's love of Jesus Christ and his devotion to duty. In the 1880s, E. Benjamin Andrews, President of Brown University (Providence, R.I.), noted: "If any American Father were asked which of our great men he would most want his own to resemble, that father, if he were wise, would be compelled to answer, 'Robert E. Lee.'"

Also, in a January 19, 1907, speech at Washington and Lee University, Charles Francis Adams II of Massachusetts, praised Lee's patriotism, faith, moral character, and perseverance during 1861-65, stating: "Under similar conditions I would myself have done what Lee did...In fact, I do not see how I, placed as he was placed, could have done otherwise."

Despite the post-war agony, Lee stated, "I fought against the people of the North because I believed they were seeking to wrest from the South dearest rights, but I have never cherished bitter or vindictive feelings, and have never seen the day when I did not pray for them." It is difficult to imagine total war advocates such as Lincoln, Sherman, Sheridan, etc., sharing General Lee's perspective.

As we witness the present-day destruction of history, it is easy to trace these actions to lowest common denominator individuals like Virginia Governor Ralph Northam, who, in a moral era, would likely be dismissed as a subpar political hack. It is obvious Northam has no discernable moral compass (Remember his comments about letting a newborn baby die after it is born if the parents do not want it?). It seems patently clear that he and his minions have more in common with Joseph Stalin than followers of Jesus Christ.

Has there ever been a clearer line of demarcation between those who admire Robert E. Lee, a humble servant of Christ, and those who stand in opposition? The question is-when will those with morality and integrity (like Lee) let their voices be heard?

GOVERNMENT TRESPASSERS

Nearly everybody understands the concepts of trespass—the violation of other people's bodies and property. It can range from the petty (walking across one's lawn) to more serious (hunting or fishing without permission) to the outright criminal (theft and vandalism).

Most people understand that we should respect each other's property, as well as their right to peacefully enjoy it without outside interference. Unfortunately, there are some who do not.

One of the popular misconceptions is that public officials can legally violate this ethic with impunity to carry out their so-called "duties." And as time has progressed, these violations have increased.

Back in the 1990's, Mrs. Larry Wayne Attaway was at home and noticed some suspicious people outside with rulers and clipboards prowling around and measuring her barns, chicken coops, and rabbit cages. She asked them what they were doing. They said they were measuring them for tax assessment. They claimed that any structure over four feet tall was a taxable outbuilding.

Mrs. Attaway was angry. They had not asked for any permission to come onto her property. She told them to leave immediately.

A few weeks later, The Attaways received a notice that their property had been re-assessed and taxed with a serious increase. Larry called the tax office and asked some pointed questions.

Larry reconfigured his rabbit cages to under four feet. Then he hit them for the tax on his house; it was underground, and no part of it (skylights, chimneys, etc.) exceeded four feet. For the following two or three years, Larry wrangled a large tax deduction, until the county adjusted its definition of taxable property.

Today, the COVID scaremongers are cranking up some serious violations to promote and attempt to force-feed the new experimental vaccines. Eagle Forum organizer, Becky Gerritson, has recently posted this notice to deal with "official" trespassers that includes information from KrisAnne Hall, JD in this informational box below: on the side of the busy, unlighted road with the task of re-loading all of his soaking wet (and likely damaged) personal belongings all by himself. Former Retired Police Officer/chief of Police, Luther Kim, said, "Not only no, but Hell No… never, never consent to a search…. You have a RIGHT to be free from unreasonable searches. Don't give up that right!

Teacher Teddie Allen, said, "When some kid cop wants to search my car, I tell him no, absolutely not. There's no reason for it, and there's better things you can be doing with your time.... like stopping actual crime."

Tom Smith said, "NEVER voluntarily allow a search of ANY kind. Do you know why cops will tell you to empty your pockets? Because they CAN'T reach in your pockets without a WARRANT! By YOU emptying your pockets you are AGREEING to a voluntary search. If cops come to your house for ANY reason, DO NOT LET THEM IN! Courts have held that by letting them into your home THEY CAN THEN SEARCH YOUR HOME!"

Former Police Officer, Pat Alexander, said, "An unlawful search is a civil rights violation and anything they found would be inadmissible."

William Thackrey said, "In our legal system, the police are not your friends. They are obliged to tell you that 'everything you say can and will be used against you in a court of law.' They're required to tell you that because it is true. You are in an adversarial situation from the very first moment you have a working encounter with a police officer. Their goal is to charge you with a crime if they

Your Power to Trespass (even Government Agents)

If a government agent or assignee comes to your property, it will be important to those who wish to protect their privacy and property to KNOW THEIR RIGHTS.

• You do not have to answer ANY QUESTIONS or make ANY STATE-MENTS to ANY GOVERNMENT AGENT or assignee. (5th Amendment of the US Constitution and corresponding section of your State Constitution)

• Simply asking an agent to identify themselves does not waive your Rights.

• You have the Right to be free from any government agent or assignee entering your property, your home, or your business without a properly obtained warrant. (4th and 5th Amendments of the US Constitution and corresponding sections of your State Constitution.) • If a government agent or assignee refuses to leave your property or returns to your property after being warned against entering or returning, that agent or assignee has committed the crime of Trespass and is subject to arrest. (State Law, 4th & 5th Amendments to the US Constitution and corresponding



sections of State Constitution as confirmed by Supreme Court Opinions).

• You have the Right to record through audio, video, or photographic recording of any government agent or assignee on your property, either with or without consent of that agent or assignee. (Multiple Federal Court Opinions recognize that the First Amendment plainly protects the filming of officers and public agents.)

Please click below for a TRESPASS WARNING FORM (Word doc) that you may print and issue to any government agent or assignee that fails to satisfy the requirements of the US and State Constitutions. HAND THE COMPLETED FORM DIRECTLY TO THE AGENT OR ASSIGNEE WHILE TELLING THEM THEY MUST NOW LEAVE THE PROPERTY AND YOU WILL NOT BE ANSWERING ANY QUESTIONS.

You should have your address pre-written on form and as the need arises, fill in the date and time. It is highly recommended that you take a picture of the agent you are serving the warning so you may then prove that this person has been issued a formal Trespass Warning.

• Simply demanding a copy of that warrant does not waive your Rights.

• You have the Right to tell any government agent or assignee to leave your property if they cannot produce a properly obtained warrant. (4th and 5th Amendments of the US Constitution and corresponding sections of your State Constitution.)

• Simply demanding an agent or assignee of the government to leave your property does not waive your Rights.

Perhaps the most hideous form of "official" trespass is law enforcement attempting to search motorists' vehicles at traffic stops. At first, one might think that he has nothing to hide and that everything will turn out fine. In many cases, that could be true. But considering that very mundane objects and substances can be claimed as contraband, allowing a search can be very risky. "Oops, that cop thought that bit of spilled flour on the floor was cocaine. He also found my friend's empty beer can. Now I'm stuck in jail for several days or longer praying for some family or friends to come bail me out."

Furthermore, searches result in the destruction of motorists' cars and their contents. Police have frequently ripped the interiors and tossed all of the luggage and other items onto the highway, even in the rain. Then when they finished, they would not even help pick it up and return it to the vehicle.

According to many hundreds of online posts on this topic, practically every last one explicitly states that allowing a search is foolhardy. "You have everything to lose, and absolutely nothing to gain." Most of them have been written by the victims of searches.

In 1992, Wes Carter, with all of his possessions, was returning to his home in east Tennessee after nearly six years in the Navy. "I was passing through Kingsport, TN sometime during the middle of the night in my 1987 Dodge Shadow with a full trunk, back seat, and a couple of guitars in the passenger seat. It was drizzling rain and very wet outside. A young Kingsport city policeman pulled me over and asked several questions about where I was going, what was I doing out so late, and if I had anything in my car he should know about. I told him that I was on my way home after completing my enlistment in the Navy, and that I had nothing illegal in my car. A second police car showed up.

"The young officer asked if I cared if he took a look inside my car. I told him to go ahead. He had me sit in his car while he and the other officer removed everything from my car and placed it in the emergency lane on Highway 11-W.... Everything I owned was wet. Clothes, guitars, cameras, tools, and all of my paperwork."

Suddenly, the cops got called to investigate a traffic accident. They left Wes

can. And you are NOT on a level playing field. It is generally illegal for you to lie to police, though it is perfectly legal, and commonplace, for them to lie to you. If you lie to them, even inadvertently, it's a crime."

This crusade of "fishing" to convict mostly innocent people via car searches is one of the most unconscionable crimes anyone can imagine. It must be stopped. We are in desperate need of a law that specifically prohibits any law enforcement officers from even asking to search any vehicle for any reason.

SOCIAL SECURITY ADMINISTRATION (SSA) SERVICES IN MONTGOMERY

The services available at your local field office are fairly standard. You can perform simple services like requesting a replacement Social Security card or more complex things like applying for Social Security Disability benefits. Here are some of the services available at your local Montgomery, Alabama office:

- Request a new or replacement Social Security card
- Request changes to your Social Security card
- Review your Social Security statement or earnings history
- Estimate your retirement benefits
- Get a copy of your proof of benefits
- Apply for Social Security retirement benefits
- Apply for benefits for Supplemental Security Income (SSI) or Social Security Disability Insurance (SSDI)
- Apply for Social Security spousal or survivor benefits
- Apply for Medicare or get a replacement Medicare card
- Set up direct deposit for your Social Security benefits

Online Services

To make things easier on you, many services today can be completed online without a trip to your local office. Not only does this usually result in faster processing of your request, but it also makes things much simpler because you never even have to leave home. Today, you can do everything from viewing your Social Security statement to applying for benefits online. A more complete list of the online services available is shown below.

How does Coronavirus (COVID-19) impact Social Security?

Due to COVID-19, many local field offices are closed to the public. In most cases, you can call the office to schedule an appointment if you need to complete a transaction that can only be done in person. Otherwise, you will need to take care of your situation over the phone with the central office or online through the Social Security website.

How do I make an appointment with the Montgomery, Alabama office?

Even in situations where your local office is open normal hours, it is always better to schedule an appointment to help cut down on your wait time. You can call the Montgomery, Alabama office at 1-866-593-0914 to schedule your appointment. When you make the call, they can also let you know what documents you need to bring to your appointment.

What kind of documentation do I need to bring?

The documentation that you need to bring along varies depending on what it is you are trying to do. At a minimum, you will need some form of identification. This might be a driver's license, U.S. Passport, or state-issued non-driver's identification card. You might also need your current Social Security card and even your birth certificate. It is usually best to take everything you can even if you are not sure whether you need it. It is better to carry documentation that is not needed than to arrive without the proper documentation.

Where is the Montgomery, Alabama Social Security office located?

The Montgomery, Alabama SSA office is located at 4344 Carmichael Rd Suite 100. This is where you will go when you need to complete any of the services that have been mentioned above.

How do I apply for Social Security benefits?

You will need to complete an application for benefits. This can be done online, in person, or over the phone. The application process is necessary whether you are applying for retirement or disability benefits. You will need your Social Security number and other required documentation to complete your application.

How can I check my Social Security benefits?

The easiest way to check your benefits is by logging into your My Social Security account online through *www.SSA.gov.* Once you get logged into your account, you can view benefit statements, benefit estimates, earnings history, and the status of any pending applications. That site should be your goto for any information related to your Social Security account.

Back in 1932, during the hight of the Depression, "Rough and Tumble" Theodore Lawrence (TL) Bear formed the Bear Lumber Company on East Jefferson Street. As the lumber and construction company grew, TL expanded into millwork and real estate. Bear was elected to the school board and served as chairman. What to do this weekend. Having a hard time deciding what to have for your next meal?

Don't cook! This is the season when it is sometimes too warm to cook and too cold not to cook. So when it is just a lazy time and you can't make up your mind what to do, just don't cook. Instead of cooking, prepare a dinner or lunch that can be prepared without cooking. I am sure there are ingredients in your refrigerator that are cooked and can put together to create a meal. Be creative preparing a salad. And since salads are never the same each time you make them, I am not including directions on their preparations.

BIRDS NEST SALAD

METHOD:

Have ready as many crisp leaves of lettuce as may be required to make a dainty little nest for each person. Curl them into shape and in each one place tiny speckled eggs made by rolling cream cheese into shape, then sprinkle with fine chopped parsley. Serve with French dressing hidden under the leaves of the nest.

NO-COOK MEAL PREP CHICKEN SALAD

Recipe Serves: 1

INGREDIENTS:

- 1 cup mixed greens or lettuce of choice
- 3 oz shredded rotisserie chicken (large, sealed bag of rotisserie chicken can be purchased at COSTCO)
- 1 hard-boiled egg (pre-cooked)
- 1/4 avocado, diced (COSTCO also sells a box of individual packaged avocado mash, 2 oz each)
- 1/4 beefsteak tomato, cut into chunks
- 2 Tablespoons red onion, diced
- 1 Tablespoon crumbled bacon (pre-cooked)
- 1 Tablespoon bleu cheese dressing

METHOD:

Pour dressing into a small container with a lid. Combine the remaining ingredients* in a meal prep container and store in the refrigerator until ready to eat.

Notes: Do not add avocado to the meal prep container until the day you are going to eat the salad. It will brown and form a crust on the fruit if

WATERMELON, ARUGULA AND FETA SALAD

INGREDIENTS:

- 1/4 cup freshly squeezed orange juice
- 1/4 cup freshly squeezed lemon juice (2 lemons)
- 1/4 cup minced shallots (1 large)
- **1** tablespoon honey
- 1/2 cup good olive oil
- 1 teaspoon kosher salt
- 1/2 teaspoon freshly ground black pepper
- 6 cups baby arugula, washed and spun dry
- 1/8th seedless watermelon, rind removed, and cut in 1-inch cubes
- 12 ounces good feta cheese, 1/2-inch diced
- 1 cup (4 ounces) whole fresh mint leaves, julienne

METHOD:

- 1. Whisk together the orange juice, lemon juice, shallots, honey, salt, and pepper. Slowly pour in the olive oil, whisking constantly, to form an emulsion. If not using within an hour, store the vinaigrette covered in the refrigerator.
- 2. Place the arugula, watermelon, feta, and mint in a large bowl. Drizzle with enough vinaigrette to coat the greens lightly and toss well. Taste for seasonings and serve immediately.

Southern Gardening Potpourri for October

Is it possible that we are getting back to a normal life? When watching the football games on Saturday, there were many cheering fans crowding the stands, which was good to see. We are certainly ready for some happy times with all the gloom and doom we are hearing in the news.

But there is one thing that has not changed and that is we can still go out of doors and garden without masks. I weeded a flower bed in the misting rain the

other day, the experience was rather fun. And speaking of rain, I think I can be absolutely sure that whatever drought we were experiencing in Alabama over last 2 to 3 years is over. One plus to all the rainfall in the Montgomery area can be summed up to saving on monthly water bills, for those who have sprinkler systems.

Let's turn our attention to the wonderful world of ground covers which in many situations can cover a multitude of problems. I have seen steep slopes in neighbors' front yards that presents problems with cutting if clothed in grass. The problem was solved with monkey grass, which held in the soil and prevented erosion.

Monkey grass (liriope) has been used though out the south to edge everything from driveways, to flower beds, you name it and monkey grass fits the bill. Both the dark green and variegated varieties, I believe are best suited as ground covers, but that is a matter of preference. The barrier that monkey grass creates is so thick that weeds and grass do not cross the line. Whether the area is shady or sunny, monkey grass will thrive. However, monkey grass borders for flower beds distract from the flowers, and gives a weedy appearance. Again, this is just my preference.

Other examples of popular ground covers are as follows: (1) asiatic jasmine (2) vinca minor (3) Blue Rug juniper (4) ajuga (5) pachysandra (6) hosta (7) English ivy (8) clover.

PLANT OF THE MONTH: Pachysandra terminalis

As stated in the prior paragraph, this is used mainly as a ground cover for shady areas. If you have a difficult spot under a tree, this plant may be the solution. When it is first planted, space the plants about 3-4 inches apart for a better and quicker cover. If spaced 12 inches apart, then do not expect cover until after 3 years. The first year not too much spread, but after the second year growth is rapid. An evergreen, and once



there is a complete carpet, rooted pieces taken out of the ground can be replanted elsewhere.

Truth is a wonderful and precious commodity in these days. Statistics show that 92% of Americans speak a lie at least once a day.

Let's all strive to be persons of truth and integrity – it will make our community and our world a better place!

Two of my favorite truth quotes are:

FORMER YOGI, MIKE SHREVE, INSISTS YOGA SHOULD NOT BE TAUGHT IN ALABAMA SCHOOL?

Should yoga be taught as part of the curriculum in the public schools of Alabama? A former teacher of yoga at four Florida universities, Mike Shreve, says, "Absolutely not!" Evidently, some Alabama legislators disagree, because in May of this year (2021), the Alabama Senate and House of Representatives passed a bill, introduced by Democrat Representative Jeremy Gray, lifting the ban on yoga in the public school system that has been in place since 1993.

Apparently, Representative Gray has a vested interest in the passing of this bill because he is a yoga teacher himself and promotes yoga-related concepts through his business called "Elevate Your Grind." In a statement given to the Associated Press, Gray recently proposed, "This whole notion that if you do yoga, you'll become Hindu — I've been doing yoga for 10 years and I go to church and I'm very much a Christian." That sounds convincing, but once you inspect Mr. Gray's belief system, it becomes clear that he does not embrace a traditional, New Testament "Christian" worldview. On his website, he proposes that the result of the study of yoga will be the following:

"Ultimately one must connect with self on a physical plane in order to connect on a spiritual plane wit [sic] God, The Universe, Buddha, Allah, Nuture [sic] or whatever deity we choose."

Mike Shreve was converted to Christianity in 1970 and he immediately shut down his yoga ashram and ceased teaching yoga classes. "The two worldviews are just not compatible," he contends. Countering Gray's point of view, Pastor Mike Shreve offers, "A true biblical perspective does not include all religions, nor does it propose that God and the universe are one. That stems from a Hindu belief called pantheism. Neither can you 'choose any deity you want.' Jesus clearly insisted, 'I am the way ... no one comes to the Father except through Me.'" (John 14:6).

Some lawmakers have recently expressed regret that they voted affirmatively for the bill. "We just didn't realize what it was all about," one commented this past weekend at a statewide Republican gathering.

Alabama was the last of 50 states to have the yoga-ban in place. "That was a trophy on Alabama's shelf that never should have been relinquished," Shreve insists. He also admitted, "I've learned one of the main reasons Alabama continued with this unpopular standard was the combined effort of some key individuals over the last 30 years like: Attorney Eric Johnston of the Rutherford Foundation, Clete Hux of the Apologetic Resource Center in Birmingham, Eunie Smith of the Eagle Forum, and Craig Branch of Watchman Fellowship. Shreve offers, "It's an honor to join with these influencers to once again hold up the banner of truth. Our hope is that Alabama legislators will revisit this bill and be courageous enough to go against this cultural megatrend, as they have in the past, and reverse their decision. It may not seem politically correct to some, but it is definitely philosophically and theologically correct."

It is true that the bill (HB-246) prohibits many overtly Hindu practices like chanting mantras, the use of mudras (symbolic spiritual hand gestures), meditation, guided visualization, using Hindu names for postures, and greeting one another with the Namaste greeting (which means "I bow to the divine in you"—a way of declaring that all human beings are manifestations of God). However, according to a BBC interview, "Mr. Gray ... hopes to remove the unnecessary aspects of these amendments in [sic] future." Which ones does he consider "unnecessary"? Unfortunately, once yoga gets a foothold, these restrictions will most likely erode over time and far eastern religious concepts will infiltrate the school system more and more.

One of the most blatant indications that the bill is unacceptable is the required wording on a permission slip that parents must sign for their children to participate. It reads:

"I am informed that my child (name of child) will participate in yoga instruction at the school named above. I understand that yoga is part of the Hinduism religion."

What? Read that again! Anyone of a different religious persuasion (Christian, Jewish, Muslim, Sikh or any other), should be disturbed by the wording of this requirement. Unknown to most people, the physical exercises (asanas) and the breathing exercises (pranayama) are the third and fourth of eight steps that are supposed to lead a practitioner to God-consciousness (according to the Hindu teacher Patanjali). No wonder, in an interview that described Hinduism as "the soul of yoga," the former managing editor of the magazine Hinduism Today, Sannyasin Arumu-gaswami, warned:

"Based as it is on Hindu Scripture and developed by Hindu sages, Yoga opens up new and more refined states of mind, and to understand them one needs to believe in and understand the Hindu way of looking at God... A Christian trying to adapt these practices will likely disrupt their own Christian beliefs."

Tim James, son of former governor, Fob James, was the concerned Alabamian who first enlisted Mike Shreve's help in the hope of reversing this ruling when the legislature reconvenes. A group of nine concerned leaders met on August 12th to discuss possible ways to accomplish this goal (including some of those who have been in this political jousting match for three decades).

Some of Shreve's strongest arguments are as follows:

"There may be an opt-out clause in the bill, but there are three reasons it will not be effective in protecting the children of Alabama:

(1) Many children will be embarrassed to opt out because of peer pressure and will make the decision to participate in order to avoid being "different";

(2) Once exposed to the fundamental principles of yoga (that primarily involve physical postures), out of curiosity, many will explore the deeper aspects of yoga. This will expose them to beliefs of Hinduism like a pantheon of 330 million gods and goddesses that are worshipped (the traditional number) and the true purpose of yoga, which is the "awakening of the kundalini (the serpent power)";

(3) In many communities, the only persons qualified to teach yoga classes will be certified yoga teachers in the area—most of whom embrace a new age or far eastern worldview. Through the building of teacher/student relationships, they will gain spiritual influence over the children that could ultimately sway them to embrace a different belief system than that held by their parents.
