97th Birthday of WWII and Korean War Veteran: Major Robert Douglas Pike



The 97th birthday of Robert Douglas Pike, a WWII and Korean War veteran, was celebrated March 24, 2022, at Frazer Methodist Church. The special event was sponsored by the American Red Cross as part of its service to the Armed Forces active duty and veterans. Presentations were made in his honor. Brigadier General Jeffry Newton, Assistant Commissioner Operations/ Chief of Staff AL Department of Veterans Affairs, presented a commendation from Governor Kay Ivey. Ed Grimes, Montgomery City Councilman for District One presented a proclamation from Montgomery Mayor Steven Reed declaring

March 24, 2022, to be Robert Douglas Pike in Montgomery. Celso Backes, an Executive in the Administration of the Central Alabama Veterans Health Care System, presented a blanket and a commendation from Amir Farooqi, Director/Chief Executive Officer (CEO) of the Central Alabama Veterans Health Care System.

The patriotic program was highlighted by the Pledge of Allegiance led by American Red Cross Service to the



War crimes are defined by the four Geneva conventions which speak to certain aspects of war crimes. Additionally the Hague convention also speaks to war crimes. War crimes began to be addressed as early as the 1400s.

The International Crimes Court could be a court to address Putin's crimes. While many countries are signatories to the ICC, there are several that do not accept it's jurisdiction. To accept it's jurisdiction could mean that a matter could be taken from the hands of a sovereign nation and tried on an international stage. Interestingly enough Russia does not accept the jurisdiction of the ICC. But neither does the United States or Ukraine.

The Court is a court of last resort meaning it does not hear a case until all other outlets have been exhausted. The Court tries individuals and not nations. Often time they are military leaders that have been tried and even in a few instances have leaders of a country been tried. Individuals brought on charges are not tried "in absentia" and must be present. So for Putin to be tried he would have to be tried in person. That gets pretty tricky because he would either need to be turned over by the Russian people/ government or be snagged after going outside of Russia. I think to snag Putin outside of Russia would be extremely hazardous if Putin is still President. Grabbing Putin would be akin to abducting the head of a state and I think Russia would respond militarily regardless of how despicable he is to many Russians.

Incumbency Prevails in Secondary Constitutional Offices

Incumbency is a potent, powerful, inherent advantage in politics. That fact is playing out to the nines in this year's Alabama secondary constitutional and down ballot races.

Several of the constitutional office incumbents do not have Republican or Democratic opposition. Of course, having a Democratic opponent is the same as not having an opponent in a statewide race in Alabama. A Democrat cannot win in a statewide contest in the Heart of Dixie.

Lt. Governor Will Ainsworth will be elected to a second four-year term without opposition. He will be waiting in the wings to follow Kay Ivey as Governor.

Agriculture Commissioner Rick Pate will be reelected without opposition. He has done a good job in this important state post.

State Treasurer Young Boozer is running unopposed for another four-year term. He does an excellent job and is uniquely qualified for the Treasurer's job.

State Supreme Court Justice Kelli Wise is running for reelection unopposed. Kelli is popular and is a good jurist. She is home free for six more years on the state's high tribunal.

Attorney General Steve Marshall has token opposition in his run for reelection. One Republican and one Democrat qualified against Marshall. However, he will coast to reelection.

There are two seats up for election on the Alabama Public Service Commission. There are three seats on this regulatory panel. The President of the PSC runs in a presidential year. Twinkle Cavanaugh is President and pretty much runs the ship. The two incumbents are Jeremy Oden and Chip Beeker. Oden has two unknown Republican opponents. Beeker has two opponents in the GOP Primary. One has some name identification, who has run before. Beeker and Oden will probably win reelection.

There are only three hotly contested and interesting secondary statewide races. That is because these three posts are open without an incumbent on the scene.

Popular Supreme Court Justice Mike Bolin, the former Probate Judge of Jefferson County, is term limited by an antiquated law that prohibits a judge

from running for the court after age 70. There are two qualified candidates seeking to follow Judge Bolin. Birmingham Defense Attorney Greg Cook is facing Anniston Circuit Judge Debra Jones. Cook appears to be the favorite to win. It is apparent that the business community in the state is backing Cook. He has also been endorsed by the Alabama Farmers Federation. The latest campaign finance reports reveal Cook has \$552,000 to spend compared to Jones \$15,000.

The State Auditors position is open. Jim Ziegler has served his eight-year stint. This will be an interesting three-man race for this benign position. Former Mobile State Representative and State Senator Rusty Glover is facing Muscle Shoals State Representative Andrew Sorrell and Jefferson County Pastor Stan Cooke. All three are getting out and working the state.

The race to succeed John Merrill as Secretary of State will be a good race. Merrill is term limited after eight years. State Auditor Jim Ziegler is wanting to move next door in the Capitol and become Secretary of State. Because of his name identification advantage, Ziegler will be favored to win the race. However, he will get a significant challenge from State Representative Wes Allen.

Young Wes Allen has been running for over a year and has a good many significant endorsements including Alfa. He has an impressive resume having served a decade as Probate Judge of Pike County and four years as a State Representative. He also has two home bases. He has lived and served in office in Troy in Southeast Alabama and was born and raised in Tuscaloosa where his father Gerald Allen has been a long time State Senator.

Ed Packard, who has run the Elections Division of the Secretary of State's office for decades, is also running. He is very well qualified.

The aforementioned current Secretary of State, John Merrill, is not seeking any elective office in 2022, even though he is still relatively young. I have said this before and it holds true today, Merrill is currently the best and most prolific retail politician in the state and one of the best I have seen in Alabama. He has a real grassroots organization in Alabama. He is literally everywhere. Even though he is not on the ballot running this year, he is out working every candidate mentioned in this column. You have not heard the last of John Merrill.

Justice Will Sellers

Had she lived, the Queen of Soul would have been 80-years-old in March. For at least 60 of her 76 years, Aretha Franklin shared her vocal gift all over the world. In addition to bringing her both critical and commercial success, her voice became a symbol for a new generation of Americans.

Older generations rooted in staid and static smugness frowned upon popular culture for breeding new forms of entertainment and activism, which promoted an expression of unique, differing and contrasting ideas.

Utilizing the appeal of her voice, Aretha would challenge numerous pre-conceived notions, and the acceptance of her music would push boundaries that had previously limited others based upon race, sex, religion, and politics. She created a following that was first attracted to her vocal virtuosity but later came to accept her change agent status.

After her birth in Memphis, her family joined the throngs of the Northern Migration to Detroit to escape the overt racism of the day and embrace the promise of greater economic opportunity. Her first performances were at the church that her father pastored, and while she considered Detroit her home, she never became part of the "Motown" sound. Commenting on her life, Barry Gordy recalled seeing her sing and play the piano as a little girl. How she escaped Gordy's talent search is remarkable. Initially, her commercial success was not readily apparent as her first records under the Columbia label failed to chart. It was only when she switched to Atlantic records and the influence of Jerry Wexler that her career took off. After almost ten lackluster Columbia albums, Wexler paired her with Rick Hall's Fame Studio in Muscle Shoals, Alabama. After that providential decision, her career took off and she never looked back. Remembering Aretha requires focusing on more than just the appeal of her music; it is also about her as a person, the times in which she lived, and the influence she had. For most musicians, having a voice with a range of Aretha's would be enough, but she also understood the nuances of music and how to write songs from her life experiences that conveyed strong emotions with a powerful cadence and drew people to her. She was also talented enough to realize that she could take the works of others, change them, and make them her own. In fact, her signature song, "Respect," was written and initially recorded by Otis Redding. Aretha's interpretation changed the song and the meaning to not merely ask for respect, but to demand it. This respect was not limited to Redding's spousal relationship, but was about American society at large, the dignity of the individual and being accepted as an equal. After all, what most people really want is respect; an acknowledgment that they are significant and that they matter. In the 1960s, that was strong medicine. Her songs increased the acceptance of the civil rights movement among baby boomers, but also caused friction in families caught in the middle of cultural and social change. It is hard to believe now, but initially her record covers avoided featuring her photo so as not to offend parents of white youngsters. But Aretha, like Miles Davis and other Black artists, demanded this "white washing"

notion that raw talent could defeat discrimination. Her acceptance in the world at large helped spread American popular culture and promoted American values not only among our allies, but also our enemies.

cease, and the album covers that followed removed another vestige of racism in the recording industry.

Aretha's support for social change was more subtle in that she crashed through racial barriers because her music appealed to all audiences. The clear implications of her concerts and the success of her records was that racial discrimination had no place among the new generation. Her support for racial equality would become more pronounced as she used her broad appeal to advocate for change and equal opportunities.

And the breadth of her success and the

popularity of her music would support the

In fact, it was a custom among Russia and its Soviet Union to dwell on issues that divided Americans. The Kremlin was a master at sowing seeds of discord among and within western democracies. Popular culture was one vehicle to highlight the shortcomings of the West in general and America in particular. But culturally Russia was unable to compete with American post-war pop culture. In the past, it was a matter of strategy to invite a Paul Robeson or Marian Anderson to perform and point out how they were mistreated in their home country, but Soviet youths, much like American teenagers, were ready for something different. Not everyone accepted Soviet entertainment, and any Soviet pop culture had a sell-by date of 1930 something. Aretha, among other artists, was their worst nightmare. From her style of music to her success and acceptance, there was nothing to exploit. The Soviets would try to create their own statist Russian pop culture, but it simply could not compete with Aretha and America. The sounds of young America flooded the worldwide airwaves, and there were not enough jammers to stop the infiltration of these new sounds and innovative musicians. Initially there was an attempt to ban the music, but few could resist Aretha and so many others. But worst for Soviet ideology, she represented the democratic spirit of America that accepted musicians based on performance ability and popular appeal. There was no way to use Aretha as an example of talent suppressed based on race to contrast America and Russia. Even their young people liked what they heard and attempted to imitate the music and style of Aretha, but under the Soviet system, there was no chance for a Russian popular artist to achieve similar success.

While there are myriad causes for the end of the Cold War, Aretha and other scions of American popular culture helped win the global culture war one note at a time.

There are few people we can trust to judge our past leaders with much accuracy. Most scholars correctly rate Washington and Jefferson at or very near the top. But these same "scholars" have very often ranked some of our very worst up there with them. Nearly all of the

popular polls and lists are very wrong.

Sadly, these people have used the wrong procedures in making their judgements. Most have used the quantity of their "accomplishments" in their ratings instead of differentiating the great and good ones from the bad, the terrible, and the treasonous.

The criteria used to correctly rank any president or any public officials are the things that protect our liberty. How well did he uphold the principles of the U.S. Constitution-individual rights, minimal taxation, limited spending, minimal regulation, minimal intrusion onto people's lives, and most importantly, safeguarding our freedom and leaving well enough alone. In our history, only a few have performed well in upholding these sacred ethics—since about1850, less than a handful.

Who can we claim as great presidents? The list is rather short. It includes Washington, Jefferson, Madison, Monroe, Jackson, Cleveland, and Coolidge.

The tyrannical ones include Lincoln, Wilson, Franklin Roosevelt, Lyndon Johnson, both Bushes, Bill Clinton, Barack Obama and Joe Biden.

Most of the rest rank from poor to acceptable.

One of the very few writers who has correctly judged our past presidents as protectors of liberty is CHUCK

Lyndon B. Johnson **BALDWIN**, who writes articles for Lew Rockwell. I have not yet found his writings on our best, but "My List Of The Ten Worst U.S. Presidents" is dead right. He based his judgements on the very issues that mattered most on keeping our nation strong and free. The list pre-dates Joe Biden, who would have certainly made it today. 1. ABRAHAM LINCOLN: In my mind, I can hear people screaming, "Oh no! Not the great emancipator!" But in truth, Lincoln was the greatest and most vicious TRAITOR in American history. Baldwin said, "Abraham Lincoln is America's absolute worst President. He did not free a single slave, but what he did do was begin the process of enslaving free men....It is no hyperbole to say that Lincoln truly governed as a dictator, not as a President." Lincoln was responsible for violating every constitutional restraint on his office, including imposing our first income tax, denial of habeus corpus, conscription (a form of slavery), and waging the bloodiest and most brutal war ever fought on American soil. Over 600,000 people died in conflict, and probably at least that many more in collateral damage, starvation, disease, and destruction of infrastructure. Sherman's march through Georgia alone was a war crime of epic proportions. Lincoln's goal was NOT to free the slaves. He frankly admitted that he did not care one way or the other. His objective was to "restore the Union"-to conquer the seceded states and subjugate them back into the Union-to repeat what King George III had attempted to do with the American colonies. Baldwin stated, "There really wasn't a 'bad' President before Lincoln. But with Lincoln as a model and with the constitutional restraints against an imperial presidency left torn to shreds, we haven't had an abundance of 'good' presidents since him " 2. WOODROW WILSON: February 3, 1913 is another date that will live in infamy—the ratification of the hated 16th amendment that enabled the federal income tax. It didn't even include a cap to prevent its rate from running away.

Like FDR, LBJ was a devout socialist. His Great Society imposed draconian inroads onto our free enterprise-shutting much of it down and replacing it with social-welfare abominations.

Chuck Baldwin states: "Before Johnson's 'Great Society,' black families were largely intact, and out-of-wedlock births were an exception to the rule. Not any more! Now, over 70% of births in the black community are out of wedlock. For all intents and purposes, Johnson's 'Great Society' replaced black husbands and fathers with Uncle Sam and took away the black man's self-respect and dignity. No wonder today's black males comprise such a large percentage of the prison population."

LBJ created the Gun Control Act of 1968, setting the stage for our numerous subsequent second amendment violations.

Besides JFK, LBJ is also a prime suspect in the assassinations of Robert Kennedy and Martin Luther King. Why? They were strong opponents of his Vietnam War and stirring up too much resistance.

5. GEORGE W. BUSH was a devout warmonger and did his utmost to intensify the brutal carnage that Reagan and Clinton had supported in the Middle East. He began a "preemptive war" doctrine and bombed Iraq and Afghanistan. He created the oppressive Patriot Act, Homeland Security, the Military Commissions Act, and the TSAI. He expunged Posse Comitatus, seized two American citizens, and held them indefinitely without a trial. Bush's brutality destabilized the entire Middle East.

6. BARACK OBAMA continued the Bush atrocities in the Middle East and forced many thousands of refugees to flee. He transported many of them into America with no regard that many could be dangerous and even potential terrorists. He released five of GITMO's most dangerous inmates in exchange for one American deserter.

Obama placed our tax and spend policies into overdrive. He more than dou-



bled our national debt—from less than \$9 trillion to over \$19 trillion. He created the infamous "Affordable Care Act" (Obamacare) that was mandated onto nearly every American, whether he could afford it or not. As a result, American health care has suffered and costs have skyrocketed.

He prolonged the great depression by imposing a minimum wage that shut out poor people from obtaining employment, forcing millions to sign up for his unconstitutional relief programs. He did his utmost to pack the Supreme Court. He also created the first restriction against our right to keep and bear arms (outlawing fully automatic firearms).

Of course, knowing that the people would never tolerate another war, he set up Pearl Harbor as a bait and goaded Japan into bombing it. He ordered conscription and rounded up all Japanese-American citizens into concentration camps.

4. LYNDON JOHNSON is the prime suspect in the assassination of John Kennedy (He knew that was the only way he could become president). Once JFK was out of the way, he escalated the Vietnam War to enhance his interests in the military industrial complex. Thousands of Americans were conscripted and needlessly killed as a result.

7. WILLIAM JEFFERSON CLINTON has done some warmongering in Bosnia and Kosovo. But his cruelest crime was a military raid onto David Koresh and his Branch Davidians, who had established a complex near

Waco, Texas, and just wanted to be left alone. Clinton claimed they had been stockpiling illegal weapons and were about to start a conflict. He sent ATF and FBI agents with helicopters, tanks and armored vehicles to rout them out. They shut off their utilities, and for 51 days, they continually played loud noises to prevent them from getting any sleep. Some of the more notable quotes/text from Hannah Lester's **Observer** [3-10-22] https://opelikaobserver.com/jay-jones-inducted-aspresident-of-sheriffs-association/ report on President Jones' induction ceremony were giving credit to a mentor in the Lee County Sheriff's Office, Major Carey Torbert. "When I first started at the sheriff's office a couple of years ago, this fellow took me under his wing and he looked out for me," Jones said. "... He has over 50 years association with the Lee County Sheriff's Office, and I'm just telling y'all right now, that man's probably forgotten more about how to run a jail, what a sheriff does in office, than most folks will ever learn in their lifetime. He's a special man and a truly, truly good friend. Major I've said it, we've talked about, but I'm going to say it to the public right now, like I have before. I wouldn't be where I'm at without you, sir.

"We're sheriffs, No other position in law enforcement, but the provision of law and the insurance of public safety is as unique as the office of sheriff. We share the mission of protection of our communities with our law enforcement partners, our colleagues, and cities and states, and around our country. But none of them, I would offer for your consideration, share the exact same relationship that we do to those that we serve. We are here because it is their choice, those people that we serve. It's not a panel, it's not a commission, it's not a council, but the vote of the citizens who we serve. No higher honor exists than to be hired directly by your neighbors, your friends and even people who have never met you, but they've heard you speak, they've talked to someone who does know you and decided, you know what, that you're the one they want to be their sheriff. An honor indeed." Chris Taylor's [3-13-22] *Lee County Bulletin* report [*https://www.leecountybulletin.com/post/lee-county-com-mission-failed-to-strip-citizens-of-their-rights*] offered some different observations. Addressing the dynamics of pay raises, Taylor wrote, "The Sheriff's appeal to adopt



the resolution to limit the people's Constitutionally Protected rights has proven unsuccessful. But, his appeal seems to have been rewarded with a 25% raise from the county, not revealed until AFTER candidate qualifying closed which may have induced others to run had they known of the raise when deciding to run. Some recall this Sheriff's prior 16% 'out of cycle' raise after espousing belief in Mike Hubbard, who was under indictment in the jurisdiction Jones held the highest law enforcement position."

CRIMES WITHIN THE JURISDICTION OF THE ICC

WHICH CRIMES FALL WITHIN THE JURISDICTION OF THE ICC?

The mandate of the Court . . . to hold such persons accountable for the most serious crimes of concern to the international community as a whole, namely the crime of genocide, war crimes, crimes against humanity, and the crime of aggression.

WHAT IS GENOCIDE?

According to the Rome Statute, "genocide" means any of the following acts committed with the intent to destroy, in whole or in part, a national, ethnical, racial or religious group:

- killing members of the group;
- causing serious bodily or mental harm to members of the group;
- deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part;
- imposing measures intended to prevent births within the group;
- forcibly transferring children of the group to another group.

WHAT ARE CRIMES AGAINST HUMANITY?

"Crimes against humanity" include any of the following acts committed as part of a widespread or systematic attack directed against any civilian population, with knowledge of the attack:

- murder;
- extermination;
- enslavement;
- deportation or forcible transfer of population;
- imprisonment;
- torture;

• rape, sexual slavery, enforced prostitution, forced pregnancy, enforced sterilization, or any other form of sexual violence of comparable gravity;

• persecution against an identifiable group on political, racial, national, ethnic, cultural, religious or gender grounds;

enforced disappearance of persons;

• the crime of apartheid;

• other inhumane acts of a similar character intentionally causing great suffering or serious bodily or mental injury.

WHAT ARE WAR CRIMES?

"War crimes" include grave breaches of the Geneva Conventions and other serious violations of the laws and customs applicable in international armed conflict and in conflicts "not of an international character" listed in the Rome Statute, when they are committed as part of a plan or policy or on a large scale. These prohibited acts include:

- murder;
- mutilation, cruel treatment and torture;
- taking of hostages;
- intentionally directing attacks against the civilian population;

• intentionally directing attacks against buildings dedicated to religion, education, art, science or charitable purposes, historical monuments or hospitals;

pillaging;

rape, sexual slavery, forced pregnancy or any other form of sexual violence;
conscripting or enlisting children under the age of 15 years into armed

forces or groups or using them to participate actively in hostilities.

WHAT IS A CRIME OF AGGRESSION?

As adopted by the Assembly of States Parties during the Review Conference of the Rome Statute, held in Kampala (Uganda) between 31 May and 11 June



2010, a "crime of aggression" means the planning, preparation, initiation or execution of an act of using armed force by a State against the sovereignty, territorial integrity or political independence of another State.

The act of aggression includes, among other things, invasion, military occupation, and annexation by the use of force, blockade of the ports or coasts, if it is considered being, by its character, gravity and scale, a manifest violation of the Charter of the United Nations.

The perpetrator of the act of aggression is a person who is in a position effectively to exercise control over or to direct the political or military action of a State.

In the context of war it is interesting to consider what events are more horrid than killing other people with not just small arms and bombs or missiles, but weapons that wreak such havoc on people that is more unconscionable than the usual rigors of war. When you include vulnerable non combatant civilians being targeted it is especially sickening to the senses. But within the realm of combatants it is criminal to kill prisoners of war or to kill those under a flag of truce. It is interesting that one can shoot paratroopers landing to fight but one cannot shoot one parachuting down from a disabled aircraft or shoot survivors from a disabled or sinking combatant watercraft.

War crimes are not wholly found as being perpetrated by our enemies in history but by American soldiers as well. Consider the massacre at My Lai during the Vietnam war where Americans under the command of Lt. Calley and Capt. Medina killed over one hundred villagers. Calley was jailed for awhile until pardoned by President Nixon for time served.

Consider Union General Sherman and his march to the sea. Targeting civilians in a manner to destroy the homes, livestock and crops of southern civilians and even the rape of women, mostly aimed at African American women. Sherman was never tried for crimes and of course neither was Grant who was complicit as was Lincoln who was assassinated.

One writer writing about a United States military officer during World War II referenced the trials of certain Nazi's at Nurembourg pointed out that atrocities that may be committed by the winners in a military conflict may be overlooked but not those of militaries defeated. A military officer exclaimed that had it not been for an American and allied win, it would have been allied officers on trial at Nurembourg. A Union victory in the War Between the States kept Sherman and other Union officers and Lincoln if he would have survived from being tried for war crimes.

Looking at the ICC definitions of war crimes, I think it is undeniable that Putin is a war criminal and almost forty countries have pressed war crimes on Putin. Being able to bring Putin to trial is another matter and would have to be able to reach beyond a Russian court without invoking a Russian military response.

Lysander Spooner: Northern Abolitionist and Supporter of Southern Independence

Court historians and perpetuators of the righteous cause myth have devoted much attention to the abolitionist John Brown. Heavily financed by the Secret Six (mainly Northern Industrialists and Unitarians), Brown led a rag-tag band of murderous misfits. The first person they killed in Virginia was Heyward Shepherd, a highly respected free Black man intelligent enough to not join

their gang. Brown was eventually arrested, tried, convicted, and hanged for committing treason against the Commonwealth of Virginia. Conversely, Northern abolitionist Lysander Spooner has received minimal attention, with that coming mostly from libertarian circles. Spooner sympathized with Brown in many ways, did not oppose the use of violence, and equally despised the slave labor system; however, as an "individual anarchist" he also understood the Jeffersonian concepts of consensual government and peaceful secession. Murray Rothbard described Spooner as "the last of the great natural rights theorists..."

Born in Athol, Massachusetts, Spooner grasped why the North would not tolerate Southern Independence. He also understood the bigotry in his region where they generally viewed Blacks as undesirable and best left confined to the Southern and Border States. Realizing the schism was driven by economics, banking and political power, Spooner knew Northerners would not invade the South over slavery, stating: "The pretense that the "abolition of slavery" was either a motive or justification for the war, is a fraud of the same character with that of "maintaining the national honor." He noted the government itself had aided and abetted the institution of slavery and suddenly, with the departure of the Southern States, their motivation to abolish it was "as a war measure." Thus, using Blacks to fight for the "regime" was important in maintaining political and corporate power. The goal was "industrial slavery," which includes all racial and ethnic groups. (As H.L. Mencken later noted.) Spooner also recognized that forcing people to live under a government they had rejected was a form of slavery itself.

A vocal skeptic of the U.S. Constitution, Spooner felt the document and/or its manipulation played a role in perpetuating slavery. He recognized the commercial interests of the North saw an independent South as a financial calamity. Abraham Lincoln, an adept corporate lawyer, helped the railroad industry enormously through numerous successful lawsuits. Lincoln's backers said a "free trade" South must be stopped. Spooner also saw control of Southern markets as a motivating factor for Northern corporate interests. Thus, various attempts were made to appease Southern and Border State slaveholders. Spooner often referenced "blood money" associated with loans from Northern banks that helped prop up slavery. Northern control of Southern markets also had a direct relationship to currency monopolization. As noted by James Garfield (and others), "He who controls the money supply of a nation controls the nation." This would provide iron-fisted control over industry and trade and keep all workers enslaved within the system.

The denial of Southern Independence required a propaganda platform so the North's corporate and banking complex could "glorify" their accomplishments under the ruse of ending slavery. Spooner saw through it: "Their pretenses that they have 'Saved the Country,' and 'Preserved our Glorious Union,' are frauds like all the rest of their pretenses. By them they mean simply that they have subjugated, and maintained their power over, an unwilling people...as if an enslaved and subjugated people – or as if any people kept in subjection by the sword (as it is intended that all of us shall be hereafter) – could be said to have any country." Indeed, Lincoln's so-called "preservation" was literally the conquerors versus the subjugated, i.e., his was an involuntary Union, the complete antithesis of the original voluntary confederation of American States.

Spooner further observed, "All these cries of having 'abolished slavery,' of having 'saved the country,' of having 'preserved the union,' of establishing 'a government of consent,' and of 'maintaining the national honor,' are all gross, shameless, transparent cheats -- so transparent that they ought to deceive no one – when uttered as justifications for the war, or for the government that has succeeded the war, or for now compelling the people to pay the cost of the war, or for compelling anybody to support a government that he does not want."

Lincoln was instrumental in turning the country over to corporate and banking interests. In our era, Big Pharma, mega-corporations, the Military Industrial Complex, and their media lackeys exercise undue influence over an often naïve public. It is unlikely that Lysander Spooner will be given credit for identifying this recurring phenomenon. In his day, the government was manipulated and largely controlled by the railroads, steel/iron companies, and banking interests. Crisis in National Character: What are We Becoming?

Much is being written in the areas of law and ethics the "character" of corporations, their corporate cultures, whether the corporation is a moral agent, etc. These writings focus on Aristotle and Virtue Ethics,

Immanual Kant and Kantian Ethics, externally imposed Corporate Compliance and Ethics Programs mandated for public corporations by the Sarbanes-Oxley Act, and external evaluations by courts when following the United States Sentencing Commission's guidelines for the sentencing of organizations.

However, very little attention, if any, is paid by the academic writers to the cultural environments in which our corporations operate and function and the effects of those cultural environments on corporate character. Some recent writers are, however, acknowledging the deleterious effects of "wokeness" and how corporate leaders are bending at the alter of wokeness and modifying their corporate philosophies under the guise of "Corporate Social Responsibility" (CSR) which has been the mantra for corporations and management teaching in business schools for years. The umbrella of CSR has provided corporate leaders "cover" to change the course of their corporations from a focus on shareholders to a more broad social focus. While that is certainly acceptable if the focus is on the recognition of social and moral obligations (not legal) to the more broad communities to which corporations might have moral obligations, corporate leaders are using the cover of that umbrella to rationalize their turn to wokeness.

This turn has been recognized by the following authors in their noted books: Stephen R. Soukup, The Dictatorship of Woke Capital: How Political Correctness Captured Big Business (2021); Vivek Ramaswamy, Woke, Inc.: Inside Corporate America's Social Justice Scam (2021); and Ben Shapiro, The Authoritarian Moment: How the Left Weaponized America's Institutions Against Dissent (2021). This move has been supported by academia and graduates of certain universities who are now populating levels of corporate management as recognized by Greg Lukianoff and Jonathan Haidt in their book titled The Coddling of the American Mind: How Good Intentions and Bad Ideas Are Setting Up a Generation for Failure (2018). The effects of this drift on the quality of citizenship has also been articulately recognized by Victor Davis Hanson, the Martin and Illie Anderson Senior Fellow in Military History and Classics at the Hoover Institution at Stanford and Professor Emeritus of Classics at California State University in his book titled The Dying Citizen: How Progressive Elites, Tribalism, and Globalization Are Destroying the Idea of America (2021).

These authors and others are taking high profile positions that certainly are not in this present day politically correct or woke-sanctioned to call our collective attention to the eating away of the American culture by conscious and calculated strategies by the Left to undermine the institutions in which we have always had trust and felt a degree of security and stability which are essential to the proper functioning of our form of government. If the Left can undermine our institutions, our trust in those institutions, and our sense of security and stability arising from them, which have always contributed to our national character, then a vacuum will be created which the Left will rapidly fill with an authoritarian philosophy.

Examples of this strategic undermining are the undermining of our law enforcement system, our legal system, the rule of law, and the attack on First Amendment values in our universities through the advent of vague and overbroad speech codes, free speech zones, and "safe places" where the tender emotions of our future "leaders" are not bruised.

American businesses that were once the last bastions of a free people who believed in free markets and the central importance of private property are now adrift to the authoritarian Left. The solution, if Americans still want a solution, is multi-faceted and complex. However, I suggest that one component of the solution must come from the faith community to help restore the moral values that are the glue that binds a moral people together and tethers a society to something beyond the natural self-serving tendencies in human nature.



Faulkner University Announces **New President**

Faulkner University is pleased to announce Dennis Mitchell Henry, J.D. as the University's newest president. Faulkner's Board of Trustees Chair Dale Kirkland and Chancellor Billy Hilyer made the announcement on the Montgomery campus on March 9, 2022.

Henry is Faulkner's 9th president in its 80-year history.

Out of 26 candidates, Henry was unanimously accepted as president-elect by the university's search committee and Board of Trustees on March 8, 2022.

Currently serving as an Associate Professor at Faulkner University, Henry teaches law to undergraduate and graduate students. He has also taught dispute resolution as an adjunct law professor at Faulkner's Thomas Goode Jones School of Law and thus knows the Faulkner community and the university's mission well. In addition, Henry serves as Professor of Practice in Auburn University's College of Agriculture, Department of Agriculture Economics and Rural Sociology, teaching agriculture law.

While teaching, Henry maintained his law practice, is a 29-year practicing attorney, and a founding member of Webster, Henry, Bradwell, Cohan, Speagle, and DeShazo, P.C. His practice has specialized in insurance defense, business litigation, estate planning, and agriculture law. He's also previously worked closely with Faulkner University's legal counsel.

"When we invite individuals to become a part of this Faulkner family we are looking for those who not only have the ability to perform well the tasks by which they are assigned," Hilyer said. "But more importantly we are looking for those who have character and desire, the heart and the passion to help us accomplish this mission to glorify God. In light of this mission, they must be individuals who love God, His word and who endeavor to walk with Him each day."

Prior to the announcement, Henry and his wife Cindy had prayed for a way to become more involved in ministry. Henry views Faulkner as his mission field.

"What does education look like at Faulkner University if developing moral character is the supreme end of education?" Henry asked. "What does that truly look like in this place? We teach, we train, we launch, and we support ministers. Not just preaching ministers, but ministers who are vocational ministers, who minister in their work. We develop Christian nurses. We develop Christian businessmen and women. We develop Christian physical therapists. We develop Christian physician assistants. Christian teachers. We develop Christian folks that work in every possible occupation, and along the way, we do develop Christian ministers who preach. If that's not enough to impress you, we develop Christian attorneys. So, how do we teach trade and launch these folks to be ministers in their vocations?"

"First, at Faulkner, we encourage young people to identify careers where they can serve the greater good, where they can share the gospel of Jesus Christ. We develop young people looking for careers and encourage them in ways that are truly intangible, things you can't teach in a book," Henry added.

Toward the end of the announcement, Faulkner President Mike Williams, who will be stepping down on May 6, 2022, passed a gold-colored baton to his successor.

"As I view academic presidency, it's not a marathon, it's not a sprint, it's a relay race," Williams said. "When you assume the presidency of Faulkner University, Mitch I'm glad you understand this, is that you cannot take the presidency of Faulkner University and not feel deeply committed to ten individuals who met on April 13, 1942 at the Panama Street Church of Christ when they decided to launch the Montgomery Bible College. And it's not just a linkage backward, it's a linkage forward. The baton reminds me that the decisions made in this moment is not just about today, but it has deep implications for the future."

On October 27, 2021, Faulkner began the search for a new president following President Mike Williams' announcement to step down as president of Faulkner University at the end of the spring semester to start his new role as Harding University's president in June. Henry, who will begin his new role in May, is a former Elder of the Vaughn Park Church of Christ where he continues to teach Bible and serve. Henry and his wife Cindy have three children, Mitchell - wife Rebecca Mann Henry, Lauren - fiancé Chase Thigpen, and Ashby. Mitch and Cindy reside on Prairie Oak, their family farm located in Hope Hull, Alabama.

Southern Gardening

Not too long ago a small child told me there were 2 holidays this April – April fool's day and Easter. How cute is that statement.

Judge Peggy Givhan

One of my favorite expressions is "April showers bring May flowers." This is my rule of thumb in the garden setting as to when I sow seed and set out small plants. Usually by mid March to late March, the chances of a hard freeze dissipates, so I begin sowing

seed and setting out plants for spring and early summer garden. Once these seedlings and plants get established before the heat of the late spring and summer months, the less problems down the line. Good care including the right soil, correct amount of light, water, fertilizer, and weed free environment will produce stronger and healthier flowers. Some people advocate heavy mulch in the beds to conserve water in the summer, but I only mulch those areas of the beds which will lay dormant in order to smother weeds which lessens the task of weeding. The mulch I prefer is pine straw since this will rot down and enrich the soil. Some seeds that I have sown include Cleome, Zinnia-Pacific Giant, Alyssum for a snowy white border, and Cosmos. Except for the Alyssum, the others, which are at least 3-4 feet in height, make a dramatic show towards the back of the beds. I also have sown Old-fashioned Poppies and Larkspur last fall for late spring bloom. How do I know where these seeds have been sown? I look at my flowerbed plan that I keep nearby in a desk drawer.

When I gave myself a critique of last summer's flowers, I will plant more Pentas or Egyptian Star-Cluster. A Victorian-age perennial, with vibrant colors of pale pink, white, deep red, and bright fuschia, has an added value for attracting butterflies. Pentas are of medium height and grow best in a hot climate. They are available in garden centers and at big box store garden departments. Try to

> plant them now and you will have large swaths of color until they freeze. Lamb's ear or stachys is one of my all time favorites for the front border of the beds. A hardy perennial with long hairy gray-green fleshy leaves lends much texture and interest to the beds. They are drought tolerant, and will die back when they are over watered.

PLANT OF THE MONTH – MELAMPODIUM

This is one of a very few flowers that has the same name for both the common and the official name. What a great hot summer mounding filler for the flowerbeds. It has been named one of the top 10 summer flowering annuals of all time. With buttery small yellow flowers, which do not hold its dead heads, produces masses of daisy-like flowers from summer until fall. The foliage is a deep dark green and forms mounds 2-3 feet in height. It does require heat to thrive, something we certainly have plenty of.

Courage is defined as "the ability to control fear and to be willing to deal with and face something that

is dangerous, difficult or unpleasant." Another source defines courage as "the quality of being brave: the ability to face danger, difficulty, uncertainty, or pain without being overcome by fear or being deflected from a chosen course of action."

This certainly describes Jesus Christ, especially during Holy Week as he faced the brutality of the Roman form of execution on a wooden cross. We often use words like unconditional love, amazing grace, and self-sacrifice to describe Jesus. These are very accurate phrases to explain his compassion for us and for everyone in the world; however, we do not normally hear the word courageous to characterize Jesus and the incredible bravery he showed as carried out his mission undaunted by the opposition and the punishment he faced.

Right now, we have another excellent and relevant example of courage. Volodymyr Zelensky, the current President of Ukraine, has shown incredible bravery as he leads the people of Ukraine in a war against Russia. Russia is a world superpower led by Vladimir Putin who apparently seeks to rebuild the former Soviet Union by attacking and acquiring former Soviet countries who are now independent and sovereign nations. Russia's military is much larger than Ukraine's: Russia has 900,000 active military vs Ukraine's 200,000. Ukraine has 146 attack aircraft vs Russia's 1,328. Russia has 31,000 tanks and armored vehicles vs Ukraine's 5,000. Regarding the Naval fleets- Russia has 605 vessels vs the 38 ships of Ukraine. And, worst of all,

Russia has 4,477 nuclear weapons and Ukraine has zero.

When Ukraine, a peaceful and sovereign nation, was attacked by Russia, President Zelensky and the people of Ukraine faced overwhelming odds. In the beginning of this unprovoked attack, almost all of the political and military experts thought the Russians would overtake Ukraine in a matter of days with a far larger and superior military force. Russian military and political leaders also assumed they would win this fight very quickly. Under Zelensky's leadership, the Ukrainian people are fighting bravely against their attackers. As of the writing off this article, many weeks into the conflict, some experts are even saying the Ukrainians could actually win this war. They have for sure put up a valiant fight even if they are not victorious against this evil force.

Without a doubt the Russians greatly underestimated the courage of President Zelensky who has inspired the Ukrainian people to stand and fight for their country. In fact, the courageous Zelensky has challenged and motivated millions around the world to support their fight to defend themselves against the Russians as he has addressed the masses via television and social media on most media outlets around the world. As he is being hunted down by the Russians, he has given speeches while wearing army fatigues in the midst of

war-torn Ukraine to the US Congress and Senate, the Canadian Parliament, the British Parliament as well as to most of the nations of Europe and other countries around the world.

Soul Searching

When the Russians first attacked Ukraine with a huge force of their military which had massed on the Northern, Eastern and Southern borders, the United States offered to send in aircraft and escort him and his family to safety outside of Ukraine. Zelensky famously gave them this courageous response,

many things and be rejected by the elders, the chief Priests and the teachers of the law, and he must be killed and on the third day be raised from the dead.""

Later in the same chapter we see in verse 51 (the NIV version) it says, "Jesus resolutely set out for Jerusalem." I especially like the Message version of this verse which puts it this way, "Jesus gathered up his courage and steeled himself for journey to Jerusalem." Of course, it was on this his last trip to Jerusalem, during what we now call Holy Week, that he would be arrested, put on trial, tortured, and crucified on a cross.

Jesus is in fact the very epitome of courage as it was defined above ... "the quality of being brave: the ability to face danger, uncertainty or pain without being

overcome by fear or being deflected from a chosen course of action."

In my opinion, the events of Holy Week, Good Friday and Easter prove that Jesus is the most courageous person who ever lived. He knew the excruciating pain of the cross awaited him, yet he ventured onward to Jerusalem to face his certain death. It seemed as if all the evil powers in the world had the advantage over him, but through Jesus' courageous act of facing the cross, he overcame darkness, sin, and death!

I hope you will choose to remember the courage of Jesus in the events of Holy Week this year (April 10-17), and I encourage you to attend the church of your choice for Easter as we celebrate the Resurrection of the Courageous Christ!

His bravery allows us to experience forgiveness of our sins and salvation through his death on the cross. His resurrection empowers us to live courageous lives in Christ!

Gunnery Sergeant Jamie Michael LyBrand

Gunnery Sergeant (GySgt) Jamie Michael LyBrand served 20 years in the United States Marine Corps. His Military Primary Military Occupational Specialty (PMOS) was Military Police, and he held other Additional MOS's (AMOS): Prevention/Physical Security, Small Arms Weapons Instructor, Marksmanship Instructor, Martial Arts Instructor, Marksmanship Coach, Formal School Instructor and Recruiter.

His decorations, medals, badges, citations and campaign ribbons awarded or authorized included 20 overall many with subsequent awards and stars: Navy and Marine Corps Commendation Medal, (with combat "V"), which is given for heroism or valor in combat, Navy and Marine Corps Commendation Medal (four), Navy and Marine Corps Achievement Medal (three), Combat Action Ribbon (Iraq), Joint Meritorious Unit Commendation, Coast Guard Meritorious Unit Commendation, Marine Corps Good Conduct Medal (six), National Defense Service Medal (two), Armed Forces Expeditionary Medal, Afghanistan Campaign Medal (two), Iraq Campaign Medal (two), Global War on Terrorism Expeditionary Medal, Global War on Terrorism Service Medal, NATO Service Medal, Military Outstanding Volunteer Service Medal, Humanitarian Service Medal (two), Navy Unit Commendation Ribbon, Naval Arctic Service Ribbon,

Marine Corps Recruiting Ribbon, Sea Service Deployment Ribbon (six), and Navy & Marine Corps Meritorious Unit Commendation (four).

GySgt LyBrand was born in 1975 to his parents, Terry and Denise LyBrand, at Ft. Bennington, GA, and was ultimately reared by his grandparents, Joseph Lee Bolden Sr. and Gloria Ann Bolden mainly in Alabama and Florida. He graduated from Pace High School in Pace, FL, in 1993.

GySgt LyBrand's family has a rich heritage of military service. Many cousins, uncles, brothers, and more distant relatives have served their country. His father served in the Army, his father's father in the US Navy, and his maternal grandfather started the US Marine Corps tradition. GySgt LyBrand's uncle, Joseph Lee Bolden Jr., picked up where Senior left off, and then it was GySgt LyBrand's turn. His younger brother served in the U.S. Marine Corps, and several other family members did too. He met his wife of over 24 years in the Marine Corps during his first enlistment.

GySgt LyBrand's wife, Mary, served on active duty for eight years in the Marines during his tenure. This had a very big impact on their two sons, Layne and Collin. Both of them earned the title of US Marine just like their mom and dad and all the way up to their father's maternal grandfather, PawPaw, who earned his title in the 1950s! The boys did it differently though as they are Marine Corps Infantry.

GySgt LyBrand enlisted in the U. S. Marine Corps on Active Duty in 1993 and retired in 2013 with 20 years of Honorable Service. He completed Basic Training at the U.S. Marine Corps Recruit Depot in Parrish Island, South Carolina. He then completed combat training at Camp Geiger in Jacksonville, N.C. and the Military Police Academy in Anniston, AL.

His first duty station was Marine Base Camp Lejeune with the 2nd FSSG (Force Service Support Group) and within a few weeks, he was deployed upon the USS Nashville in support of Operations in Haiti in 1994. Following that operation, he deployed for cold weather training to Norway and then to Estonia to support the Baltic countries' (Estonia, Latvia, and Lithuania) entrance into





Sergeant Mary LyBrand

Sergeant (Sgt) Mary LyBrand served eight years in the U. S. Marine Corps. Her Military Occupational Specialty (MOS) was Tactical Switching Operator (tactical telephones and switchboards). She received the following decorations, medals, badges, citations and campaign ribbons: Marine Corps Good Conduct Medal (2nd Award), Navy and Marine Corps Achievement Medal, Iraq Campaign Medal (with one Bronze Service Star), Sea Service Deployment Ribbon, Global War on Terrorism Service Medal and National Defense Medal.

Sgt LyBrand was born December 1, 1976, to her parents, Steve and Mary Andrews, in Cleveland, Ohio, where she was reared and graduated from Parma Senior High School in June 1995.

On January 29, 1996, she shipped off to US Marine Corps Recruit Training at Parris Island, South Carolina. There were family members who served in the U. S. Army and Air Force in the Reserves, but she became the first family member to serve on Active Duty, the first in her family to earn the title of U.S. Marine and the first female in her family to serve in the US Military period!

Sgt LyBrand completed the 12 weeks of Basic Training at the U.S. Marine Corps Recruit Depot in Parris Island, South Carolina where all female recruits go for boot camp. She had entered

service as "open contract". She was sent to the Marine Corps Air Ground Combat Center Twenty-nine Palms, CA, for training in communications where she learned to run wire, install telephones, and establish tactical switchboard networks in the field as a Field Wireman. Sgt LyBrand then served at the Marine Base Camp Lejeune for the remainder of her four years of enlistment.

Sgt met her husband-to-be, Marine GySgt Jamie LyBrand, at Camp Lejeune, and after becoming a mother of two sons, she remained a full-time homemaker for seven and one-half years and finished an Associates Degree until she reenlisted in the U. S. Marine Corps September 12, 2007 in order to fulfill a few goals she hadn't accomplished. She returned for service at Camp Lejeune to resume work as a Field Wireman and deployed to Iraq in 2009 and was there for a year. She served in Al Taqaddum also known as TQ located 74 kilometers from Bagdad where she continued working as a Field Wireman. She completed her second enlistment of four years September 11, 2011 at Camp Lejeune.

Sgt LyBrand her husband, Marine GySgt Jamie LyBrand, have two sons who are also U. S. Marines. Their son, Layne LyBrand, is a Corporal in the Infantry. He is a proud machine gunner, and their youngest son, Collin, is a Lance Corporal infantry rifleman.

After her military service, she worked for a retired Marine as an administrative secretary in New Bern, N.C. for three years until her husband, GySgt Jamie LyBrand, retired from military service. They moved to Spanish Fort, AL.

Using the G.I. Bill, Sgt LyBrand earned a B.S. Degree in Legal Studies with honors. For the past three years, she has been employed by the USDA Farm Service Agency in Wetumpka, AL, as a program technician initiating farm loans, providing customer service to assist local farmers in the 12 counties in Alabama her Field Office serves. Sgt LyBrand is a member of the Townsend Detachment #920 Marine Corps League. Sgt LyBrand enjoys cross stitching embroidery. She loves animals especially her dogs, and one day she wishes to own a horse or two! She and her husband enjoy riding their motorcycles throughout rural Alabama. Sgt LyBrand's conclusions about her service as a Marine are, "I don't think that most people could handle the service especially the Marine Corps. I know that it changed my life. There were three things that I wanted to accomplish that had not occurred during my first enlistment, namely, (1) to be promoted to Sergeant, (2) to deploy and (3) to receive the Navy and Marine Corps Achievement Medal. During my second enlistment, I checked those boxes by picking up Sergeant, deploying to Iraq for a year and getting an Achievement Medal for my tour there." # end #

NATO. He later deployed on a humanitarian mission to El Salvador in support of Central American countries that were ravaged by hurricanes in the late 1990s.

During his time with his first unit in the Marines, he earned Meritorious Promotion to Corporal, and then he re-enlisted for the first time.

He then picked up the rank of Sergeant meritoriously, and upon return to the US from El Salvador, he was assigned to Recruiting Duty. He was sent to Valdosta, GA, for recruiting duty, and while there he earned Meritorious Staff Sergeant/E-6.

After recruiting duty, he served a couple tours in Iraq, including Fallujah. He completed other deployments such as the Marine Expeditionary Unit (MEU) Float and even a year in Afghanistan at the tail end of his career.

One particular seven-month deployment was one of his best ever due to his being as Naval tradition would call it a "Polly Wog" with the 26th MEU Expeditionary Unit. He got to sail across the Atlantic Ocean into the Mediterranean Sea through the Suez Canal and below the Equator where he became a "Shell Back", which involves a ceremony citing the crossing of the Equator by Naval Service Members. He returned to Camp LeJeune, served a year in Afghanistan and had two assignments with Special Operations Training Group (certifying MEUs for deployment). He retired from military service officially on December 31, 2013.

Important notes: while on recruiting duty, he realized that he should practice what he preached that is to utilize the benefits that the US Military provides specifically educational benefits. He made that a goal. In the ladder half of his military career, he earned a bachelor's degree in criminal justice and completed half the requirements of a master's degree. After military retirement, by 2015, he completed two graduate degrees and earned a graduate certificate.

Since his military retirement and completion of graduate studies, GySgt LyBrand has continued Federal Service for the last seven years starting with the U.S. Marshals Service (USMS) for the first two years and Department of Homeland Security (Citizenship) for four years, and now he is back with the USMS as a Supervisor for a year.

GySgt LyBrand praises his wife, Mary, who served eight years in the Marines saying, "She's the reason that I have amounted to anything. I would not have excelled in anything or amounted to anything if it had not been for my bride, Mary. I am a family man and we have two sons in the Corps. I couldn't be prouder as I am in our family's accomplishments, it is an honor to serve our great country!"

He is a member of the Townsend Unit #920 Marine Corps League. He takes great pride that their two sons are on active duty with the U. S. Marine Corps. He enjoys supporting the local community, Townsend Detachment, Lima Company 3/23 and any Marine, Corpsman, or Chaplain that he can find.

GySgt LyBrand statements regarding his military service as a Marine are, "Being a Marine is something that is special. It is a very small percentage of the U.S. population that has ever done it. It is pride that you carry in your heart and soul. You know that the people who went before you are heroes. They are awesome and amazing Americans. They helped build this country. There is no greater sense of pride and belonging during my 20 years. There is something special with serving as a United States Marine."

PANDA is an acronym for **Providing Alzheimer's N' Dementia Assistance.** Funding is provided by the Administration for Community Living (ACL). The program was originally piloted in 2020 by Middle Alabama Area Agency on Aging (M4A) in Shelby County.

The PANDA Project will provide People with Dementia (PWD), People with Intellectual Disabilities (IDD), and Caregivers enhanced direct service interventions across Autauga, Elmore, and Montgomery counties.

The goal of PANDA is to enable individuals with Alzheimer's Disease and related dementias, including those that live alone, people with intellectual and developmental disabilities and dementia, and their caregivers to continue to obtain or provide support needed to help reduce critical incidents, such as falls, hospitalizations, emergency room visits, and overall healthcare costs; allowing individuals to remain in their homes.

New initiatives created by the program will include: "Alzheimer's Foundation of America (AFA) FREE web-based and in-person trainings; AFA "Dementia Experience"; Dementia Education and Awareness Campaign; Evidenced-based care management protocols designed to support family members providing care to adults; Specialized legal assistance for individuals with IDD and their caregivers.

CAAC will partner with several organizations including Alabama Disabilities Advocacy Program, Alzheimer's Foundation of America, Capitol City Health & Rehab, Legal Services Alabama, People First Alabama, TCARE and Trualta, Inc.

Services began in March of 2022 and include: "individual Person-Centered Support Plans; regular Home Visits and Telephone Calls; One-on-One Caregiver Interventions & Training; Homemaker and Respite; Remote Safety Technologies; Home Modifications; and Legal Services."

You and Your Family May Be Eligible for Increased Benefits

We know your circumstances may change after you apply — or become eligible — for benefits. If you, or a family member, receive Social Security or Supplemental Security Income (SSI), certain life changes could increase your benefit amount.



As part of our Potential Entitlement initiative, we want to help you identify where you might qualify for a higher benefit. For example, you may

be entitled to higher benefits based on your own earnings record or someone else's record. Some of the life changes that could possibly increase your benefits include the following scenarios:

• If your spouse or ex-spouse dies, you may be eligible for a higher survivor benefit based on their earnings record. The death of an ex-spouse may entitle you to a higher survivor benefit even if you are already receiving a survivor benefit on another spouse's record. We encourage you to read our publication, Survivors Benefits, for additional information at *www.ssa.gov/pubs/EN-05-10084.pdf*.

• If you are receiving Social Security benefits based on your spouse's work and you worked and earned credits, you may be eligible for a higher retirement benefit based on your own work. You can view our Retirement page at *www.ssa.gov/retirement*.

• If your deceased adult child provided at least half of your support, you may be eligible for a higher parent's benefit based on your child's work history. Our publication, Parent's Benefits, includes information you may want to consider at *www.ssa.gov/pubs/EN-05-10036.pdf*.

We continue to focus our Potential Entitlement initiative on people who face barriers. These populations include older people, children with disabilities, veterans, SSI recipients, and people with limited English proficiency. We are proud to say that since we started the initiative in 2017, our efforts have resulted in approximately \$553 million in retroactive and total monthly increased benefits paid.

Supplemental Security Income Benefits for Children with Disabilities

Did you know that Social Security's Supplemental Security Income (SSI) program provides cash payments to children with disabilities whose families have limited income and resources?

A child must meet all of the following disability requirements to be considered medically eligible for SSI:

• The child, if not blind, must not be working or earning more than \$1,350 a month in 2022. If the child is blind, they must not be working or earning more

than \$2,260 in 2022. The earning amounts usually change every year to keep up with inflation.

• The child must have a medical condition(s), that result in "marked and severe functional limitations." This means that the condition(s) must very seriously limit the child's activities.

• The child's condition(s) must last for at least a year or expected to result in death.

Some older teenagers may have part-time jobs or are involved in work programs, which may affect eligibility to SSI. In addition, if an unmarried child under age 18 is living at home, we may consider some of the parents' income as the child's income. We make allowances for the parents and their other children living in the home when we consider the parents' income. You can learn more about children's benefits in our publication, Benefits for Children with Disabilities at *www.ssa.gov/pubs/EN-05-10026.pdf*.

We also help children – and adults – through our Compassionate Allowances program. Compassionate Allowances are a way to quickly identify conditions that, by definition, meet our standard for disability benefits. You can read the list of conditions at *www.ssa.gov/compassionateallowances/conditions.htm.* Compassionate Allowances can help reduce the wait time for us to make a disability determination for children with the most serious disabilities. Thousands of children receive benefits because they have a condition on this list, but children with conditions not on this list can still qualify for SSI.

The Alabama Legislature has once again introduced a lottery proposal that would give voters the opportunity to choose whether or not Alabama can have a lottery. It is one of the only states in the union not to have a lottery.

They do this every year.

I write about it every year.

They meet, and talk, and wring their hands, and second-guess themselves. They open it up for public discussion. Then they get anxious and table whatever

plan they were considering and agree to start over from scratch during the next legislative session.

Part of them feels obligated to include casinos, since there are already casinos operating around the clock every single day of the year in Alabama. Some barely want to allow it all. They are much more comfortable with control in their hands than a spread of cards.

I have long suspected that most of the

members of the Alabama Legislature do not enjoy

gambling ... at least not with money. And money, which Alabama needs, is exactly what a lottery would generate. Which has been a problem in the past. They can never decide what to do with the proceeds ... should they ever finally decide to give the people of Alabama the opportunity to vote on the matter by putting it on the ballot again for the first time in over 22 years.



It is all seems rather slow to those who routinely visit area casinos and play neighboring state lotteries.

The legislature should maybe consider that its wager is losing value every year they delay implementing a lottery. Alabama gamblers are already gambling and do not need permission from the Alabama Legislature. We have horses.

This morning, as I write, at not quite yet 6 a.m., I am waiting for the third day of the Cheltenham Festival in the UK to begin. It is the highlight of Jump season, or "hurdles." It is a culmination of some of the world's most talented jockeys, paired with finest of horses who have been trained by the elites. It draws huge crowds both physically and virtually, and has pools that grow to staggering amounts.

Granted, you have to follow the horses to know the horses, riders, trainers, and tracks, but you can play horses around the clock and around the world from your phone. It is completely legal - even in Alabama - because it is a game of competition as opposed to a game of chance.

You can quickly and easily join in by creating an account with one of the interactive platforms. There may be several, but the New York Race Association (NYRAbets.com) offers wagering in Alabama, as does Saratogabets.com. You can wager and watch all races online, or on the Television Games channel. American tracks start around 11 a.m. daily, but until that time of day the African, French, and United Kingdom tracks will keep you entertained, and when American tracks call it a night just shy of midnight the Australian tracks are in full swing. Pick your preference – hurdles, harness, or flat. It's not free, but then again you won't be buying gas to get there either. Or you can continue to wait on the Alabama Legislature to decide if they have the gumption to give us the opportunity to vote on their half-ass, watereddown version of a lottery bill that should have long since been allowed.

Southern Cuisine

I was surfing the web, looking for ideas for my next article. I came across several articles that caught my eye. They were articles written about the fast food restaurants that on the surface sounded like they are serving the standard



fare for a typical fast food restaurant: hamburgers, chicken sandwiches, gumbo, biscuits and gravy, and grilled-cheese sandwiches. What caught my eye was that most of the descriptions of the food were missspelled. You could tell what they were trying to describe but it was just slightly misspelled. There was a restaurant that served a VLT: Vegan Bakun, lettuce and tomato sandwich. Or try their Bakun cheeseburger. How about an order of chickun tenders? It seems that we cannot let go of meat in our diet, or at least the taste of meat. One problem I see, is that you think that the plant-based meat substitutes are healthier that the real meat. But what about the chemicals that are added to the plant-based item to make it taste like meat? However, plant-based meats are far from perfect. They typically have higher amounts of sodium, usually to make them more palatable and shelf-stable. Too much sodium can cause adverse health effects, including high blood pressure and stroke.

Plant-based meats are also highly processed and filled with less healthy ingredients, such as refined coconut oil and modified food starch. Research from the National Institutes of Health suggests that processed foods cause people to consume an extra 500 calories a day and ultimately gain more weight.

Plant-based meats can fit into a healthy diet when eaten in moderation no more than a couple of times a week, but do not make it your only source of protein. Stick to whole foods instead.

The recipes for this article cover an updated recipe for a cake for dessert, an Irish holiday entrée, and a healthy fish dish.

I will start with the cake. It has been our family's favorite cake and our friends' favorite cake for years. This recipe will add a new flavor, lime. The first recipe was a vanilla bean Bundt cake and has been a Scotch-flavored cake. The zing a lime in the cake and for the icing has made this flavor a real hit. We also tweaked the method of cooking the cake, which made for a much better presentation.

Key Lime Pound Cake

INGREDIENTS:

- 3 cups all-purpose flour ¹/₄ tsp. salt ¹/₂ tsp. baking powder ¹/₂ cup shortening 1 cup (2 sticks) softened butter 3 cups sugar 6 room-temperature large eggs ¹/₂ cup buttermilk 5-oz. size carton of Chobani Key
- **Lime Yogurt**
- 1 tsp. vanilla
- 1 tsp. lime extract ¹/₄ cup key lime juice 1 tsp. lime zest

METHOD:

- 1. Preheat oven to 325 degrees.
- Generously grease a bunt pan with Crisco. Set aside. 2.
- 3. Sift together flour, salt, and baking powder, set aside.
- Cream together butter and shortening, add sugar and cream well. 4.
- 5. Add eggs one at a time, beating after each addition until light and fluffy.
- In another bowl mix yogurt and buttermilk. 6.
- Add dry mixture alternating with yogurt mixture to the butter, shorten-7. ing mixture. Add vanilla extract, lime extract and lime zest, mix until combined.
- Sprinkle sugar into greased bunt pan. Spoon batter into prepared pan.
- Bake for 1 hour and 15-20 minutes or more depending on your oven.
- 10. Check for doneness by inserting a wooden skewer into the center of the cake until it comes out clean.
- 11. Cool cake for 10 minutes in the pan. Turn cake over on to the serving plate and leave the cake pan on the inverted cake for 5 minutes, then remove. Let the cake cool completely.

ICING:

8 oz. cream cheese, room temp 3 to 4 Tbsp. butter, room temp



Next, is a new twist for us when cooking the corned beef for Saint Patrick's Day. The addition of Irish whiskey to the poaching liquid has made the corned beef very tender and vary delicious. Try this any time of year or family meal, such as Easter dinner.

Corned Beef

INGREDIENTS:

- 3- to 4-lb flat cut or point cut corned beef brisket, rinsed well
- One large yellow onion peeled halved and sliced
- 4 cloves garlic peeled and lightly

Spice packet provided with the

- 1. Put onion and garlic in the bottom of a Dutch oven, place corned beef on top with the fat side up.
- 2. Pour the spice packet on top of the corned beef.
- Pour beer into the Dutch oven and then add enough water to almost 3. cover the beef.
- 4. Simmer on the stovetop for an hour and half, flipping the corned beef after 45 minutes. Add additional water if necessary.
- 5. After an hour and a half, remove the corned beef from the Dutch oven.
- Add the small potatoes and carrots the beer liquid. Simmer until the 6. potatoes are tender.
- 7. Pre-heat the oven to 325 degrees.
- Pat dry the corned beef with a paper towel and place on a lined baking 8. sheet.

MUSTARD SAUCE:

¹/₄ cup brown sugar

4 Tbsp. whole grain mustard ¹/₄ tsp. ground cloves

¹/₄ tsp. black pepper 2 Tbsp. Irish whiskey or bourbon

METHOD:

- 1. Spoon the mustard sauce over the corned beef.
- Cover with foil and cook for an hour and a half. 3. After heated, remove corned beef from pan and sliced against the grain. 4. Serve with potatoes, carrots, cabbage and mustard sauce.



4 cups confectioner sugar

2 to 3 tsp. key lime zest 1 tsp. vanilla extract

juice

¹/₄ cup freshly squeezed key lime

To make the icing, cream together the butter and cream cheese until smooth. Slowly add confectioner sugar and lime juice a tablespoon at a time. Add key lime zest and vanilla. Beat until smooth. Spread on completely cooled cake. Garnish top of cake with thinly sliced lime wedges and additional lime zest if desired.

The next item for the article is for sea bass. Salmon and sea bass are two popular fish. Where salmon is somewhat healthier, sea bass has a rich buttery taste and if you do not the overly fishy smell and taste of fish, sea bass is for you. It is mildly sweet and has a meaty consistency. But because of the amount of mercury in both fish, sea bass should be limited to 2 to 3 times per week, whereas salmon should be limited to once a week.



Sea Bass

INGREDIENTS:

8-oz. sea bass 2 Tbsp. butter 2 Tbsp. fresh lemon juice Salt to taste 2 tsp. olive oil **1** garlic clove 5 fresh basil leaves chopped or 4 Tbsp. dry basil

METHOD:

- 1. Heat a small saucepan over medium heat.
- Gently sauté the minced garlic in butter for about 2 minutes, until fragrant and golden.
- 3. Stir in the lemon juice and $\frac{3}{4}$ of the basil.
- Add salt to taste. Remove from heat and set aside. 4.
- 5. Pat the fillet dry and coat both sides with olive or canola oil.
- Heat a medium frying pan (nonstick if you have it) on medium-high 6. heat.
- 7. Pan fry one side for about 3 to 4 minutes. The edges should turn golden brown.
- 8. Flip and cook the other side 1-2 more minutes or until fish is cooked through.
- 9. Transfer the fish to a serving dish.
- 10. Spoon sauce over the fillets and sprinkle the remaining basil on top.
