As the first Regular Session of the Quadrennium evolves there are a myriad of complex issues arising. I am reminded of three simple truisms regarding the Alabama legislature and the governing of the State of Alabama.

## First of all, if anything significant or Our National Debt is Unsustainable

controversial or any major initiative is to be addressed, then it is dealt with in the first year of the four-year quadrennium. Thus, giving legislators three years before their constituents vote on them again. The political pragmatism and expectation is that voters will forget.

Secondly, there may seem to be an urge to deal with all the hundreds of bills that have been thrown into the hopper and special interest groups or lobbyists are espousing that a particular piece of legislation has to be dealt with or it will be the downfall of the state. Not so. The only definitive legislation that has to be dealt with are the state budgets. That is the only constitutional mandate required of legislators in a session.

The third truism surrounds the second. In regard to passage of the budget, our Constitution wisely has a sacrosanct conservative mandate that there must be a balanced budget. The Alabama Legislature cannot deficit spend or overspend the projected revenues for the year. Our current super Republican majority legislature is so conservative, they not only adhere to the Constitutional prohibition against deficit spending, they do not even spend 100% of the year's budget.

For the past decade they have put state revenues away into a rainy day fund. They are truly budgeting conservatively. If that were only true of our United States Congress. Our U.S. Congressmen and Senators are simply printing money in Washington. They are recklessly spending our nation into an abysmalhole, one that we may never be able to get out of. This tremendous federal deficit is our nation's most acute problem.

The United States cannot survive and keep spending money that we do not have. Our national debt is so high that we are basically nothing more than a third world country.

Communist China will not take us over militarily or by flying balloons over our country. They will take us over without firing one bullet. They will defeat us economically. Again, it is a serious problem that must be addressed if we are to survive as a nation.

The national debt is so devastating that within the next year it will be higher than our Gross National Product (GNP). In fiscal year 2022 alone, the deficit

Trading in commodities, which are ingredients or components of finished goods, is the focus of global commerce. Information about commodities, their availability, and the impact of events that create scarcity, affect both current and future prices.

These self-regulating groups realized that no amount of legal jargon - regardless of the length of the contract - could ever take the place of honesty among business leaders. Anyone not living up to his word or otherwise trying to avoid an obligation would be ostracized and humiliated in a way that legal

Two hundred years ago, one significant commodity was tallow, a substance rendered from animal fat that was used to make candles, served as a basis for early skin care ointments, and was an essential ingredient of soap. Today, when we think about commodities, we don't think about cow and sheep fat, but two centuries ago, trade in tallow was critical to manufacture these everyday items. At that time, more than 65 percent of all tallow came from Russia and the Baltic region and was imported into England to create finished goods.

Given the need for tallow, speculators would bid the price up and down, making the market very unstable and hurting industries that needed tallow at a consistent price to produce goods.

To curb speculation and create a more stable market in the tallow trade, a group was formed 200 years ago this month. Called the Baltic Club, this group met at a coffee house and was one of the first self-regulating voluntary associations working to reduce price volatility in the tallow trade with an index of prices.

The initial group was limited to 300 members and their goal was two-fold. First, given the extent of global trade in and around London, the club sought information from returning ship captains about market conditions in other countries and the price paid and charged for cargos of commodities. From this information they compiled a list of the prices for tallow to reduce speculation based on fear mongering from limited information.

The club also brokered cargo space in ships for tallow and, eventually, other commodities. This informal offee house grew to become the Baltic Exchange, which still exists today.

Two hundred years ago, the coffehouses and taverns of London were the basis of a number of important groups all connected with shipping and trade. Everyone knows Lloyd's of London from insurance, but other groups like the Baltic Club were critical to the growth of international trade.

These clubs or exchanges were not created by government, nor were they regulated by any outside committee or commission. THE BALTIC VLIG INSIGNIA HAVING ITS 200TH BIDTHDAY THIS MONTH



Rather, they were formed by merchants and **ITS 200TH BIRTHDAY THIS MONTH** other businessmen to create an organization of honest brokers to reduce market

instability and create a consistent price index for more robust trading.

In the case of the Baltic Club, the motto adopted by the members was: "*Our Word, Our Bond.*" Thus, the entire enterprise was based on the personal integrity of each member. Buying and selling commodities with price fluctuations and daily changes did not allow for precise contracts that were necessary for insurance. Instead, individual members agreed to a price and the ability to deliver the goods and acceptance of the agreed upon price was based on the ethics of the individual buyer and seller.

And should anyone fail to deliver or pay the agreed terms of the transaction, they would be removed from membership and not permitted to trade with other members again.

proceedings could never achieve.

Voluntary and self-regulating business organizations were critical to the development of commerce and the growth of British prosperity. While government might pass laws that taxed the import or export of commodities, the actual regulation of the internal aspects of trade was deemed to be beyond the reach of government.

The enforcement of contracts related to shipping, the value of cargo, and its sale was enforced by the courts. But, there was no authority to inspect the "Personal integrity, fairness, and trustworthiness will always remain a foundation of best business practices."

quality or quantity of the traded commodities and cetainly no interference with the free flow of goods on the London docks.

The limited role of government worked well as long as merchants, vendors, and traders possessed high morals, believed in fundamental fairness, and acted honesty. Unlike the Medieval guilds, which sought to restrict trade and limit commerce, the exchange clubs sought to expand trade by limiting speculation and providing a stable marketplace to confidentlybuy and sell.

 $T_{o}$  make thiswork, membership was exclusive and limited. The strict rules for admission mandated that a vacancy be filled only by the nomination of a current member. A nomination had to have a second member's consent; then, any existing member had two weeks to voice objetions. Membership was forfeited by unacceptable conduct.

The hallmark of these exchanges was trustworthiness and integrity to abide by the terms of a transaction regardless of changes in the market. Self-regulation worked well as long as leaders carefully managed the exchange and policed rouge behavior. Expulsion impacted an individual commercially, socially, and personally. Thus, the significance of the penalty was sufficient to maintain high standards and a fluid trade in commodities.

Many of these exchanges continue in England, but in other countries, self-regulation has given way to government licensing, review, and restrictions. In any organization, especially those engaged in commerce, one miscreant can taint the entire exchange. And, in many cases, rather than allow internal discipline by expulsion or otherwise, governments routinely intervene to prevent bad actors. But frequently the regulations imposed overreach beyond what is needed to control racketeering speculators. The regulations become a limiting factor restraining the growth of commercial activity by restricting the free flow of goods at competitive prices.

The world of self-regulation may be a thing of the past, but the principles embraced by commercial exchanges are still applicable. Governmental regulations and intervention notwithstanding, personal integrity, fairness, and trustworthiness will always remain a foundation of best business practices.

And no amount of contracting can ever replace honest brokers who embrace the motto: *My Word, My Bond.*

we will discuss the Florida law and incident.

Two families driving down a Florida became involved in a road rage incident between the two men that were driving. Both men were husbands and fathers, each having at least one child being a daughter. The two men would run in front of the other's vehicle slamming on brakes to try and cause an accident. At some point the windows were rolled down while I am sure they exchanged verbal insults and threats and probably obscene gestures.

During this time one father threw a water bottle through the open window at the other driver and his family. Not being exactly sure what was thrown, the other father then picked up his handgun and shot into the vehicle of the man that had thrown the water bottle. The bullet hit the leg of the five-year old daughter of the man that threw the water bottle. The other father, now defending his family picked up his own handgun and shot multiple rounds into the other vehicle striking the fourteen-year old daughter in the back. At least one person called 911 during the incident and law enforcement was able to stop both vehicles without incident. Both daughters survived and both men were arrested.

After consideration, the man that was on the receiving end of the thrown water bottle and returned fire, striking the fourteen-year old was released under the "stand your ground" statute.

### So what are the basics of the "stand your ground" statute?

When I came through law school there was only a no duty to retreat from an aggressor under the "castle doctrine" when you were in your home, business or vehicle. Several years that changed. Instead of a duty to retreat when possible from a life-threatening incident, a person is now allowed to "stand your ground".

When such an incident occurs provided it is not a threat from legitimate law enforcement, or it is not while you are committing a crime or you are not in a place that you don't have a right to be in. It was determined that the one that threw the water bottle was the aggressor by throwing a "missile" into the other vehicle causing the other driver to fear great bodily harm. The arresting sheriff was pretty upset about the actions of two grown men (age range from late 30's to early 40's) who could have both ended up with dead daughters due to their actions.

The criminal trial will be interesting and I The incident occurred in Florida on the interstate. The expect a civil trial to follow which will two men are from different states but with the incident occurring in the sovereign State of Florida, Florida law and jurisdiction applies regardless of the law in the residential states of the two men. Florida, as you may recall has a "stand your ground" law. Alabama also has a similar stand your ground law but

include a counterclaim by the defendant. Both men acted recklessly and both would be liable under various tort theories.

Interestingly enough Florida uses a comparative negligence theory. That means under the causation if driver A is found the be eighty percent liable and the other driver (B) is twenty percent liable then driver B is awarded theoretically only 80% of what he asks for should he win the case. Alabama, which follows contributory negligence as only a handful of states do would not award anything under that theory to driver B because he contributed a scintilla or more in the way of negligence in the case. And of course, driver A would also recieve nothing.

Alabama had an interesting case in Birmingham where a man was coerced by "friends" to sell marijuana to four others. He went to the place with a marijuana sample and his pistol. He was told he was being robbed by those he met with who took his pistol and drug sample. They forced him back to his apartment to rob him of the marijuana stash and did so. Once the four men left, the man grabbed another gun and went outside to see if they had left. They began shooting at him and he returned fire. The other vehicle eventually stopped and three men ran out because one had been shot dead. The man who killed one of the four men was released under the Alabama "stand your ground" law.

Even though it occurred during the commission of a criminal act it was held that he was involved in the act because of coercion and thus entitled to "stand his ground".

I think retreating when you can is wise to keep from escalating the incident to where a bad injury or death occurs. I had an incident where someone driving a pickup on I-85 harassed me and my family by driving aggressively and not letting us pass could have escalated, but the safety of all involved was too important and prudent.

### I think the older approach to retreating when possible was wiser. It's very hard to know how you would react in such a situation but I think swallowing some pride and deescalating an incident when possible is the best course.

When you get past God the Father, Jesus the Son, the Holy Spirit and the bible being the inspired word of God, unfortunately interpretations and divisions fiercely emerge. So, the question today is still relevant, why are there 45,000 Christian varieties and what did the New Testament Church look like? Did Christ intend on their being so many divisions within one body?

In 1979, I began a seven-year quest researching the answer to this question, and my early conclusion was, if you were a Christian in the first 1500 years AD, you were either Roman Catholic or Orthodox (Coptic). My research also concluded that all post Reformation Christian expressions are less than 500 years old. Here is what triggered my search; please stay with me.

After attending a pro-life event in Birmingham, my wife Deborah and our family attended a church service, where Jim Pinto was the pastor. He and his wife Joy organized the pro-life event. During the service, we recited the Apostles Creed, which is still embodied in many Christian services today. I called Reverend Pinto on my way home and asked him where did it come from, his simple answer at that time was: "I do not know." This one question began my expedition of Christian history. The facts I unearthed on this journey, changed my perspective for life. With only the Old Testament around, the Creed became the "Mission Statement for Christianity." I always found it interesting, we always made a big deal swerving away from the word "catholic" in the creed and stress "universal," but the facts and history confirms this is the language chosen by the early church.

Continuing on this exploration, I bumped into the Nicene Creed, now what is this? From about 150 AD when the Apostles Creed was written until 325 AD, a disagreement arose earning the title as the "Arian Heresy." The core of this heresy was rooted in the view that Jesus could never be humanity and divinity all in one person. Severely splitting the Roman Empire apart, Constantine being the head of state called a church meeting, including Arian to settle this notion. The Nicene Council was formed in 325 AD giving birth to the Nicene Creed, which tightened up and eliminated any wiggle room in the language from the Apostles Creed. Both creeds are divided into 4 sections: God the Father, Jesus the son, the Holy Spirit and one holy, catholic and apostolic church. This was another weight point for me, the Catholic church is authenticated for having apostolic succession, meaning there is a line of senior pastors (Pope's, Cardinals and Bishops), much like the Wall of Presidents with 2000 years of history. All other expressions of Christianity are less than 500 years old.

My next convincing check point on this tour was in 397 AD, the Council of Carthage canonized the 27 books of the New Testament. Christianity was now almost 400 years old, there was no New Testament, just the creeds, word of mouth, letters sent around and traditions passed down from the linage of Apostles. I was a sola scriptura advocate until these 400 years without the New

Just after Easter 2004, the front-page of almost every daily newspaper in Alabama cited; "Christian Coalition President converts to Catholicism." Who cares, but the media saw this as a divisive opportunity, particularly in the deep south. The Christian Coalition had been catapulted into several high-profile statewide encounters including defending the Ten Commandments in State Judicial Building, defeating casino gambling and the lottery, passing a constitutional marriage amendment and opposing a \$1.2 billion tax hike on Alabama families. This is a plausible explanation for the media coverage, but the real story lead is a lifelong Protestant converting to Catholicism, Why?

After my seven-year historical exploration, it became clear to me the Roman Catholic Church dates back to Peter emerging as the lead apostle launching the New Testament Church with his powerful message converting and baptizing 3000 on Pentecost Sunday. In addition, the Catholic church gave us the New Testament. Like the early apostles and all Christian churches down through the years, the catholic church has experienced the leadership of flawed men, but the seven sacraments and the catechism has remained intact and core beliefs were inked in. Publicly noted sinful lifestyles of leadership never changed or affected the core teachings and beliefs of the church. All of my perceptions about what I thought the Catholic Church taught and believed were proved incorrect and a misguided view, slowly dissolving my observations that were opinion only, not fact.

I have noticed in candid talks with fellow Christian friends that are not Catholic, often they mention something is missing or void in their current worship setting. I have three observations, the creed, ancient liturgical worship and the seven sacraments.

When Jesus died on the cross, the veil in the temple was ripped from top to bottom. Up until that point, there were daily sacrifices at the temple, while readings and prayers were done in the synagogues. In a catholic service, there is the liturgy of the word, which is what took place in the synagogues and the liturgy of the eucharist (communion) sacrificing the lamb presented at the temple. The two forms of worship became one. Jesus the word and Jesus the sacrificial lamb found in ancient liturgy.

The Catholic Church reflecting on Jesus earthly ministry, instituted seven sacraments: baptism, confirmation, eucharist, reconciliation, anointing of the sick and holy orders. The Eastern Orthodox left all sacraments intact when departing the Catholic Church around 1054 AD. Post reformation, only a hand full of Christian expressions (Denominations) actually listed any of these as sacraments. The Creed, Seven Sacraments and the Ancient Liturgy are at the three-legged stool of Catholicism.

Looking back, the Catholic Church was never on my multiple-choice list, but at least now I know the answer to the question I asked my father 63 years ago. On this voyage I also concluded what others were missing in their expression of Christianity, and since my decision in 2004, never once looking back.

One Holy, Catholic and Apostolic Church.

## **The Rise of Tesla**



As long-range battery technology advances by leaps and bounds, there is no question that the popularity of electric cars and trucks will rapidly advance in the next few decades, due primarily to far greater fuel economy and expected shortages of petroleum and possible cutoffs from OPEC and other hostile countries. Ford, General Motors, Toyota, and many others are ramping up production.

But one company is far ahead—TESLA. It makes ONLY EVs. In July, 2003, Martin Eberhard

and Marc Tarpenning founded it as Tesla Motors. In February 2004, Elon Musk invested \$6.5 million dollars to become its largest shareholder and later became its CEO in 2008.

In 2008, Tesla built and sold its Roadster, followed by its Model S sedan in 2012, Model X SUV in 2015, Model 3 sedan in 2017, Model Y SUV in 2020, and Semi truck in December, 2022. Its iconic Cybertruck is due July or later this year (2023), but "volume production" won't begin until 2024.

By 2021, Tesla had sold more battery electric vehicles worldwide (21%) than any other EV producer. In October 2021, its market capitalization reached \$1 trillion and has now become the world's most valuable automaker. In Q3 of 2022, Tesla produced 68% of all EVs sold in the USA.

Today's best sellers are models 3 and Y. Over a million were sold in 2021; about 1.31 million were delivered in 2022 and 422,875 were delivered in O1 of 2023.



Tesla does not sell its vehicles like other makers. It has no advertising, no dealers, no car lots, no hassles with MSRP add-ons (like dealer prep), no contrived "discounts," no bait and switch schemes, and no reams of fine print paperwork. This saves Tesla tons of money by not hiring non-essential personnel and not building retail outlets-money that enables it to avoid greedy and sometimes shady dealers and middlemen.

To buy a Tesla, a customer goes to Tesla.com, picks out the model and options that he wants, downloads the Tesla app and follows its instructions, agrees to the price, and waits for his turn to purchase—from a few weeks to several months (for a Cybertruck or Semi, probably longer). After payment, a Tesla representative delivers his new vehicle.

Today, the demand for Teslas far exceeds the supply, but that deficit is about to be rectified within a decade or less with its new state of the art "gigafactories" in California, Nevada, Texas, New York, China, Germany, and plans for one in Nuevo Leon, Mexico. These establishments are "vertically integrated" with all of the essential parts made and assembled in the same location so any hickups in production can be immediately addressed on the spot with no long delays for responses and deliveries from far away locations. Once finished, these facilities will crank out new Teslas at lower costs and greater savings that will eclipse all other makers.



of its hardness, it cannot be stamped into body parts. Instead, it is laser cut, laser etched, folded in one direction only, and stir-welded together-hence its unique angular appearance. The stainless steel construction also eliminates corrosion and the costly, time-consuming process of painting.

The Cybertruck has adjustable self-leveling air suspension, up to 3,500 pounds of payload capacity, a towing capacity of over 14,000 pounds, 100 cubic feet of lockable storage space, a slide-out tailgate that doubles as a ramp, on-board power and compressed air, comfortable seating for five people, 0-60 mph in as little as 2.9 seconds, up to 500 miles of range per charge, 15 watt "Lazer Blade" headlights that illuminaqte the road up to three km, and a tonneau cover that is strong enough to stand on (like Elon Musk demonstrated to Jay Leno in a YouTube video). Elon has promised an MSRP of under \$40,000 for the one motor version, under \$50,000 with two motors, and under \$70,000 for the three motor deluxe version. Over 1.7 million people have already pre-ordered it.

The Cybertruck does have a drawback. At seven feet wide and about 19 feet long, this beast cannot fit into many garages and parking spaces or easily negotiate narrow trails in the woods.

An utterly fail-safe car is impossible, but Tesla's safety record is impressive. Tesla's crash about 12 times less often than average. Fatalities are also 12 times fewer. A Tesla safety exclusive is its driving software. Autopilot, which comes standard with every Tesla, keeps it within its lane and adjusts its speed to avoid hitting a car in front. It also includes "Active Crash Avoidance" that enables it to instantly recognize an obstacle and steer and/or slow down as needed—far more quickly than a human's reaction.

Full-Self-Driving is a deluxe extra that can automatically change lanes, recognize and obey signals and stop signs, and can find its way through cities and even on dirt roads. Other companies have been working on similar versions for years, but Tesla has developed it to the point of practical use. It is not yet fully autonomous or officially approved to having nobody in the driver's seat, but it can outperform a human driver with far faster reaction times and greater ability to avoid accidents. And if a self-driving Tesla should crash, Elon has already covered it by buying an insurance company. Call Tesla, and it pays for it, regardless of who was at fault.

The most expensive part of any EV is its battery pack. An 85 kWh version for a Tesla Model S consists of 7104 '18650' lithium-ion cells that are slightly larger than AA flashlight cells-----modified Panasonic NCR18650A 3100 mAh cells with nickel-cobalt-aluminum cathodes." The cells are made into modules, each containing six groups of 74 cells wired in parallel. The groups are wired in series to complete a module. Sixteen modules are wired in series to complete the 1200 pound battery pack. A titanium plate is placed under it for protection from collisions and/or road hazards.

Repairing and/or replacing EV batteries has been a challenge for both consumers and repair shops. The battery pack is the most expensive part of any EV. An invoice from Tesla stated that a new 75kWh pack for a Tesla Model 3 cost \$13,500 for the pack itself, and with added labor costs, \$16,550.67 installed. A different quote said \$22,500 for an out of warrenty replacement.

Even with anti-collision software, people in other cars do sometimes hit Teslas and damage them, including the battery packs. That makes them problematic when they are used as structural components. Auto manufacturing teardown expert Sandy Munro says a damaged Tesla Model Y has "zero repairability," and that "A Tesla structural battery pack is going straight to the grinder," where it may not be properly recycled. Elon could be well advised to simplify battery replacement and repair procedures, possibly by placing the modules into a rigid, sturdy aluminum or stainless steel frame where they can be well protected, but also easily accessed and replaced. Ford and GM are already working to make their batteries fixable.

All of the gigafactories are huge, but they do vary greatly in size—from 1.2 million square feet of work space at Buffalo, New York to 10 million at Austin, Texas.

The original Gigafactory at Sparks, Nevada contains 5.3 million square feet of operational floor space and produces approximately 35 gigawatt-hours of batteries annually.

The biggest factory, Giga Texas, at Austin, is the site of Tesla's corporate headquarters and is one of the largest buildings in the world with more than 10 million square feet of floor space. Construction began in July 2020, and the first complete Model Y rolled out in August, 2021. Deliveries began at an opening party called "Cyber Rodeo" on April 7, 2022. Besides the Model Y already in production, this factory will build the Model 3 and become the primary producer of semis and Cybertrucks. Elon Musk said it will hire as many as 20,000 new employees.

Tesla's Shanghai factory, built in a single year, is already producing about 450,000 Models 3 and Y annually.

Tesla's new factories are (or soon will be) equipped with massive state of the art aluminum die-casting machines called "giga presses" that weigh 410 to 430 tons each--- "the largest high-pressure die casting machines in production as of 2020, with a clamping force of 55,000 to 61,000 kilonewtons (5,600 to 6,200 tf)." A Model Y front or rear single piece casting is made by injecting 180 lbs. of molten aluminum into the machine at 22 mph for about 80-90 seconds, producing 40-45 castings per hour.

The most exciting recent developments are Tesla's trucks. A few semis have already been finished at the Nevada factory and sold to PepsiCo in California. Once the Texas gigafactory is completed and running full steam, they will be making deliveries everywhere, and will be especially thrifty in crowded cities like Atlanta, where about every fourth vehicle on the interstates is a semi. During traffic jams, while the diesels idle and waste tons of fuel going nowhere, the EVs consume NONE. In the near future, many will be equipped with Tesla's Full Self Driving (FSD) software, and during the all too frequent jams, the drivers can take brief naps, enjoy snacks, and, yes, text on their phones.

Tesla's latest and most spectacular product is the Cybertruck, a futuristic "cross between a DeLorean and a Stealth Fighter"—a sleek, gleaming, faceted stainless steel jewel with every component designed for superior strength and endurance. It is armored with an "exoskeleton" of "Ultra-Hard 30X Cold-Rolled stainless steel" that is a full 3 mm (1/8") thick and can withstand the impact of a sledge hammer with barely a dent and even stop a 9 mm roundthe same 301 stainless used to make the bodies of SpaceX Starships. Because

Another challenge is to minimize the consumption of scarce and expensive cobalt, which comes primarily from the politically unstable DRC (about 85% of the world's deposits). The most efficient batteries available now require both cobalt and nickel for their cathodes. LiFePO4 cells contain neither and cost less, but are a bit less efficient. To provide longer ranges at lower costs, battery technology still needs improvement.

Tesla is very young and has a great deal of growing ahead. Today, it makes vehicles for the upper and upper middle classes. For the masses, Musk plans to build a smaller "Model 2" in his proposed Mexico plant at half the \$33,600 cost of a basic Model 3 and retail it for under \$25.000.

Besides the richest, Elon Musk must be the world's most ambitious man-SpaceX, Mars colonization, Starlink, Powerwall, and of course, Tesla. Some people have mentioned that he could be a reincarnation of Nikola Tesla.

## ARRESTED FOR PREACHING THE GOSPEL IN ALABAMA?

Maybe in North Korea, maybe in Cuba, maybe in Iran – but not in the United States, the land of religious liberty.

Well, maybe in Boston, or San Francisco – but certainly not in Selma, Alabama, right in the center of the Bible belt.

But it happened. A man was arrested for preaching the Gospel of Jesus Christ on the street.

It was Halloween 2022. People in Selma were walking, some in costume, in an annual Monster March. And Rickey Caster, a Georgia street evangelist accompanied by his sister, came to tell them about Jesus Christ.

All went well for awhile. But then a police vehicle parked beside Rickey, and an officer demanded to see Rickey's permit. Rickey said he didn't need a permit to preach, but the officer said he needed a permit because he was using a microphone. Rickey then set down the mike and began preaching without it, but the officer still insisted he had to stop. His sister then asked whether Rickey could preach on a different street corner, but the officer was adamant. Deciding that he must obey God rather than men (Acts 5:29), Rickey continued to preach, whereupon the officer handcuffed him, placed him in the patrol car, and took him to the police station where he was booked and released pending trial.

The police charged Rickey with disorderly conduct in violation of the **Code of Alabama 13A-11-7**. The complaint alleges that he "cause[d] a public disturbance by blasting his voice over several speakers, at parents and children," and that he "placed his speakers within inches of said participants as they crossed over to the southwest side of the sidewalk."

Fortunately, or perhaps we should say providentially, Rickey made several wise choices.

**First**, he and his sister videoed the entire event, and the video clearly refutes the officer's account. The video proves that Rickey set up his speakers, not *"inches,"* but clear across the street from the pedestrians, although some of them did come close to him during the march. He was speaking loudly enough to be heard, but he wasn't shouting, he wasn't getting into people's faces, and he wasn't threatening or insulting people. The people didn't seem bothered by his preaching. Most hardly took notice; a few looked his way, and a few spoke words of encouragement like *"Preach it!"* When the patrol car arrived, several made comments like *"He's not bothering us."* Rickey was respectful toward the officers, always addressing them as *"Sir,"* but he was firm about his right and duty to preach the Word of God.

Second, Rickey promptly sought legal help. He contacted the Alliance Defending Freedom, which referred him to the Foundation for Moral Law, a nonprofit legal foundation in Montgomery, AL for which I serve as Senior Counsel. Together with Foundation attorneys Talmadge Butts and Katrinnah Darden, we began to prepare Rickey's defense.

The disorderly conduct statute prohibits "*abusive or obscene language*" and "*unreasonable noise*." It sounds like the kinds of prosecutions that took place during the civil rights era, but race played no role in this case. Rickey is black; the arresting officer and the officer who accompanied him are black; the prosecutor and the judge are also black. But the principle is the same. Free

exercise of religion and free speech are civi rights, and Rickey's civil rights were violated. Rickey's speech certainly wasn't obscene, so the City could only claim that it was "*abusive*." But is street preaching abusive? A few might think so, but many might view it favorably. We prepared to argue that the statute as applied was void for vagueness and violated the Fourteenth Amendment guarantee of due process of law because it did not give adequate notice of what was prohibited.

We prepared a motion to dismiss the charge. In the motion we argued that Rickey did not violate the statute, and further that even if he did violate it, the statute was unconstitutional because of vagueness, and because of the free exercise of religion and free speech and free speech clauses of the First Amendment.

We also noted the case of *Shuttlesworth v. City of Birmingham*, 373 U.S. 262 (1963). The Supreme Court in that case ruled that Rev. Shuttlesworth and his fellow demonstrators had a right to demonstrate without a permit, and when the City refused them a permit, they had a right to conduct their demonstration without it. The Court further noted that the requirement of a permit was "prior restraint," requiring advance permission to exercise the right of free speech, which is highly disfavored in American law; see Near v. Minnesota, 283 U.S. 697 (1931). We were convinced that this prohibition on prior restraint applied to Rickey, and we were hopeful that the court would grant our motion to dismiss.

So on March 29, Rickey, Talmadge, Katrinnah, and I drove to Selma for Rickey's trial. The courtroom was filled with people waiting for their cases to be called. Then the prosecutor entered the courtroom and asked to talk with us in the back room. There we explained the case to him, along with our factual and constitutional objections. He spoke to the officer, and they agreed to dismiss the charge. Selma is Bible belt country, and they don't want to seem hostile to preaching. But the officer wanted to make a statement to the court. He said Rickey had a constitutional right to preach and he was welcome to preach again in Selma, but others have rights too, and Rickey needs to respect them.

Rickey was sitting next to me, and he whispered that he hadn't been disrespectful and wanted to answer the officer's remarks. But I whispered back, *"Rickey, you've won. Now it's best to just thank the court and keep quiet until we get out of the courthouse."* He agreed.

### Rickey is a fine man of God, and we are thankful for the privilege of having represented him. May he continue to preach God's Word and lead many precious souls to Christ.

## Lincoln, Republicans, and Corporate Welfare

"I supported President Lincoln. I believed his war the corporate welfare/internal improvements



policy would be the only way to save the country, but I see my mistake. I visited Washington a few weeks ago, and I saw the corruption of the present administration—and so long as Abraham Lincoln and his Cabinet are in power, so long will war continue. And for what? For the preservation of the Constitution and the Union? No, but for the sake of politicians and government contractors." J.P. Morgan—American financier and banker, 1864.

Many individuals are familiar with President Dwight D. Eisenhower's warning about the "military-industrial complex" in his January 17, 1961, Farewell Address. The crux of this foreboding was to be leery of the military-industrial establishment's propensity to influence America's actions at home and abroad. Although this primarily referenced "war for profit" (echoing Smedley Darlington Butler's description of the war profiteers in his book, War is a Racket), it is not always confined to the war industry. Indeed, the intertwining of corporations and government can extend to multiple industries. Corporate welfare is typically manifested in the form of special favors, grants, tax breaks, etc.

Abe Lincoln's political career was intimately connected to corporate and banking interests. In 1832 Lincoln described his political philosophy: "I am in favor of a national bank. I am in favor of the internal improvement system, and a high protective tariff." These beliefs remained consistent, whether he was a Whig or a Republican.

The Republican Party was the amalgamation of several factions, one being the Protectionist Wing of the defunct Whig Party. This sects' philosophy mirrored many of the early Federalists relative to Lincoln's aforementioned trifecta of political thought. When Lincoln, a minority president, came to power, astute Southerners anticipated what was in store. A modern example that puts it in clear perspective appears in the AMC show Hell on Wheels, where Thomas Durant describes a circuitous railroad route to the bewilderment of some |observers. The route is drawn to maximize per mile federal subsidies and line the pockets of the group with direct financial interest in the railroads. Many of Lincoln's supporters would reap the rewards of this venture.

As one of the highest paid lawyers in the country, Lincoln's services were in high demand, especially by the railroads. He won numerous cases that benefitted the railroad industry and received many personal benefits in return. The Union Pacific Railroad, approved by Congress on July 1, 1862, was a key part of West Coast railroad expansion. [Massachusetts-born Thomas Clark "Doc" Durant was intimately connected to the Union Pacific, serving as its Vice-President. He was also part of the Credit Mobilier scandal.] Given the responsibility of naming the terminus of the newly created railroad, Lincoln selected Council Bluffs, Iowa; he owned property in the area. In one pen stroke Lincoln was able to greatly increase the value of his own property.

Many Southerners were aware of Lincoln and his ilk and the Confederate Constitution reflected it. One upgrade over the original constitution was the way

agenda was handled. From the outset, many Southerners complained about the ambiguously worded General Welfare Clause; Patrick Henry and others saw it as an open door for federal interventionism. The U.S. Constitution stated "...provide for the common defence and general welfare of the United States" whereas the Confederate Constitution stated "provide for the common defence, and carry on the government of the Confederate States..." This rewording was designed to lessen the chance of corporate/government abuse.



President Abraham Lincoln

Not only did the Confederate Constitution

"clean up" the "General Welfare Clause" it supported free trade and opposed protectionism. Article I, Section 8, Clause 2 stated: "but no bounties shall be granted from the Treasury; nor shall any duties or taxes on importation from foreign nations be laid to foster any branch of industry." [This wording is not in the U.S. Constitution.] This was clearly aimed at the Republican agenda of protecting industries that fostered cozy relationships with political leaders or parties.

The Southern States had fought the corporate welfare efforts of these political factions since the beginning of the republic. This "internal improvements" agenda went hand-in-hand with corporate welfare. Economist Randall Holcombe explained: "Southern Founders sought to prohibit general revenues from being used for the benefit of special interests. Tax revenues were to be spent for programs that benefited everyone, not a specific segment of the population." As another way to deter financial shenanigans, the Confederate Constitution gave its president a line item veto, where parts of a bill could be removed.

It is not surprising that so many modern Democrats, Republicans, Neoconservatives, Globalists, Socialists, etc., place Lincoln on a pedestal. As J.P. Morgan noted, Lincoln and his cabinet were masters of corruption and connecting favored industries with government.

"For veterans, military life comes with its own set of risk factors and potential causes for substance use and mental health issues," said Michael Leach of Addicted.org. "It's critical they receive the support and help they need."

Awareness of what leads to these problems can

ensure family and friends are equipped to help a loved one who is a veteran access the help and support they need. Risk factors can include the following:

- Trauma or stress because of past service, deployment, or combat.
- Struggling to reintegrate into civilian life.
- Mental health issues because of military service, such as PTSD, brain injuries, depression, or anxiety.
- Injuries and chronic pain because of military service.

Veterans struggling with substance use or mental health problem also need help overcoming the barriers to accessing the treatment they need. These barriers may include cost, stigma, inadequate funding, and limited resources in rural locations.

## **SLAM THE SCAM WITH SOCIAL SECURITY!**

The Social Security Administration and its Office of the Inspector General (OIG) continued to raise public awareness about Social Security imposter scams during the fourth annual "*Slam the Scam*" Day held in March. Social Security scams — where fraudsters pressure victims into making cash or gift card payments to fix alleged Social Security number problems or to avoid arrest – are an ongoing government imposter fraud scheme. For several years, Social Security imposter scams reported to the Federal Trade Commission. We've made concerted efforts to address this issue, through extensive outreach and investigative initiatives. These efforts have made a significant impact, reducing money reported lost to Social Security scams by 30 percent from 2021 to 2022.

## READY TO RETIRE? APPLY ONLINE WITH SOCIAL SECURITY

It's never too early to start planning for retirement and our online tools can help. Go to https://www.ssa.gov/myaccount/ to access your personal my Social Security account to get an estimate of your retirement benefits based on your earnings record. Once you have an account, you can use our Plan for Retirement tool to see how your benefits can change at different ages. Don't have a personal my Social Security account? You can create one at https://www.ssa.gov/myaccount/

You can also use your personal my Social Security account to see your entire work history and make sure we have all your wages recorded correctly. We base your benefit amount on the earnings reported to us. If you find any errors in your work history, read this guide *www.ssa.gov/pubs/EN-05-10081.pdf* to learn how to correct your Social Security record.

When you're ready to apply for Social Security retirement benefits, you can complete our online application in as little as 15 minutes at www.ssa.gov/re-tirement. We will contact you if we need any further information. You can check the status of your application through your online account.

You can apply online for Social Security retirement benefits, or benefits as a spouse, if you:

- Are at least 61 years and nine months old.
- Are not currently receiving benefits on your own Social Security record.
- Have not already applied for retirement benefits.
- Want your benefits to start no later than four months in the future. (We cannot process your application if you apply for benefits more than four months in advance)

### YOUR PERSONAL MY SOCIAL SECURITY ACCOUNT IS FOR EVERY STAGE IN YOUR CAREER

Your personal my Social Security account is here for you at every stage of your career. You don't have to be retired or even close to retirement to take advantage of it. With an account, you can conduct much of your Social Security business online. For example, you can request a replacement Social Security card (in most states and the District of Columbia) whether you receive benefits or not.

If you are not currently receiving benefits, you can use your personal my Social Security account to:

- Review your earnings history.
- Estimate your future benefits to help plan for retirement.
- Get instant proof that you do not receive benefits
- Check the status of your Social Security application, if you decide to apply for benefits.

If you already receive Social Security benefits, use your account to:

- Change your address.
- Get instant proof that you receive benefits.
- Set up or change your direct deposit.

"I am proud of the work we have done to combat Social Security imposter scams and raise public awareness," said Kilolo Kijakazi, Acting Commissioner of Social Security. "We will continue to use every tool at our disposal to protect the public and their critical benefits. We urge Americans to remain vigilant, do not give out personal information or money, and report any scam attempts."

Scammers use sophisticated tactics to trick potential victims into disclosing personal and financial information. *Typically, they use the five P's – Pretend, Prize or Problem, Pressure, and Payment.* 

For example, scammers pretend they are from Social Security in phone calls or emails and claim there is a problem with the person's Social Security number. The scammer's caller ID may be spoofed to look like a legitimate government number. Scammers may also send fake documents to pressure people into complying with demands for information or money.

Other common tactics include citing *"badge numbers"* and using fraudulent Social Security letterhead to target individuals for payment or personal information.

### We will never:

- Tell you that your Social Security number is suspended.
- Contact you to demand an immediate payment.
- Threaten you with arrest.
- Ask for your credit or debit card numbers over the phone.
- Request gift cards or cash.
- Promise a Social Security benefit approval or increase in exchange for information or money.

Our employees do contact the public by telephone for business purposes. Ordinarily, we call people who recently applied for benefits, are already receiving payments and require updates to their record or requested a phone call from us. If there is a problem with a person's Social Security number or record, we will mail a letter.

"Working with our law enforcement and private sector partners to inform consumers about scammers and their deceptive practices remains a priority for my office. We will continue promoting National Slam the Scam Day to help protect consumers from these predators. Slamming the scam begins with consumers quickly taking a step to hang up the phone, or delete suspicious texts and emails, without responding to the scammers," said Gail S. Ennis, Inspector General for the Social Security Administration. "That remains the easiest and most effective method to avoid falling prey to these vicious scams."

## "April showers bring May flowers"

The old adage, "April showers bring May flowers" will hopefully hold true for May 2023. And with these

showers come many weeds. Before getting down to the business of actually planting, preparing the beds is a must. And this includes weeding, adding any soil or organic material, and applying fertilizer.

Over the years, many newer gardeners have asked how much water do flowers and shrubs require. Of course, some plants need more water than others. As a rule of thumb, a woody stemmed flower requires less water than a herbaceous plant.

Watering requirements also depend on the time of the year. Naturally plants take less water in the dead of winter than in the middle of July. For example, the common marigold can thrive in constantly wet soil which would rot impatiens. Let me put it this way, there are always exceptions to the rule. When purchasing unfamiliar flowers and plants, the plant label is a good guide for watering requirements. Below are some general guidelines which have helped me over the years.

### **General Watering information:**

1. Water flowers and shrubs before noon, so that they dry out, as opposed to later in the day this time of the year. This timing is essential to allow the moisture on the leaves and the top layer of soil to dry out. If the watering takes place in the late afternoon and/or evening, the soil will be warm and together with the wet foliage, it creates a magnet for mold, fungus and pesky insects. And if the soil has been mulched to conserve water, then watering before noon can be critical for the health of the plants. Watering before noon allows the maximum amount of water to reach the roots before the water evaporates.

2. Many people believe that they have adequately watered their plants by sprinkling the ground or pot with a hand held hose. Much of the time, although the ground looks wet, only the surface of the dirt is wet and not the roots. The best rule of thumb is to poke an index finger into the ground to the depth of the first knuckle. If the soil feels watered, the watering is complete.

3. The above caveats are good for the pot garden.

4. Although overwatering plants is rare, it can also be a problem. Most flowers and shrubs do not like what is called "wet feet", which means that the roots are sitting in water. Poor drainage rots the roots, leading to death of the plant. In pot gardens, the cause usually can be attributed to the drainage hole being stopped up with the pot collecting water.

5. To prevent poor drainage in flower pots, no matter the size, add gravel or broken pottery over the bottom hole. This prevents caking of the soil which acts like a plug in a bathtub drain. If the soil in the garden does not drain, the first thing to notice is yellowing of the leaves which alerts one to the poor drainage issue. Also, when lifting the plant, the plant roots may have an odor attributed to what has become sour soil. So the remedy would be to take all plants out of the ground, and raise the beds between 4-6 inches. Of course those plants with the rotten roots should be discarded.

### PLANT OF THE MONTH--CLEMATIS



Clematis is a member of the Buttercup family and includes climbing species and shrubby forms. Most are familiar with the woody stemmed vines, which produce showy bright flowers in the spring. I have had clematis vines for years which bloom off the dead wood. Spectacular saucer sized flowers adorn the vines. They need moist humus rich soil and at least 4 hours of sun per day. Some say that if you put their feet in the shade and their heads in the sun, they will thrive.

## **Metastasized Breast Cancer stage 3** The story I didn't expect.....

I was diagnosed with cancer in my lymph nodes next to my breast where I had breast cancer 21 years before with a total radical mastectomy.

How did I know? I was encouraged to have a breast MRI with contrast by the Mongomery Imaging Center when I had my yearly mammogram. It is by the Grace of God that I responded to their request. It began within a order, day, there was also an prearranged CT scan for that day to check my lungs. Both tests showed two lymph nodes that looked cancerous. An ultrasound was two days later which confirmed it on the day before Thanksgiving.

A needle biopsy was ordered for six days later confirming they were finding at least two cancerous lymph nodes. Iwould need to have an appointment with my oncologist, Dr.Stephan Davidson. He reassured me, then told me how surprised to see me with Metastasized Breast Cancer. He bragged on about how I always had my mammograms and scheduled oncology appointments. But he wanted a PET scan done. I am thankful his scheduling secretary was able to get a quick appointment.

A PET scan let him see if there are cancerous tissues or cells anywhere else in the body. He saw me December 20 to discusswhat the scan showed. Only saw a few nodes in my lungs he is watching.

He discussed all procedures he needs to consider such as surgery first or shrink the nodes first before surgery.

I choose to wait until after Christmas to go to the surgeon. I asked for Dr. Pam Strickland. I decided to have surgery on December 30 with Dr.Strickland, breast surgeon.

She did a follow up with me to discuss what the pathology report from UAB showed after surgery. She located five cancerous lymph nodes and cancer around one in the tissue. She removed it all.

In the meantime I experienced a Seroma. It is where fluid gathers around the incision. She had me come into her office two times to drain the fluid, each time it was 4 ounces. On February 14, the second visit she decided to place a drain in my incision to take the fluid out for 10 days. I emptied it several times a day.

Then I saw my oncologist on February 16, he said until all fluids are gone, plus the hematoma, seroma and incision are healed, no chemotherapy can start.

We made the decision to have a smart port surgery before starting chemotherapy. After chemo radiation is recommended, when it is completed I will begin a new chemo pill.

The first visit to use my port was a successful

> one. It is still a little difficult to get comfortable sleeping with the port. I had a few side effects that were uncomfortable.

The first was thrush in my mouth and throat. Yes, think of those poor babies that have it and don't understand.

There is a lot of special skin care this time, and I started losing my hair two weeks after my first chemo treatment. When I went for the second treatment on April 12, I am bald.

Another side effect is lymphedema, I have a special consultant with TherapySouth. She has told me what I needed to be successful with this. I have a routine of massaging and lifting exercises I can do. I will need a lymphedema sleeve for airplanes and higher elevations.

As far as radiation treatment, that is the recommended next step. After my last chemotreatment I will be checked to see if I am ready for radiation.

Expect to hear more from me soon.

Southern Cuisine Chef David Spooner, Retired Chef

Southern cuisine in the United States has been shaped by a variety of influences, including African and Asian cuisines. Both of these culinary traditions have left an indelible mark on the flavors, techniques, and ingredients of Southern cooking. The influences of African

and Asian cuisines have helped to shape the unique and diverse flavors of Southern cuisine. From the use of spices and herbs to the incorporation of new ingredients, these culinary traditions have contributed to the evolution of Southern cooking over time. Two recipes introduced this month will be examples of the African and Asian influence to Southern cuisine.



African slaves were brought to the Southern United States during the 18th and 19th centuries, and they brought with them a wealth of culinary knowledge and traditions. Many Southern dishes today, such as gumbo, jambalaya, and black-eyed peas, have roots in African cuisine.



One significant contribution from African cuisine is the use of spices and herbs, such as cumin, coriander, and ginger, which add depth and

## Ingredients:

- 1 cup ketchup

In a small bowl, whisk together the flour and milk. Stir the mixture into the lima beans and cook for 2-3 minutes, or until the mixture thickens.

Crumble the cooked bacon and stir it into the lima bean mixture. Pour the lima bean mixture into a 2-quart casserole dish and sprinkle the grated Parmesan cheese on top.

Bake the casserole for 20-25 minutes, or until the cheese is melted and bubbly.
