# THE WALL



The Replica of the Vietnam Wall traveled through Montgomery September 6, 2023 with a stopover at the intersection of U.S. Highway 80 and U.S. Highway 31 in the parking lot of the Winn Dixie grocery store. Representatives from Vietnam Veterans of America Chapter 607 dressed in their Vietnam veterans' hats, veterans on motorcycles and representatives of the Central-East AL Chapter of the American Red Cross lined up behind escorts from the Montgomery County Sheriff's Department and the Montgomery Police Department who led the procession as it traveled along the Eastern Boulevard to the Troy Highway. Many accompanied the special truck labeled "The Wall" to its destination for display of the Replica as the Escort added vehicles along the way and even had a fire truck with the large American Flag hanging from the ladder as it passed through Troy.

The convoy stopped briefly in Ozark to pick up a Huey Helicopter from the Friends of Army Aviation in Ozark to fly "Cover" for the procession as it travelled the last 30 miles of the 111 mile Escort and finished at the Festival Fairgrounds at Dothan, AL, where it was displayed for five days. The driver of the truck for The Wall, Jim Gilliand, a veteran from Texas who served 28 years in the U.S. Army including Desert Storm, has been driving the Replica's truck for three years throughout the nation. Gilliand states, "I like to travel and to support and honor the Vietnam War veterans.'

# It's Official - Alabama will have New Congressional Districts.



delegation under new lines next year. The federal court has spoken. The special master drawing the lines has acted and the final omnipotent power, the U.S. Supreme Court, has concurred and confirmed the decision. It is over.

The result that the plaintiffs desired has been decreed by the courts. There will be a new second majority Black Congressional district. This accomplishment has been sought for decades.

Now the question becomes, can the Democrats succeed in electing a Black Democrat to this new opportunity district. It is not a slam dunk. The new district is 50% Black and 50% White. It favors a Montgomery candidate. The bulk of the population and the geographic center of the new district is Montgomery county. Montgomerians are like the rest of the state, they adhere to the wellknown predilection known as "friends and neighbors" politics. That means they prefer to vote for someone from their neck of the words, especially their county.

My early prediction is that Montgomery mayor, Steven Reed, will be the Democratic nominee and will be the favorite to win the new Seat.

The special master that drew the new lines attached an index to his maps that revealed that if there were a congressional race within this new district that this district would have voted for the Democrat in 15 out of 17 of the last 17 elections. Therefore, the court's desire to make a second minority Democratic district where a Democrat has a good opportunity to win has been accomplished.

The entire basis of this high profile federal case has been centered around the fact that Alabama has one Black Democratic Congressperson, Terri Sewell, and six White Republicans. One Black Democrat constitutes 14% of the state's population. The plaintiff's argument that the state's Black population is 27%. Therefore, there should be two Black Democratic congressional seats in the Heart of Dixie. The courts bought that argument and hung their hat on the 1965 Voting Rights Act and having one seat rather than two violates and dilutes Black voters in Alabama's voting rights.

The question now becomes, what are the down home political implications and results of these court mandated new congressional lines. All of you who live in middle and north Alabama, which is most of you, are unaffected. The majority of the people in Alabama, who live in Birmingham north are not affected. In fact, everyone north of Montgomery is unaffected. All of the commotion and

Our three powerful Republican congressmen are left with basically their same districts. Republicans Robert Aderholt, Mike Rogers and Gary Palmer, who are our centers of power in the House, have their same if not enhanced GOP districts. Huntsville's freshman congressman, Dale Strong's district is unchanged.

Congresswoman Terri Sewell's Democratic district has been favored in the drawings. She has a perfectly drawn district that pretty much mirrors her current Birmingham based seat. She will probably be spared a Republican challenge. However, State Senator Bobby Singleton, who hails from the Black Belt, may challenge her in a Democratic primary out of spite. He wanted a district that favored him but lost to Sewell in the legislative battles over the drawing of the new Black district.

The real rubber meets the road within the Republican ranks in the Wiregrass, and Mobile and Baldwin counties. The five Wiregrass counties of Covington, Dale, Geneva, Houston, and Coffee are sent to Baldwin and Mobile. Therefore, new Congressmen Jerry Carl from Mobile and Barry Moore from Enterprise/Coffee are in the same district. Moore is the odd man out in this dilemma. The majority of votes in this new district are in Baldwin and Mobile counties. Carl will be the prohibitive favorite against Moore, or any other Republican. It will be a very conservative Republican district. Therefore, six of our seven seats will be in safe reelection journeys for our incumbent congressmen. Jerry Carl in the first, Mike Rogers in the third, Robert Aderholt in the fourth, Dale Strong in the fifth, Gary Palmer in the sixth, and Terri Sewell in the seventh are very safe bets for reelection in 2024. Therefore, all of the turmoil and court intervention only affects one area of the state.

All the brouhaha and action will be in the newly drawn second district. It is Montgomery Democratic Mayor Steven Reed's race to lose. He will be the favorite to win and change Alabama's delegation in Washington from six Republicans and one Democrat to five Republicans and two Democrats. However, I would handicap that race as a 50/50 toss-up. There will be a lot of Republican dollars from Washington showered upon the Republican nominee. It will be interesting.

#### WHY DO EMPLOYERS SEEM TO FAVOR A 401(K)/ **403(B) OVER THE OLDER PENSION PLANS?**

In 1978, Congress passed a new tax code which included a new provision in the Internal Revenue Code, being section 401(k). The 401(k) provision is used by employers in the private for-profit sector. The 403(b) provisions are very similar but used by non-profits. Since the 1980's the **401(k)** and **403(b)** section retirement plans have become generally

favored over pension plans. Pension plans were entirely driven by the employer. Pension plans make the employer consider the length of service of the employee, the highest salary and the potential number of years that the employee may have in retirement.


One of my grandfathers, due to an single blinding eye disease in his youth could not serve in the armed forces during World War II. He eventually became a vice-President in an insulation firm that insulated many of the ships manufactured during World War II. He and my grandmother lived a good life as they went into retirement. While the occurrence was when I was a teen, I was told by my parents that the insulation firm went bankrupt when my grandfather was in his seventies and I was told that my grandfather lost his pension. He panicked because he lost one of the three parts of his retirement and I recall that he was applying to work at a gas station pumping gas. The 401(k) places the individual in a position to take on the risk and to contribute most of the retirement funds. Generally, the worker can contribute pre-tax at a time when their taxes are highest to a standard plan and if desired they can contribute post tax to a Roth plan. The worker may have the flexibility to have their individual plan managed by the investment company based on their risk tolerance and age or to even manage their investments themselves which requires time and educating oneself on best investments.

While a smaller risk is placed on the employer for a sponsored plan, it is not entirely without legal exposure. I do not include securities and investments representation in my law practice, but I have been able to learn some about the process of an employer sponsored plan. Hiring an investment firm that will meet the retirement goals and flexibility is one part to consider. Additionally, employers should also hire professionals to work with their oversight committee to consider the plan direction with less chance of the employer being negligent in their fiduciary duty.

Another part are the investment goals. Two goals have arisen in recent years; whether following indices of performance or industrials or a newer goal found principally among a few of the investment firms are funds that invest in com-

panies that promote ESG (environmental, social and governance) consciousness. While investing in **ESG** promoting companies may give some investors a feel good

about social consciousness, when intertwined with index funds there may be a conflict of interest and can result in misrepresentation by investment firms. Some of my recent reads have included comparison of **ESG** funds versus funds not committed to ESG values, showing the ESG funds being out performed. The reader should not take to heart this generalization in ESG investing and must do their own research or consider

# **We Must Reclaim Our Global Leadership**

America is falling far behind in the global arms race – specifically in the realm of hypersonic missile technology. With China and Russia making leaps and bounds, boasting speeds of Mach 10 and Mach 27 respectively, the United States finds itself in an unfamiliar, even precarious, position: playing catch-up.

To truly grasp the magnitude of the challenge we face, it's essential to understand the sheer speed of these hypersonic missiles. Mach 10 is an astounding 7,672 mph, while Mach 27 is an almost unimaginable 20,715 mph. In comparison, a U.S. cruise missile, like the Tomahawk, has a speed of about 550 mph. This means that China's DF-ZIRCON, traveling at Mach 10, is roughly 14 times faster than a Tomahawk missile. Russia's hypersonic missile, which can reach Mach 27, is a staggering 38 times faster. It's not just a matter of a few extra miles per hour, it's an entirely different league of speed. This gap isn't merely a technical discrepancy, it's a chasm that highlights the urgency of our need to innovate and advance our defense capabilities.

How has the country that, under Ronald Reagan, championed the doctrine of "peace through strength" found itself in such a dire state? China, as many reports indicate, has already undertaken a staggering 270 hypersonic weapons tests since 2014, mastering a technology that many consider to be the future of warfare. Their missiles like the DF-17 and DF-ZIRCON are not mere prototypes or ideas on a drawing board, they're realities that could now pierce through our defenses with unnerving speed and agility.

Russia, not to be outdone, has displayed its hypersonic prowess with the Kinzhal and Avangard. Disturbingly, they've used the Kinzhal in Ukraine, sending a clear message to the world about their military capabilities and intentions.

And where does the United States stand in this high-stakes race? Unfortunately, we're still in the development phase, with our Hypersonic Glide Body and Long-

Range Hypersonic Weapon scheduled for deployment in the mid-to-late 2020s. It's almost as if we've been caught

flat-footed, unaware of the rapid technological advancements of our competitors.

This is not just about maintaining an edge or having the most advanced toys in the sandbox, this is about global security. The terrifying reality is that these hypersonic missiles can potentially deliver nuclear payloads. Their agility and speed make them nearly impossible to intercept, presenting a real and present danger of nuclear escalation in any conflict.

What's especially galling is the basic research, that they built their hypersonic missiles on, is American.

Our path forward is clear and uncompromising. The U.S. must double down on its efforts, channeling resources into hypersonic missile development to ensure we remain a formidable deterrent against the growing might of China and Russia. Further, collaboration with our allies in creating defenses against these missiles is paramount. We must, as a nation, strive for nothing less than leadership in this pivotal technology. In the face of hypersonic threats, second place simply isn't good enough.

# Remembering the Life and Legacy of Lee Kuan Yew

Imagine a country in the 20th century that in a matter of 30 years went from a per capita income of \$500 to one of \$50,000. Imagine further that the country had no natural resources and was roughly 150 times smaller than Alabama.

And what would we think about a leader who achieved such spectacular results?

Meet Lee Kuan Yew, who, had he lived, would be 100 years old this month. From 1959 to 1990 he served as prime minister of Singapore and was largely responsible bringing a third world country into the first world.

In short, he was a visionary leader who contemplated a greatness for his country that few could imagine. He refused to accept the low expectations of his peoples' capabilities and embarked on a mission of almost unachievable goals.

When Lee (in Singapore last names come before given names) accepted the mantle of political leadership, the world bequeathed to him was neither stable nor secure or certain. Singapore was a city state with a strategically located port where ships from all over the world docked, but that seemed to be its only natural asset.

Far from homogeneous, Singapore's people were ethnically diverse with a stratified community of various faiths and cultures, with little historical memory. Other than the business of trade, the country had no unifying or organizing principle for political cohesion.

But, Lee, who trained as a lawyer in Cambridge with a smattering of additional education from the London School of Economics, created a political party that focused on a peaceful transition to home rule within the British Empire. Politically, he never sought independence, but saw Singapore as part of a larger state, merged with other, smaller countries that were former colonies in his region.

Initially, this concept worked, and for at least a few years, Singapore was part of Malaysia. But, with boundaries artificially defined and few commonalities between the people, Singapore was not a great fit as part of an emerging country.

Within the combined territories that comprised Malaysia, there were many factions based on ethnic issues and fueled in many ways by competing cold war ideologies. Singapore became infected with racial strife leading to riots stirred up by Malaysian ethnic rivalries.

To stop the bloodshed, Malaysia decided to expel Singapore at which point Singapore became the first country to inadvertently achieve independence. Thus, against its will, Singapore was foisted, kicking and screaming, into nationhood.

At this time, no one was sure how a large city could maintain a separate independent state in a rough neighborhood. Were it not for Lee's leadership, Singapore could easily have become a pawn in the larger cold war or a satellite in the Chinese sphere of influence.

But Lee had a different vision. While he was devastated by Singapore's expulsion, he embraced the opportunity and created a vision for Singapore that would set in motion a prosperity unimaginable to anyone-except for Lee Kuan Yew.

Realizing the vulnerabilities of the new country, Lee sought Singapore's diplomatic recognition. He applied for entrance and was accepted into the United

Nations. Largely dependent on other countries and with no minerals or other resources, he entered into treaties with surrounding nations. He also imposed conscription to rapidly built up a defense force.

Within his government, he removed all communist elements and supported President Johnson's policies in Vietnam. Thus, within a few years of independence, Lee had placed his small city state on the world stage.

Economically, Lee realized he must create employment opportunities for his citizens. Knowing that work and a high standard of living were a key to his independent country's growth and development, he created an economic policy that provided incentives for foreign investments.

He built factories and provided job training. Critically, he embraced the British legal system, adopting the common law so that foreign investors would know with certainty their rights would be protected against any nationalization. This stability, along with a low tax base and a highly skilled, but cheap labor force, expanded Singapore's economy to new heights.

As prime minister, Lee ran a squeaky-clean government with zero tolerance for corruption. One means to prevent corruption was to pay government employees a high wage so there was no incentive to supplement a government salary with bribes.

But the economic growth came at a cost. Even while embracing a market

economy to efficiently allocate resources, the people of Singapore were not given the rights Lee observed from his time in Britain. The press was not especially free as censorship was practiced to prevent criticism of government policies.

Under Lee, Singapore strictly enforced its criminal laws with public corporal

punishment for littering and executing anyone found guilty of trafficking in narcotics. When questioned about the severity of these laws, Lee's supporters pointed to the cleanliness of the city and the lack of serious crime.

Even though several human rights groups objected to Singapore's human rights violations, that did not stop foreign investment in the manufacturing sector, financial services, and international trade. Businesses liked the stability of the government but were also drawn to the work ethic of the people.

When asked why Singapore experienced such dynamic growth, Lee said that the most critical factor to achieve national competitiveness is "manpower resources," which he believed is exhibited in creativity, innovation, entrepreneurship and good management.

As Lee retired from government in 1990, he continued to serve in an advisory role and became a commentator about leadership, economic development, and the power of ideas.

Even after his death in 2015, his legacy as a visionary leader has grown, and his accomplishments are studied and cited as authority for creating a dynamic economy from scratch.

Remembering Lee Kwan Yew on his birthday, one quote is worth highlighting:

"A nation is great not by its size alone. It is the will, the cohesion, the stamina, the discipline of its people, and the quality of their leaders which ensure an honorable place in history".


you go. Very Shallow Thinking!! Let's discuss the Seven Pillars of Conservatism.

#### Appeal to Judges Manasco, Moorer & Marcus; **Mapping Our Future**

As expected, the three Judge panel in Birmingham rejected another disingenuous Congressional district voting map submitted by our Montgomery politburo. Much ink has spilled w.r.t. keeping 'communities of interest'

intact... one manifestation of ever cascading collateral damage driven by addressing symptoms instead of repairing the problem as population continually increases. We've witnessed far too much rhetoric evoking the 14th Amendment's Equal Protection Clause and Section 2 of the Voting Rights Act of 1965 instead of adherence to Constitutional [Article 1, Section 2] representation to address and resolve the problem.

I pray Judges Manasco, Moorer and Marcus give this specific [Article 1, Section 2] Constitutional design to the 'special master and cartographer' to complete their work. Start with one for 30,000 round-up districts and construct two districts to meet the guidelines for two black majority Congressional Districts. The political problem with more Constitutionally correct districts? ...decreased likelihood of reinstalling corrupt public servants like Congressperson Sewell to keep duopoly graft churning. 



# COLONEL HENRY P. FOWLER valiant veteran, Col Henry P. Fowler, served so Air Force, As a fighter pilot during the Vic



The valiant veteran, Col Henry P. Fowler, served 26 years in the United States Air Force. As a fighter pilot during the Vietnam War, he was shot down, captured and survived six years as a POW in the infamous Hanoi Hilton. His Air Force Specialty Code (AFSC) was fighter pilot and Staff Judge Advocate. His 19 medals, decorations, ribbons and citations included: Silver Stars (two), the Legion of Merit, the Bronze Star with Valor Device, Purple Hearts (two) and Air Medals (three).

He was selected as one of the outstanding young men of America in 1994, and he was chosen to be an "Eagle' by Air Command and Staff College's prestigious "Gathering of Eagles" which recognizes heroes past and present. In 2017, Maxwell Air Force Base honored him by dedicating its courtroom in his name.

Col Fowler was born at Washington., D.C. March 6, 1939 to his parents, Henry and Madeleine Fowler. He was reared at Bethesda and Chevy Chase, MD, and graduated from Bethesda-Chevy Chase High School. He enlisted and served in the U.S. Navy Reserve during 1964-1967. He graduated from George Washington University with a B. A Degree in Sociology and Psychology, and while attending college, he worked in apartment rentals and in construction.

Col Fowler's military career as an officer began when he received his commission February 10, 1965 as a distinguished graduate of the U. S. Air Force Officer Training School at Lackland Air Force Base, TX. He completed Undergraduate Training and was awarded his pilot's wings at Williams AFB, AZ, in May 1966. This was followed by Pilot Systems Operator Training and *F-4 Phantom II* Combat Crew Training from May to December 1966.


His first assignment was as an F-4 Pilot with the 433rd Tactical Squadron at Ubon Royal Thai Air Base, Thailand, from January 1967 until he was forced to eject over North Vietnam and was taken Prisoner of War on March 26, 1967. Col Fowler spent 2,157 days in captivity, and he was released during Operation Homecoming February 18, 1973.

POWs in Vietnam struggled to survive horrid conditions, physical pain and psychological deprivation often for years on end. Conditions were appalling. POWs were isolated often for years on end. POWs were isolated, beaten, tortured and paraded for propaganda. American POWs in North Vietnam were released in early 1973 as part of Operation Homecoming, the result of diplomatic negotiations concluding U.S. military involvement in Vietnam. On February 12, 1973, the first of 591 U.S. prisoners began to be repatriated, and return flights continued until late March. After Operation Homecoming, the U.S. still listed roughly 1,350 Americans as prisoners of war or missing in action but whose bodies were not recovered.

After his release, Col Fowler was briefly hospitalized to recover from his injuries, and then he completed *C-141 Starlifter* transition training before serving as a *C-141* pilot with the 86th Military Airlift Squadron at Travis AFB, CA from February 1974 to October 1975.

"It is an honor I never expected," said Fowler. "I do not have the words to express my feelings on the honor of this award today. I can only say thank you for this honor."

He received an Air Force Institute of Technology assignment to complete his Juris Doctorate Law Degree from Cumberland University of Law from October 1975 to August 1978. Upon completion of his Law Degree, Col Fowler served in the Civil Law Division at *Maxwell AFB*, *AL*, from August 1978 to June 1980.

His next assignment was as Assistant Staff Judge Advocate at *Maxwell AFB* April to November 1979 and then as Chief of the Military Affairs Division at *Maxwell AFB* November 1979 to June 1980. Col Fowler then served as an Instructor at the **Air Force Judge Advocate General's School (JAG)** at *Maxwell AFB* June 1980 to 1983.

Col Fowler was then deployed to Ramstein AFB, Germany, to serve as Deputy Staff Judge Advocate July 1984 to July 1987. He returned for service in the U.S.A. and served as **Staff Judge Advocate** at *Offutt AFB*, *NB*.

Col Fowler's military career ended August 1, 1991 at Headquarters at Maxwell AFB where his final assignment was **Staff Judge Advocate.** 

Since his military retirement, Col Fowler taught law at the Jones Law School at Faulkner University and at South University both located in Montgomery, AL.

He retired from all employment in 2023 completing exemplary military and law careers.


Col Fowler and his wife, Carol, have been married 10 years. He has two children and four grandchildren by a previous marriage. He has been a member of First Baptist Church, Eastmont Baptist Church and Vaughn Forest Baptist Church at Montgomery. AL. He enjoys reading as well as shooting his pistol at a shooting range.

Col Fowler's is quite modest about his heroic military service and survival. He states, "I am extra proud to have served my country. It was an honor to serve.

On Easter Sunday, March 26, 1967, Col Fowler and three other F-4 pilots were in pursuit of North Vietnamese aircraft at tree-top level when his aircraft was struck by surface-to-air missiles. Fowler ejected from his wounded aircraft at more than 250 miles per hour, suffering severe back injuries. He was captured 10 minutes after parachuting to the ground and taken to the Hanoi Hilton, where he remained in captivity for 2,157 days in a seven-by-nine-foot windowless cell. He was released on Feb. 18, 1973, during Operation Homecoming.

First Lieutenant Henry P. Fowler Jr. distinguished himself by gallantry in connection with military operations against an opposing armed force as an F4C Pilot in North Vietnam on 26 March 1967. On that date, Lieutenant Fowler's flight was on a day strike/combat air patrol mission against a target area with numerous defenses.

Lieutenant Fowler delivered his ordnance directly on target under withering fire from hostile forces.

After all ordnance was expended the strike was engaged by hostile aircraft. With complete disregard for his own personal safety, Lieutenant Fowler suppressed the hostile aircraft engagement subjecting himself to intense attack by numerous surface-to-air missiles.

By his gallantry and devotion to duty, Lieutenant Fowler has reflected great credit upon himself and the United States Air Force.


#### COL MICHAEL VERNE CHURCH: AGE 74



Col Michael Verne Church served 30 years in the United States Army. His Military Occupational Specialty (MOS) was Light Infantry. His medals, awards, citations, and decorations included: Distinguished Service Medal, Legion of Merit (2nd award), Defense Meritorious Service Medal, Meritorious Service Award (4th award), Army Commendation Medal (3rd award), Army Achievement Medal, National Defense Service Medal (2nd award), Humanitarian Service Medal, Army Service Ribbon, Overseas Service Ribbon (3rd award), Expert Infantryman Badge, Master Parachutist Badge, Air Assault

Badge, Ranger Tab and Joint Chiefs of Staff Iden-

tification Badge.



Col Church began his military service August 8, 1970, completing the **Infantry** Officer Basic Course at Ft. Benning, GA, followed by three weeks of Jump **School and nine weeks of Ranger School.** His first assignment was at Ft. Bragg, N.C., where he served with the **82nd Airbourne Division** as a *Platoon* Leader and an S-3(air) for three years. His next assignment was at the Panama Canal Zone for three years, first at Ft. Davis serving with the 193-Infantry Brigade as a Company Executive Officer and then as a Company Commander in the 4th Battalion 10th Infantry Brigade. He then transferred and served at Ft. Sherman at the Jungle Operations Training Center.

After his overseas assignment, Col Church attended the Infantry Officers Advanced Course at Ft. Benning, GA, for six months followed by attendance at the Defense Language Institute at Presidio of Monterey, CA, where he studied German. He then attended the Foreign Area Officers Course at Ft. Bragg, N.C. He was deployed to Bonn, Germany, for one year where he traveled over western Europe as a Foreign Area officer for one year. Benning, GA, when both of their fathers were serving in the military. He has enjoyed hunting, fishing, playing the guitar, and writing, singing, and recording country music. In 2010, he became an Anglican deacon, and in 2011, he was ordained a priest in the Anglican Church. He completed ministerial studies at St. Joseph of Arimathea Anglican Seminary in California. He has filled in as a priest at the Anglican Church of the Holy Comforter at Montevallo, AL, and at St. Andrews Anglican Church at West Point, GA. Since 2016, he has served as the rector at St. Thomas Aquinas Anglican Church at Montgomery, AL.

Col Church's conclusions about what serving in the military means to him are:

"Military service was a tradition in my family as my father served." His mother also served as a civilian employee of the Army Signal Corp during WWII. His goal throughout his Army career was to take care of soldiers. He would like to be remembered as a man of God and as a soldier's soldier.


He was sent to Luke AFB, AZ, for his entire time of active duty and was discharged

# IN MEMORY OF: EVERETT K. COLE

March 7, 1949 - September 1, 2023

Lance Corporal (Ret.) Everett K. Cole left this world suddenly on Friday evening, 9/1/2023. He was 74 years old. He leaves behind his wife of 53 years, Alice Law Cole, daughters Tina Cole Campbell, Meloney (Eric) Gwin, and Helen Diboll

as well as grandchildren, nieces, great nieces, nephews, uncle and cousins. He was a man who loved his family, friends and his country. He enjoyed being a Marine and loved God. A Celebration was held in his honor on October 7, 2023 at Vaughn Park Church of Christ on Vaughn Road. The celebration was as tribute not only to Everett, but to his Marine comrades who became such an important part of his life.

Taps and Reveille by Raymond Keel with Buglers of America, as well as prayers, bagpipes, songs and personal stories of commitments and friendships will last in memory forever.

"Go forth rejoicing in the knowledge that Everett is no longer in pain, is whole again and is resting in Paradise."

Everett K. Cole was a U. S. Marine who served in combat in VietNam, stepped on a mine May 22, 1969 and immediately suffered the loss of the right leg at the ankle with multiple severe shrapnel injuries to the left lower leg, damage to the knee and severe muscle damage to the left thigh.

Heroic measures of doctors and nurses saved the left leg from amputation, at that time. The left leg was amputated above the knee in August, 2014, due to a series of infections following five failed knee replacements.

He remained steadfastly loyal to the Marine Corps and the United States. This remarkable man's life personifies courage and determination to survive and to achieve in spite of extreme circumstances. He received the following medals and awards for his military service: Purple Heart, Bronze Star Medal with 'V', Combat Action Ribbon, National Defense Service Medal, VietNam Service Medal, Vietnam Cross of Gallantry and Vietnam Campaign Medal with 60 devices.

Everett was born March 7, 1949, in Moss Point, MS, to his parents, C.W. Cole and Helen R. Cole. He was reared in Century, FL, Cantonment, FL, and Pensacola, FL, and he attended Tate High School through the 10th grade attended Escambia High School until March,1967. In May, 1968, he was notified to report for a physical for the military draft and then joined the U.S. Marine Corps May 20, 1968, at age 19.

He completed Marine Corps Boot Camp at Parris Island, SC, October 21, 1968, and he was sent to the Marine Corps Camp LeJeune, NC, for infantry training for eight weeks. After reporting to the Marine Corps Camp Pendleton, CA, he received two more weeks of training followed by five days in Okinawa arriving for combat in VietNam February 6, 1969.

> Everett's four months tour of duty in VietNam ended when he triggered a landmine resulting in catastrophic injuries to his legs. Everett concluded that because his injuries occurred about 10:15 a.m. instead of p.m., he was quickly medevaced by helicopter to a Naval hospital in Vietnam by 10:30 a.m. which prevented his becoming a casualty. He also credited God's hand in saving his life. One hour before he was wounded, the lieutenant leading his unit had the patrol element practice drills to know what to do if someone might be wounded. Everett's best friend was assigned to carry the radio for the squad, and this was his first patrol as radio man. When the explosion went off,

Everett could hear the transmission for a chopper. As it turned out, a chopper with the call sign "Lady Ace" intercepted the message and stated that he was in the air with another wounded Marine and could take a couple more Marines.

This Lady Ace became Everett's rescue angel. The records show total rescue time was 12 minutes! After triage in Vietnam, he was sent to the 106th U. S. General Army Hospital in Yokohama, Japan, for three weeks where more of his right leg was amputated followed by treatment at the Philadelphia Naval Hospital in Philadelphia, PA, for four months. Everett was then sent to the VA Hospital in Montgomery, AL, where he met his future wife, Alice, who was employed there. After one year of treatment in military and VA hospitals, he was discharged May 30, 1970. Everett was medically retired from military service and in 1974 given permanent medical disability retirement from the Marine Corps.

Everett stated, "I have lived my life to the fullest and the best that I could. Vietnam stole my youth. I never had a chance to grow up." He married in 1970, and using the Chapter 31, Vocational Rehab benefits from the VA, he attended Alabama Christian College (Faulkner University) for two years receiving an Associate Degree transferring to

Huntingdon College graduating with a B.A. in Secondary Education in May, 1975. Instead of teaching, Everett was offered a job with the VA, where he worked at the VA Regional Office in Montgomery reaching the level of GS-13. He helped veterans by reviewing decisions made about veterans including processing education awards for G.I. Bill requests, reviewing disability ratings and serving as an adjudicator on legal documents retiring April 4, 2004, at the end of 30 years of service.

Although Everett suffered traumatic injuries at age 19, he retained his loyalty to the U. S. Marine Corps saying, "It gave me the ability to overcome saying, "I can't.' It gave me the drive to be the kind man that I should be. I believe in courage, commitment and honor. I've tried to live my life by that including God, family and the Corps. My wife of 49 years deserves the title of Marine as much as I do because of what she has gone through with me. I have always had a wife who listens."

# **COLUMBUS:**







During a recent speaking engagement in Columbus, Ohio, I asked to see the Columbus statue near City

My hosts sadly informed me that, after a protest that claimed Columbus had engaged in violence and enslaved Native Americas, in 2020 the statue had been placed in storage and will be replaced by

"a work of art that better represents the people of Columbus."

Why, we should ask, did Columbus come to America? It wasn't to prove the world is round; every educated person in 1492 knew that. Isaiah 40:22 speaks of the "circle of the earth," and the Hebrew word means "sphere."

So did Columbus say to Queen Isabella, "Send me west so I can brutalize and enslave natives"?

Hardly. The voyage to the west was to reach the Orient, preach the Gospel of Jesus Christ to the Great Kahn, and form a Christian alliance that could stand against the Islamic powers that posed a formidable barrier between Europe and

In his *Book of Prophecies* Columbus wrote:

"It was the Lord (I could feel His hand upon me) who put into my mind to sail to the Indies. ... There is no question that the inspiration was from the Holy Spirit, because He comforted me with rays of marvelous illumination from the Holy Scriptures..."

When Columbus first landed on October 12, 1492, he named the newfound island San Salvador (Holy Savior), he found friendly people known as the Taino or Arawaks. He wrote of them in his October 12 Journal entry,

"They remained so much our [friends] that it was a marvel...I believe that they would easily be made Christians, because it seemed to me that they belonged to no religion."

Four days later, on October 16 he wrote, "I don't recognize in them any religion, and I believe that very promptly they would turn Christians, for they are of very good understanding.'

But not all relations with Native Americans were friendly. A warlike tribe was moving northward from the southern islands, called the Caribs (Caribbean) or Canibs (cannibal). The Canibs were literally eating the Arawaks alive, and they made war on the Spaniards as well. As he and his men defended themselves and the Arawaks against the Canibs, he reluctantly decided that enslavement was the only way to subdue them. Unfortunately, those who came after Columbus did not differentiate between the Arawaks and the Caribs and

indiscriminately enslaved both. This was indefensible, but it was not what Columbus had intended. As Admiral of the Ocean Sea, Columbus was a great explorer and discoverer; as Governor of the Indies he was less effective in restraining the impulses of those who came after him.

In the Spanish conquest that followed, millions lost their lives, but mostly to disease, primarily smallpox, against which Native Americans had not built up immunities. This is tragic beyond proportion, but can moral blame be attached to it? No one at that time knew how disease was spread. Contact between the two worlds was inevitable, whether by Spaniards discovering America or Aztecs discovering Spain.

So the question remains: Should Columbus Day be celebrated or mourned?

To answer that question, we need to look at the facts, going back to the original sources such as the diaries, journals, and letters of the explorers and those who came with them. Columbus's Journal and Book of Prophecies deserve our attention, as does The Conquest of New Spain by Bernal Diaz del Castillo, One of Its Conquerors (5 vols). I have cited these and other works extensively in my own 1992 book, Columbus and Cortez, Conquerors for Christ.

But we interpret facts through our world view. To a cultural relativist, the Spanish Conquest is often condemned as one culture displacing and destroying another. If there are no absolutes, if cannibalism just a matter of dietary preference, and if human sacrifice might be either good or bad depending on which end of the knife you are facing, then the Canibs should have been allowed to continue eating the Arawaks and the Aztecs should have been permitted to continue sacrificing Toltecs and those of other tribes upon the pyramid altars to their gods. (But if there are no absolutes, then what is wrong with that? The relativist world view always ends up shooting itself in the foot.)

But what if you believe absolute truth does exist, and it is found in the Bible, the Word of God? What if you believe Jesus Christ is the only begotten Son of God who died for the sins of the world, and eternal salvation is found in Him and only in Him?

If you believe this, then the significance of Columbus Day must be judged based upon the millions of souls that are in heaven as a result of the way God used flawed instruments like Columbus, Cortez, and the rest of us, to bring the Good News of Jesus Christ to this western world.

# Tascalusa's **Burial Ground**

This month marks the 483rd anniversary of Hernando de Soto's great battle at Mauvila, a location that so far has not been found and examined. But one thing that has been discovered is a small mound complex that yielded the graves of important natives who had fought there, possibly including the great chief, Tascalusa.

The Pine Log Creek site (1Ba462), in the Alabama-Tombigbee Confluence Basin, might have seemed to be a routine native-American burial at first, but it has turned out to be a spectacular discovery.

The site was first mentioned in 1969 by Dr Herbert H. Holmes, who commented, "A skeleton unearthed by my father and uncle on the banks of Pine Log Creek, together with the copper buttons and insignia on the casket was identified as that of a soldier of De Soto."

The claim of a casket and "a soldier of De Soto" is utterly false. The Spaniards would have never buried their dead among Indian graves, and they would have never made caskets while traveling through a wilderness. The copper buttons and insignia were probably real, but they were not what made this place special. In 1981, an archaeology team from the University of South Alabama investigated this site and found five holes dug by pothunters. Scattered around them were human bones and large pottery sherds. The University made a "sketch map" and collected the bones and debris remaining on the surface. Later they recovered the looted artifacts from the pothunters and obtained some "general provenance data." Unfortunately, the landowners did not allow any further excavation and study of the site.

The graves yielded 4265 shell-tempered sherds, 46 shell-tempered vessels some whole—some partial, six copper headdress pieces, 58 stone items, 72 shell beads and pins, and "38 European artifacts, likely all 16th century Spanish." The latter included sword fragments, a lance or pike head, a bridle and cheek plate, a mule shoe, iron spikes, and 4 faceted seven layer chevron beads.

But the really extraordinary objects were two brass Spanish religious itemsa capstan-style candlestick and a holy water container—objects that the Hernando de Soto expedition had specifically documented being stolen during the battle at Mauvila. The Spaniards would have never traded or given away their personal utensils for saying Mass. These were none other than items that the Indians had pilfered from the Spaniards' stash during the battle. They were not items from Tristan de Luna or any other Spanish expeditions.

Without any doubt, these graves were related to Mauvila. And they were not just any random burials. Considering the huge quantity of precious (to the Indians) metal objects that were buried there, the skeletons were undoubtedly very important high-ranking people—Tascalusa's "principals," and very likely including his son.

Tascalusa's son had been documented as "lanced" by Soto's men. The probability of him being buried at this site is very high. He was recorded being as tall as Tascalusa himself, but more slender. Tascalusa's own death was never documented. Some Indians claimed he had escaped. Others said he was probably killed, but his body was never found. If Tascalusa had been killed and recovered by his warriors, he also would have been buried here.

One of the big questions that has never been answered is how big and how tall was Tascalusa? Soto's men described him as a "giant," but what was his actual size? There is no realistic documentation, except one likely false claim that his feet dragged on the ground while he sat on a horse.

If Tascalusa or his son were buried here, examination of the bones could verify their true sizes. Has anybody ever bothered to examine the recovered bones to see if any came from a very large or tall individual? Have any DNA tests been done to prove or disprove any family relationships to other tribes in the area? What about relationships to today's natives? How many of the bones have been saved, and how many were just left behind? Finally, are there any intact skeletons remaining that the looters had missed?

The site's position is something of an enigma. It is several miles south of the likely location of Mauvila (at or near Stolls Point, next to Hals Lake). Why were these important warriors buried there? One plausibility could be that the Indians had feared the Spaniards might later return to the battle site and desecrate their graves. So they buried their important "war heroes" beyond the areas the Spaniards had ravaged and in the opposite direction of where they proceeded.

Since 1981, the Pine Log Creek site has been neglected. For a long time, the property owners have rejected studies by archaeologists. This was a very selfish decision. It was also a very foolish one; it left the site as a target for looters instead of allowing experts to save, study, and protect the contents.

What about today? The property has likely changed hands since then. Perhaps the current owners understand the precious information that can be gained from a serious study, as well as needed protection. Has anybody even bothered to contact the owners recently? If they are still refusing, WHY?

Considering the site's great importance, an archaeological "eminent domain" might be proposed to study it. It would allow qualified people to dig and study the site and contents, but at the end, in all fairness, after studies and documentation have been done, recovered artifacts would be returned to the property

Right now, archaeologists need to get off of their duffs and get to work. The 500th anniversary of the Battle of Mauvila is only 17 years away. Very little work has been done to search for it, and the few who have made any attempts have very wrongfully concluded that it was somewhere at or near the lower portion of the Cahaba - far beyond the documented 30 leagues from Ochuse (Pensacola, Florida), and in spite of the burned daub and other evidence that had previously been discovered by Caleb Curren just west of Choctaw Lake. And of course, the Pine Log Creek site itself proves that Mauvila was only a short distance away.

In the future, perhaps some years from now, after the site has been fully explored and all artifacts and skeletons have been extracted and secured, local natives might want to erect a monument there to honor the brave warriors who gave their lives at the Battle of Mauvila.



You should be all set to receive the Montgomery County Sheriff's Office push notifications!









#### **Tuberville Sponsors** Legislation to Protect Alabama's Shrimp Industry

WASHINGTON, D.C – This week, U.S. Senator Tommy Tuberville (R-AL) joined Senators Bill Cassidy (R-LA), Joni Ernst (R-IA), John Boozman (R-AR), Cindy Hyde-Smith (R-MS), and Roger Wicker (R-MS) in introducing the Prioritizing Offensive Agricultural Disputes and Enforcement Act to protect U.S. agriculture while ensuring that the food which appears on U.S. store shelves meets U.S. health standards.

The Prioritizing Offensive Agricultural Disputes and Enforcement Act establishes a joint task force on agricultural trade enforcement led by the U.S. Trade Representative (USTR) and U.S. Department of Agriculture (USDA). The task force will proactively monitor upcoming foreign subsidies, rather than waiting to react after subsidies are in place and bring them to the attention of the World Trade Organization (WTO). Additionally, the bill will direct actions on countries that unfairly subsidize their producers and then flood the market with their products, such as India.

"Alabama's shrimp industry can out-compete anyone in the world—as long as the rules are fair," Coach Tuberville said. "But right now, the rules aren't fair, and our fisherman are suffering because of other countries who cheat at their trade obligations. We can't let that continue. This legislation would put a watchdog on agricultural trade to ensure that other countries play by the rules. That will let our fishermen thrive more than ever."

#### **BACKGROUND:**

During recent Farm Bill listening sessions throughout Alabama and the Southeast, Coach Tuberville heard the concerns of farmers and producers who are struggling in Joe Biden's economy. One of the concerns he heard was regarding Indian shrimp and rice being dumped on the U.S. market, driving down prices, and driving down income for American fishermen.

Establishing a USDA-USTR task force urges USTR to hold bad actors, like India, accountable for agricultural WTO violations and requires regular reporting to Congress and industry on those efforts.

Since 2005, the U.S. has imposed antidumping duties and conducted reviews of those duties on shrimp. These antidumping duties were placed on foreign shrimp suppliers as a result of unfair trade practices. These practices flooded the U.S. shrimp market with foreign frozen warm water shrimp, deteriorating the per-pound price from \$6.50 in 1980 to under \$1.00 today. The decline in shrimp prices has driven domestic harvesters out of business and allowed foreign entities to control this U.S. market. India is the world's top shrimp exporter, accounting for roughly 40 percent of U.S. shrimp imports, largely due to massive subsidies from the Indian government.

Alabama shrimp farmers produce approximately 200,000 to 300,000 pounds of shrimp annually. In 2020, Commercial Fishing Operations landed approximately 25.3 million pounds of wild shrimp in Alabama. In 2021, Commercial Shrimp Landings in Alabama totaled \$69.6 million in value.

As Alabama's voice on the Senate Committee on Agriculture, Nutrition, and Forestry, Coach Tuberville is committed to supporting Alabama's farmers and producers.

Act to add tree nuts, including pecans, to USDA's Seniors' Farmers' Market Nutrition Program. This would provide a new market for pecan producers and allow seniors increased access to nutritious, locally-sourced pecan products.

#### THE COMMERCIAL SHRIMP INDUSTRY IS ONE OF THE MOST VALUABLE FISHING INDUSTRIES ON THE GULF COAST.



Whether shrimp are wild caught or farm raised, success requires an understanding of shrimp biology, habitat requirements, and management approaches.

Shrimp are among approximately 8,500 species of invertebrates called decapods (10 feet) in the class Crustacea. The Alabama shrimp industry consists of wild-caught and farm-raised species, with wild caught having a far bigger harvest. The waters of Alabama contain fifteen to twenty-two species of shrimp, but only three are eaten and found in commercial quantities in the Gulf of Mexico (figure 1): brown (Farfantepenaeus aztecus), white (Litopenaeus setiferus), and pink (Farfantepenaeus duorarum).

In 2021, commercial shrimp landings in Alabama totaled 10.4 million pounds (\$34.3 million) of white shrimp, 10.8 million pounds (\$27.7 million) of brown shrimp, and 2.9 million (\$7.6 million) of pink shrimp, making this a valuable industry to the coastal economy (www.fisheries.noaa.gov).

For those in Alabama's shrimp industry, many factors go into a successful harvest. Chief among them is cultivating and preserving the habitats needed by shrimp to thrive.

Recently, the Native American Guardians Association (NAGA) lobbied the Washington Commanders football team to bring back the Redskins name. Billy Dieckman, Kiowa Tribe member and NAGA adviser, described Redskins as "a status symbol for elite warriors." (Fox News) A poll was cited showing 90% of American Indians see it as a positive term. It is also likely that some American Indians do not appreciate being can-

celed, such as the way Land O Lakes terminated the

"Mia" image (some Indians supported this change). Sports nicknames and brand images are generally considered honorary, not derogatory. Who do you think is behind this agenda? Could it be the group Malcom X detested? -- "The White liberal is the worst enemy to America and the worst enemy to the Black man..." (Goodreads) This description could certainly encompass other groups these Jacobins want to lord over.

Despite the multiple battles between White settlers and American Indians, there was a degree of regional and cultural commonality that transcended much of the historical acrimony. This is found in the fact that the only "official" allies of the Confederate States were the Indian tribes of the South. Treaties were signed between the Confederate States and the Choctaw, Chickasaw, Cherokee, Creek, Seminole, Comanche, Caddo, and others. These tribes were promised representation in the Confederate Congress. Anti-secessionist Confederate General Albert Pike arranged many of these agreements. Pike, born in Massachusetts, left that State in 1831 and became involved with fur trapping and trading. "He settled in Arkansas and became a noted poet, author, and teacher. He bought a plantation and operated a newspaper, the Arkansas Advocate." (History) Pike developed cordial relations with the Indian population and often provided legal representation for those who had disputes with the federal government.

Although many Indians likely felt the South's quest for independence was not necessarily their fight, the enormity of the event led many to pick a side. Should they align with the Union that had rarely, if ever, honored a treaty or should they side with the Confederacy, which offered recognition of their sovereignty and pledged to respect it? The vast majority sided with the Confederacy despite the fact some Southerners had been part of the 1830-1847 federal removal. Not only had experience shown the dishonesty of the U.S. government, there were other red flags, e.g., William Seward and other Republicans encouraging the distribution of land in Indian Territory to White settlers.

Each Indian Nation provided military support for the Confederacy. Units included the following:

- Cherokee--the 1st Cherokee Mounted Rifles, the 1st Regiment of Cherokee Mounted Volunteers, Cherokee Special Services Battalion, and several more. Plus, the last Confederate General to surrender was Stand Watie, a Cherokee Indian.
- Creek (Muscogee)--the 1st and 2nd Regiment of Creek Volunteers
- and the 1st Battalion Creek Confederate Cavalry. • Seminole--the 1st Regiment Seminole Mounted Volunteers and the 1st Battalion Seminole Mounted Volunteers.

- Confederate Indians • Chickasaw--the 1st Regiment of both Chickasaw Infantry and Cav
  - of Mounted Volunteers. • Choctaw--the 1st, 2nd, and 3rd Regiments of Choctaw Mounted Rifles, Deneale's Regiment of Choctaw Warriors, and others.

alry, the 1st Battalion of Chickasaw Cavalry and Shecoe's Chickasaw Battalion

• The Northwest Frontier Command of Indian Territory--the 1st Osage Battalion, Major George Washington's Frontier Battalion, and Major James W. Cooper's Battalion.

Although there were "Native Americans" in Union service, some Yankees did not shy from their disdain for American Indians. For example, William T. Sherman said: "The more Indians we can kill this year the fewer we will need to kill the next, because the more I see of the Indians the more convinced I become that they must either all be killed or be maintained as a species of pauper. Their attempts at civilization is ridiculous...." (Pt. Lookout) Not to be outdone, Union General Phil Sheridan proclaimed: "the only good Indian I ever saw were dead, as spoken to Tosawi of the Comanches." (Kibby) Furthermore, seemingly an early advocate of the "replacement" agenda, Sherman said: "To the petulant and persistent secessionists, why death is mercy, and the quicker he or she is disposed of the better. Until we can repopulate Georgia, it is useless to occupy it..." Is there a lower form of humanity than someone who wishes to exterminate a racial or ethnic group?

Slightly under two years into the war, Lincoln exhibited a similarly callous attitude when, on December 26, 1862, he ordered the mass execution of 303 Indians in Mankato, Minnesota, after their questionable convictions by military trials. Concerned about negative European perception, Lincoln reduced the execution number to thirty-eight.

Of course, American Indians were punished during the post-war "Reconstruction" similar to others who fought for Southern Independence.

The Benefit Screener helps you determine your eligibility for benefits and the Card Replacement Screener helps you request a replacement Social Security card. Let's go over how you can use these tools.

#### **Benefits Screener**

You can access the Benefits Screener tool at:

https://www.ssa.gov/prepare/check-eligibility-for-benefits

to determine which benefits you may be eligible for, typically in 10 minutes or less! Whether you're considering retirement, disability, survivor, or other types of benefits, this tool will guide you in the right direction.

To use the screener, select the "Start" button and answer a few questions about what's going on in your life. You will immediately get a response that tells you which benefits you may be eligible for based on your answers.

#### **Card Replacement Screener**

You can access the Card Replacement Screener at: https://www.ssa.gov/number-card/replace-card If you need a physical Social Security card, you can use this screener to determine the best way to replace it.

Depending on your situation, you may be able to request a replacement Social Security card without visiting a local office. Select "Answer a few questions" on the Replacement Card page to get started. If you can't complete the process online and have to visit an office, you can save yourself time by starting with the online application.

Requesting a replacement Social Security card is free. In most situations, you do not need to present a physical card – just knowing your Social Security number is usually enough. But if you do need the physical card, you can use this online screener to get started.

# MINIMIZING THE RISK OF FINANCIAL ABUSE FOR PEOPLE LIVING WITH DEMENTIA

Financial crime against older Americans is a growing problem. People living with dementia are at an especially high risk of becoming victims. That's why we're committed to combatting fraud.

As their memory and other thinking skills decline, people with dementia may struggle to make financial decisions. They may not remember or report the abuse – or understand that someone is taking advantage of them. This abuse can occur anywhere – including at home or in care settings.

Victims of fraud who are 80 years and older lose an average of \$39,200 every year. Studies show that financial exploitation is the most common form of elder abuse. However, only a small fraction of these incidents are reported.

You can help protect others by learning to recognize common signs of financial exploitation and abuse, including:

- Unopened bills.
- Unusual or large purchases.
- Utilities being shut off due to unpaid bills.
- Money given to telemarketers or soliciting companies.
- Unexplained withdrawals from the person's bank account.

There are also many simple things that caregivers can do to reduce the risk of financial abuse for people with dementia and similar conditions, like Alzheimer's. Do your best to make sure they're involved in deciding which safety measures to put into place.

Some options include:

- Agreeing to spending limits on credit cards.
- Signing up for the "Do Not Call" list at DoNotCall.gov.
- Setting up auto-pay for bills instead of paying them by check.
- Signing up to receive automatic notifications for withdrawals from bank accounts or large charges to credit cards.
- Requesting electronic bank and credit card statements and watching for unusual purchases or changes in how the person typically spends money.
- Asking credit card companies to stop sending balance transfer checks and opting out of future solicitations.
- Creating a separate account where you can keep a small, agreed-upon amount of money that the person can use for recreational activities, meals with friends, etc.

# DISABILITY: PART OF THE EQUITY EQUATION

People with disabilities play an important role in a diverse and inclusive workforce. We would like to tell you about Amy and her path to financial independence through work.

#### Meet Amy

Amy has a developmental disability that affects her speech, learning, and social interactions. When she was ready to find a path to financial independence through work, Amy turned to her **State Vocational Rehabilitation (VR)** agency for help. Amy's VR counselor told her about **Social Security's Ticket to Work (Ticket) Program.** 

The Ticket Program supports career development for people with disabilities who want to work. Adults ages 18 through 64 who receive Social Security disability benefits or Supplemental Security Income (SSI) qualify for this free and voluntary program. Through the Ticket Program, service providers offer free employment support services.

Amy had questions about how employment could affect her benefits. Her State VR counselor connected her with Full Circle Employment Solutions. Full Circle is an Employment Network (EN) with benefits counselors on staff who explained how working might affect her disability benefits.

Amy's benefits counselor also told her about Work Incentives. Work Incentives make it easier for adults with disabilities to enhance their job skills and gain work experience. They do so while receiving Medicaid or Medicare and Social Security benefits or SSI payments.

With a better understanding of these supports, Amy was ready to explore her employment options. She pursued an internship with **Project SEARCH**, a training program for young adults with developmental disabilities. Through **Project SEARCH**, Amy landed an internship that led to a permanent position with her local government.

Amy earned her way to financial independence and no longer receives SSI. Now, she's a union member, receives benefits through her job, and enjoys the security and stability that come with full-time employment. She's grateful for the support she received through the Ticket Program and looks forward to building the future she always hoped for.

"This job makes me feel needed and welcomed," she says. "I have learned about what motivates me and how to keep going, even when things get hard."

# Couthern Cuisine

 $m{K}$ emember that this is the ending of summer and the starting of Fall. One of the joys of Fall is enjoying the delicious and comforting meals that are typical of the season. In the South, there are many dishes that celebrate the bounty and flavor of autumn, such as fried okra, sweet potato casserole, collard greens, apple pie, tomato pie, and pecan pie. These are some of the most popular meals in the South and they can be made with fresh, local ingredients that are harvested this time of year.

A hearty, endlessly customizable stew, traditional burgoo often contains game meat, pork, root vegetables like potatoes and cabbage, and beans. Give yourself an afternoon to let this dish simmer on the stove (or in the slow cooker) to allow the flavors to develop. Often made in large quantities, the original was said to serve Frankfort's Buffalo Trace distillery, so be ready to freeze extras or bring this main dish over to your next church function.

"It's the Kentucky version of gumbo," Landry said. "It has been made with all kinds of meats over the years but was often a communal endeavor where the bounty from the hunt was shared. Many suggest it is from the French ragout (pronounced ra-GOO), meaning stew."

#### Gumbo

While slimy okra gives many modern eaters the yuck, the veggie serves an essential purpose in this Louisiana stew: as a thickener. "The name gumbo comes from a West African word for okra, Ki Negombo, as okra was often used in the stew as a thickening agent. This demonstrates how African culinary practices were incorporated into the New World."

While there are two schools of thought when preparing gumbo, the well-spiced stew typically contains a protein, the Holy Trinity of vegetables (onions, bell peppers, and celery), a roux to thicken, and is served over rice.

Whether you prefer a Creole version with shellfish or a Cajun version with andouille and chicken, there's no wrong answer when it comes to gumbo. With influences and ingredients from many cultures, including African, French, Spanish, German, and Indigenous peoples, gumbo reflects the many people who made Louisiana their home.

This tuna noodle casserole is the best with a classic creamy taste from my childhood. The sauce is rich and creamy but not overwhelmingly heavy. The crunch from the topping and fresh bite from the parsley create the perfect balance. Let's not forget that this is a great budget-friendly meal to feed a crowd!



#### TUNA NOODLE CASSEROLE

#### Ingredients

- 1 (12 ounce) package egg noodles
- 2 (10.5 ounce) cans condensed cream of mushroom soup
- 2 cups shredded Cheddar cheese, divided
- 2 (5 ounce) cans tuna, drained 1 cup irozen green peas
- 1/2 (4.5 ounce) can sliced mushrooms
- 1/4 cup chopped onion
- 1 cup crushed potato chips or panko

#### Directions

The panko gives the casserole a crunchy crust.

Gather all ingredients. Bring a large pot of water to a boil. Add egg noodles and 3 teaspoons salt to the boiling water; cook until tender yet firm to the bite, about 6 minutes. Drain noodles. Return to pot and set aside.

Heat 2 tablespoons butter and 1 tablespoon oil in a large skillet over medium-high heat. Add mushrooms and onion and cook until mushrooms are softened, and onions are translucent, about

Add remaining butter; stir constantly until melted. Sprinkle flour over vegetable mixture and cook, stirring constantly, for 1 minute. Stir in milk and stock and bring to a simmer, stirring often. Simmer for 5 minutes. Stir in lemon juice, Dijon mustard, 1 teaspoon salt, and pepper. Add sauce mixture to reserved noodles. Stir in 1 cup Cheddar cheese, peas, and tuna. Pour mixture into the prepared baking dish and sprinkle remaining Cheddar cheese over the top. Stir together panko, remaining 2 teaspoons oil, remaining 1/4 teaspoon salt, and paprika in a small bowl. Sprinkle bread crumb mixture evenly over the casserole. Bake in the preheated oven until golden and bubbly, 25 to 30 minutes.

Sprinkle with parsley and serve.

### Chow Chow

Also known as Piccalilli and Indian Pickle, the sweet a nd briny relish is made of the summer's bounty of veggies, often including green tomatoes, cabbage, onions, bell peppers, and spices like mustard and celery seeds. Open a Southern Grandma's pantry, and you'll likely find a few jars of the condiment put up and ready to be served with barbecue, hot dogs, or more traditionally, soup beans.

The origin of the name likely comes from one of the main ingredients, cabbage. In Louisiana, many of our recipes come from the Acadian people from Nova Scotia who were expelled from Canada and later settled in Louisiana. While the origin of the word is debated, we believe in Louisiana that the term came from the French word for cabbage, "chou".

Unusual names are common place in Southern cooking as much as uncommon combination of ingredients. One good example of uncommon combinations of ingredients in this next cake. Tomato soup is not something that you will commonly find in a spice cake. But it is in this cake.

#### **Tomato Soup** Spice Cake with Cream Cheese Frosting

#### Ingredients for cake

- 2 cups all-purpose flour
- 11/3 cups sugar
- 4 teaspoons baking powder
- 1 teaspoon baking soda
- 1 1/2 teaspoons ground allspice 1 teaspoon ground cinnamon
- 1/2 teaspoon ground cloves
- 1 (10 3/4 oz) can condensed
- tomato soup 1/2 cup unsalted butter melted
- 2 eggs
- 1/4 cup water
- 1 cup raisins

# CREAM CHEESE FROSTING

8 oz cream cheese, at room temperature 1/2 cup unsalted butter, at room temperature 2 to 3 cups sifted confectioners' sugar 1/4 teaspoon ground cinnamon

#### Instructions

Preheat the oven to 350°F. Grease a 9×13-inch baking dish. In a large bowl, whisk together the flour, sugar, baking powder, baking soda, allspice, cinnamon and cloves. Add the soup, butter, eggs, and water and, using an electric mixer, beat until smooth. Fold in the raisins. Pour the batter into the prepared pan. Bake the cake until a tester inserted in the center comes out clean, 30-35 minutes. Let the cake cool completely.

To make the frosting, beat the cream cheese until smooth and light. Add the butter and beat into the cream cheese. Add 2 cups of the confectioners' sugar and beat until combined. Continue to add confectioners' sugar until you have your desired consistency. Beat in the cinnamon. Spread the frosting on top of the cooled cake. Cut into slices to serve.

# **Hush Puppies**

Deep-fried spoonfuls of a cornmeal-based batter, hush puppies are golden brown fritters often served as a side dish. Crunchy on the outside and fluffy on the inside, you'll see both sweet (made with a bit of sugar) and savory (with some grated onion) versions of this dish.

Enjoyed as a starter, sometimes for free at seafood places and barbecue joints, don't hesitate to order a few if you see them on a menu.

While we savor the snack today, a century ago, this dish might have been table scraps to keep the pups quiet."They were the little morsels that were fed to begging pups to keep them quiet. We say that hush puppy got used because shut the #\$%@ up was too crass."

A food historian Robin Caldwell argues that the dish can be traced to Indigenous cuisine. She said, "The recipe itself is really old, and the derivations of the recipe can go back to Native people cooking balls of ground maize in Texas and Mexico."

#### APPLE PIE is another iconic dessert that is perfect for Fall. It is made with sliced apples that spiced with cinnamon, nutmeg and cloves and baked in a flaky pastry crust. some people like to add cheese on top.





# Southern Gardening



October heralds in the first full month of fall, with cooler temperatures and of course "falling" leaves. So after doing all the weeding during summer, we now have the task of raking leaves. One good thing about these leaves is that they make good soil in a compost pile. So as with most unpleasant things, there is a happy ending. We also celebrate Columbus Day on October 9th, however, I believe there are a few States that are trying to cancel this holiday. There may have been other countries who made their way to the

have been other countries who made their way to the Americas before Columbus, but he was the first to initiate permanent colonization of the New World. Let's give credit where credit is due. So let's raise our flags in a salute to Christopher Columbus this month.

Besides the Lantana which I speak to later, the absolute work horses in my gardens are: dianthus, dusty miller, and Mexican heather. All are drought resistant and with some mulching, are perennials. Just before a hard freeze, cut them back,water and mulch with pine straw. Next spring, up pops the shoots from under the mulch. Amazing. All of these plants are available on the open market, Home Depot, Lowes, and other box stores. Of course, nurseries are another great source. Once these plants are established, add in the reseeding of the Pacific Giant Zinnias, and voila, the beds are practically filled with flowers. If you have bought any plants recently, the old "six packs" are hard to find. And the pots, which may have only 2 plants, are about \$4.50. Inflation has hit the flower and plant market too. What is a gardener to do? Root plants taken from cuttings in the spring, and get up flower seed now and in the spring.


Seeding the flower beds is an easy task but one has to be mindful of timing. As the Bible states, there is a time and season for all things and I might add sowing seed. If you desire poppies in the spring, one must throw out the seed now and no later than November.

Just clear away any mulch in the area, scratch the dirt, and deposit the seed. Do not cover with mulch, and do water the area. I would place this area on a plan of the bed so you do not over plant. Tipping

of the bed so you do not over plant. Zinnias, Cosmos, Cleome may be planted in late March or after any late freeze date.

#### PLANT OF THE MONTH-LANTANA (lantana camara)

I know this sounds silly, but I have always had a prejudice against lantana. However, this last year I planted a few clumps in my garden at the farm because I could not find anything better to fill in some holes in the







These three responses served as a catalyst to me and caused me to start thinking about the impact I wanted to make with my life. I want to live a life that outlasts me. What kind of impact do you want to make? Here are three of the most important impact questions you can ask yourself:

#### Will I Reflect More?

The Psalmist writes: "I will study your commands and I will reflect on your ways." -Psalms 119:15

And Luke tells us that "Jesus often withdrew (alone) to the wilderness to pray." (Reflect, meditate) - Luke 5:16

And Socrates it was who observed, "The unexamined life is not worth living."

Your soul is the most important thing about you. You have a body, but you are a soul. Your soul is the essence of who you are. Is your will, mind, body and spirit all rolled into one. It is the part of you that is eternal.

What does that look like for you? Maybe it is taking a stand at work or school





#### REFLECTIONS! BY MICHAEL BROOKS We'll Work 'Til Jesus Comes, And Then Some

Every generation has slang or shorthand spoken to members of that generation. It's been a while since anyone said, "Hey bro, that's groovy. Far out!" I'm not really sure we boomers said this anyway, though we were accused of it. But our language is

constantly changing with new words and new phrases and new definitions. In the 60s we "surfed" with the Beach Boys, whereas today we "surf" on the Internet. In those days we didn't talk about RAM and megabytes and storing things "in the cloud." I learned some new phrases lately from radio broadcaster Kim Komando. She told about

"quiet quitting" which means not doing one's best on the job. According to a Gallup sur-

vey, only about one-quarter of the U.S. workforce is actively engaged in working hard every day. Hard work built our country and produced American exceptionalism, so it's sad to read these projections, if true. The broadcaster shared another term popularized on social media: "lazy girl job." In the

days of remote work, the phrase means little or no supervision, no schedule and no overtime. Ms. Komando suggested we shouldn't be upset with lazy people since "they didn't do anything!" Scripture teaches labor is a gift from God. In the book of Genesis God said "it was good"

a number of times but said "not good" a time or two as well. One "not good" was that it wasn't good for man to be alone, so he designed a mate to complement him. But God also said it wasn't good for man to be idle. Thus, he made Adam the first

gardener whose responsibility was to take care of Eden. The responsibility to work is outlined in chapter two, before chapter three when work took on added drudgery.

And scripture implies that work is eternal. Isaiah described the "new Jerusalem" including the building of houses, agriculture and the drudgery or vanity of Genesis 3 removed.

Isaiah's most well-known word about eternity is of warriors who beat swords into plowshares and spears into pruning hooks (Isaiah 59,2). Whereas the primary meaning of this prophecy is world peace, it's also true that both plowshares and pruning hooks are agricultural tools.

Scripture exhorts Christians to look beyond human supervisors and recognize that we work to please God. Twice in Colossians 3 the Apostle Paul wrote that we "serve the Lord Christ" in whatever we do; thus, we bring honor to him in our work. As Ted Key said, we strive to "autograph our work with excellence."

Being good employees means that we earn the right to tell others about the hope we have in Christ and how he motivates us with a new ethic in work and character.

#### THE APPEARANCE OF EVIL.

The Bible says, "Abstain from all appearance of evil." (1 Thess. 5:22).

Who can deny that virtually all of the symbols of Halloween are evil? Witches, monsters, ogres, vampires, ghosts, ghouls, goblins, devils and demons all portray evil! On the other hand, Christians are called to be "followers of God" (Eph.5:1), and "lights" to a sin darkened world. How can we justify our masquerading as creatures of darkness in the light of the Scriptures? And if our houses and churches are dedicated to God and are to glorify Christ, how do we justify decorating them with demonic and occult symbols?

Virtually all of the common Halloween decorations represent something **Demonic or Occult. For instance:** 

The "Jack-o-lantern" is the ancient symbol of a damned soul.

The "black cat" has long been associated with Witchcraft and numerous superstitions are still connected to it.

Witches and Witchcraft are a dominant theme of the holiday, but are an abomination to God (Exodus 22:18; Deuteronomy 18: 8-14;

Leviticus 18: 24-30).

Even the "trick-or-treat" is a threat! It's nothing less than extortion! "You either give me a treat or I'll play a trick on you."

What's wrong with Halloween? Everything about it is wrong! It does not have even one single redeeming virtue. It is a demon inspired, devil glorifying occult festival! Those who love the Lord Jesus Christ should have nothing to do with it!

"Let us cast out the works of darkness, and put on the armor of light." (Rom. 13:12)

"Ye are all the children of light, and the children of the day: we are not of the night, nor of darkness." (1 Thess.5:5)

"For what fellowship hath righteousness with unrighteousness? And what communion hath light with darkness? And what concord hath Christ with Belial? Wherefore come out from among them, and be ye separate saith the Lord, and touch not the unclean thing..." (2 Cor. 6:14-17).

The Christian should not fear any of the powers of darkness, for we have authority over them (Mk. 16:15; Lu. 10:19), and "God has not given us the spirit of fear..." (2 Tim. 1:7). But at the same time, "We are not ignorant of Satan's devices" (2 Cor.2:11)

Some may call me "legalistic" for doing so, but I have forsaken this pagan celebration altogether. Perhaps its time you considered doing the same.

"For ye were sometimes darkness, but now are ye light in the Lord: walk as

#### children of light." (Eph. 5:8). IT IS DISOBEDIENCE TO GOD!

God repeatedly forbids his Children's participation in such demonic activities, as the following passages attest: Deut. 18:14; Ex. 7:11-12, 22:18; Lev. 19:26, 31; 20: 6, 27; 1 Chron. 10:13-14; 2 Ki. 21:5-6; Isa. 2:6; Jer. 27: 9-10; Zech. 10:2; Mal. 3:5; Acts 8:9, 16:16; 19:19; Gal. 5:16-21; 2 Tim. 3:8; Rev. 21:8, 22:15.

#### John Martín "Jack" Campbell December 12, 1955 – September 24, 2023





#### Don't be RUDE!

Did you see the report – "Parenting priorities: international attitudes towards raising children" – conducted by King's College London that found American parents are the least likely to think good manners matter for children?

The survey included participants from 24 countries asking them to choose five qualities they thought were essential for children to learn at home. Those choices were good manners, tolerance, independent, hard work, and respect for others.

In Egypt, parents evidently feel very strongly that manners matter. Egypt claimed first place in this survey with 96% of participants reporting that teaching children good manners at home isimportant.

Second place went to Nigeria with 89% of respondents indicating that teaching their children excellent manners is a priority.

Let's repeat that because the eye may need to hit on that twice. Nigeria – a third world country, which by definition means it has low human development – took second place in a survey about the importance of manners.

Third went to yet another third world country, Morocco, at 88%. The United Kingdom was only slightly behind them, coming in sixth at 85% - and yet, they still ranked lowest internationally. But the United States, the world's superpower, was dead last. Not near the bottom, no, rock bottom at 52%. I take it that a lot of us here in America don't give a damn. We seem to have completely given up and surrendered to our children. And frankly, it may be beginning to show a little in our society.

Another part of this same parenting survey studied attitudes toward obedience.

One aspect of children's behavior is the degree to which they listen to and obey their parents and other trusted adults in positions of authority.

Nigeria was first in this category with 58% of participating parents marking obedience as important. Nigerian parents seem to mean business with their kids, but again, the United Stateswas way down in the lower half of the table with only 21% of placing any importance on obedience.

It didn't just start. There has been a decline in the value placed on obedience in the United States, as well as other Western nations, since 1990 – way back when 76% of American parents felt manners and obedience were important.

Today, the qualities parents in America value most are tolerance of others, independence, and diligence.

I'm not convinced frustrated employers hiring the young adults coming of age after being raised with the more relaxed attitude would agree with the diligence part. Maybe...but I doubt it.

There may be a bit of work left to do with the tolerance and independence parts too. Tolerance doesn't involve being judgmental and cherry picking, and independence means moving out frommom and dad's – both physically and financially – before turning 36.

As we strive to diligently tolerate one another's independence...can't we still teach manners? They are easy. All you need to do to teach them is to have them.
