

Sitting here on vacation, there are so many things going on but today I only want to cover two items y beaches to see so here goes

#### 1. The Olympics:

We also toured the Washington Monument and World War II Memorial but without a doubt, the Holocaust Museum was the highlight, not only of DC but our entire vacation thus far.

I have been to many WWII museums, I have seen hundreds of photographs, watched dozens of WWII videos and movies covering the holocaust and nothing comes close to this experience. Nothing. I would say that if you were to take a child, depending on their age, you may want to cover their eyes when approaching certain displays.

floors of movies, videos, slide shows, audio presentations, models and artifacts to view. Some of these to be honest are quite horrific and some from Russian archives have not been readily seen in the West. Of some of the many artifacts there are

The museum gives us three full

large concrete fragments from the Chelmno crematorium blown up by the SS in April 1943 in an attempt to hide their activities. There is the actual Tarnow Cemetery gate where between September 1939 and June 1942, 5-10,000 Jews were killed. They have an actual cobblestone street which was part of the Warsaw Ghetto, an actual "Karlsruhe" freight car used to transport Jews to camps. To add to this experience the freight car is resting on actual tracks that led to the Treblinka station. So many fascinating artifacts are there that you can easily spend 5 hours or more and not see or hear everything.

#### 3. Room of Shoes

For me, the most visceral and disconcerting display was the room of shoes. As you come out of a hallway and turn a corner, you are confronted with a room with nothing but thousands of shoes. Each of these shoes belonged to someone killed at a camp. In typical German efficiency, when people were "processed," everything about them was taken away. Clothes, shoes,



jewelry, and even hair was taken, catalogued and then stored. When the camp at Auschwitz was liberated for example, over 15,000 pounds of hair was found stored and bundled into canvas bags. But for me, it was the room of shoes where I say more tears than in ANY exhibit I have ever seen. Black, white, asian, old, young, even one young muslim girl stood looking at those shoes with a face full of tears. I heard one woman crying and turned to see it was my wife reading the following passage from Elie Wiesel's book, "Night."

"Never shall I forget that night, the first night in camp, which has turned my life into one long night, seven times cursed and seven times sealed. Never shall I forget that smoke. Never shall I forget the little faces of the children, whose bodies I saw turned into wreaths of smoke beneath a silent blue sky. Never shall I forget those flames which consumed my faith forever. Never shall I forget that nocturnal silence which deprived me, for all eternity, of the desire to live. Never shall I forget those moments which murdered my God and my soul and turned my dreams to dust. Never shall I forget these things, even if I am condemned to live as long as God Himself. Never."

Yes my friends, I highly recommend this museum/ memorial experience. One of the poignant yet unfortunate truths was as after we got home, I showed my brother almost identical photographs of trenches lined with dead bodies recently shot by ISIS. Dead babies, decimated towns and a world once again in denial of the evil in man's heart. A sick denial that again allows for such criminal activity to go on with world watching in disbelief. The only difference between the Nazis and the ISIS scourge is a matter of degree. If these guys had the opportunity and capability to perform a holocaust on the same scale as the Nazis, you had better believe they would. It is up to all of us in the free world to ensure this never happens again. This is the true value of museums such as this. Without them, people would argue that these crimes never happened and if they did, that it could never happen. I am here to tell you they are all dead wrong.

## POLITICAL CANDIDATE QUALIFICATIONS

For many years, I have wondered about the procedures employers use to select applicants who apply for jobs. From my observations, employers like to see resumes that have a complete list of previous employment, with exact dates and other trivia, with no gaps, going all the way back to high school or earlier. Other qualifications, like talent, honesty, dependability, health, and other attributes seem to go onto the back burner if they are even con-

sidered at all. As a result, I have seen many examples of incompetent klutzes receiving multiple offers for well-paying positions while other highly skilled, dependable people spend months or even years to land positions of any kind—just because they are too honest to lie or embellish their resumes to cover all the gaps.

The question is why don't employers try hiring some people based on their talent and ability, on a trial basis if necessary, to see what they can do. They would have for better odds in getting employees that will help their companies

would have far better odds in getting employees that will help their companies grow and prosper.

So what does that have to do with ordinary people who do not own or run businesses? Everything! Every grown person has the authority to hire people—

businesses? Everything! Every grown person has the authority to hire people—the most important employees we would ever hire—our public representatives, from the President down to the lowliest city councilman. But sadly, many people don't seem to have a clue on how to judge the candidates.

The election of 2008 was one of our most catastrophic national disasters. For President, the Republicans rejected **Ron Paul**, one of our greatest national heroes with a near perfect lifetime record that dates back to the 1970's. Another

fine candidate, **Herman Cain**, was also cast aside. Instead, they nominated one of their weakest members — **John McCain**. The Democrats did far worse, nominating a hard-core Muslim socialist who was raised in Indonesia. In the general election, the American people snookered themselves by electing this man who has been waging a jihad against American principles and free enterprise for the past seven and a half years and enough socialists in both houses to provide a filibuster-proof majority in the years 2009-2010. The result has been volumes of radical, unconstitutional legislation that must be repealed before an economic collapse destroys us all.

In this year's primary (2016), most of us have still done a deplorable job of making our selections. The Republicans turned down their finest Presidential contenders, **Rand Paul** and **Ted Cruz**—both with nearly perfect voting records in the Senate. The Democrats nominated **Hillary Clinton**, the second most dangerous person to ever run for the office (behind **Barack Obama**).

Long before one steps into a voting booth, he should carefully study all of the candidates. A crooked candidate with experience can and probably will steal a great deal more of our revenue than an equally crooked one with none. That's why we have term limits for some offices and proposals for the same for additional ones. Therefore, experienced candidates with high name recognition, high campaign contributions and lots of advertising should be avoided unless they have strong records of fiscal restraint and upholding Constitutional principles. In our area, a good example was the highly principled **Becky Gerritson** vs. the experienced but unrestrained incumbent **Martha Roby** (U. S. Congress, district 2).

#### Biblical Principles in our Federal and State Constitutions and **Other Founding Documents**

For what nation is there so great, who hath God so nigh unto them, as the LORD our God is in all things that we call upon him for?

And what nation is there so great, that hath statutes and judgments so righteous as all this law, which I set before you this day?

#### Introduction

**Happy birthday to our Constitution!** If it had a cake, there would be over 220 candles on it. In 1956, President Dwight D. Eisenhower proclaimed

Our Constitution was approved and signed on September 17, 1787, in Philadelphia by the delegates of twelve states. Rhode Island was not represented and did not approve it. Of course, to become binding on the states it still

had to be ratified by nine states. This happened on June 21, 1788, as New Hampshire became the ninth state to ratify it. A Bill of Rights was added to insure further protection for the people and the states from the federal government. Since the Bill of Rights was added, our Constitution has only been amended sixteen times. This is amazing, confirming the fact that our Constitution is the world's most enduring written constitution! British Prime Minister William Gladstone once remarked that our Constitution is, "the most remarkable work known...in modern times to have been produced by the human intellect, at a single stroke." Gladstone is correct that this is a remarkable work, but those who have done their research know that this was not a work that was produced solely by the human intellect. It was a work that was produced predominantly by Christians who applied their understanding of the Scriptures to civil government.

Our state constitutions, the Declaration of Independence, the federal Constitution and other founding documents were so Biblically based that in 1892 the Supreme Court was prompted to conclude that we were a Christian

This is a religious people. This is historically true. From the discovery of this continent to the present hour, there is a single voice making this affirmation ...these are not individual sayings, declarations of private persons; they are organic utterances; they speak the voice of the entire people...these and many other matters which might be noticed, add a volume of unofficial declarations to the mass of organic utterances that this is a Christian nation<sup>1</sup> (Church of Holy Trinity vs. US)

Notice that the Supreme Court indicates that their conclusions are based upon organic utterances. Organic means belonging to the fundamental or constitutional law. In other words the evidence that we are a Christian nation is found in our written founding documents. Let us briefly look at some of that evidence, including our federal Constitution.

#### **Declaration of the Causes and Necessity of Taking Up Arms**

The document that was the precursor to the Declaration of Independence was the July 1775 Declaration of the Causes and Necessity of Taking Up Arms. Our representatives meeting in Philadelphia made this declaration just one year before they declared independence. It is full of references to God, recognizing His sovereignty. Here are a few phrases giving evidence of its Biblical nature:

- If it was possible for men, who exercise their reason to believe, that the divine Author of our existence intended a part of the human race to hold an absolute property in, and an unbounded power over others, marked out by his infinite goodness and wisdom... • But a reverence for our great Creator, principles of humanity, and the
- dictates of common sense, must convince all those who reflect upon the subject, that government was instituted to promote the welfare of mankind, and ought to be administered for the attainment of that end. • Our forefathers, inhabitants of the island of Great Britain, left their
- native land, to seek on these shores a residence for civil and religious
- Our cause is just. Our union is perfect. Our internal resources are great, and, if necessary, foreign assistance is undoubtedly attainable. We gratefully acknowledge, as signal instances of the Divine favor towards us, that his Providence would not permit us to be called into this sincere controversy, until we were grown up to our present strength, had been previously exercised on warlike operation, and possessed of the means of defending ourselves. With hearts fortified with these animating reflections, we most solemnly, before God and the world, declare, that exerting the utmost energy of those powers, which our beneficent Creator hath graciously bestowed upon us, the arms we have been compelled by our enemies to assume, we will, in defiance of every hazard, with unabating firmness and perseverance, employ for the preservation of our liberties; being with one mind resolved to die freemen rather than to live

slaves.

 With an humble confidence on the mercies of the supreme and impartial judge and ruler of the Universe, we most devoutly implore his divine goodness to protect us happily through this great conflict, to dispose our adversaries to reconciliation on reasonable terms, and thereby to relieve the empire from the calamities of civil war.<sup>2</sup>

#### The Declaration of Independence:

Other than the indirect references to God and Biblical principles, there are four direct references to God in the Declaration of Independence:

- laws of nature and of nature's God, indicating God as the Supreme lawgiver.
- that they are endowed by their Creator with certain unalienable rights, acknowledging God as the all-powerful Creator who alone is the author of rights which, since they are not granted by man, cannot be taken away.
- appealing to the Supreme Judge of the world, indicating that God is the ultimate and supreme Judge who is judged by no man yet stands in judgment of all including civil rulers and governments.
- with a firm reliance on the protection of Divine Providence, affirming that their hope and trust in this life is not in man, but in a God who cares for His creation and watches over all, ordering their steps and intervening in their

#### **State Constitutions**

As you read these excerpts from our state constitutions, bear in mind that religion in that day was understood in a different way than how we use this word today. Here is Webster's original definition of *religion*:

Religion in its most comprehensive sense, includes a belief in the being and perfection of God, in the revelation of his will to man, in man's obligation to obey his commands, in a state of reward and punishment, and in man's accountableness to God; and also true godliness or piety of life, with the practice of all moral duties. It therefore comprehends theology, as a system of doctrines or principles, as well as practical piety; for the practice of moral duties without a belief in a divine lawgiver, and without reference to his will or commands, is not religion.3

#### Constitution of Delaware, Article 22:

Every person who shall be chosen a member of either house, or appointed to any office or place of trust...shall...make and subscribe the following declaration, to wit: I, \_\_\_\_\_, do profess faith in God the Father, and in Jesus Christ His only Son, and in the Holy Ghost, one God, blessed for evermore; and I do acknowledge the holy scriptures of the Old and New Testament to be given by divine inspiration.4

#### Constitution of Maryland, Article 36:

That, as it is the duty of every man to worship God in such manner as he thinks most acceptable to him; all persons, professing the Christian religion, are equally entitled to protection in their religious liberty; wherefore no person ought by any law to be molested in his person or estate on account of his religious persuasion, or profession, or for his religious practice; unless, under color of religion, any man shall disturb the good order, peace or safety of the State, or shall infringe the laws of morality, or injure others, in their natural, civil, or religious rights...<sup>5</sup>

#### Constitution of Massachusetts, Article II:

It is the right as well as the duty of all men in society, publicly, and at stated seasons, to worship the SUPREME BEING, the great Creator and Preserver of the universe.6

#### Constitution of New Hampshire, Article V:

Every individual has a natural and unalienable right to worship GOD according to the dictates of his own conscience, and reason; and no subject shall be hurt, molested, or restrained in his person, liberty or estate for worshipping GOD, in the manner and season most agreeable to the dictates of his own conscience; or for his religious profession, sentiments, or persuasion provided he doth not disturb the public peace or disturb others in their religious worship.7

#### **Constitution of Vermont, Article III:**

That all men have a natural and unalienable right to worship ALMIGHTY GOD, according to the dictates of their own consciences and understanding, regulated by the word of GOD; and that no man ought, or of right can be compelled to attend any religious worship, or erect, or support any place of worship, or maintain any minister, contrary to the dictates of his conscience; nor can any man who professes the Protestant religion, be justly deprived or abridged of any civil right, as a citizen, on account of his religious sentiment, or peculiar mode of religious worship, and that no authority can, or ought to be vested in or assumed by, any power whatsoever, that shall, in any case, interfere with, or in any manner control, the rights of conscience, in the free exercise of religious worship: nevertheless, every sect or denomination of people ought to observe the Sabbath, or the Lord's day, and keep up, and support, some sort of religious worship, which to them shall seem most agreeable to the revealed will of GOD.8

### Constitution of Virginia, Sections 15 & 16:

That no free government, or the blessings of liberty, can be preserved to any people, but by a firm adherence to justice, moderation, temperance, frugality, and virtue, and by frequent recurrence to fundamental principles. That religion, or the duty which we owe to our Creator, and the manner of discharging it, can be directed only by reason and conviction, not by force or violence; and therefore all men are equally entitled to the free exercise of religion, according to the dictates of conscience; and that it is the mutual duty of all to practice Christian forbearance, love, and charity towards each other.9

#### **Human Government Must be Limited**

One of the most fundamental and absolutely essential Biblical principles embodied in all of our founding documents and specifically our federal Constitution is the principle of limitation of all human governments. This is God's idea, fully declared in His Word. It is necessary because of the fallen nature of man, which of course also is the reason for the necessity of civil government. English philosopher John Locke lived in a day when the idea of limits on civil government or limits on the civil ruler were questioned. In reality, in all of history, man has dealt with this issue. The doctrine of the divine right of kings, absolutism or the absolute power of the monarchy or king has been around for thousands of years. In the early 1600's Robert Filmer, a country squire, wrote Patriarcha, a defense of absolute royal power. For this great act

he was knighted by Charles I. Filmer stated: The greatest liberty in the world—if it be duly considered—is for a people

to live under a monarch. It is the Magna Charta of this kingdom; all other



# "BIDNESS AS USUAL" IN LEE COUNTY & ALABAMA

Forgive the overload of issues to address starting in Lee County. It seems removing Hubbard as Speaker of the House made little difference. It became crystal clear Hubbard minions would shamelessly continue their crony 'bidness as usual' practices when it was revealed Auburn City Schools contracted with felon Hubbard in July awarding exclusive authority to broadcast Auburn School sports for free. With a heavy hand I type the courage and sacrifice of true Auburn men (specifically Buddy Mitchell) have been for naught in the attempt to remove this pollutant from our Plains of Dixie.

This school system (flush with overpaid educrats) turned down proposals from larger stations offering payment for exclusive broadcast authority. According to Bill Britt (*Alabama Political Reporter*) a comparison of the plans show Tiger Communications' signal of 25,000 watts and the biggest coverage area in the county had offered \$11,500/yr. for five years - i.e., a total of \$57,500. The next largest station (iHeart Media with a signal of 6,000 watts) bid \$1000/yr. for a total of \$5,000. Hubbard's Auburn Network with only 4,200 watts was awarded the contract and paid **NOTHING**.

No surprise to those who know the 'bidness as usual' paradigm - perhaps it was foolish to think the dozen felony convictions would slow the pace of these parasites sucking our economy sluggish. In August 2013 APR discovered the same day the House bill allowing a tax referendum for Auburn Schools was certified, Hubbard's Auburn Network contracted the exclusive authority to broadcast Auburn High School sports. This coincidence helped fuel rumors and speculation Hubbard agreed to muscle this tax referendum to pass the House in exchange for Auburn School Superintendent Karen Delano's promise to grant Hubbard the broadcast contract for the city's high school sports programs.

Repeated **APR** attempts to contact Delano's office at the time proffered promises Delano would respond but never did according to Mr. Britt. HB266 received House Certification on May 20, 2013, becoming Act No. 2013-321 allowing the City of Auburn to hold a referendum to raise ad valorem tax on property owners in the city. For over six decades WAUD radio (Tiger Communications) was the home of the Auburn High School team broadcasts. In 2013, Auburn City School Superintendent Delano failed to inform owner Tom Hayley of Hubbard's deal. Hubbard's **\$0** versus Hayley's **\$57,000** raises questions worthy of further investigation about our impenitent felon and shows nothing has changed. Sound, accomplished businesspeople like Mr. Hayley who truly care about AHS are put out so parasites like Hubbard can continue to feed on productive citizens, students and taxpayers.

Those sickened by the Riley & Assoc/BCA as usual machine have called for Auburn City Schools Superintendent Karen DeLano's immediate resignation. Most notable Mike Hooks of Auburn who sounded the alarm these parasites are still alive and actively feeding upon us. DeLano certainly fits in with Riley, Hubbard, Lowder, et al types who see government education as little more than a fat hog to keep their pork churning. This is the same superintendent who told the community in 2013 if we didn't support the proposed massive property tax increase, we were not "for the children of Auburn" - straight from the Riley Amendment 1 tax explosion playbook. Mr. Hooks' Op-ed also reminded readers DeLano claimed the tax hike was necessary to fund the new \$96 mil. high school project, to avoid cutting sports, music, arts and even buses. The tax hike failed (54% to 46%) yet the new high school will open on schedule and the AHS band plays on. DeLano also magically found over \$600,000 to put in Astroturf at Duck Samford Stadium where natural grass had sufficed for nearly half a century. Hooks further noted her hiring the highest paid football coach in Alabama, then she recently found \$6.8 mil. dollars for two lots of dirt to possibly build another high school, even while the new \$96 mil. dollar high school is under construction. DeLano is yet another 'public servant' who's earned grand jury investigation along with many other Hubbard minions. Further evidence of 'bidness as usual' was found in a recent e-mail (as if

e-mails used adjudicating the 23 felony charges weren't despicable enough) from felon Hubbard to "business leader(s)" encouraging them to read his latest motion. Mr. Britt (APR) cited Hubbard's text, "...it very clearly lays out multiple reasons a new trial should be held, explains why the verdict on each charge was incorrect and how it negatively impacts business moving forward." It smells like more spin from a desperate thief still attempting to delay and deny justice in desperate need of cash for his over-paid/under-performing 'dream team' criminal defense. Maybe a little more difficult these days to get unsecured loans from a buddy at a local bank...

AGAIN Hubbard filed a motion in Lee County Circuit Court (8/5/16) to

dismiss all charges against him or grant him a new trial, then four days later sent his plea to business leaders. **APR** further cited from the letter Hubbard claims Judge Walker allowed "ridiculous...interpretations of the ethics law... which were never contemplated when passed," and that the ruling makes it "impossible" for a lawmaker to have a "private sector job and not violate the law." Hubbard's dire warning to business owners claims the court's rulings have "very serious issues with businesses and associations who employ lobbyists." He further warns company owners the court has found, "every member of a board is now a principal," and that, "even asking for advice is a 'thing of value' and therefore a crime."

According to **APR**, the BCA is lobbying for legislation to make only the

signer of the Principal statement accountable under the ethics law. Hubbard also reminded recipients about prosecutorial misconduct, which he alleges, "... took place prior to the trial." He closed with, "I hope you will read it and feel free to share it with others who may not understand exactly what took place and the dangerous precedent it sets." Indeed dangerous to incompetent businesspeople like Hubbard who cannot survive in a competitive environment without cronyism and favoritism. Again, 'bidness as usual.' Hubbard's most recent pleading, this email, letter, etc. provides nothing new for the court (or us) to consider, just another replay of his slick PR spin attempting impact public opining and acquire more money for his expensive marquis player 'dream team' defense. Mr. Britt claimed, "Those with close ties to Hubbard say he recently received a fifty-thousand dollar check to cover the most recent round of motions. Hubbard's past reliance on campaign contributions to fund his defense is no longer viable. On a brighter note, the State stepped up to the plate and filed a Supplemental Brief in support of ordering Hubbard to pay \$1.1 mil. in restitution for his criminal acts. It seems the prosecution took Judge Walker's well founded concerns seriously before sentencing felon Hubbard. Walker was very clear the State would have to make a sound case for his consideration before assigning any amounts in restitution. The brief argues the court should not allow felon

Hubbard to keep his ill-gotten gains, obtained as a result of breaching the

public's trust. I think Jake Walker will find the prosecution's assertion that

unless the court orders restitution, "Hubbard and his businesses will continue

reaping the returns from his sale of his office as Speaker, even after he serves his prison sentence," most compelling.

Further evidence to forecast 'bidness as usual' will continue in Hubbard's hyper-gerrymandered District 79 came in the form of Joe Lovvorn's local donors and PAC's (totalling \$61,050) making it clear this 'good ole joe' is the anointed one to be felon Hubbard's replacement. The primary PAC's are all apparently run by Fine, Geddie & Associates (SAVEPAC, BIPAC, NEWPAC) and the biggest is from group out of Atlanta, Halstead Family Foundation (\$10,000) There a three big local donors at \$5,000+ (Allen Harris, Alice Henderson & James Parker) then the usual contractors/developers wanting subsidies and bonds released to avoid paying for the increased cost on our infrastructure to promote more of the cancerous, unsustainable growth harming our county. Most revealing Lovvorn is being groomed as felon Hubbard's heir comes from campaign contributions by Robert Lowder (who first mentored Hubbard on how to milk the system) and Robert Dumas (another 'public servant' on the AU BoT) to lowly realtors the government pays well to appraise properties they want to take at a third of the legal compensation so property owners must waste their time and money in the courts. Swatek, Azbell, Ross & Howe names in the mix (for the more 'plugged-in' folks - esp. those following the Hubbard felonies trial) make it all the more clear 'fireman joe' Lovvorn is a Hubbard man to keep the graft churning. Disappointing to see my insurance agent among the bigger Lovvorn donors - seems those telling me he's changed and to look elsewhere for coverage may have merit.

Another 'bidness as usual' clash in Lee County comes in the form of Constitution Party candidate Kenneth Busby's efforts to get on the Nov. general election ballot for District 1. After Busby submitted a more than sufficient number of signatures for verification, Probate Judge English wrote the AG for an opinion in regards to numerous parts of the ballot access laws he seemed unable to understand/follow. The opinion answered our befuddled Probate Judge's questions pressuring Mr. English to finally begin the verification process **FIVE** months after properly submitted.

Candidate Busby's major concerns dealt with the timing of the Convention and the fact this Probate Judge had somehow missed the filed statement of action recorded in Mr. English's office (at his request) the Friday before the petitions were turned in. Both issues were found to be unnecessary steps according to the AG's opinion stating Minor parties were not subject to section 17-13-42 or 17-13-50(b). This only left the question of how many signatures were required and where those electors had to reside. The Opinion stated that "Pursuant to section 17-16-22 of the Code of Alabama, the Constitution Party is required to submit the signatures of at least 159 electors who are registered to vote in Lee County Commission District 1. This number represents three percent of the qualified electors who cast ballots for the office of Governor in the last general election in District 1 of Lee County."

With all the stalling exacerbated by one of the most anti-competitive ballot access environments in the nation, Busby still awaits notification from Judge English on validation of his petition signatures. Mr. Busby said, "After reading the opinion and knowing that the majority of our petitions came from door to door solicitation in the district I have every confidence that we will exceed the required 159 signatures and be on the ballot in November." Mr. Busby's opponent, Ms. Eckman was one of the most vocal commissioners pressing for special election abuse to get the recent sales tax to pass after failing on two general election ballots more reflective of citizens' preference; some readers may recall my "Political Theft By Deception" (http://www.alabamagazette.com/story/2014/10/01/news/political-theft-by-deception/316.html) column on the matter.

What Mr. Busby experienced in Lee Co. is not unusual. Macon Co. Commission candidate Frank Dillman is also getting discriminated against for third party and independent ballot access. Much like Judge Bill English, Probate Judge Alfonza Menefee not acknowledging or replying to Dillman's written and telephonic inquires have been discouraging and serve the purpose of stalling and exacerbating this anti-competitive result. Dillman contacted the SoS for answers which could have been determined and received more efficiently directly from the probate judge. Petitions submitted mid November took almost three weeks to move up one flight of stairs for verification by the registrar, who received instructions to hold onto them until the Judge requests them.

Nervous about not hearing from the judge three months later, Dillman made

an appointment about a week before the primary election deadline to be informed, "of course you are qualified, everyone knows that," according to Mr. Dillman. Poor way of receiving his first official notification, but as I type Candidate Dillman still has **not** been given (as requested) an official document stating he'll be on the Nov. 8th ballot. Another Macon County resident wanting to run for office as an independent submitted petitions the day before the March deadline and as is also unsure of his status FIVE months later according to Mr. Dillman who further stated, "The system of filing and cooperation by the Probate Judge has been most frustrating as compared to all other aspects of my desire to serve Macon County residents and visitors. In this day and age, not having the records on-line is beyond reason -- that is unless it is by design, which certainly is a strong possibility. The current system is without checks upon someone who may abuse authority and power to stymie an independent candidate in an 80% one-party county is overwhelming."

For evidence of 'bidness as usual' at the State level. Chair of the ATPCC

For evidence of 'bidness as usual' at the State level, Chair of the ATPCC Planning Committee, Dr. Lou Campomenosi (Political Science, Tulane University) has been most illustrative this summer. The ATPCC is widely accepted as "The Hub" of the real T.E.A. Party in Alabama and has been successful at not being co-opted by the traditional/big-govt. Republicans. He sounded the alarm on a bill attempting to make the State Board of Education an appointed entity rather than elected (as currently determined) writing, "SOUND FAMILIAR? SAME POWER GRAB BY THE BCA THAT THEY TRIED TO DO LAST SESSION WHEN THEY TRIED TO MAKE JIM ZEIGLER'S STATE AUDITOR POSITION AN APPOINTED OFFICE TOO! If they try this gambit again, regardless of whatever office they are attempting to control, they must be stopped!!" The ATPCC has recently again said NO to any lottery scheme for a variety of reasons most notable the supposed "need" for a lottery would be eliminated if Hubbard and Marsh had been fiscally responsible and accomplished their most pressing task - i.e., Balance the budget without gimmicks, kicking the can down the road, bond and spend, special election abuse to raid the ETF, etc. With recent reports of record revenue collection, it doesn't



Learn how to research the internet. The New American and Freedomworks can provide voting records for Congressmen and Senators. LewRockwell.com can provide additional information on these and others. The scores are given as percentages of a perfect score of 100. Grading them is easy, just like in school-90+ = A, 80-89=B, 70-79=C, 60-69=D, and below 60 is a failure. Look at the scores. The majority of our Congressmen and Senators are failures, and that includes all of the Democrats.

Study the candidates' web sites. How do they stand on important issues? Check their voting records and their ideologies. Have they done, or do they plan any actions that jeopardize our individual liberty and laissez-faire economics? Or will they work hard to limit the power of government, eliminate needless programs and projects, and do everything they can to reduce spending, taxes and regulations?



### MAKING SURE WE LEAVE A GOOD **IMPRESSION WITH NON-HUNTERS**

I know a lot of you folks have deer on the brain for just about every waking moment, and I can say that I'm no different. I'm always thinking about all the different things that go with it, and with my work at QDMA, I'm also looking at what hunting means to us as both individuals and as members of society at large. Ultimately, I'm also thinking about what will lead to maintaining deer hunting as one of our great heritages that we can proudly pass down to the next generation.

For starters, we need to always obey the law. Those laws are put into place for good reason, and we need to ensure that we always strive to follow them. It's not just about putting a deer on the ground at all costs; we're ultimately responsible for the deer population and the public's perception of hunters. Each of us is an ambassador for deer hunting, and our individual actions each reflect upon us all. The law, and good ethics, is what separates the good hunters from the ones that bring down the public on our heads. While we shouldn't hide the fact that we are hunters, waltzing up to the local diner covered in blood isn't really appropriate, either, nor is acting a fool in public while wearing camo and hunter's orange. I can't tell you how to live your life, but I do ask you to think about how your image affects the rest of us deer hunters. The kinkajous are from Central and South America, they primarily live in trees, hang by their tail, and love to eat fruit and honey. However, the kinkajou (Potos flavus) is not a primate. Actually more closely-related to raccoons, coatis and lemurs.

Kinkajous are one of only two members of the Carnivora order

with prehensile tails, the other being the binturong. Fully-grown kinkajous weigh 8-10 lbs and have a total body length of 16-24 inches. In addition, their powerful tails may equal or exceed their bodies in length. Kinkajous have five toes on each foot and possess the ability to turn their back feet backwards. This allows them to descend trees headfirst.

Despite being grouped as carnivores, most of the kinkajou's diet is made up of ripe fruit such as figs as well as honey. Small mammals, insects, and eggs are also eaten as well as flowers and nectar. They are called honey bears because they raid bees' nests. They use their long, skinny tongues to slurp honey from a hive, and also to remove insects like termites from their nests. Their 5-inch-long tongue can reach inside flowers or beehives for tasty honey or nectar.

Their short, dense fur provides a natural protection from bee stings. Their dexterous paws help them manipulate food. They often hang by their tail while reaching for their next piece of fruit! Kinkajous are important pollinators. As they travel from flower to flower to drink nectar, the flower's pollen sticks to their face and then smears off at the next flower. Their particular feeding habits make

it an important pollinator in the rainforest ecosystem.

Kinkajous live in rainforest canopy ranging from southern Mexico to much of northern South America. They are nocturnal animals that usually forage alone in the dark of night,

returning to sleep in tree

holes with a family unit during daylight hours as a group they are called a troop.

Kinkajous breed throughout the year and can live for well over twenty years. The oldest living kinkajou in captivity was 41 years old. They can be quite noisy with their high-pitched squeaks, hisses, and barks. They screech and bark all around the forest, earning them yet another nickname: la llorona, Spanish for the crying woman.

Many people own and want to own a kinkajou as a exotic pet. Before you make that decision check your state and federal laws on ownership.

Kinkajous are beautiful animals and can make wonderful pets, since their personalities are often playful, yet docile and sweet. They are not destructive animals and have been known to be kept in the house without a cage. Kinkajous are generally quiet and docile, and they have no noticeable odor. We have a kinkajou and his name is Balou. He is a handsome little fellow with the cute factor radiating. If you would like to meet him give us a call or send us an



Millionaires are serving as offensive or defensive coordinators in the SEC. The fans love it. The administrators want it. The Board of Trustees demand it! ## Where is the fine line between government and religion where one does not encroach upon the other?

That is a great question and to be honest I think you will receive various answers even among Constitutional attorneys. To begin to try to find that line, it must start with the plain language of the Constitution.

While religion is not per se addressed within the body of the main Constitution, religion is addressed within the First Amendment. Many people think about the Constitution's First Amendment only having to do with free speech but it also includes two sections about religion. **The First Amendment reads:** 

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances."

Note that the first part says that Congress shall make no law respecting an establishment of religion. That first part has become the predominant subject of many lawsuits and Constitutional issues that have included Christmas displays, public school groups and athletics at public schools, which includes colleges and has even touched some of the various courts which has included the Alabama Supreme Court building. This will be the greater part of our discussion and include a recent opinion by the Attorney General of Texas.

The second part of the first sentence says, "..., prohibiting the free exercise thereof" which seems to have been relevant in many cases but like the Tenth Amendment which seems to hold little power (The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people) it is largely felt that no one is prohibited from the free exercise of their religious beliefs. When I was in high school in the early to mid seventies I was able to participate in the Fellowship of Christian Athletes, a school group dedicated to talking about our faith not only to each other but to others throughout the school, a morning prayer over the intercom by a student government officer and prayer before athletic events. These were student led, not exclusive of anyone that wanted to be a part and with my recall no one was ever made to be a part of what was done. To get back on point however, citizens can choose to participate in religious worship of any kind and while anything that seems to be endorsed by a governmental entity or publicly funded will for the most part not be allowed by the respective entity tied to our tax dollars, the bottom line is that one is not prevented from overall worship but rather there is a restriction of activities that overlap with that tax funded entity.

As far as "Congress shall make no law respecting the establishment of religion", many have long held that the intent of the Framers was to prevent a state religion such as the Church of England. Over many cases it has come to mean that no function of government shall suggest that they favor any religion of any sort. Christmas/ Hanukkah decorations placed in various towns and cities may include

a manger scene, a Menorah as well as a neutral "holiday" tree and maybe a Santa Clause. The tree which ties even back to pagans and the Santa Clause are considered historical and while displayed alongside a

manger scene have been considered in context as acceptable. There has been a range of events tied with public schools which may only require it be student led to requiring that the event be held off site from the public building.

A recent opinion by the Attorney General of Texas is interesting. Note that the opinion is just that, an opinion and has not yet been scrutinized by a Court so it may be in the end that the opinion is not valid. However, it seems that the Attorney General has thoughtfully considered Supreme Court and lower Court decisions that might impact the events in question.

Montgomery County, Texas, Justice of the Peace, Wayne Mack (he is also the coroner) instituted a program whereby a religious leader of any faith might lead the courtroom in prayer. Prior to the prayers, anyone in attendance is given the opportunity to leave the courtroom with a promise that attendance shall have no effect on the outcome of their case. JP Mack had received a letter of caution from the Texas Commission on Judicial Conduct. Texas Lt. Governor Dan Patrick who has been vocal about his Christian beliefs requested the Attorney General's opinion.

AG Paxton, in his six-page opinion summarized his opinion saying, "A Justice of the Peace does not violate the Establishment Clause by opening a court session with the statement "God save the State of Texas and this Honorable Court." A court would likely conclude that a Justice of the Peace's practice of opening daily court proceedings with a prayer by a volunteer chaplain as you describe is sufficiently similar to the facts in Galloway (Town of Greece v. Galloway, 134 S. Ct. 1811, 1825 (2014)) such that the practice does not violate the Establishment Clause. A court would likely conclude that the volunteer chaplain program you describe, which allows religious leaders to provide counseling to individuals in distress upon request, does not violate the Establishment Clause."

The Freedom from Religion Foundation has expressed an interest in the case and anyone "exposed to the prayers" that may wish to sue.

## Continuing Despite Our Discouragement

Our nation is less than 90 days away from electing the next president of our United States of America, although "united" seems to be a misnomer with the divisive political and cultural elements at work in our nation.

This certainly has not been the presidential cycle I anticipated nor is it one that persuades me to think that the result in November will heal our wounds and place our nation on a corrected path to fiscal solvency. Regardless of the outcome, limited constitutional government will take yet another hit in the executive office of America, and likely in the seats of Congress as well.

As it relates to politics, this has by far been my greatest season of discontent. The serious fiscal and culture-related issues we face at the local, state, and national levels are certainly enough to discourage the most hard-core conservative activist, but a recent devotional reading was a source of enlightenment as to the root of my frustration.

The devotion relates the struggles of Elijah in confronting the corrupt rulers of Israel and the exhaustion and feelings of isolation that he experienced in those conflicts. From Elijah's perspective, he was fighting the battles for faith by himself and experiencing some serious depression as a result. Elijah certainly wasn't the only Old Testament prophet who knew those feeling of despair, as Habakkuk shared similar feelings of anguish while he cried out to God for justice. Both prophets are actually described as "activists," albeit spiritual ones in the devotion, and the point was made that the feelings of exhaustion and isolation are classic negative activist symptoms.

How similar are the feelings and response of constitutional and social conservatives regarding our own efforts in our nation? We just don't seem to be winning very many battles of late and are simply drained by defeat.

Whether we lose to those on the political left or to the big government politicians on the right – though it is much harder to stomach from those who pretend to be with us long enough to be elected – continual political defeat is a bitter pill to swallow, and it's one I unfortunately know all too well.

Is it the overwhelming number of issues that require our constant attention and action, or our culture of champions and wanting to only be on the winning team that discourages us from standing up and showing up for the battles we might lose? Is it possibly a fear of rejection, or going against the new cultural "normal" that will label us as intolerant, backwards, or worse?

In the devotional scripture references, God assured Elijah that there were indeed thousands of others who were engaged in the battle of faith and He reminded Habakkuk that even though his vision was limited to what he could see, there was something working behind the scenes. The message of living by faith is one that we make very difficult to follow if we are only consumed with the immediate results of our work, and I think that is what many conservative

immediate results of our work, and I think that is what many conservative activists are feeling these days.

I confess to the same feelings of despair with our current political system and those we elect to serve. I've experienced far too many hours of wondering why bother to remain informed and respond with efforts that appear woefully

inadequate to influence policy when the Goliaths of special interests and anticonservative sentiment run rampant in our country.

I considered the perfect timing of this devotional encouragement as yet another

political issue emerged with the special session of our Alabama Legislature to

consider a lottery bill, and further heartened as work done "behind the scenes" led to the emergence of a coalition of principled House representatives who attempted to keep a poorly-designed lottery bill off the November ballot by the proper adherence of procedural rules.

While my opposition to a lottery as a means of resolving budgetary shortfalls includes my a concerns regarding the negative impact on families and their financial resources, it includes my skepticism that this legislative body can produce any legislation that will contain the corruption that is sure to follow the expansion of gambling in our state.

To me, it's a lazy way of funding government and one that puts the burden on those who can least afford the expense. Yes, it's a personal choice to gamble in any form, but the lure of easy money is most likely to prey on those desperate for a way out of a financial situation, or those who have a difficult time with addiction issues. I'm also of the belief that it further erodes the work ethic on which our nation was built, and contributes more to the entitlement mentality that is destined to destroy us all.

So as I once again take my concerns to my elected representatives regarding this issue and others to come, I will strive to remember that while I may certainly be discouraged by the things that I can see, our continuing efforts for good government are desperately needed and must never be viewed as wasted. What might be going on "behind the scenes" is quite possibly a result of the seeds we have sown.

## I AM ALONE (DEPRESSION)

Feeling down from time to time is a normal part of life, but when emotions such as hopelessness and despair take hold and just won't go away, you may have depression. Depression makes it tough to complete daily task from eating to taking a shower to going to work. But no matter how hopeless you feel, you can get better. Learning about depression—and the many things you can do to help yourself—is the first step to overcoming the problem.

#### What is depression?

Depression is a common and debilitating mood disorder that is affecting more and more people around the world. In 2014, an estimated 15.7 million adults aged 18 or older in the United States had at least one major depressive episode in the past year. This number represented 6.7% of all U.S. adults (National Institute of Mental Health, 2104).

While some people describe depression as "Life having no meaning" or having a feeling of impending doom, others feel lifeless, empty, and apathetic. When you're trapped in depression, it feels like nothing will ever change. But it's important to remember that feelings of helplessness and hopelessness are symptoms of depression—not the reality of your current situation.

#### Symptoms of Depression

- Feelings of sadness, worthlessness, or guilt
- Poor appetite or eating too much
- Lack of energy
- Loss of interest in and withdrawal from usual activities Trouble sleeping or sleeping too much
- Nervousness and worry
- Irritability or restlessness
- Inability to think or concentrate
- Increased risk-taking behavior, including reckless driving or substance abuse
- Chronic pain or other physical problems that do not respond to treatment
- Abuse of drugs, medications and alcohol
- Repeated thoughts of death or suicide

shows or pretexts of liberty are but several degrees of slavery, and a liberty only to destroy liberty.<sup>10</sup>

The amazing thing is, Filmer makes his case for monarchy from the Scriptures! He argues that all power derives from the father's power over his child, which is absolute. Since kings are an extension of earthly power, we must honor them as we would our natural fathers.

John Locke in his First Treatise on Civil Government devastates Filmer's argument by properly interpreting the Scriptures. He points out first that the Bible says to honor your father and your mother. He wonders what Filmer concludes about the mother aspect since he only talks about the male king as head. Then Locke points out that children are only to obey their parents absolutely until they reach the age of maturity and reason. Since a king has adults as his subjects he cannot claim authority over them as a parent over a child.

Our federal Constitution is an expressed powers document, which means the federal government was given only a few, implicitly stated powers. All other powers were reserved to the States or the people. This is a very important statement, that the federal government was to be limited, just as state governmental power was limited and indeed all civil power in our country had been limited.

Civil government is an institution created by God, and its purpose is the protection of life, liberty and property. (Romans 13:1). Civil government has the power of the sword to enforce its will: it has a monopoly on the use of deadly force. Therefore, its power must be carefully guarded lest it be abused! God limits civil government; our Founding Fathers recognized this fact and incorporated this idea into the Constitution. The history of man has been the history of the abuse of the power of civil government (I Samuel 8: II Chronicles 10). In America, our civil government has grown to proportions far beyond Biblical and constitutional boundaries, threatening to swallow up the liberties of states, churches, businesses, homes and individuals. A total tax burden of 40–50% is proof of this assertion. The tax rate that caused our Founders to declare the British government tyrannical was estimated to be less than 5%. The following article from WORLD Magazine illustrates the problem: What book has 75,606 pages, which no one has read completely, but its contents cost the nation hundreds of billions of dollars? The answer is the Federal Register, which lists the rules and regulations that businesses and citizens of the United States must follow.

The Cato Institute, in a study called The Ten Thousand Commandments, reports that the register continued to grow under the Bush administration, with federal agencies issuing 4,167 new rules last year. (The unreadable book had merely 74,258 pages in the final year of the Clinton administration.)

The estimated cost of all of these arcane rules to businesses and their customers: \$860 billion, or five times the current projected budget deficit. 11

The ultimate reason for a growing external civil government is the decrease of Christian self-government. Therefore, the ultimate solution to this problem is not found in passing some sort of legislation, but in restoring Christian selfgovernment to the American people and leadership. A Christian government, with laws based upon the Law of God, would provide the greatest degree of liberty to a people. Our Constitution codified the idea of the limits of civil government and this is a fundamental principle of government that we need to

restore! The Preamble to the Constitution The Preamble to the Constitution is a bold declaration that acknowledges God's sovereignty over civil governments, for it expresses in a very concise way what God has declared to be the purpose of civil government. It declares

that government is to do the following: establish justice (I Peter 2:14; Genesis 9:6) ensure domestic tranquility (I Timothy 2:1; 2) provide for the common defense (Romans 13:4; Luke 22:36) promote the general welfare (Romans 13:4) secure the blessings of liberty (Genesis 1:27;

II Corinthians 3:17; Ecclesiastes 5:19)

### **Food for Thought**

Move your body!

When you are depressed, just getting out of bed can seem very difficult, let alone working out! However exercise has been proven to be an excellent source of combating depression and one of the best tools in your recovery arsenal. Research shows that regular exercise can be as effective as medication for relieving depression symptoms. To get the most benefit, aim for at least 30 minutes of exercise per day. I would encourage before you start any exercise regimen you consult with your physician . I always encourage people to think outside the box sometime when it comes to exercise people in their mind think that they have to lift weights run 10 miles, be creative. Exercise can be anything from mowing the lawn, doing the laundry to washing your car. A 10-minute walk can improve your mood for two hours.

#### Support your health!

Shoot for eight hours of sleep. Research shows that when we have slept sufficiently your body has time to restart itself and reenergize the body. Depression typically involves sleep problems; whether you're sleeping too little or too much, your mood suffers. Another good way to support you health is to expose yourself to sunlight every day. If you every wonder why people who stay locked up in their homes get depressed more often than those who go outside research has also shown that exposure to sunlight can help battle the blues. Aim for at least 15 minutes of sunlight a day to boost your mood. I also encouraged people to challenge the negative thoughts that come cascading thru your mind when you're depressed, you leap to the worst possible conclusions. Tell yourself what is positive in your life what success have you had in your life. I am sure you can find several examples it is all about your perspective. I encourage you to do something new. Go to a racetrack a museum. Pick up a used book and read it on a park bench. Volunteer at a local church. Take a language class. Try to have fun. Life is to short to stay depressed. If you're depressed, make time for things you enjoy. Force yourself to do it because depression makes it so that you don't want to do anything.

#### **Biblical Principles of Government**

Other principles either contained in the Constitution or which can be deduced from other founding documents include:

- 1. A Sovereign God presides over the affairs of men and nations. He alone is our ruler and all earthly rulers must be in submission to Him. (Psalms 2, 47:2; 103:19, and 146:3; Matthew 28:18; Acts 12:21–23; Daniel 4:31–37; 5:18–21)
- 2. In a Christian nation, civil laws should be based upon God's law. (Deuteronomy 4:7–8 and Matthew 5:17–19)
- 3. All men are equal before God and before the laws that they make. (Genesis 1:27; Matthew 22:16; Romans 3:9; and II Chronicles 19:17)
- 4. Individuals are created to, and able to govern themselves under God's government. (Proverbs 6:6–8, 16:32, 25:28; II Corinthians 9:27)
- 5. Man has inalienable rights that come from God (Alienate—withdraw or transfer). (Galatians 5:1; I Corinthians 9:19; I Peter 2:16)
- 6. For a republic to be maintained, the people must be virtuous. (Matthew 25:23; Proverbs 11:10, 14:34, 28:2, and 29:2,8) 7. Constitutional government means government by laws, not the arbitrary

There are people who make a living by separating good, honest, hard-working, trusting people from their hard earned money. Please be aware of these SCAMS! There is not a Police Department or Sheriff's Office around that will call you on the phone and tell you that there is a warrant for your arrest, and you can get out of it by going to the store and buying credit or gift cards. That is NOT how the Judicial System in Alabama works. If someone is asking for payment in Green Dot Cards, iTunes Cards, or other types of gift cards...YOU ARE BEING SCAMMED! Please do not become a victim.

Identity Theft is a growing concern, especially in Autauga County. There is not a week that goes by without one or more of my deputies that has to do a report for a victim of Identity Theft. Once your identity is stolen it can be difficult to get it back like it was before it was stolen. Here are a few tips to help protect your identity:

- ✓ Install passwords on your credit card, bank and phone accounts. Avoid using information like your mother's maiden name, birth day, or Social Security Number. Don't use the same password for more than one account.
- ✔ Protect your deposit slips and check book.
- ✓ Monitor your accounts and keep receipts to review against your monthly statements.
- ✓ DO NOT GIVE OUT INFORMATION OVER THE PHONE OR INTERNET TO UNSOLICITED CONTACTS! If you did not request contact with a credit card company, bank official, internet service provider, or a government office, these calls are a SCAM. Please do not provide any names, Social Security Numbers, or account numbers.
- Guard your mail from theft. If you see someone going through neighbors mailboxes, report it at once to your local law enforcement agency.
- ✓ Buy a shredder! Shred all documents that show personal, financial and medical information before you throw them away.
- ✔ Have recurring checks direct deposited into your bank.
- ✓ Only carry the debit/credit cards and identification you need. Never carry your social security card.
- ✓ Secure personal information in a safe place. Write down all your credit card numbers and contact phone numbers in case they are lost or stolen, you have a list to call to report.
- ✓ ONLY GIVE YOUR SOCIAL SECURITY NUMBER WHEN ABSOLUTELY NECESSARY!
- ✔ Order a copy of your credit report each year and review it for accuracy. Checking your report will show any unauthorized accounts using your identity.



#### Create an Identity Theft Report

An identity Theft Report can help you get fraudulent information removed from your credit report, stop a company from collecting debts caused by identity theft, and get information about accounts a thief opened in your name. To create an identity Theft Report:

- file a complaint with the FTC at ftc gov/complaint or 1-877-438-4338; TTY. 1-866-653-4261. Your completed complaint is called an FTC Affidavit.
- take your FTC Affidavit to your local police, or to the police where the theft occurred, and file a police report. Get a copy of the police report.

The two documents comprise an Identity Theft Report.





# Southern

I packed my lunch for work this morning. It would be the usual mix of leftovers from a dinner my wife and I had earlier in the week or something my wife and I made to have for lunch for the week. My lunch came from me opening the icebox and putting together a meal from the leftovers. This time it was a pork loin that I stuffed with fruits that were grown in our yard. I made the stuffing from pears, frozen and dried figs, apples, and peaches, chopped into small dice of about 1/4 to 1/2 inch. I put a small amount of chicken stock, a half cup of chopped walnuts, and a quarter cup each of Spiced Fig preserves and Bourbon Peach preserves into a pot with the fruit and cook the mixture down until it was a fairly thick and dry and ready to stuff into the pork loin. The preserves were from last years crop that we jarred. A microwavable bowl with a layer of leftover rice, a slice of the stuffed loin and topped

with leftover stuffing would be my entree for lunch. My appetizer was pimento stuffed jalapenos wrapped in bacon and the pimento cheese I made.

The standby for lunches if we don't have enough leftovers will be soup. It is a vegetable soup made from what leftover vegetables we have and fresh, frozen and or canned vegetables we have in the pantry. It changes weekly, a bean and vegetable soup, a vegetable broth soup or a cream based soup. My wife likes to make the soups, since that is her mainstay for lunch. After making a large pot of soup, she puts it in wide mouth canning jars, puts on the lid and freezes them. Wide mouth jars are freezable and easier to eat out of. She takes a jar to work and by the time lunch comes around, a few minutes in a microwave and she has a nice hot meal. A bag of crackers completes it.

The TV cooking shows are right to some degree, you can spend a weekend afternoon and prepare meals for the week. It doesn't take that long to prepare a evening meal if you have a well stocked pantry, have some basic go-to recipes that you can start from and plan your menu before hand.

Speaking of TV cooking shows, here is some bad news. The meals that are prepared on cooking shows are not the healthiest of meals. I believe it was because of high calories and large portion sizes. So people that cook the meals they saw on TV are heavier by about 15 pounds than people that just watch. And another bad thing is the study was only done with women. So like the saying goes, "Never trust a skinny chef."

As usual, I was doing some research on Alabama food, what was popular then and now, what was the influences and what is in the future. I found a list of food that were attributed to Alabama in a book, *NATIONAL COOKBOOK: A KITCHEN AMERICANA* by Sheila Hibben, Harper & Bros. 1932. This list has more than 22 items and some seem pretty straight forward. Potato Soup, Stuffed Squash, Corn Pone, Beaten Biscuits and Fresh Fig Ice Cream. Some, **GOOGLE** and **WIKIPEDIA** couldn't find. I found some in my copy of *THE WHITEHOUSE COOKBOOK*, Hugo Ziemann Saalfield Publishing Co., 1919. The Baked Oyster Omelet is something I'm going to try, I found a recent recipe which is easy, bake oysters, add to omelet. The second recipe comes from the WHITEHOUSE cookbook. It calls for a white sauce, cayenne pepper and chopped parsley. Sounds good.

Here are some of the recipes listed in the book, Rich Amelia, Fish Pudding, Methodist Biscuit, Curds and Cream and Aunt Sue's Snowballs. I'll stick to blogs, apps and Pinterest for recipes that I want to try.

I am going to share a recipe I found handwritten on a index card, written with an ink pen. You know the writing instrument used to write in ink before the ball point pen.

The card was in my 1919 printing of the WHITEHOUSE COOKBOOK

along with a business memo note with a business name and telephone number for Long Beach California that only had 5 digits.

The recipe is for **DATE STICKS**. After the name of the recipe the person wrote Delicious. I am copying the recipe just as on the card.

### DATE STICKS

Dash salt

#### INGREDIENTS

3 eggs -- 2 eggs plenty 1 cup of sugar 1 cup of bread flour 1 teaspoon baking powder

1 cup nuts (Broken) 1 cup Dates (chopped) 1 teaspoon vanilla

#### METHOD

- 1. Beat eggs till light & slowly add sugar. Beat well.
- Sift dry ingredients and add.
   Fold in nuts, dates & vanilla
- **4.** Turn into well greased pan (shallow)
- **5.** Bake 350 for 20 to 30 minutes.
- **6.** Cut in bars and roll in powdered sugar.
- **6.** Cut in pars and fon in powdered sugar.

I want to get back to the weight gain and watching TV story. I don't think that the TV shows are at fault. It's the couch potatoes that watch

the shows. You can watch a show that has moderate amount of fats and sugar in their dishes. But then if you sit there and watch the show and then go to your kitchen and prepare the dish and then have it for a meal later, you have most likely, not burn the calories in your coffee creamer you had that morning.

I say it's not the foods fault. Critics say there is too much fat, too many carbs,

too much sugar in Southern cooking. There are a lot of calories from fat, sugar, and carbs because the people that were developing the Southern style of cooking, were hard working, poor and the menus spoke of what was available to eat. And they burned up those calories mighty quickly.

I guess it is harder to get people off their couches and start burning a few

I guess it is harder to get people off their couches and start burning a few thousand extra calories working and exercising than to make them eat healthier food. I like my couch and would never trade Collard greens "pot lycker" for brown miso soup with tofu cubes!

But, there is always a but. Your health is very important and eating a healthy diet is one key part in maintaining you health. And there is nothing better than comfort food to help you maintain your sanity in the world today.

I found a few changes or "hacks" you can use to make Southern Cooking healthier. I won't say it will taste better but it will be better for you.

Let's start with catfish. To make it healthier, don't fry it, bake it. Add some

lemon juice, maybe Cajun seasoning(watch for the salt), and don't let it dry out. If you want to fry it, don't use a cornbread batter, but a dusting of cornmeal. And fry it in a healthier oil like canola.

Next on the list is collard greens. Sorry but you can not cook them with ham

Next on the list is collard greens. Sorry but you can not cook them with ham hocks, bacon or butter. Watch the salt added to the pot and use red pepper flakes, onions and garlic for flavor.

Make barbecue pork with your own homemade BBQ sauce. Store bought sauces have a lot of sugar. Save the sugar for your sweet tea. A base of tomato sauce, apple cider vinegar and maple syrup is a good start for your own sauce.

Biscuits and gravy is for me the hardest item to change. Recipes I found used cashews and almond milk. I'm sorry but I'm not going to make my gravy with almond milk and cashews. I'll use turkey sausage in the gravy and use this



recipe for the biscuits:

#### **BISCUITS**

#### INGREDIENTS

1 cup Whole White Wheat flour 1 cup all-purpose flour ½ teaspoon salt

- 1 Tablespoons baking powder
- 1 1/2 cups milk of choice

#### METHOD

- Preheat oven to 425 degrees.
- **2.** Mix together all ingredients.
- **3.** Use an ice cream scoop with a release lever to scoop balls of dough onto a parchment lined surface.
- **4.** Bake 12-15 minutes.

*Note*: I am not sure if the milk of choice in this recipe is like 2% or 1% or can you use soy milk or almond milk.

#### CATFISH WITH PECAN SAUCE

#### INGREDIENTS

- 1 1/2 pounds catfish fillets 1 tablespoons fresh lemon juice
- Sauce:
- 6 tablespoons butter 1/2 cup chopped pecans
- 2 heaping tablespoons chopped fresh parsley
- 3 tablespoons fresh lemon juice 1 teaspoon Worcestershire Sauce
- 1/2 teaspoon grated lemon peel, no pith

#### METHOD

- 1. Preheat oven to 400 degrees
- 2. Lightly grease a baking dish large enough to hold the fish in a single layer and arrange the fillets in the dish. Add enough water to come halfway up the fish, then add lemon juice.
- **3.** Cover with greased piece of wax paper. Bake 10 minutes for each inch of thickness. Transfer fish to hot platter.
- While fish is baking, prepare the *Pecan Sauce*. In a small frying pan melt the butter over low heat. Add the pecans, parsley, lemon juice, Worcestershire, and lemon peel and cook for 1 to 2 minutes, until the sauce is heated and the nuts are toasted. Spoon Pecan Sauce over the hot fillets and serve immediately.

Coleslaw is next on the list. It is fairly simple, don't use mayonnaise. I would recommend low or non-fat Greek yogurt.

Jambalaya is made with brown rice and turkey sausage. Don't use bottled hot sauce. The salt content in these will make you head spin.

And fried green tomatoes as you guessed are not dropped into a fryer or skillet inches deep in oil. They get a coating of flour, egg whites and panko. Then pan seared in olive oil.

Red beans and rice are not red anymore and the rice is brown. Substitute black beans, chicken or turkey sausage and brown rice for this dish. I you spice up your beans and find some andouille turkey sausage, this will be as good as the original.

Mashed potatoes is simple, use sweet potatoes. I switched to sweet potatoes long ago. When baked potatoes are on a menu and white and sweet potatoes are both offered, I get the sweet potato but with the toppings for the white potato. Not the brown sugar and butter they think everyone should have. The sweet potato is a complex carb. I just have to watch what toppings I load up on.

Sweet tea is the easiest of them all. There is not one sweetener that to me has that distinct taste of cane sugar. Just use a little less. Period.

Just to prove that there are other ways to cook catfish, I found a recipe from Nathalie Dupree's <u>SOUTHERN MEMORIES</u> for Catfish with Pecan Sauce. She describes the dish as delicate and very simple.

So as you sit there in front of your TV, with some talking head telling you how to cook, remember that Chef's don't make mistakes, they invent new dishes. So get your happy self in the kitchen and invent something!

## Southern Gardening Potpourri for September

by Peggy Givhan another spectacular biennial available at nurseries or garden centers. Get

We are heading into the home stretch of 2016, and September can be a spectacular month for the garden. Many flower beds have that tired, fatigued and worn out appearance. And rightfully so, since the summer garden has been producing since late May. Between the stifling heat and daily rains which have left some areas soggy, the annuals need a

facelift. Many annuals such as coleus, zinnias, and cleome, can be pruned back and with some liquid fertilizer, are ready for the second act in late September. If you have let some of these annuals go to seed, they are now on life support and can not be resuscitated. We can still pull out the zinnias, and reseed these areas. They will bloom by mid October and go about their business until the cold takes

If you have geraniums, and begonias, cut these back now, but use a liquid fertilizer. These will bloom their hearts out in the fall. They and petunias glory in cooler nights. Why do I suggest feeding these plants with a liquid fertilizer? The answer is the heat. With high 90 degree temperatures, stronger fertilizers could very easily burn the roots. That is fatal to the plant. Osmocote, a timed release fertilizer is the exception.

Besides some of our plants being weary, some of our gardeners get weary of moving forward with a fall garden. Let's not think of gardening as hard work with pulling weeds, planting, pruning, refurbishing or tilling soil, and getting our hands dirty. Let's think of all the positive attribute of gardening. Consider gardening as a vehicle to reconnect with nature which relieves stress, or a method to help feed pollinators, also a means to provide herbs and vegetables, or as the supreme expression of one's creativity. Whatever we think of gardening, the bottom line is that gardening should be FUN.

This summer I found at a garden center a tray of foxglove or Digitalis. Lucky me, for I planted some in pots, and others in a semi shady area of the beds. These foxglove will have plenty of time to produce a healthy root system, winter over and be show stopping beautiful next spring. These are, of course, biennials which do not bloom the first year, bloom the second season, then die. Delphinium is

as many as you can get your hands on and plant immediately. Their blooms are all shades of blue to almost a white blue. Most of the old fashioned varieties have to be staked, but this is a small effort compared to the heavenly display in



If we see large empty areas where we have to pull out this month, one reliable filler would be mums. Do not purchase small 4" pots of mums, they will not have time to get large enough to fill in. To properly grow mums, the smaller plants would have to be planted in early spring, disbudded of bloom heads in June so that they have time to grow and bloom in the fall. So the solution is to buy bigger pots, plunge into the empty spots and

## Why? Whatever happened to Utopia?

"What's in it for me?"

Early on in your chronicler's quest for knowledge an interesting work was perused, the title of which was: The Republic.

It's author was a Greek philosopher named Plato, who, in a sense invented education, and who really seemed to have a handle on things worth knowing.

He envisioned Utopia, a civilization run by philosopher kings, whose sole purpose was to see that the people were afforded an education, and that they were taught by knowledgeable educators whose sole purpose in life was to insure that their charges were taught the things they needed to know in order to become valuable and useful citizens. Among his early proteges was Aristotle; and it all seemed to be going well from there.

In his Republic, those in charge of things, the philosopher kings, had one responsibility: sharing their knowledge with their charges, and insuring that the end product would be a civilization of educated individuals whose primary consideration was that this knowledge would be enhanced and passed on to

These revelations were found to be quite inspiring: that man should be infused with a thirst for knowledge, and that he would pass this knowledge on to others; along with it a sense of values.

But, after reading the mighty tome was finished, and a musing over its content began, the first question that presented itself was: If this is certainly the right way for a society to conduct itself, why isn't it? And then the answer came crashing down: No wonder his book was often referred to as Utopia, the word translates as "No place." And, unfortunately, No place like Plato's Utopia exists; especially on these shores.

The theory behind the book was profound: Competent and knowledgeable philosopher kings, would share with society their knowledge and wisdom, in order that society might put this knowledge to work, and that society would, in turn, enhance it and pass it along to generations to come.

But, when one includes the human factor, Utopia falls apart.

Look at our society today. Is there anything anywhere that even closely resembles Utopia? Are there philosopher kings about who might teach generations of potential philosopher kings what they have learned, and enhanced upon?

No! Not even close. In fact, we're sinking into a quagmire of ignorance that

would reduce Plato and his disciples to tears.

And why, one may ask, are we allowing this to happen to us, and to those younger generations who look to us for guidance?

Mainly, it's because we view life from a What's in it for me" perspective. Or, worse yet, from no perspective at all.

And why is this so? One may ask.

major concern is not one of teaching young people, of passing along to generations to come information that may help them to become greater and more productive heirs to the society they are entering into. Rather, their major concerns are: Will I get tenure? Why am I not receiving a

higher salary? Why must I do this, or that. And, most importantly: What's in

it for me? Is it any wonder, then, that the primary question posed by students, as their teachers introduce them to new knowledge, is: "Will this be on the test?" And,

What the students don't understand, because they are never taught it, is that the knowledge they needed was not on the test because the teacher didn't have the time to introduce this knowledge into his or her classroom lectures. They had other things to do beside explain the important factor: Why? It's because teachers are required to insure that an attractive bulletin board is conspicuously displayed, that the teachers desk looks neat, that the blackboards present a pleasant appearance, and a host of other non-educational factors—most of which have little to do with knowledge, or the gaining thereof.

Two questions that are seldom asked, and are seldom answered any more are: Why aren't teachers teaching? And why aren't learners learning?

And this is why we have no Utopia today.

Of all the people in the world, what group enjoys the greatest amount of freedom? "Americans" might be the preferred answer, although some people in other

places might disagree. Strangely, however, the answer has nothing to do with borders within which someone lives. Of all the people in the world, those who enjoy the greatest amount of freedom are Christians. In fact, Christians living under an atheistic dictator enjoy more freedom than a person without faith living right in America.

Of course, you recognize this matter comes down to the definition of freedom. From the point of view outside faith, Christians aren't free at all. There is a verse in the Bible which says "The love of Christ constrains us..." (II Cor. 5:14) Christians often refer to doing "God's will." To some, that doesn't sound much like freedom.

It wouldn't sound much like freedom when other person's definition is to live without constraints and to do as one pleases. It means being your own boss, making your own decisions without any outside restraint. Such an idea means choosing to go to school or not, to work or not or to live as undisciplined life as possible. As good as that may sound on paper, it doesn't lead to much productivity or happiness. There really is no such thing as total freedom. Neither are most of those very free who seek that kind of freedom. The usual application of that philosophy of life is slavery to something else such as broken lives, failing health, various addictions and loss of job or worse.

The point of this article is not to point an accusing finger at those with whom we might not agree, but rather, to lift up a positive word about Christianity and personal freedom in Christ. It is a discussion I think we must have in a post-modern society and one in which Christianity is less of an influence than it once was. We must consider that freedom is not as simple a concept as it may sound at first in both the social as well as spiritual arena of life.

There are those who think Christianity is the enemy of freedom. For example, some think Christianity is culturally rigid and the religion of the white man. One writer has said of the faith, "It forces people from different cultures into a single mold. It is the enemy of pluralism. Actually that is not so.

Christianity has been highly adaptive wherever it goes. We don't have to go far in our own state to see how faith is practiced in very different styles and structures which address a broad spectrum of cultures. In our own city we have churches under a number of language groups each having their own manner of worship and making disciples. Go to the large metropolitan areas of our land and you would be amazed at the number and variety of practices of the Christian faith. They may be different than our practices, but are genuinely Christian from their understanding of the Bible and faith.

Christianity did begin in a small part of the world but has spread and adapted to every culture and people group. Christianity thrives in Africa, South America and continues to grow in the Asian world as well as being a vital part of American history. In each of these places one finds uniqueness in expression of the faith and an ability to relate to a Savior in Jesus Christ. Why the ability to adapt anywhere? Christianity addresses the sense of sin and lostness present in people everywhere rather than simply trying to make churches all alike. It does not require its followers to wear certain garments or to have specified methods and times of prayer.

Cultural diversity was built into the New Testament. There wasn't a more different people from the beginning than Gentiles and Jews. Christianity holds out the hope of one day being where there is no tongue, tribe, people or nation. (Is.

60 and Rev. 21) Christianity is not a western religion which destroys the cultures it touches. Instead, it lifts people out of poverty, stands against injustice, uplifts women and seeks to give hope to the hopeless.

In contrast to what some claim, Christianity is about freedom. It is about the freedom to become the person God created no longer under the burden of sin. It is the freedom to be and to do. To appreciate this freedom in Christ, one has to understand freedom is about choice, not lack of any restraint and not shifting into neutral. Freedom cannot be defined in negative terms or as the absence of confinement or direction.

For example, if someone wants to be a musician or an athlete, that person expects hours of training and practice. It is the exchange of the freedom to do nothing in order to engage in something you were free and wanted to do. Christians live their lives under Christ because it gives them the ability to fulfill a purpose.

It is much like falling in love. The very word implies a choice not to love anyone else or anything else in the same way. It is a commitment of time, energy, emotion, finances, etc. Someone said, "If you want to keep your heart intact, love no one." But does that really work? Yes, it limits your freedom while at the same time allows you to be free to be yourself.

We love Christ and one another because we have been freed to do so. We un-

derstand that an athlete who plays football is free to do so within the boundaries of the field and not the parking lot. In the same way a fish is only free to breathe if it is in water. Otherwise, even though it is surrounded by oxygen in the air, it will die. The fish dies if we do not honor its purpose of life in creation. The Christian does not flourish except within the tenets of his or her faith which become the boundaries of life. We submit because we want to be on His team, not because we are forced. Have

you ever thought about how many athletes and mommas and daddies would give anything they had if their sons could play football at AL and AU? They would not complain or worry if their son's freedom to do as he pleases was curtailed if he got a scholarship to play football at the highest level. It's all relative to choices which add meaning to life.

Let me be honest, "It's far easier for me to love God than to love myself or anything else." I am free in Christ to be me. You also discover in life that loving is easy when you love a person. It doesn't feel oppressive to give a present to someone you love.

That's why for the Christian, it's not hard to love Jesus. He has done so much for us. Freedom for Christians is not about the absence of limitations and structure to live, but finding the right ones that fit our nature and liberate us. So when the Bible says, "The love of Christ constrains us," it simply means that you aren't afraid of giving up personal freedom in order to find real freedom in Him.

### THE GOOD AND THE **BAD SIDE OF ANGER**

I went to the business office to get a purchase order for office supplies; I think it was a box of file folders

or paper clips, and the attendant questioned me like I was Oliver Twist asking for more gruel! I felt anything like a professional. My face began to burn and I stepped outside before saying something I might regret. Most of us have been in similar situations and know the body language of anger. Our face flushes, our jaws tighten, our eyes become narrow slits and often our voices are raised an octave or two. Anger is normal and natural.

It's noteworthy that the Apostle Paul wrote about two kinds of anger in Ephesians--an anger we must avoid (4:31) and an anger we harness for good

Destructive anger brings physical harm, degradation of character or selfesteem and loss of fellowship with God. We've said about others, "That just didn't sound like him." Anger can turn us into a different person--a person others don't like and a person we don't like!

Jesus warned in the Sermon on the Mount that we must not harbor anger in

lives. He noted the Old Testament forbade murder, but it's like murdering another person in our hearts if we hold animosity for them.

Remember the housefly who gorged himself on stale baloney and then climbed up the knife handle to fly away, but fell dead. The moral is don't fly off the handle when you're full of baloney!

But there is an anger that leads to constructive change in our lives and in our society. We've seen several notable examples in recent years.

Adam Walsh was abducted and killed in 1981. His father, John, has done more than anyone to highlight the issue of child exploitation and abduction. Many businesses now have "Code Adam" when a child is reported missing. President Bush signed the Adam Walsh Child Safety Act in 2006.

Candace Lightner was heart-broken in 1981 when her daughter Cari, age 13, was killed by a drunk driver. Lightner was angry when she learned the driver had two previous offenses with minimal sentencing. She founded Mothers Against Drunk Driving which has done more than any other group to raise awareness of this problem.

And closer to home, we remember the sad story of Natalee Holloway who disappeared in 2005 in Aruba. Her mother, Beth, founded the Safe Travels organization and speaks to young people around the nation about protecting themselves when traveling overseas.

Anger can be good if it leads to positive change.
