The recent wave can be traced to April 29, 1999, at Columbine High School in Littleton, CO. The profiles of these assassins varies as much as the locations, with many having warped manifestos, but others none.

Other infamous murderers include Ted Kaczynski, who began in the 1970s by using bombs while in 1982 in Chicago, the Tylenol murders, which remain unsolved, led to packaging security manufacturing across the world. Of course the 9/11/2001 hijacking and murders changed our "open" society forever, causing fear, vigilance and modifications to the point none have occurred in the united State since that awful day.

Both sides of the political spectrum turn toward the Second Amendment as the source of contention.

While reams of paper have been dedicated to the topic, the best source of meaning of the Second Amendment can be understood by the literal words of those who drafted it. If our society desires to alter the Second Amendment to reign in the terror of gun violence, we have a political mechanism to accomplish this goal. Some states and cities have attempted to do a work around with the result that places like Chicago, Washington D.C. and Los Angeles have

some of strictest gun control laws in the United States while at the same time experiencing the highest homicide counts in the country:

#### Can the government really come to the rescue to stop this violence?

One need only look to Ukraine as a cautionary tale of what happens when you believe government's comforting words of paternalism. Ukraine once commanded the world's third largest stockpile of nuclear weapons, arguably a strong deterrent and defense against possible assaults from surrounding countries. But, the U.S negotiated with the its people

to relinquish its weapons with the assurance that our government would defend it should it be attacked (1994 Budapest Memorandum). Less than 30 years later, the country lies in ruins, millions of Ukrainians have become refugees, and the U.S. declines to get it hands bloody by fighting a proxy war with little hope of winning.

Gun violence is horrible. In 2021, over 21,000 people were murdered, and 24,000 people committed suicide. Compared to the total number of mass shootings (defined as four or more deaths), which included 702 murdered and 2,800 injured since first documented, one could surmise that mass shootings are so statistically insignificant so as not to warrant a sea of change in cultural and legal thinking.

However, in Daniel Khaneman's book, *Thinking Fast and Slow*, he delves into our thinking mind that categorizes events and decision making into Systems 1 and 2. He explains how emotions (S1) often erroneously override facts (S2) when it comes to our understanding, actions and responses.

But, statistics do not heal wounds, mollify anger or solve problems. The pain inflicted from these callous acts can never be fully removed. We as a culture have changed dramatically in the last 50 years. I am old enough to remember Sears' catalogues selling rifles. Most of my friends had hunting guns to use long before their 18th birthdays. For 60 or so years, no school, movie house, or church was ever targeted for such heinous behavior. So, what has changed? Is it that the sanctity of life has been maligned by, for example, at-will abortions (approximately 70 million since Roe v. Wade, 1973) Or is it inculcating malleable minors with harsh media in the form of slasher movies, brazen disregard for laws, or utter contempt for anyone not in agreement with selfish motives, whether it be breaking a grocery store line or road rage. *Or could one look toward the video* game industry with such violent interactive products like Call of Duty, Grand *Theft Auto, Diablo, or Fallout?* Could it be the multiple failures of the religious community ranging from materialism to hypocrisy to apathy? Could it be the disintegration of the nuclear family? Or is it something else? At its core this **EVIL** that surrounds us is no different than that found in the Bible spoken so long ago yet so clearly by the prophet Jeremiah in Chapter 2.

But through this temporal grief and despair, we have eternal hope found through prayer. Let us bow our heads, kneel, and pray. As President Lincoln explained, "I have been driven many times upon my knees by the overwhelming conviction that I had nowhere else to go."


golf course developer for our famous state links. Dave Thomas was maybe hoping that voters would think he was the Wendy's hamburgers founder.

Ole Shorty was the King of run-for-the-fun-of-it candidates. He ran for governor every time and really didn't care how many votes he got. He just ran for the fun of it and, boy, was he fun to watch and visit with. He brought new meaning to the word colorful.

Shorty was a native of Barbour County, which by the way is George Wallace's home county. In fact, Wallace and Shorty grew up together as contemporaries around Clio. Hi-Five!

May was an interesting month for our neighbors to the South. This year, Mexico commemorates the 200th anniversary of the coronation of Emperor Agustín I, and the 160th anniversary of the Battle of

These seemingly obscure events are vital to a complete understanding of the Mexican experience. As a colony of Spain, the internal government of Colonial Mexico was

dependent upon the competency of Spanish officials sent to govern in the name of the King. The absolute power of the King was never debated, and his representative reflected a dictatorial bent in governing the country.

But, as Spain liberalized under the limited influence of the Enlightenment, Mexico moved away from a central autocrat and, in a practical attempt at local government, divided the country into geographical territories resembling our

The revolutions in both America and France had an impact on Mexico in two ways. First, given the close proximity to the American Colonies, Mexico was well aware of independence gained from England and shared a similar mother country/colonist relationship with Spain that was neither warm nor ap preciated. Second, with close ties to Spain and the various 19th century wars and dislocations in Europe, Spain was so completely distracted by continental concerns that governing Mexico became an afterthought.

Mexicans saw the possibilities of independence and the idea of freedom. But, in as much as Spain might have been influenced by Enlightenment liberalization, Mexico as a culture and society had no basis to receive the fruits of these new liberties. So, when Mexico declared independence from Spain and actually became a sovereign country, that was a far as things went. It was a onenight stand with no long-term commitment.

Mexico had no historical memory of self-government and no real system to replace the representative of the King with an alternative. The rule of law was arbitrary and the structure for government as initially attempted never truly became anything close to a democracy, much less a republic.

So, in freeing Mexico from Spain, there was no model of past experience to guide the new nation. And while there were military men who lead by force, they were incapable of converting their military leadership to govern and build institutions for sustained self-government. In short, there was no George Wash-There were only strong men who gained power by force while attempting

to unify the country, but they ultimately found despotism easier than the niceties of collaboration. Thus, in the preliminary stages of Mexican independence, government emerged from a survival of the fittest contest, and the execution of political rivals was often considered to be much easier than campaigning or submitting to a vote.

Achieving independence was easy as Spain was distracted with its own internal issues. But, when the new government attempted to draft a constitution and establish a working government, discussions broke down, and factions buoyed with rational and enlightened ideas were unable to reach any consensus for a sustained period of time.

With only ideas and no experience in self-government, the initial government disintegrated. Two hundred years ago, into this void stepped Agustín de Iturbide. He had been a successful general and had the presence of mind to unify his command with opposition forces to form a governing coalition. With the frustration that any new country would face and without the experience of history to provide any guidance for independence, the coalition failed.

But there was one history lesson observed and that from Napoleon who crowned himself Emperor. Agustín de Iturbide followed suit and simply proclaimed himself Emperor Agustín I without any consent, approval, or other ratification. Truly an amazing feat and in reality, a turn away from any enlightenment reason to dictatorial hubris.

The Emperor's reign was short-lived. He abdicated and left the country for the safety of Europe. General Antonio López de Santa Anna, known by all Texas schoolchildren as the enemy of the Alamo, now started his rise to power.

While intending to unite the country under his leadership, Santa Anna was never able to fully control the country or provide a basis for continuity of government. He, too, would be forced into exile, and Mexico would again start the cycle of near anarchy resulting in military rule, quelling freedoms so anticipated by independence from Spain.

With significant natural resources even then, rampant corruption prevented any stable funding of a cohesive national government. Had a strong leader emerged with skills to create an effective government and pursue a viable constitution, outcomes might have been different.

But given the abundant natural resources, dictators were able to obtain easy credit allowing a posh lifestyle for themselves and their supporters. Each extension of credit led to further debt renegotiations, until the government was unable to pay.

Collecting debts in our modern world is easy. There is a simple reliable system that deals with debtors and creditors in an equitable manner to sort out disputes and allow repayment. The rule of law acknowledges the importance of debt and its repayment, so we have courts to manage disagreements and even an entire system of bankruptcy laws to effectively compromise legal obligations.

Nations in the 19th century had no such system, so when Mexico's debts were so large and could not be repaid, the country simply stopped paying. While this gave initial relief, the long-term consequences were not good; in Mexico's case, the creditor nations, opting to collect by force, sent their armies across the Atlantic and invaded.

At first, the major European creditor countries united and were able to achieve some level of credit satisfaction, but the French remained chagrined, so they embarked on a crusade to not only collect debts owed to them, but also to

While marching on Mexico City, a far superior French Army was checked and defeated at the Battle of Puebla on May 5, 1862.

Victory over a major European power was a significant and emotional victory for the Mexicans, and it offered ample cause and opportunity for celebration.

The anniversary of this battle is recognized as Cinco de Mayo; an important consequence of the Mexican experience now embraced internationally. With a history of more lows than highs, May 5th serves as a great excuse to reflect upon Mexican independence.

166,814 – Of all unique encounters, these were single adults.


Mostly men.

# 2022 Primary Retrospective: No Ad too Dumb for a Dumb Ad!

With all due respect to Gov. Ivey's high-steppin' through the bovine (dare I type BCA?) excrement, my beautiful bride took a sigh of relief as all the *Dumb Ads* disappeared Wednesday after the 5/24 primary. Still

clueless what "No step too high for a high-stepper," means, but it didn't win my most **Dumb Ad** award. It was nonetheless a good political 'weapon of mass distraction' by this BCA incumbent's handlers. More on that later...

In spite of challenger ads touting Kay's snubbing of 'Don and the MAGAts' show, Ivey won the primary without a run-off. Too bad candidate James didn't put together a coalition of small govt. conservatives instead of consorting with Bill Armistead and other Felon Hubbard types to more likely get this block of conservative voters' support. 
As for Statewide **primary** turnout, it was only 23.4%. 

### Jefferson Davis: Is Government by Consent a Lost Cause?

The birthday of Jefferson Finis Davis is on June 3rd. Although it is a State Holiday in Alabama there will likely be little recognition from most circles. Davis, a Jeffersonian and a Christian (Episcopalian) who served as the only President of the Confederate States of America, certainly has many detractors in modern statist America, especially the Orwellian Thought Police (largely modern Bolsheviks) who typically despise Jef-

fersonians, Christians, and the Confederacy--Davis managed to accomplish the proverbial "hat trick." Another strike against Davis is his uncompromising belief in voluntary, consensual government. Today's tendency to blindly submit to the status quo would be antithetical to Davis' philosophy.



Davis described what the South was fighting for ad nauseum—it was government by consent or what some call "The Lost Cause." Davis opposed secession; however, once his State (Mississippi) decided to leave the union, he was duty-bound to follow. Possessing in-depth knowledge of American history, constitutional republicanism, federalism, and State sovereignty, Davis identified the nature and characteristics of legitimate government: "Governments rest on the consent of the governed, and that it is the right of the people to alter or abolish them at will whenever they become destructive of the ends for which they were established." This is the antithesis of the "Soviet-styled" belief that the federal government is essentially the overlord of the Statesa common belief among collectivists who

Brady (original) ment is essentially the overlord of the States—a common belief among collectivists who advocate top-down, centrally planned, "command and control" government. This centralized government philosophy is similar to what was advocated by Alexander Hamilton and the Federalists during the Constitutional Convention. Robert Yates recorded the proceedings of the convention and John Taylor of Caroline County, Virginia, expounded on Yates' notes in his 1823 book, New Views of the Constitution of the United States. The "nationalists" did not get their way during the convention but Abraham Lincoln later implemented many parts of their agenda while working overtime to deny Southern Independence

parts of their agenda while working overtime to deny Southern Independence. In 1846, Davis explained the only legitimate powers of the Federal government: "I answer, it is the creature of the States; as such it could have no inherent

power, all it possesses was delegated by the States." These delegated powers are found in Article 1, Section 8 of the U.S. Constitution. All "undelegated" powers remain with the States (i.e., the people of the States). Davis was somewhat bewildered that Americans would question which government a State preferred to be associated with: "The withdrawal of a State from a league has no revolutionary or insurrectionary characteristic. The government of the State remains unchanged as to all internal affairs. It is only its external or confederate relations that are altered. To term this action of a Sovereign a 'rebellion' is a gross abuse of language."

On August 2, 1864, while conversing with a Yankee spy named Edward Kirk, Davis explained, "We are not fighting for slavery; we are fighting for independence." What would happen to a teacher who referenced this quote in a modern high school or college, i.e., a quote that does not fit the propaganda narrative? Would they be fired, reprimanded, or sent to some type of "re-education" class? Although it sounds like something out of the satirical Babylon Bee, there is nothing too absurd for the "Woke Bolsheviks."

Davis also noted the fallacy (insanity) of "might makes right" – the mantra of every tinhorn dictator throughout history when he said, "A question settled by violence, or in disregard of law, must remain unsettled forever." However, he did offer some insight and a ray of hope for the future by observing, "The principle for which we contend is bound to reassert itself, though it may be at another time and in another form."

Despite the level of suffering, Davis insisted the effort to gain Southern Independence was worth it and he would follow the same course again. Davis contended the South was correct constitutionally and in principle: "Our cause was so just, so sacred, that had I known all that has come to pass, that had I known what was to be inflicted upon me, all that my country was to suffer, all

was so just, so sacred, that had I known all that has come to pass, that had I known what was to be inflicted upon me, all that my country was to suffer, all that our posterity was to endure, I would do it all over again."

H.L. Mencken noted, "Nobody ever went broke underestimating the intelligence of the American public." As cynical as Mencken was, history indeed shows people take only so much abuse before they demand a change. Jefferson Davis had his faults like any man but he never backed down from his belief in

voluntary and representative government. As we witness the collapse of

America, one has to wonder when Davis' prediction comes to fruition and the demand for representative government reasserts itself.

### I have read a little about a Qui tam action but why does a "whistleblower" need a lawyer?



Qui tam actions are a part of the False Claims Act. Whenever a government contractor or payee defrauds the Federal Government, the Federal Government wants to know about it so that they might recover lost funds or in some cases the False Claims Act can cover illegal acts by companies. To do so the Federal Government encourages "whistleblowers" to

report the wrongful action and if found to be legitimate, a private attorney and possibly Government inclusion (intervention) may pursue the wrongful gains for a recovery. In addition to wrongful gains, the actions by those that have defrauded the government may even cause harm to patients having insurance such as Medicare, Medicaid and Tricare or harm to military personnel. For the "whistleblower" it may well include monetary compensation for reporting the wrongful action.

The False Claims Act was passed in 1862 during the War Between the States and is sometimes called the Lincoln Law. Originally the "whistleblower's" reward was 50% plus \$2,000.00. In the 1940's the reward was significantly reduced. Qui tam actions were significantly reduced as a result. When reports in the 1980's of \$400 hammers and \$600 toilet seats surfaced, Congress looked again at the False Claims Act. Congress decided that the wrongdoer should be fined triple the actual damages to the government. Amendments in 2009 addressed judicial interpretations that did not fall in line with original Congressional intent and amended in 2010 under the Patient Protection Act and the Affordable Care Act.

The "whistleblower," dubbed a relator under these cases is generally an employee, an ex-employee, a contractor or subcontractor or even a competitor. If the relator is an employee then protection is extended to the relator in that the relator cannot be terminated from employment because they have turned in their Rewards to relators can fall between 10% and 30% of the penalty. Where

most of the facts are publicly known a relator's recovery is 10%. When the government is included, the relator's recovery falls between 15% and 25%.

As an example I have met an individual that saw an irregularity within the company that the individual worked for. My description is purposely vague to protect the person's identity even though it is publicly available. My understanding

is that this person objected to the practice and ultimately left the company. At some point the individual contacted an attorney and the government did become involved. When the case was resolved the company was fined several million dollars and the individual received a very handsome reward. Though still significant, after taxes and attorney fees that amount becomes significantly less.

In answering the original question let's consider what we have discussed thus far. Number one, the government does not always intervene so attempting to bring such an action without being an attorney and even specializing in qui tam actions would be at a significant disadvantage. Number two the government does not per se represent the individual so there would be no protective counsel from a private attorney. Even though a current employer cannot retaliate against a relator one must consider that professional harm might come once an individual is identified. I would guess that future employers may well be concerned that they might become the subject of a False Claims Act investigation even if they always attempt to do everything within the law. With an investigation a company could end up settling a claim and should they end up with multiple claims for different issues it could be financially difficult.

If you have determined that a company is defrauding the government and feel you should "do the right thing" you should contact an attorney that specializes in *qui tam* actions.

#### Because of the plethora of corporate corruption scandals over the last few years and the criticisms that colleges of businesses received, especially the Harvard Business School, for turning out business leaders who were integral influences on or causes of those stories of corporate corruption, courses of study in business ethics

have proliferated in schools of business. For instance, Troy has two stand-alone courses focused on business ethics. One is Business and Society, at the undergraduate level, and Ethical Management and Leadership, at the graduate level. I personally teach both courses. In both courses, I focus on teaching future business leaders to understand

themselves better by focusing on what Psychologists refer to as one's "moral identity," how to recognize ethical issues, and how make ethical decisions both in their personal lives and in their business lives as both followers and leaders. Since business involves communities, just like other communities i.e. civic communities, etc., I focus on the ethical functioning of future business leaders in their organizational structures. This focus involves orienting students to their ethical responsibilities to create ethically healthy organizations.

This focus not only allows them to examine themselves as ethical persons, ethical role models, and ethical leaders, but to focus on what management scholars refer to as "followers" in leaders' organizations. When looking at ethical leaders and the ethics of followers, and when exploring the processes of ethical decision-making, we focus on the research done by Psychologists that emphasizes a cognitive process of ethical decision-making that involves being able to recognize the ethical and moral components of issues that are faced by them as leaders; understanding the various models of ethical decision-making; applying those models to the problem facing them; recognizing that the different models

of ethical decision-making might produce different ethical solutions; making a choice among those potential ethical solutions as to which one is "right;" and having the moral courage to pursue or implement the chosen ethical solution.

healthy one because unless the leader himself or herself, those in other leadership positions in an organization, and the employees in the organization have the moral courage to step up and express problematic ethical activities that they see or problematic ethical decisions that are being made by leaders, then no matter how well a person can analyze ethical dilemmas, it is all academic unless leaders and followers have the moral courage to stand up and be heard.

That brings into focus the ethical obligation of leaders to create what Psychologists call "moral spaces" in their organizations in which leaders and followers alike can exercise their own independent critical thinking and to feel actively engaged in their organizations so that all members, leaders and followers alike, can feel like active participants in their organizations. This type of moral space diminishes the tendency of people to remain silent when unethical activities are taking place around them and to have the moral courage to speak up. Unless a leader creates an organization with moral space for other leaders and followers so that there is a "speak up" culture, unethical conduct rots the soul of an organization and eventually leads to its downfall.

Creating moral space for other leaders and followers where individual moral thinking and moral courage are nurtured by a leader is clearly the responsibility of a leader to create an ethically healthy organization. Therefore, in ethics courses in business schools there should not only be a focus on recognizing moral dilemmas, understanding a process to resolve those moral dilemmas, but equally important there must be an inculcation of a clear sense of responsibility in future business leaders of their ethical responsibility to create and nurture organizations that have moral spaces where other leaders and followers feel free to exercise their own senses of morality, to critically evaluate the corporate

culture in which they find themselves, to identify ethically problematic activity

taking place, and to exercise their moral courage to speak up. This focus should

be central to an organizational leader if he or she is going to be an ethical role

model and a moral agent for his or her organization. ### opywrongs

Editor's note: This article discusses the copyright issues that the Alabama Gazette and other publishers might encounter that is very important, especially in today's easy access to the world wide web. It is so simple to snag a picture here and there seemingly floating around on the internet. And everybody does it, so why not? It won't hurt anyone, right? Well, it's best to live by the old adage: "Just because you can, doesn't mean you

should." In the case of copyright infringement, it is a situation where it is NOT better to ask forgiveness than permission as it can be costly. There are ways to obtain consent for use of information and images, and we always do our best to

People frequently hire lawyers to search the web and published material to specifically look for copyright violations. This can be rational when violations of well-known artists and writers are numerous enough to cause financial losses. But scammers can copyright ordinary photos, drawings, or whatever and publish them on web sites like Facebook and Instagram where millions of people post and share routine uncopyrighted material. The scammers intentionally give no hint of any copyright notices, wait for people to "violate" their "work," and hire less than ethical lawyers to search for those who have taken their bait. When a lawyer spots a hit, he concocts a stiff fine—enough for his client and his own fee for the lengthy and boring job of searching and collecting.

Before 1989, the United States required copyright notices on all published materials to inform would be violators, and if such notices are not given, the copyright owners shall not be able to prosecute or collect any penalties. Any lawyers attempting to usurp it would be guilty of malpractice.

But in 1989, our copyright law adopted the Berne Convention Implementation Act, which rendered copyright notices optional. This opened the door for scammers and crooked lawyers to create "infringements" that generate heavy

Copyright abuses like this must be ended. The current law makes it too easy for scammers to fleece innocent people with contrived violations. The mandate for notices must be restored to protect everybody from traps like this. Victims should notify law enforcement.

Several years ago, many restaurants and other places that routinely celebrate clients' birthdays refused to use the classic tune "Happy Birthday to You" for fear of violating a dubious copyright, never mind that it is well over a century old, and if it ever had a legitimate copyright, it had long expired. Its authorship has been attributed to American sisters Patty and Mildred J. Hill in 1893, but whether they actually composed the tune is disputed. Early copies of the lyric contained no credits or copyright notices, but in 1935, the Summy Company registered a copyright and claimed Preston Ware Orem and Mrs. R. R. Forman as authors. In 1988, Warner / Chappell Music purchased the company for 25 million dollars and estimated the value of "Happy Birthday" at \$5 million. Warner / Chappell collected licensing fees until 2015. Then a federal judge declared the copyright invalid and ordered a payback of \$14 million.

"Happy Birthday to You" is now officially in the public domain.

There is no question our copyright laws need to be reformed and greatly simplified. For starters, the lengths of copyrights are far too long. Like patents, a copyright gives the creator exclusive rights to his work for a limited time. Then it becomes public domain. Like a patent, a copyright grants a temporary monopoly in exchange for it to later be available to everybody.


The length of copyrights could be different depending on the materials and the need for the public to have access to them. For works like music compositions, art, novels and other fiction, 40 years is ample for anybody. That should be the maximum for anything. That includes NO renewals. The one and only exception would be trademarks. They would be allowed to last for the life

Other works deserve shorter times. News stories, photos and videos—daily, weekly and monthly publications—are essential to be readily available to the public in a timely manner. Copyrights for these should be short—perhaps a year—certainly no more than five. Other nonfiction works can also have essential properties. Ten to 30 years might be right for most of these.

A special case could be made for software. Since it evolves and becomes obsolete very rapidly, lengthy copyrights are essentially useless anyway. But they can be burdensome to people developing new software if it must incorporate portions of older versions. A good example was when Bill Gates bought the rights to DOS for pennies on the dollar and then monopolized it. Software copyrights should last NO MORE than ten years.

Another problem with ridiculous copyright time spans is potential censorship. They can be used to restrict all kinds of "politically incorrect" literature, photos, videos, sound recordings, art, and whatever else. Our founding fathers had a good reason to specify 28 years. That is ample time for any monopoly.

Another reform we need is to avoid treaties with other nations that demand unreasonable copyright laws in our country. Any items like this already in effect should be nullified ASAP.



Look at the chart above. Beginning in 1790, copyrights in the U. S. lasted a reasonable 28 years and could be renewed (if needed) one time for another 28. In 1831, the time jumped to 42 years, retroactive to 1817. In 1910, it rose to 56 years and retroactive to 1867. In 1978, it went to 85 years and retroactive all the way back to 1906 at 75 years.

The latest revision is the infamous "Sonny Bono Act," bulldozed through Congress by (obviously) Congressman Sonny Bono in 1998. At this time, many Disney copyrights were about to expire, and the Disney empire colluded with Bono and the rest of Congress to push copyright limits beyond human life spans—all the way up to 105 years and retroactive all the way back to 1922 at 95 years. Disney has a reputation of clinging to its intellectual property with a vengeance upon anybody who even lightly treads onto it. It pulled out every stop to keep any of it from becoming public domain for a very long time.

A good example was when a mother asked a local monument maker in Montgomery to create a Mickey Mouse tombstone for her deceased little daughter. The CEO contacted the Disney people. They initially refused to allow it, stating that their property, including their characters, were protected by very strict copyright laws and that violations would not be tolerated. The mother told them that her daughter was very fond of everything Disney and that she really loved Mickey Mouse. After some lengthy discussion, Disney relented and allowed the monument company to make one—but only one—not any more—

Back in the day, Walt Disney and his company were loved by everybody, especially children. It was family oriented for people of all ages. But in later years, after Walt's death and spectacular growth, the company began getting greedy. In recent years, the prices for everything at Florida's Disney Worldadmission, lodging, food, events, souvenirs, and everything else have skyrocketed well beyond affordability for many people.

Recently, Disney decided that it could dictate how children should be taught about sexual orientation between kindergarten and the third grade in primary

That was the last straw. Florida's Governor, Ron DeSantis, announced that Disney's generous package of corporate welfare, special districts, tax breaks, and other perks financed on the backs of the taxpayers will be coming to an end.

On April 22, 2022, DeSantis signed a bill to dissolve Disney World's selfgoverning status in the state and eliminate Disney's Reedy Creek Improvement District. He said, "You're a corporation based in Burbank, California, and you're gonna marshal your economic might to attack the parents of my state? We view

that as a provocation, and we're going to fight back against that." Disney's special district is scheduled to be dissolved by June 1, 2023.

#### What Tax Issues Face a Non-profit Organization?

A non-profit organization, also known as a non-business entity, not-for-profit organization, or non-profit institution, is a legal entity organized and operated for a collective, civic or social benefit, in contrast with an entity that operates as a business aiming to generate a profit for its owners. A non-profit is subject to the nondistribution constraint: any revenues that exceed expenses must be committed to the organization's purpose, not taken by private parties. An array of organizations are non-profit, including some political organizations, schools, business associations, churches, socially concerned groups, philanthropic and consumer cooperatives. Non-profit entities may seek approval from governments to be tax-exempt, and some may also qualify to receive tax-deductible contributions, but an entity may incorporate as a non-profit entity without securing tax-exempt status.

Non-profit regulation in Alabama involves a complex set of rules that govern non- profit organizations and charitable giving throughout the state. Major issues surrounding nonprofit regulation nationwide include the following:

- contribution limits · donor disclosure
- the redefinition of issue advocacy.

There's a lot of confusion around whether non-profits can participate in advocacy activities without jeopardizing their 501c3 tax-exempt status. Many organizations shy away from important advocacy opportunities because of the fear that it may land them in hot water—and instead choose to distance themselves to avoid the risk altogether, oftentimes at great disadvantage to their own impact. Alabama is one of 39 states that require charitable organizations, and those intending to solicit on their behalf, to register with the state in order to solicit contributions, whether they are an Alabama organization or based out-of-state. In Alabama a large number of groups and organizations are exempt from registration. These groups, however, must still apply with the state for that exemption; it is not automatic.

Non-profits are not immune from damage that can be caused by unscrupulous and fraudulent solicitors, financial improprieties, and executives and board members who care more about their own financial welfare than the mission of the organization. Problems, when they do arise, are particularly disturbing because of the nature of nonprofits themselves — organizations created to provide public benefit.

Each year the Internal Revenue requires most tax-exempt organizations to submit the Form 990 and its relations, including the following items:

- Income Statement with specific revenue and expense categories like donations, salaries, postage, rent, etc.
  - Balance sheet with specific categories like cash, accounts receivable, accounts
- payable, etc.
- Functional Expense Statement with all expenses allocated to either program services, fundraising or operations.

• Individual Program Expense Statement that reports all of the expenses for each

### **Master Chief Petty Officer** Marion Lee Hornsby: Age 88

Master Chief Petty Officer (MCPO) Marion Lee Hornsby served 21 years in the United States Navy. His Military Occupational Specialty (MOS) was Boiler Technician Chief Master. He received the following decorations, medals, badges, citations and campaign ribbons: Vietnam Service Medal, China Service Medal, National Defense Medal and five Good Conduct Medals.

MCPO Hornsby was born August 11, 1933 to his parents, Luther and Irene Hornsby, in Tallassee, AL, where he was reared and graduated from Tallassee High School in 1952. MCPO Hornsby worked as a cotton inspector in a cotton mill in Opelika, AL, for two years.

MCPO Hornsby volunteered and enlisted in the U.S. Navy July 27, 1954. He received Basic Training at San Diego, CA, where he was assigned to work in the engine rooms of ships operating the generators and boilers. He was assigned to serve at the North Island Naval Shipyard, San Francisco, CA, where he worked with fuel oil tankers for two years. He was then transferred to an ammunition ship, USS Vesuvius, at Port Chicago, CA. He left the Navy for two months and then reenlisted. He was sent to the Navy's boiler technician school at the Philadelphia Naval Yard and the Naval Leadership and Ethics Center at the Naval Station, RI. He was then sent to serve on the USS Catamount, a Casa



Grande-ship, for 52 months where he sailed back and forth across the Pacific Ocean. This included bringing supplies to U.S. military in South Vietnam. He then was promoted to Chief Petty Officer for a temporary assignment to the Philadelphia Naval Yard in anticipation of the launching of the USS Dale, a Leahy-class cruiser. Next, he served on the USS Martin, an Evarts-class destroyer for two years followed by service on a cargo ship. In 1962, he was transferred to San Diego where he worked at the Naval Boot Camp for three years followed by service in Naval ship maintenance at the Philadelphia Naval Yard. He then served as an inspector and supervisor of the generator plant on the USS Shenandoah, a Yellowstone-class destroyer and the USS Forrestal, a super carrier. He last served as a boiler inspector at the Norfolk Naval Station, VA, for two years where he retired August 27, 1974.

MCPO Hornsby and his wife, Barbara, were married 48 years before she passed away, and they had six children, 11 grandchildren and 13 greatgrandchildren and one great-great grandchild. For many years, they enjoyed towing a camper visiting 45 states including Key West, FL. He is a member of Providence Primitive Baptist Church at Kent, AL.

After his military retirement, MCPO Hornsby completed training in vehicle electrical maintenance at the John Patterson Technical College in Montgomery, AL., and he then drove a cement truck with the Robertson & Son Builders Supply Inc. in Tallassee, AL, for six months. 




#### Master Sergeant Neal R. Schultz: Age 85

His last assignment was with the 509th Combat Support Wing at Pease AFB, NH, where he retired January 31, 1974.

Following his military service retirement, MSgt Schultz worked in retails sales selling cars in AZ and AL for eight years and then worked as a supervisor with Service Master, a company that provided inspection controls for hospitals, and he was a leader opening a hospital in Centre, AL. While working in retail sales, he used the G.I. Bill and attended Snead Junior College in Boaz, AL where he earned an Associate Degree in Applied Science in Real Estate Law. He then attended Alabama A.& M. University and graduated Magna Cum Laude with a B.S. Degree in General Business in 1985.

MSgt Schultz's concludes about his military service are, "I served my country with my whole heart."





Robertson, who was serving as a Rotary Wing Aviation Unit Commander, 227th Assault Helicopter Battalion, 1st Calvary Division, was killed October 9, 1966 during the Vietnam War, leaving her a widow with a two month-old son. Sandra became a member of the Gold Star Wives of America in 1969, and she served as the National President 1979-1981 and as Treasurer 1984-2008. She continues to serve on committees of the national board, and she continues to assist surviving spouses and veterans with benefits issues. The Gold Star Wives

of America is a Congressionally

chartered non-profit service organization that provides assistance and friendship to those who have lost their spouses to a military related cause of death

In addition, Robertson has served as a volunteer with the Central AL Veterans Health Care System for the past nineteen years. Robertson has served in many other capacities in the AL community including volunteering in Digital Assets at the AL Department of Archives and History. She has current memberships in the AL American Legion Auxiliary, Unit 911, Blue Star Salute Foundation, Inc. (AL), Daughters of the American Revolution, Atagi Chapter, Military Officers Association of America (MOAA), Montgomery Area Chapter - MOAA (Maxwell AFB, AL, Marine Corps League, Townsend Detachment #920, Montgomery, AL, Retired Officers' Wives Club, Montgomery, AL, and Support Committee for the Alabama National Cemetery, Montevallo, AL.

Robertson was employed for 30 years, and her professional career included Pacific Bell Telephone, Southern Bell Telephone, American Airlines, Hayes International Corporation, Paige Aircraft Company, Alabama Hospital Association Credit Union Manager, and Max Credit Union serving in Customer Service, Accounting Departments, Credit Union Manager/Bookkeeper, all aspects of collections to include fraud and bankruptcy litigation. She has attended many seminars and classes to further her expertise in all financial aspects, to include Business Law courses. She has held professional membership in International Association of Credit Card Investigators, Credit Professionals International (CPI), CPI Capitol City Association as President, Treasurer, and Parliamentarian; CPI 25 Year Career Club President, CPI of AL President (2001) and Parliamentarian (2003).

Robertson's conclusions about receiving the DAR Women in American History Medallion are, "I was not expecting the award and was over come with emotion. I have been a supporter of veterans and surviving spouses because I found as a widow with a two month-old child in 1966 there were no support groups for widows other than my immediate family and friends plus the excellent military assistance helping me through a difficult transition. The only organized group was Gold Star Wives of America, Inc., and through this group, I found my purpose which is to assist other veterans and spouses. I do this in

## Southern Gardening

### Potpourri for June

Although gas prices have become a topic of discussion with their ever-increasing prices, June could bring a surge in travel. For gardeners, this is a great opportunity to view botanical gardens or other plantings around our state or out of state. If you are in Fairhope, just look around the downtown area to be amazed at their municipal plantings. From hanging baskets to bedding

plants, the color combinations and variety of flowers cannot be matched. The extensive rose garden near the municipal pier showcases hundreds of roses, which gives off a lovely fragrance. Make a record of the good ideas with either a pen and notebook or, better yet, the camera on your cell phone since a picture is worth a thousand words. I have done this over the years and have drawn good ideas for my personal garden. Other garden venues, which are within easy driving reach of this area, would be the Birmingham Botanical Gardens, the Athens Georgia Botanical Gardens, and Bellingrath Gardens in Mobile.

What to do now in the garden? First of all, eradicate all weeds in the beds. Pulling these out can be onerous, but still needs to be done. If there are areas that have not been planted and are simply weedy patches, carefully use RoundUp or glyphosate to spray the area and wait about a week to ten days before over planting or sowing seed. When using this chemical, always wear gloves and garden goggles. June should see all the daffodil and tulip leaves turning yellow or brown. It is now time to clip them off and leave daffodils in the ground. In the south, tulips need to be dug up and saved for planting next year. Place them in a brown paper bag, lightly dust with Sevin to prevent mite or bug infestation and place them on a shelf in a dry shed or garage for future use. I have found that the blooms are not as large, but great for cut flowers. The month of June is ideal for planting caladium bulbs. Caladiums are finicky about soil temperatures. Even if you plant them early such as in March, unless the soil reaches about 60 degrees, no way are they shooting up out of the ground. Of course they require lots of water to get them up out of the ground, so you risk bulb rot if they are planted too early. Usually I plant all one variety for a uniform appearance, but I have an area that has an open spot in between white impatiens, so I am trying a mix of different varieties. Before the era of the landscape begonias, begonias had to be in the ground around March 15th to thrive. But now, most begonias can be planted in the heat of the summer and should thrive with proper watering and Osmocote or other time-release fertilizers. Never sprinkle commercial fertilizer on begonia leaves as they will surely die. If this type is all you have, immediately shake any fertilizer off the leaves, and water the leaves and plants well. The advantages of the large begonias are that they shade out weeds, drop their dead heads, and bloom continuously through frost. What a great bang for the buck. June is also the perfect month to sow zinnias, cleome, and cosmos. In fact these can be sown anytime, and you could pull out one crop in July or August, and sow another crop for fall.

### PLANT OF THE MONTH: CROCUS SATIVUS

Common Name for Saffron Crocus or Autumn Crocus



This species of flowering plant is in the iris family, iridaceae and its claim to fame is the production of Saffron. The thin filaments or stigmas inside of the crocus bloom head are harvested and dried for mostly culinary uses, but also used as dyes. The corms must be planted in summer 4-6 inches deep or 3 months before frost. They are hardy in our Zone 8 and require soil with a pH of 5.8 to 7.8, which is neutral to alkaline as acid pH is less than 6.5. Soil must not be a heavy clay, such as we are cursed with in the Montgomery area, but well drained. Also, saffron requires at least 8 inches deep of good soil. Please note that the corms are poisonous. While the saffron corms or bulbs cost about \$1.00 per bulb, the filaments sell on the open market for between \$1,500 and \$5,000 per pound. In areas of the south where the summers are dry, they can be grown as perennials, and left in the ground. Note that it is necessary to dig them up and remove to another area once every 4-5 years.

Nina Jankowicz, the executive director of the Disinformation Governance Board resigned Wednesday. She explained in her resignation letter that it was because the future of the board was uncertain.

Later the same day, the new White House press secretary, Karine Jean-Pierre – widely touted as being the first gay Black White House press secretary – read

the statement from the Department of Homeland Security saying plans for the Disinformation Governance Board have been placed on pause due to the board being intentionally mischaracterized.

The board was created by Homeland Security, and Homeland Security Secretary Alejandro Mayorkas had insisted the Disinformation Governance Board was only concerned with disinformation from Russia, China, Iran, and the cartels. He seemed confused as to why there was criticism toward the board.

There was criticism because a lot of people did not feel a disinformation board was necessary in American where we have a free press. Also, many Americans take pride in being woke enough to think for themselves.

Foreign disinformation was not how Nina Jankowicz described the mission of the board. Her definition of the board's responsibilities included gendered and sexualized disinformation.

She issued a report, which was then shared by Secretary Mayorkas and the White House, stating that Russia, China, and Iran exploit "these American made narratives."

It appeared Jankowicz's self-described job description was to track these narratives on social media. In her shared report she wrote that social media companies should "create a cross-platform consortium to track and respond to online misogyny, similar to existing consortiums which counter terrorism and extremism.'

Her controversial report was written during her reign as the former global fellow of the Wilson Center – an independent forum for independent research, open dialogue, and actionable ideas. In short, it's a think tank.

Her report wasn't what caught everybody's attention though. It wasn't her saying Hunter Biden's laptop was a Trump campaign tool either. No. It was her performance as Mary Poppins in a TikTok video she made singing about disinfor-

Ms. Jankowicz is much more of a Disney fan than I am for sure, but there was one line in her jingle I took note of and I really liked. The line came after she sang "disinformation is how you hide a little lie" and repeated it several times.

She sang us a sentence of value we can all agree with and support. A pearl of wisdom from a partisan woman assumed to have none. She basically said don't support these people you don't agree with – who are spreading these lies disguised as disinformation. She sang we should not support them with "our wallet, voice, or vote."

Those are words everyone should live by in this new Biden economy. In this time of inflation and supply line issues, do not spend your money with people or companies who are not in line with your views and values. If like attracts like and only the strongest survive ... let's roll the dice. We are already gambling with our investments and our country's future.

promises to offer peace and comfort if we continually seek Him. "Now may the Lord of peace himself give you peace at all times in every







## Southern Cuisine

I just saw what the inflation rate is and what the rate is expected to rise to before the year is over. I did not have to read the newspaper or watch the news

to tell me that everything is getting more expensive. I went to the grocery



store to buy food to buy gas. I have not received a pay raise that would cover the extra that I must shell out to make up for the additional costs. But I do have a few tips that will ease the pain of higher costs. I have mentioned it before in other articles. The first tip is to vote out everyone who is responsible for the mismanagement of the economy. So far that would mean voting out almost everyone who is running this country now. That is not a quick fix since the next election is not until November 8. So, in the meantime look at where you spend most of your money and change your buying habits.

I am a shopper. I will go up every aisle of a grocery store and compare prices. Even to the point where I will look at the weight of similar items and pull out my phone and calculate some items down to the cost per ounce. Just because you always hear that the larger packaging has the lower the cost per ounce does not always hold true. Now, just because an item comes in at a lower price per ounce, does not mean I will always buy that item. Mayonnaise is such an item. I will only buy DUKE'S, even if there is a cheaper alternative. Even though on my list of fifty ways to save money on groceries, says at number two, don't be afraid to buy store brands.

I have friends that will throw away leftovers. What a waste! Use your cooking skills and figure out how to make different dishes out of your leftovers. Shop at your local farmers market for the freshest and most abundant items to cook from scratch. The less an item is handled at the store or in a factory, the less you must pay for the extra labor to package the item. If you want to save gas, plan your shopping

and try to make the most of your trip to town. Just because some items seem pricey, they may not be healthier for you than other items. I had cut back on my purchases of avocados for that reason. I though they were too expensive until I realized that I was losing out of my bodies need for potassium. I cut back on chocolate, not realizing that the cheap chocolate was full of sugar and lacked iron and magnesium. Did I mention that eggs are not based on how good they are for you because of color? In most people eggs do not

negatively affect your cholesterol. Just because the egg is brown does not mean it is better for you. The following recipes were prepared for my birthday. The items listed for my birthday dinner are some of my favorite for a birthday meal. I have been a fan of orzo ever since I worked as a Banquet Chef. It was colorful, easy to cook and was easy to serve and could replace any type of pasta you wanted to change. The next recipe is my favorite pasta salad. Colorful and easily adapted to what ever salad ingredients you had on hand.

### Orzo Salad

#### **INGREDIENTS:**

#### Dressing:

- 2 tsp lemon zest (1 lemon)
- 6 Tbsp freshly squeezed lemon juice (2 to 3 lemons)
- 1 medium clove garlic, grated ½ cup extra-virgin olive oil, plus more as
- needed
- 2 tsp kosher salt
- 1 tsp freshly ground black pepper

- 1 lg red, yellow or orange bell pepper, diced
- ½ lg seedless English cucumber, watery pulp scooped out & discarded, diced (about 1½ cups)
- ½ medium red onion, finely chopped (about 3/4 cup) 1 (15.5-oz) can chickpeas (garbanzo beans), rinsed & drained
- 1 cup pitted & halved Kalamata olives
- 1 cup roughly chopped walnuts
- 1/4 cup finely chopped fresh mint
- 3 Tbsp finely chopped fresh Italian flat-leaf parsley
- 3 Tbsp kosher salt
- 1 lb dried orzo
- 6 ozs brine-packed Greek feta, crumbled (optional)

- To make the dressing, in a small mixing bowl, whisk together the lemon zest and juice, garlic, 1/2 cup olive oil, 2 tsp of salt and 1 tsp of pepper. Set the dressing aside.
- To make the salad, combine the bell pepper, cucumber, onion, chickpeas, olives, walnuts, mint and parsley in a large mixing bowl. Meanwhile, bring a large pot of water to a boil. Stir in 3 Tbsp of salt
- and a small splash of olive oil.
- Add the orzo and cook for 7 to 9 minutes, or according to the directions on the package.
- Drain the orzo in a colander, and then add it to the vegetable mixture while the orzo is still hot.
- 6. Immediately pour the dressing onto the orzo and vegetables, and stir to combine. The hot orzo will readily absorb the dressing. Add a splash more olive oil if the salad seems too dry.
- Allow the salad to cool to room temperature, and add the feta, if desired. Cover and refrigerate for 1 to 2 hours.

I love seafood. My favorite response for answering a question about what I want to eat is Lobster. But I have been spoiled having visited Maine during the summer and having the rule that you have to eat lobster everyday. But shrimp and scallops are always good substitutes. And if they are in a creamy casserole, I will have better luck having someone share the meal with me.

### Tuscan Shrimp and Scallops

#### **INGREDIENTS:**

- ½ lb shrimp raw, peeled, and deveined
- ½ lb sea scallops 1 cup spinach fresh
- ½ shallot finely diced
- 3 garlic cloves finely minced
- 1 cup heavy cream
- 2 Tbsp sun-dried tomatoes 2 Tbsp parmesan cheese freshly grated
- 1 tbsp butter
- Red crushed pepper to taste optional Salt and pepper to taste

### **METHOD:**

- 1. Season the shrimp and scallops on both sides with salt and pepper. Heat some oil in a large skillet over medium-high heat.
- Cook the scallops for 2-3 minutes on each side, and then remove them from the skillet. Add some butter and shallots to the skillet and cook for 1 minute.
- Stir in the spinach and red crushed pepper, season with salt and pepper. Cover and cook for 1-2 minutes.
- 4. Stir in the fresh garlic and cook until fragrant. Add the heavy cream and parmesan cheese. Once the sauce thickens slightly, add the shrimp and cover. Cook the shrimp for 1-2 minutes or until the shrimp is cooked through. Be careful not to overcook the shrimp or the shrimp will get chewy.
- Place the scallops back into the skillet and cook for an additional 10-20 seconds.
- 6. Serve on rice.

Next is my favorite birthday cake. It is actually the only cake I want for my birthday. I have this same cake every year and have had it ever since I can remember. I am not a fan of vanilla but I love the smell and taste of coffee. I always wanted an icing that had a taste of coffee. I never cared about the shape of the cake, either a loaf or round, just the taste of the coffee.

### Angel Food Cake w/Mocha Coffee Icing

#### **INGREDIENTS:**

#### Cake:

- 2 cups egg whites
- (from about 16 lg eggs) 2 tsp cream of tartar
- ½ tsp salt
- 3 cups sugar
- 2 cups cake flour
- 1 tsp pure vanilla extract
- 1 tsp pure almond extract

#### Buttercream Icing:

- $1\frac{1}{2}$  cups butter at room temp
- 4 cups powdered sugar <sup>3</sup>/<sub>4</sub> cup cocoa powder
- 4 Tbsp heavy whipping cream 2 tsp vanilla extract
- Pinch salt 3 tsp instant coffee powder dissolved in the cream

#### **METHOD** for CAKE:

- 1. Preheat the oven to 325°. In a standing electric mixer, beat the egg whites at medium speed until foamy. Add the cream of tartar and salt and beat until stiff peaks form. Beat in 2 1/2 cups of the sugar, a few Tbsp at a time, until smooth and glossy, about 4 minutes.
- 2. Transfer the egg whites to a large, wide bowl. Using a fine sieve, gradually sift the flour over the egg whites, gently folding in the flour with a spatula. Fold in the vanilla and almond extracts. Scrape the cake batter into a 10-inch angel food cake pan. Using a table knife, slice through the cake batter several times to release any air bubbles. Tap the cake pan once or twice on a flat surface.
- 3. Bake the cake in the center of the oven for 20 minutes. Increase the oven temperature to 350° and bake the cake for about 35 minutes longer, until a toothpick inserted in the center comes out clean. Invert the pan onto the neck of a wine bottle and let the cake cool completely.
- To loosen the cake, run a thin-bladed knife around the side and tube of the pan. Unmold the cake and transfer to a platter.

#### **METHOD for MOCHA BUTTERCREAM ICING:**

- 1. In the bowl of your mixer beat the butter on medium speed until nice and creamy.
- Turn the mixer down to the lowest setting and slowly incorporate the powdered sugar and cocoa powder into the butter. Once you have added all the sugar to the mix add the heavy cream with
- instant coffee, vanilla, and salt. Turn the mixer up to medium-high speed and continue mixing for 10
- minutes until light and fluffy.
- Cover the cake and enjoy. Candles are optional.
