# A TIME TO HEAL

When I first walked through the "hanging garden" of six-foot steel tablets, I was taken aback at the sheer

number of "in-your-face" structures there were. The Equal Justice Initiative's, EJI, National Memorial for Peace and Justice in Montgomery reflects the 4,400 documented lynchings of black Americans between 1877 and 1950. There are 800 of these hanging metal structures within the 6-acre site, one for each county identified as to where a lynching took place. As the EJI states on its website, the design is to both "conceptualize racial terror" and to "symbolize thousands of racial terror lynching victims in the United States and the counties and states where this terrorism took place." I for one think they have succeeded in this.

Sorry Ms. Fredna, but I have to say this. I hate math. I hate it mostly because I am no good at it. I see the need for it but alas, I am for the most part a math idiot. But as a historian, I love numbers. Give me numbers, not so much statistics that can be manipulated, but big, fat, juicy numbers to analyze and work with. I believe within the proper historical context, numbers can give us perfect historical insight. Let me give you several of my favorite examples as to how numbers help us quantify historical reality.

1. Operation Barbarossa: From the German invasion of Russia, on 22 June, 1941 until the German surrender on 7 May, 1945 we have a total of 1,416 days. Although some sources vary in exact numbers, if we assume the Russians indeed


Operation Barbarossa Areas of Germany Areas of USSR

21,000,000 (yes, that is 21 million) people during war, basic math (as complex as I get) tells me that on average, every single day of the Russian war, they had 14,380 people killed. Let that sink in for a moment. Every, single day, for 1,416 days the Russians almost six times

the number of people killed than we had killed on D-Day (2,499) and almost as many people we had killed during the entire Battle of the Bulge (19,000+). This is perspective at its best.

**2.** Paperclips: A middle school in Whitwell, TN decided to do a class assignment wanting to collect one paperclip for every Jew killed during the holocaust. They eventually extended this to include the total 11,000,000 or so



killed by the Germans extermination. through Whitwell's plan was to acquire an actual railcar (which they did on September 11, 2001) that was used to transport people to camps and then to make a display inside the railcar with the paperclips and other artifacts from the war. The result? 11,000,000 paperclips will not fit inside the railcar. million is such a big number that they had to put bags of overflow paperclips in storage areas within the school. Now that is something we can sink our historical teeth into because we can see 11 million and yes, it is an ugly number within this context. The beauty, however, is that it

now becomes much more than just a number on a piece of paper. It becomes something touching, heartfelt and personal. Without seeing it, how many of us can comprehend a number this large? (As a side note, the documentary "Paperclips" is worth seeing).

3.88,000 Airplanes: What? When I fly, I carry with me fourteen 3 ½" by 5" sheets of paper taped together and when unfolded extends to over 4 feet in length. Each sheet is filled with over six-thousand asterisks each representing one airplane; there are 88,000 asterisks in all. When the topic comes up, I will pull the sheets out to illustrate the number of airplanes the Russians actually admit to losing in WWII. Again, it is something someone can see and visualize. 88,000 becomes more than just a number but actually a real "holy cow"

4. What is a trillion? I wrote once before about our national debt which at the time stood at \$18 trillion and asked how big is a trillion? Okay, if one million seconds is just over 11 days then how long is one trillion seconds? Best guess anybody? How about 31,709 years. That is pretty much an in-your-face

Numbers such as these put a "face" on historical or current events. The pillars and their words on display at The National Memorial for Peace and Justice is that face. Numbers, to me at least, are often where the proverbial rubber hits the historical road. Too often, we simply throw out numbers without context and thus forfeit the ability to correctly conceptualize it. But as either a historian, a student of history or anyone trying to glean information from a historical event, numbers outside of context and truth are unfortunately nothing more than just that, numbers.

Yes, I have done a lot of research and writing on the German ace Hans-Joachim Marseille. Yes, he shot down 158 airplanes. But those airplanes represented much more than just 158 yellow victory marks on his rudder. Those victories all represented men. Fathers, uncles, brothers, sons, cousins, friends; human beings. People who once laughed, cried, ate and celebrated holidays yet at the end of things, most of them died a bullet ridden, fiery death. In a letter Marseille penned to his mother in 1940 he wrote, "Dearest Mother, Today I shot down my first opponent. It does not set well with me. I keep thinking about how the mother of this young man must feel when she gets the news of her son's death. And I am to blame for this death. I am sad, instead of being happy about the first victory. I always see the face of the Englishman in front of me and think about his crying mother."

When I entered the "hanging garden" in the memorial, as a historian I was confronted with similar historical numbers. Yes these 800 hanging pillars

represent the counties where a lynching took place, but more than that they are historical layers to a truth many of us fear and do not want to confront. On the surface, each pillar represents a county. The next layer down is the name of a person while the next is the date that person was murdered. Put each of these together and you get something much more than an abstract event. You now have a real person. Not just one of 4,400 nameless people but a person who you now know lived and died a horrible death in some feckless county, at an impossible time in American history, swinging from the end of a rope. Who was she? Who was he? What were their lives like? Their desires; their dreams; their wants; their loves? Children? Educated? We may not know but now we have the opportunity, if so inclined to pursue further research.

When I looked at the Carroll County, Mississippi pillar for example and saw the 23 people killed on 17 March 1886, I stopped to think about the unimaginable carnage and insanity of that day. Can you even begin to imagine the events surrounding that single snapshot in American history? Who were these people? We know some of their names but others are listed only as "unknown." So did

mobs just go out and kill anybody they saw? Fortunately for us there is a book on the subject. But I asked myself things like, what were their last moments on this Earth like? Did they fight back? Cry? Plead for their lives? Wonder at the madness as dozens gathered around to watch and cheer the barbaric spectacle? At the same time, I thought about the evil inside those who committed this mass murder. Did any of them ever feel remorse for their actions as did Hans Marseille after shooting down his first airplane? What were their first thoughts after going home and seeing their faces in the mirror? Did they feel shame? Guilt? Remorse? Pity as they watched the 23 broken bodies hanging in front of them? My guess is a resounding "no" because nobody was ever convicted for this crime and this county had an additional five lynchings in later years after this one



event. No, I don't think there was much guilt by most of the people there. It is highly unlikely the archives will ever uncover any meaningful, "Dearest Mother" letters in the vein of Marseille's heartfelt cry of regret.

One thing the Legacy Museum, in part, captures is the true brutality of lynching. Let there be no mistake, lynching was a brutal, savage form of state sponsored and justified murder often involving, being burned alive, dismembered, tar and feathered, gutted, castrated or some other wicked torture eventually ending up hanging from a tree, lamp post, bridge or other "suitable" structure as a warning to others who might decide to step out of line. Not that I am comparing lynching to scourging as mentioned in the Bible, but when one realizes what the method actually entailed, you get a much clearer picture of what victims actually endured as their lives were snatched away from them.

But through it all, my one major hope about The National Memorial for Peace and Justice as well as The Legacy Museum: From Enslavement to Mass Incarceration is that as Americans we can get past these clearly horrific times in our past and heal our nation. We clearly cannot change history but we can surely learn, evolve and grow from it should we choose to. To me, it is sort of like reading a tombstone -- "Joe Bagodonuts 1919 – 1942." # Less than Two Weeks to Primary – Governor's Race

As we get down to the lick log in the 2018 June Primary, there are few if any surprises in any of the major state races. Polling indicates that all of the contests are about where they were three or four months ago when the races began.

There is a tremendous amount of apathy and indifference as we head into the final days. This lack of enthusiasm has also affected fundraising. Most of the high-profile races have not attracted the amount of dollars as in the past.

Kay Ivey is sitting on a sizeable lead in the GOP gubernatorial primary. She took a slight dip in the polls when she ducked out of debates. However, it is not as pronounced as it would have been if she had appeared. Her campaign has been managed brilliantly.

Coincidentally, at the same time that her staff adroitly kept her out of the debates, her polling picked up that preserving the confederate monuments was an issue with conservative Republican primary voters. Kay's media folks responded with an ad that could have come out of the George Wallace playbook. They had her telling folks that northern liberals and scalawags were not going to tell us what we are going to do with our monuments. Her resolve made folks wonder if she was actually there when the monuments were erected.

Last week, with only three weeks until the primary, lesbian lawmaker and LGBTQ activist Patricia Todd suggested in social media posts that Kay was gay. Ms. Ivey adamantly denied the tweet. She has adroitly deflected any and all inquiries into her private life.

The bottom line is that polls indicated she had a 30-point lead three months ago, and that lead is about the same now with less than two weeks to go to the Primary. The question is do her challengers push her into a runoff. Speculation is that she could win without a runoff the same way that her mentor, Lurleen Wallace, did in 1966.

The surprise in the GOP race could be Birmingham evangelist, Scott Dawson. He has run a very energetic campaign. Evangelical, rural, Roy Moore voters may be coalescing around the young minister. His strength might be underestimated by polling data.

This white evangelical vote is ironically similar to the African American vote in the state. It is quiet and beats to a different drummer. The message resonates

through word-of-mouth between church pews rather than through the media and social media. Although, it eventually gravitates to being somewhat in lock-step with a predictably higher than average turnout.

Most observers expect Huntsville mayor, Tommy Battle, to make a late run at Ivey. He has money in the bank. He will also come out of the vote rich Tennessee Valley with good Friends and Neighbors support. He should get enough votes to run second and force Ivey into a runoff. However, there will still be a 15-to-20 point spread in favor of Ivey when the votes are counted on June 5. Kay will have to put on her campaign bonnet for another six weeks. She will still not debate.

The Democratic Primary for governor has two thoroughbreds battling it out for the opportunity to face the GOP candidate, probably Ivey. Polling in this race between former Chief Justice Sue Bell Cobb and Tuscaloosa Mayor Walt Maddox is inconclusive.

Most of the folks who vote in the Democratic Primary on June 5 will be African American. Although this vote is not monolithic, the pendulum swings toward one candidate

The African American leadership in the party is actively supporting Walt Maddox. He has also captured a good number of young white millennials and college students. My guess is that Maddox is the winner in the Democratic Primary.

Troy King will probably lead the balloting in the Attorney General contest. Alice Martin and Steve Marshall are battling for a place in the runoff with King.

Twinkle Cavanaugh is poised to get a good vote in the Lt. Governor's race. If she has a runoff, it will probably be Will Ainsworth from Sand Mountain, who has had a significant TV buy.

State Senator Gerald Dial has surged in the Agriculture Commissioner race, primarily due to a brilliant and upbeat television ad. It is the best TV spot of the year. He is also benefiting immensely from grassroots support from rural volunteer firefighters throughout the state.

Voter ambivalence favors incumbents and those who have voter name identification. Therefore, my prognostication is that when all of the votes are counted in November, we will have a female Republican Governor, Kay Ivey, and a female Republican Lt. Governor, Twinkle Cavanaugh.

We will see.

# I DON'T REALLY HAVE ANYTHING, WHY DO I REALLY NEED A WILL?

I get that question all too often. Even poor people have more than they probably think. Do you have a home (even a mobile home)? Do you have a car or truck? Do you have any money in a bank? While there are some ways around transferring a home, vehicle or bank account to a loved one or loved ones after death there are exceptions and even then it probably needed death and plead in the proper formet. A proper Will

to be planned before your death and placed in the proper format. A proper Will takes care of those items in one document. It's true that you probably still have to probate that Will after death to have a proper transfer, but a properly done Will can at least provide a solution for your "stuff" after death.

Without a Will (interests), costs are greater for the probate process then if there

Without a Will (intestate), costs are greater for the probate process than if there is a Will. When no Will exists an heir has to step forward to be the personal representative. With no heir to step forward it becomes a little more complicated in that either the largest creditor or County Conservator may have to step forward. The availability of a County Conservator is based on County population. The Personal Representative has to be bonded based on value of the estate and an inventory of the estate with appropriate values must be filed within sixty (60) days after a Personal Representative is appointed by the Probate Judge. Short of unusual circumstances a Will does not require the Personal Representative to be bonded or an inventory to be done. The only intestate exception to bonding is for the Summary Distribution of a small estate, which is an estate under \$25,000.00 of probate assets. Remember that probate assets do not include beneficiary distributions (i.e. life insurance) or Payable on Death (POD) from a bank account, Transfer on Death (TOD) from investments or items titled to a Trust. Also not included is real property that divests to one with right of survivorship or with a remainder interest under a life estate deed. Probate assets do not include bank accounts with right of survivorship to another person or persons also on the account. HOWEVER, those bank accounts because their funding was by the deceased, must first be available for debts. If a co-owner takes the money and runs and there are debts then the estate must ask for it back, up to the fair share to pay debts or the estate may need o sue the one that has taken the money and not made it available for debts.

I think as you read this and reflect on your assets, you realize you have more to consider than you realized. It is well worth a trip to see a lawyer and to get your estate plan in order.

As I have gotten older, I have thought more about not just a Will, but how your estate plan reflects your legacy. Will your heirs look at what you left and remark about your irresponsibility? When they look at your financial account will they wonder what you did with the money that you had? Will they say, Mom and/or Dad never had much but look what they did with it and no wonder they were comfortable in retirement. Without even considering one's stuff what will be said about your character.

In addition to your Will you can also leave a personal directive of sort speaking to your beliefs and values and directing your heirs as well as possible which

characteristics they should live their lives by. One of the greatest fathers in the Bible was a man named Jonadab, son of Rekhab and found in 2nd Kings as well as Jeremiah. Jonadab had a zeal and love for God. Though murderous by today's standards he was involved in tricking the worshippers of Baal to come together in their temple only to be locked in and all killed. But that was his zeal for God and how to treat anyone that was an enemy of God. But what Jonadab did in life was

remarkable and his heirs for generations were honored by God. Jonadab's directives

to his children and children's children was that they should not drink alcohol and

never build a house nor plant a vineyard. About 250 years later (still living in tents)

in Jeremiah 35:15-18 we read this concerning the descendants of Jonadab son of

15 Again and again I sent all my servants the prophets to you. They said, "Each of you must turn from your wicked ways and reform your actions; do not follow other gods to serve them. Then you will live in the land I have given to you and your ancestors." But you have not paid attention or listened to me. 16 The descendants of Jehonadab son of Rekab have carried out the command their forefather gave them, but these people have not obeyed me."

17 "Therefore this is what the LORD God Almighty, the God of Israel, says: 'Listen! I am going to bring on Judah and on everyone living in Jerusalem every disaster I pronounced against them. I spoke to them, but they did not listen; I called to them, but they did not answer.'"

18 Then Jeremiah said to the family of the Rekabites, "This is what the LORD Almighty, the God of Israel, says: 'You have obeyed the command of your forefather Jehonadab and have followed all his instructions and have done everything he ordered.' 19 Therefore this is what the LORD Almighty, the God of Israel, says: 'Jehonadab son of Rekab will never fail to have a descendant to serve me.'"

Jonadab's commandments to his descendants were not Biblical commandments, but it was his love and zeal for God that allowed the Recabites to escape disaster. What will your legacy be?

#### The Great Divide

With each news cycle describing incidents reflecting the increasing political and cultural divide that exists in our nation, the more the following Scripture repeats in my mind.

Every kingdom divided against itself will be ruined, and every city or household divided against itself will not stand. - Matthew 12:25

The mainstream media is on a daily mission to exploit every possible area of division in an effort to ramp up envy and hostility between the races, genders, and economic groupings of America. It is so very tiresome at best, and depressing at worst. And it's being used as a tool to discourage us all.

For quite some time, I've been increasingly disturbed by all the ways that we have allowed hostile division to occur in our nation, our communities, and our families, and how that divisiveness obstructs civil conversation as we seek to solve the problems that we all face. While our political process is so vitally important to the preservation of our liberty, politics divides us as we too often and unwittingly become partisan pawns of those elect to serve us. One of my biggest concerns is identity politics which encourages and even demands that one support a particular candidate based on race, gender, or ethnicity rather than character or qualifications. Social media divides as it really isn't very social when we fall into the trap of online commenting that escalates into a brutal attacks of words not likely spoken in face-to-face conversations.

But much-needed encouragement for so many in our community was provided last month during the annual Montgomery Prayer Breakfast and the National Day of Prayer. As I shared in my April article about the Prayer Breakfast, it's a time in which our city and county elected leaders together with citizens from our River Region gather for corporate prayer on the National Day of Prayer.

In our times and culture in which the public acknowledgement of the Holy Trinity is increasingly under attack, I am truly thankful that our elected officials in our Capitol City are willing to take a bold stand for their Christian faith. It was a tremendous blessing to see so many diverse individuals – black and white, male and female, Republican and Democrat – unite for a prayer breakfast where the Rev. Cromwell Handy of the Dexter Avenue King Memorial Baptist Church

remarked as he looked over the crowd gathered, "This is what heaven looks like."

We united at noon for an intense prayer time at our Capitol as we prayed for our elected leaders regardless of political affiliation, the restoration of our families, and for our churches to rise up to spread the true Gospel, not a watered-down version that is weak in addressing our moral decay. The theme of the breakfast and the prayer at noon was "unity" and for me and others who attended, it was so beautifully manifested through the diversity of those who believe in Jesus Christ, our Savior and Lord.

Neither an annual prayer breakfast nor a National Day of Prayer will ever unite us as one political party with the same ideology, or one demographic of the same race or gender. That's not the intent nor is it the definition of the unity so desperately needed in our nation. I want to share what one of my local pastor friends, Keith Moore of iMpact Christian Church, shared as his understanding

"Unity is not being the same. No, unity means that we are diversely and drastically different, but we choose that one thing that brings centrality to our lives and it is Christ Jesus by the power of the Holy Ghost."

"See, I'm always going to be a black man, and a white man is going to be a white man - until we get to heaven. I'm always going to be a man and you're always going to be a woman. Being unified has nothing to do with our natural makeup, it has to do with our hearts coming together as one. #### **Check out Zimbabwe**

Don't laugh. Little Zimbabwe could be a model for providing prosperity for the entire world. Most people remember this African nation for

creating the most rampant hyperinflation in recorded history—a rate of 231 million percent annually. In the end, people were carrying boxes of \$100 trillion

Some also recall the ancient granite structures of Great Zimbabwe, from which the country derived its present name.

Zimbabwe (formerly Rhodesia) has some of the most fertile farm land in Africa. During much of the 20th century, it grew massive amounts of food and was nicknamed "The Breadbasket of Africa." It became the second wealthiest nation on the

continent—second only to gold-rich South Africa. In 1980, Robert Mugabe and his ZANU (Zimbabwe African National Union) party won

elections that ended the white minority rule. His

regime took over the country and directed groups of

black militants and an elite North Korean trained Fifth Brigade to seize the rich land from the mostly white farmers and rout them out. In doing so, they killed and tortured thousands of people including many of the farmers and burned their homes. With no one to run the farms, they soon fell into disrepair, and most food production ceased. The country's economy plummeted. People began starving. The hyper-

inflation destroyed the currency. Epidemics Approximately 25% of the people became infected with HIV. In 2008, Mugabe's party lost its outright majority

and had to share its power with the Movement for Democratic Change (MDC). Parliament member Tendai Biti became finance minister, and in a 30 minute speech, he announced the end of essentially all government interference in the economy. He treated Zimbabwe to instant free markets. Regulations, licensure, import permits, and exchange and price controls all went out the window. In 2009, the country scrapped its worthless hyper-

inflated dollars and adopted the U.S. dollar and the South African rand for its official currencies. These two simple reforms became Zimbabwe's

"Great Experiment," ironclad proof of the travesty of government regulation. In a few weeks, Zimbabwe's economy blossomed

with explosive impact. Food and fuel shortages

suddenly vanished. Empty supermarkets stocked up to their limits. The once rampant inflation dropped to a minus 7%, and within two years dropped to the lowest in southern Africa. Over the next four years, the economy grew about 8% annually. Tax revenue jumped almost eight fold. Foreign currency abounded. Unemployment plummeted. Entrepreneurs thrived and made record profits. Masses of people bought cars, took vacations, and sent their kids to the best private schools.

The magic of laissez faire (just leave me alone) had almost overnight transformed a destitute third world loser into a model of first world prosperity.

But it did not last. In 2013, in an election that was probably stolen, Mugabe's party regained full control and immediately re-imposed the previous government shackles—thus ending the few years of Zimbabwe's glory.

However, in December 2017, after a "soft coup," Mugabe was deposed and succeeded by Emmerson Mnangagwa, who promised "sweeping reforms." But so far, he has not delivered.

Zimbabwe's next move is an election right now (June 2018). The people will once again have an opportunity to elect an opposition party and put Tendai Biti back into office—that is, if the election

That will make Zimbabwe great again.

And now, we have a proven model to make America great again.

And, yes, even the entire world.

### **Tortured for Christ**

**Is Nothing New** 

It is the story of "Persecuted Believers" all over the World

A few weeks ago, Wycliffe Associates held their annual banquet in Montgomery with the Southeast Director, Noel Davis, updating us on the Voice of the Martyrs' current activities.

The underground church worked partly in the open, preaching in the streets. On a Sunday in January of 1948, he was kidnapped and taken to prison, where he remained 8 years. His wife did not know if he were alive or dead. He was tortured with the intent of forcing him to betray his brethren, which of course, he would not.

Those who tortured him would often use quotations from Lenin to justify the torture: "You cannot make omelets without breaking the shell of eggs." Wurmbrand spoke of seeing Christians tied to a cross and being left there for four days and nights.



## State School Board Races: worthy inquiry to Secretary Merrill?



Recent political Kabuki theatre has some contemplating Gov. Ivey's dating preferences and Judge Sue Bell Cobb's campaign hiring practices. How candidates deal with these may be revealing. I also wonder why Cobb did not quickly and simply apologize, then remove the convicted sex offender from her campaign team. I'm similarly at a loss on the dearth of political discussion on Ivey's inaction w.r.t. the Alabama PACT program during our last economic melt-down and forecasts of her abilities to address another contraction. With so much unsustainable economic activity driven more by govt. distortion and bailouts instead of market forces, the next bubble pop promises to be as profound as our last a decade ago. Given my greater affection for the mundane - like why our Secretary of State eliminated an election to install Felon Hubbard's preferred replacement, I'll ask readers if they think an inquiry about candidates in some of our State School Board races is apropos.



Section 16-3-3 of the code of Alabama declares "No person who is an employee of the board or who is or has been engaged as a professional educator within five years next preceding the date of the election shall be eligible for membership on the board. For the purposes of this section the term 'professional educator' shall include teacher, supervisor or principal of any public or private school; instructor, professor or president of any public or private university, college or junior college or trade school; any state, county or city superintendent of education; or other person engaged in an administrative capacity in the field of education."

Page 13 (lines 11 thru 27) of Rep. Collins 2018 House Bill 70 still included these requirements in §16-3-3 of Alabama Law <a href="http://web.alsde.edu/.../2018Regular/2018RS%20HB0070%20OR.pdf">http://web.alsde.edu/.../2018Regular/2018RS%20HB0070%20OR.pdf</a>... Rulings in 1976 and 1983 found 16-3-3 unconstitutional under equal protection grounds, specifically because of limitations on a person to be involved in the political process. The most recent case I found to challenge these rulings was decided in 2004. The plaintiff referenced the 1976 and 1983 cases to challenge the GOP not allowing him to run for State school board. The judge dismissed that specific claim with prejudice. Our State's own law manual [p. 134] for superintendents also references the 1976, 1983 and 2004 cases, acknowledges the findings, and elaborates our State Ethics Commission effectively supports 16-3-3 because a school employee cannot ethically be on the same governing board which employs them.

"Association rights are also implicated in situations where the school employee is politically active. Section § 16-3-3 Code of Alabama (1975) prohibits a person who is an employee of the (state) board or who is or has been engaged as a professional educator within five years prior to election to be eligible for membership on the board. A federal district court found this prohibition to be an unconstitutional provision in Gold et. al. v. Baggett et. al., Civil Action No. 76-120-N (M.D.Ala. 1976). The same conclusion was reached by a state court in Alabama State Ethics Com'n ex rel Charles Graddick v. Dr. Evelyn Pratt, Civil Action No. CV-83-175-G (Circuit Court, Alabama Fifteenth Judicial Circuit, 1983). However, state ethics commission rulings have made it clear that it is a conflict of interest for a school employee to be on the same governing board that employs him or her. (See, materials on Alabama State Ethics Commission, compiled by Dr. Paulette Rogers, and included in the materials following Module 33.)"

Parties have a history of changing an election rule or practice without first

seeking approval from the US DoJ as specifically required by the Voting Rights Act of 1965. Parties have also violated the instruction of at least one opinion of a past Alabama Attorney General attempting to enforce, or otherwise support by means of the Party apparatus a provision in State law prohibiting professional educators from serving on the Alabama State Board of Education previously determined unconstitutional.

Application of the Voting Rights Act of 1965 to election related actions under-

taken by political parties has been long settled in the current legal/political environment. In Morse v. Republican Party of Virginia (94-203), 517 U.S. 186 (1996), The U.S. Supreme Court has held, "Shortly after the statute was passed, the Court thoroughly reviewed its legislative history and found that Congress intended §5 to have "the broadest possible scope" reaching "any state enactment which altered the election law of a covered State in even a minor way." It also has long established law that any and all such changes in election rules or practices in Alabama, even minor ones, require pre-clearance by the DoJ as per Chapter 5 of the 1965 Voting Rights Act.

The form of and processes of certifying the ballots for primary elections is established in Section 17 of the Alabama Code which makes it clear no political party is obliged to hold a primary. Section 17-16-11 of the code of Alabama states, "...the state party chair shall, no later than 5:00 P.M. 55 days before the primary election, certify the names of all primary election candidates, except candidates for county offices, to the Secretary of State." Some have asserted a pattern of behaviour indicating (by means of Party apparatus and improperly enacted and selectively applied rules) an attempt to enforce a portion of State Law barring professional educators from serving on the State Board of Educa-

Law barring professional educators from serving on the State Board of Education previously been held to be unconstitutional.

Enough on the legal minefield. Sadly in Alabama, taxpayers fund Party

**primaries** where they must decide which **ONE** they will participate in although

they pay for *both*; then suffer lack of choice due to restrictive duopoly ballot access laws in **general** elections taxpayers **ARE** obliged to provide. What role does our Secretary of State play in verifying eligibility of candidates placed on taxpayer funded ballots? If a Party (paying for their own caucus, primary, smoke filled room, etc.) wants to put someone on the ballot who's not eligible, will violate ethics laws, etc. that's fine; it can then be addressed on the taxpayer funded general election ballot the State IS obliged to provide. Our State spends much time and effort verifying signatures, candidate filing forms, etc. to allow one to be placed on the ballot - where does the responsibility fall? Can one file an ethics complaint/inquiry to impede certification before it is too late and more unethical contracting and decisions are determined? Recent passing of *Amendment 14* suggests a block of individuals who do show to vote not wanting (and/or caring about?) properly passed legislation in Alabama these past decades.

A complaint was filed with the ALGOP steering committee with respect to eligibility of two candidates for State School Board District 2. It appears more effort was put toward 'sweeping it under the rug' reading text from Terry Latham who relied on Brian Taylor's (the Governor's connection to BCA/Riley Inc.) interpretation of the law which indicates failure to read the court of appeals decision and the Ethics Commission's opinion. A complaint was also sent to Sect. Merrill who routed it to the Assistant Attorney General assigned to the Secretary of State's office, who indicates a similar lack of due diligence. I couldn't find anything they've publicly submitted to refute ineligibility claims under circumstances of this sort. A reliable source said efforts to obtain a temporary restraining order is moving forward in an attempt to (re)assert these specific eligibility rules in the Alabama code are defended and enforced for State School Board members. From my vantage point (as most readers know, I really don't care if they're Democrat or Republican) here are some candidates who may be worthy of scrutiny in this regard:

**Jackie Zeigler** - 1st District: **incumbent**, shows information indicating time as school principal in the five year window which applies.

**Melanie Hill** - 2nd District: information indicating employment with the Dothan city school board less than five years ago, resigned before her term ended.

**Adam Jortner** - 2nd District: information indicating current employment as a professor.

**Tracie West** - 2nd District: information indicating current president of Auburn city school board.

**Yvette Richardson** - 4th District: **incumbent**, with information indicating current employment as a teacher/superintendent and educational consultant, unopposed in the primary.

**Don Wallace** - 4th District: information indicating employment as a part time instructor in the 5 year window.

**Cynthia McCarty** - 6th District: **incumbent** with information indicating current employment as a professor **and** professor when originally installed into the position, unopposed in the primary.

Some candidate research found those like Rich McAdams and Wayne Reynolds (both 8th District) who appear to be adhering to the 5 year rule; John Taylor (2nd District) shows information indicating much volunteering in schools but no official educational positions which would make him ineligible. Some candidates appear to be eligible, but are suspect with so little history I've found/available for verification of adhering to this specific rule. The usual caveat applies, this is simply more of my opining - I make no claim to have superior access over the offices of Sect. Merrill or AG Marshall. Doubtful I've enumerated all State School Board candidates worthy of investigation; nonetheless alarming how many candidates who appear to be in violation are incumbents, two of whom are also unopposed in the primary. One has to wonder how often and for how long these ineligibilities are left uncontested. The tradeoff of **not** having educators (revolving door/capture theory of regulation) in the mix to curb corruption is the reason for the legislation. If lawmakers think we no longer have worries in this regard then remove the law... which seems de facto repealed under the observed results in these Districts aided/installed by party apparatchiks and Sect. Merrill.

Who verifies? Are Parties allowed to thumb their nose at the law and ethics violations? If so, why waste taxpayer effort and time on forms and filings? Will they **also** be allowed on the taxpayer funded **general** election ballots? If the AG, Ethics Commission, Parties, Secretary of State, et al fail to address this, how does one proceed? First request an Ethics investigation? Is it possible to have class action lawsuit to lower the cost of removing **all** these results in one action? It appears in 1976, 1983 and 2004 each time a candidate was removed under 16-3-3 the appeals were denied; if correct - I await argument(s) on how candidates listed above, if verified, are different. Perhaps most if not all citizens, readers, taxpayers, voters will find these foolish inquiries unworthy of consideration... Mencken sagely asserted we get the government we deserve.



Retirement doesn't have the same meaning for everyone. Some people plan to retire and never work again. Some people plan for second careers in occupations that wouldn't have adequately supported their families, but they do the work for pure enjoyment. Some people, whether by design or desire, choose to work part-time or seasonally to supplement their retirement income.

Retirees (or survivors) who choose to receive Social Security benefits before they reach full retirement age (FRA) and continue to work have an earnings limit. In 2017, the annual earnings limit was \$16,920 for those under FRA the entire calendar year. In 2018, it is \$17,040. If you earn over the limit, we deduct \$1 from your Social Security monthly benefit payment for every \$2 you earn above the annual limit.

In the calendar year you reach FRA, which you can check out at www.socialsecurity.gov/planners/retire/ageincrease.html, you have a higher earnings limit. Additionally, we will only count earnings for the months prior to FRA. In 2017, the limit was \$44,880. In 2018, it is \$45,360. In the year of FRA attainment, Social Security deducts \$1 in benefits for every \$3 you earn above the limit.

There is a special rule that usually only applies in your first year of receiving retirement benefits. If you earn more than the annual earnings limit, you may still receive a full Social Security payment for each month you earn less than a monthly limit. In 2018, the monthly limit is \$1,420 for those who are below FRA the entire calendar year. The 2018 monthly limit increases to \$3,780 in the year of FRA attainment.

Once you reach FRA, you no longer have an earnings limit, and we may recalculate your benefit to credit you for any months we withheld your benefits

due to excess earnings. This is because your monthly benefit amount is calculated based on a reduction for each month you receive it before your FRA. So, if you originally filed for benefits 12 months before your FRA, but earned over the limit and had two months of

Social Security benefits withheld, we will adjust your ongoing monthly benefit amount to reflect that you received 10 months of benefits before your FRA, and not 12.

Most people understand that if they work while receiving benefits before FRA, their benefit

may be reduced. What most people do not consider in their retirement planning is that we recalculate your Social Security monthly benefit at FRA to credit you for Social Security benefit payments withheld due to earn-

ings over the limit. Explaining the earnings limit is another way that Social Security helps secure your today and tomorrow. Understanding both the earnings limit and the possible recalculation of your ongoing Social Security benefits will provide an additional perspective on retirement for you to consider.



### A Biologist's Opinion on Turkeys

My last article seems to have kicked off a firestorm of discussion! From all around the South, I've had fellow turkey hunters confirm exactly what I had been experiencing; a severe shortage of turkeys!


The big 3 reasons, to me, were predators, habitat, and baiting. All 3 of these are tied together, compounding each individual problem into something worse. Of course, I'm not a biologist, so I got in touch with the real deal, Ted DeVos. Asking for his views, this what he sent me.

I believe your 3 "reasons" are all valid. I would add that weather has probably played the largest part in the "decline". It is the most "region-wide" thing affecting turkey populations and the decline is region-wide. Pigs and other nest predators are also pretty much on the incline with the decline of trapping furbearers. We also have record high populations of hawks which actively hunt and prey on turkey poults. I would say that the conservation dept can't do much nor should be expected to do much since they can't control the weather, nor increase trapping or decrease hawk populations. They could stop the proliferation of corn and that would do more to help turkeys than reducing the limit or shortening the season. Alabama and each state surrounding us is showing that the real problem is the number of poults that are recruited into the population in the fall. We simply are not, and have not for several years, been getting enough poults to 3-4 months old where their survival rate is high. Predators and weather probably are the largest contributing factors. Habitat is definitely a factor but changes slowly and is not "region wide." It probably has little to do with the decline of the last 10 years. Another one we haven't discussed much is the proliferation of turkey hunters and their use of blinds, decoys and fans. There are WAY more turkey hunters than in the past regardless of what any surveys may say. No question.

As Mr. DeVos says, there are more than a few things contributing to our turkey hunting woes. One thing I've learned from my time in Mississippi is that the fertilizer plays a big role. Chicken manure is a great choice for fertilizer. In Mississippi, according to one of our callers on the radio show, it has to be heated through to kill bacteria before it can be used. There is no regulation like that the state of Alabama, to my knowledge.

Even the corn we use can have a major impact on the birds. Certain molds produce what's called aflatoxin in corn, which can make animals and people pretty ill. Of course, you can't use that corn for livestock or for supper, but we still use it for feed and bait. Be careful when you start grabbing those bags of feed corn!

As Mr. DeVos said, a lot of what's going on is out of our hands, but that doesn't mean we can just kick back and watch. Negligence won't get us anywhere! Keeping hogs and coyotes under some amount of control is a big start, as is good

property and timber management. We can't do much for the weather, but that's all right. I know I'll keep doing what I can to ensure turkey hunting, and all of the other hunting sports we love, continues to be a tradition that we can share and pass on to the next generation. So get out there, save those birds for next year, and go get'em!

# Kritter Korner

#### The Worlds largest rodent Capybara

The Capybara is a large, semi-aquatic rodent that is found inhabiting the water-logged regions of Central and South America. Closely related to other South American rodents such as Chinchillas and Guinea Pigs, the Capybara is the largest rodent in the world weighing up to 145 lbs and measuring nearly 4 feet long. Despite their enormous size though, these mammals have adapted well to life in the water and have a number of distinctive characteristics that aid their amphibious lifestyle, including the webbed skin between their toes which is particularly helpful when swimming. Interestingly enough, the common name of the Capybara is thought to

mean "Master of the Grasses", where its scientific name comes from the Greek word for water hog.

The Capybara is a heavy,

stocky-looking animal with a short head and muzzle in comparison to its body and hardly any tail at all. They have short but sturdy limbs and hoof-like claws on their toes which along with the webbing, helps the Capybara both when negotiating the slippery banks and with swimming and also prevents the Capybara from sinking too deeply into the surrounding mud. Their coarse, short fur is pale to dark brown in colour with varying tinges of yellow, red and grey and the Capybara is back on land. One of

is perfectly designed to dry out quickly once the Capybara is back on land. One of the Capybara's most distinctive feature sis the fact that their eyes, ears and nostrils are all positioned on top of its head meaning that they still have excellent sight, sound and smell whilst in the water. The placement of these features also means that when threatened, the Capybara can retreat into the water only leaving these parts of its body exposed to hide from potential predators.

The Capybara is found throughout a variety of habitats in Central and South America providing that there is a constant source of standing fresh water. They are found in Panama, Colombia, Venezuela and Peru, down through Brazil and Paraguay and into northern Argentina and Uruguay where they are most commonly found in swamps, marshes, rivers and lakes. The Capybara can be found inhabiting grassy plains and even in rainforests where they occupy territories in herds, with these areas reported to be adequate territories year round even with the differing seasons. During the dry season the Capybara must have water and areas where they are able to feed (often small sandbars in the water), but in the wet season when the area floods they must still be able to graze which they often do on the grassy banks.

must still be able to graze which they often do on the grassy banks.

The Capybara is a very sociable animal that tends to inhabit densely vegetated areas close to water in herds of around 20 individuals, which are usually made up of a dominant male with a number of females and their young. Capybara herds occupy very stable home ranges that are known to vary in size depending on the size of the herd to ensure that there is enough food, and although small parts of their territory may overlap those of another herd, they will tend chase intruders off their patch. The Capybara actually sleeps very little, preferring instead to doze while resting during the morning in thickets on the banks, or wallowing in the mud and water when cooling down in the heat of the midday sun. They begin to emerge onto land in the early evening when they graze on grasses and aquatic plants which the Capybara

will continue to do throughout most of the night. In a Capybara herd it is only the

dominant male that has the breeding rights to the females, and although it can occur all year round depending on the conditions, the breeding season tends to be during the rains in April and May. After a gestation period that lasts for around five months, the female Capybara gives birth to between 1 and 8 pups on land. Capybara young are very well developed at birth and not only have

all their fur and can see, but are also able to run, swim and dive within hours of birth. The female rejoins the main group within hours with her newborn offspring, which begin to eat grass after about a week (although they will continue to suckle milk from their mother until they are around four months old).

The Capybara tends to live for up to 10 years in the wild and slightly longer when kept in captivity. The Capybara is a herbivorous animal that only eats plant matter in order to acquire all of the nutrients it needs. The diet of the Capybara is mainly made up of grasses and aquatic plants, along with fruits and berries and the occasional munch on soft tree bark. Despite spending a number of hours during the night grazing, the Capybara is quite fussy with around 75% of their diet involving between three and six different species of plant. Like all other species of rodent, their two front teeth grow continuously throughout their life meaning that they must gnaw and chew their food to grind them down which they do in a back and forth motion rather than from side to side. They are also known to both regurgitate their food in order to chew it again (much like a Cow) and also eat their own droppings which help to break down the cellulose in the grass, along with aiding their digestive system in general.

Despite the large size and secretive aquatic nature of this large rodent, their slow and gentle disposition makes them a rewarding meal for numerous hungry predators throughout their natural range. Wildcats including Jaguars, Pumas and Ocelots are the primary predators of the Capybara along with Caimans and Eagles that can hunt the younger ones from the sky above. The Capybara is also one of the best sources of food for the world's heaviest snake, the Anaconda, along with other species of large snake.

The Capybara is also hunted by Humans in parts of its natural range for both its meat and the hide which is prized amongst some. Although the global Capybara population is not considered to be under threat, numbers in these areas have declined. Habitat loss also affects Capybara populations through Central and South America as they are specifically adapted to life in their unique watery wilderness.

Capybara never stray far from water as when one senses danger it gives a short bark that encourages the herd to quickly scuttle into the water to hide. They are so well adapted to going unseen in the water that the Capybara is actually able to hold its breath for up to five minutes after diving in. Although Capybara herds tend



to average between 10 and 30 individuals, larger groups are not uncommon with some numbering up to 100 members in home ranges generally larger than those of smaller groups. Capybara are known to communicate between one another using both scent (which is secreted by their glands) and sound, and have a number of different vocalizations including whistles, barks, grunts and squeals. Due to their slow and generally gentle nature,



# Rotary Clubs make Montgomery Dog Park a Reality

Work was recently completed on a new development in downtown Montgomery which will attract new visitors to downtown Montgomery...four-legged visitors to be exact!

With the addition of a public art project, City of Montgomery officials and four local Rotary Clubs are celebrating the completion of Rotary Dog Park which inhabits an existing greenspace adjacent to the parking deck at Montgomery City Hall at the corner of Coosa and Bibb Streets. Development officials chose the site due to its central location, size, treescape and underutilization. The park features mature trees and a large water fountain but also includes brand new infrastructure that includes vinyl fencing, pet fountains, a new drainage system and





enhancing the quality of life and adding to the overall vibrancy of our city," Montgomery Mayor Todd Strange said. "Not only do we anticipate Rotary Dog Park enhancing livability downtown for existing residents, but it will serve to entice future residents who may now more easily envision themselves moving downtown with their pets."

The park culminates a collaborative effort by four local Rotary clubs in Montgomery to serve the local community. Sunrise Rotary Club President Jimmy Hill said, "These clubs and their combined membership chose to partner with the City of Montgomery and convert a section of this park into a dog park, and I say 'chose' because that's what Rotarians do: we choose service over self. This place is going to the dogs...and that's a good thing."

In the future, additional phases of development to the park could incorporate skills and agility training equipment for both large and small dogs. In addition to the equipment, Rotary, with help from a local Gumption Fund grant, commissioned a large mural which extends along the side of the parking deck and features colorful Rotary cogs and the Four-Way test: guiding principles for Rotarians to use for their personal and professional relationships.

The public art project not only increases the visibility of the dog park, but serves as a reminder of the code of ethics for Rotarians worldwide. It's hoped that people can take encouragement from the mural while their pets are enjoying the freedom to run in some grass: all in the middle of a busy downtown.


#### Camp Show n' Tell July 31st - August 3rd

The Montgomery County Sheriff's Office has a new phone app called "Montgomery County AL Sheriff" that can be accessed through your



If you are a retired chef, there is a good chance for your birthday you will receive a cookbook. If the gift giver knows that you write an article for the Alabama Gazette called Southern Cuisine, it is a better chance the cookbook will have recipes from the South. Moreover, if the book is from your sister, it will not be the run of the mill cookbook. It will be "The Southern Sympathy Cookbook, Funeral Food with a Twist", by Perre Coleman Magness.

This cookbook will compliment a funeral food cookbook I already have, "Being Dead is no Excuse, The official Southern Ladies Guide to Hosting the Perfect Funeral", by Metcalfe and Hays. It is from books like these

that you will expand your knowledge of everything Southern, such as learning what is a "bosom casserole"? And in case you do not know a "bosom casserole" is an enticing dish a widow brings to the home of the new widower in an effort to catch his eye. These two books are about the role tradition plays in the South. How we look out for each other in times of need and whatever the situation is in life. A good meal made by caring hands, will comfort the sad, the lost and the troubled.

A side observation is that I noticed a common thread in the recipes in the books was bourbon. Add three tablespoons to a 3-cup recipe of Pimento Cheese, add some to your roasted pecans, and add to the ham in the slow cooker. Do not forget to add it to the mustard made for the ham. Jack and Coke sheet cake did not get its name just from the soda from Atlanta! Finally, do not forget your pecan pie. It was ironic that I got the book right before I took a trip to Kentucky. Back to the food! Being prepared to bring comfort to a family or participat-

ing in a dinner on the grounds or being prepared for a visit from friends and family can easily be accomplished. Pick a weekend when you can spend time in the kitchen prepping and preparing "make ahead meals". There is no loss of recipes from books, magazines, and from friends and family. Type in the search panel on PINTEREST for Funeral food and the choices are plentiful. All the recipes can be labeled and referenced as "make ahead meals". In addition, the nine by twelve casserole dish is the perfect vessel for these meals.

The recipes are usually in the vein of mix the ingredients together, place in dish, and bake. If you want to produce mediocre casseroles, follow those instructions. Your goal should be to prepare a dish that is not your ordinary dish, something with a slight twist that will make my dish stand out and be noticed. The ingredients can be no different from anyone else's, however something as subtle as changing the shape can set one dish ahead of another.

An example that I like to prepare is a version of classic comfort food, chicken potpie. To me, a potpie should be shaped like a pie! Not nine by twelve rectangles but round! In addition, I want a "make ahead meal" that is freezable and easily transportable. Also, is there a point when you can freeze part of the prep for a later day? The other criteria; being concerned with servings. Do you have to cook the one dish all at once or is it sized into smaller portions to cut down on leftovers that are usually thrown away.

### **Chicken Pot Pie**

Makes 2 whole pies

(Pie plates are from Dollar Tree, with a cardboard lid. They may be called round 8-inch foil cake pan. Deeper than regular pie plates with straight sides, the lids are for freezing and transporting only. Do not cook with lid on. Use foil to cover when baking)

#### Ingredients

1 cup chopped onion ■ 1 cup sliced mushrooms 1 cup 1/4inch slices of peeled carrots 1 cup potatoes 1/2 inch diced peeled ■ 1/3 cup butter

1/2 cup all-purpose flour, sifted 2 cups chicken broth 1 cup milk

1 2 cups rotisserie chicken, cooked, chopped



1 cup frozen peas, thawed 1 teaspoon dried thyme 1 tsp. salt

4 unbaked pie crusts (homemade or store-bought)

#### **Directions**

- 1. To make filling: Sauté the first 4 ingredients in butter in a big skillet over medium heat until tender. Add flour; stir until smooth. Cook 1 minute, stirring constantly. Add chicken broth, thyme and milk; cook, stirring constantly until thickened and bubbly.
- 2. Stir in chicken, peas, salt, and pepper. Stir to thaw peas.
- 3. Cool, VERY important!

#### I Freezing instructions:

Prepare crusts.

Roll them out, place the bottom crusts in the pie plates, and set aside the top crusts until ready to cover. Pour filling mixture into bottom crusts and cover with top crusts.

Fold edges under and crimp. Poke slits in the top

• Cover with foil, label, and freeze.

#### TO PREPARE POT PIE FROM FROZEN ■ Bake the whole pie from frozen.

Preheat oven to 375 degrees.

Bake, uncovered, for 30 minutes, then cover with foil and bake 30 more minutes. Crust should be a golden brown. Remove from oven and let rest for ■ 10 minutes before cutting. Serves 16 (from two pies).



Our home freezer is full of frozen made ahead meals sealed in mason jars. We have chili, beans, vegetables, soups, and desserts all waiting for someone in need or just hungry. Wide mouth pint mason jars are perfect to store servings to be defrosted and then heated in the jar. Each is a perfect serving or even a serving for two. They are great for meals on the go also. When you are finished, screw the lid back on, and take it home to wash and fill again.

Imagine the whiff of cornbread batter and listen to the sizzle as it is poured into a hot cast iron pan that has been liberally drenched with bacon **drippings.** As it bakes in the oven, you stare through the oven door window, anxiously waiting to drench a slice of the fresh hot cornbread with soft butter. In addition, you taste the mix-ins that you put in the batter. What, you did not add anything to the batter? Cornbread is great by itself, but so much better with some flavor enhancers, aka, mix-ins. I like yellow corn, chopped jalapenos, and shredded cheddar cheese added to my cornbread batter. However, I have added bacon, bell peppers, sausage, and onion in the past.

I found this recipe on the Food Network website and it is a good reference for add in's with the amounts needed to fill a 9 by 12 casserole dish. You are going to bake yours in a cast iron skillet, aren't you? You can start your own list and pretend it is a menu for a Chinese restaurant, and pick from the different

In a separate bowl, whisk 1 egg, 1 cup milk, 1 cup sour cream or plain Greek yogurt, and 2 tablespoons melted butter; whisk into the dry ingredients until combined. Fold in the prepared mix-ins and cheese.

### Southern Gardening Potpourri for June by Peggy Givhan

growing.

June is the month that most people are in earnest about their gardens. If you do not believe me, just go to nurseries and garden centers on these warm sunny days. Women and men are filling shopping carts full with an array of summer annuals, perennials, bulbs and tropicals. The congestion can get frantic and the lines long, so I suggest going during the week days and avoid the week ends. Also early in the mornings

the gardening trade would be lighter. If you are starting from scratch or have large areas in which there is nothing, do not forget to purchase good soil to use as a top dressing which will prove to be a great start for the small plants. And do not forget the fertilizer. I usually apply it after I plant, and then water it in really good. Osmocote which is time released, and after applied, should last most of the summer. The only flower that will not tolerate commercial fertilizers to remain on its leaves are begonias. The fertilizer pellets burn the leaves and could affect the future health of the plant. If you use what I call common or cheaper raw fertilizer on begonias, shake the leaves well before watering. Of course liquid fertilizer is good in any situation.



There is one thing for sure in the gardening realm, if at first you don't succeed, try again. That holds true if the color scheme is bad, pull out or transplant to another area the block of plants that do not work, and re-plant.; if the seedlings have poor germination, re-sow the seed, as you will know within a couple of weeks; if the weeds out pace your ability to

get control, put up blinds around flowers you want to keep and use a normal solution of Round-up. Gardeners know that nature always gives

I really like to place plants in close proximity where one gets a sequence of bloom or the plants bloom simultaneously. In my backyard, which is mostly semi shade, I am enjoying a huge terra cotta pot filled with blooming light purple digitalis with three oak leaf hydrangeas in full bloom behind and off to the side-a dynamite sight. These two techniques show good garden planning and gives one a lot of bang for the buck. On a black privacy fence, a good combination of plants that bloom at the same time, are red Knock roses and white confederate jasmine. Also the jasmine gives off a wonderful scent. Both of these choices have very long bloom cycles and look great framed by the black privacy fence. A sequence of blooms example includes a mass of daffodils in front of old fashioned day lilies. When the daffodils die down with browning leaves, the day lilies are shooting up fresh green leaves hiding the daffodils' ugly feet. One has to allow the bulbs to die down to the ground in order to be nourished for bigger blooms next season.

#### PLANT OF THE MONTH- PHLOX

There are mainly three varieties of Phlox. One can say that we can have

a Phlox for all seasons with a full range of colors and sizes. We have P. paniculata, a garden or summer Phlox which gets to around 4' in height; P.stolonifera, a creep-Phlox which grows to around 10 inches in height; P. subulata, moss pink lavender grows to 5 inches or so. All three of these varieties are hardy to USDA Zone 4, needs a sunny location and well drained soil. Our region is in USDA Zone 8, the higher the number, the colder the climate. In other words, these do well

#### **IDENTITY THEFT**

When your personal identification information (name, social security number, driver's license number, etc.) has been used fraudulently to open credit accounts, bank accounts, obtain loans, utilities, telephone services, etc., without your knowledge or permission, you are the victim of the crime of identity theft. If you believe that your identity has been stolen, you should take the following steps:

Immediately contact the company or financial institution's fraud department where your information was used and alert them of this fraudulent account. Have the account closed or cancelled.

File a police report with the law enforcement agency holding jurisdiction where the identity theft occurred and obtain a case number.

Contact the three credit reporting companies listed below to report an identity theft complaint. You will need to confirm that a fraud alert is placed on your personal credit file. This alert should help any future acts of fraud involving your personal identification information where a credit check would be conducted with the three credit bureaus.

**Placing a fraud alert is free.** The initial fraud alert stays on your credit report for 90 days, and can be renewed after 90 days. Be sure the credit reporting company has your current contact information so they can get in touch with you.

Order your credit reports. After you place an initial fraud alert, the credit reporting company will explain your rights and how you can get a copy of your credit report. Placing an initial fraud alert entitles you to a free credit report from each of the 3 credit reporting companies. Review each credit report for accuracy.

**Create an Identity Theft Report.** Submit a complaint about the theft to the Federal Trade Commission. You will need to fill out an Identity Theft Affidavit online at *www.identitytheft.gov*. When finished writing all the details and completed the report, print a copy for your records. It will print as an Identity Theft Affidavit. Attach the Identity Theft Affidavit to your police report to make a complete Identity Theft Report.

An Identity Theft Report helps you deal with credit reporting companies, debt collectors, and businesses that opened accounts in your name. You can use the eport to:

Get fraudulent information removed from your credit report.

Stop a company from collecting debts that result from identity

Stop a company from collecting debts that result from identity theft, or from selling the debt to another company for collection.

Place an extended fraud alert on your credit report.

Get information from companies about accounts the identity theft opened or misused.

Remnants and reminders of rural summer memories.

It has been almost 40 years since I spent my last summer with Fannie. She would not believe the lives we live now.

Even in the 70's she lived somewhere far back in time. It was partly, I suppose, because she was in rural Marengo County. We lived only minutes away from one another, but we were worlds apart...minus the weekdays we would spend together.

I would often arrive at her house early enough the fog would still be rising over the farm fields. It would slowly lift, surrendering to the golden beams of the rising sun.

Most of our time inside was spent within two rooms, the kitchen and her bedroom. The bedroom had a fireplace in it that would be boarded-up during the summer months. There was a closet with a curtain that served as a door. Behind the curtain was evidence of a fire that had gotten out of hand once. The charred wood had never been replaced.

There was also a small black-and-white television in the bedroom. She was a fan of the Price Is Right. We watched it every day and she would personally advise all the players who made it to the stage. She won with them and lost with them for the hour.

The rest of my day would be spent following in behind her. She drew their water from a well three times a day. I would often miss her first early morning trip, but I would be with her for the next two. We would also trek across the road diagonally to her elderly mother's house to check on her. Nobody seemed to know for sure how old she was, she was somewhere in her nineties. They said they didn't keep records when she was born. But I think that was primarily due to the fact that she was born Choctaw. Fannie had such features too. Her sister Mary, who lived in the old dog trot house with their mother, did not. Her skin was darker and her hair was not long and straight, nor was it braided.

The two sisters would do laundry in the back room using an old wringer style washer. They would open the door to their mother's room so from her bed she could be included in their conversations. I had the privilege of being able to hear them talk, as I would play on the back porch where ripe figs were an arm's stretch away.

Like so many, Fannie always kept a garden. It wasn't unusual for her to be canning corn, snap beans, and pink-eyed purple hull peas while she cooked dinner. And it was dinner. I was midday, but it was dinner, not lunch, and it would be simple, consisting mostly of chicken, fried okra, cornbread, and sliced tomatoes. In season, there would be a row of tomatoes with their orange bottoms turned up on the counter. Sometimes the chicken would just be fried gizzards.







