Women in our country for a long time have certainly gotten the short end of the stick. No doubt. From pay issues, to the right to vote and equal access to jobs in every job market in this country, I will admit that women, like blacks and other minorities, have thankfully made great strides securing their rights to work and contribute to our society. For a long time, the military was one of the final frontiers of inequality in the work place for women. When I went to Undergraduate Pilot Training in 1983, we had a couple of women in my class and one female instructor

pilot in my T-38 flight. Although women went through the same training as the men, they were barred from flying combat aircraft. No matter how good their grades were or what they wanted to fly, women were restricted in what they could fly. In many cases, this in turn limited how far many of them would go in the military. **ROE v. WADE was decided January 22, 1973:** 

**SYNOPSIS:** Under existing law, it is unlawful for any person to intentionally perform or attempt to perform an abortion except where a medical emergency exists. This bill would prohibit a physician from performing an abortion if a fetal heart beat has been detected or if no test for a fetal heartbeat has been performed, except in circumstances where a medical emergency exists.

### State Senate Will Have Little Turnover in 2022

[The year ] 2022 was anticipated to be an exciting competitive election year. However, it is going to be a yawn of a political year. If you thought there was no competition for the constitutional offices and the House of Representatives' seats in next year's elections, then you have not seen anything like the lack of turnover in the Alabama State Senate. Incumbency will prevail.

In fact, the power of incumbency in the Alabama State Senate is on par with the incumbent return percentage for Congress, which is probably comparable to the Russian Communist Politburo. There are 35 state Senate Seats, 27 of the 35 are held by Republicans. Out of the 27 Republican state senators, 24 are running for reelection and all 24 probably will be reelected. Almost all of them have no opposition.

The Democratic minority has just as high a reelection bar. Of the eight Democrats, seven probably will be running unopposed. The only Democrat not running will be Priscilla Dunn who has not been to the Senate this entire four-year term. Most of the first-term State Senators have never met her. According to rumors she is in poor health and cannot attend. The 150,000 people in Senate District 19 in Jefferson County have been without a voice or vote in the Alabama Senate for four years.

The three retiring Republican State Senators are giants. Del Marsh, Jimmy Holley, and Jim McClendon's shoes will be hard to fill. These three seats will be filled by new Republicans. The 27-8 super Republican majority will continue.

State Senator Del Marsh (R-Anniston) has been a leader in the Senate for 23 years. He served as President Pro Tempore of the Senate most of that time. He ran a very effective ship of state.

State Senator Jimmy Holley (R-Elba/Coffee) is an icon. He was a master of Senate rules. He also was a mentor to a good many young senators.

State Senator Jim McClendon (R-St. Clair) will be sorely missed in the state senate. The gentleman from St. Clair served with honor and distinction for eight years in the State Senate and 12 years before that in the House of Representatives. This freshman class of senators has bonded and works cohesively with the

veteran leaders. The Freshman Class includes Will Barfoot (R-Pike Road), Tom Butler (R-Huntsville), Sam Givhan (R-Huntsville), Dan Roberts (R-Jefferson),

Garlan Gudger (R-Cullman), Randy Price (R-Lee), Donnie Chesteen (R-Geneva/Houston), David Sessions (R-Mobile), Jack Williams (R-Mobile), Chris Elliott (R-Baldwin) and Andrew Jones (R-Cherokee/Etowah). Senator April Weaver (R-Shelby/Bibb) won her seat recently when Cam Ward left to become head of Pardons and Paroles. April Weaver previously served in the House of Representatives. She is the only female GOP Senator. She has a bright future. All twelve of these new senators have done an excellent job and all will be reelected. Ten of the twelve will probably run unopposed.

There are some exceptionally talented and dedicated veterans in the Senate that will coast to reelection. Most, if not all, will be unopposed. This stellar group of legislative leaders include President Pro Tem Greg Reed (R-Jasper/Walker), Senate Majority Leader Clay Scofield (R-Guntersville), Senator Clyde Chambliss (R-Autauga/Elmore), Senator Steve Livingston (R-Scottsboro/Jackson), Senator Shay Shelnutt (R-Jefferson), Senator Tom Whatley (R-Auburn/Lee), Senator Gerald Allen (R-Tuscaloosa), Senator Greg Albritton (R-Escambia) the Chairman of the Senate Finance General Fund, Senator Arthur Orr (R-Decatur) Chairman of Senate Finance Education, and last but certainly not least, the legendary Jabo Waggoner (R-Vestavia), who chairs the Senate Rules Committee.

There will be some outstanding veteran Democrats returning to the State Senate. There are several giants, who include Senator Bobby Singleton (D-Greene), Senator Vivian Figures (D-Mobile), Senator Rodger Smitherman (D-Birmingham), and Senator Billy Beasley (D-Barbour).

Senator Kirk Hatcher (D-Montgomery) is new to the senate. However, he bears watching. He is gregarious, likeable and a quick study. He will be effective for the Capitol City.

The senate abounds with outstanding leadership on both sides of the aisle. The lack of competition the members are garnering is a testament to their good work. This returning group of leaders could well portend for a successful future quadrennium. With this kind of experience and leadership, they will also be an independent group. They will not be a rubber stamp for governor.

Avoiding Saigon's Quagmire in Manila

This article recalls the Philippines off-year Philippine army was as ineffective as it was demoralized. Given the amount of

election in 1951. It is a little known story about how the good guys avoided a communist takeover. Regrettably, these lesson were forgotten in Vietnam some 10 years later. I hope *Alabama Gazette* readers will find it of interest.

Seventy years ago, the Philippines came within a whisper of being the pre-game for Vietnam.

But much like the dog that didn't bark or the accident that didn't happen, few people appreciate how close the Philippines came to communist domination. That this didn't happen is testimony to the effective combination of American soft power and ethical local leaders who captured the hearts and minds of the people.

As in many countries during World War II, all sorts and conditions of indigenous resistance fighters challenged the occupying Axis powers. Included among these patriotic guerrilla fighters were committed communists who saw the fascists as another hurdle in the struggle to achieve the workers' paradise. Once the war ended, these various revolutionary movements became the spawning ground for political leaders.

As is so often the case, most pro-western groups quickly declare victory and move forward to cash their peace dividend while forgetting the need for eternal vigilance and continuous engagement. The communists never do this because their version of peace is only a steppingstone toward total control and ultimate domination of the political machinery of government.

The Philippines had been an American territory, and, prior to the war, was well on its way to independence. The Japanese occupation delayed this, but once American forces liberated the country, civil government was restored. In fact, General Douglas MacArthur, insisted that civilian administration, as opposed to military governance, be returned immediately to avoid any appearance of imperialism.

Ultimately on July 4, 1946, the Philippines became a sovereign state and no longer a U.S. commonwealth. Regrettably, several political factions that had proven so effective in fighting the Japanese refused to lay down their arms and participate in a constitutional government.

And as the Philippines was recovering from the devastation of war, aid of all sorts flooded into the country to begin the process of reconstruction. As critical as this foreign aid was to revive the economy, the magnitude of the funding created an environment of political corruption as many in the ruling party personally benefited from the largess.

As a war torn, third-world country with limited experience in self-government, the leadership of the Philippines on many levels became abusive as position, power, and pesos were used to maintain control. Somewhere along the way, the constitutional ideas about popular elections and consent of the governed gave way to fraudulent elections and a power structure that forgot about the people. And as the citizenry witnessed rampant corruption, they lost faith in the government and were easily swayed to revolutionary ideas which promised the usual equity and equality for all.

Into this deadly combination stepped the communist guerrilla leader Luis Taruc, who used his military skills and personal charisma to charm the peasants into joining his revolution to end their exploitation. Because of corruption, the

Philippine army was as ineffective as it was demoralized. Given the amount of military assistance, the armed forces became an employment agency such that maintaining national security and fighting the revolutionaries took a back seat to graft, corruption, and social engineering.

Those who had fought the Japanese and wanted to maintain their independence saw their army overrun by Taruc's Huk insurgents. The army had the resources it needed, but with low morale, it was difficult to maintain the discipline necessary to win.

But some leaders of the Philippines understood the threat and realized their country was on the brink of disaster that would send them backwards, gutting their independence, and voiding their constitution. Sensing this clear and present danger, Congressman Ramon Magsaysay developed a plan to fight the communists. He realized that corruption, especially within the army, had to be stopped.

Initially the ruling government would not listen to his ideas, but once the success of the insurgents carried them to the outskirts of Manila, the leadership changed tack, and Magsaysay was appointed defense minister. In this position, he very quickly reformed the armed forces and rooted out corruption. Using skills learned as an insurgent against the Japanese, he realized that winning the countryside and making the peasants his allies was critical to successfully defeating the communists.

His efforts to both defeat communism and embrace the peasants were aided by an American Air Force Colonel, Edward Lansdale. Rather than have American aid siphoned off to line the pockets of corrupt officials, Lansdale used funds to help the peasantry with food, advocated land reform, and provided the people with the means to sustain themselves. Using psychological warfare tactics, he reduced the effectiveness of communist forces by not only cutting off rural support, but also re-educating captured terrorists to secure their acceptance of Magsaysay's reforms.

The team of Magsaysay and Lansdale was wildly successful. By restoring the people's confidence in a constitutional government and standing against corruption, they paved the way for a reform movement that started in November 1951, with the elections of an anti-corruption and reformist Philippine senate. This election became a referendum on Filipino leadership and was significant in sweeping in a government that would fully support Magsaysay's plans for development.

This election marked a turning point as national support receded against corrupt officials in both the government and the armed services. Once the army was restored as a fighting force and not a social benefit organization, the communist Huk's days were numbered. When the government showed respect for the peasants by giving them ownership of their land and not abusing them, they gained allies and eliminated the fertile ground which nurtured and sustained the communist threat. This combination of government reforms and military action allowed the Philippines to avoid the terrors of internal revolution that could further devastate their developing country.

The success of Magsaysay's plans to provide for the people and defeat the communists made him so popular that two years later he would be elected president. That the Philippines did not become a communist quagmire is a testament to Magsaysay's success in respecting the people, eliminating the prestige of corruption, and establishing the foundation for a strong democratic republic.

### Don't Hate Me Because I'm Right

Do you guys remember the 1980s-ish, super-sexy Pantene shampoo commercials featur-

ing actress Kelly LeBrock? She stared into the camera, fluffed up her hair and said, "Don't hate me because I'm beautiful." I'm sure 99% of all red-blooded American guys liked that commercial.

But unfortunately, today, I am not writing about shampoo, nice hair, pretty women or anything of the sort. Today I am going to write about something concerning our military that I have written about in the past. The topic for sure is a hot-button subject and I am sure many of you guys and gals out there are going to vehemently disagree with me on this subject. I remember one time talking about it with Kelvin Elkins on his radio show and some lady called in and called me some very unflattering names. But you know what, I can take it. Like the title says, don't hate me because I'm right.

That folks, is discrimination.

Finally, in 1993, people pulled their collective heads out of you know where and authorized women to fly combat aircraft. That year, Jeannie Flynn (now Jeannie Leavitt) became the first female USAF fighter pilot while Cara Hultgreen became the first Navy fighter pilot. Since that time, we have females flying every aircraft in the Air Force and Navy inventories and we have even had at least two female USAF Thunderbird pilots.

Back in 2012, the US Army decided to open jobs to women in some of its all-male combat units. Since practical experience already showed there was much cross over anyway, the Army simply decided to make it official. This change is expected to open up close to 14,000 new jobs for women although some 250,000 jobs reportedly remain closed. Some of the jobs opening up are tank mechanics, artillery and rocket launcher crewmembers. Yes, the world, rightfully so, is opening up to everyone who wants to contribute.

This brings us to 2021 and the draft Defense Authorization Bill. In the draft version, a provision was made that would require women to register for the draft. Unfortunately, and yes, in my opinion, Missouri Senator Josh Hawley and several other congressional Republicans to include Ted Cruz and Tom Cotton, unfortunately opposed the provision; effectively killing it before it gained any real traction. The National Defense Authorization Act of 2022 initially included a provision to "modernize the Selective Service System" by requiring women ages 18 to 25 to sign up for a draft but Senator Hawley filed an amendment on 29 October to keep the American mindset in the Neolithic Age. The bill was an attempt at modernization of the selective service program by supporting "the mobilization needs of the Department of Defense by including women if the all-volunteer model is no longer able to recruit enough people during a time of national crisis."

Hawley wrote, "It is wrong to force our daughters, mothers, wives, and sisters to fight our wars. [Women] have played a vital role in defending America at every point in our nation's history. But volunteering for military service is not the same as being forced into it, and no woman should be compelled to do so." Wow.

So here I sit in my study and unfortunately have to ask a most important and extremely unpopular question. Why is it that ONLY men, aged 18-25, are required to register for the Selective Service System (SSS)? In other words, register for the draft? I'm throwing this out there only because I really have not heard a good excuse as to why not. Much like Hawley's statement, most arguments lack any substantial logic. Look, according to the SSS, male citizens and immigrants, documented and undocumented, residing in the U.S. and its territories must register. Why not women, too? For crying out loud, even illegal immigrants are required to register. "WHO MUST REGISTER? Male U.S. citizens and immigrants, documented and undocumented, residing in the U.S. and its territories must register if they are age 18 through 25." I love the quote on the registration form that reads, "FAIRNESS AND EQUALITY by registering all eligible young men, the Selective Service System ensures a fair and



equitable draft." Does it really? If it excludes 100% of the women in our country, how exactly is that actually fair and equitable? It's not!

All I am saying here is that women have rightfully fought for the right to participate in combat roles. They have reasoned that they have as much right to fight for this country as do men. Since they have successfully argued their case to fight for this country and fly some really cool airplanes while doing it, how can anyone rationally protest that women should be excluded from registering for the draft? They can't. The logic there does not exist. This people, is also discrimination.

I have had people tell me, "I don't want to see my daughter in combat." Well, most folks don't want to see their sons in combat either. Besides, if a draft ever occurs, not everybody will be drafted into combat roles. There will be plenty of need for non-combat personnel should the proverbial balloon ever really go up. In fact, the vast majority of military jobs are non-combat related. I have also had people tell me, "Not all women want to go into the military." Again, I say, neither do all men. Not all men are fit for combat and neither are women. But once again, not all people drafted will be put into combat and more importantly, what is good for the goose is good for the gander. Here is a perfect example. In the next great war, which will hopefully never happen, we are going to need a lot of smart, tech savvy people. I am sure that many of our smartest, computer hacker, computer programming stars in this country are women. In a highly complex cyber type war, why in the heck would we not want to have women fighting this type of war from the safety of their office hundreds or thousands of miles away from the fight? To ignore this resource, in my opinion is stupid. Without the draft, would these brilliant assets ever willingly step up to the plate so-to-speak and join of their own volition? Maybe, maybe not.

The bigger point here is this. Since women fought for this right, how can they selectively choose which military requirements they are willing to support? Can you imagine if Al Sharpton said that no blacks should be required to register for the draft since not all blacks want to serve in the military? That would be like the Governor of California telling the federal government that no men from his state will ever again register for the SSS because California doesn't believe in war. Sorry folks, but equal rights exist, or rather should exist, in every situation and every case. Equal rights should not be enforced only when you want it to serve your myopic political agenda.

Do I really want to see women drafted into combat? No, but neither do I want to see men drafted into combat. But should the draft ever again be necessary, I think all of us will have "bigger fish to fry" than this single issue. But living in the greatest democratic republic on this planet should *require* potential sacrifices of **all** its citizens; male and female. No group should be allowed to pick and choose which sacrifices they want to make. In my view it is all or nothing and if women really want America to be the sex-blind society they have fought so hard to create, they should be the first ones to step up to the plate and say, "Yes, we will stand shoulder to shoulder with our brothers, do what is right and register for the draft." Certainly, most women should willingly admit that they have more of a vested interest in this great country of ours than the illegal immigrant who is required by law to register.

### **DID YOU KNOW?**

Fourth in a Series

The U.S. Congress, on July 25, 1861, passed the Crittenden-Johnson Resolution, also known as the War Aims Resolution, stating it had no interest in interfering with the internal affairs of the States, which would include slavery; and the purpose of the War was to return the seceded States to the Union.

"This war is not being waged in any spirit of appression, or for the purpose of conquest or subjugation, or the purpose of overthrowing or interfering with the established institutions of those States but to defend and maintain the supremacy of the Constitution and to preserve the Union with all the dignity and rights of the several States unimpaired, and as soon as these objects are accomplished the war ought to cease"

Horace Greeley was the editor of the *New York Tribune*, the largest newspaper of the day, and an ardent abolitionist. He urged President Lincoln to end slavery. Lincoln wrote a reply to Greeley on August 22, 1862, saying he had no interest in freeing slaves, but would do what he thought effective in winning the War, whether that involved freeing some, all or none of the slavers.

"My paramount object in this straggle is to save the Union, and is not to either save or destroy slavery. If I could save the Union without freeing any slave, I would do it; if I could save it by freeing all the slaves, I would do it; and if I could save it by freeing some and leaving others alone I would do that. What I do about slavery and the colored race, I do because it helps save the

#### Is IT GOOD TO THINK ABOUT ANY LEGAL ISSUES FOR THE NEW YEAR?

Without specifics about yourself I'll make this answer generic in a personal and in a business sense.

I presume you looked at your financial estate planning (401k, mutual funds, stocks and bonds, life insurance, etc) and as you do you also think about your legal estate planning. After all you are a year older; you may have gotten married, had a new child,

had a child reach the age of majority (19 years), gotten divorced or suffered the

death of a spouse or even a child. You may have a child graduate, enter the workforce and be off your payroll. Even if the child is off your payroll you may keep them on your health insurance until they reach age twenty-six (26) as a buffer or necessity if you still have a family plan but it may be that you decide not to continue to carry the young adult child if the plan has changed and the cost can drop significantly. Your financial estate planning goes hand in hand with your legal estate planning and you should discuss that with your lawyer, not that he or she will try to advise you on whether your investment advisor is steering you correctly but rather the impact of your financial worth on your legal estate.

For 2022 the gift tax exclusion moves up from recent years to \$16,000.00 a person, as a gift (child, grandchild, etc.) not requiring the filing of a Gift Tax return or up to \$32,000 to a person if both you and your spouse gift to the same person once per year. There is a lifetime basic exclusion and generation skipping tax (GST) limit of \$12.06 million in 2022. There may be a tax advantage for the wealthy in that and if this seems to be something that might be helpful to your financial planning you should seek the advice of an accountant or other tax/ financial professional (may include a tax attorney). For 2021, there was a \$11.7 million total estate tax exemption per individual; 2022 will provide a \$12.06 million tax exemption. The total GST and total estate tax exemption are inclusive in total in that they cannot exceed \$12.06 million The portable portion mentioned above may be available to a surviving spouse who may be able to combine through election their unused estate credit amounts up to a total of \$24.12 million. See your tax professional after the death of the first spouse if your assets are in the millions. Remember that life insurance is considered for estate tax purposes if you have control over the policy (i.e. ability to change the beneficiaries, cancel the policy, etc). Some individuals have large insurance policies and in the past not inconceivable for high middle class people to have an estate over prior limits but the possibility could even exist with some wealthier individuals. If you die in 2022 with an estate of greater than \$12.06 million (or \$24.12 million for a second to die spouse) then that amount over \$12.06 million will be taxed at 40%.

With President Biden and the Democrats in control, there are some items that may well change and as of this writing are speculative. Rather than the annually successive increase from \$12.06 million this year, set to be rolled back in 2026 to \$6 million per individual, it is a distinct possibility that things may roll back earlier; but when and how much is anyone's guess. Other items that have been thrown around include a rollback to \$3.5 million, a 45% tax on amounts greater than whatever the excluded amount is for the year you die or changes to capital gains tax rates.

With that said you need to pull out your Last Will and Testament and review it. If you have had any life changes (marriage, divorce, death, large inheritance, new child, etc.) a new Will may be in order. If you don't have a Last Will and Testament you need to have a lawyer prepare one as soon as possible. Why do you need one? Because if you don't then the State of Alabama has one for you. Some of the spousal examples under the rules of intestacy (dying without a Will); (1) first \$100,000 to spouse and then 1/2 of the remaining estate to the living parent(s) when there are no children, (2) if children then the spouse gets \$50,000 and 1/2 of the rest, (3) if one or more of the children are not yours then the surviving spouse only gets half of everything, period. This is probably not the estate plan you have in mind. There are internet sites and software programs that can also assist with a Last Will and Testament but there is no guarantee that it will pass muster regarding state rules on probate nor a guarantee that it will do what you want upon your death. The best chance of meeting estate goals is through a lawyer and if you are of moderate means, you may be surprised that it is less expensive than you think. In the long run a Will may save money since an intestate estate when probated requires the bonding of the Personal Representative and an inventory of the decedent's estate. I run into too many old or non-attorney prepared defective Wills when it really counts and there is an attempt to probate the estate. Obviously such probate is not without issue. If you have an out of state prepared Will it should be acceptable for probate since under the Full Faith and Credit Clause (Section 1, Article 4) of the United States Constitution a valid Will prepared in one state is valid in Alabama. There can be issues so a review with an Alabama attorney is always a good thing to do.

Aside from the Last Will and Testament, you may want to have a Power of Attorney prepared, both one for financial reasons and health. Most prepared these days are durable which require wording that the power of attorney is effective even in your disability or incapacity. Financial Powers of Attorney became a statutory form as of 1 January 2012. Most attorneys have concerns about the filling in the blank and initialing choices format and most now insert tried and true language used in their practices for their many years. A financial Power of Attorney is now by default a Durable power; however I insert the needed language anyway to make sure that there are no questions about it's durability. A Power of Attorney (POA) can be very powerful and placed in the wrong hands can be damaging such as a daughter that is named AGENT and decides to sell your lake house and push you towards moving to an assisted living facility. On the other hand, naming a trusted AGENT and retaining the POA for future needs can be extremely beneficial. The POA can be used so that someone can write your bills for you during incapacity, file your taxes and with health/ Health Insurance Portability and Privacy Act (HIPAA) provisions monitor your care with the doctors and hospital as well as handle medical insurance billing. The POA may also be used to nominate whom you would want as a conservator or guardian should one need to be named for you through a Court proceeding. A health care power of attorney can be used to coincide with the Advance Directive mentioned below should you have need to name another or others to help with health care decisions.

The final personal document would be an Advance Directive for Health Care, which is composed of a Living Will and Health Care Proxy nomination. It will allow you to make certain decisions about end of life issues should you later become unable to speak for yourself and two doctors have determined that you will likely die in the near future. This is the document that Terri Schiavo DID NOT have and for that reason the court found the testimony of the "husband" who was then living with another woman to be credible as to Terri's final wishes. Hmmmmm. Naming a Health Care Proxy is the same as naming a health care power-of-attorney such as under a POA. The proxy is given limited rights under which situations that they can make decisions. And by the way, the ex-spouse automatically loses that job as proxy upon divorce. That's dodging a

If retirement is nearing and you will also receive Social Security, consider that the 2022 Medicare Part B will move from the 2021, \$148.50 to \$170.10 per month dependent on whether the senior is subject to the statutory "hold harmless" provision. With higher income brackets so does the cost for Part B increase. If you need nursing home (skilled nursing) care under Part A, days 1-20 are fully covered provided you continue to meet Medicare's requirements for those days; the co-payment for days 21-100 (if you qualify) will be \$194.50 per day (\$185.50 per day in 2021). After day 100 you are 100% on your own unless you have some other means of long term care payment. If you have not already checked on long term health care insurance you should do so now. It not only will cover nursing home care but can also cover assisted living or in home care. If you consider this insurance also look carefully at the options since they may be equally as important as the policy itself. This includes inflation increases which are very important or even the option of continued coverage for a certain amount of time when one with "forgetfulness" forgets to pay the premium.

With the exception of a few states and the District of Columbia, the individual mandate under the Affordable Care act (Obamacare) was changed in 2019 to zero. That of course continues to be contentious in that without the mandate it is argues that the ACA is null. Four states and the District of Columbia have state mandate penalties though Vermont has no penalty attached to their mandate. The time to make health care changes under the ACA is extended for open enrollment until 15 January 2022 and unless you have a qualifying event or become eligible under Medicaid/ CHIP after the open enrollment period passes this will be the last opportunity until the 2022 period begins in November. Older Americans may be eligible both for Medicare and Medicaid and impoverished Americans may be Medicaid eligible when they cannot afford premiums under Obamacare and some Americans are eligible for insurance from the market place with subsidized premiums.

If you are currently in business or considering a business, what about entity? A sole proprietorship offers pass through taxation but no limited liability. Your personal and business assets are at risk in a lawsuit. A Limited Liability Company (LLC) or a Registered Limited Liability Partnership (RLLP or LLP) offers the same pass through tax advantages as well as limited liability. A "C" corporation offers the same limited liability but there is taxation on the corporation and taxation on the shareholders. If you are in one of these entities and about \$80,000.00 plus salary talk to your accountant about the possibility of an "S" corporation election. Current tax considerations suggest that pass through entities not involved as professional service businesses (accountants, attorneys, etc) such as sole proprietorships, LLC's, LLP's and S corporations may take an additional significant percentage off their income. Because pass through entities are taxed at the owner's tax rate this will give an additional percentage decrease in taxable income.

In addition to the advantages of pass through taxation and limited liability there may also be some self-employment tax advantages since some of the income can be paid to a shareholder-employee as a profit distribution. The Internal Revenue Service however looks for Shareholder-Employees that pay themselves substandard salaries for their position in order that they can take more from the company as a distribution and save more on Self Employment taxes. The IRS will consider a reasonable income based on IRS summarized factors considered by a Court case from the Eighth Circuit, which advised shareholders to give them careful consideration in establishing their compensation.

The factors are:

- (1) Employee qualifications;
- (2) The nature, extent, and scope of the employee's work;
- (3) The size and complexity of the business;
- (4) Prevailing general economic conditions;
- (5) The employee's compensation as a percentage of gross and net income; (6) The employee-shareholder's compensation compared with distributions
- to shareholders; (7) The employee-shareholder's compensation compared with that to non-
- shareholder employees or paid in prior years;
- (8) Prevailing rates of compensation for comparable positions in comparable concerns; and
- (9) Comparison of compensation paid to a particular shareholder-employee in previous years where the corporation has a limited number of officers.


An "S" Corporation election only exists through the IRS and has specific requirements. So you can be an existing LLC, C Corporation, etc. but elect via the IRS as an "S" Corporation. Ask your accountant about whether it is right for your business.

Mary: Yes Excellency.


Solomon: Very well Mary, go forth in Peace and I pray to never see you again in this court under such circumstances.







### We Lost Some Good Ones in 2021

We lost some good ones this year. We lost our oldest past governor, John Patterson in June. Governor Patterson passed away at age 99 at his ancestral home in rural Tallapoosa County surrounded by his family.

Patterson was Governor from 1959-1963. He defeated George Wallace in the 1958 Governor's Race, which featured a field of 14 candidates. He is the only man to beat George Wallace in a governor's race. Patterson was Attorney General of Alabama prior to being elected Governor. He subsequently was appointed to the Court of Criminal Appeals by Wallace and was reelected numerous times and retired as a Judge of the Alabama Court of Appeals. He was a treasure trove of Alabama political history. He was Governor during a turbulent time in Alabama history.

Former Alabama Attorney General Jimmy Evans died in February at 81. Evans was a native of Montgomery and was Montgomery County District Attorney prior to being elected Attorney General.

Retired Alfa lobbyist Milton Parsons passed away in March at 91. Milton was renowned on Goat Hill as a straight arrow and straight shooter. He was an honest, trustworthy, Christian gentleman. He was Alfa's chief lobbyist for 50 years. He was a devoted family man and devout Christian.

Former Troy mayor, Jimmy Lunsford died in May at 78. He was mayor of Troy for 30 years. Economic development was his forte. He was a tremendous steward of the city's finances. He left Troy in good shape financially.

Former Mobile congressman Sonny Callahan passed away at 88 in late June. He was one of a long line of popular and effective congressmen from the first district. The list includes Frank Boykin, Jack Edwards, Jo Bonner, Bradley Byrne and Sonny. Congressman Callahan served 10 terms in the U.S. House of Representatives. Prior to his two decades in Congress, he served in the Alabama



## And Then There Were Two ... Bama Faces Georgia in Title Game

The Tide prevailed against The Cincinnati Bearcats 27 – 6 in the New Year's Eve Cotton Bowl in Dallas Texas.



With a whole lot of hoopla, Cincinnati trash talking and a little uncertainly the game would come off due to another rise in Covid outbreaks, we were treated to yet another amazing victory by the Alabama Crimson Tide. The Tide 2.0 featured a rejuvenated offense line and a running attack that was powerful and relentless. This was certainly not expected by me, and, obviously, the Bearcats, as well. It's not surprising the fashion in which 2021 finished. There were cancelled bowl games, last moment replacement teams in bowl games, and lots of COVID to go around.

Brian Robinson rushed for 408 yards, the most by any Alabama player in a bowl game. The fifth-year senior has rushed for 1275 yards, averaging 5.1 yards per carry this season, so far. Robinson is quite a story, patiently waiting his turn as the starter. He carried the ball 249 yards this season, bearing most of the load for Bama's run game. A significant change from the 91 carries in 2020, playing behind Najee Harris. Robinson had 14 touchdowns on the ground and caught 31 passes for 268 yards, which included 2 touchdowns.

Robinson was quoted after the game:

"We just know how to fight, man," the fifth-year senior said, via Tuscaloosa News. "We know how to fight 'til the end. We know how to come together as a team, as a unit. Man, we're just warriors. We fight until the end with everything we do. That's why we're going to win the natty — repeat."

The Tides offensive line had a dramatically improved outing against the Bearcats. I think they challenged themselves to be the Tide OT that we are accustomed to seeing.

Heisman Trophy winner Bryce Young and company were successful moving the ball through the air, producing 181 yards and three touchdowns. While watching, it was apparent the running was very effective, so stick with it.

And all of this must be prefaced of course; we are living through an amazing time in Alabama Football History since Coach Saban arrived on the scene to coach the Tide 15 years ago [today], January 3, 2007.

In the telling of the Cotton Bowl, obviously it's important to concede; much to the chagrin of some fans, that it's difficult to grasp the complexities of a successful college football program. Believe it or not, that's one of the reasons there are press conferences after each game.

Sometimes the questions just aren't very good.

I understand that coach Saban, Bill O'Brien and his team created this specific offensive package for the Bearcats defense, to exploit their defensive configuration, and the Cincinnati team just could not adjust to this "new look" Tide running attack.

Alabama has morphed from its "quick strike" offensive under offensive coordinators Lane Kiffin and Steve Sarkisian to a more moderate passing attack under O.C. Bill O'Brien. I think Alabama's offensive change is dictated more by injured personnel than philosophy at the moment.

Remember Alabama lost 11 players from last year's class. And there have been injuries to some of the starters on the offensive line. We lost right guard Emil Ekyior; additionally, the right tackle was lost late in the game as well. These are just from the Cotton Bowl. The good news is that Coach Saban is expecting some of the walking wounded back to play in Title game.

While the Crimson Tide's passing game has been hugely successful, if the Tide is able to run against Georgia, this will absolutely change the metrics of the game.










A Brief History of the Academy (excerpt)

The Academy of Honor was created by the state of Alabama "to bestow honor and recognition upon living Alabamians for their outstanding accomplishments and service." The bill establishing the Academy was passed in the 3rd special session of the Alabama Legislature in 1965 and signed into law by Governor George Wallace on October 29, 1965 . . . Three years passed before the Alabama Academy of Honor was formally organized . . . The law creating the Academy stipulated that all governors would automatically be considered elected to membership. Up to one hundred additional members

could be elected, but the number of members "from the political field" was limited to no more than twenty-five

Due to Covid concerns, a ceremony to induct the Class of 2020 was not held. Instead, it was combined with the 2021 Induction Ceremony, which occurred on Thursday, December 9, 2021, in the Alabama Ballroom of the Renaissance Hotel in Montgomery. Even before the pandemic, however, worship attendance was dropping rapidly across the USA. Regular weekly worship attendance is down from 45% in 1993 to 27% in 2020. I have also seen our church family on a regular basis joyfully come around people and families to celebrate

a birth, a wedding or some other important milestone. Conversely, I have also know many people who have no church family and en suffer alone through a tragedy, a crisis or a death. It is so sad to w this, but it happens all the time. I honestly do not know how people make it through crisis, tragedy and loss without a loving church family around them. They do not know what they are missing. But it doesn't have to be that way.

God designed us to do life together in a community of faith. Please prayerfully consider engaging in worship and connecting with a family of faith if you do not already have one. And if you have a church family but rarely attend, then make it a priority to re-engage. You are needed and you need them too. More than you may know!

#### PLANT OF THE MONTH CHRISTMAS CACTUS -A new year with new beginnings and hopefully a year we see Covid in our rear view mirror. My sincerest wish is for each and every one of

you to experience a happy and prosperous 2022. Back in the garden, there some things we all need to take care of. If you have chilled tulips for 4-6 weeks, go ahead and plant them this month either

in pots or in the garden beds. A good technique, which I have mentioned in the past, is over planting tulips with pansies, dianthus or even dusty miller. The effect is quite stunning with a ground cover of low flowers and the spiked look of the upper tier of the tulips. This garden design of over planting can be used in the beds with low annuals and over planted with taller flowers

such as Gaura. Overplanting with the shorter flowers and taller ones is also great for very formal beds. Daffodils and other bulbs can be planted now, again

in outdoor pots, in beds or in naturalized areas. I prefer to naturalize the daffodils outside of the flowerbeds. All looks beautiful during their bloom cycle, but when they die down, the leaves turn yellow and brown for about a month. One must remove the blooms but allow the leaves to die back in order to feed the bulbs for next

year's blooms and to assist in the bulbs multiplying. If the yellowing leaves are trimmed back (as they are unsightly) next year's blooms will be stunted.

### Southern Gardening Potpourri for January

The Christmas Cactus is a succulent and a cousin to the cacti that thrives in the deserts. They bloom for long periods of time around Thanksgiving and Christmas indoors with some of the most exotic blooms in nature. It is truly a plant that keeps on giving. They are easy to propagate either rooting in water or in potting soil. To speed the process, which normally takes about 2 weeks, the

cuttings should be placed in a sunny window. If you are propagating in soil, take a cutting where there are knots or calluses and plant it in the soil and water until slightly moist. They prefer a drier environment. Do not over water or let the soil get too soggy as the stem will rot rather than root. They are peculiar in that they like to have crowded roots or what we would call root bound and love clay pots since these are porous with good air circulation. In addition to the moist soil, they love misting from a spray bottle and watering only at the base of the plant. To keep the plant with continuous bloom, be sure to deadhead all of the spent blooms. People keep Christmas Cactus year round mainly for their interesting leaf structure.

#### **Captain Nimrod Thompson Frazer (92)**

Captain (Cpt) Lt. Nimrod Thompson Frazer served three years in the U. S. Army including the Army National Guard and the regular Army with service in Korea during the Korean War. His Military Occupational Specialty (MOS) was Tank Platoon Leader. His military decorations, medals, badges and commendations included the Silver Star given for his gallantry in action, a Presidential Unit Citation and the Parachute Badge. He received a letter of appreciation from Kim Dae-jung, President of the Republic of Korea.

Cpt Frazer was born in Montgomery, AL, December 10, 1929 to his parents, William Johnson Frazer and Margaret Frazer. He attended schools in Montgomery and in Wilcox County, AL, graduated from Wilcox County High School in 1948. He attended Huntingdon College in Montgomery, AL, and left college in December of 1950 to join the Alabama National Guard when it was called to active duty. After Basic Infantry training at Fort Jackson, SC,

he attended Officer Candidate School at Fort Knox, KY. He was commissioned 2nd Lieutenant on February 14, 1952 before assignment to the 82nd Airborne Division and the 44th Tank Battalion at Fort Bragg, NC. He volunteered for Korea and served there for ten months with the 140 Tank Battalion.

After leaving the Army, he served in the Army

National Guard in the Special Forces. He was discharged September 20, 1953 and then returned to service in the AL Army National Guard. Returning to civilian life, 2nd Lt. Frazer used the G. I. Bill and resumed his studies at Huntingdon College and graduated with a B.S. Degree in Business in 1953. He resumed his military service rejoining the AL Army National Guard and was promoted to Captain in the 20th Special Forces. He also used the G.I. Bill in attending Columbia University and then in earning a Master of Business Administration from Harvard University in 1956.

Cpt Frazer has had a long and successful career in investment banking, continuing even until now in 2021. He began his career working with the brokerage firm, Sterne Agee and Leach, followed by working with Thornton, Farish and Gauntt, an investment banking firm. In 1976, he cofounded the investment banking company, Frazer Lanier Company, with Clifford Lanier, Jr. Then, in 2008, Cpt Frazer formed a real estate brokerage, The Jobs Company LLC, in which he continues his success located in the historic Union Station building in the heart of Montgomery, AL.

Cpt Frazer and his wife, Lee Martin Frazer, have five children, nine grandchildren and two great-grandchildren. He is modest and is hesitant to talk about his achievements and honors. He received an honorary degree, the Doctor of Humane Letters from Huntingdon College May 14, 2000 which is given to those who have distinguished themselves through humanitarian and philanthropic contributions to society. He was recognized as a Senior Warden by St. John's Episcopal Church in 1996. He received the Distinguished Service Award from the Alabama Historical Commission and the Mary Ann Neely Historic Preservation Award from the Landmarks Foundation of Montgomery, AL in 2018. The Daughters of the American Revolution awarded him its highest decoration, the Congressional Medal of Honor. The University of Alabama named him to the Alabama Business Hall of Fame, and Marion Military Institute named him to the Alabama Military Hall of Honor.

Cpt Frazer's conclusions about his military service are, "The Army taught me how to manage people and to lead people." His family has a rich heritage of patriotic service to their country. His brother served valiantly during WWII, and his father, Sergeant William J. Frazer, served with the 167th Infantry Regiment with the 42nd Division during WWI earning a Purple Heart at the battle of Croix Rouge Farm in France.

Cpt Frazer has written two books about WWI. He described the Rainbow Division's heroism in his book, Send the Alabamians: WWI Fighters in the Rainbow Division, published in 2014, and The Best World War I Story I Know, published in 2018, describing the grit and determination the 35th, 1st and 42nd Divisions doughboys. In addition, he has provided the funding for the acquisition and erection of sculptures of two WWI soldiers: the Rainbow Soldier and the Return from the Argonne, at the Union Station in Montgomery where Alabama Infantry in the 31st Dixie Division and mostly African-American soldiers in the 366th Infantry Regiment of the 92nd Division who fought in the Argonne had departed from this train station to join the Rainbow Division. He funded another such sculpture of WWI Pilots, the Daedalous, which was erected at Maxwell Air Force Base, and there he was awarded the Legion of Honor, France's highest honor, August 27, 2017. This medal was given because of his efforts to keep alive the memory of French and American soldiers who fought and died in WWI and for commissioning a memorial to the Rainbow Division near Chateau Thierry. He funded the Jim Butler monument of the Rainbow soldier at Croix Rouge Farm at Fere en Tardenois in France.

#### 1st Lt Norma Lynn Lundy (82)

1st Lt Norma Lundy served two years, nine months and 23 days in the United States Air Force. Her Military Occupational Specialty Code was Staff General Duty Nurse.

1s Lt Lundy was born March 4, 1939, to her parents, Alfred Eugene and Margaret Berney in Knoxville, TN, and she was reared with a family of four brothers. During her first five years, the family moved to Birmingham, Atlanta and Montgomery while her father worked as a typewriter repairman. After WWII, her family moved to Montgomery where she was reared and educated. She attended Chisholm Elementary School, Capitol Heights Junior High School, Lanier High School and Robert E. Lee High School. Her family then moved to Memphis, TN, where she graduated from White Station High School in 1957.

At Memphis, a friend took her to visit St. Jude's Children's Hospital and this visit had such a dynamic impact upon her, she decided to become nurse which resulted in her achievements in pediatric and geriatric medical care. She graduated from Jefferson Davis Hospital School of Nursing at Houston, TX, in 1964. For one year, she worked in pediatric research at Texas Children's Hospital in Houston where she took care of two sets of Siamese twins and many other children including newborn babies who carried the Rubella virus. After working at Mount Sinai Hospital in New

York City, she enlisted in the U. S. Air Force February 13, 1966. Her decision was based upon her many years of having an uncle who was serving in the U. S. Air Force visit her family and share his experiences of traveling worldwide. 1st Lt Lundy's three-month basic training was at Gunter Air Force Base

(AFB), AL, followed by assignment at Amarillo AFB, TX, where she worked in a variety of medical areas. While there, she met her husband, John Lundy, and they were married 23 years. They had two children and three grandchildren. He was also an officer in the Air Force, and they were deployed together to Wheelus Air Base, a United States Air Force base located in British-occupied Libya and the Kingdom of Libya. At one time, it was the largest US military facility outside the US. It had an area of 20 sq. miles on the coast of Tripoli. They lived in a WWII trailer measuring eight feet by 35 feet on the beach of the Mediterranean Sea.

1st Lt. Lundy became pregnant and then delivered a baby in a U. S. military hospital in Weisbaden, Germany. Because the military at that time would not allow females in the military to remain in service if they had children while serving, she was forced to resign from military service December 3, 1968. With tears in her eyes and a quiver in her voice, her reflections upon her are military service are, "I knew that I could make a contribution to the well being and to the lives of the people who serve. Once I discovered nursing, it was a natural avenue that I could go do that. When I took care of those Airmen torn up from serving in Vietnam and the pilots who crashed in the desert in Libya, I knew that I was doing good for the country. I was inspired to be a nurse without even thinking about the fact that it could be my avenue to go and see the world. I got to see all of the Middle East. Holland, Germany and Spain. I was interested in other cultures and how people lived."

After leaving Libya, 1st Lt. Lundy's husband was transferred to Malmstron AFB, at Great Falls, MT, for four years followed by assignment to Little Rock AFB, AR, for four years, and then to Sheppard AFB, TX, TDY in the summer of 1974. While in AR, she received a B.S. Degree in Gerontology from the University of AR at Little Rock. Her husband's next assignment was to Elmendorf AFB, AK, for 10 years. This move to Anchorage, AK, proved to be a major turning point in 1st Lt Lundy's life because this is where she resumed her career in the medical field and started working in community care for the aging. She worked for the city of Anchorage as the Director of Senior Citizens Programs.

Using a federal grant of \$10,000, she completed certification as a Gerontological Nurse Practitioner from the University of Washington in 1985. 1st Lt Lundy's 13 years in gerontology encompassed first working at Anchorage Pioneer Home, one of five Pioneer Homes serving older adults in cities in Alaska. She worked with a gerontologist-physician for 12 months. She opened a private practice and served as a nurse practitioner at the nursing home, Mary Conrad Center. She served as the Medicaid Commissioner for the state of Alaska and opened a new nursing home in Anchorage. She did what needed to be done for senior adults in Anchorage for seven years.

1st Lt. Lundy went to Kauai, Hawaii, to teach staff at Wilcox Hospital how to take care of nursing home patients for three months. She went to Honolulu and became the Vice President of Long Term Care for the State of Hawaii. This was a private corporation for a lobbying group for all of the hospitals and nursing homes in Hawaii. She traveled to every Hawaiian Island and taught geriatric nursing at each nursing home for a year. In 1991, she returned to Kauai working as nurse practitioner at Wilcox Hospital Long-Term Care, but Hurricane Iniki struck Hawaii. It was the most powerful hurricane to ever strike Hawaii. She was involved in the evacuation of 90 nursing home patients and their care, and for six weeks, there was no running water or electrical power.

In 1995, 1st Lt. Lundy moved to Pensacola, FL, to work as the geriatric nurse practitioner in the skilled nursing unit at the West FL Hospital for two years, and this permitted her to come to Montgomery, AL, to care for her terminally ill mother on the weekends. Then she traveled for six months across America visiting friends, and she remained in San Diego for one year. She returned to Hawaii working as the resident case manager at the assisted living facility, The Ponds at Punalulu, on the northern shore of Oahu. She then worked for Wilcox Hospital at Kawaii in quality medical review, and then she worked setting up four out-patient clinics as project creator and director for chronic disease retiring in 2004.

1st Lt. Lundy spent several months traveling across America and then went to England where she lived six months at the Tara Kadampa Buddist Center at Derbyshire where she shared in cleaning, teaching classes, sewing and meditating. She moved to Atlanta, volunteering at the Atlanta Area Agency on Aging, followed by working part time there for four years. She dealt with aging disability resource managing four years retiring completely in 2010. She then moved to Pennsylvania to assist in caring for her grandson for five years. She moved to Pensacola for five years and then back to Montgomery where she now resides.

The remarkable woman has significantly contributed to the improvement of medical care for the eldery and has provided leadership in medical facilities wherever she has been.

#### **Staff Sergeant Ronald Urquhart (62)**

SSG Ronald Urquhart served in the United States Army on active duty for three years and in the Alabama Army National Guard for 21 years. His Military Occupational Specialty (MOS) was radio teletype operator while in the Army and field lineman in the Army National Guard. His medals, awards and decorations include: Marksman (Rifle) and Marksman (grenade).

SSG Urquhart was born in LeGrand, AL, June 23, 1959, to his parents, Howard and Gussie Mae Urquhart. He was reared in Ramer, AL, and leaving high school, he volunteered to serve in the U.S. Army at the age of 17.

SSG Urquhart's military service began June 7, 1977, and he completed induction at Ft. Jackson, South Carolina, followed by eight weeks of Basic Training at Ft. Gordon, GA. He completed a 12 week self-paced course in radio-teletype operator in seven weeks. He served at Ft. Hood, TX, including a three month TDY deployment to Stuttgart, Germany, until he was discharged June 6, 1980.

After about one year, SSG Urquhart reenlisted in military service and in the Alabama National Guard. He served two weekends monthly in the Montgomery, AL, area and two weeks each summer mostly at Camp Shelby, MS. SSG Urquhart earned his GED in 1985 and

then used the G.I. bill for one year at Alabama

Christian College (Faulkner University) in preparation for later becoming an x-ray technician. During this time, he was working at night as an aide in the x-ray department at the Baptist South Medical Center in Montgomery, AL. At this same medical facility, SSG Urquhart completed two years of training to be a registered x-ray technician in 1990 and continued working there. Next, in September 1993, he worked in giving CT scans at the Montgomery Cancer Center. In 1995, He completed further training for one year at Chattanooga State Community College in Chattanooga, TN, to become a licensed radiation therapist. He has worked as a radiation therapist for almost 28 years at the Montgomery Canter Center. SSG Urquhart's conclusions about his work with cancer patients are, "I love it. I get to meet a lot of people. When I go to work, I know that I am getting to help a lot of people. It is so rewarding to see people when they return saying that they are well."

SSG Urquhart and his wife, Cheryl, have been married for 33 years, and they have two children and one grandchild. They enjoy traveling and also watching movies at home. They have been members of the United Faith Christian Church in Le Grand, AL, where he has served as a deacon. He exercises by jogging and walking daily.

SSG Urquhart's reflections upon his military service are, "It was a pleasure to serve. I learned a lot of things in the Army. It helped me to grow up real fast as I was very immature when I enlisted. The camaraderie and friendships helped me to learn to depend on other people. If I had to do it over again, I might change a few things, but I would have definitely made the military my career. I have no regrets. Being in the military gives benefits such as being able to use the Maxwell Air Force Base, the VA Out-Patient Clinic and insurance discounts for veterans. Looking back, I can say that I am proud to have served in the military." #end#



#### Petty Officer 1st Class Lynn W. Jinks, Jr. (100)

Petty Officer 1st Class (PO1) Lynn W. Jinks, Jr. served five years in the United States Navy during WWII. His occupational specialty (MOS) was Navy Air Controller. The flights of incoming and outgoing aircraft from U.S. naval bases were controlled by Tower Operators. PO1 Jinks was involved in U. S. Naval combat to liberate islands from the Japanese in the Pacific Theater.

PO1 Jinks was born January 10, 1922 in Union Springs, AL, to his parents, Lynn W. Jinks Sr. and Clarice Peddy Jinks. He was reared there and graduated from Union Springs High School in 1939. Shortly after the Japanese attack on Pearl Harbor on December 7, 1941, he volunteered for military service and served in the United States Navy at the Naval Air Station in Pensacola, FL, at the Naval Air Station in Long Beach, CA, and in the Pacific Theater on the Palawan Island in the Philippines during WWII. The battle to take the Island from the Japanese was at a hostile site with a Naval task force of cruisers and destroyers from the 7th Fleet. He worked in the control towers as a control tower operator at the Naval air stations and bases. He was discharged in 1946. Using the G.I. Bill, PO1 Jinks graduated

from the University of Alabama Law School, became a member of the Alabama Bar Association September 15, 1949 and practiced general law in Union Springs, AL, for 50 years including assisting the Bullock County

prosecutor for several years retiring in 1991.





PO1 Jinks was married to Beth P. Jinks for 53 years until she passed away. They had three children, five grandchildren and six great-grandchildren. He has been a member of the Union Springs United Methodist Church. He and his wife, Ruby R. Jinks, have been married 33 years. She served as his Office Administrator in his law practice office for many years. After his retirement, they moved to Montgomery, AL, where they have lived for 26 years.

PO1 Jinks' conclusions about his military service stating, "I was proud to serve." His wife, Ruby, adds that she would like future generations to remember him as being a

good person.



#### **Person Appointments Re-Entry Plans**



SSA is taking steps to increase in-person help for people unable to complete their business online or by phone. SSA continues to increase in-person appointments for limited, critical issues, and to hold voluntary hearings by online video and phone. During much of the pandemic, offices have been open only for in-person appointments for limited, critical situations, depending upon local office conditions. These measures have helped

to protect the health and safety of employees and the public. During this time, SSA has continued to offer many services on its website

that are secure and easy to use. Additionally, representatives continue to help people by telephone when they call the National 800 Number and local offices.

SSA recognizes that many underserved people face barriers to service when they are unable to access or use the internet or telephones to get the help they need. Therefore, if you know someone who cannot use the online services at www.ssa.gov, please encourage them to call and speak to a Social Security representative. They can call their local Social Security office or the National 800 Number for assistance. If SSA cannot help by phone, the representative can determine if an in-person appointment or other option might be available.

The public can call the National 800 Number at 1-800-772-1213 between 8:00 a.m. - 7:00 p.m., Monday through Friday. Wait times to speak to a representative are typically shorter Wednesdays through Fridays or later in the day. We also offer many automated telephone services, available 24 hours a day, so you do not need to speak with a representative.

Please note that we are upgrading our National 800 Number system. During this transition, you may experience longer wait times. We sincerely apologize for any inconvenience and we appreciate your patience while we work towards a new, more modern phone service.

If you're deaf or hard of hearing and use TTY equipment, you can call our TTY number at 1-800-325-0778.

#### **2022 Social Security Benefits Increase**



Approximately 70 million Americans will see a 5.9% increase in their Social Security benefits and Supplemental Security Income (SSI) payments in 2022. Federal benefit rates increase when the costof-living rises, as measured by the Department of Labor's Consumer Price Index (CPI-W).

The CPI-W rises when inflation increases, leading to a higher cost-of-living. This change

means prices for goods and services, on average, are more expensive, so the cost-of-living adjustment (COLA) helps to offset these costs.

We will mail COLA notices throughout the month of December to retirement, survivors, and disability beneficiaries, SSI recipients, and representative payees. If you have clients who would like to know their new benefit amount sooner, they can securely obtain their Social Security COLA notices online using the Message Center at www.ssa.gov/myaccount. They can access this information in early December prior to the mailed notice.

If your clients prefer to access their COLA notices online, they can opt out of a mailed COLA notice. They can do this with their personal my Social Security account. By updating their Preferences in the Message Center, they can opt out of any other notices that are available online. They can also receive a text or email alert when there is a new message waiting for them. A person must have created their account by November 17, 2021 to receive the 2022 COLA notice online. Your clients can find more information about the 2022 COLA at www.ssa.gov/cola.

January 2022 marks other changes that will happen based on the increase in the national average wage index. For example, the maximum amount of earnings subject to Social Security payroll tax in 2022 will be higher. The retirement earnings test exempt amount will also change in 2022. 



## Southern Cuisine

I hope you and your family had a wonderful holiday and were able to celebrate Christmas with your loved ones. This time of year is all about tradition.

With Covid still lingering, busy schedules, and just life in general, some families extend their get-togethers into the New Year. If you are like me, you have fond memories of baking pies, giving of presents, or having a meal with your friends and family. All of this demands planning to make Christmas a memorable event. Did you prepare the traditional meal that you have every Christmas? What was the centerpiece this year? This is a very important decision, and it set the tone for the entire evening. Once you decided on the main course, there are hundreds of side dishes, appetizers, and casseroles to include and do not forget the refreshments. Instead of the common baked turkey, try

wrapping it with bacon. Try a cauliflower gratin instead of potatoes. Is it going to be a bacon-wrapped turkey or bacon wrapped scallops? Most likely, your family has already gathered so perhaps this column can help you prepare for the next big family meal, such as Easter!

I did not follow tradition this year. It's fair game for you to prepare what ever you want and you do not have to check and make sure that the side dishes go with your main course. Instead of game go with seafood as a main dish or an appetizer. These suggestions are for side dishes. And can be served as a main dish or side dish at the pre-celebration meal. This is the meal that you eat while you are preparing the main meal, and it keeps people out of the kitchen while you prepare the main courses. After all, as a good host, you have to feed the stay over guests.

We will start with a simple side dish that will go will any main dish you to prepare – a baked vegetable that goes with any meat.

#### Asparagus Rollup

#### **INGREDIENTS:**

- 24 thin asparagus spears (about 1/2 lb)
- 4 slices applewood smoked deli ham (about 6 oz)
- can (8 oz) refrigerated **Crescent Rolls (8 cnt)**
- 1 pkg (5.2 oz) Swiss cheese 1 tsp olive oil

#### **METHOD:**

- 1. Heat oven to 375°F. Line large cookie sheet with cooking parchment paper, or spray with cooking spray.
- Remove woody ends from asparagus spears; discard. In 10-inch skillet, heat 1/2 inch water to boiling. Add asparagus; reduce heat to mediumlow. Cover; simmer 2 to 3 minutes or until crisp-tender. Drain. Plunge asparagus into bowl of ice water to cool; drain on paper towels.
- 3. Cut ham slices in half; wrap one half slice around middle of 3 asparagus spears. Repeat for remaining ham and asparagus spears.
- On large cutting board, unroll dough; separate dough into 8 triangles. Crumble and press a generous tablespoon of cheese onto bottom wide end of dough. Place one asparagus and ham bundle on wide end of dough, and roll
- dough into crescent shape; place on cookie sheet. (Ends of asparagus will stick out of both ends of dough.) Repeat for remaining bundles. In small bowl, mix breadcrumbs, Parmesan cheese and olive oil; mix
- well. Sprinkle on top of crescent dough, pressing lightly to stick. Bake 14 to 19 minutes or until deep golden brown. Remove from cookie
- sheet to serve.

The next recipe can also feed the stay over guests but not fill them up. It is a more filling dish and can be assembled by the guests. It does require some preparing such as either frying or baking the main ingredient. But tacos can be simple to prepare and easy to eat. This dish also comes with a special sauce.

#### Fish Tacos with Sauces

There are as many ways to make fish tacos as there are recipes for tuna salad. This recipe uses breaded fish fillets and is baked. You can also use breaded catfish deep fried. And another variation is to use flour tortillas

#### **INGREDIENTS:**

Fish fillets, any kind you like (easiest is breaded so you only have to bake them.) 1 dzn corn tortillas (3 per person)

Vegetable oil

Jicama Salad Mango Salsa



**Iceberg lettuce shredded Baja Sauce** Avocados, chopped in small squares & lightly covered with lemon juice

#### **METHOD:**

- 1. Prepare the Mango Salsa Prepare the lettuce and avocado. Thinly slice lettuce. Put in a small serving bowl. Sprinkle with cider vinegar (about a Tbsp) and salt (about a tsp). Mix in the vinegar and salt. Peel avocado and remove seed. Chop and reserve for later.
- 2. Heat the tortillas.
- 3. One way to easily soften and heat a tortilla to simply heat it in the microwave for 20-25 seconds on high heat, on top of a napkin or paper towel to absorb the moisture that is released. Set aside.
- Cook the fish. Depends on the type of fish either fresh fillets or breaded, just follow your favorite method or manufacturers recommended
- Assembly: Spread a little Baja sauce on warm tortilla, then a little lettuce Add fish and top with Mango Salsa.
- Serves four.

#### These tacos are better with the Baja sauce.

#### **INGREDIENTS:**

- 12 oz mayonnaise
- 12 oz sour cream
- 1½ cups cilantro leaves
- 6 jalapenos, seeded and chopped 3 avocados, use pulp only
- 3 Tbsp fresh lime juice

#### **METHOD:**

- 1. In a food processor, blend cilantro and jalapenos Add remaining ingredients and blend
- Keep refrigerated until serving

Here's another "snack" to keep the guest busy and out of the kitchen, unless they help.

#### Serves 10-20

#### **INGREDIENTS:**

- 2 8oz. packages cream cheese
- 2 Tbsp Worcestershire Sauce 1/4 tsp garlic powder
- ½ small onion, grated
- 3 T. Mayonnaise
- 1/8 t. salt 2 - 3.75 oz. cans smoked oysters,
- Chopped pecans and/or parsley

#### **METHOD:**

- 1. Cream together cream cheese, Worcestershire, garlic powder, onion, mayonnaise and salt. Spread onto a sheet pan lined with plastic wrap about ½ inch thick.
- Chill for an hour.
- Place drained smoked oysters on top of cheese mixture and roll up; then roll into a ball. Roll the entire ball into either the pecans or parsley or a mixture of parsley and pecans.
- 5. Chill 24 hours before serving. Serve with crackers. Freezes well.

The last recipe is added to the menu to keep it "Southern" and to add a different way of serving "greens."

#### Not Your Grandma's Collard Greens

#### **INGREDIENTS:**

- 3 bunches of collards (about 3 lbs)
- 1 onion, diced
- 4 cloves of garlic, minced 1 carrot, diced 2 Tbsp of olive oil
- 2 tomatoes, peeled & diced or 14 oz. can of diced tomatoes 2 chipotle peppers in adobo,

Smoked Oyster Roll

- chopped 1/4 cup of smooth peanut butter
- no sugar added 1 Tbsp apple cider vinegar

#### **METHOD:**

- Thoroughly clean each collard leaf, remove ribs and stems. Tear each
- In a large pot or Dutch oven, saute on medium the onions and carrots in the olive oil, until lightly brown, about ten minutes.
- Add the garlic and cook for one more minute. Add the tomatoes and chipotles.
- Add torn leaves to the pot and add four cups of water.
- Bring water to a boil, and then turn heat down to a simmer.
- Add the vinegar and stir in the peanut butter.
- Cook greens for 1½ hours or until they are the texture you prefer.
- Serve with pepper vinegar or hot pepper sauce such as Tabasco.
