Monday rolled in with clouds and mild winds. With rain to follow in a day or two. So much devastation still remained. Power crews still were stringing. Samaritan Purse was still feeding. Red Cross and FEMA were still assessing damage since the President had declared Selma a Federal disaster area.

One of the team memers slowly rolled down a street in his beat up pickup truck passing strewn vehicles that looked like they had come in third place in a Saturday night Demolition Derby in Dothan during the Peanut Festival.

One lone elderly gentleman, with Einstein hair, ever so slowly reached for a roof shingle on the battered ground. He needed help. Asked if he could use some help, he responded with an exasperated sigh, "yes, you are a Godsend". He explained that he needed to get some meds, which under normal circumstances would be delivered, but now he would have to negotiate the debris piles and closed streets to reach the drug store. For the remainder of the day he let Rotary assist him.

Chimney bricks graced the ground like dead roses. Uncountable glass shards glistened up like kaleidoscopes. Aluminum roofing sheets, from two houses away, wrapped themselves around his barren trees like mangled Christmas bows. The worker volunteers didn't talk much, just nodded occasionally. Then a quiet man from Autaugaville walked by and wanted to help, and did. No explanation of why, he just did. Together the workers toted logs, limbs and

aluminum roofing to the street and piled it up a mile high. After several hours it was time to say good bye. The job was mostly done. The victim stood and spoke to the volunteers at length for the first time. His bushy eyebrows could not hide his despair.

Turns out, this house was his medical office where people had come to be healed for over 40 years. A bit later in the day his office assistant (who was in the structure when the whirlwind came) confided that he was around eighty years old. This was his life. He had a contractor coming in the morning to replace the roof. How he was able to secure one so quickly was quite the story, the first of many. But, his patients came first. He is The local psychiatrist.

He shared histories and stories. He recollected when he listened to Joni Mitchell singing in a dingy bar in Boston. He remembered the chess masters outside "Havad Yad"

(Beantowners don't pronounce the R) taking easy money from unsuspecting freshmen who thought they knew all about the gambit. He harkened back to a time in his childhood when his dad ran a used car dealership in Montgomery and his sometimes mechanic was a crooner named Hank Williams (that's Sr.). The singing ruffian would ply his songs in his father's two bay garage to anyone who would listen. His father would have to drive Williams

to local concerts because he was too soused to get behind the wheel. Once Hank came by their house and his dad wouldn't let his young son shake his hand because he considered the man irresponsible and worthless. But, eventually he returned to his construction story asking about our experience in the field.

In turn, one mentioned, almost apologetically, something about his efforts to restore downtown Montgomery by renovating old abandoned buildings. One, the Segall Ice House was used to mature, house and distribute Chiquita bananas throughout central and south Alabama in the first half of the 20th century. He laughed as he interrupted and told me the story of Samuel Zemurray.

Sam was a Selma citizen, he immigrated from Russia around 1900. He started-out with \$150 and a dream, Sam worked for and became president of the United Fruit Company, the largest and most influential fruit company in the world at the time. Sam, the doctor continued, was so wealthy that he once owned the entire country of Honduras, via a coup he orchestrated by overthrowing the then president. Sam "hand picked" a successor who passed very favorable laws for the banana industry. Thus, the term "Banana Republic" was coined about "Sam the banana man, from Selma".

One final note. The doctor was mentioned he was concerned about getting meds from the drug store. They were for his patients, not for him. He puts service above self. He truly is the Godsend to his community, and to the workers he met that day. Dr Hodo will have his hands full over the next weeks and months helping those struggling with grief, loss and uncertainty. Please pray for him and his family. A True Hero.

### SHELBY'S LAST HURRAH



Richard Shelby's last week as our United States Senator was poetically amazing.

The nation watched as he gave his farewell address to the Senate. His speech was followed by a tribute from his longtime friend Senator Patrick Leahey. Senator Shelby and Senator Leahey from Vermont are best friends and cochaired the U.S. Senate Appropriations Committee together for their final sixyear terms, which ended January 3, 2023. They walked out together after a lasting three decade partnership.

The national media made note of the fact that Leahey, a Democrat, and Shelby, a Republican, were the last vestiges of bipartisanship in Congress. They worked together congruently to get things done for the nation and yes primarily for the states they represented. Shelby, who served 36 years as our senator, retired at 88 last month.

To say that he went out with a bang would be a dramatic understatement. As he was making his farewell adieu speech, he and Leahey were crafting their final federal budget. The budget was passed the next day, two days before Christmas. When the experts discerned the 4,000 plus page document, it revealed that Richard Shelby had again played Santa Claus to the people of Alabama. He not only brought most of the money from Washington to Alabama, practically speaking he brought the entire North Pole and Rudolph and all of the reindeer to the Heart of Dixie as he was walking out the door of the U.S.

The national media dubbed Shelby the "Greatest King" of earmarked procured money for their state in history. Indeed, the amount of federal dollars Senator Shelby brought home to our state as Chairman of the Senate Appropriations Committee is historical. He probably surpassed the previous "King of Pork" for their state, the late Robert Byrd of West Virginia.

In his last hurrah, Senator Shelby appropriated a mind boggling \$660 million of extra earmarked dollars to our state. Folks, that is quite an amazingly, unfathomable, incomprehensible, Christmas gift for our state.

As I was exchanging Christmas greetings with a state senator who is a close friend, I commented about Shelby's departing \$660 million Christmas gift to the state. He quietly commented, "Flowers, that is over 25 percent of our entire state General Fund Budget." However, if you dig deeper into the federal budget that Shelby passed, his \$660 million is also met with upgrades of funds Shelby allocated in previous years to amount to \$4 billion. That is more

than the entire State of Alabama's annual budget. Every part of Alabama was showered with Shelby's gifts, which will make generational changes to our

In Huntsville alone Shelby has played a pivotal role in shaping this Tennessee Valley area into the science, space, and technology capital of the south, if not the nation. In his final hurrah, the Huntsville Redstone area received funds for Army research weaponry, a space launch system, nuclear thermal propulsion for the Marshall Space Flight Center, construction of a new FBI Headquarters, which Shelby moved from Washington to the Redstone Arsenal in Huntsville, and several other new buildings at the Redstone Arsenal.

Shelby earmarked a great deal of federal money for his home area of Tuscaloosa including millions for new buildings and education centers for the University of Alabama, funds for a new bridge, and millions for the Tuscaloosa airport.

He took care of the Montgomery/Wiregrass area, which is military laden for years to come. This area received multi-millions in new money for Ft. Rucker for flight training and Air Surface Missiles, along with millions for the Hellfire missiles made in Troy.

There is over a billion dollars going to UAB for biomedical research and new buildings. Shelby has been instrumental in transforming UAB into one of the most pronounced medical research institutions in the nation.

He took care of Mobile for generations to come. There are millions of earmarked funds going to the Port City. In addition, Shelby completed his mission of building Alabama a new deeper and wider Port with a \$200 million dollar appropriation for the Alabama State Port Authority.

In my 2015 book, Of Goats and Governors: Six Decades of Alabama Political Stories, I have a chapter entitled "Alabama's Three Greatest Senators, John Sparkman, Lister Hill and Richard Shelby. If I were writing that book today, Richard Shelby would be alone as Alabama's greatest United States Senator

#### DIVIDING CHURCH & STATE: UNITING FAITH & REASON

Five Hundred years ago, the Protestant Swiss reformer, Ulrich Zwingli's theology was designated the official religion of Zurich.

The rumblings of the Reformation were just starting. As education expanded, literacy allowed more people to read the Bible, increasing curiosity about theology. Families sent their best and brightest sons to become ordained priests. Seminaries become a concentration of intellectually curious male teenagers; rather than

accept the authority of the status quo, these seminarians questioned the practices of the church when compared to their reading of the Scriptures.

Like Martin Luther, Zwingli had no desire to break from the established church. Instead, he simply wanted to reform the church and conform its practices with his understanding of the Bible.

Having some sense of academic freedom in debating points of theology, Zwingli asked the Zurich City Council to convene a debate to decide which doctrines should be allowed to be preached in the city.

At this time, there was only one church, both literally and figuratively. Zwingli was designated as the minister for the church in Zurich. He was well-educated and influenced by the humanist Erasmus into studying not only the Bible but also other scholarly texts of the virtuous pagans. Zwingli was an engaging and innovative preacher and known for ministering to the sick and downtrodden.

As he began his ministry in Zurich, his unique worship style included reading passages from the Bible in the language of his mostly illiterate congregation. And, as he read through each verse, he would comment on the words of the passage providing interpretation and application to current issues.

Working his way through the Bible, Zwingli began to note differences between the practices of the church and passages in the Bible. His sermons expressed thoughts that were at odds with certain customs and traditions of the establishment.

At first, some of these differences were minor, but, as he preached his way through the Bible, the differences became more significant. When some complained, Zwingli decided the best way to deal with accusations of error was to host a debate. At his request, the city council asked the Bishop to come and discuss Zwingli's 67 points of theology.

Amazingly enough, in January of 1523, Zwingli had not heard of Martin Luther or his 95 theses, but, in many ways, his concerns were very similar.

It is hard to imagine that the agenda for any city council meeting would include a theological debate to decide which Biblical teaching a city would embrace, but it occurred in Zurich.

Separation of church and state was a foreign concept. Government officials and clergy worked together as faith was established, recognized, and supported by the government. Freedom of conscience and liberty of belief was virtually a heretical abstraction.

It made just as much sense for a city to decide the faith of its citizens as it would


today to decide a zoning variance.

The debate was held. When the Bishop's scholars failed to effectively debate Zwingli and were unprepared to answer his 67 questions, the city councilors voted and confirmed that Zwingli would continue to be their minister, and his

be teaching would established beliefs of Zurich.

Zwingli's triumph was the beginning of the Swiss Reformation and would have a lasting impact on the goals, beliefs, and techniques of Protestantism. But with the city establishing a church and the church taking on roles of the state, a collision course was bound to occur. And it did.

Rather than allowing debate over issues and differing ideas, Zwingli did what he accused others of doing. He developed a smug dogmatism, accepting only his beliefs as accurate



So great was Zwingli's zeal for his faith, he encouraged a war against other Swiss cities that rejected his belief system but continued to acknowledge the authority of the Pope. Zwingli would tragically die on the battlefield literally fighting for his faith.

The beliefs that Zwingli held inform Protestant Christianity today. However, his practices in advocating for a politically established church and imposing his beliefs as an official religion without room for dissent could not survive.

What Zwingli and other reformers failed to understand is that the faith they developed from their reading of the Bible would be similarly experienced by others. But, as with any writing, people find different interpretations based on any number of grammatical conventions, preconceived notions, prejudices, or personal experiences.

In establishing a state-sponsored religion, Zwingli should have realized that the ability to argue beliefs and allow open debate is as good for faith as for any thought process. Ideas are polished by debate, and dissent makes faith stronger. A healthy dose of skepticism is good for confirming aspects of faith. For a political community to prosper, toleration of diverse beliefs is entirely appropriate.

Learning from this experience, the United States Constitution was an attempt to allow all beliefs to compete for the souls of the faithful. Americans realized that the personal nature of faith made it impossible to have any government impose it. Unlike the cities and other political subdivisions of the Old World, America would not allow state religions, and would opt, instead, for freedom of conscience. While governments cannot designate and support one faith, it can limit practices so that faith doesn't become a license or an excuse to break established law.

Zwingli and the other reformers showed that engaging in debate about faith was intellectually progressive. But government can only provide a framework of allowing open debate so that faith is discussed and opposing points of view are respected. The debate, however, should never stop, but continue as ideas are challenged and discussed to provide a moral fabric of virtue, peace, toleration, and goodwill to stabilize the state.

BTW, when I say intentional lapses, this is just what they are. At the level these people are operating and with the sheer number of documents, I simply do not, will not and cannot believe it to be accidental. Sorry, I just don't.

When I first entered the world of classified information, I remember the detailed background checks by, at the time to a 23 year-old guy, pretty threatening people. Not only do you answer their questions, but they are going to go around and ask people you know all about your life. Then we get trained, tested, trained and trained some more. Every year. What is classified? How do you handle classified? What are the different levels of classification? What can I do and not do with classified? Let there be no mistake, when someone says they did not know they could not take classified data home, they are lying; to your face.

If someone says they didn't realize they could not put classified data on a thumb drive or burn it to a CD, they are lying; to your face. All of us familiar within the world of classified data know exactly what is and is not legal. If someone tells you they don't, they are lying; to your face.

Every single person who has ever had a security clearance knows that you cannot store classified information in a shabby box while being protected by your custom Corvette. There is no gray area here, folks. None. Black and white. Right and wrong. Legal and illegal. No questions; no debate. Why is this so hard for people to understand. People want to debate you although they have no clue what they are talking about. I was on a layover one day going to our hotel. This was just as Hillary's server issue came up. So, the other pilot and I were talking about it when the van driver jumped in the conversation. "I don't think she did anything wrong. What's the big deal?" So I asked the guy what year he got his security clearance and he said he never had one. My response? "So you are sitting there arguing with me over something you have no idea what the h#ll you are talking about! Really?" Needless to say the remainder of the trip to the hotel was rather "frosty."

Command existed, both bombers and tankers sat a week of alert. For this entire week, we had to stay on the base in our alert facility, close to our airplanes just in case. As part of alert, the first thing we did was we had to go to the intelligence shop and grab all the information for the missions we would be tasked to fly in case the balloon went up. Each crew was given a specific mission to fly and we had to study

it. It was called EWO (Emergency War Order) study. We had to study where we would go, what plane(s) we would refuel, what bases they came from, where we would land, etc. All highly classified stuff. But as we would study, we sat a table with a lot of information piled in front of us. When finished, we would gather the information, put it back in the flight case where it was stored, grab our own gear and go to the alert facility.

Well one day, "Joe" accidentally grabbed a classified document and put it into his own flight kit. He took it to the alert facility and then a week later when he was off alert, he took his flight kit home. There he discovered the document. He immediately drove back to the base and turned it in to the intelligence office. "Joe" was almost court martialed and tossed into jail. Only because of a gracious wing commander did he avoid a vacation in Leavenworth prison. Today, we have people intentionally mishandling classified data and people want to act as though it is totally acceptable because nothing ever seems to happen to the offending big fish.

You ever hear of former CIA director John Deutch. After he left the CIA, they found a cache of classified in his home. Although he lost his security clearance, he did no jail time. # IN LIGHT OF THE DOBBS DECISION WHAT IS THE STATUS OF LEGAL ABORTION?

The Dobbs decision overturned the "Constitutional" right to abortion under Roe v Wade. The decision was to return the denial or the availability of abortion to the people (of the various states). Justice Kavanaugh pointed out in his concurring opinion that the Consti-

tution neither provides a right to abortion nor does it allow a barrier to abortion. There is considerable statutory language available from the states and even some states while they were yet territories which criminalized abortion. Most of these statutes were enacted in the nineteenth century; some enacted in the early to mid-twentieth century.

Justice Kavanaugh pointed out that the United States Supreme Court in Roe v Wade had moved from a neutral position to one of deciding for the people. In Dobbs, the Court moves back to the neutral position. There is speculation that the Biden, White House and Democratic members in Congress may push to codify a Federal right to abortion. If that were to happen and a judicial review sought, with the Supreme Court seeking a neutral position one has to wonder the outcome. Is the will of the majority of people through their representatives of the State of Alabama and just over a quarter of all states to completely ban abortion going to remain in place, recognizing the sovereignty of those states? Are the representatives of other states, especially those much larger that incline towards a impersonal view of fetal death for convenience sake going to impose their will through a Federal law that allows infanticide? Should that happen how does a "neutral" Supreme Court then rule for or against the will of state sovereignty?

The other almost three fourths of the states allow for various limits on abortion. Georgia has a six-week cutoff. There are a few states that have no cutoff on fetal age for abortion. There are several states that provide abortion until twenty-two weeks and many that provide abortion until viability. With modern science viability is an unknown. Is the abortion of a child born alive one to be set aside until it dies or is murdered by the abortionist or are measures enacted to save the life of the child? There are children and adults living today that have survived abortion rather than experiencing a joyful and wanted live birth. The Lozier Institute reports about 60% of babies born at 22 weeks survive when they receive active hospital treatment. A 1981 article in the Philadelphia Inquirer noted a baby surviving an abortion as a "dreaded complication".

Though prior to Dobbs, I ran across an interesting case from 2018, NATIONAL INSTITUTE OF FAMILY AND LIFE ADVOCATES, DBA NIFLA, ET AL. v.

BECERRA, ATTORNEY GENERAL OF CALIFORNIA, ET AL. A California law was passed to regulate pro-life, crisis pregnancy centers. That law required such centers whether licensed or not, "California provides free or low-cost services, including abortions, and give them a phone number to call. Its stated purpose is to make sure that state residents know their rights and what health care services are available to them. Unlicensed clinics must notify women that California has not licensed the clinics to provide medical services. Its stated purpose is to ensure that pregnant women know when they are receiving health care from licensed professionals." The Supreme Court noted that the state attempted to regulate free speech under the First Amendment by requiring speech contrary to the position of the clinics. California attempted to separate "professional" speech from the speech of other individuals and show reason to regulate it. California regulated such speech asserting that women did not know what type of clinic that they may have entered. The only justification that the Supreme Court saw for such regulated speech was whether or not a pregnant woman would be receiving care from licensed professionals. The case was therefore reversed and remanded to the lower court with support for the pro-life pregnancy centers.

The Dobbs decision settled the lack of Constitutional address of abortion. The states will have to individually figure out the will of their residents. Hopefully, an overreaching Federal government will not seek to impose its will on those unwilling to support a legalized freedom to impose the death penalty on the inconvenient, imperfect or unwanted pre-born.

Our board of directors and everyone associated with this work are volunteers. We have a part-time executive director, who also works full time as Director of a pregnancy resource center



#### THE TYRANTS STRIKE AGAIN

Here we go—another dirty trick from the Biden regime.

Back when he hired his new army of 78,000 new IRS agents, nearly tripling the roughly 45,000 we already had, greedy Joe Biden claimed he was only going after "the rich tax cheats." Now we have the proof that his real targets are poor people—specifically **the poor WORKING people.** 

In my October article, I already mentioned that tax collections from wealthy people, in spite of their much higher tax rates, generate only a tiny fraction of the revenue that the IRS extorts from middle and low income people: "In the IRS fact book for 2019 (the most recent year of available records), the IRS audited about 343,000 individual tax returns, but only 8200 were incomes above \$500,000. The IRS audited LOWER incomes OVER 4,400% MORE than higher incomes. The tax yield was \$28 million from 4350 \$1 million earners. But 184,000 audits of low incomes of \$1 to \$25,000 yielded an extra \$707 million."

What is Biden's game this time? He is already spouting that there won't be any tax increases for anybody. Even if that claim is really true, he and his cronies are still about to load us with reams of new and expensive, invasive paperwork. After all, he has jobs for those 78,000 new agents. Otherwise, he wouldn't have an excuse to hire them. That also means additional toil for us—unpaid slave laborors without a nickel of compensation.

Furthermore, this scheme is another serious privacy invasion which allows the government to stick its nose even deeper into the smallest details of everybody's financial affairs.

Until now, few of us had ever heard of the IRS Form 1099-K. Most of us never file a 1099 of any kind. Those are for relatively rich self-employed people who do work on the side.

Last year (2022), Congress made some changes in the American Rescue Plan Act of 2021 and sneaked in a nasty little surprise that's almost impossible to find. It lowered the threshold for the 1099-K from \$20,000 to a piddling \$600. That means that this year (2023), low income taxpayers who never suffered a burden like this before are likely to be inundated with 1099-Ks from payment services like Square, Venmo, PayPal, Apple Cash, and also eBay, Etsy, Facebook and Amazon.

The 1099-K is sent to people who sell goods and do part-time work and are paid with these services. Each one will send a separate form, meaning many individuals will receive several to fill out. We will be smothered with "a tidal wave of Forms 1099-K hitting millions of unsuspecting taxpayers and... overworked tax preparers."

Prior to 2022, this form was required only for 200 or more annual third-party transactions totaling \$20,000 and above. But Biden's "Gestapo" has now lowered that minimum all the way down to ONE transaction totaling a mere \$600. SIX HUNDRED DOLLARS—an amount so absurdly low, almost everybody who earns money in this manner will be forced to perform extra paperwork and suffer the agonizing liability of a painful audit if he fails to comprehend its complications and makes mistakes. Many will suffer the extra expense of hiring professional tax services to avoid the likely penalties of failure. The tax professionals will probably be the only people who could benefit from this scandal. They will certainly profit from the extra work—unlike the poor taxpayers who are forced to perform free extra labor and suffer the agonies ofperforming complicated mandated bookkeeping duties.

Even working children can be impacted. Those who mow lawns and baby-sit for only \$600 annually will be required to document every little job and keep careful records. If they should become a bit negligent, they and their parents could be victims of IRS retribution. Now a single transaction or several totaling \$600 will receive a 1099-K.

This is just one more case of runaway government overreach where it utterly lacks the morals and common sense to just leave things alone.

Last August (2022), over 70 mostly conservative and free market organizations, including the National Taxpayers Union, Americans for Tax Reform, the Center

for a Free Economy and the American Business Defense Council, sent an open letter to congressional leaders emphasizing the urgency of the issue:

"Under the prior law, a 1099-K was issued only in the event that a business charged customers at least 200 times in a year, and \$20,000 in the aggregate. "H.R. 1319 eliminated the 200 transaction threshold entirely, and lowered the dollar hurdle to just \$600. As a result, both very small business ventures and unwitting non-business taxpayers have found themselves caught in the 1099-K reporting net. Millions of Americans who have never received a 1099-K form before, and don't know what to do with it, will get one. If they seek help from the IRS, they will quickly run into an overwhelmed agency trying to process this gusher of new 1099-K returns, keep up with filing season, clear out prior backlogs, respond to correspondence, and even answer the 800-number telephone line."

Ryan Ellis stated: "The letter raises the urgent issue of 1099-K information reporting. If Congress doesn't act before the end of the year (2022, millions of unwitting teenage babysitters and lawn mowers, college student tutors, people selling junk from their garages and basements, roommates splitting rent, and friends sharing bar tabs will get a new (to them) "1099-K" form from their payment processor. With the IRS ready to hire 87,000 new auditors (and unable to do simple customer service tasks like answering their 800-number), this is the wrong time for the IRS to see every new jot and tittle of your financial life."

There is one bright spot in this debacle. When the law was originally written, the 1099-K forms would have included all income earned in 2022, including income received prior to the law's passage—before any taxpayers would have ever thought about keeping the records needed to comply.

Fortunately, on January 3, the IRS spotted this catastrophic mistake and made adjustments for the change to begin this year (2023). But now, get ready for the upcoming 1099-K tsunami.

If the IRS wants more compliance, it should first consider using more carrots and fewer sticks. When the taxpayers are mad, they are less inclined to comply with excessive and abusive regulations. Minimize and simplify the paperwork. There is no reason why we can't have a single two-sided piece of paper for everybody's entire tax return; that is ample space to list all of the income and deductions the IRS should ever need.

Another reform the IRS should consider is to go back before 2010, back when it sent every taxpayer a complete booklet in the mail that contained all of the forms and instructions needed to file a return, including an addressed envelope. Better yet, it should also have a stamp on it so we won't have to run to the post office to buy the one stamp that we use every year.

The IRS should also sell its guns and ammo and use the money to purchase enough phones and supporting equipment to promptly answer their 800 number from people with tax questions.

Just do it. Contented taxpayers will be far less angry and less inclined to cheat.

Alabama Counties Eligible for FEMA Public Assistance

PRATTVILLE, Ala.— *Autauga, Barbour, Chambers, Conecuh, Coosa, Dallas, Elmore, Hale* and *Tallapoosa counties* are eligible for FEMA Public Assistance for debris removal, emergency protective measures and permanent work due to the Jan. 12 severe storms, straight-line winds and tornadoes.

Greene and Sumter counties are eligible for debris removal and emergency protective measures.

FEMA's Public Assistance program provides reimbursement to local and state government agencies for the costs of emergency response, debris removal and restoration of disaster damaged public facilities and infrastructure. Houses of worship and other nonprofit organizations may also be eligible for FEMA Public Assistance.

# It's Important to Submit an SBA Loan Application

Prattville, Ala. – FEMA may refer survivors of the Jan. 12 storms and tornadoes in Alabama to the U.S. Small Business Administration (SBA) with information on how to apply for a disaster loan. It's important to submit the loan application as soon as possible.

If your application is approved, you are not obligated to accept an SBA loan but failure to return the application may disqualify you from other possible financial assistance from FEMA.

SBA disaster loans are the largest source of federal disaster recovery funds for survivors. SBA offers long-term, low-interest disaster loans to businesses of all sizes, private nonprofit organizations, homeowners and renters.

SBA disaster loans cover losses not fully compensated by insurance or other resources. Survivors should not wait for an insurance settlement before submitting an SBA loan application.

You may apply online using the Electronic Loan Application (ELA) via the SBA's secure website at disasterloanassistance.sba.gov/. Paper applications may be requested by calling the SBA Customer Service Center at 800-659-2955. If you are deaf, hard of hearing, or have a speech disability, please dial 7-1-1 to

services or send an email to disaster-

customerservice@sba.gov. There is

no cost to apply for an SBA disaster

Homeowners may be eligible for a disaster loan up to \$200,000 for primary residence structural repairs or rebuilding. SBA may also be able to help homeowners and renters with up to \$40,000 to replace important personal property, including automobiles damaged or destroyed in the disaster.

Survivors can apply for disaster assistance at disasterassistance.gov, by using the FEMA mobile app, or by calling 800-621-3362. The helpline is open, and help is available from 6 a.m. to 10 p.m. local time in most languages. If you use a relay service such as video relay service (VRS), captioned telephone service or others, give FEMA the number for that service.

# ARE AMERICANS FINANCIALLY EDUCATED ON RETIREMENT SAVINGS?

**F**inancial education helps people learn about savings, credit, and loans. It also helps prepare people for life changes and weather the unexpected. Financial knowledge is essential when planning for retirement.

So, how prepared are adults in the United States for their retirement? The National Endowment for Financial Education (NEFE) conducts polls on key issues, like retirement savings, that affect a person's financial past, present, and future.

Here's what we have learned over the past year:

- In a financial well-being poll conducted during the COVID-19 pandemic, 85% of respondents confirmed that some aspect of their personal finances was causing them stress. For 31% of respondents, that concern was "having enough saved for retirement."
- In that same poll, 70% said they made financial adjustments due to the COVID-19 pandemic. Of that group, 27% increased contributions to their emergency savings, retirement savings, or other savings or investments. In comparison, 21% tapped emergency savings—or borrowed against retirement savings.
- In a poll about financial education mandates, 80% of adults said they wish they were required to complete a semester- or yearlong course focused on personal finance education during high school. Also, 88% think their state should require a semester- or year-long course for high school graduation.
- In that same poll, 84% of those approaching retirement age said "spending and budgeting" should be taught in schools.

COMMANDER ROBERT NEALY SCRUGGS JR.

CDR Robert Nealy Scruggs served 22 years in the U.S. military including five years in the U. S. Marine Corps Reserve, 10 years in active duty in the Navy and seven years in the Navy Reserve. His Military Occupational Specialty

Code (MOS) was Naval Flight Officer. He received the following medals, citations and decorations: National Defense Medal, Meritorious Unit Commendation with three Air Medals, Vietnam Service Medal, Vietnam Campaign Medal and US Marine Corps Reserve Ribbon.

CDR Scruggs was born October 3, 1938 in Nashville, TN, to his parents, Neal and Monteen Scruggs. He lived there four years, nine months at Alpine, TX, and 14 years at Corpus Christi, TX, where he was reared and graduated from Roy Miller High School May

CDR Scruggs family has a rich history of its members serving in the U.S. military. Three uncles served in WWII as well as his father who served in the U. S. Marine Corps. He has a son-in-law who retired from the Marines and has a grandson who is an aviator with the Marines. Following the examples of these relatives, CDR Scruggs volunteered to serve in the U. S. Marine Corps, enlisted September 4, 1957 and completed Marine Basic Training at the Marine Depot in San Diego, CA, and advanced combat training at Camp Pendleton, CA. He returned to Corpus Christi and continued serving in the Marine Corps Reserve. He completed an Associate Bachelor's Degree from Del Mar Jr. College in general studies in May 1960. He taught English and speech at Tuloso-Midway High School at Corpus Christi for one year. He then worked as the assistant personnel officer for the American Smelting and Refining Company at Corpus Christi, TX.

CDR Sruggs volunteered and reported for duty to serve in the Navy's flight program January 1, 1965, at NFO Pensacola, FL; however because of a vision acuity problem, he could not become a pilot. On May 21, 1965, he was commissioned as an Ensign, USNR and continued training as a navigator. He completed requirements and was awarded wings as Naval Flight Officer (NFO) January 7, 1966. He reported for training as NFO (Airborne Ops) at NAF Glynco, GA.

CDR Scruggs' first assignment as Naval Flight Officer with Airborne Ops was to Guam with the primary mission of supporting air ops with the Navy Fleet, and the secondary mission was tracking typhoons in support of the Navy's fleet with multiple deployments to the Philippines and Chu Lai, Vietnam. In 1967, during the Vietnam War, he flew in the Gulf of Tonkin assisting in night air ops in the fleet for two years.

CDR Scruggs then served as the military personnel officer at the NAS Chase Field, Beeville, TX, 1968-1971. He went to CA for training in anti-submarine warfare in 1971, and he went to NAS Moffett, CA, for NFA (anti-sub) training from February 2, 1972 to August 18, 1971. Next, he was assigned to VP-17, NAS Ewa Beach, Hawaii, for three years where he often flew patrol ops with deployments to Okinawa, Philippines, and Thailand (Vietnam Ops). He then

served as the aviation safety officer at the NAS Millington, TN, for nine months leaving Navy active duty July 7, 1965. While there, he received a MS Degree in Systems Management from the University of Arkansas in 1975. He then

served as personnel list manager for the U.S. Department of Energy at Oakridge, TN. He went into the Navy Reserve in 1975, and he flew with a Navy Reserve patrol squadron at Glenview NAS Chicago starting in 1976. Scruggs retired from all military service December 23,1983.

After military retirement from the Navy reserve, CDR Scruggs worked in civilian personnel at Arnold Air Force Station at Tullahoma, TN, in 1983. This was followed by employment as civilian personnel officer at Dyess Air Force Base, at Abilene, TX, at Maxwell Air Force Base, at Montgomery, AL, at Aviano Air Base, Italy, at USAF Civilian Personnel School, Maxwell Air



Force Base-Gunter Annex, Montgomery, AL, and as head of labor relations training and as CPO at Royal Air Force Mildenhall, England. His last civilian employment was serving as Director of Labor Management Relations training at USAF Civilian Personnel School, Maxwell Air Force Base Gunter Annex. He retired from civilian service June 2, 2000 as a GS-14 with credit for 34 years of service including some credit for military service. He received two Exemplary Civilian Service Awards and one Outstanding Civilian Service award. CDR Scruggs taught courses in Management at Auburn University of Montgomery for one and one-half, and he retired from all employment in 2001.

CDR Scruggs and his wife, Julia, have been married 47 years. He has two daughters and one stepdaughter. Robert "Bob" Scruggs is an active member of Frazer Methodist Church at Montgomery, AL, where he serves as a teacher of the Living Today Sunday school class and volunteers in congregational care such as the cancer support group and various other activities. He enjoys playing golf and pickleball and reading.

CDR Scruggs' conclusions about what his military service means to him are:

"The war in Vietnam was impersonal for us in the beginning because we did not fly out of Vietnam. Once we began flying out of Chu Lai, Vietnam we saw first hand grim evidence of the effects of the war on our troops and the Vietnamese. It was sobering and also made us appreciate the sacrifices that were being made. We were glad to contribute our part in helping the fleet take care of crippled aircraft returning to the carriers and/or conducting search and rescue or whatever else was needed. I am grateful for the opportunity to have served our great nation and to stand with so many wonderful men and women who are willing to make such sacrifice. God will bless America as long as we continue to have those who are willing to support our values in sacrifice."



#### JOHN F. MORROW: BATTLE OF THE BULGE HERO



**J**ohn F. Morrow is a 101 year-old WWII veteran who served as a U. S. Army tank driver in the liberation of Belgium, Holland, France and Germany. Lt. General George S. Patton was his commander during the Battle of the Bulge in the Ardennes, a region in southeast Belgium that extends into Luxembourg, Germany and France. The Battle of the Bulge was the major German offensive campaign on the Western Front during World War II taking place from December 16, 1944, to January 25,1945 during the coldest months of the year in northern Europe. Not only was Morrow enduring extremely hazardous combat, he was also responsible for maneuvering tanks in the Ardennes region in rugged terrain that encompasses rolling valleys, meandering rivers, extensive caves and dense forests. Despite heavy casualties, Lieutenant General George S. Patton's successful maneuvering of the Third Army to Bastogne proved vital to the Allied defense, leading to the neutralization of the German counteroffensive. The Battle of the Bulge was the costliest action ever fought by the U.S.



Morrow was born February 2, 1922, in Big Flat, AK, to his parents, Calvin and Matilda Morrow where he was reared and graduated from Marshall High School. At age 19, he volunteered to serve and joined the U. S. Army. He completed the Army Basic Training learning to drive Sherman tanks at Ft. Knox, KY. The M4 Sherman tank had a five-man crew including a commander, gunner, loader, driver and assistant driver/bow gunner. Further training to drive each of the Army's vehicles was completed at Camp Polk, LA, followed by desert training at Death Valley, CA, paratrooper training at Ft. Benning, GA, and frigid training at

Camp Shanks, New York. All of his military driving within the U.S. was done driving a half-track vehicle. He was deployed sailing on the liner, the Queen Mary, to Scotland landing at Normandy after the Allies D-Day landing. His unit's first mission with the 23rd Armor Division was to recapture Paris from the Nazis. He suffered burns to his eyes and was hospitalized for several weeks. While still driving the half-track, he was wounded three more times. He then joined the 7th Army Division as a tank driver and suffered a bullet wound to

one ear escaping a serious injury to his head because he turned his head to the side just before he was shot. After the success in the Battle of the Bulge, he was the first tank driver to cross the Rhine River as the Army entered Germany. Morrow received the military award, the European Theater of Operations Medal with Four Clusters and also received citations from colonels. His unit participated in the liberation of concentration camps. His unit of tankers gave all of their food to liberated prisoners expecting to be replenished by the supply truck; however his unit was surrounded resulting in having no food or water for three days and nights. He had opportunities to shake hands with Generals Patton, Eisenhower and Bradley. Although it was planned for his unit to go to the Pacific Theater for battle, the Japanese surrendered in August, 1945. Morrow was discharged in October, 1945.

After discharge, Morrow returned to Arkansas where he did some review study at his high school followed by graduation with a B. S. Degree in Science at Northeastern Teachers College in Tahlequah, OK. He taught high school biology and chemistry and coached basketball at Timbo, Marshall and Leslie, AR, for 16 years. His next employment was at Hanford Works, a nuclear production complex, in Richland, WA, for seven years. He returned to AR and worked in dry wall construction in houses and commercial buildings retiring in 1988.

He was married to his first wife, Joyce for 54 years until she passed away, and they had two sons and nine grandchildren. Now he has been married to Carie Nell for 18 years. He and Carie enjoy playing cards and dominoes with friends weekly. Since 1957, Morrow has been serving in the ministry as a pastor. He serves as a pastor to senior adults to the New Home Baptist Church in Elmore County, AL, and the Clearview Baptist Church in Chilton County, AL.

Morrow concludes about his experiences as a tank driver in combat saying:

"The thing that sticks most in my mind is how scared I was, and I was sitting there seeing German tanks shooting at me. I went in because I love this country, and I always want this country to be free. Don't let anybody ever tell you that there wasn't any praying going on out there."



#### PO3 PEGGY HOLLEY AGE 100



Petty Officer Third Class (PO3) Peggy Holley served three years and 16 days in the Women Accepted for Volunteer Emergency Services (WAVES) in the U.S. Navy. The WAVES were created during WWII to free up male personnel for sea duty. Her final MOS was Petty Officer (PO3) having been promoted from Apprentice Seaman, Seaman 2nd Class, Seaman First Class and Mailman 3rd Class which is a Petty Officer.



She was born December 13, 1922 in Butler County, AL, to her parents, Joseph and Otie Mae Murphy. She was reared in rural Butler County, and after the family moved to Montgomery, AL, she graduated from Sidney Lanier High School in 1940. She then worked at the Montgomery Fair, a department store in Montgomery, AL, in the basement department where overalls were sold.

PO3 Holley volunteered and joined the U.S. Navy WAVES January 26, 1943 reporting for duty at Birmingham, AL. She entered active service February 16, 1943, and she completed three months

of Basic Training at Iowa State College at Cedar Falls, Iowa. After Boot Camp, she was assigned to Naval Air Station at Atlanta, GA, for clerical work maintaining the manuals of the Navy pilots who were being trained for instrument flying service in WWII. Training some 3,000 pilots and over 4,000 instructors, NAS supported the vase expansion of naval aviation that probed decisive in the Pacific War against Japan. PO3 Holley states, "I learned about people serving in the Navy. I had grown up in a rural area. The Navy pilots were extremely careful about using the manuals for instrument flying, and I was responsible for updating the data in the manuals. I met some interesting people. \*\*\*\*\*\*\*\*\*\*\*\*\*\*

After discharge from the Navy February 11, 1946, PO3 Holley returned to Montgomery, AL, married Richard Taylor Holley, and they were married for 63 years. Richard served in the Infantry in the U.S. Army for 30 years including service in WWII and in the Korean War. He earned a Bronze Star for service

in Papua New Guinea in WWII and a Bronze Star-Meritorious for his service in Korea. During his military service, he and his family lived in Germany as well as at other Army military bases in the United States. They had three daughters and two grandchildren. She recalls sewing and making all of the clothes for her daughters even after they went to college. They enjoyed vacations to Gulf Shores, AL. They were members of First Baptist Church of Montgomery where she served as president of a Sunday school class and served as an outreach leader making calls to church members who were



ill. She served as the founding member of the church's committee to hire a social worker to run the church's Caring Center. She worked as a record keeper in the AL Department of Health for 18 years starting out as a clerk and becoming second in leadership, and she found that work interesting and enjoyable.

PO3 Holley conclusions about her life are:

"One thing that I have tried to focus on is the positive. There is no point in focusing on the negative. God gave us good things, and he expects us to follow his teachings. We have to follow God's guidance."

#### American war casualties:

**AMERICAN** REVOLUTIONARY WAR (1775-1783): 25,000

#### BLACK CONFEDERATES: MYTH OR REALITY?

November 2022, The University of Dayton student newspaper ran an article about Al Arnold and his 2015 book, Robert E. Lee's Orderly: A Modern Black Man's Confederate Journey. Arnold, a devout Christian descended from a Black Confederate Veteran, has likely relied on his faith to shield himself from the backlash caused by deviating from the "government-approved narrative." In reality, Black loyalty to the South was critical, as they ran or helped run small and large farms and plantations, traveled with the armies and engaged in fighting, digging fortifications, building bridges and breastworks, blacksmithing, scouting, etc. Of course, many were cooks and teamsters and critics argue that they were not

really Confederate Veterans. If that were true, cooks and teamsters from other ethnic groups would not be Confederate (or Union) Veterans either.

As a lukewarm abolitionist, Abe Lincoln was criticized by the extreme abolitionists for proclaiming the goal of the war was "preservation of the union." [As though forcing States in a union they voted to leave has anything to do with preservation.] These fanatics worked feverishly to convince Lincoln to change the goal to the abolition of slavery. One fly in this ointment was that, when you include West Virginia, five Slave States fought for the union.

The Black population in the South was roughly 3.6 million in the mid-1800s. There were approximately 262,000 free Blacks in the South. Henry Lewis Gates noted, prior to the war, the North never had more free Blacks than the South. Another complication arises from the fact that just under 3,800 slave owners were Black. Indeed, William Ellison, Justus Angel, and Mistress L. Horry were large slave owners in South Carolina, August Donato owned slaves in Louisiana, and the list goes on and on. John Hope Franklin wrote that there were 3,000 Black slave owners in New Orleans, equating to roughly 28 percent of the free Blacks living there. The actual situation was complicated and extended beyond Tom Woods' renowned "Index Card of allowable opinion."

At least 2,807 Blacks received Confederate Pensions. The post-war financial devastation of the Southern States diminished the number of qualified pensioners, regardless of their race or ethnicity. According to researcher James Hollandsworth, Jr., Blacks receiving Confederate pensions included: 1739 from Mississippi; 121 from North Carolina; 328 from South Carolina; 195 from Tennessee; and 424 from Virginia. If these individuals were not loyal and had no role in Southern Independence efforts, they would have been ineligible for

In 1863 Confederate General Patrick Cleburne understood the extreme manpower shortage the South faced. He also recognized a large percentage of Blacks were loyal and would fight for the South. Anyone who fought both expected and deserved something in return, specifically freedom and a chance to become self-sufficient. There were mixed opinions among those in the Confederate hierarchy. Initially the skeptics held sway but, over time, more Confederates understood using Blacks as Confederate soldiers was pivotal to

gaining independence. Robert E. Lee supported it, stating: "I believe that with proper regulations they can be made efficient soldiers. They possess the physical qualifications in an eminent degree." Lee felt they should be rewarded with "immediate freedom to all who enlist, and freedom at the end of the war to the families of those who discharge their duties faithfully (whether they survive or not), together with the privilege of residing at the South. To this might be added a bounty for faithful service." Of course, the March 13, 1865, Confederate Congress authorization to recruit 300,000 Black Confederates was too late to make a significant impact.

Private Levi Oxendine, Free Negro, age 53;

friends Alexander Harris and George Dwell, First Volunteer Regiment of Georgia;

Amos Rucker, 7th Georgia Regiment;

Tim Billing, cook for the Columbus Guards;

Bill Yopp, of Marietta, Georgia, went through the war with his master, Captain Thomas Yopp;

Jim Lewis, servant to Stonewall Jackson and led Jackson's horse, "Little Sorrell" in Jackson's Richmond funeral procession;

the Coney family of New Orleans who set up a home warning system beginning with "Damyankees a-comin";

Alex Street, member of Captain Claiborne's expert bridge building crew; Allen Griffin and Emanuel Pinks, of Macon, Georgia...

The same old naysayers will claim Blacks who served the Confederacy were coerced when the actual records reveal a much more complicated situation. With "Lincoln Cultists" and "Righteous Cause Mythologizers" controlling the narrative, thousands of very real Black Confederate loyalists, such as Al Arnold's great-great grandfather, Turner Hall, Jr., could be transformed into a myth.

# oul Searchin

#### NO RESERVES, NO RETREATS, NO REGRETS

 $m{I}$  have a sign in my office that reads, "No Reserves. No Retreats. No Regrets"

These words remind me to be bold in my convictions and to never consider retreating from standing tall for what I believe! They also remind me to live my life in such a way that when I am old and grey that I will look back on my life and have no regrets!



William Whiting Borden "No Reserves, No Retreats, No Regrets" 1887-1913 New Haven. To try to rehabilitate them, he founded the Yale Hope Mission. One of Bill Borden's friends wrote that he "might often be found in the lower parts of the city at night, on the street, in a cheap lodging house or some restaurant to which he had taken a poor hungry fellow to feed him, seeking to lead men to Christ."

Let me share with you where I discovered these inspiring words...

In 1904 William Borden graduated from a Chicago high school. As heir to the Borden family fortune, he was already wealthy. For his high school graduation present, William Borden's parents gave their 16-year-old son a trip around the world. As the young man traveled through Asia, the Middle East, and Europe, he felt a growing burden for the world's hurting people. Finally, Bill Borden wrote home about his "desire to be a missionary."

One friend expressed disbelief that Bill was "throwing himself away as a missionary."

A story often associated with Borden says that, in response, he wrote two words in the back of his Bible: "No reserves."

Even though young Borden was wealthy, he arrived on the campus of Yale University in 1905 trying to look like just one more freshman. Very quickly, however, Borden's classmates noticed something unusual about him and it wasn't that he had lots of money. One of them wrote: "He came to college far ahead, spiritually, of any of us. He had already given his heart in full surrender to Christ and had really done it. We who were his classmates learned to lean on him and find in him a strength that was solid as a rock, just because of this settled purpose and consecration."

During his college years, Bill Borden made an entry in his personal journal that defined what his classmates were seeing in him. That entry said simply: "Say 'no' to self and 'yes' to Jesus every time.'

Borden's first disappointment at Yale came when the university president spoke in a convocation about the students' need of "having a fixed purpose." After that speech, Borden wrote: "He neglected to say what our purpose should be, and where we should get the ability to persevere and the strength to resist temptations." Surveying the Yale faculty and much of the student body, Borden lamented what he saw as the end result of an empty, humanistic philosophy: moral weakness and sin-ruined lives.

During his first semester at Yale, Borden started something that would transform campus life. One of his friends described how it began: "It was well on in the first term when Bill and I began to pray together in the morning before breakfast. I cannot say positively whose suggestion it was, but I feel sure it must have originated with Bill. We had been meeting only a short time when a third student joined us and soon after a fourth. The time was spent in prayer after a brief reading of Scripture. Bill's handling of Scripture was helpful... He would read to us from the Bible, show us something that God had promised and then proceed to claim the promise with assurance."

Borden's small morning prayer group gave birth to a movement that soon spread across the campus. By the end of his first year, 150 freshman were meeting weekly for Bible study and prayer. By the time Bill Borden was a senior, one thousand of Yale's 1,300 students were meeting in such groups.

Borden made it his habit to seek out the most "incorrigible" students and try to bring them to salvation. "In his sophomore year we organized Bible study groups and divided up the class of 300 or more, each man interested taking a certain number, so that all might, if possible, be reached. The names were gone over one by one, and the question asked, 'Who will take this person?' When it came to someone thought to be a hard proposition, there would be an ominous pause. Nobody wanted the responsibility. Then Bill's voice would be heard, 'Put him down to me.'

Borden's outreach ministry was not confined to the Yale campus. He cared about widows and orphans and the disabled. He rescued drunks from the streets of

Borden's missionary call narrowed to the Muslim Kansu people in China. Fixing his eyes on that goal, Borden never wavered. He also challenged his classmates to consider foreign missionary service. One of them said of him: "He certainly was one of the strongest characters I have ever known, and he put backbone into the rest of us at college. There was real iron in him, and I always felt he was of the stuff martyrs were made of, and heroic missionaries of more modern times."

Although he was a millionaire, Bill seemed to "realize always that he must be about his Father's business, and not wasting time in the pursuit of amusement." Although Borden refused to join a fraternity, "he did more with his classmates in his senior year than ever before." He presided over the huge student missionary conference held at Yale and served as president of the honor society Phi Beta Kappa.

Upon graduation from Yale, Borden turned down some high-paying job offers. It has been reported that in his Bible, Bill Borden wrote two more words: "No retreats."

William Borden went on to do graduate work at Princeton Seminary in New Jersey. When he finished his studies at Princeton, he sailed for China. Because he was hoping to work with Chinese Muslims, he stopped first in Egypt to study Arabic. While there, he contracted spinal meningitis. Within a month, 25-yearold William Borden was dead.

When the news of William Whiting Borden's death was cabled back to the U.S., the story was carried by nearly every American newspaper. "A wave of sorrow went round the world . . . Borden not only gave (away) his wealth, but himself, in a way so joyous and natural that it (seemed) a privilege rather than a sacrifice" wrote Taylor in her introduction to his biography.

Was Borden's untimely death a waste? Not in God's perspective. As the story has it, prior to his death, Borden had written two more words in the back of his Bible. Underneath the words "No reserves" and "No retreats," he is reported to have written: "No regrets."

This story really touched me when I first read it. William Borden didn't die in vain. In his short life he shared the gospel with many, but he also left a great legacy by his life journey and those three simple phrases he wrote in the back of his Bible: "No Reserves. No Retreats. No Regrets."

Yes, these simple proclamations have inspired so many young Christians, missionaries and Pastors to live and give their lives serving Christ without any reservation, without ever considering retreating from the mission and without a single regret!

I pray you will be inspired by William Borden's story and these three statements of faith found in his Bible. May all of us seek to live our lives, as William Borden did, for Christ's sake and the good of others with no reserves, no retreats and no regrets!

If we do that, we will enjoy a rich and satisfying life no matter how long that

# Southern Gardening

In February, our thoughts first go Valentine's Day with
Cupid firing off his arrows of love. I can remember as
a child picking out boxes of small Valentine cards at

Woolworth's Dime store to give to classmates. They were adorned with flowers, funny valentine greetings and were appreciated by all. I really have not noticed in today's world with Email, Tik-Tok, texts, Instagram, and Facebook whether these silly little valentine cards are still sold. February can certainly be named the red and white month with a little chocolate thrown in. In order to get in the Valentine mood, I made a wonderful flower arrangement with red roses, Baby's Breath (gypsophila paniculate) and white carnations. A fact I was not previously aware of is that Baby's Breath is toxic and should not adorn cakes or other food., so be careful.

If we had planted daffodils, and narcissi, earlier this year, these should be coming up and blooming their heads off--harbingers of spring. Other blooming bulbs would be: Snowdrops(galanthus), crocus, iris reticulata, Helleborus, and cyclamen. Shrubs which are in bloom are camellias, Kiss -me-at-Gate, and perhaps some Japanese Magnolias budding out. Pansies, violas, candytuft and dianthus round out the mix this month. If your garden has none of the above, start planning for next February's garden by purchasing these harbingers of spring through the year.

What to plant this month for a spectacular early spring and early summer garden. I have planted tulips in early February, after 6 weeks of chill in the refrigerator, to great success. If fact I have even staggered the planting, some in early January, some in early February for a longer tulip sequence of bloom.

My favorite look is to plant tulip bulbs amongst pansies and dianthus as it gives the pots or the garden a dramatic dynamic. Also experiment with different color combinations such as mixed colored tulips and mono chrome-colored flowers



or vice versa. You want to achieve a uniform contrast rather than a cluttered mess. It is not too late to plant pansies, and dianthus with geraniums and begonias later. We call this a spring garden in progress. Both pansies and dianthus will bloom until the heat of the early summer. Seed that has been sown in the fall, such as poppies, larkspur should be breaking the soil for blooms next month. Also, this is the month to sow the seed of cleome, nasturtiums, petunias and zinnias directly into the ground.

#### PLANT OF THE MONTH ROSEMARY

A commonly known herb is one of the best small to medium sized shrubs one can place in the garden, pots or herb bed. Plant this perennial shrub in the spring for one of the most aromatic herbs known. Rosemary has many uses from culinary, to medicinal, to insect repellent, to cosmetic. The leaves, fresh or dried, can be used as an antiseptic, as a tonic and diuretic. Mostly we use Rosemary as a pungent flavoring for fish dishes, soups, marinades, egg dishes, and lamb. It is easy to grow, non-invasive and grows to about 3-4 feet high and can get to 5 feet tall. It would need some protection if the winter temps fell well below freezing. I have used this shrub in herb beds, flower beds, and pots.

A beautiful buck came out about sixty yards to my right. Just by the size of his rack, I knew he was a good deer – a definite ten-pointer.

I didn't have much time to gather myself for a good shot because he wasn't going to stay around long. When I fired I wasn't sure I had made a good shot, from the way he ran. But shortly thereafter I realized my shot was perfect. He was a beautiful animal with a wide rack. As I began to count his points, I discovered my ten-pointer was only an eight. I say "only" here for emphasis. Because this was an absolute gorgeous deer, and I was still so pleased with it. I was so pleased that if I had known he was an

eight before I shot, I still would have. My pictures verify my assessment. As my friend and I admired the deer, we realized this buck was never going to be anything but an eight-pointer. One could tell that while he would have gotten greater in mass and size, he would always remain a deer with eight points unless some trauma happened.

That doesn't mean he couldn't have been the king of the hill, but his limits were there according to his genetics. What did I think of his limits? I thought he was so perfect that I decided to have a picture of him blown up and put on canvas. It arrived two days ago.

I am reminded of the words of the apostle Paul when he explained how every member is important in the church. He compared it to our physical body and admitted that some parts of the body don't seem as important as others.

He was saying that some will be ten, twelve, and even fourteen pointers, but others will always be a six or an eight.

Then he encourages us in two ways. First by explaining how all parts are needed, no matter how insignificant some may think they are. A good example of that is my foot. It re-



mains hidden underneath a sock and shoe, but without it I am on crutches. And about its little toe, I promise you when it hits the bed frame, the pain doesn't remain just in my little toe and foot. It reverberates throughout my entire body.

But Paul also encourages us by reminding us how God elevates those in the Body of Christ who seem to have lesser gifts. Here's what he says: "So, God has put the body together such that extra honor and care are given to those parts that have less dignity" (1 Corinth 12).

What he was saying that while God's twelve-pointer might gain more attention, His eight gets his picture blown-up, put-on canvas, and displayed in ways like no other. No matter who you are or what position you have, you matter to God and are an extremely important part of His eternal plans.

I'm always excited about the times I get to go on an extended hunting or fishing trip. The expectations are always high and the opportunity to go with a friend makes the miles pass quickly and the laughs come in abundance. I just returned from my final deer hunting trip of the year. Each day of this four-day hunt offered its own challenges, and hours in the tree stand made nights in a warm bed even more comfortable. We fought cold and windy days along with discovering we were too early for the rut. By the last day my mind was drifting toward home. I was tired of fighting the elements, tired of battling my bodies urge to stay in bed, and tired of being away from family. I wanted to go home.

As I reflected on my desire to leave, I was reminded of a lesson I had learned earlier in life – one that helped me understand more about death and dying.

Over the years I have stood at the bedside of many of the elderly who were sick and dying. Many of them were battling all sorts of illness or disease. Instead of continuing to fight, their desire was simple. They wanted to go home. Not to their brick-and-mortar earthly dwelling but to their heavenly home.

As a young man I never understood why anyone would trade life for death. As an older man, I do. It was not that these men and women wished to cease to live

but it was that they wished to live in a better place; one that promised a new body and where most of their loved ones were waiting.

It was sort of like my hunting trip. It was not that I did not love to deer hunt but when it came right down to it what I really loved more than anything was at home. And not only could I be with the ones I loved, but I could also do it without facing the battles I was looking at right now.



# Southern Cuisine

It seems that the holidays this time of year just are speeding along and will catch you off guard. With Groundhog Day, National Tater Tot Day, National Carrot Cake Day, Thank Your Mailman Day, National Send A Card to a Friend Day, Super Bowl Sunday, Valentine's Day, Random Acts of Kindness Day, National Sticky Bun Day, and

with National Waking the Dog Day how do you expect to get any thing done this month? The only day that I could not find an excuse to party was February 24.



You will not have time to do much celebrating this month because the recipes I have for you will take up much of your time. The MISSISSIPPI POT ROAST will take up some time cooking but is light on the prep. The RED BEANS & RICE recipe has many options to pick from in the preparation and the recipe will also require you to follow the instructions carefully. What kind of beans and sausage and how spicy you like you food will give you many options to pick from. The last recipe has a fair list of ingredients and needs a long rest in the refrigerator.

The recipe below is the long one. Read the recipe first to make sure you have all of the ingredients needed and you understand all of the steps.

### Red Beans & Rice



#### **INGREDIENTS:**

2 tablespoon olive oil - divided

1 pound Smoked Andouille Sausage - sliced into 1/2-inch rounds

2 medium yellow onions - diced

3 ribs celery - diced

2 green bell peppers - stemmed, seeded and diced

5 cloves garlic - minced

1.5 tablespoon Cajun seasoning

1/2 teaspoon cayenne - plus more if desired

2 teaspoon thyme

1 teaspoon salt - plus more to taste

1/2 teaspoon black pepper

3 cans red kidney beans - drained, not rinsed

2 bay leaves

2 cups broth - (chicken stock, vegetable or beef broth), plus more as needed

2 cups white rice - cooked according to package instructions or see notes below

Optional garnishes: - chopped parsley, green onions, cilantro, or hot sauce (like Tabasco

#### **DIRECTIONS:**

**Brown the sausage:** Heat a large, heavy-bottomed Dutch oven or pot over high heat. Add 1 tablespoon of olive oil and swirl to coat the bottom of the pot. Once hot, add the sausage to the in a single layer and cook for 1-2 minutes before flipping to brown on the other side. Remove sausage from the skillet and set aside.

Sausage: Spicy smoked Andouille sausage is what I used in this recipe. You'll find all kinds of different smoked sausage available at your local grocery store, so pick your favorite. Since it has already been cooked, there's no need to cook more than a few minutes. Can't find Andouille sausage? Alternatives include Mexican Chorizo, kielbasa, or any other spicy smoked sausage.

The "holy trinity" (Mirepoix): To the same pot over medium-low heat, add the last tablespoon of olive oil. Stir in the minced onions, bell pepper, and celery, mixing well to combine. Sauté for 8-10 minutes, stirring frequently. Add the minced garlic, Cajun seasoning, cayenne pepper, thyme, salt, and black pepper. Mix well and continue to cook for 1

Red beans and broth: Add in the drained red beans, bay leaves, and broth to your pot. Mix well to combine and add additional liquid if needed. Increase heat and bring the red beans to a low boil. Immediately reduce heat to low, cover, and simmer for 15 minutes. If you prefer a thicker sauce, simply whisk together 2-3 tablespoons of tomato paste with approximately 1/2-1 cup of

broth from your pot. Thoroughly mix to combine and gently stir back into your pot.

**Return the sausage:** Return the sausage back to the pot and continue to simmer for 5-10 minutes more. Season with additional salt and pepper, to

Serve approximately, 1 cup of beans and sausage in a shallow bowl topped with approximately equal amounts of rice. Garnish with fresh chopped parsley or green onions, if desired.

# Mississippi Potroast

Cook Time 8 hrs **Servings 8** 

(3-4 pounds chuck roast

1 packet ranch dressing mix 1 packet au jus gravy mix

1/4 cup butter 4-5 pepperoncini peppers



#### **DIRECTIONS:**

Place roast in the slow cooker and sprinkle the top with the ranch dressing mix and the au jus mix.

Place peppers on top of the mixes, and add the butter. Cook over low heat for 8 hours. Serve with noodles, rice or mashed potatoes.

#### **Enjoy!**

Do not add any water or broth to this! It will make enough liquid as it cooks.

This tastes delicious with potatoes and carrots! I like to add a few quartered russet potatoes and a large handful of baby carrots to the crock-pot when there is about 1-2 hours left of cooking time

# Mocha Chocolate Ice Box Cake

Yield: 8 servings

2 cups cold heavy cream

12 ounces Italian mascarpone cheese

1/2 cup sugar

1/4 cup coffee liqueur

2 tablespoons unsweetened cocoa powder

1 teaspoon instant espresso powder

1 teaspoon pure vanilla extract 3 (8-ounce) packages chocolate chip

cookies,

Semisweet chocolate, for garnish

#### **DIRECTIONS:**

In the bowl of an electric mixer fitted with the whisk attachment, combine the heavy cream, mascarpone, sugar, coffee liqueur, cocoa powder, espresso powder, and vanilla.

Mix on low speed to combine and then slowly raise the speed, until it forms firm peaks.

To assemble the cake, arrange chocolate chip cookies flat in an 8-inch springform pan, covering the bottom as much as possible.(I break some cookies to fill in the spaces.) Spread a fifth of the mocha whipped cream evenly over the cookies .Place another layer of cookies on top, lying flat and touching, followed by another fifth of the cream.

Continue layering cookies and cream until there are 5 layers of each, ending with a layer of cream. Smooth the top, cover with plastic wrap, and refrigerate overnight .Run a small sharp knife around the outside of the cake and remove the sides of the pan.

Cut into wedges and serve.
