The Liberty Bell

is an iconic symbol of American independence, located in Philadelphia, Pennsylvania. Once placed in the steeple of the Pennsylvania State House (now renamed Independence Hall), the bell today is located in the Liberty Bell Center in Independence National Historical Park. The bell was commissioned in 1752 by the Pennsylvania Provincial Assembly from the London firm of Lester and Pack (known subsequently as the White-chapel Bell Foundry),



and was cast with the lettering "Proclaim LIBERTY Throughout all the Land unto all the Inhabitants Thereof", a Biblical reference from the Book of Leviticus (25:10). The bell first cracked when rung after its arrival in Philadelphia, and was twice recast by local workmen John Pass and John Stow, whose last names appear on the bell. In its early years the bell was used to summon lawmakers to legislative sessions and to alert citizens about public meetings and proclamations.



Best races of the year have been for **Attorney General and Lt. Governor**

The best races of the year have been for Attorney General and Lt. Governor, as well as Agriculture Commissioner and for the 2nd Congressional district.

The Attorney General post is considered the best stepping stone to Governor and U.S. Senator. It is very high profile and prosecutes bad guys who go to jail and cannot vote against you, and you look like a good guy to the rest of the law abiding voters in the state. Therefore, in recent years it has attracted ambitious politicians rather than veteran dedicated prosecutors. These aspirants were novices at being lawyers, much less prosecutors. They sought the position for political posturing rather than the job as the state's top law enforcer. We have not had a

As the race began, there were three major candidates with prosecutorial experience. Troy King had been Attorney General, Alice Martin had been the U.S. Attorney in the Northern District of Alabama and had handled numerous major high-profile convictions. Even the Bentley appointee, Steve Marshall, had been a district attorney.

tough former DA since the days of Bill Baxley and Charlie Graddick.

Troy King had begun the race as the front runner simply because he had some name identification from having been Attorney General. Early polls showed him with around 27 percent with Martin and Marshall at 10-12 and Chess Bedsole at 5-6. The final results wound up mirroring the amount of money spent by the

candidates. There was an amazing correlation to money equals media equals name identification, which results in votes. "Money is the mother's milk of politics." Troy King and Steve Marshall ended up in a dead draw with 28 percent each.

Alice Martin got 23 percent and first-time candidate, Chess Bedsole, got a surprising and impressive 21 percent. He got a great vote in Mobile and Birmingham, especially in the silk stocking boxes. His \$1 million media buy did not hurt. The runoff between Troy King and Steve Marshall will be interesting. Again, it

will probably boil down to money. Marshall made the runoff by outspending Alice Martin significantly. He used the power of incumbency to strong arm contributions. Both candidates will have to go negative. Marshall is more vulnerable. He campaigned for Obama and was a Democrat only a few years ago. He was appointed DA by Democrat Don Siegelman and was appointed Attorney General by Robert Bentley. These are not good calling cards in a GOP Primary runoff. King will be the favorite on July 17.

The winner will not get a free ride in November. The aforementioned Don Siegelman's son, Joseph Siegelman, won the Democratic nomination on June 5 and will be a viable opponent in the Fall.

The Lt. Governor position has very little power. However, over the past few decades the Lt. Governor has risen to Governor quite a few times. Therefore, this race has gotten a lot of attention from voters and campaign donors. Twinkle Cavanaugh entered the race as the favorite simply because of name identification. Will Ainsworth and Rusty Glover had very little of that. However, Ainsworth came to the dance with the ingredient to buy name ID. Money is that recipe. He had it and he spent it. Twinkle wound up with 43 percent to Ainsworth's 37 percent and Glover's 20 percent.

Twinkle will be a slight favorite in the runoff. However, if Ainsworth spends another million and stays with negative or some say comparison ads, it will be

Rick Pate bested Gerald Dial 40 to 30 in the Agriculture Commissioner race despite Dial outspending him with a catchy jingle ad. Alabamians inexplicably have a way of ascertaining who is the farmer in that race. Pate was the only farmer. The Alabama Farmer's Federation Endorsement helped him in the first primary.

Over 61 percent of the 2nd Congressional District GOP voters voted against incumbent Martha Roby. Bobby Bright may very well win this rematch, which has been years in the making. Bright is well known and liked in the District, especially in the Wiregrass where he was born and raised as well as in Montgomery where he was Mayor for 10 years.

How Can California Divide Itself **Into Three Separate States?**

The state of California has a larger economy than many countries and is the most populous state within the United States. Many in California think differently from those of us in Alabama with resultant taxes and the cost of living being significantly higher, in case of taxes by design of it's legislators. Even so, within California there are different schools of thought and that is somewhat evident by the current number of Californians leaving to settle

in other states which has California losing more residents than those that move

A gentleman by the name of Tim Draper began the division proposition of California into six states and has now narrowed it down into three states. There are now enough signatures to place the proposition on the ballot in November.

The proposition is to change the state into three states called, Northern California, California and Southern California. Interestingly enough Los Angeles is not included in Southern California but rather the "new" California. Northern California would include the capitol of Sacramento. Because "new" California would include Los Angeles and thus Hollywood it would be a more affluent state. Southern California may be a wild card in that it may be more in the middle of how much of the country thinks. One California county has not been mentioned and could potentially merge into Nevada.

The equity of living in the current California has had a huge effect on lower and middle class residents. To illustrate, a one-bedroom apartment in Los Angeles of about \$2,200 per month is about \$3,400.00 in the San Francisco area. Certainly even a one-bedroom apartment in Los Angeles far exceeds the average cost in Alabama.

Article Four, Section Three of the United States Constitution reads, 1: New States may be admitted by the Congress into this Union; but no new

State shall be formed or erected within the Jurisdiction of any other State; nor any State be formed by the Junction of two or more States, or Parts of States, without the Consent of the Legislatures of the States concerned as well as of the Congress.

Consider historically that the State of West Virginia was carved out of the State of Virginia during the War Between the States. Constitutionally, I would suggest that the statehood of West Virginia was done illegally even though the State of Virginia had seceded. While the seceding states were returned to the Union after the War, Virginia remained as two separate states.

So what would the process be for a division of California? After an affirmative vote by the citizens of California it would be considered by California legislature, the California Supreme Court and then Federal and even the Supreme Court of the United States. If the division was successful then there would be two Senators from each of the three states, assuming those Senators then in office would occupy seats in their respective states. Because House representation is based



on population there may be some change in House membership since populations would shift even though they would grossly be unchanged.

Should the vote pass and as well in the California legislature and California Supreme Court I would think there would be opposition by most or all Republican Senate and House members. But at this point while I cannot look into a crystal ball and foresee the thinking of the United States Supreme Court. I think the allowance of separation of statehood of California would be a dangerous precedence to other states. What if the state of Huntsville (Alabama) were to come to exist? While it would be a relatively affluent and conservative state, it would definitely damage the economy of Alabama and I can see the possibility of some areas of other states that feel they bear a greater economic burden or simply have a very different way of thinking wanting to break away as well.





representatives for the thirteen colonies came together in June and July of 1776 to consider severing their allegiance to their mother country, now considered an oppressive government. They pledged their lives, fortunes and sacred honor and risked conviction for treason in order to gain liberty for themselves and posterity. On July 4, 1776, the Unanimous Declaration of the Thirteen United States of America was passed unanimously. Eleven years later, the Constitution was framed, based upon its principles.

These dates are more important than most of us realize. On July 4, 1776, a nation was born, whose citizens have enjoyed a greater degree of civil liberty than any other previous nation in history, since the nation of Israel in the Old Testament.

Samuel Adams, called the Father of the Revolution, after signing The Unanimous Declaration on August 2nd said that:

We have this day restored the Sovereign to whom all men ought to be obedient, and from the rising to the setting of the sun, let His kingdom come.¹

Is it true that with the birth of our nation, the Sovereign God was restored to His rightful place in civil affairs? Did this act allow His kingdom to come on the earth in a fuller measure than previously? Let us explore these questions more fully.

Take 30 Minutes

Take time to read the actual document and examine how its principles are timeless, giving us wisdom for the restoration of our great nation.

In addition to the indirect references to God and Biblical principles, there are four direct references to God in The Unanimous Declaration. The first reference that we come to is the phrase, "laws of nature and of nature's God entitle them 'This is a powerful statement indicating God as the Supreme Lawgiver. The "laws of nature" refer to the laws that God made that apply to all men, that can be known even if one does not have God's written revelation.

These include laws against murdering or stealing. This natural law condemned Cain for killing his brother, many years before God put in writing, Thou shalt

The "laws of nature's God" refer to the law of God as codified in the Bible written revelation. America's founders taught that men were to be subject to the Supreme Lawgiver and to His Law, His Word. They knew that only then would the Lord, the first Founding Father, bless this new nation. As George Washington stated in The First Inaugural Address, "the propitious smiles of Heaven, can never be expected on a nation that disregards the eternal rules of order and right, which Heaven itself has ordained . . . "2

Volumes have been written on the preamble to *The Unanimous Declaration*, particularly concerning this sentence:

that they are endowed by their Creator with certain unalienable rights, that among these are life, liberty, and the pursuit of happiness.

We hold these truths to be self-evident, that all men are created equal,

The truth that all men are created equal is derived from the Bible, and for the first time in history, an attempt was made for a nation to live by it. We also observe that the authors of this document declared their belief in and reliance upon God, the Creator. This is a powerful affirmation, for He who creates must also sustain. This is why they often referred to God as their provider by calling Him *Providence*. Finally, they also indicated God as the all–powerful Creator who alone is the author of rights, which (since man does not grant them) cannot be taken away. This was a deliberate and bold break from the past, for in the history of mankind, civil government always established itself as the grantor of rights.

The next section of the Declaration details that right, and even duty, of the people to properly steward their civil government. Just as the people are to steward themselves (self-government), their family (family government), their church (church government), and their voluntary associations (voluntary government), they are also to steward their civil governments. This is a responsibility given to them by God, and they must alter or abolish their civil government as is necessary to bring it into conformity to Biblical principles. In I Samuel 12, we see Samuel giving an account of his judgeship to the people. He asks to be judged by the people, that they may have an opportunity to be stewards over their civil government. Of course we know that they chose foolishly by asking

for a king, and they were judged (I Samuel 12:19).

Tyranny Exposed and Rebuked Thomas Jefferson once stated, "God who has the power to force us to do His will, didn't." The essence of tyranny in civil government is the abuse of power. The next section of the Declaration lists the abuses of King George. The list is quite extensive and makes very interesting reading, especially in light of

ments today that are exercising powers beyond their Biblical jurisdiction, we would have quite a long list as well. Let us enumerate a few examples, appropriate to America today:

Establishing A Secular Culture

- 1. Demanding an application of the "separation of church and state" that effectively denies many public expressions of Biblical Christianity such as displaying Christian symbols and public prayer
- 2. Favoring non-Christian expressions over Biblical ones

Suspending Assemblies

- 1. Persecuting, harassing, and in some cases closing down Christian schools and homeschools
- 2. Forbidding Bible studies, prayer, or other expressions of Christianity in government schools

Usurping Power

- 1. *Judicial activism* effectively turning judges into lawmakers.
- 2. Executive orders that greatly expand the power of the executive branch beyond its constitutional limits
- 3. Mandating school attendance through compulsory education laws, usurping the rights of parents

Harming The Citizens Through Policies And Practices

- 1. The establishment of public schools producing millions of functionally
- 2. Overstepping its jurisdiction and passing many laws thought to protect us (seatbelt and helmet laws, mandatory vaccinations, minimum wage laws, etc.)

Economic Tyranny

- 1. Interfering in the free market in myriads of ways
- 2. A taxation rate that is way beyond what is Biblically considered tyrannical (e.g., 10% was considered tyrannical: see I Samuel 8)
- 3. False philanthropy: multitude of wealth redistribution plans that effectively steal from some to give to others

Violations of Conscience

- 1. Enforcing attendance in government schools where unBiblical ideas are diligently inculcated on a daily basis
- 2. Taxpayers forced to finance such things as government schooling, welfare and abortion
- 3. Removing rights of health care providers to refuse to perform procedures to which they are opposed

God Is The Supreme Judge

After pleading their case by listing the grievances against King George, the signers of The Unanimous Declaration submitted their case to the Judge. They knew and recognized the fact that there existed lesser judges, however their case was being tried before the Supreme Judge of the world, the Lord Jesus Christ. "Appealing to the Supreme Judge of the world," indicated that God is the ultimate and supreme Judge, who is judged by no man, yet stands in judgment of all, including civil rulers and governments. When it was stated that they were appealing "for the rectitude of their intentions," this indicated that they believed that they were declared righteous; that is, that they were acting in accordance with God's Word and the King was not.

The Unanimous Declaration was as much a declaration of dependence as it was a declaration of independence. God used Dr. John Witherspoon, Presbyterian pastor and later President of the College of New Jersey, to add the phrase with a firm reliance on the protection of Divine Providence. This indicated that their hope and trust in this life is not in man but in a God who cares for His creation and watches over all, ordering their steps and intervening in their lives. We know that God did intervene many times during the long war to finally win their independence. They repeatedly acknowledged the evident protection of God. In so many circumstances they would have been defeated had not God miraculously intervened. Washington at one point was prompted to acknowledge this:

The great Director of events has carried us thro' a variety of Scenes during this long and bloody contest in which we have been for Seven Campaigns, most nobly struggling.³

Finally, they continued to act according to Biblical covenant as they vowed to, "mutually pledge to each other our lives, our fortunes, and our sacred honor." Of the 56 signers, many of them would soon lose their lives, and many would have to forfeit their wealth. There is a cost to liberty, and they were more than willing to pay it.

It is the common fate of the indolent to see their rights become prey to the active. The condition upon which God hath given liberty to man is eternal vigilance; which condition if he break, servitude is at once the consequence of the crime and the punishment of his guilt.⁴

As Biblical Christians, God is holding us responsible for the stewardship of the liberty He has given us. Accordingly, there are questions that we need to ask



Alabama Power finally 'zaps' the Canary in the **Drummond Mine:** time to 'dissolve' the BCA...



Bill Britt (4/18/18 Alabama Political Reporter) stated current and former BCA members thought the board's vote to demand Canary's resignation was good news for the State's future and those close to the process were angry Chairman Hand wanted to keep Canary until the fall. APR's sources said this was an attempt for the BCA to further influence election outcomes. The plan was to control campaign donations and win enough races to stage a comeback. Hand seemed willing to risk everything protecting Canary, one source said other BCA board members saw no upside to challenging the seven most influential

A political operative who speaks regularly with individuals at BCA said staffers see the future as unclear if not fatal. "It's time. "We are at risk of losing our biggest members, which basically mean we are swirling around the toilet waiting for one more giant flush all because of this guy [Canary]," said a staffer.



another source who said these corporations may not immediately leave BCA altogether but would substantially reduce their dues payments to around \$1,500 to \$2,000 a year instead of the hundreds of thousands or millions they presently The *APR* article made a compelling forecast; if the threat came to fruition,

"I'm sorry, it's time for a change," as quoted in the APR article further noting

it would cripple BCA at a critical time when Alabama is rebuilding after the failed leadership of Canary and his minions. Some of those demanding Canary's resignation (most notable Alabama Power, Blue Cross Blue Shield and Regions - the only Fortune 500 Company headquartered in our State, last I checked) exiting leaves a 'power vacuum. What will fill that vacuum is what political insiders, swamp monsters and other big govt. redistributionist are buzzing about "What was amazing," according to APR's person with intimate knowledge

of the meeting, "is that there were executive board members who had no idea there was even a problem with Canary." Over the last several years, Canary has painstakingly stacked the board with members who don't pay attention to politics and believe Canary has been leveling with them on every issue. The 'seven sisters' voted to remove Canary but Chairman Hand and a few loyalists refused to act, concocting schemes to give Canary more time. Establishment apparatchiks of Riley, Inc. and the BCA (BIG Business Council of Alabama as Sen. Rice recently dubbed the organization) have shown great acumen circumventing the will of members and general welfare of our citizens. From my vantage point it seems many individuals are BCA members for insurance purposes (think Felon Hubbard getting well rewarded for mandating auto insurance) providing a decent revenue stream from those not paying attention to the corruption they're subsidizing. "If these guys give Canary a day beyond May, it shows that Canary and

Hand have outfoxed the big players," said one of *APR*'s informers. In addition to prominent corporate leaders, the article claimed no secret US Sen. Richard "Cash-register" Shelby made his disdain for BCA's leadership clear since being outed in Felon Hubbard e-mails. Shelby made it widely known Canary was no longer welcome in his office; loss of access means avenues to accomplish corporate welfare redistributions from the District of Corruption unlikely. "Sen. Shelby made calls letting folks know that he was done with Canary," said a close advisor in the APR report. Canary, a Washington political insider in control. Canary was a political hack who would carry out dirty tricks and chicanery for George W. Bush and Karl Rove. Bob Riley and Mike Hubbard controlled the BCA through Billy Canary. Riley still continues to pull the strings and make money. Under Canary's and Riley's reign, BCA has abandoned its mission of supporting business and the general well-being of the state and now, in the opinion of many, does more harm than good. Billy Canary's leadership goes past simple failure and begins to enter the realm of causing real harm to the state and the businesses he represents. Canary once boasted of his position on convicted Speaker Mike Hubbard's "kitchen cabinet." However, in the Hubbard trial, Canary was less than convincing on the stand as his memory fades on issues discussed with Hubbard. Some of those issues were part and parcel of the 12 felony convictions that removed Hubbard from office. Most folks expected Canary would be indicted with Hubbard. Now, BCA and Canary face possible involvement in the north Birmingham corruption investigation that has already resulted in one House member's confession to crime."

Columnist Flowers further explained, "Some observers believe the scandal surrounding an anonymous ethics complaint that scuttled Dr. Craig Pouncey's bid to be the state superintendent of education may lead back to Canary. The Board of the BCA and everyone concerned with the future of Alabama should be asking why in the world Canary has taken a once proud and effective organization into such controversial issues that have so little to do with core business interests. The answer is simple - Billy Canary has numerous conflicts of interest. During his tenure as president of the BCA, Canary has continued to maintain outside consulting contracts that pose clear conflicts with his role at BCA. However, this should come as no surprise since Billy Canary's home is New York." No doubt Canary (inserted by Boob Riley soon after his installation as Governor) and Felon Hubbard are kindred spirits in this regard.

Alabama Power withdrew from the BCA, "effective immediately," according to a letter from CEO Mark Crosswhite dated June 18th. Dennis Pillion (dpillion@al.com) cited the letter where Crosswhite wrote Alabama Power exited the powerful business group because the organization had "needlessly alienated federal and state officials, failed to communicate with its own members, squandered our collective corporate goodwill, allowed its financial health to decline, and become a divisive force in our State." The letter was addressed to BCA Chairman Perry Hand, stating the power company had expressed concerns with BCA leadership since August 2017, with "no meaningful response," and "At this point, further discussions would be fruitless and a waste of everyone's time." Crosswhite further explained Alabama Power was a founding member of the BCA, but the company has become "concerned that membership in the BCA has become a liability rather than a benefit." The BCA released to AL.com a letter addressed to Crosswhite in response to Alabama Power's decision, saying the utility had not been a member of the group since April because of nonpayment of dues... still no shortage of hubris in the BIG Business Council of Alabama's upper level bureaucrats even as they see the 'seven sisters' disengage. The exchange describes numerous conversations between Crosswhite and

BCA leadership, in which the letter says Crosswhite "asked that the committee remove our President and CEO [William J. Canary] by May 1 or June 1." Political insiders intuit the importance of the dates with the election cycle. According to Pillion, the letter says the BCA Executive Committee was scheduled to meet this week to approve a "transition plan" aimed at "having a new CEO installed no later than January 1, 2019." The timing is important. This is a fight to the death to get an AG and appeals court judges to bailout Felon Hubbard and protect his unindicted coconspirators. Massive amounts the BCA plowed into the final days of the (Bentley installed) Marshall campaign to make sure two malleable candidates made the Republican primary run-off AG race speaks for itself. With the help of always last place Bedsole's huge 'I'm the Trumpiest' ad blitz, the small government/anti-corruption voters easily duped by big govt. Democrats (like Regan, Shelby, Trump, et al) turned Republican rhetoric made sure the AG candidate who's actually disciplined the BCA was boxed out. They further quoted two Republican State senators affirming the withdrawal is a major blow for the BCA. "That's a big deal," Sen. Cam Ward [R-Alabaster] said. "That's a big seismic shift there. I think the question is now, where does the Power Company go? Do they create a whole new organization? Do they maybe join another organization out there? There was an assumption that when the Republicans took over the BCA got everything they wanted and that was never really the case. And a lot of that had to do with the changing nature of the Republican Party. You had a lot of populist folks who kind of honestly resented some of the ways that BCA may have tried to persuade them to vote for an issue one way or another." Sen. Dick Brewbaker [R-Montgomery] noted BCA relationships with some

lawmakers had become strained. He said (still to AL.com) BCA's support of Common Core curriculum standards in schools has also caused some friction. "Some of the positions they've taken on things that didn't have anything to do with business, whether it's Common Core, or autism, or issues like that, it generated a good bit of ill feeling among some Republicans. And I'm sure that hurt their ability to pass legislation in the state Senate," Brewbaker also affirmed losing Alabama Power membership is significant in the following quote. "If you're the on the board of the BCA -- and I'm sure the Southern Company is probably the biggest business interest that operates in Alabama, I can't think of a bigger one -- that is a huge deal."




IN MEMORY OF TED SOPHOCLEUS

The purpose of a law, any law, is a singular objective—protecting people from the wrongdoings of other people. To be moral, just, legitimate, and Constitutional, it must meet that criterion. Otherwise, it is usurpation and oppression.

Laws that are obviously just are those against murder, bodily harm, theft, destruction, and any other actions that hurt or violate other people and/or their property. These can be readily understood by any civilized person. Common sense dictates that only a few laws are needed to protect people in this manner.

But we all know that all over the world, we have an enormous hodgepodge of laws that are fundamentally and morally wrong—that instead of protecting people, they protect specific groups and often allow them to violate other people. The presence of laws that violate legitimate laws has been stated as an "insurmountable conundrum of all statist philoso-

phies." Examples can be found everywhere. In many cases, people who enforce our laws are often

allowed to do things that would land most people in

prison. A classic example is civil asset forfeiture, a

law that allows police and others to plunder innocent people at will. Enforcers have seized millions of dollars from thousands people on real or imagined pretenses that the money (or property) was in some way connected to a crime. This same law is also structured to make recovery very expensive and extremely difficult. (Did you know that nearly every Federal Reserve note in your pocket will test positive for traces of cocaine and other illegal drugs?)

Less extreme examples are much more common. Nearly everybody at some time or another has received at least a few unwarranted traffic citations. Over the years, the fines and court costs have skyrocketed from minor inconveniences to major financial losses. Points against drivers' licenses and increases in insurance premiums impose additional burdens. Safety regulations have been another sore point.

Every individual is responsible for his own safety. It is his right to judge his actions and the risks he is willing to take. Government has no business or right to interfere unless these actions can be proven to be dangerous to others.

Over the years, government has had less and less respect for private property. Eminent Domain abuses have been on the rise for several decades. Authorities have arbitrarily declared that some properties are "wetlands" and have imposed draconian restrictions on their uses and development. Municipalities have

instigated hostile annexations of outlying properties

and then imposed zoning and other land use restric-

tions in addition to jacking up the property taxes,

ostensibly for city "services" that the landowners

never wanted.

The really scary bottom line is that politicians never tire of creating more and more reams of new oppressive laws. Some, like consensual "crime" laws (recreational drugs, prostitution, gambling, etc.) are widespread. Others are so absurd that anyone with common sense cannot imagine why they should ever exist. Certain communities in California have prohibited residents from collecting the rainwater that falls onto their houses. Some in Florida won't let homeowners grow vegetable gardens in their front yards. Still others prohibit mini-wilderness spots on vacant lots and back yards.

There is an old saying that ignorance of the law is no excuse. In times long gone, when nearly all laws were reasonable, brief, and few, compliance was not very difficult. But with today's huge volume of mostly illegitimate and unconstitutional laws, compliance is utterly impossible. One source claims that the average American commits about three felonies every day. What would they be? Your guess is as good as mine. Enforcement, of course, is also utterly impossible. Otherwise, every one of us could be in prison.

If our legislators really want to do something to improve our state, they should forget about concocting piles of new laws. Instead, they should first seek out abusive laws that should be repealed, and then draw up bills to do exactly that.

I strongly recommend that everybody read a small book, *THE LAW*, by Frederic Bastiat. It is an all time classic, and it is just as pertinent now as it was when it was written back in 1850. If I was a teacher in high school or college, it would be

required reading for every single student. THE LAW can be read and downloaded for free at several web sites.

At an early age, John was exposed to his daddy's interest in tennis. When John's parents moved to Selma he was in the sixth grade. Tennis courts were more available there. John participated in all sports throughout junior high school. But, the real lure of tennis got stronger as he read about all the tennis greats and saw pictures of them in action magazines. By the time John was in high school he was the best player in Selma. He organized and captained the tennis team at Parrish High School.

When John qualified for the National Junior Championships while playing for Parrish High School in Selma, he was excited. So, he went to talk to his father about going to the tournament. He said, "Dad, I really would like to go to this tournament." His Dad looked at him with a not so favorable look and said, "Boy you've got to work in the store on Saturday."

That was the end of that. John worked in the store that Saturday.

From 1952 to 1957, John played on the University of Alabama Tennis Team. He was the number one player and captain for three years. After graduation he got his first taste of national competition by competing in

the Southern Men's Circuit and National Clay Court Championships with partner Ray Senowski. They took one of the best doubles teams in the country to three sets. In 1957 and 1958, he was on the winning team of the Chicago Pro Doubles two years in a row. In 1964, he and Nadine Netter won the Eastern Mixed Doubles Tournament.

John's career is so hard to comprehend that I think it is best understood in chronological outline form. My most interesting story was when John was the tennis pro at The River Club in New York City from 1964 to 1967. It was there that he taught private playing lessons to Bishop Fulton J. Sheen, Senator Robert Kennedy, Jacqueline Kennedy, Dina Merrill, Cliff Robertson, Mildred Natwick, Huntington Hartford and James Van Allen. How about that!

It would take three columns to

due justice to the tennis exploits of John McWilliams so we decided to show what we could in pictures, and list some of his many accomplishments:

- Called service line during the U.S. Open for four years. Called service line when Rod Laver won his first Grant Slam in
- Officiated and umpired matches on the Jack Krammer Pro Tour, The Pan American Games and the National Clay Court Championships.
- Conducted clinics in Chicago with Althea Gibson at Comenski Park.
- Narrated a history of tennis at the Worlds Fair in New York.
- Director of Tennis Sales and Promotion for Wilson Sporting Goods in New York City 1958-1964.



Coach McWilliams thanks Tennis Pro Rod Laver for coming to Huntingdon in 1994 to play an exhibition and conduct a clinic. Laver won the Grand Slam of tennis twice, in '62 and '69. Laver is the only player in history to win the Grand Slam twice.

In 1972 John came back to Selma to begin a new venture in tennis. He began a coaching career that has never really ended.

He was hired at Marion Military Institute in 1980 where he coached the college and the high school teams. His high school team won the State Private School Tournament in 1987 and his college team qualified for the National Junior College Tournament 1988 and 1989. While at Marion, he founded the Alabama Tennis Academy, which attracts young people from all over the south-

east.

The last stop on this extraordinary journey brought John McWilliams Montgomery as the head coach of the men's and women's tennis teams at Huntingdon College. John was never just a head coach even as much as that entails. He



held camps and clinics all over the state. Ever the promoter, John was able to bring the great Rod Laver to Huntingdon for an exhibition and clinic on the Huntingdon Campus in 1994. Rod is the only player in tennis history to win two Grand Slams.

Today, John is content to occasionally "coach" his granddaughter, Anna and her daddy John IV. It is my belief that John enjoyed teaching the young children more than any of his accomplishments. He has devoted the

later part of his life developing young tennis players. His "Tennis Across **Montgomery"** has involved thousands of young tennis hopefuls just like he was when he got started in Selma over seventy-five years ago. At the age of 84 John McWilliams, "Coach" McWilliams. can talk tennis as long as you can listen. But, he can't play very well anymore. He has earned the right to rest for a while!

Conservation is Now the Key to Outdoor's Future

Conservation. It's a word with a whole lot of different meanings to different people. While the general idea might be the same, it's a distant after thought for many Americans. To those of us in the outdoors, hunting, fishing, hiking or camping, conservation is a constant effort to maintain the precious resources we

As a member of QDMA, conservation is one of my primary goals. After all, you can't go deer hunting if there aren't any deer left! The amount of research and education we invest in is tremendous, but the constant effort pays off in spades. We've seen Alabama become, and remain, a deer hunting destination, which brings in plenty of cash flow to both our State and local businesses. With careful management, it'll surely stay that way, too.

There are plenty of challenges, of course. Chronic Wasting Disease, or CWD, is a serious illness that can absolutely decimate a deer population. It spreads easily and quickly throughout the herd, silently eliminating the deer population, out of our sight. Careful management and regulatory action can help stymie the spread of CWD, and Alabama has so far been up to the challenge. Keeping deer from being brought across state borders, for instance, has been a wise move.

Speaking of regulatory action, Alabama's red snapper season is going incredibly well, so far. There are some real big fish being caught down in the gulf, and we have our state government and its it's hard working officials to thank for that. The federal regulators wanted to keep us to a meager handful of days to fish, using the data they had. However, through programs like Snapper Check, the data obtained convinced the powers that be to let the State determine the season for itself. Conservation, when all the gears are moving smoothly, lets us enjoy our hunting and fishing heritage, not only today, but tomorrow as well.

Naturally, we've still got plenty of work ahead of us. As most of you Turkey Hunters know, we're in the middle of a rough spot for turkey conservation. Simply put, there ain't a lot of turkeys out there. Both the experts and us good ole boys agree that something is going on out in the woods, and it's going to take some work to address it. Between habitat loss, over predation, and some unusual weather, the turkey population has seen better days. If we drop the ball on this, we will probably end up like it was decades ago, when seeing a bird was near a miracle, much less harvesting one.

Fortunately for both the critters and us, there's a lot of help to be given in the name of conservation. Private organizations like QDMA work hard everyday to help improve and maintain deer herd numbers and quality. The state also has plenty of fine folks in charge of public lands and the wildlife in our state, doing everything they can to protect what resources we have.

Ultimately, the responsibility for conservation falls to each one of us individuals. If hunting, fishing, and other outdoor activities are gonna be around to enjoy for years to come, we've all gotta work together to see it through. My work with QDMA has only strengthened my resolve to help maintain what we have, and I encourage all of you to keep conservation on your mind this year, going forward. Engaging in programs like Game Check, Snapper Check, and the like can only help out the cause. If you're fortunate enough to be a part of an organization like QDMA, spread the word and study up.


American Badger

An American Badger, are they considered fearless and vicious as we have portrayed them for years? The answer is they are no less vicious than any other animal when it comes to cubs, food or dens. However, there is another badger species that carries that title with full respect of all species. It's the Honey Badger, considered the most fearless and vicious of all badger species. The American Badger is a brown fur-covered mammal with short legs and low profile. The head appears pointed and small for the body. They have short ears and a short, furry tail.

Badgers weigh 10 to 20 lbs. The body is flattened, and the legs are short and stocky. The fur on the back and flanks of the animal ranges from grayish to reddish. The ventrum is a tan color. The face of the badger is distinct. The throat and chin are whitish, and the face has black patches. A white dorsal stripe ex-

tends back over the head from the nose.

Badgers are found primarily in the Great Plains region of North America. Badgers occur north through the central western Canadian provinces, in appropriate habitat throughout the western United States, Badgers prefer to live in dry, open grasslands, fields, and pastures. Badgers are also known to live in open



Badgers are carnivorous (meat eaters). They eat a variety of small animals, including pocket gophers, ground squirrels, moles, marmots, prairie dogs, wood rats, kangaroo rats, deer mice, and voles. They also eat insects and birds.

Badgers are solitary animals that are mainly active at night. They tend to be inactive during the winter months. They are not true hibernators, but spend much of the winter in cycles of torpor that usually last as long as 29 hours. (Toper: a state of motor and mental inactivity with a partial suspension of sensibility.)

Badgers are known to be excellent digging machines. Their powerfully built forelimbs allow them to tunnel rapidly through the soil and other substrates. They construct underground burrows for protection and sleeping. A typical badger den may be as far a 9 feet below the surface, contain approximately 32 feet of tunnels and an enlarged sleeping chamber. Badgers use multiple burrows

within their home range. If threatened, they attack explosively with hissing, growling and biting. Mating occurs in late summer or early autumn. The actual gestation is only 6 weeks. They have litters of 1 to 5 offspring, with an average of 3, born in early

spring. Females are able to mate when they are as young as 4 months old, but

males do not mate until the autumn of their second year. Most females mate after their first year. Female badgers prepare a grasslined den before giving birth. Badgers are born blind and helpless with only a thin coat of fur. The eyes of the youngsters open at 4 to 6 weeks old. The young are nursed by their Ron VanHerwyn mother until they are 2 to 3 months old. The



cubs (young badgers) may emerge from the den as early as 5 to 6 weeks old. Juveniles disperse at 5 to 6 months.



a steady decline in memory. Nearly 5 million Americans have Alzheimer's or some related illness, i.e., Autism or Down Syndrome which is occurring more and more and also needs to be addressed. No matter what illness vour loved one suffers from, the Montgomery County Sheriff's Office is committed to assisting the community one day at a time to make sure your loved one is safe!

WORKING TOGETHER

By agencies working together and pooling their resources in order to find ways to help people that suffer from memory impaired illnesses; our plans are to issue bracelets to everyone that suffers from a memory-impaired illness. With that being said, if one of the registered persons in the program wanders off, anyone that comes in contact with your loved one will know who to contact. The main contact person on the bracelets will be the Montgomery County Sheriff's Office. It will also contain a personal pin number that is registered to the victim. Once contact is made with the Sheriff's Office, we will notify the caregiver of their location. There has been incidents when a person has wandered to another state. These bracelets will let law enforcement officials or any agency from any state make contact with us, making sure your loved one is returned safely.

PLEASE remember this is not a program to find out personal facts or information about a person, but a program to help a caregiver find and return a loved one. The Montgomery County Sheriff's Office is dedicated to working with you to make this happen!

TECHNOLOGY BRACELETS

Sheriff Cunningham has a Deputy assigned to the program for registration. This program was founded in April 1999 by the Chesapeake Sheriff's Office. It uses state-of-the-art personalized radio transmitters on identified persons who are at risk of wandering away from their homes and becoming lost.

These are the statistics from the National Alzheimer's Association:

60% of people with Alzheimer's disease wander and become lost 75% are repeat wanders

46% may die if not found within 24 hours

Hopefully with the use of these transmitter bracelets to assist victims that have a history of wandering, we can reduce the national statistics here in Montgomery County. Also with the use of the identification bracelets we will be able to let the caregivers know that we care about the safety of their loved ones!

Sheriff's Office APP

The Montgomery County Sheriff's Office has a new phone app called "Montgomery County AL Sheriff" that can be accessed through your



phone's app store. Once you have added this app to your phone, you can easily set your phone up to receive important push notifications. Push notifications are quick, important messages that can notify you of road closure(s), blocked road(s), anything pertinent to your travel, escapee, etc.

While our app can help you with many things including checking to see if someone is in the county jail, it is most helpful to receive push notifications. After you have downloaded the app, go through the following steps to make sure your phone is set up to receive the push notifications:

- Go to your phone's setting icon Scroll down and click "Applications"
- Scroll down to "MCSO" or "Montgomery County Sheriff"
- Click "Application Manager", if it doesn't take you directly to the
- location Click "Notifications"
- Turn 'on' "Allow Notifications" and "Previews in pop-ups"

You should be all set to receive the Montgomery County Sheriff's Office push notifications!





Remember when if you heard bells jingle you ran to the street to get your favorite frozen treat. There are not enough Good Humor trucks roaming the neighborhood now a days, and that is a shame. We have to go to the store to get our favorite treats. Like a Drumstick; a cone filled with ice cream and the ice cream sticking out is dipped in chocolate and then peanuts. A real treat is when you get to the bottom of the cone and there is a chunk of milk chocolate waiting for you. Fudgsicles; not really chocolate and no special coating, just to die for decadence of industrial chocolate taste and density to keep it from melting too fast. Just slow enough to keep it from dripping all over you. Well sometimes. Some people call them Creamsicles, I call them Dreamsicles. Maybe because I dream of them every summer. Where else can you mix dairy and citrus and freeze it on a stick? A Pushup Pop was a good substitute for an ice cream snack if there was some flavor besides vanilla. I am not a fan of vanilla ice cream. Klondike Bars; How far with you go for a Klondike Bar? This treat has been around since the 1920's and can be found in about any grocery store, gas station, and convenience store and in dozens of different flavors. Also, found in my freezer in any of these flavors, Mint Chocolate Chip, Krunch, Rocky Road, Heath, and Oreo.

Another sign of summer is the menu for our supper club this month. The entrée is Conecuh dogs and hamburgers. I'm bringing a grilled appetizer, but I am not sure what I will grill. The bag of small colorful bell peppers always lends itself to some sort of appetizer. Halved and laid out like little boats and then stuffed with whatever tickles your fancy and then grilled produces a perfect finger food.

I was scrolling through the internet looking for ideas and noticed a new crop of recipes for hamburgers. You heard of the IHOP-IHOB publicity brew ha-ha? Well the reports I read were favorable. The Big Brunch burger is a soft brioche bun with a special sauce, sound familiar. Loaded with a hash brown patty, then a patty of Black Angus, American cheese, hickory-smoked bacon and then an over easy fried egg.

Restaurants are required to follow food safety rules, even when serving an over easy egg on a hamburger. However, with the Fourth of July barbecues, picnics, and other outdoor eating events it is important to you pay attention to the time and temperature rules. The CDC says there are 76 million cases of food-borne illness every year in the United States. There is an easy rule to remember to keep you and your guests as safe as possible. If the temperature where you are having your outdoor soiree is below 90 degrees, the food can stay out for a maximum of 2 hours. If the temperature is above 90 degrees then a maximum of one hour is allowed. There is still another catch. If the food is in direct sunlight, these rules do not apply. Sunlight will heat up the food very quickly. Even dishes such as salads need special attention. Remember a few items that can stand the high temperatures of an outdoor feast are condiments, like hot sauce, mustard, catsup, and relish. Butter will melt but will be safe, and pickles have enough acid to keep the bacteria at bay. Over half of the food sold in the United States is grown in developing countries. Their safety standards may not be the same as ours. That is important if you are serving fresh uncooked items. And it can be a concern even for food items from the U.S. Remember romaine? Thanks be! our cookies and chips will be safe left out; just do not let them get wet.

Greek Pasta Salad with Sun-Dried Tomato Feta Dressing

Depending on the ingredients, there are plenty of salads that can be served outdoors. Acids in the dressings, the oil, and salt will help protect them. This salad is one to try. It is colorful is good for an outdoor meal.

Ingredients

- 16 oz. rotini Good olive oil
- 1 pound garden fresh tomatoes,
- medium diced 1 red bell pepper, chopped
- 1 yellow bell pepper, chopped
- 1 cucumber, sliced and
- quartered 5 sun-dried tomatoes in oil,
- drained
- 3/4 cup pitted Kalamata olives pitted and diced
- 1 pound feta cheese, medium diced

Serves 12

Feta **Dressing** 1-8.5 oz. jar sun-dried

- tomatoes in oil 1 cup fresh packed flat-leaf
- parsley
- 1/4 cup freshly grated
- parmesan
- 2 peeled garlic cloves
- 1/4 cup almonds 1/4 cup red wine vinegar
- 1 tablespoon lemon juice
- 1 teaspoon dried oregano
- 1 teaspoon salt
- 1/4 teaspoon pepper
- 1/4 teaspoon red pepper flakes

Instructions Cook pasta in generously salted water according to package directions.

- A high quality Feta makes all the difference in this salad. Taste several brands and take your pick.

hamburger patty connoisseur, try different mixtures of the meats used for the patty. A combination I like is to mix a pork sausage and beef. I have mixed a 50/50 ratio, of 1-pound ground pork breakfast sausage and 1 pound of lean ground beef. I freeze the 6-ounce patties and use them for both breakfast biscuits and for grilled hamburgers. Another tasty mix is a combination of andouille sausage and ground beef. Pulse a 4 ounce smoked fully cook andouille sausage in a food processor and mix with 12 ounces of 90/10 ground beef sirloin. While I was in college, one of my favorite burgers was the Yellow Submarine.

It was a patty formed with American cheese in the center. When you bit into the burger, the hot gooey cheese would run out. I found a recipe that is a very good upgrade from American cheese. It used pimiento cheese instead and you froze the cheese before you formed a beef patty around it. My upgrade would be using Jalapeno Palmetto Cheese.

Another rendition of the classic burger patty would be a Mexican chorizo Burger. You can buy Mexican chorizo but make sure you use a very lean ground beef. chorizo has a high fat content that renders orange oil when it cooks. I make my own chorizo using lean pork and I can adjust the seasoning. For me it has to be spicy and lots of garlic. Mix 6 ounces of chorizo with 10 ounces of lean ground meat.

Where you have a choice of ingredients for a hamburger patty, your choices when it comes to a hotdog is somewhat limited. There are different brands of hotdogs with some added ingredients, but you are limited. Where the artwork comes to play are the toppings you can think of for your hotdog. Wrap the hotdog in sliced pastrami, place in bun and top with sauerkraut and 1000 Island dressing and you have a Reuben Dog.

Here is a list of options that could would go on a hotdog. You may like it. Try Kimchi, Balsamic onions, Giardiniera, (it in the relish section of your grocery store), Furikake, (seaweed, sesame seeds and bonito), Old Bay, Peanut Butter, grilled pineapple, Mac and Cheese, Peaches with chopped green onions and a fruit chutney, to list a few. There is no hard fast rule that your hotdog bun has to have a hotdog in it. Ever heard of a Caroline Bird Dog? Chicken tenders, chopped bacon, cheese and honey mustard. If Chicago, can have a hotdog named for it, how about the Slow Cooker Pulled Pork with Alabama White Barbecue sauce, Conecuh Sausage Dog. If nobody has thought of that yet, I claim it! You will be hungry just trying to say it. Of course don't forget the sweet tea to wash it all down.

If I do not get to claim the Slow cooker Pulled Pork with Alabama White Barbecue Sauce, Conecuh Sausage Dog, I already have claimed this recipe and won First Place in the a cooking competition. It was years ago but it is still listed with my other award winning SPAM* recipes at Foodnetwork.com. The name for this recipe is about as hard to say as the Alabama Dog recipe.

Napa Valley Stuffed Grape Leaves With Six Pepper SPAM*, Fruit Relish and Pine Nuts. Recipe by David Spooner

Ingredients

One 12-ounce can SPAM* 1 teaspoon Six Pepper Spice, or mixed color peppercorns, plus more to taste 1/4 cup pine nuts 1 jar grape leaves

Makes four, serves two.

Yogurt dipping sauce 1/4 cup plain yogurt 1/4 cup strawberries, cleaned and hulled 1/4 cup fresh figs, and stemmed 2 tablespoons honey, plus more to taste



Fruit Relish

Directions

Place the **SPAM*** in a meat grinder, and grind until it reaches the consistency of ground sausage.

Blend until combined, adding more honey as desired. Set aside. Serve the steamed grapes leaves with the yogurt dipping sauce.


Fruit Relish:

Worldviews Shaping American Culture

Worldviews Shaping American Culture What's Your Worldview? You've got a worldview. Everybody has one. What's a worldview?

It's everything you believe about what's real and what really matters in life.

It's the filter by which we process all of our information. The lens through which we understand reality.

Ronald Nash in his book, <u>Worldviews in Conflict</u>, defines it this way: "A worldview is a set of presuppositions (or assumptions) which we hold (either consciously or subconsciously) about the basic makeup of our world." Can you name the top 3 worldviews shaping American culture?

Mikel Del Rosario, a Professor of Apologetics and World Religion at William Jessup University, recently wrote an article in which he outlines the top 3 worldviews in America:

1. Historic Christianity

This is the main version of something called ethical monotheism. This is the idea that God's real; that God created us and gave us a real moral law. And all people everywhere are obligated to obey the moral law—whether they want to or not. Some things, like loving your parents, treating others as you would like to be treated and telling the truth, are really good. Other things, like hurting a child, murder, lying or treating others unjustly, are really wrong.

The next two represent the major movements of the opposite camp.

2. Scientific Naturalism

What's this? Think X-Men. No matter how out there something might seem (like bending metal just by thinking about it), absolutely everything can be boiled down to physical processes (like a genetic mutation). This view says only the physical world is real. You're pretty much just your brain. And everything you do is just the result of things like your genetics and how you were raised.

Another key idea: Science is the only way we know things. If you can't measure something in a lab or use science to prove it, you can't know it. So



you can say you know Advil will help with your headache. But you can't say you actually know God exists.

3. Postmodern Relativism


For this one, think, "live and let live". All truth and reality is relative to you or your community: "That's true for you but not for me." It's supposed to be a feel-good, politically correct worldview where no one's perspective is ever wrong about anything—especially when it comes to spiritual things (unless you happen to think Christianity is actually true). Another key idea is words don't really mean anything. You decide what words mean to you.

These two worldviews agree you can't know things about stuff you can't see, touch, taste, hear or smell. This directly challenges historic Christianity which teaches that we can know the truth and the truth will set us free (Jesus, John 8:32).

So, there you have it. The top three worldviews shaping American culture: Christianity, Naturalism, and Postmodernism. Which one most shapes your views?

Whatever your worldview, a person's worldview can be changed. It happens all the time. People can perceive reality in a new way. When people change from being cynical, critical, and sarcastic to being trusting, kind, and gracious, it encourages us not to give up.

There's always hope...people can and do change!

and we felt it was best if it was combined into an existing leadership staff position. She will be able to make an immediate, positive impact on our conference and I am looking forward to working with



Suspended Chief Probate Clerk, "I'm not taking the fall for a con."

One reason Wilcox County stays broke is because people steal.

That is not in any way meant to take away from the gross mismanagement we've come to call normal, but theft happens too often and audits are too few.

The latest sin to slither out of the courthouse emerged when the bank called retiring Probate Judge Jerry Boggan and informed him that funds were not sufficient for the checks that were being presented.

Now I don't know, but I would think that in that very moment, the Honorable and kind Judge Boggan may have fainted.

There's some history.

Some nasty history I hate to bring up because it is in the past.

It is lumped in with a lot of other not so long ago ugly history that Wilcox County is – more or less – trying to get beyond. In 1999, Judge Boggan was removed from office – with pay as the law states – by the Court of Judiciary after being found guilty of depositing \$23,000 from the Probate Office account to his personal account. He then gave the appearance of returning the money with a false deposit ticket.

He was found guilty.

He was ordered to pay restitution.

And then the very next year, in 2000, Wilcox County voters put Judge Boggan right back in as Probate Judge where he patiently remains today, awaiting the runoff election set for July 17, that will begin his countdown to the sweet freedom of retirement.

But I still think he would have welcomed a couple of Tums and a sniff of whiskey when the bank called about the latest shortage in the Probate account.

Judge Boggan approached the County Commission with the matter at last week's meeting. Chief Probate Clerk, Shekita Jenkins, a resident of Camden, allegedly wrote a check to herself for just over \$12,234. She cashed the check in Thomasville.

Two other checks totaling \$5,985.94 were written to made-up names. Jenkins has been placed on suspension. This case continues under state investigation and audits are still ongoing.

Jenkins had been out on leave recovering after having a tummy tuck along with liposuction to her abdomen, flanks, upper and lower bra rolls, and inner thighs. According to a post on Jenkins' Facebook page, her procedures totaled \$14,250, and were performed by Dr. Curves in Atlanta.

Her surgery was a known fact to her co-workers and around town, but when the news of theft allegations became public, Jenkins became angry and commented under the article to me personally saying, "I will not take the fall for a con."

She eluded in other comments to Judge Boggan, possibly because of his well-known past transgressions.

But due to his past, paired with his being on his way out of office...maybe another con could be conning us.

Jenkins has since deleted her Facebook account.

Southern Gardening Potpourri for July by Peggy Givhan

SNAP. CRACKLE. POP. Firecrackers, fireworks and even laser light shows celebrate the 4th of July. We see flags displayed throughout towns and neighborhoods even red, white and blue market lights a blaze at night. Everyone wants to say Happy Birthday to our country in their own way, but please be aware of the dangers of the myriad fireworks. Always have a safety plan in case things go south.

Now lets turn our attention to the garden setting and size up what needs to be done. First of all, I am aware that much of the vinca, geraniums, lambs' ears, and other drought resistant flowers have drooped with the rainfalls and depressed sunlight. All of these plants need to dry out. My potted geraniums were in larger outdoor pots, which held water and just about drown these. Always check for soggy pots, and remove the plants before implementing drainage control. I just took out the smaller pots of geraniums out and drained to larger pot. My problem turned out to be a clogged drainage hole.

Gardening in the shade is one topic I am having more and more interest in since my neighbors' trees and my oak trees are practically forming a canopy over most of the area. I did have a tree man limb up some of the lower branches to let in more light, but now I have partial shade. In a border with the most shade, I have planted several varieties of hosta, along with hydrangeas as a back drop. Instead of impatiens or begonias, which are go to plants for the shady environment, I planted stands of coleus, Lime Wizard (lime colored), Volcano (rusty red), and Bellingrath (variegated green, salmon and cream) which are readily available varieties in our area. And to make the area look a little more dramatic, I added giant elephant ears in three spots.

I have always liked to have my cake and eat it too. And we can do this by designing portable flower centerpieces for the home. First of all measure your indoor containers, and obtain outdoor pots with drain holes to grow the plants. These can be terra cotta, black plastic or any type really. They will need to be smaller than the indoor container. If some of the outdoor container is taller than your indoor container, purchase Spanish moss to hide the edge. Now decide what flowers to plant that will fill the pot to be brought from outdoors to indoors and placed into the container. The pot can contain one variety of flowers, such as Dragon Wing begonias, or the newest variety of landscape begonia call "Big", or get creative with herbs and flowers, or flowers paired with trailing succulents. Referring to the landscape begonia "Big", the leaf shape is similar to the regular

mounding types, but much larger. I recently purchased a small tray which

are a beautiful creamy pink. You can experiment not only with different flowers, herbs, succulents, but also bulbs. Anyway, keeping the plants growing outdoors in the proper light situations, allows you to have instant indoor pots of flowers when needed.

PLANT OF THE MONTH--BLOOD LEAF (Iresine herbstii)

I have been reading some articles on tropicals, and ran across this plant. If you like giant fancy coleus, you will love blood leaf. It is a tropical perennial in zones 9-10 which would include the panhandle of Florida and even New Orleans I, but an annual in our zone 8. We would have to protect it in our winters. Blood leaf grows quickly and spreads up to 3' across.



The bright magenta foliage is quite a sight. It hails from Brazil, is tolerant of neglect, and grows well in bright shade,. To propagate, take cuttings to root, or sow the seeds in potting soil and barely cover the seed. The variety that is the showiest would be Purple Lady. My sister in Athens, Georgia has bought me a plant which I will immediately plant in a large outdoor pot. I will keep tabs on it progress and report later.




