### Five Good Horseraces Set For 2026

The 2026 election year began on May 19 when campaign fundraising could begin. Our elections will be May 19, 2026. Our Republican primary that day, and subsequent runoffs four weeks later, will be our election day for all statewide offices. Winning the Republican Primary for state office is tantamount to election in Alabama.

Qualifying for all offices next year will be in January. However, for all practical purposes, the primary races are set and the horses are in the chute. It will be a four-month sprint from mid-January to mid-May. All 105 State House Seats and all 35 State Senate Seats are up for election. However, State Senate and House Seats are becoming analogous to Congressional Seats. Very few incumbents are ever defeated, or even challenged. Over 80% of the legislature is running unopposed. There are only three to four open Senate Seats. The makeup of the State Senate will probably remain 28 Republicans and 7 Democrats.

Since all of our statewide offices are held by Republicans and will remain that way, the endorsements and campaign contributions from all of the major pro-business organizations in the state flow to the Republican candidates. These important groups are the Business Council of Alabama, Manufacturing Alabama, the Alabama Forestry Association, and especially ALFA.

Coach Tommy Tuberville has received all of the above organizations endorsements in his cakewalk tour to the Governor's office.

The brass ring of Alabama politics, the governor's race, will be uneventful given Tuberville's uncontested victory is inevitable. However, there will be a handful of important statewide battles that will be close, and the ALFA endorsement will be critical in those races.

The ALFA endorsement is golden in a statewide Republican Primary. It has been a pivotal gamechanger in almost every statewide race over the last decade. It gave credibility and impetus to the senate campaign of Tommy Tuberville six years ago. Their continuous endorsements of Governor Kay Ivey have been a fortress for her over the years.

This treasured endorsement is not easily given but earned. They also remain loyal to political figures who are loyal to them. They live by the adage that you do not leave old friends to make new friends.

To get the ALFA endorsement, candidates have to go to the county leaders in each

county and earn their vote and support. All 67 county ALFA organizations have the same vote. The hierarchy of leadership in Montgomery does not dictate the endorsement. It comes from the grassroots throughout the state.

The ALFA endorsements will be critical in the five close statewide races. These races are for Lt. Governor, Attorney General, Secretary of State, Agriculture Commissioner, and the U.S. Senate.

The Lt. Governor's race will be one of the best on the ballot next year. It will pit two very popular Constitutional officeholders striving to capture another Constitutional office. Secretary of State Wes Allen and Agriculture Commissioner Rick Pate will be the two horses in this contest. It is so close that it is difficult to say who is the favorite. One of the factors that will play out is if one of them can do a better job than the other in fundraising.

The Secretary of State race between current State Auditor Andrew Sorrell and dynamic political newcomer Caroleene Dobson began close but Caroleene Dobson may be moving ahead in this race.

The open Attorney General's race will be an important race to follow since this is one of the most important constitutional offices. Supreme Court Justice Jay Mitchell is favored to win because he will be endorsed and supported by the Alabama Business Community. However, Assistant Attorney General Katherine Robertson could be a player. She is being supported significantly financially by out-of-state dark money special interests. Blount County District Attorney Pamela Casey is working hard and is very well qualified but is lagging behind in fundraising.

The Agriculture Commissioner race will be one of the best. It will be a three-way horserace between State Senator Jack Williams of Mobile, Agribusiness woman Christina Woerner McInnis of Baldwin County, and Marshall County farmer Corey Hill.

The race for the open Senate Seat of Coach Tuberville will be the big race next year. It will pit Alabama Attorney General Steve Marshall against Congressman Barry Moore. Big Washington money will decide this race.

It will be a good political year.

**U. S. Senator Katie Britt Highlights Deadly** Consequences of Soft-on-**Crime Polices in Democrat-Led Cities** 

U.S. Senator Katie Britt (R-Ala.)

participated in a Senate Judiciary Committee hearing to address the problem of crime in Democrat-run cities across the country. Witnesses

in the hearing included Ms. Forlesia Cook, whose 22-year-old grandson was shot and killed in Washington, D.C. in 2017, and Detective Gregg Pemberton of the D.C. MetropolitanPolice Department and Chairman of the D.C. Police Union.

Senator Britt detailed Democrat-led policies that have left cities across the country increasingly plagued by crime, saying, "The problem that we're facing today was created by blue cities ... Whether it's cashless bail policies, downgrading classifications of whole categories of crimes, undermining rights and protections afforded by law enforcement officers like we saw in D.C. in 2022 ... Or creating systems to ensure pretrial releases of even the most violent offenders."

Senator Britt's first line of questioning was directed toward Ms. Cook: "Your grandson should still be with us today. And we need to utilize every tool in our toolbox to make sure that that is the reality for another grandmother somewhere in D.C. or wherever across this country. And you said today that when you told your story that no one heard you ... You said today, for the very first time, you feel heard. Can you talk to me about what it means with President Trump placing

emphasis on keeping our communities safe? What it means to someone like you who has lost someone, your very first-born grandson, so near and dear to your

Ms. Cook responded, "If we don't send the killer a message, then they're going to keep killing."

The Senator directed her second line of questioning to Detective Pemberton, asking, "You obviously are well aware of D.C.'s 2022 Comprehensive Policing and Justice Reform Act and the impact it had on the MPD ... From your experience, when you have elected leaders that undermine law enforcement, that don't seem to be standing shoulder-to-shoulder with law enforcement ... Can you tell me what that does on morale and what it does for recruitment and retention of law enforcement officers?"

Detective Pemberton answered, "I can, [it] is absolutely, unquantifiably the worst piece of public safety legislation that I have ever seen ... And I can tell you exactly what it did. It took us from nearly 4000 police officers to 3200 police officers in five years. We went from 30,000 arrests per year to 15,000 arrests per year. It created liabilities for police officers for administrative, civil and criminal penalties even when they do their job properly ... it made it so it's impossible to hold criminals accountable even when they're convicted of violent crimes. It has absolutely destroyed the police department in ways that I certainly don't have time to get

Senator Britt recently helped introduce the <u>CLEAN D.C</u>. Act, which would repeal the D.C. City Council's Comprehensive Policing and Justice Reform Act of 2022. Upon introduction, Senator Britt said, "In 2023, one of my staffers was carjacked and held at gunpoint, just one mile from our nation's Capitol building. D.C.'s crime rate is higher than the national average and even higher than that of many capital cities in third-world countries. To put it simply, anyone who says D.C. doesn't have a crime problem isn't facing the facts.'

### What is the use of a 529 plan and its tax implications?

I am not a tax attorney and this is an article for those that are drawn to the Alabama Gazette; not scholarly enough for my peers but based on my research and personal experience. I enjoy the many fine writers that contribute to this paper, but I do not count myself as one of those writers that draw Alabama Gazette readers back month after month. Regardless, I hope that you

as a kind reader will gain something from this.

The 529 plan is named after the Internal Revenue Code section in which this plan is derived (26 U.S. Code §529). Each state has a sponsored 529 plan, other type college savings or a prepaid tuition plan; the Alabama 529 plan is administered by Union Bank and Trust. There are almost 126,000 529 accounts open in Alabama, understanding that there may be multiple accounts open for one child

by parents plus grandparents or other relatives. My research shows that only about 35% of families use a 529 type vehicle or other non-standard savings plan for their kids higher education. The contribution is Alabama tax deductible. Though the plan contributions have already been taxed and provided that the funds are only used for educational purposes, then presumably the plan's appreciable income and dividends typically taxed for individuals are not taxed by the Federal government.

The 529 plan can be used to pay for tuition, books, other educational fees and housing provided the housing is associated with the institution. One would need to communicate with the institution to make sure the room and board is an eligible 529 expense.

Two months after my son was born I began to contribute to a 529 set up by our financial advisor. At a time when I should have been contributing a larger amount I started with a smaller amount not really considering the growth potential over time. On a whole your earlier contributions have an opportunity to grow by a larger percent rather than those contributions made a decade or more later. Union Bank has several investment strategy tiers based on your child's age and while I am not familiar with the details, I assume that the latter tiers take on more conservative approaches. After all, the investments are directed in the same manner as a prudent individual would invest and there is not only a good historical chance for real growth but understand that the 529 may also be affected by a bear or declining market. Certainly, one thing to avoid if possible is beginning to take withdrawals during a downturn in the economy.

While I have named several higher education costs that a 529 can be used for, there are many other circumstances in which a 529 can be used, some based on changes in the law such as the Secure Act of 2022. In addition to using 529 money for higher education, you can also use up to \$10,000.00 per year for K-12 schools. Such schools may be private, charter or public, but one would need to check with the school or your advisor on the specifics.

You cannot tax deduct in Alabama more than what is capped which is \$10,000.00

per year per set of married parents who file married and jointly on their taxes. Otherwise the tax deductible contributions are capped at \$5,000 per person.

When a child is very small, it is difficult to have any idea about your child's future educational needs. Will it only be a technical school, or will they do so well that scholarship money covers the majority of educational expenses? What if the child died? What if the child does not pursue higher education? The answers are as follows. The 529 can be transferred to a family member for educational use. One can withdraw up to \$10,000 to pay towards an educational loan. If the money is in the account for a minimum of fifteen years and the money is unneeded then the maximum contribution for a Roth IRA of \$7,000 per year currently can be placed in a Roth IRA provided that the beneficiary's name exists both on the 529 and the


Roth IRA. This can be done year after year until a maximum of \$35,000.00 has been rolled over. Imagine your smart kid that gets a lot of college paid for by scholarship and if as much as \$35,000 exists it can be rolled over to a Roth IRA at a maximum rate of \$7,000.00 per year. As an example, a 529 is opened and funding begins after birth. After contributing for fifteen years and say the child is a 10th grader with all A's. Should you strongly feel or know to some degree that the child should have significant scholarships available then you may thereafter set up a Roth, contributing \$7,000 per year for the next five years. In that scenario a Roth IRA such as this can grow significantly for retirement after a contribution of \$35,000.00 has been made and the child has only just graduated a four year college.

Looking forward to age 67 with no further contributions and a 6% average return could yield an amount approaching a half of a million dollars.

It's difficult to know the best answer for your child's educational funding while also funding for your golden years. You must use your best judgement and talk to professionals. A simple savings account will never yield the kind of returns a 529 has the potential for and you pay taxes on dividends. Unfortunately, it wasn't. Automakers and government meddlers continued experimentation and finally concluded that the most vulnerable spot in a car was the front passenger seat, where its occupant could be thrown into the windshield during a collision—IF he failed to fasten his seat belt. That aroused some makers to install an air bag in that

device that injures and kills people? Why wasn't the



But air bags anywhere else do little to prevent injuries and deaths. The steering wheel usually prevents the driver from hitting the windshield. Back seat passengers would strike the padded backs of the front seats. Inexpensive seat belts are ample here. Air bags are a gross, expensive overkill. They are far beyond the limit of the law of diminishing returns.

In 1998, government goons imposed the **Intermodal Surface Transportation Efficiency Act**, which mandated that all passenger cars and light trucks built after September 1 be equipped with driver and front passenger air bags. By 1999, car shoppers found it difficult to save that money with a new mass market car without them. In 2024 US dollars, they cost \$1879 each.

And finally, in later years, government mandates literally went "hog wild" and imposed thousands of dollars worth of excessive air bags about wherever they could place them.

There are some types of accidents where air bags are always utterly useless. In a collision with a semi truck's trailer, a car can easily "underride" it and strike the driver and passengers right on their heads, decapitating them.

The pipe dream of making our highways totally failsafe is just that. It is impossible. Every time we step outside, we take a minuscule risk of getting injured or killed by ways we can't even imagine. Life has always been that way. It will not change. We have to live with it. But our lives will always be far better when government nannies and do-gooders get out of the way and let free market innovations solve these problems without outside interference.

But as years went by, common sense went straight out the window. Government goons kept concocting and enforcing more and more extreme idiotic abominations only crazy bureaucrats could imagine.

Promoting Infrastructure in Early America

Two hundred years ago, the Erie Canal was finally completed, and to celebrate the achievement the Governor of New York and other local elected officials engaged in a progressive celebration.

They sailed from Lake Erie to New York Harbor with stops at communities along the way. It was like a 10-day tailgate with parties, speeches and all-day public celebrations, and it culminated in a ceremonial when water from Lake Erie was poured into New York

The completion of the canal was hardly inevitable. While not the first, it was certainly one of the major regional economic development activities undertaken by any government in America, and while there were some supporters for the project, their numbers were initially small.

Like most large, visionary projects there is always the first "idea man" who sees the potential and possibility and then sets out to make the vision real. In this case, the man was flour merchant, Jesse Hawley, who realized while in debtor's prison that if the farmlands in the western portions of his state could access an Atlantic port, they would have new markets for their produce.

Transportation was a challenge in the early days of America. Natural rivers provided the most efficient means for trade, but interior sections of the country, where rivers were not abundant, were limited to ground transportation. Roads were scarce and not well maintained, and transporting goods required pack animals that could travel only short distances. Depending on the topography, pack animals could cover a little more than 20-25 miles a day, as opposed to river barges, which could move significant quantities of goods could be shipped faster, farther, and cheaper. Pack animals simply could not carry the same weight with the same efficiencies.

Engineers in Europe had successfully built canals to solve this problem. In America, canals of short distances using small locks had been competently constructed, but the expense of larger canals was too great for private financing, so proponents of the first stages of the Erie Canal attempted to get the State of New York to bankroll the undertaking. Initially, the legislation went nowhere. When the idea was suggested to President Thomas Jefferson, he rejected the proposal as sheer madness.

Even with his creative mind, Jefferson could not envision a man-made public river spanning more than 360 miles that required cutting through rocks, clearing trees, and excavating uneven terrain. To make matters worse, there were no civil engineers in America to design the placement of locks up and down this expanse, yet Hawley refused to give up. With grand visions but little financing, he lobbied for the federal government to support various infrastructure projects, which would include his Erie Canal.

Even though the bill had wide support and passed Congress, President James Madison vetoed the measure on the grounds that it was unconstitutional as he did not believe the Constitution allowed the funding of infrastructure projects. He believed those were best left to the states.

Hawley then worked to enlist the support of New York Governor DeWitt Clinton, who realized this type of canal would link the western and eastern portion of his state to open up new trade routes. Despite opposition, Clinton became the champion of the project and worked to have the state issue \$7 million — more than \$200 million today — in bonds to finance the canal. The project would be derided as "Clinton's ditch," which initially seemed accurate given the struggles, setbacks and pit falls that occurred as the initial 15 miles of canal took more than two years to complete.

But Clinton persisted and did all he could to support the project. The canal would be the second longest in the world, and even today, something of this enormity would be considered an enormous undertaking. The magnitude of the project is even more astounding as there were only animals and human labor to cut through rock, fell trees, and dig navigable ditches. Construction equipment was limited, but with each obstacle, American creativity, if not ingenuity, succeeded. In fact, the construction of the canal created new means and methods of

construction techniques.

As the project moved forward and as each section was opened and utilized for trade, those along the route realized the communal benefits of the project. Once they saw the ease of moving goods along the canal, the possibilities became abundantly clear. Thomas Jefferson even came to embrace the project and the visionary wisdom of Gov. Clinton.


The canal was completed in 1825 following eight years of hard work. While the initial intent was to open up trade between Lake Erie and New York, the unintended consequences were even more promising in the growth and prosperity communities all along the canal. In addition to the ease of transporting goods, new businesses sprang up along the canal route providing even more goods to ship on the canal Tourism flourished as individuals and families curious about the canal explored the interior of the country staying at hotels and dining at restaurants along the way.

The project exceeded all expectations. In its first year of operation, the canal generated more than \$1 million of revenue, which allowed the bonds to be paid off early. Transportation costs decreased more than 75% and, in some instances, even more. Tariffs generated from goods shipped and received from New York Harbor became one of the most significant revenue streams for the federal government. Perishable goods could now be shipped quickly, so seaboard residents had fresh produce and interior residents had edible seafood.

The canal was among the main reasons New York City prospered. In fact, New York's port activity caused other seaboard cities to consider similar canals to open up their interior in the same way to enhance their trade. But New York had a head start and never looked back.

What started out as Clinton's folly became Clinton's success as economic development from the canal increased trade, prosperity, and tax revenues.

We hear "Lost Cause" commentary ad nauseum from so-called experts, most of whom are political leftists, neocons, Straussians, and others of a similar ilk who claim the War for Southern Independence was about maintaining slavery. In reality, the only threat to slavery was outside of the Southern and Border States (Lincoln and the Republicans made that crystal clear). This arose, at least partially, from the Republican agenda of

wanting only White settlers in the West; they consistently affirmed that they did not want Blacks as neighbors or as job competitors. Numerous Republicans, e.g., Greeley, Lincoln, Wade, etc., vocalized it and even wrote about it. The Free Soil Party echoed this agenda.

We also hear excerpts from Alexander Stephens' Cornerstone Speech and are led to believe Stephens was the spokesman for the South. Stephens, Abraham Lincoln's one-time friend, said his comments were taken out of context. Regardless, the individual with the most informed view of the Southern cause was Confederate President Jefferson Davis. On multiple occasions, he noted the States are the sovereigns in a voluntary federal republic and the South was fighting for independence, just as their "Revolutionary" ancestors had done. While conversing with Yankee spy, Edward Kirk, Davis is reported by said spy to have stated, "We are not fighting for slavery; we are fighting for independence." Understanding the detrimental effects of the system, Robert E. Lee said: "The best men of the South have long been anxious to do away with this institution and were quite willing to see it abolished." He also said, "So far from engaging in a war to perpetuate slavery, I am rejoiced that slavery is abolished. I believe it will be greatly for the interest of the South..."

Hundreds of thousands on the Southern side understood the goal was independence. Confederate General Richard Taylor, son of President Zachary Taylor, said the Confederates "have striven for that which brought our forefathers to Runnymede, the privilege of exercising some influence in their own government." Taylor also scoffed at Stephens' controversial "Cornerstone" statement. When questioned by James "Birdseye" McPherson about the reason for secession, Brigadier General E.P. Alexander explained: "It was not for slavery but the sovereignty of the states, which is practically the right to resume self government or to secede."

Conversely, why was the Union determined to coerce the seceded States back into the Union? In his First Inaugural Address on March 4, 1861, Lincoln stated the "only" reason for invasion would be to regain the forts in order "to collect duties and imposts." Lincoln "reminded a visiting abolitionist toward the end of January: 'We didn't go into the war to put down slavery. To act differently at this moment would, I have no doubt, not only weaken our cause but smack of bad faith. … The first thing you'd see would be a mutiny in the army.'" Union Officer Donn Piatt echoed Lincoln's comments: "Lincoln well knew that the North was not fighting

to free slaves, nor was the South fighting to preserve slavery. In that awful conflict slavery went to pieces." There is no evidence the North invaded the South to end slavery

Massachusetts abolitionist Lysander Spooner understood the mercenary nature of the individuals so adamant about denying Southern Independence: "The pretense that the "abolition of slavery" was either a motive or justification for the war is a fraud of the same character with that of 'maintaining the national honor.' ... And why did these men abolish slavery? Not from any love of liberty in general... but only 'as a war measure,' and because they wanted his assistance, and that of his friends, in carrying on the war they had undertaken for maintaining and intensifying that political, commercial, and industrial slavery, to which they have subjected the great body of the people, both black and white." Spooner also said the denial of consensual government is itself a form of slavery.

In 1864, J.P. Morgan, prominent American financier and banker, witnessed the "saving the union" fallacy first hand: "I supported President Lincoln. I believed his war policy would be the only way to save the country, but I see my mistake. I visited Washington a few weeks ago, and I saw the corruption of the present administration—and so long as Abraham Lincoln and his Cabinet are in power, so long will war continue. And for what? For the preservation of the Constitution and the Union? No, but for the sake of politicians and government contractors."

It can be argued with considerable evidence that Union soldiers were fighting for the "Unrighteous Cause" of protecting the interests of Northern banks and corporations. This is the reality that later struck Smedley Darlington Butler (War is a Racket) when he realized he was fighting in foreign wars for similar reasons.

### HAPPY BIRTHDAY, NICENE CREED!

It was the fourth century A.D. Yes, I know the politically-correct crowd says we're not supposed to use B.C. and A.D. anymore, because they mean "Before Christ" and "Anno Domini" (in the year of our Lord). Those terms, we are told, refer to the birth of Christ and that is offensive to some.

Instead, we're supposed to say B.C.E. ("Before the Common Era") and C.E. ("Common Era"). But what makes the Common Era common, other than the birth of Christ? Our Founding Fathers finished the Constitution with the words "in the year of our Lord one thousand seven hundred and Eighty seven." I'll keep saying B.C. and A.D.

Back to the fourth century. The Church was sharply divided over issues of doctrine. All professing Christians believed in Jesus Christ, but they disagreed over many issues of theology: the divinity and humanity of Jesus, the Trinity, the Incarnation, the procession of the Holy Spirit, and others. These issues threatened to divide not only the Church but the Roman Empire as well.

You see, the Roman Empire had become mostly Christian. After the pagan Emperor Diocletian died in A.D. 304, a struggle took place between Maxentius and Constantine. Before the great Battle of Milvan Bridge, Constantine saw a vision of a cross in the sky with the words "In this sign you shall conquer." Following the cross, he and his soldiers won a great victory. By A.D. 313 Constantine was the undisputed ruler of the Empire, and he publicly embraced Christianity.

Some say Constantine's conversion was only political, but I believe he was sincere. He ended Christian persecution but granted tolerance to pagans. He ordered confiscated property restored to Christian churches and ordered and paid for hand-lettered copies of the Scriptures to be placed in Christian churches. He issued orders prohibiting corruption and unchastity and abolished crucifixion as a punishment. Although he delayed baptism until shortly before his death, that was a common practice among the Montanists and Novatianists who believed (mistakenly in my opinion) that baptism covers only the sins committed before baptism.

The theological controversies that wracked the Church disturbed Constantine, not only because theology was important to him but also because they threatened the unity of the Empire. So in A.D. 325 – exactly 1,700 years ago – Constantine called a church council to be held in Nicea, a city in what is now Turkey. About 318 bishops attended the council, coming from as far east as India, north as Germany, and west as Spain. Constantine presided over the council and impressed many with his understanding of the theological issues under consideration.

The major issue was the nature and pre-existence of Jesus Christ. Arius, an influential presbyter from Alexandria, believed Jesus was the son of God but was not co-eternal with or equal to the Father. Rather, Jesus was created by the Father, and as Arius said, "there was a time when He was not." He argued that Jesus was heteroousious (different substance) from the Father.

Athanasius, a young clerk and a very capable debater, stood in opposition to Arius. He argued that Jesus was equal to the Father and co-eternal with the Father, having existed with the Father in eternity past. Jesus, he said, was homoousious (one substance) with the Father.

The debate waged on from May to the end of July. Some of the bishops tried to advance a compromise position, that Jesus was homoiousious (similar substance) with the Father. But with Constantine's support the Council settled on homoousious, the position of Athanasius, declaring that Jesus was

"begotten, not made, being of one substance with the Father, by whom all things were made."

I'd like to say this ended the controversy once and for all, but it did not. Arius was exiled, but he had powerful friends who brought him back again and again. Far from basking in victory, Athanasius was excommunicated five times, but he persevered and died in A.D. 273 in the good graces of the Church.

And the Nicene Creed prevailed and brought a measure of unity to the Church, distinguishing orthodoxy from heresy. Around A.D. 1054 the Roman Catholic Church and the Eastern Orthodox Church split, officially over another passage of the Nicene Creed (the filioque, which says the Holy Spirit proceeds from the Father and the Son; Eastern Orthodoxy says He proceeds only from the Father). Even after

the Reformation, Catholics and Protestants agreed on the Nicene Creed, and the Orthodox agreed on all except the filioque. Only in the modern era, with the advent of religious liberalism, modernism, progressivism, and emergent theology did the Nicene Creed become passé.

And 1,700 years later, churches still use the Nicene Creed as the test of orthodoxy, and many recite it during worship services. I urge you to recite, even memorize the Creed, saying it with your whole heart and spirit, in the knowledge that you are saying it in unity with hundreds of millions of Christians of many denominations all over the world, past, present, and future.

#### Don't have a copy? Here it is:

I believe in one God, the Father Almighty, Maker of heaven and earth, and of all things visible and invisible.

And in one Lord Jesus Christ, the only-begotten Son of God, begotten of the Father before all worlds; God of God, Light of Light, very God of very God; begotten, not made, being of one substance with the Father, by whom all things were made. Who, for us men for our salvation, came down from heaven, and was incarnate by the Holy Spirit of the virgin Mary, and was made man; and was crucified also for us under Pontius Pilate; He suffered and was buried; and the third day He rose again, according to the Scriptures; and ascended into heaven, and sits on the right hand of the Father; and He shall come again, with glory, to judge the quick and the dead; whose kingdom shall have no end.

I believe in the Holy Ghost, the Lord and Giver of Life; who proceedeth from the Father and the Son; who with the Father and the Son together is worshipped and glorified; who spake by the prophets.

### **FEDERAL SHUTDOWN**

OCTOBER 2, 2025

The federal government remained shuttered Thursday as partisan gridlock deepened, leaving hundreds of thousands of workers furloughed and critical services disrupted. With Congress failing to pass a funding resolution before the October 1 deadline, the shutdown has now stretched into its second day, triggering warnings of mass layoffs and long-term agency cuts.

### **Political Standoff Intensifies**

President Donald Trump met with Office of Management and Budget Director Russ Vought to discuss which federal programs might face permanent cuts. In a post on Truth Social, Trump wrote: "I have a meeting today with Russ Vought... to determine which of the many Democrat Agencies... he recommends to be cut, and whether or not those cuts will be temporary or permanent."

Meanwhile, Senate Democrats and Republicans failed for a third time to advance competing funding proposals. With Yom Kippur observances underway,

the Senate is not expected to vote again until Friday. ensuring the shutdown will last at least one more day.

### **Federal Workforce Faces Uncertainty**

The Congressional Budget Office estimates that up to 750,000 federal employees are currently furloughed. Essential personnel remain on duty but are working without pay. The Trump administration has signaled that mass layoffs could begin within days if the shutdown continues.

Vice President JD Vance and Press Secretary Karoline Leavitt warned that the administration is preparing for permanent reductions-in-force, a departure from the usual practice of temporary furloughs during funding

### **Legal and Civic Disruptions**

The Justice Department has begun requesting delays in federal court cases, citing staffing shortages. In one case, attorneys opposing the government argued that the shutdown should not be used to postpone litigation involving National Guard deployments in Washington, D.C.

Public services such as national parks, passport processing, and small business loan approvals are facing closures or delays. Infrastructure and climaterelated projects in states that voted for Kamala Harris in 2024 have been paused, including \$18 billion in New York and \$8 billion across 16 states.

### Alabama Impact

While many federal facilities in Alabama remain operational due to essential status, agencies such as the USDA, VA, and Social Security offices are bracing for service interruptions. Local union leaders have warned that furloughs could affect administrative staff and delay public-facing services.

### What's Next?

Senate GOP leaders plan to hold another vote Friday on a House-passed bill to reopen the government. Democrats continue to demand the reversal of Medicaid cuts and the extension of Affordable Care Act subsidies, which remain key sticking points.

As the shutdown continues, the stakes grow higher-not just for federal workers, but for families, businesses, and communities across the country.

### Title IX and the Debate Over Transgender Participation in High School Sports

U.S. Senator Tommy Tuberville (R-Alabama) has recently drawn attention to the issue of transgender participation in high school athletics. Tuberville presented documents showing that 122,000 transgender individuals competed in high school sports last year. This figure has sparked a renewed conversation about fairness and the future of gender-based protections in athletics.

According to Tuberville, the growing number of transgender athletes raises concerns about the integrity of women's sports. He emphasizes the need to take action, calling for the permanent restoration of Title IX protections to maintain the separation between men's and women's sports.

Title IX, enacted in 1972, was designed to ensure equal opportunities for women



in education and athletics. The ongoing debate centers on how best to uphold these protections while considering the inclusion of transgender

Tuberville's remarks highlight a perspective that prioritizes the preservation of women's sports and calls for policy changes to address current

Tuberville is a sponsor of legislation to define gender as the sex that God and biology assigned one at birth – not the one you (with the help of your

doctor and big pharmaceutical companies) choose on a whim.

"We must PERMANENTLY restore Title IX protections and KEEP MEN OUT OF WOMEN'S SPORTS," Tuberville stated.

Democrats in Congress – cowed by big money donors in the community – disagree and are using the filibuster to stymie Senator Tuberville's common sense legislation.

Alabama has already banned experimental transgender surgeries on children citing that their immaturity prevents them from giving informed consent – the same way that the law protects children from being able to lease an automobile or get a payday loan. Radicals within the Biden administration attempted to challenge the Alabama law in court and withhold Title IX funds from the state of Alabama if the state did not allow boys who claim to be transgender to compete in girl's sports.






It can be used by 9-1-1 agencies to quickly send first responders to the location of an emergency with more information, by emergency management to better plan for and respond to disasters, and by municipalities to send emergency notifications to their citizens.

By creating a Safety Profile for your family, you are providing potentially life-saving information to public safety officials at the time when they need it most.

The 9-1-1 service of Smart911 allows you to create a Safety Profile for your household which will proactively provide details on your family and home that 9-1-1 may need in order to send help in the event of an emergency.

The emergency management service of Smart911 allows you to answer questions about yourself, your family and your household that will help emergency management officials plan for and respond to disasters by being able to understand the needs of their community. The emergency notification service of Smart911 allows you to opt-in to receive alerts from your community through a variety of communication channels including

voice, text or email. While every community may offer a different combination of services to their citizens, your Smart911 account will allow you to opt-in and manage all services

available to you in one place. Smart911 is free, private and secure and endorsed by citizens, community groups and public safety officials. Smart911's availability is constantly expanding as communities across the country are implementing one or all of the three services offered to enhance their public safety services.

### Why Should I Sign Up for Smart 911?

Today over 70% of calls made to 9-1-1 in the U.S. are made from mobile phones, and these mobile phones relay limited information **about the caller.** Unlike a landline, a mobile phone does not link directly to an address or include a caller's name. 9-1-1 call takers are trained to ask specific questions to determine the location of the emergency, who is in need of assistance and other specific details in order to send the correct response teams, tot he correct location, quickly.

These questions can take time, and often during an emergency the caller may not be able to speak, or may be too panicked to effectively communication. When your Smart911 Safety Profile immediately appears to the call taker, the information you have provided can help the dispatcher obtain the information they need to help you quickly.



Frazer Free Methodist Church extends its ongoing support and prayers for all who serve on the front lines.



Growing up in the small town of Camden in Wilcox County, Alabama, and working on her father's farm, Kay Ivey was taught the value of hard work and living within one's means. Her parents instilled the Alabama values of faith, family and community.

After graduating from Auburn University in 1967, Kay worked as a high school teacher and a bank officer. She served as Reading Clerk of the Alabama House of Representatives under Speaker Joseph C. McCorquodale and was Assistant Director of the Alabama Development Office, where she worked to spur job creation and economic development across the state.

In 2002, Kay became the first Republican elected State Treasurer since Reconstruction, and she was re-elected in 2006. As Treasurer, Kay was committed to making the office more open, transparent, and efficient. Kay was elected Lieutenant Governor in 2010, becoming the first Republican woman to hold the office in Alabama's history.

She again made history on November 4, 2014, by becoming the first Republican Lieutenant Governor re-elected to the office. Governor Ivey has been honored to receive numerous awards for her service to the state of Alabama, including the 2015 ALFA Service to Agriculture Award; Newsmax's 50 Most Influential Female Republicans in the country; the American Institute of Aeronautics and Astronautics (AIAA) 2016 Public Service Award; and 2017 Citizen of the Year, by River Region Living Magazine. In September 2019, the Alabama-Florida Council of the Boy Scouts of America distinguished Governor Ivey as a Golden Eagle for her 'scout like service' and being a trailblazer for women. In 2021, Governor Ivey was awarded the prestigious Army Aviation Order of St. Michael Knight Award. The American Village also presented the governor their highest honor, the Cornerstone of Liberty Award. Most recently, Governor Ivey was presented the inaugural Cognia STEM Champion Award and the Alabama Automotive Manufacturers Association Hall of Fame Award.

On April 10, 2017, Governor Ivey was sworn in as the 54th Governor of the state of Alabama in the Old Senate Chamber in the Alabama State Capitol by Acting Chief Justice Lyn Stuart. Following a successful nineteen months in office, the people of Alabama made history again in November 2018 by electing Governor Ivey to a full term. She is the first Lieutenant Governor of Alabama elected to a full term after taking over as governor due to a vacancy in the Governor's Office.

On January 14, 2019, Governor Ivey was officially sworn in for her full term by Associate Justice Will Sellers. Governor Ivey's first term brought conservative leadership with effective results to make this generation more productive and the next generation more prosperous.

Governor Ivey was reelected to a second full term November 2022 in a landslide voting outcome, and she was sworn in January 16, 2023. Noting education, economic development, roads and bridges, broadband expansion, public safety and government reform as the top priorities of her second administration, Governor Ivey vowed to keep Alabama working, ensuring the state's best days are yet to come.

Gov. Ivey said she was shocked by the recent assassination of Charlie Kirk. She hates political violence and said it saddens her to see Americans attacked. She said our own Rotary 4-Way Test should be the rule for everyone in society. Gov. Ivey noted that last year, she joined the National Governors Association's Disagree Better initiative. It is designed to show a healthy way for voters and elected leaders to debate political issues. One of the honorary chairs of the initiative is the governor of Utah, the same state where Kirk was killed.

Gov. Ivey said President Trump is keeping his campaign promises to close borders and to fight crime. In Alabama, she said the new Metro Area Crime Suppression unit (MACS) is getting results in Montgomery, while the new Back the Blue law will provide protections for law enforcement. A state ban is now in place for so-called Glock switches, which allow guns to function as machine guns.

As for education, Gov. Ivey says the new Focus Act, which prevents students from using phones and other electronic devices during the school day, is common sense legislation. She started her Back to School tour two weeks ago and is happy to report that reading and math scores are up. Alabama now ranks 34th in reading and 32nd in math, up from being at or near the bottom several years ago.

Economically, the Department of Labor will become the Alabama Department of Workforce on October 1, with former State Sen. Greg Reed as its first secretary. The change reflects the mission to make Alabama's workforce better prepared for the future. Gov. Ivey said the current unemployment rate is 2.9%, which is the lowest in the South and one of the lowest in the country. The relocation of Space Command from Colorado to Huntsville is a big achievement. She said overall economic development since 2017 has been \$55 billion, with 93,000 new jobs.

Gov. Ivey said that as we approach the 250th anniversary of the United States, she is proud of Alabama and our citizens, but she said. "let's not waste a moment," in trying to improve our state and our nation.

Major Sallie Louise Duncan is on active duty with the U.S. Space Force, and she has served 15 years. The United States Space Force is the newest branch of the U.S. military, established in 2019 to protect American interests and ensure freedom of operation in, from and to space. It is responsible for organizing, training, and equipping space forces to provide space capabilities to the joint force and defend U.S. and allied interests in the space domain. Her Space Force Specialty Code (SFSC) is 13S. She has received the following medals, commendations, awards and ribbons: Defense Meritorious Service Medal, Meritorious Service Medal, Air and Space

Commendation Medal with one Oak Leaf Cluster, Joint Services Achievement Medal, Joint Meritorious Unit Award, Air and Space Outstanding Unit Award with one Oak Leaf Cluster, Combat Readiness Medal, National Defense Service Medal, Global War on Terrorism Service Medal, Nuclear Deterrence Operations Service Medal with one Oak Leaf Cluster, Air and Space Longevity Service Award with two Oak Leaf Clusters and Air and Space Training Ribbon.

Major Duncan was born to her parents, J.R. and Betty Skelton in Macon, GA, and she was reared there. She graduated from Perry High School in May 2001, and she then attended Brewton parker College for two years. She went on to attend college at Wright State University in Ohio from 2005 to 2010 where she graduated with a bachelors in English and Commissioned into the United States Air Force.

Major Duncan's military service began October 21, 2010, where she was a student at Vandenberg Air Force Base. After completion of training, her first duty station was during September 2011 to September 2013 as Crew Commander for the 10th Space Warning Squadron at Cavalier Space Force Station, North Dakota which monitors satellites and objects in space, and tracks potential missile launches against North America. Next, she served as an OPIR (Overhead Persistent Infrared) Crew Commander for the 11th Space Warning Squadron at Schriever Space Force Base, CO, for three years during 2013 to 2016. During 2016 to 2018, she served at Vanderberg Space Force Base, a space launching

base launching space craft to the Western Ridge that also performs missile testing. While there, she first served as an instructor of undergraduate space training and then as an OUST (Officer Undergraduate Space Training) Development Manager. Her next assignments were for four years at Buckley Space Force Base, CO, during 2019 to 2022 as the OPIR Mission Director and then during 2022 to 2023 as Assistant Director of Operations. Major Duncan has been serving at Maxwell Air Force Base, AL, since July 2023 where she has served as the Division Chief of Future Operations, and now as the Deputy A7/A9 Academic Administrator for ACSC (Air Command and Staff College).

Major Duncan has been married to her husband, Matthew, for 15 years, and they have three children. She is a member of First Baptist Church in Wetumpka, AL, where she sometimes plays the bass guitar, and she is a member of Atagi Chapter of DAR.

Major Duncan's conclusions about what serving in the U.S. Military means to her are: "Serving in the military has been an experience that has made me appreciate my family and their support. It has also shown me that as big as the world is, there are a lot of things that we have in common with people from other countries that makes defending our freedoms and our allies that much more important. I've learned that people I've served with all come from different walks of life, and getting to wear this uniform with them is an honor and a privilege. This isn't an easy job, but I don't regret signing up and wearing the uniform."

Her conclusions about how she would like people to remember her are: "I hope that when people think of me, they remember me as an optimistic person who believes in them and encourages them to never give up on themselves and believes in them. I expect a lot from myself and from our leadership, and I have always done my best to do right by everyone around me. I hope that they remember me as someone who encouraged good morale and was willing to be a sounding board when they needed it."





### First Lieutenant Guy V. Martin, Jr.





Lieutenant Martin (Army ordinance, active duty 1969-71), was born June 2, 1947, in El Paso, Texas, to his parents, Guy V. and Eula V. Martin, while his father was stationed at Fort Bliss as an artillery captain. Lieutenant Martin was reared at Army bases from the Presidio in California to Fort Buchanan in Puerto Rico, and then after his father was honorably discharged in 1953 with a 100% disability because he had been wounded in WWII and again in Korea. Lieutenant Martin moved with his family to their cattle farm north of Trussville, Alabama. He graduated from Hewitt Trussville High School in 1965 as valedictorian and president of his student council.

He chose the Navy first becoming a Navy ROTC midshipman at Vanderbilt University until his dad's health issues caused him to transfer to Army ROTC. He graduated in 1969 with a B.S Degree in Economics, magna cum laude.

After training at Ft. Bragg, North Carolina, Aberdeen Proving Grounds, Maryland, and Redstone Arsenal, Alabama, he served as a procurement officer in the 40 millimeter program at the Ammunition Procurement and Supply Agency (APSA) in Wilmington, Illinois, and then in Vietnam (1970-71), first in Da Nang and then at USARV HQ, Long Binh where he served under an outstanding general, Major General James J. Ursano whose influence almost inspired him to make a career out of the Army, but his father's poor health brought him back to Alabama. He was discharged from military service in Oakland, California.

After his military service, Mr. Martin used the GI Bill to earn a Juris Doctor Degree from the University of Alabama School of Law in 1974, graduating first in his class. He worked as a commercial real estate finance attorney in Birmingham, AL, and as an adjunct professor at the University of Alabama School of Law and the Birmingham School of Law. He retired in 2020.

Mr. Martin and his wife, Lynne Torbert Martin, from Hurtsboro, Alabama, have been married 46 years and have three children and three grandchildren. As President of National Junior Achievement, he has given speeches across the country extolling the virtues of free enterprise. He has served as director of the Foundry Ministries and Christian Life Center, a Boy Scout leader (He and his three sons are Eagle Scouts.), lay pastor in Protestant churches and as a youth director. He and his wife are members of Wesley Methodist Church in Montgomery.


Mr. Martin is a prolific writer, having written several op-ed's, including "Lessons from Roy Moore's Law Professor" and "A Tale of Two Sites" (both in al.com),

"Stallings Restored Hope to Parents of Children with Down Syndrome," (Montgomery Advertiser, 3/30/2025) and writings regarding the United Methodist Church. Soon to be published is an article regarding his template to revitalize religion. A Ruby Life Master in bridge, he won a national event with his son in 2022, and he has written pieces on the advantages for children and adults for playing bridge. He enjoys tennis, farming, gardening, travel and watching ducks and Canada Geese land on the lake that he built behind his house on his cattle farm south of Montgomery.

Regarding what his military service has meant to him: "I have great respect for the educational, ethical and skill levels of Navy, Marine and Army officers that I've worked with as well as those of my Korean counterparts in Vietnam. I have zero respect for politicians who mangled the Bay of Pigs invasion, engaged in Vietnam against the advice of our military (including MacArthur on his deathbed) and once engaged, failed to follow the advice of boots on the ground soldiers that prevented us from winning. Compared to those mistakes, when you arrive in a war zone, being told not to shoot unless you're shot at, is merely a minor footnote proving how unsmart our leaders were. You never get over reading in the Stars and Stripes what politicians like Senator McGovern said that they saw in Vietnam. (He called the Vietnamization program a failure which it wasn't)-much less the sights of Jane Fonda wearing an NVA helmet and sitting on an NVA anti-aircraft weapon."

"On a positive note, it's hard to imagine a better two years in terms of preparing me for challenges to come. Military service gives you a severe re-set on how smart and tough you think you are—winning the 880 in track is nothing compared to carrying your buddy through a swamp (which I did only in training) being one of many examples; working with a general with a photographic memory and Korean officers who can speak five languages and quote from Sun Tzu others; what soldiers go through to be a Navy pilot, a Seal sniper, an Army Ranger and Airborne qualified (I was none of those, but I saw

training films and what those types could do)-brings you down to earth. It provides a perspective on religion you don't get as a civilian: you never feel closer to God than you do in harm's way. An unshakable bond with your comrades is formed and thus a taste of how united we all could be under God regardless of race or religion or political bent. My best chaplain was Jewish who'd qualified expert on his M16 and could preach on Christ with the best. Every youngster I've advised to enter the military (including the Coast Guard) has thanked me over the years."



### POW-MIA REMEMBRANCE CEREMONY

The State of Alabama's POW-MIA Remembrance Committee hosted the 2025 POW-MIA Remembrance Ceremony on the south lawn of the state Capital on Saturday September 20, 2025. The Committee is composed of Veteran Service Organizations (VSO), local and state government agencies and Veteran's Auxiliary units. The Annual Ceremony is presented to keep the citizens of Alabama aware of our lost and missing service members and to honor those who were held captive as Prisoners of War. At this time over 1,100 service members from Alabama have not returned from the conflicts in which they served. We will remember until they are found and accounted for, and our families deserve to know the final resting places of their loved ones.

The ceremony featured the delivery of the POW-MIA flag by the American Legion Motorcycle riders. Prior to the POW-MIA flag reaching the Capitol grounds, it had traveled around the northern part of the state, and it was raised and flown on flag poles in Fultondale, Haleyville, Florence, Decatur, Huntsville, Scottsboro, Henagar, Ft. Payne, Jacksonville, Bynum, Talladega, Lineville, Millbrook and Prattville.

Once the POW-MIA flag arrived on the grounds of the state Capitol, the ceremonies began. The VFW Department of Alabama Color Guard opened with presenting the American Flag, and subsequently it posted the American Flag with the Service Branch flags on display. Duke Martin, Chaplain, Department of Alabama American Legion, opened the ceremony with prayer. VSO leaders and other dignitaries were recognized as attendees of the ceremony by the moderator, Chuck Moore of the Marine Corps League.

Brigadier General, Retired Jeffery L. Newton, Commissioner of the Alabama Department of Veterans Affairs, welcomed the assembled and read the proclamation from Governor Kay Ivey proclaiming POW-MIA week in Alabama. Active duty military members from the Army, Captain Micaela Tierce, Marine Corps, Corporal Andreus Baker, Navy, Hospital Man 1 Dante Fuller, Air Force

Staff Sergeant Stephanie Mendoza and Coast Guard IT Specialist 2 Stephen Tidwell who are all assigned to the Montgomery MEPS Eastern Sector honored the Missing in Action from their service branch with placards displaying the number of missing waiting to be located and returned to Alabama. As a medley of military service songs was played, the Active-Duty Military members raised their placard, and members of the audience who served in that branch stood to be recognized. The service members then proceeded to the State of Alabama Capitol flag pole and raised the POW-MIA flag on the state pole as authorized by the US Congress and the Alabama Legislature on this occasion. Mrs. Lela Brown sang the Battle Hymn of the Republic and God Bless America. Mrs. Brown has honored the guests at the POW-MIA Remembrance Ceremonies for many years with her voice and patriotism.

State House of Representatives, District 77, retired First Sergeant, United States Army, Kenneth Paschal, was the keynote Speaker. 1st Sergeant Paschal has served as the sponsor of the POW-MIA Remembrance Ceremonies on the Capital Grounds for many years. 1st Sergeant Paschal inspired the attendees to remember the missing, honor the POWs and never forget the work that is needed to do to account for every American military member who is waiting to be found and brought home.

Linda Roloff VFW Auxiliary and her honor guard presented the Missing Man Table ceremony. Linda and her team have received National Recognition for their Missing Man Table presentation including an invitation from the U.S. Naval Academy to perform the ceremony at the Academy.

Wreaths were placed by the American Legion Auxiliary, The VFW Auxiliary, and Gold Star Wives Association. Roses were presented by Pat Jeffries of the Marine Corps League to families of the Missing, Gold Star Families, and POW families. The Ceremonies were concluded with the playing of Taps.



### Soul Searching...



### Freedom Can Be Yours

Only four people ever successfully escaped to freedom from the federal prison on Alcatraz Island. The following story is an excerpt from my book, Free For All, which explores the different ways we can experience God's amazing grace. It is only by God's grace that we can be truly free!

Alcatraz Island sits in the middle of San Francisco Bay, surrounded by almost two miles of turbulent and treacherous water. For nearly one hundred years, the island housed a prison, and the place earned the nickname "The Rock" because it was inescapable.

Constructed by the United States Army in the 1950's, the twenty-two acre island became an army prison in the Civil War. In 1933, Alcatraz was turned over to the Department of Justice to be used as a federal penitentiary, and during the next thirty years it housed some notorious criminals- Al Capone, Whitney Bolger, Bumpy Johnson, and Arthur "Doc" Barker, son of the infamous Ma Barker were among its denizens.

Prisoners sent to Alcatraz did not escape, and those who tried served as a caution to the rest. Doc Barker successfully climbed the prison walls but was shot to death on the beach while trying to construct a makeshift raft. Joseph Bowers was shot while trying to climb the fence and died from his injuries sustained by the fall. Aaron Burkett overpowered a guard while taking out the garbage. He jumped into the water and tried to swim, but his body was found two weeks later floating in the bay. Over the years, fourteen documented escape attempts ended in prisoners being killed or presumed drowned in the San Francisco Bay.

There is usually an exception to every rule, and someone did escape Alcatraz. No swimming and no makeshift life raft however. Four inmates simply walked out in 1903. An inmate who was the brains behind the operation worked in the prison print shop. He created a copy of a piece of letterhead bearing the War Department logo and wrote on it a letter remitting the sentences of himself and three other prisoners. He forged the signatures of Judge Henry Morrow and Major Williams. A second prisoner, who worked as a prison postal clerk, smuggled the letters out

of the prison. An outside accomplice mailed them to the prison commander, Major Paxton. Believing the documents to be authentic, Paxton released the four prisoners. These inmates who escaped by means of a fake pardon were never found

Did you know you have been granted a pardon - a genuine one! You've been set free and your release orders were signed by the One who judges all humankind. That is the whole point of these verses found in Paul's letter to the Ephesians: "God saved you by His grace when you believed. And you can't take credit for this; it is a (free) gift from God. Salvation is not a reward for good things we have done, so none of us can boast about it. For we are God's masterpiece. He has created us anew in Christ Jesus, so we can do the good things He planned for us long ago." (Ephesians 2:8-10 NLT)



"Ye are all the children of light, and the children of the day: we are not of the night, nor of darkness." (1 Thess.5:5)

# Southern Gardening Potpourri for October



With the leaves falling and dotting our yards with yellow, light tan, red and orange, this is a good JUDGE PEGGY GIVHAN indication that the season has changed from summer

to fall. I can tell that we have had plenty of rain this summer because the leaves seem more brilliant than last year when we were in a drought. Since I have large oak trees which produce large leaves, I have placed them on top of my dining room table. These leaves stand out in contrast against a white table cloth. Then add pumpkins and instantly the tablescape is fall, halloween and Thanksgiving all rolled into one. In October we will be celebrating one official holiday, Columbus Day, and one unofficial holiday, halloween. Let us all be mindful that safety comes first when trick or treating.

#### **GARDEN DESIGN TIP**

A good design concept in landscapes or in flower gardens, is the Rule of 3. This idea means that one would be planting trees and shrubs in lots of 3 or other odd numbers to create a more natural, balanced appearance. If you look at nature, you do not see trees or shrubs lined up like soldiers in the field. Rather there are more random, scattered plantings. Odd numbers create a more appealing and balanced look giving the garden or landscape a sense of depth and rhythm. In the flower garden, this translates to the larger the plant, the less you need in the clump. For instance, and this also depends on the actual dimensions of the area, digitalis or hollyhocks would normally be planted in groups of three where fillers. such as impatiens, would have 5 to 7 plants. Now if you are planting formal beds, this concept does not apply since the beds would most probably consist of one or two flowers. If you follow this tip, your flower garden or landscape will create a dynamic and cohesive planting.

#### PHYSICAL BENEFITS OF GARDENING

There is data available to show that gardening is good for your health. The bending, lifting, digging, and just plain moving not only burns calories, but helps tone muscles, supports dexterity, and balance. Also spending time outdoors in sunlight, is a great avenue to obtain Vitamin D which helps the bones, the brain

and the gut. Gardening gets you outside with nature which improves mental health and is a key to one's overall happiness. When one is engaging in gardening, this reduces stress, and instills a sense of purpose. So when you spend time in your garden, you are truly investing in a healthy future.

#### PLANT OF THE MONTH -- COREOPSIS-Asteraceae, Aster family



The large genus of flowers is made up of summer blooming and fall blooming perennials that produce daisy-like flowers. They range in height from under a foot to over 6 feet tall. They are easy to care for, make great cut flowers, and will return year after year. Another asset is that they are drought tolerant. Although they really do not need to be constantly dead headed like geraniums, I just give them a haircut after the flush of blooms die which encourages more blooms. To propagate this flower, one can collect seed and sow in the spring, or take stem cuttings in

early summer which root quickly or by division. These plants come in a variety of colors, even variegated. I have purchased them in local nurseries and big box store garden centers.




One of the best places to put up a tree stand or blind is in a funnel. A funnel is a small area where two or more ridges run out or down into a small hollow or trail. If you can imagine the dip between two crests, you will understand what a funnel is. It is basically the easiest route for deer, or any other animal, to travel. 

## A STORY OF DOMESTIC ABUSE AND OVERCOMING IT'S EFFECT!

Most of the time people think of domestic abuse as man beating a woman with bruises and scars that show on the outside. People don't see or are not even aware of the abuse of a narcissistic spouse that constantly deflates you as a person. The constant criticism, the lowering of confidence and selfworth of a person. No, it does not happen suddenly, it happens slowly over a period of time. You are not even aware of the boundary line being moved further and further away, week by week. They will test you to see how far you are willing to go then they press on a little more over time. **Isolation and control is what they seek.** Yes, it is a slow and painful death of yourself, of your own will, of your spirit. You could never imaging being in this position. You feel the humility and shame. You become numb. You shut down and stop fighting for your own position because if you stand up for yourself the yelling begins. All you want is peace and quiet. To stop the noise, so, you just give in to keep the peace.

They will make you believe that you cannot make it without them. They will tell you lie after lie and convince you that you need them to survive in this world. The real truth is, you can overcome all this with one hard but necessary step. **Get out! Leave! Flee with all your might!** But, one day, when you have reached your limit of tolerance and you finally have had enough, you will leave. It won't be easy, it will be the most difficult thing you ever do. It will take all the strength you have.

The day I left, he pointed a 38 revolver to the back of my head and threatened to kill me one more time. It became a routine thing by now that he threatened my life. He seemed to get a thrill out of scaring me. He seemed to want to kill me at least once a week. And I mean this was not because of something I did, no, he would just come home and come straight to me and threaten me for no reason. I had lived through so much fear and verbal abuse but it had become more and more violent and unprovoked. It seemed my silence was all that was needed to set him off.

Finally, from deep inside myself, I gathered the strength to leave. And I left everything. I knew if I left I would lose everything. My family, children, grandchildren, home, job and possessions. I knew if I called the Sheriff and had him put in jail, he would get out within 24 hours and come straight to me and kill me. He had been arrested before for violence on other people, he got out of jail that same day. So, I knew I could not do that and be safe. And so, I took what I could and just left. Fearing for my life; I stayed with friends for several weeks, trying to put pieces of myself back together. I felt like I was a burden to my friends. I felt so much shame for being in this position. I felt so lost and confused. But, it was not my fault. At the time I was in survival mode. I was just living each day on autopilot. Completely numb. I hated asking for help or asking my friends to hide me. But I knew in order to find safety and peace, I had to leave. I had to remove myself from the horror and violence. I had to protect myself.

I finally moved into my mother's house – a place of refuge. But he was still next door and could see my every move. He would call, text or email me with his continued threats and tell me in detail of the things he would do to me. He would tell me he was watching my every move. His threats became more and more emphatic! He could not control me any longer and that made his rage even hotter.

I found help at the **Family Sunshine Center.** They gave me council for my broken spirit and the tools to help me rebuild my life without him. They referred me to the **One Place Family Justice Center** who were able to help me with my legal problems. Such getting a restraining order and getting him out of my house. Yes, it was MY house on MY land. But he still refused to leave!

I went through thousands of dollars and four attorneys to get to the place where I was able to be divorced and move back into my own house. I went to court six times. I filed for divorce and it took nine months before it was settled and signed. I filed for a restraining order. I filed for contempt of the divorce agreement. I filed for him to get out of my house. I filed for bankruptcy. I had no car, I had nothing but what I was able to move out in a one hour period that the Sheriff allowed that day, I took what I could. He made each step a hard fight.

But I did not give up! Are you asking why? I had God on my side. With each step I got stronger and smarter. I gained confidence in myself. Yes, I was angry and hurt, but I did not fight out of anger or pain or to get back at him. I was only fighting for what was right and what was rightfully mine.

You see, all the while this was going on, I lost my job. I had my elderly mother to care for and my brother who was sick. I was responsible for much more than myself. That is one reason I stayed so long and endured so much. After three months of searching, I found a great job. I continued to work hard and take care of my mother and brother. Then my oldest brother had a stroke, and I had to step in and be his caretaker also. Work, hospitals, nursing homes, and lawsuits were my new way of life. I focused on all of that and stayed in church. I kept my faith, read my bible and I prayed a lot! Now, all of this time, I still had fear and shame in my heart. But, when you are a victim of abuse, you learn to push the fear and pain down and focus on the task of the moment. That fear and pain would have to wait.



TWELVE YEARS LATER: with a LOT of therapy and hard work, I have become an independent and successful woman.

My mother and my two brothers have passed away. I have been left alone to make it in this world. But, guess what? I have become the strong woman I wanted to be. Because of my faith in God and through all the blessing he has given me. (Even though I do not feel like I deserve them.) That is why it is called Grace! I have survived all of this and I am a much more independent person. I have retired from my sixty hour a week job that paid so well and gave me back my independence and ability to pay my way out of the hole I was in. I was able to buy a car and pay bills again. I thank God every day for that job. I worked so hard, and it paid off. God gave me the strength and ability to do that.

I am retired now, but not unemployed, and still have two part time jobs that I love. (God has blessed me with these jobs also. I was not looking for a job. They came to me! **By God's grace!**)

I spend time in my yard and on my property, tending to God's beautiful landscape and animals. I spend time with my friends who have been there for me throughout my journey and to whom I am eternally grateful. I spend time in my church, giving back what I can and receiving much more from the Holy Spirit. I am so very thankful for my church and church family. I am so thankful for my faith and for prayers. (Prayers make big difference in the life of those you pray for!) I believe I have guardian angels watching over me. If not, I would be dead one hundred times over. I am here for a reason.

Maybe this story will help someone who is suffering at the hands of someone who abuses them. Maybe they are plain mean and hateful. Maybe they are on drugs and have become a completely different person than the one you knew before. Most of the time these people have their own demons that they are struggling with.

I do not hate him. I pray for him! That is all I can do for him now. I forgave him years and years ago. WHY? You ask, well it is because **our God is a forgiving God**. He forgave me of my sins. He gave his only son who was born in a manger and died a horrific death on the cross for me. He died and took our sins and pain on his shoulders and asked his father, GOD, to forgive us. So, I forgave him because I wanted to be forgiven! You see, you cannot be forgiven if you keep hate and rage in your heart. It has to be washed white as snow with the blood of Jesus. You have to put forth an effort to receive his blessings. You have to read the word and pray in order to understand how to live your best life.

My life was such a mess. I thought it was over. I had given up hope of ever making it or even surviving. But, I did not only survive, I THRIVED and OVERCAME because GOD lifted me up in his arms and carried me through!

### Auburn Equestrian Opens 2025-26 Season October 4 with Championship Aspirations

October 2, 2025 - AUBURN, AL. — The Auburn University Equestrian team will open its 2025–26 season on Saturday, October 4, with a home meet against UC Davis at the Auburn University Equestrian Center. After finishing last season ranked No. 3 nationally, the Tigers enter the new campaign with high expectations and a roster stacked with returning talent and promising newcomers.

### A Legacy of Excellence.

Under head coach Jessica Braswell, Auburn has become a perennial powerhouse in collegiate equestrian. The program boasts four national championships (2011, 2016, 2018, 2019) and consistently ranks among the top teams in the National Collegiate Equestrian Association (NCEA).

Braswell, entering her third season as head coach, emphasized the team's focus on consistency and mental toughness:

"We've got the talent. Now it's about execution, preparation, and riding with confidence every time we enter the ring."

### **Key Riders to Watch**

- Maddie Buchanan (Horsemanship): A senior leader known for precision and poise, Buchanan posted a 9–3 record last season and earned All-American honors
- Emma Kurtz (Equitation Over Fences): The junior standout returns after a breakout season, including multiple MOP (Most Outstanding Performer awards.
- Sydney Smith (Reining): A rising sophomore who impressed in postseason competition and is expected to anchor the reining squad.

The Tigers will rely on a deep bench and strong recruiting class to maintain their competitive edge across all four disciplines: Horsemanship, Reining, Equitation on the Flat, and Equitation Over Fences.

### Season Outlook

Auburn's schedule includes matchups against SEC rivals Georgia and Texas A&M, as well as national contenders like Oklahoma State and SMU. The team will also host the SEC Championship in March 2026, giving Alabama fans a chance to see elite collegiate equestrian competition on home soil.

### Community Engagement

The October 4 opener will feature fan-friendly events, including rider meet-and-greets, barn tours, and educational booths for youth and families interested in equestrian sports. Admission is free, and gates open at 9:00 AM.

Braswell added: "We want the Auburn community and the state of Alabama to feel connected to this team. These athletes represent the best of college sports—discipline, teamwork, and heart."

### **Grandmother Tucker's Dressing**

- 1. Make cornbread I use buttermilk and lots of bacon grease (You can also use saved and frozen cornbread from other meals.) Crumble cornbread in a large bowl.
- 2. Cut 6 stalks of celery and 3 medium onions salt and pepper to taste, cover amply with chicken broth; cook until tender; set aside. The other thing I do is I cook the onions and celery in chicken broth and butter rather than water and adding melted butter later.)
- 3. Add to crumbled cornbread: 8 slices of toasted or dry bread, 1 sleeve of Ritz crackers, 8-10 biscuits or dinner rolls and 1 sleeve saltine crackers. Crumble and mix together.
- 4. Add:
- 1 can cream of chicken soup (I add 2 or 3 cans.)
- 1 can cream of celery soup
- 1 can chicken broth (I use the boxes.)
- 3-4 eggs
- add by the spoonful, including the broth, celery and onion to taste salt and pepper to taste

sprinkle of sage

onion powder and celery salt to taste...you might not need this poultry seasoning if needed to taste

(You will need more broth than this... You mix all of this with a big spoon or your hands until all of the crumbles of the breads are broken up...it's the feel and texture of a thick cornbread mixture with onions and celery. You do not want to be able to see parts of a piece of bread or a biscuit. I use a hand mixer to mix everything completely.

I also add about a half a stick of melted butter.)

Bake in a greased baking pan at 350 degrees for 45 minutes check often to be sure it does not burn.

### **INCORPORATION FACTS:**

- The community must have 300 people to incorporate with residences being contiguous.
- A petition signed by at least 15% of qualified electors within the proposed municipality must be submitted to the county probate judge as the official application.
- No territory can be included unless at least four qualified electors reside on each 40-acre tract and sign the petition in support of incorporation.
- The probate judge must order an election within 90 days of approving the petition.
- After incorporation, property owners can request to be annexed into the town.
