





#### If Alabama Loses Space Command, It Is Because We Lost Shelby




Make no mistake about it, the decision as to where the heralded National Space Command Headquarters will be located is political. If you think otherwise, you are politically naïve.

Senator Richard Shelby is the reason and only reason that the federal military officials even considered moving Space Command from Colorado to Huntsville, Alabama in the first place, period. Folks, you are just beginning to see the impact Senator Shelby's retirement meant to the State of Alabama.

Our freshman congressional members and even state and Huntsville leaders are continually referring to the results of a commission study that supposedly analyzed the qualifications and best locations for the Command Center and Huntsville was the best choice. Commissions and studies like that are created every day of the week by Washington's most powerful senators to justify what they want to accomplish. Guess what, Shelby wanted the study to say that Huntsville was the place.

The bottom line is the only reason there was any consideration towards moving the facility from Colorado to Alabama was Richard Shelby, and the only reason that it might not be moving is because he is gone. ### **Nothing Left To Lose?**

country of origin, pledge their allegiance to the United States, and officially become U.S. citizens.

Witnessing people from all walks of life and from every continent become citizens creates an infectious patriotism and offers a rare glimpse into

the sacrifice others make to become an Americans.

In evaluating other countries, Ronald Reagan said that the acid test of a nation's liberty and system of

government is determined by the gate test. This test was a simple observation of a nation's borders to see which side of the gate had a lock and armed guards. The test is pass-fail. If the country had guards to keep its citizens from getting out, then it fails the gate test, but a country that must guard to prevent people from getting in, passes.

This test examines perceptions of future opportunity to determine which country would gain population if people were allowed to accept or reject citizenship based on a vote of their feet. There are some countries that people yearn to inhabit and others they would leave immediately if they could.

Almost since inception, the United States has received high marks on the gate test. But, the journey to citizenship is not easy. Without experiencing or observing the process, it is difficult to fully appreciate the sacrifices legal immigrants make for the privilege of being called Americans.

In fact, 70 years ago this month, Lt. Franciszek Jarecki became a United States citizen. His path to citizenship required a literal act of Congress. Because he had defected from Poland, and was a former member of the Polish Communist Party, he had to have a congressional dispensation.

Unlike today, the Poland of Jercki's era failed the gate test. Its people wanted to leave, but guards kept them in. Jarecki, though, was a pilot and had been trained to fly the state-of-the-art MiG-15. This high-performance aircraft was by all accounts the best jet fighter in the world.

Allied pilots fighting in Korea took notice when this new aircraft was introduced into the conflict. The MiG's advanced technology had aeronautical engineers scratching their heads. It was critical to acquire one of these planes to fully check out its design and determine its vulnerabilities.

To this end, the CIA instigated Operation Moolah, which promised any MiG-15 pilot \$50,000 upon defection and political asylum in America. And, to prove the genuineness of the proposal, the testimony of Lt. Jarecki appeared on leaflets that were dropped over North Korea touting his warm welcome and acceptance.

At the time of his defection, Jarecki was only 22 years old. He was an exceptional student as only elite pilots were allowed to operate the MiG-15. But, in Poland at the time, the Soviet fist dominated everything, and the centuries long antagonism between Russia and Poland was inescapable. Fences and guards held the people in, and any sense of freedom was extinguished by the Soviet puppet government in Warsaw.



To coincide with Independence Day, many foreign nationals will publicly renounce all loyalties to their When his unit was moved closer to the Baltic Sea, a military briefing inadvertently revealed that the Danish island of Bornholm was a short distance from his base and contained a small landing strip.

> One morning while leading his patrol, he decided without much advanced planning to make a run for freedom. Wanting it to appear that his plane was having mechanical issues while also getting under Soviet radar, he dropped his excess fuel tanks and made a severe dive without any communications with the other pilots on his patrol.

> Realizing that time was critical, Jarecki flew very low above the water but was noticed by another pilot and began to hear chatter on his radio that Soviet planes were being scrambled to stop him. He was able to avoid further detection and, in a matter of minutes, had landed his plane undamaged, on Danish soil.

> His defection was risky as the consequences were severe. In fact, a few months before his flight to freedom, another Polish pilot had tried to defect but didn't have an allied airfield as close. That pilot was caught, tried for treason, and without any due process or legal niceties, summarily executed. Jarecki knew the price was high. What he didn't know was that his mother would be arrested and imprisoned because of her son's defection. Another gate test failure.

> Nevertheless, he succeeded and provided the West with the first completely intact MiG-15. Engineers from the United States were immediately dispatched to conduct a detailed examination of the plane, and Jarecki was on hand to explain the maneuverability from his pilot's perspective.

> Once the aircraft was completely reviewed, photographed, and documented, it was returned to Poland by ship. Even though Denmark was a NATO member, its proximity to Russia and the Warsaw Pact countries was such a cause of worry that Danish officials felt returning the plane even without the pilot, would serve as a goodwill gesture.

> Jarecki was treated as a hero and the Free Polish government in London recognized his service with a medal. From London he went to the United States, where he confirmed his status as a defector and supplied information about Soviet air capabilities, tactics, and his experience as a MiG pilot.

> While the United States compensated him and gave him asylum, he could not become a citizen. U.S. policy required anyone seeking citizenship to have been in the country for several years, and precluded former communists from an easy path to naturalization.

> But there was an exception, and that was for Congress to pass an act, specific to Jarecki, which effectively waived these requirements. Given the large Polish American population of his district, then-Congressman Gerald Ford sponsored

> the legislation to allow Jarecki to become an American.

Seventy years ago, this act was passed, providing yet another example of how



#### **AUGUST 14TH IS CELEBRATED AS VJ DAY** WHY DID THE UNITED STATES INTER BOTH ITS JAPANESE IMMIGRANTS AND JAPANESE-AMERICAN CITIZENS?



After Pearl Harbor and the means in which the sneak attack was carried out, Americans became highly suspicious of the Japanese. There were over 110,000 Ronald A. Hollsford Japanese living on the United States West Coast of which about 70,000 were citizens. Many lived near

strategic military areas on the West Coast, which was also closer to Japan and susceptible attack. Some Japanesethus more to Americans were very committed to the mother country, having sent tinfoil and money in Japan's war with China. Some Japanese children had dual citizenship ensured by their parents and some received a significant portion of their education in Japan. Many radio transmissions were intercepted following the Pearl Harbor attack and submarines attacked ships as they left West Coast ports. About 5,000 Japanese refused to pledge allegiance to the United States and several thousand requested repatriation to Japan. The evacuation of Japanese and other subversive persons from the West Coast was recommended by the commanding officer of the Western Defense Command. Though second and third generations of Americanized Japanese might be affected, General DeWitt still felt their loyalties might lie with Japan. Oddly enough, he stated, "... the very fact that no sabotage has taken place to date is a disturbing and confirming indication that such action will be taken" (yes, you read that correctly).

President Franklin D. Roosevelt signed Executive Order 9066 and Congress enacted it as law in March 1942. More than 100,000 Japanese in parts of Arizona, Washington, Oregon and all of California were removed to camps more inland if they had not already moved. Their property was seized. The curfew, removal and detention of Japanese-Americans was challenged and affirmed in the Supreme Court cases of Hirabayashi v. United States, Ex Parte Endo and Korematsu v. United States.

Korematsu was arrested and convicted under the law after being found in a prohibited area in California. It was argued by defense that Mr. Korematsu understood both that he was to leave or be arrested but also that anyone found in the area would be arrested.

Justice Hugo Black of Alabama wrote the majority opinion. Justice Black believed that such restrictions on a single race are suspect as being unconstitutional, but also stated that pressing public necessity might justify such action as that taken with those of Japanese ancestry on the U.S. West Coast. Black felt that only the gravest imminent danger to the public could constitutionally justify either the confinement of a race to their homes during certain hours of the day or the removal from their home.

Black said, "It was because we could not reject the finding of the military authorities that it was impossible to bring about an immediate segregation of the disloyal from the loyal that we sustained the validity of the curfew order as applying to the whole group." Further Black said, "To cast this case into outlines of racial prejudice, without reference to the real military dangers which were

presented, merely confuses the issue." We cannot- by availing ourselves of the calm perspective of hindsight-now say that at the time those actions were unjustified."

Justice Murphy wrote a dissenting opinion, saying, "The judicial test of whether the Government, on a plea of military necessity can validly deprive an individual of any of his constitutional rights is whether the deprivation is reasonably related to a public danger that is so immediate, imminent and impending as not to admit of delay and not to permit the intervention of ordinary constitutional processes to alleviate the danger." But to infer that examples of individual disloyalty prove action against the entire group is to deny that under our system of law individual guilt is the sole basis for deprivation of rights." Also dissenting, Justice Jackson wrote, "A citizen's presence in the locality, however, was made a crime only if his parents were of Japanese birth. Had Korematsu been one of four- the others being, say a German alien enemy, an Italian alien enemy, and a citizen of American-born ancestors, convicted of treason, but out on parole- only Korematsu's presence would have violated the order."

The 1984 Federal District Court case, forty years after Korematsu v. United States served to correct an error of fact (writ of coram noblis). Justice Patel wrote that the overturning of conviction was due to a factual error and not error of law in the 1944 Supreme Court case. Congress passed Title II of the Internal Security Act in 1950 to allow the President to have those apprehended that might reasonably engage in espionage or sabotage. It was suggested by a U.S. House of Representatives committee, that the law be used to detain those involved in urban riots. It enraged African Americans and was repealed in 1971. It was not the first time that a United States President had repealed the civil rights of some of its citizens, Abraham Lincoln had suspended the writ of habeas corpus during the War Between the States.

Though worthy of more than a footnote, segregated Japanese-American troops served with distinction in the European theatre during World War II as evidenced by numerous medals of valor awarded many of its members. The 60,000 surviving detainees were given \$20,000 each as reparation in 1988.

### IS BASTILLE DAY LIKE **THE 4TH OF JULY?**

Last month's column, "Declaration of Independence: Rebellion, or Interposition?" asked whether the Declaration of Independence and the War for Independence that followed were consistent with the Bible's admonition that we are to obey the civil authorities (Romans 13:1-7; I Peter 2:13).

We saw that civil disobedience is sometimes justified (Exodus 1: Daniel 3. 6: Acts 5:29); but further, we saw that the American War for Independence was neither rebellion nor civil disobedience; it was lawful interposition in which lesser magistrates "interpose" or place themselves between the people they represent and the higher magistrate who has become a tyrant. Interposition is consistent with II Chronicles 10 and the English Magna Charta of 1215. And on 4 July we celebrate Independence Day.

But France celebrates in July for another reason: 14 July is Bastille Day, the day in 1789 when, as some tell it, freedom-seeking French peasants stormed that notorious prison known as the Bastille to free the political prisoners and establish "liberty, equality, fraternity." (The original slogan was "Liberty, Equality, Fraternity, or Death!") And some think the French revolutionaries and the American patriots were fighting for the same cause.

#### [Note to readers: Does that bear any resemblance to events of today?]

In the late 1700s France was suffering from moral decay. As historian Otto Scott wrote in Robespeirre -- Inside the French Revolution (New York 1974),

"French intellectuals, middle and upper classes had grown ashamed of their country, history and institutions. Such a phenomenon had never before arisen in any nation or race throughout the long history of mankind. A great loosening began; the country slowly came apart. For the first time since the decadent days of Rome, pornography emerged from its caves and circulated openly in a civilized nation. The Catholic Church in France was intellectually gutted; the priests lost their faith along with the congregations. Strange cults appeared; sex rituals, black magic, satanism. Perversion became not only acceptable, but fashionable. ... The air grew thick with plans to restructure and reconstruct all traditional French society and institutions."

As France plummeted into economic collapse, agitators dispersed into the countryside to destroy grain stores and terrorize peasants, while hired mobs staged "spontaneous" riots in Paris. On July 14, 1789 a mob stormed the Bastille to free the "political" prisoners. Ignoring a white flag of truce, they massacred the warden and his soldiers, carrying their heads on spikes through the streets. As it turned out, there were a total of seven prisoners in the Bastille, none of whom were political. (The last arguably "political" prisoner, the Marquis de Sade, had been transferred ten days earlier.) King Louis XVI and Queen Marie Antoinette were beheaded, and in June 1792 a mob seized the National Assembly and made Danton dictator of France.

The National Assembly was increasingly radicalized under the leadership of Georges Jacques Danton and Maximilien Robespierre, and during this time the terms "left wing" and "right wing" were first coined. Led by Robespierre, the radical Jacobins sat on the left side, but they also used the term "left" in defiance of Christian tradition which portrayed believers at the right hand of God and unbelievers at His left hand.

In 1790 the National Assembly nationalized the Roman Catholic Church, made priests government employees, and created a French church under the control of the government. Priests who obeyed the Pope and refused to submit to the Assembly were evicted from their pulpits. An openly-atheistic national religion was created, the "Cult of Reason," and an actress was enthroned in the Notre Dame Cathedral as the "goddess" of reason." Over 2,000 churches were seized, renamed Temples of Reason, and used to promote this cult.

The Reign of Terror was in full swing as mobs roamed the streets looking for anyone who might not be fully committed to the Revolution. Mere accusations were tantamount to convictions, and no real opportunity was given to present a defense. 40,000 people were dragged to the guillotine (exact figures vary), two-thirds of whom

were peasants. 300,000 were executed by firing squads and other means, both in Paris an throughout the countryside.

Evil usually destroys itself, and the revolutionaries turned on each other. Danton decided Robespierre was too bloodthirsty and urged restraint; on 5 April 1794 Robespierre had him guillotined on charges of corruption. Before



his execution Danton declared, "Robespierre will follow me". And sure enough, less than three months later the mob turned on Robespierre andguillotined him 27 July

By this time the people of France had had enough, and they established a five-member committee called The Directory to restore order. But the Directory was unable to govern effectively, facing uprisings by royalists on the Right and Jacobins on the Left, and was overthrown by Napoleon Bonaparte in 1799. Liberty, equality, and fraternity gave way to dictatorship, and millions died in the Napoleonic wars that followed.

So should we celebrate Bastille Day and the French Revolution? Did they fight for the same ideals as American patriots? Observe the differences:

- 1. The American War for Independence was an act of interposition waged by the duly-constituted governments of the 13 colonies and their Continental Congress, not seeking to overthrow King George III but only seeking independence. The French Revolutionaries were a mob of self-appointed thugs who represented nobody but themselves.
- 2. The American War for Independence was, as Samuel Eliot Morison of Harvard called it, "The Conservative American Revolution." It left property, laws, and local governments in place, and only changed the seat of the national government. The French Revolution became a Reign of Terror, confiscating and redistributing property, abolishing national and local governments, and dragging untold thousands to their deaths. There was no guillotine on the streets of Philadelphia.
- 3. The Declaration of Independence is based on the "Laws of nature and of nature's God," recognizes our creation by God as the only basis for true equality and our God-given rights as the only basis for calling rights unalienable, appealed the "Supreme Judge of the world" for the rectitude of our intentions, and affirmed its "firm reliance on the protection of divine Providence." Many American churches and clergy supported the movement for independence, although some opposed it. In stark contrast, the French Revolution embraced atheism and engaged in open warfare against Christianity.
- 4. The Declaration of Independence, the War for Independence, and the Constitution of 1787 established the United States as a free nation and served as model for freedom-loving peoples throughout the world. The French Revolution became the model for socialist and Communist movements everywhere.

What do Vladimir Lenin, Josef Stalin, Fidel Castro, Mao Tse Tung, Pol Pot, and other

Rape is one of the most heinous crimes

man can commit against a woman. It has existed since before the dawn of history and has remained a serious problem in many parts of the world right until the present day.

A 2001 WHO study revealed that 20% of women worldwide had been rape or attempted rape victims at least once. In 2011, the CDC said that one in five women in America are sexually assaulted, and more than 40% are under age

Rape preventing devices are relatively recent. The earliest ones were chastity belts, which were first introduced in about the 1400's. They remained popular in many cultures up until Victorian times in the 1800's and sometimes beyond. Needless to say, they were very uncomfortable.

More radical devices began at least as early as the Vietnam war in the 1960's, when soldiers took liberties in raping women in the local villages. During that time, in Vietnam and neighboring countries, the local people developed Anti-rape devices made from short pieces of bamboo lined with sharp blades.

To make one, a piece of bamboo with a node on one end was selected for a suitable size and length to fit comfortably in a woman's vagina. Rough edges were polished off to ensure comfort. The piece was then split lengthwise to facilitate installation of the blades—anywhere from one to perhaps as many as four. The simplest design was a razor blade mounted horizontally about halfway down, which would slice a penis lengthwise anywhere from a few millimeters up to perhaps two inches, depending on the force of the input. Other designs might contain pointed blades facing downward with the sharpened edges on their back sides, allowing the penis to slide in, but cutting it on the way out. The two bamboo halves were securely glued back together, for strength and also to function as a condom to prevent impregnation and venereal diseases.

Although popular, they were condemned by others who had softer hearts for violent criminals instead of their victims.

In much of the world, and especially in African countries, rape convictions are rare. Victims have little access to medical care, and DNA tests to track down rapists are expensive.

In Post Apartheid South Africa in the 1990's, rape escalated to explosive levels, and it has now become "The Rape Capital of the World." A University of South Africa study estimated 2,777 rapes per day—a total of 1 million every yearplagued the country. Anti-rape activist Charlene Smith claimed that a South African woman is now raped every 26 seconds—40% of them children, and 65% gang-raped. Successful convictions continue to be few. People in nearly all of the country are terrified. Some women resort to drastic measures, right up to wrapping razor blades in sponges and inserting them into their vaginas. No wonder South Africans have vowed to take serious action.

In 2000, Jaap Haumann (a South African) designed a tampon-like device with "a hard cylindrical plastic core containing a tensioned spring blade primed to slice... the tip of a penis... in effect performing a minor penectomy." Haumann figured that a million women would buy and use it. Critics claimed it was barbaric. Sales never materialized, and the media ridiculed him.

Sonette Ehlers, who worked at the South African Blood Transfusion Service, met many rape victims. One of them told her, "If only I had teeth down there. That was Ehlers' "eureka" moment.

On August 31, 2005, Ehlers unveiled a condom-like anti-rape device she called RAPEX. (In 2006, the name was changed to Rape-aXe because RAPEX is also a European warning system against dangerous goods on the market).

The Rape-aXe is "a latex sheath embedded with shafts of sharp, inward-facing barbs that would be worn by a woman in her vagina like a female condom." A

rapist's penis would easily slip into the device, but upon withdrawal, the barbs would snag it and cause "excruciating pain," distracting and disabling him and allowing the victim time to escape.

The device would remain attached to the rapist's penis, and would only become more painful if he attempted to pull it loose. He would also be unable to run and chase the victim.

The rapist's only option is a hospital emergency room, where it can be safely removed surgically. The hospital can then take DNA samples and detain him for the police.

Unlike the crude Vietnamese devices, and in spite of the pain, the Rape-aXe does not damage the penis or even break the skin. Like an ordinary condom, the Rape-aXe also prevents impregnation and veneral diseases.

Nevertheless, some critics, including many women, have condemned the Rape-aXe for being cruel. It is not. It does no permanent damage, other than some well-deserved trauma for the rapist. WHY are they feeling sympathy for vicious sadists, and none for the victims?

Ehlers consulted engineers, gynecologists, psychologists, and convicted rapists to determine its effectiveness and sold her house and car to begin production. She reportedly distributed 30,000 for free at the 2010 World Cup soccer venues. After a trial period, they would be sold for about \$2 each.

Women would not need to wear the Rape-aXe all of the time. Ehlers said, "The ideal situation would be for a woman to wear this when she's going out on some kind of blind date ... or to an area she's not comfortable with.'

Development of the Rape-aXe is still under way. Many prototypes have been made. The cost of production has been brought down to one rand, about 14 cents each—a huge profit margin with a retail price of \$2.

But production and marketing are still on hold. WHY? We do not yet know when the Rape-aXe will become available for the public. Many women are praying that it will be very soon. Eighteen years have passed since its introduction in 2005.

ATTENTION, SONETTE EHLERS: Rape victims all over the world have been waiting NEARLY TWO DECADES to purchase your product. STOP the rape pandemic. STOP dragging your heels. Quit begging for donations on GoFundMe. PRODUCE a batch and sell them on Amazon and eBay IMMEDIATELY. Use that 14X profit margin to make more and repeat, again and again. Soon you will have that \$310,000 you want for more research and development, if it's even needed.

And ENTREPRENEURS need to come forth and manufacture similar devices, just in case Sonette fails to deliver.

When rumors of this radical policy change began to circulate in December, Senator Tuberville issued a stern

warning to Pentagon officials, threatening to block their nominees in the Senate if they persisted. However, the administration defiantly proceeded with their illegal plan, prompting Senator Tuberville to fulfill his promise by blocking nominations.

In response, the Washington outrage machine sprang into action. Majority Leader Chuck Schumer took an unusual step calling out Senator Tuberville by name on the Senate floor. Being relatively new to Capitol Hill, Tuberville was surprised to find himself the specific target of the majority leader four days in a row. A symphony of pro-abortion Democrats joined Schumer, reproaching Tuberville for staying true to his word.

This indignation, however, is markedly selective. Senate Democrats have recently threatened holds on military nominations to halt the relocation of the military's Space Command from Colorado to Huntsville, Alabama – a decision deemed optimal by the Air Force.

Senator Tuberville's hold has so far impacted 187 nominations. Yet Democrats need not chastise him, especially as they disregard the military's real crisis: recruitment. Thanks to the Biden administration's liberal appointees, the military has experienced its sharpest drop in recruitment in 50 years. There's a shortfall of more than 15,000 Army recruits from last year, not to mention over 8,000 service members discharged due to Biden's vaccine mandate.

Democrats have failed to elucidate how abortion makes our military stronger or safer. Their sole focus is to win the culture war.

Contrary to Democratic rhetoric and outright lies by the mainstream press, Senator Tuberville's hold does not prevent confirmations. Senators could circumvent his hold with a straightforward confirmation vote on a specific nominee. It merely stops nominees from being confirmed en masse via a process known as unanimous consent. With the Senate having taken 35 days off this year, there has been ample time to vote.

Senator Tuberville is not a career politician. He is a proven leader and a devoted public servant. His unconventional path to the Senate has equipped him with a fresh perspective and a distinct set of skills. He has shown that he can face the opposition, rally his team, and deliver results. He is the kind of leader that America needs — a leader who prioritizes principle over politics and service over self-interest.

#### **Nathan Bedford Forrest Revisited**

In the October 2022 Alabama Gazette I covered part of the legacy of Nathan Bedford Forrest (https://www.alabamagazette.com/story/2022/10/01/opinion/the-false-demonization-of-nathan-bedford-forrest/2434.html). If anyone has been a victim of "the winners write the history," it is Forrest. From his humble Tennessee roots, Forrest was the quintessential self-made man, a masterful military leader, and the antithesis of most of

After his father died, sixteen-year-old Forrest became the sole supporter of his family. He eventually met Mary Ann Montgomery. Mary Ann had also lost her father and she became a ward of her foster father and uncle, Rev. Samuel N. Cowan, a Cumberland Presbyterian parson. In 1845 Mary Ann married Nathan Bedford Forrest despite Cowan's disapproval, much of which arose from Forrest's "cussing and gambling."

Possessing a great work ethic and sharp mind, Forrest engaging in farming, horse-trading, real estate brokerage, and slave trading. By the war's outset, he was worth a million and a half dollars. He enlisted as a private in the 7th Tennessee Cavalry, and used his own money to raise and equip a battalion of mounted troops. In a short time, Forrest's military prowess became obvious—it was admirably recognized by Robert E. Lee and somewhat begrudgingly acknowledged by U.S. Grant, William T. Sherman, and other Union commanders.

Although some modern residents of Selma, Alabama, lack appreciation for Forrest, he deserves credit for doing everything in his power to keep Selma from being totally destroyed by the invaders. Forrest led roughly 4,000 defenders (perhaps half were actually soldiers) as they attempted to stop approximately 9,000 well-armed Union soldiers. The overwhelming odds did not allow for Selma to avoid destruction.

On July 27, 1871, Forrest testified before a Congressional Committee for over four hours. Facing charges of being a founder and early Grand Wizard of the Klan and being part of the Knights of the White Camelia, Forrest vehemently denied the accusations. The Klan was actually started in Pulaski, Tennessee, by six individuals (four were lawyers), with the original intention of being a social club. The term "Klan" was thought to be a variation of "Clan" based on the prevalence of the "founders" Scottish and Scots-Irish lineage. The original Klan also had a social welfare and aid angle to help those who had been harmed by Reconstruction. According to writer Lochlainn Seabrook, the original Klan had Black members and it undoubtedly had Jewish members. The Klan that sprang up in the early 1900s was totally different.

During the Committee's interrogation, Forrest stated: "I said to 45 colored fellows on my plantation that I was going into the army; and that if they would

go with me, if we got whipped they would be free anyhow...Eighteen months before the war closed I was satisfied that we were going to be defeated, and I gave those 45, or 44 of them, their free papers for fear I might be called...It is clear from the end of 1863 to the close of the war these 44 black men served as free men under the flags of the Confederacy." A few Blacks who served with Forrest included: Thornton Forrest, Ben Davis, Nim Wilkes, Polk Arnold, Jones Greer, Frank Russell, Preston Roberts, Alfred Duke, George Hanna, Ned Gregory, Robert Bruce Patton, Marshall Thompson, Hardin Starnes, John Terrill, Wright Whitlow, Lewis Muzzell, Alex Porter, James Jefferson, and John Sharp. All received Confederate pensions. Wilkes asserted, "I was in every battle General Forrest fought after leaving Columbia..." Duke stated, "At the beginning of the war I was with General Forrest's regiment...I was in Confederate service almost the entire period of the war." Nelson Winbush, a descendant of Louis Napoleon Nelson, of Forrest's 7th Tennessee Cavalry, referenced loyal Black Confederates: "You won't see this in the history books because the history books are written by Yankees. They aren't about to put in there that they had some black dudes shooting at their asses for keeps." Winbush is correct. Modern court historians would never acknowledge such a deviation from the "government-approved" narrative.

Post-war, Forrest was heavily involved with the railroad industry. He felt all Southerners should be given a chance to work and support themselves and their families and he worked tirelessly to achieve that reality. Indeed, after becoming a Christian, many considered Forrest to be a social liberal.

For over twenty years, Butch and Pat Godwin have celebrated the birthday of Nathan Bedford Forrest at Fort Dixie, near Selma. Sadly, due to health concerns, this year's event had to be canceled. The Godwins are amongst the few who know the true history of Nathan Bedford Forrest and have the temerity to display it. As Pat stated: "Perhaps this year 2023 will be called the HICKUP YEAR and next year will be the 25th Anniversary of Ole Bedford's Birthday Celebration!"

#### The surplus in the Education Budget was enormous.

How to spend this surplus became the focus of the entire session. There is a very accurate political assessment, that it is much more difficult to deal with a surplus budget than a lean or deficit budget. George Wallace told me about this same thing during his last term as governor when I was a freshman legislator.

Accolades go out to Senator Arthur Orr (R-Decatur), Chairman of the Senate Education Finance and Taxation Committee and Representative Danny Garrett (R-Trussville), Chairman of the House Education Ways and Means Committee. These two gentlemen essentially, singlehandedly wrote the Education Budget and did a masterful job. They were cognizant that what goes up has to come down. Therefore, they created several savings accounts and rainy day funds for the rainy days ahead, because they will come.

The Education Budget was an historic \$11.5 billion. It gave increases for pre-kindergarten programs, school supplies, school nurses and a significant 2% cost of living salary increase to teachers and support personnel. All colleges and universities in the state received increased funding. Non-education entities

were given money. There was \$100 million for prison education.

The high profile aspects of the Education Budget windfall were a onetime rebate going back to taxpayers in November. Governor Ivey had wished for a \$400

per person and \$800 per couple rebate. However, the final result is \$150 per person and \$300 per married couple. Most legislators preferred eliminating the grocery tax or long-term tax cuts to this one-time check back in November.

The surprise in the Christmas stocking from the Education Budget surplus is the reduction on the state sales tax on groceries. Eliminating or reducing the state tax on groceries has been championed by Democrats for years, as the tax is regressive and hurts the state's lowest income earners the hardest. However, the measure garnered Republican bipartisan support this year after 20 years and passed with an overwhelming vote in both Chambers. It is, however, a gradual reduction. The grocery tax would decrease 2% in two steps, with the tax being reduced 1% this year and another 1% percent new year, if the funds are available.

The state General Fund had a good year as well. The \$3 billion General Fund was record shattering. The largest in history. The Chairmen, Senator Greg Albritton (R-Escambia) and Representative Rex Reynolds (R-Huntsville), oversaw a \$159 million increase over the current year. The largest increases in the budget were in Medicaid by \$69 million and Corrections

State employees will see a 2% increase in pay, which will go into effect as the new fiscal year begins October 1. The legendary head of the Alabama State Employees Association, Mac McArthur, has quietly garnered state employees a cost of living raise, five out of the last six years.





Master Sergeant (MSgt) Thomas Charles Ford served 20 years in the United States Air Force, and his Air Force Specialty Code (AFSC) was medical technician. He received the Good Conduct Medal three times, the Unit Citation and the Meritorious Service Medal.



MSgt Ford was born October 21, 1938 to his parents, Thomas Edward and Julia Ford at Antigo, Wisconsin. Although he dropped out of high school at age 18 and entered military service, he received a B.S. Degree in Business in 1973 and a Master's Degree in Business in 1976 from Auburn University using the Veterans Administration Tuition Assistance while still in military service.

MSgt Ford enlisted in the U.S. Air Force March 3, 1957 at the induction center at Milwaukee, WI. MSgt Ford completed 15 weeks of Basic Training at Lackland, Air Force Base (AFB), TX. He trained as a medic for

four months at the Naval Station Great Lakes. His first assignment was at Olmstead AFB, PA, for 18 months where he worked in the dispensary, the emergency room and the wards. He was transferred to Elmendorf AFB, AK, for two years where he worked in the hospital first in the emergency room and then as a surgical technician for three months. He was transferred to Andrews AFB for a one year assignment working in the emergency room 1961-1962, trained as a cardio-pulmonary technician at the nearby National Naval Medical Center at Bethesda, MD, for one year 1962-1963 and then returned to Andrews AFB working as a cardio-pulmonary technician for two years 1963-1965. He was next deployed to work as a cardio-pulmonary technician at the hospital at

Wiesbaden Air Base, Germany, for three years. He returned to the U.S.A. to work as a cardio-pulmonary technician at Travis AFB, CA, for three years where he worked in the hospital for two years and then cross-trained as a computer program technician for one year while at Travis AFB. Next, he went to Bolling AFB, Washington, D.C. where he worked as a computer

programmer. His final assignment was at Maxwell AFB, AL, as a computer programmer where he retired March 31, 1977.

MSgt Ford and his wife, Doris, have been married 58 years, and they have three children, six grandchildren and five great-grandchildren. Since retirement, he served as a volunteer repackaging medicines at Medical Outreach Ministries, a medical clinic for uninsured adults at Montgomery, AL. He is a member of Frazer Church, at Montgomery, AL, where he volunteered in the kitchen and served on the Board of Stewards. For recreation, he has enjoyed bowling.



MSgt Ford's conclusions about what serving in the military has meant to him are: "It saved me. It gave me a future. My parents did not have much. I was interested in doing something for my country. My great-great grandfather had served in the American Revolution and the War of 1812. My great-grandfather served in the Civil War. I wanted to continue my family's tradition of military service. It was time well spent. If I had to do it, I would do it over again."



#### LT. COL GEORGE ROBERT PARTRIDGE

Lt. Col George Robert Partridge served 33 years in the U.S. Military including seven months enlisted in the Marine Corps Air Reserve and 32 years in the U.S. Air Force including four years as enlisted and 28 years as an officer. His Military Occupational Specialty Code (MOSC) was fighter pilot racking up more than 5,000 hours flying military aircraft. Lt. Col Partridge served three "temporary" tours for a total of 13 months in Vietnam. The F-100 Super Sabre, the first fighter in the inventory that could break the speed barrier in level flight, the most versatile day fighter in service and a fighter-bomber with nuclear delivery capabilities was his favorite mount in the service. He received the following medals, decorations, citations and badges: Silver Star; Bronze Star; Distinguished Flying Cross; Air Medal and Purple Heart.



Lt. Col Partridge was born to his parents, George and Lenna Partridge, at Doraville, GA, in 1933. He was reared at Chamblee, GA, and Norcross, GA, and he graduated from Lilburn High School in 1949. He attended North Georgia College, a military college, for two years majoring in mathematics. Because of his strong desire to become a military pilot, on March 4, 1951, he enlisted in the Marine Air Corps Reserve, but he served only until March 28, 1952, and then on March 29, 1952, he enlisted in the U.S. Air Force, where he completed eight weeks of Basic Training at Lackland Air Force Base, (AFB), TX. He was sent to Claysburg, PA, a radar site, where he

worked in administration for six months. He then attended the Jet Mechanic School at Amarillo, TX, for 12 months.

Next, he returned to Claysburg, PA, followed by assignment to the New Castle Airport, DEL, a joint use base with civilian aircraft operating as well as U.S. Air Force where he worked as a jet mechanic until January 1955. He was finally sent to Lackland AFB, TX, for preflight pilot training followed by training to fly the T-34 and T-28 at Spence Air Base, GA.

Next, he was sent to Bryan AFB, TX, for training to fly the T-33 jet. He returned to serve at the New Castle Airport, DEL, to fly the F-94-C jet with the 97th Fighter Interceptor Squadron for one year. This was followed by serving at Hamilton AFB, CA, where he flew the F-89 Interceptor from January 1958 to September 1958 and also when he was transferred to Canadian Force Base, Goose Bay, Labrador. Next, he served at Tyndall AFB, FL, where he completed radar controller training, and then he served as a mobile radar controller at Ft. Gordan, GA, on Temporary Duty at Vietnam for five months September 1961-February 1962 where he flew the F-100 serving as a forward air controller with the 1st Infantry Division and then on regular duty at Shaw AFB, SC. He then served as a pilot of the F-100 at Cannon AFB, NM, flying and instructing.


In 1965, he had a three month deployment to Japan and Korea. Col Partridge escaped fatal injury when he was forced to eject from his F-100 when flying near Kunsan, Korea, because of weather and fuel problems in May 1965. He served as the Forward Air Controller to the 2nd Battalion, 2nd Infantry, 3rd Brigade, US Infantry Division on a second TDY tour to Vietnam September1965 to February 1966. He then served as a pilot and instructor of the F-100 at Luke, AFB, AZ, 1966-1968.

Next, he served as the Action Officer at the Pentagon preparing information for the generals 1968-1970. Although he volunteered for service as a pilot of the F-100 at Vietnam, he was assigned to serve as the Operational Plans Officer at Seymour AFB, N.C. and at Shaw AFB, S.C., 1970-1971 followed by two years of service at Clark Air Base, Philippines as Assistant Plans Officer Plans Officer in 1971 with the 405th Fighter Wing. He was sent TDY to Tan Son Nhut AB, Saigon, Vietnam, on June 1,1972 to serve as the Fighter Duty Officer for the 7th Air Force Tactical Control Center. He completed training at the U.S. Survival School at Fairchild AFB, WA, and at the USAF Air/Ground Operations School at Hurlbert Field, FL. He served one year in 1973 at Osan Air Base, Korea, with the 19th Tactical Air Support Squadron as Operations Officer. Next, he served at Eglin Field AFB, FL, as the Division Chief in Command and Control 1974-1977. Then he served at Mitchell Field, N.Y., as the Liaison Officer to the New York Civil Air Patrol 1977-1982 and also in this role with the AL Civil Air Patrol Headquarters 1982-1984 where he retired from military service October 1, 1984.

After his military service, for 10 years, Lt. Col Partridge worked as the Job Coordinator at the Louise M. Smith Development Center at Prattville, AL, where services included daily living skills, prevocational training and basic

education for high school students and adults. During this time, he also returned to his love of flying working as an instructor at the Maxwell AFB Aero Club. While working at Montgomery, AL, he graduated from Troy University with a Master of Science Degree in Adult Education in December 1983. Lt. Col Partridge retired from all employment in 1999.

Lt. Col Partridge and his wife, Patricia, were married 45 years before she passed away, and they had two children and two grandchildren. He and his wife, Margaret, have been married 20 years. They have enjoyed traveling especially to reunions of Air



Force squadrons and to sites in Europe which his father had described in his letters where he had served during WWI. They belong to First Baptist Church of Prattville, and he belongs to the Daedalians, the premier organization for U.S. military aviators and to the Lions Club International at Prattville, AL, from which he received the Lions Club Melvin Jones Fellowship Award. He was inducted into the Georgia Military Hall of Fame and in November 2018 received the Medal for Valor in combat in Vietnam. His autobiography, My Story...And I'm Sticking to It, I think, is available for sale on Amazon. For many years, he presented a "live" military uniforms ceremony at Prattville, AL, using items from his collection of military uniform memorabilia.

Lt. Col Partridge's conclusions about his military service are: "It was a life long ambition to be an Air Force pilot, to become a veteran pilot and to retire. I felt good about my service as I am a patriotic person. I wish people would remember why we are free today."

#### SOCIAL SECURITY EXPANDS OUTREACH AND ACCESS FOR SSI

Social Security has expanded its outreach to people in critical need of financial help who may be eligible for Supplemental Security Income (SSI). SSI provides monthly payments to adults age 65 and older or to other adults – and children – with a disability or blindness who have limited income and financial resources. SSI helps pay for basic needs like rent, food, clothing, and medicine.

We identified underserved communities in rural and urban areas across the country. We focused on areas with the greatest decline in SSI applications since the pandemic. Our outreach efforts targeted areas where a majority of people are living at or below the federal poverty threshold.

People who receive SSI may qualify for other financial help, including Supplemental Nutrition Assistance Program or SNAP benefits (formerly known as food stamps), Medicaid, and discounted internet service through the Federal Trade Commission's Affordable Connectivity Program. Social Security beneficiaries may also be eligible for SSI.

### Truth Is Like A Lion

Two of my favorite truth quotes are:

"You will know the truth and the truth will set you free." -Jesus, John 8:32 And ... The Apostle Paul states, "Love does not delight in evil but rejoices in the truth." -1 Corinthians 13:6

God is truth. When we tell the truth, we live as God wants us to live and as God has commanded us to live. "You must not testify falsely against your neighbor." Or "You shall not lie." -Exodus 20:16

When we lie, we go against what God expects of us, and we disobey His Commandments. Often people lie because they are concerned about getting in trouble or perhaps they fear that by telling the truth they will hurt someone. But we lose our integrity when we lie. We hurt ourselves, and we hurt others. We lose our integrity not only in the eyes of others but also in the eyes of God. Lying diminishes our relationships with others and destroys trust.

Think about how the world would be different if no one ever lied. At first it is a scary thought. After all, if we didn't lie people would get hurt right? For example, you might hurt your relationship with your best friend if you told him or her that you couldn't stand a certain character trait of theirs. Or you may have to pay a bit higher taxes if you told your accountant about a particular gift or inheritance you didn't want to declare on your income statement. Yet, not being able to lie might teach us to be more tactful with our friends or more honest about our business affairs.

We must learn the skills that will help us be honest in all of our relationships. If we want to be people of integrity and honesty, we have to overcome the temptation to lie. It can be frustrating at times and fear is the biggest emotion we must overcome when we face the temptation or desire to lie. Yet we must always keep in our hearts and minds that there is a way to tell the truth that is good, right and wholesome!

How can we live as people of truth?

Think first.

Sometimes we lie so we can give a quick answer to someone. Before you speak or answer a question, take a deep breath and pray about how you can say the truth in a tactful way. Sometimes you don't need to say anything at all.

#### **Keep It Real**

Lies aren't always full untruths. Sometimes we exaggerate or stretch the truth. Exaggerating or stretching the truth is also lying. We often do it to make ourselves look better. But is it worth it? Be authentic. Be real. People are usually very impressed with people they can always trust to tell the truth no matter what.

#### **Set Things Right**

We have all given in to the temptation to tell a lie or exaggerate. If you have or if you do in the future, pray about and look for the opportunity to make it right and tell the truth. It will be uncomfortable, but telling the truth will set you free to be who God created you to be. You will experience a freedom that comes from being a person of integrity who speaks the truth.

Determine today that you will be a person who always speaks truth. I will close with two more of my favorite quotes about truth:

"Speak the truth in love." - Paul, Ephesians 4:15

#### "REFLECTIONS"

On a lark I located Robert Fulghum's three books lately and reread them. He was my favorite writer in the 80s, best-known for "All I Need to Know I Learned in Kindergarten." My favorite story is

the namesake of his second book. Fulghum reported that firefighters rescued a man from a burning bed. They asked if perhaps he was smoking and fell asleep, but he responded, "No, it was on fire when I lay down on it."

This poor man was obviously chemically impaired that day, and fortunate to survive!

But I think of this story often when I observe some of us doing the same thing.

I see this in marriages when couples rush into relationships without thinking about the challenges they'll face. It's been said that many couples spend more

time planning for a 20-minute wedding than planning for a 50-year life.

A couple I know found a local church offering an eight-week premarital course. I told them they were my heroes and I'd use them as an example forever more since they did it right.

Most of the time those in second marriages have learned hard lessons previously and enter the new relationship with greater understanding that moonlight and roses can become daylight and diapers! But there are couples who sign-on for a new marriage quickly "on the rebound" without proper foresight about acquiring new children and perhaps bitter ex-relatives. The bed is burning

Dr. Charles Chandler who founded "Ministering to Ministers" for ministers in crisis situations often talked about "the messiah complex." Pastors suffer from this when they rush to accept calls to conflicted churches, reasoning "I know they've had problems, but they've never had a pastor like me!"

Sam Rainer wrote about a church that had four congregational splits in a tenyear period. The new pastor learned that the previous split happened after a business meeting. Someone in "new business" claimed that a family had stolen one of the church's Christmas trees. Then someone else said that no one would do this because the trees were ugly, which offended the family who donated them. And then someone else accused members of misusing the church's photocopy machine. And on it went.

It all made sense when the church secretary told the new pastor he best not mention Christmas trees or copy machines.

This church was certainly "on fire," but not in zeal for the Lord.

Wise church leaders do their homework. They take time to discuss issues and programs with key leaders, valuing their insight, instead of rushing into a business meeting or worship service already "on fire."

Fulghum's wisdom remains: if the bed is burning, we should be very cautious

### Potpourri for August

Recently I had a disaster in my flower garden with a rogue armadillo rooting and digging up some expensive

Pentas that I had just planted a few days before. The unfortunate incident occurred at the farm which is in south Dallas County. I have had trouble with these critters before, and I ordered from Amazon a product named Armadillo Scram. It seems like I used up the whole bag in 2 areas about a year ago. So what do they say, out sight, out of mind. After replanting these Pentas which most survived, I ordered more of the repellant. But before it came, my son's dog, Belle, chased down both of these destructive pests and in an instant we had 2 funerals. I now look at Belle as a heroine.

Annuals, perennials and even herbs have escalated in price. For instance, herbs at any of the box stores costs about \$5.00 per plant. Ridiculous. So I have begun sowing seed in black plastic 6 packs and when I ran out of them, I used the **CARDBOARD EGG CARTONS** that I saved after using the eggs. These are great as they



do not seem to dry out as quickly as plastic and when the seeds are big enough to plant in the garden, you can plant the carton as is into the soil. The spacing for

most seedlings is just about right. Some plants need to be sown directly in the garden without transplanting from the seed tray. These would include: **zinnias**, **cleome**, **and cosmos**. These can be sown at any time from April through late fall. We in zone 8 can have, for example, 3 crops of these wonderful tall showy annuals.



This year I have had great luck wintering over Dragon Wing Begonias, and geraniums. Around the end of March, I cut off any dead stems and leaves from the plants and put them into large outdoor pots, fertilize, and water them in. Do not be discouraged as they will most probably look a little rough. Within a couple of weeks they will put on new growth and thrive. Now at the end of July or the first of August, they will have gotten so large, it will be necessary to cut them back by a third. If I do not cut them back, within a month they will get leggy and flop over. I admit this task is hard to do because they look so beautiful, full of blooms and so vibrant. But you must be ruthless if you want an outstanding pot garden for fall. During the summer months I fertilize the geraniums at least 3 times per month, and usually feed the begonias a liquid fertilizer about one time per month.

Some people still have not learned that to prune flowering shrubs such as camelias, azaleas, and forsythia now, will assure that these bushes will have no blooms next spring. Someone asked me why their indica azaleas were spotty bloomers for years, and then I found out their annual ritual of pruning all shrubs late summer was the reason why. One can prune these flowering shrubs as much as you desire up to 6 weeks after their spring bloom.

Here is another tidbit I have learned over the years which helps with increased indeterminate tomato production. Of course plenty of fertilizer, periodically pruning up the plants from the bottom to let in more light.

The difference between determinate and indeterminate tomatoes can be summed up by saying that determinate plants produce all at once and the indeterminate plants bloom and produce until frost.



worst four-letter word in the English language. Wait. Ugh! What a disgusting word. And yet, it is perhaps God's greatest tool for building trust. The prophet Isaiah wrote about waiting. He said this.

and to him who has no might he increases strength.


Even youths shall faint and be weary,

#### TOMATO PIE

A rich and savory pie that is best made with summer tomatoes at the height of ripeness.

#### Ingredients:

½ cup Lemon juice

- 3 T vinegar
- 1 cup butter
- 2 teaspoon pepper
- 1 teaspoon red pepper 1 teaspoon dry mustard
- 1/2 teaspoon salt
- 1 medium onion chopped
- 1 teaspoon garlic powder
- 3T Worcestershire sauce



#### Filling:

2 cups shredded sharp cheddar cheese, about 10 ounces

- 1 cup Dukes mayonnaise
- 1 tablespoon chopped fresh parsley
- 2 green onions, white and green parts, chopped
- 1 tablespoon grated Parmesan cheese
- 1 cup Panko bread crumbs

½ pounds firm fresh tomatoes, sliced ½ inch thick Corn meal as needed. About 1 tablespoon

#### Instructions:

- 1. Make pie crust. Combine flour, salt and sugar in a food processor. Add butter and pulse until the mixture resembles coarse meal, about ten seconds.
- Slowly add ice water, pulsing the mixture for no longer than 30 seconds, just until it begins to form a ball.
- 3. Divide the dough ball into 2 pieces and place each piece in a piece of saran wrap. Flatten into a disk, wrap in plastic wrap and refrigerate for at least 1 hour.
- 4. Remove dough from refrigerator. Let the dough rest for several minutes at room temperature and then roll it out on a lightly floured surface until it fits a nine inch pie plate. Transfer pie crust to pie plate. This is easy to do if you roll the dough on a piece of parchment paper and then just flip the pan and peel the paper off.
- 5. Place the tomato slices on paper towels to remove most of the excess moisture.
- 6. Preheat oven to 425 degrees.
- 7. In a medium bowl mix together the cheese, mayo, parsley, green onions, parmesan and bread crumbs.
- 8. Layer ½ of the tomato slices with the cornmeal in the pie pan. Cover with half of the cheese mixture. Repeat layers.
- 9. Bake for about 30 minutes or until the top of the pie is browned and bubbly. Serve warm.

Notes: Makes about two pies. You can try using pre-made pie crusts. Use very ripe tomatoes. Use pepper-jack cheese to spice it up a little bit. Add a bit of tarragon or Italian seasoning. Recipe adapted from the Tupelo Honey Café Cookbook

If there is any better time to use items that you picked last year, open up your freezer and find your stored frozen peaches. Peaches were not a good crop this year. Without a freezer and if you have a desire for a peach dessert, you have two choices! Canned or paying an arm and a leg for peaches in the store. I happen to have a freezer and had a good crop of peaches last year. This recipe is one reason to have a freezer pantry.

#### Potato Salad

No picture is needed for this because no summer picnic is complete without potato salad. This classic recipe is easy to make and is always a crowd pleasure. It has hard-boiled eggs, celery, onion, dill relish and mustard. It goes with any sandwich or grilled meat. You can make it ahead of time and keep it cold until ready to serve.



#### **CUMCUMBER BOATS**

#### **Combine all ingredients** desired in a bowl and chill.

- 4 cucumbers peeled if desired.
- 3 cans tuna drained
- 3/4 cup chopped celery
- 3/4 cup Dukes mayonnaise
- ½ teaspoon celery salt
- 1 tsp. onion salt
- 1 handful basil. Finely chopped
- 2 hard boiled eggs, chopped
- 3 Tbsp. whole grain mustard Juice from one lemon.



Any other items such as small chopped apples, chopped grapes. Cut the cucumbers lengthwise and scoop out the seeds Fill each cucumber with desired mixture and serve chilled as a cold side dish. Top with chopped parsley.

- 2. Press dough onto the bottom and halfway up he sides of a 9x13 inch pan.
- 3. Cover dough with the drained peaches.
- 4. Make the topping by mixing the cream cheese, sugar, and reserved juice with an electric
