## Fragile Ceasefire Holds Between Iran and Israel After 12 Days of Escalation

June 24, 2025 – WASHINGTON, D.C. —

President Donald J. Trump (R) announced a tenuous ceasefire between Iran and Israel bringing at least a temporary halt to nearly two weeks of intense military conflict that drew in the United States and had some more hyperbolic pundits even warning of World War III.

On June 21, 2025 President Trump addressed the nation to announce that the U.S. had launched devastating attacks on three Iranian nuclear sites. The U.S. Air Force used B2 stealth bombers to drop 14 bunker buster bombs to penetrate the hardened bunkers protecting the Iranian nuclear enrichment facilities. The U.S. Navy also launched 30 Tomahawk cruise missiles at the targets. Most Alabama leaders were supportive of the President's actions. Representative Mike Rogers (R-AL03) is the Chairman of the House Armed Services Committee.



The President made the correct decision to strike Iran's nuclear sites," said Congressman Rogers in a statement. "Iran made the choice to continue its pursuit of a nuclear weapon and would only be stopped by force. It would be a grave mistake to attempt any retaliation against our forces or homeland."

Alabama Governor Kay Ivey (R) said on social media, "God bless our country, and God bless our troops! Proud to live in the greatest nation on Earth."

Congressman Dale W. Strong (R-AL04) said on X, "A nuclear-armed Iran is a threat to the entire world. They had ample time to come to the table and make a deal but forced President Trump to take action to ensure the safety of our country and our allies."

Alabama Attorney General Steve Marshall (R) said on X, "I support President Trump's swift and decisive action to protect America and our allies. Praying for our men and women on the front lines. We stand strong with Israel."

U.S. Senator Tommy Tuberville (R-Alabama) said on X, "God bless our Troops. God bless President Trump. And may God continue to bless the United States of America."

Congressman Robert Aderholt (R-AL04) said on X, "I fully support President Trump's decision to take out Iran's nuclear facilities. As I have said, I believe that if Iran gets a functioning nuclear weapon they would not hesitate to use it against Israel or the United States. When they say death to Israel and death to America, we have no reason not to believe them. I pray this action has made the world safer. President Trump has pledged to get us out of "forever wars." This could be a step toward ending the war we have been in with Iran since 1979. They have killed hundreds and hundreds of Americans in the past half century."

Former State Representative Perry O Hooper Jr, (R-Montgomery) said, "The strikes on Iran's nuclear facilities were not just a show of strength-they were a message. A message to Tehran, to their terrorist proxies, and to the world: The United States will not sit idly by while the world's leading sponsor of terror races toward a nuclear bomb." Hooper is a columnist whose works are regularly published in the Alabama Gazette.


Congressman Gary Palmer (R-AL06) said in a statement, "I fully support President Trump's decision to destroy Iran's nuclear facilities. This decision was forced upon us by the refusal of the Iranian leadership to accept the reality that the U.S. would never allow them to have a nuclear weapon. With this action, American resolve to eliminate any and all threats against our country and our allies was put on full display."

Alabama Lieutenant Governor Will Ainsworth (R) said, "I trust President Donald Trump and believe he is taking the steps necessary to protect our country, promote its interests, and put America first. Iran has been a bad actor for 46 years, and bad actions reap bad consequences. Support our President and ask God to bless America."

Congressman Barry Moore (R-AL01) said on X, "I stand with President Trump. God bless him and our brave service members."

Auburn men's basketball Coach Bruce Pearl said on X, "Thank you Mr president for your strength and vision, keeping us safe. Proud of our troops! You did what no one has had the courage to do for far too long. You were patient and clear. Pray for Peace through prosperity in the Middle East, expand now on the AA. You prevented a War."

Congresswoman Terri Sewell (D-AL07) took a much harsher tone. "The Constitution is very clear: only Congress can



Rep. Sewell said in a statement. "It puts U.S. forces and our diplomatic personnel at peril and brings us dangerously close to all-out war in the Middle East. The Trump Administration must immediately brief Congress and takes steps to prevent further escalation of this conflict."

The conflict began on June 12, 2025 when the Israeli Air Force rained bombs down on Iran. The Israeli attacks had destroyed much of the Iranian Air Force and

defenses as well as killed many of their Republican Guard leadership prior to the U.S. operation.

Alabama Attorney General Steve Marshall (R) said on X at the time, "We stand firmly with our ally as it acts to ensure the safety and sovereignty of its citizens."

Congressman Robert Aderholt (R-AL04) said on X, "Israel has a right to defend itself from those who wish it harm and its extinction. And there is no greater threat to Israel than the prospect of a |nuclear armed Iran. These strikes tonight come not because of Israel but because of the path Iran has chosen. Years of appeasement."

The United States was briefed by Israel ahead of their actions.

"Israel advised us that they believe this action was necessary for its self-defense," said Secretary of State Marco Rubio. "President Trump and the Administration have taken all necessary steps to protect our forces and remain in close contact with our regional partners. Let me be clear: Iran should not target U.S. interests or personnel."

The Iranians retaliated against Israel by firing missiles at them. The Iranians had launched two largescale unprovoked attacks the year before with little effect. Some of the Iranian missiles did get through Israel's 'Iron Dome' missile defense system killing 11 Israelis and wounding over a 100. After the U.S. bombed the Iranian nuclear sites Iran fired missiles at Qatar where 8,000 U.S. service members are based. Those missiles were all safely intercepted.

The ceasefire was initially marred by mutual accusations of violations. However, by late Tuesday, both sides had largely ceased hostilities, and international observers expressed cautious optimism that the truce will hold. The White House declared the U.S. bombing campaign a success. "Last weekend, the United States successfully carried out a massive precision strike on Iran's nuclear enrichment facilities, and it was very, very successful—It was called OBLITERATION," said President Trump on Truth Social. "This incredible exercise of American strength has paved the way for peace, with a historic ceasefire agreement..."

#### ACCS Is Just What the Doctor Ordered for Alabama Jobs

The recently completed 2025 Regular Session has concluded successfully. Anytime you record solid balanced budgets, you have succeeded.

Both the Education Budget and General Fund Budget are sound, thanks to the good work of the Budget Chairmen. Senator Arthur Orr (R-Decatur), Representative Danny Garrett (R-Trussville), Senator Greg Albritton (R-Escambia), and Representative Rex Reynolds (R-Huntsville) have done yeoman work. Legislative leaders, like Speaker Nathaniel Ledbetter (R-Rainsville) and Senate President Pro Tem Garlan Gudger (R-Cullman), have provided outstanding leadership.

The Education Budget reflects the respect and knowledge of the importance of our **Alabama Community College System**. This system is the mainstay of job creation, economic development, and future economic growth for Alabama. The Community College System is the leader when it comes to creating jobs and employment in our state.

# What are the legal implications of the pregnant "brain dead" woman in Georgia?

The 2022, Dobbs decision handed down by the United States Supreme Court ended the long held Federal right to abortion under the 1973, Roe v Wade case. In ending the Federal right, it returned the decision to the states. Many states quickly implemented bans or restrictions on abortion. There were those that had trigger laws in place that immediately implemented bans upon the overturn of Roe, there were those states that required some action by state officials, a couple of states that

implemented laws effective thirty (30) days after Dobbs, some states included abortion restrictions and the states that had a hybrid implementation of bans and restrictions. Both Alabama and Georgia have implemented bans; Georgia also has restrictions as does Alabama to a lesser degree. Georgia's restrictions are no abortions after cardiac activity has been detected (at about six weeks gestation) with some exceptions. The exceptions include law enforcement documented rape or incest, the health of the mother where death or serious health consequences can occur or certain fetal abnormalities have been detected. Alabama's law is closer to a near ban with the only exceptions being rape, incest or serious health consequences to the pregnant woman if the pregnancy continues.

Adrianna Smith was a pregnant, thirty-one year old nurse in Georgia and has a seven year old son. In February, she began experiencing horrible headaches and went to the hospital. It sounds as if her testing was not very extensive and I would guess the physician weighed certain imaging studies with the radiation safety ALARA (As Low As Reasonable Achievable) principle wherein it is the duty of medical personnel to keep the radiation exposure as low as possible. Because she was nine weeks into her pregnancy at the time, one certainly wants any radiation exposure to be as low as possible so as to not contribute to any potential fetal abnormalities. She was given some medication and sent home. The next day she woke having difficulty breathing and making a gurgling noise.

She was again taken to the hospital and this time had a CT of her brain which revealed blood clots within her brain. At some point she was declared brain dead but in keeping with Georgia law it was determined that she should be placed on a ventilator and other life supporting measures. The goal was to reach thirty-two (32) weeks gestation and to perform a C-section. Ms. Smith's mother has recounted her agony in watching her daughter on such machine to keep her alive with the plan to deliver a viable child. On 13 June her young son delivered. He weighed 1 pound and 13 ounces and was named Chance. Chance is certainly an interesting name for this little boy.

I am pro life and I have read some of the pro and con rationale from a medical ethics web site regarding the late Ms. Smith. The late Pastor Harry Reeder at Briarwood Presbyterian Church in Birmingham often talked about a culture of life and a culture of death. The culture of death, which is not in line with a Christian world and life view is one where a preborn child's life is terminated by abortion because it is unwanted or inconvenient. Certainly this stand is espoused by many organizations such as Planned Parenthood. On the tail end of life there are those that find older adults or adults with certain disabilities as inconvenient or unwanted and one is concerned that the lives of older adults may one day become a life that can be prematurely terminated.

Baby Chance Smith, did not ask to come to this world. Ms. Smith's family celebrated her 31st birthday during her pregnancy but also railed against the Georgia abortion law. Killing baby

Chance via abortion would not have saved Ms.

Smith. Yes it seems hard to wrap your brain around having a brain dead Ms. Smith as an incubator to deliver Chance at a point in the future. The writer of the so called medical ethics article that I read was not kind to giving baby, Chance, a "chance" at life. The writer wonders what decision Ms. Smith would have made and felt that the family should have been allowed to make the decision on possibly terminating Chance's potential viability early on. It is believed that baby Chance may have disabilities which may not be evident for some time; it is reported that he is holding his own.

Alabama's Natural Death Act includes an Advance Directive for Health Care. The Advance Directive for Health Care allows an adult to make decisions about the end of their life should it come down to it. Those decisions would come into play if by a terminal illness or injury or permanent unconsciousness and in the event that individual would likely die in the near future they can make "Living Will" type decisions about artificially provided food and hydration as well as life sustaining treatment. The document also allows an individual to name a health care proxy if they like which can be used to make decisions beyond the black and white scope of the document.

Near the end of the document it says three things. One is that if a physician or hospital will not honor the document then the institution must see that the person is cared for a physician or hospital that will honor the document. The document is not a Dr. Kevorkian type assisted suicide document; it is one that allows for the (un)natural process of dying. Another statement is that if it is a pregnant female then the wishes of the Advance Directive will not be honored until after the birth of the child.

Baby Chance did not ask to be conceived. God planned it and has a plan of some sort for baby Chance. Prayerfully, baby Chance will have no constraining abnormalities. Hopefully Chance will understand that in death, Adrienne Smith gave him life and I pray that Chance will honor his mother and be a child of God that bears witness to the Christian world and life view and a culture of life.



#### The Chronic Need for Small Trucks

Have you ever wondered why you seldom see any small pickup trucks in recent years? And the few you do see are older ones—1980's and earlier. Why don't automakers make and sell any new ones? Today, we see huge hulking gas-guzzling behemoths with big 4-door cabs and often puny 4 to 5 foot beds that won't haul very much. They are utterly impractical for most farmers, contractors, handymen, and anybody else who needs an inexpensive utilitarian truck to carry stuff around.


From 2020 through 2026, the minimum mpg allowed for the smallest trucks has jumped from a difficult 41 mpg up to an essentially impossible 54 mpg. We won't be getting any new ICE vehicles with that much economy when we figure in other mandates that keep adding more weight. The limits on the smallest trucks have become so extreme that manufacturers are unable to make them comply. The end result is that everybody is obligated to buy and drive larger cars and trucks that consume more fuel with more lenient

and reducing emissions. Can you scream "HYPOCRISY?

limits—precisely the opposite of the "pie in the sky" goal of consuming less fuel

What should our government do? The solution is ridiculously simple. REPEAL this stupid mandate and let a free market determine the optimum fuel efficiency. You can bet your bottom dollar that efficiencies will increase to their practical limits and consumption and emissions will minimize.



The final coup de grace against small trucks comes from our government "Safety Nazis" who impose additional extreme limits onto small vehicles. Besides paying a tariff, we Americans have essentially been slapped with an outright BAN. We can't import small trucks, and we can't even build and use our own.

The EPA and safety bans are still standing strong. If I had been President Trump, on the day of my inauguration, I would have issued an executive order to REPEAL all government mandates that restrict the manufacture, importation, sale, and use of these essential vehicles. This should be a top priority for the DOGE right now.

However, we do have a silver lining in our dark cloud of punitive overregulation. If we had ELECTRIC small trucks that were simple and inexpensive, we could kill the emission mandate, since emissions are zero from electric vehicles. Overall fuel consumption would also diminish by about two thirds. Safety mandates like flimsy crumple zones could be replaced by sturdy bumpers (that can actually take a bump when needed) equipped with cameras and radar that can apply braking and warning sounds whenever a careless driver or pedestrian should run in front of it. But American auto makers are not making small inexpensive electric trucks either. All of them are only building big, expensive ones—including Tesla. If Elon had been REALLY smart, he would NOT have started out with the huge, complicated, expensive, over-frilled, trouble-prone Cybertruck. Instead, he would have followed Ford, Volkswagen, and Toyota with a small, basic, simple, inexpensive, minimalist electric truck that would be quick and easy to manufacture in large quantities and that large masses of people could afford (See my October, 2024 article for my suggestion for Tesla). Elon and all others must focus less on the classes and more onto the masses.

Simplicity and durability would be paramount—optional A/C, mechanical locks and hand crank windows—similar to the Model T, Beetle, HiLux Champ, and IMV Zero. The chronic demand from the American people would sell millions. The huge volumes would quickly generate profits of millions of dollars for all automakers.

And yes, we MUST get government out of the way to make it happen.

Today we have an even bigger threat against small trucks—the Corporate Average Fuel Economy (CAFE) mandate—first imposed in 1975, two years after the infamous 1973 OPEC oil embargo. Its goal was to reduce fuel consumption, enhance energy security, and reduce toxic emissions. It imposes minimum miles per gallon for all vehicles based on their "footprints" (The number of square feet the vehicle occupies). The most extreme part of this regulation means smaller vehicles must meet greater efficiencies than larger ones. And finally, every year, the limits become more and more extreme.

#### Misunderstanding the Road to Independence

Before the Declaration of Independence, there was the Olive Branch Petition.

Written 250 years ago today, the Olive Branch Petition was Thomas Jefferson's first attempt to explain to King George III why the American Colonies were rebelling and ask for reconciliation.

The "Shot heard 'round the world" had been fired almost three months earlier, and the Battle of Bunker Hill had just ended. It was readily apparent to the Second Continental Congress that the situation was spinning out of control.

In a last-ditch effort to stave off a rebellion and attempt a peaceful settlement, John Hancock authorized the drafting of a document to explain the colonies' position, acknowledge their loyalty to the King, and propose a solution to the conflict.

The "revolution" was premised on a misunderstanding. Few, if any, of the colonists appreciated the growth of Parliament's authority at the expense of the King's. The colonists had little experience in dealing with Parliament as their main connection to the Mother Country was through the King.

In fact, most of the colonies had been established through royal charters issued by various monarchs going back to King James I. The basis for colonial government and the ownership of land was from the decree of the sovereign with neither the advice nor consent of Parliament.

The King's crown, seal, and coat of arms were symbols of colonial authority; Parliament was nowhere to be seen. The colonies were administered through the Royal Governor, which colonial law recognized as the King's representative. In fact, colonial governors acted as the executive of each colony with authority to appoint judges and sheriffs and administer British law in the name of the King. They could also call colonial legislatures into session, dissolve legislatures, and veto legislation deemed offensive to the King.

Everything the colonists knew about their government was that the King's representative controlled most of the governing of their political subdivision, and the actions of the Royal Governor were generally respected as if the King himself was in residence.

What the colonists could not appreciate was the emerging British constitutional government caused Parliament to become more powerful while the King's authority gradually eroded. Most critical in this tug of war for authority was the power of the purse. The King and Parliament routinely argued over taxing and spending with Parliament eventually gaining the upper hand.

But during this time, while the role and responsibility of the King and Parliament were being established, the colonies were in the midst of creating their own unique political system. Initially, the colonies grew and developed with little, if any, input from the King. The customs as British subjects were transferred in a seamless manner, almost by osmosis, that accepted a local structure of self-government that was limited and almost invisible. The law and accompanying political organization were accepted by the colonies because they were familiar; but most importantly, they worked.

No one would have considered Parliament to have any role in the administration of the colonies, but after the various European wars devolved into proxy wars in the colonies, Britain had to act to secure the economic engine of its colonial outposts. Protecting the colonies from foreign invasion and control was done in the self-interest of maintaining the lucrative trading system between the colonies and Britain.

Always looking for new revenue to fund both the Crown and Parliament, the colonies became an untapped revenue stream. Under the excuse that the cost of protecting the colonies from foreign invasion should be paid for by the direct beneficiaries (the colonies), Parliament acted.



Beginning in 1764, Parliament sought to impose various taxes on the colonies. The King benefited from these taxes as a portion of the generated revenue directly funded his royal court, but the numerous acts imposing taxes were not issued in the name of the sovereign, but in the name of Parliament.

The colonists assumed that it was Parliament, not the King, that was causing them harm. They reasoned that a good working relationship with the Crown had been maintained for more than 150 years. Most colonists revered the King and prayed for him as part of their Sunday worship, so if anything bad was happening, surely the parliamentarians must be the bad actors.

So, with each tax, the colonists became more vexed and sought to avoid new levies in many ways; some benign, like smuggling or boycotting to avoid payment, or direct action, like the destruction of property to illustrate displeasure. But in all these aggressions against parliamentary acts, the colonists reasoned that if King George could understand the situation and reign in Parliament, then the colonial relationship could be restored. The colonists failed to appreciate the King's complicity in the imposition of the various taxes.

When the relationship between the colonies further deteriorated and red coats were ordered to disarm colonial militias, the war of words turned into a hot war with the loss of life and destruction of property.

Lexington, Concord, and Bunker Hill were more than simple police actions they were serious military conflicts with significant casualties. With the conflict escalating, the Continental Congress tried one last step and appealed to the King with the Olive Branch Petition, which almost begged for a restoration of their former relationship.

Thomas Jefferson's initial draft of the petition was too strident and bellicose, so with input from other founding fathers, John Dickinson would tone it down, and his revision was sent to the King after being approved by Congress.

King George never read the conciliatory document and instead responded by issuing his own Proclamation of Rebellion authorizing force to restrain the rebellion and hang the leaders.

The Olive Branch Petition was an attempt to avoid bloodshed and restore an amicable relationship between the crown and colonies, but in rejecting the petition, the King, to his eventual detriment, turned loyalists into rebels.

One year later, Jefferson's Declaration of Independence would set an inevitable course; Washington's victory at Yorktown would conclude the matter.

#### The New York Draft Riots

The June 2025 Los Angeles riots have initiated including military uniform supplier constitutional questions about State vs. Federal authority. Per Article IV, Section 4 of the U.S. Constitution, it is up to the Governor or legislature of a State to request federal assistance; otherwise, the federal government generally has no authority to interfere with State affairs. Furthermore, the 1878 Posse Comitatus Act prohibits the use of the military in domestic law enforcement. A catalyst for this act was

to avoid a repeat of the military occupation and post-war martial law imposed on the South after the denial of Southern Independence. Protecting "federal" facilities is a separate issue. Another incident in history trumps (no pun intended) the present situation – the New York Draft Riots.

The Lincoln Administration sought to meld together numerous disparate Northern factions. Despite sometimes intense Northern animosity against Irish ("No Irish need apply.") and German immigrants (especially Catholics), the need for "fresh bodies for the military," served to lessen this bigotry. Even the anti-Catholic Know Nothings accepted them. Many of the Germans, who settled heavily in the Midwest, were Forty-Eighters, and a significant number supported socialism and communism. Indeed, some were Union officers and were literally friends with Karl Marx. They combined with the pro-protectionist manufacturers and New England intellectuals to form some of Lincoln's most loyal supporters.

Throughout history, the Irish have been used as "cannon fodder." (Some insist they were also traded as slaves.) The Enrollment Act of 1863 was another chapter in this historical legacy. All male citizens between ages 20-45 were mandated to enroll, including males seeking citizenship. Wealthy Northerners could either fight or pay a \$300.00 exemption from the draft. The Irish, mostly coming from meager circumstances, typically lacked the funds to buy exemptions. Whereas large numbers of wealthy Southerners fought, few wealthy Northerners did. William Tecumseh Sherman alluded to this, stating, "that without conscription there would have been no way to 'separate the sheep from the goats and demonstrate what citizens will fight and what will only talk." Furthermore, Blacks were not considered citizens and were exempt from the draft, making them even greater targets for Northern anti-war factions. The draft reflected Northerners who "physically" supported the war; John Chodes, the New York playwright and historian, noted that about four times more men were drafted from New York than Massachusetts.

In July 1863, many Irish and German immigrants in New York City violently protested the implementation of the first Federal military draft, realizing they would be primary targets to fight in a war that had little relevance to them. The first day (Saturday, July 11) started as organized resistance and was relatively incident free; however, when the names of those conscripted began to spread, the anger intensified. By Monday, protests became violent with destruction of property, including the draft equipment used by the locals. Attacks were made on Horace Greeley's New York Tribune office. Even the Colored Orphan Asylum was attacked—the children were safely removed but toys, clothing, and supplies were destroyed, and the building was set on fire.

The rampage continued on Tuesday with looting and the destruction of businesses,

Brooks Brothers. Mob attacks became more intense--at least two Blacks were lynched. Wednesday, at least four more Blacks were killed. Over a five-day period, New York City was disrupted by the destruction of property—both public and private, factory closings, violence against law enforcement, and brutal violence against Blacks. "The long



term damage to New York's black population was significant: In the aftermath of the riots, the city's black population plummeted by more than 20 percent, to below 10,000 (the lowest number since the 1820s), as blacks fled the city in droves."

Prior to the Draft Riots, racial tension had been fueled by the issuance of the Emancipation Proclamation, which Lincoln described as a "war measure" in his attempt to change the reason for war. Not only did thousands of Union soldiers desert after its issuance, there was a strong fear that more Blacks would move to New York and compete for jobs. By the end of the draft riots, over 100 civilians had been killed and at least eleven Blacks had been lynched. The New York Times reported: "No period in the history of this city will be more memorable than the riot week. It will not be forgotten by this generation, and the stories of it will be transmitted to the generation that follows us."

The story of the New York Draft Riots is often treated as a footnote in history. Nonetheless, the riots were extremely violent and deadly. Lasting almost a week, the riots were finally suppressed by the appearance of several thousand troops, including New York State Militia and Union troops from New York, Michigan, and Indiana.

#### PANAMA CANAL: TIME FOR TEDDY ROOSEVELT'S BIG STICK?

South Dakota's Mt. Rushmore exhibits the faces of four presidents immortalized in stone: George Washington, Thomas Jefferson, Abraham Lincoln, and Theodore Roosevelt (TR).

As the story goes, one morning in 1979 Washington noticed that Roosevelt was missing from the monument. When asked, Jefferson said simply, "All I know is, he muttered something about it being HIS canal, and he picked up a big stick and started walking south,"

TR described his foreign policy as "speak softly and carry a big stick." And who could blame TR for being upset? The Panama Canal was one of his greatest achievements, doing much to advance commerce between the Atlantic and the Pacific, shortening voyages from New York to California by about 8,000 nautical miles.

A marvel of engineering, the lock chambers operate to raise ships about 85 feet and then lower them to sea level at the other end. In 2024, 11,240 vessels traversed the canal, carrying more than 213,000,000 metric tons of cargo. The canal's economic importance for world commerce and its strategic value for military transport cannot be overstated. As early as the 1500s, Spaniards recognized that a canal across the isthmus of Panama would save a lengthy voyage south around South America's Cape Horn, the search for a northwest passage proving elusive. French efforts to construct a canal collapsed, so the United States stepped up to the plate. In 1902, under Roosevelt's leadership, Congress passed the Spooner Act which authorized purchasing the French assets and negotiating a treaty with Colombia (of which Panama was then a part). Negotiations with Colombia broke down, but in 1903, Panama declared independence from Colombia. Some claim the United States orchestrated Panamanian independence; however, tensions existed between Panama and the Colombian government since the 1800s, including a short-lived independent State of the Isthmus (1840-1841) and a Panamanian rebellion in 1885. The Hay—Bunau—Varilla Treaty was negotiated between Panama and the United States, creating the 10-mile-wide Panama Canal Zone over which the United States was given authority to act as "if it were the sovereign."

The United States governed the Canal Zone from 1914 to the 1970s, at which time the late President Jimmy Carter proposed giving the canal to Panama. Ronald Reagan strongly opposed the giveaway, saying we were giving the canal to a dictator (Omar Torrijos) "who's there, not because he had the most votes, but because he had the most guns," and that the world would see this transfer "as once again America backing away and retreating in the face of trouble." Reagan declared, "We bought it, we paid for it, we built it, and we intend to keep it," and polls showed a huge majority of Americans agreed with him.

Nevertheless, Carter managed to pressure the Senate to ratify (by one vote) a treaty

transferring control to Panama. Although of questionable constitutionality - because Article IV, Sec. 3, Clause 2 gives Congress exclusive authority over territories of the United States - this treaty recognized Panamanian sovereignty over the Canal Zone effective 1979 but authorized the United States to continue operating the canal through

President Donald Trump says it is now time for the United States to regain control over the canal. He notes that Hutchison Ports, a company based in the Chinese territory of Hong Kong, manages two ports on the canal – Balboa on the Pacific and Cristobal on the Atlantic. America's chief adversary now has effective control over the Panama Canal! "If these companies control both ends of that canal in a time of conflict, and the Chinese tell them, 'Shut it down and don't let the U.S. go through there,' we've got a big, big problem," Secretary of State Marco Rubio explained. A 2021 study by the Center for Strategic & International Studies warned that Chinese control over the canal is much more extensive than had been previously supposed. The 1978 prediction of U.S. Sen. Strom Thurmond (R-S.C.) may be coming true: "The loss of this canal would contribute to the encirclement of the United States."

Clearly, giving away the canal in 1979 was a bad mistake and a sign of weakness. But what can we do about it now?

Consider this: At the time he gave the canal away, Carter also signed a Neutrality Treaty with Panama, which guaranteed the canal's permanent neutrality and authorized the United States to use military force, if necessary, to keep it open.

So here is the answer: The United States is authorized to use military force to keep the Panama Canal open. This, I would argue, includes not only the right to act to prevent China from suddenly shutting down the canal but also the right to take preemptive force to prevent that from happening.

But sometimes Trump's opening salvo is just a first step toward getting what he really wants. Perhaps his intent is not to send troops to Panama but rather to gain concessions that will give the United States firm assurance that a Chinese coup in Panama isn't going to happen. A few possibilities could include increased U.S. military presence or increased U.S. infrastructure investment.

Keep watching. And Teddy, don't put down your big stick.



Few presidents showed more courage and sagacity than Buchanan trying to allow the peaceful transfer of central/federal power to a new coalition of States without bloodshed. After South Carolina seceded Buchanan asserted:

"Apart from the execution of the laws, so far as this may be practicable, the Executive has no authority to decide what shall be the relations between the Federal Government and South Carolina. He has been invested with no such discretion. He possesses no power to change the relations heretofore existing between them, much less to acknowledge the independence of that State. This would be to invest a mere executive officer with the power of recognizing the dissolution of the confederacy among our thirty-three sovereign States."

President Buchanan understood an integral part of guaranteeing republican forms of government within a sovereign State is the right of the people in each State to independently determine their desire to remain in any coalition/confederacy of States. No Legislature or Governor (of a State like South Carolina, seceded from the USA/changed to the CSA or from a State like Maryland, still in the USA) asked for federal troops to address civil unrest or insurrection within their State when considering the Force Bill. Not getting the February 1861 Force Bill from Congress after President Buchanan makes it clear he will not commit Article 3, Section 3 treason pressed Mr. Lincoln and the Republicans' orchestration of military action before Congress reconvenes to accomplish their desired transfer of wealth and power.

President Buchanan adhered to the letter, Spirit and pre-Lincoln tradition of the Constitution, unwilling to fail his oath of office and step outside his authorization at perhaps the most difficult time since the Nullification Crisis. He understood there are no enumerated powers for the executive to act unilaterally, esp. in this manner not authorized. This is well reasoned by Buchanan in his following words:

"The question fairly stated is, has the Constitution delegated to Congress the power to coerce a State into submission which is attempting to withdraw or has actually withdrawn from the Confederacy? ... After much serious reflection I have arrived at the conclusion that no such power has been delegated to Congress or to any other department of the Federal Government, It is manifest upon an inspection of the Constitution that this is not among the specific and enumerated powers granted to Congress, and it is equally apparent that its exercise is not 'necessary and proper for carrying into execution' any one of these powers."

## **Rogers Applauds Agreement to Raise NATO Spending Commitments to Five Percent of GDP**



**Congressman Mike Rogers 3rd Congressional District** 

June 25, 2025 -WASHINGTON, D.C. -**Today, House Armed Services Committee Chairman Mike** Rogers (R-AL03) praised NATO's decision to set a new increase in defense spending to 5% of gross domestic product (GDP) spending by 2035.

"NATO's decision to raise its defense spending commitment to 5% of GDP is a vital response to the growing threat posed by Vladimir Putin and the deepening cooperation among Russia, China, Iran, and North Korea," said Chairman Rogers. "Front-line allies like Poland and the Baltic

states were already pulling their weight, and now the long-overdue investments pledged by other European and Canadian allies will strengthen the Alliance significantly. President Trump was right to insist that our Allies shoulder a greater share of our collective defense—and his leadership was critical to making it happen. Ultimately, a more lethal NATO, backed by continued U.S. leadership and real burden sharing, will deter our adversaries, preserve peace, and advance America's national interest."

The landmark decision that reshapes the future of transatlantic security, NATO member states have agreed to raise their defense spending target to five percent of gross domestic product (GDP) by 2035, more than doubling the previous benchmark of 2%. The move



comes amid rising global tensions and sustained pressure from U.S. President Donald J. Trump (R), who has long been critical of America's European allies for underinvesting in collective defense.

The agreement was announced at the NATO summit in The Hague, where leaders from all 32 member nations signed a joint declaration reaffirming their "ironclad commitment to collective defense" under Article 5 of the NATO treaty.

A New Standard for Defense

Under the new framework, member states will be required to allocate:

- 3.5% of GDP to core military spending, including personnel, equipment, and operations.
- 1.5% of GDP to defense-related infrastructure and resilience measures, such as cybersecurity, energy security, and civil preparedness.

Each country must submit annual plans outlining a credible path to reach the 5% target by 2035. The alliance will conduct a formal review in 2029 to assess progress and adjust for evolving threats.

Trump's Influence and Strategic Calculus

President Trump hailed the agreement as a personal victory.

"I've been asking them to go up to 5% for a number of years, and they're going up to 5%," President Trump told reporters. "From 2%, and a lot of people didn't even pay the 2%. So I think that's going to be very big news".

During Trump's first presidency his demands were met with skepticism from European leaders and critics of the President alike. Since then Russia has invaded Ukraine exposing that Europeans don't have the men or material to fight a lengthy ground, air, and naval war like what Ukraine (who is not a NATO member) is experiencing. That as well as concerns about instability in the Middle East as week as concerns over China's global ambitions have convinced European leaders that they need larger and more modern armies, navies, and air forces.

NATO Secretary General Mark Rutte called the agreement a "quantum leap in our collective defense".

Spain's leftwing socialist government has publicly stated it will not meet the 5% target. Belgium and Slovakia have also expressed reservations, though they did sign the declaration.

French President Emmanuel Macron voiced concern over the financial burden, especially in light of U.S. trade tariffs.

The spending hikes will mean hundreds of billions of dollars in new defense spending for Canada and Europe over the next decade. Analysts say it will bolster deterrence against Russia, modernize aging military infrastructure, and expand NATO's capabilities in cyber and space domains.

Woods told the Tuscaloosa News, "I look forward to being a conservative voice for all of District 5. We've got a lot of good things happening in Alabama and I'm going to work hard to ensure we remain a conservative, pro-growth, and pro-freedom state".

Alabama Republican Party Communications Director Jeannie Burniston released the following statement:

"Congratulations to Senator-elect Matt Woods on tonight's victory. During his time in the House of Representatives, Matt has been a consistent fighter for conservative values and protecting Alabama families. From championing the REACH Act, which gives adults another pathway to earn a high school diploma, to passing the Alabama Child Protection Act, which criminalizes the use of AI to generate child pornography-Matt Woods has proven he's serious about getting results. We're excited to see his continued leadership and impact in the Alabama Senate."

SD5 includes Fayette, Lamar, and Walker Counties, as well as portions of Jefferson and Tuscaloosa Counties.

This seat became vacant earlier this year when former Senate President Pro Tempore Greg Reed (R-Jasper) resigned to join Governor Kay Ivey's (R) cabinet as Secretary of Workforce. Reed is tasked with overseeing the transition of the Alabama Department of Labor into the Department of Workforce.

Rep. Matt Woods' election to the Senate means that his House seat now becomes vacant. Gov. Ivey will set the dates for qualifying for the special election to fill the vacancy in HD13.

The crushing win demonstrates both the personal popularity of Woods and the strong preference for the Republican Party in SD5.

#### **Governor Ivey Announces \$23.2 Million in SEEDS Grants to Boost Alabama's Economic Growth**

June 24, 2025 – MONTGOMERY, AL – Governor Kay Ivey on Tuesday announced that applications for the third round of Alabama's Site Evaluation and Economic Development Strategy (SEEDS) grant program will open on July 1, 2025, with a total of \$23.2 million available to support site assessment and development efforts across Alabama.

The SEEDS program, administered by the Alabama Department of Commerce in partnership with the Economic Development Partnership of Alabama (EDPA), is designed to strengthen the state's portfolio of industrial sites, enhancing Alabama's competitiveness for high-impact economic development projects.

Once the application window opens, communities can apply for SEEDS funding via a portal on the EDPA website until the deadline of September 30, 2025.

The first two rounds of SEEDS funding supported a total of 56 sites statewide, helping local communities and economic development organizations advance critical site readiness efforts.

"Alabama continues to be a leader in economic development, and a key factor in that success is ensuring we have development-ready sites available," said Governor Ivey. "The SEEDS program is a smart, strategic investment in our future — and I look forward to seeing even more communities benefit from this next round of funding."

In the third round of funding, SEEDS will provide support for both site assessment grants to evaluate the potential of new or underutilized sites and site development grants to fund targeted improvements that increase a site's readiness for industrial projects.

"We've seen firsthand how SEEDS funding can transform promising properties into serious contenders for job-creating projects," said Commerce Secretary Ellen McNair. "This next round of funding will allow us to build on that momentum and continue preparing Alabama's communities for long-term

EDPA plays a key role in administering the SEEDS program and ensuring that investments align with the state's broader economic development strategy.

"We are proud to partner with Governor Ivey and the Alabama Department of Commerce to help communities unlock the full potential of their industrial sites," said EDPA President Miller Girvin. "SEEDS is making a real difference on the ground, and we're excited to work with local leaders to make Round Three another success."

#### ICE Conducts Raids Across Alabama



June 24, 2025 — There have been a series of immigration enforcement actions by U.S. Immigration and Customs Enforcement (ICE) across Alabama

U.S. Senator Katie Britt (R-Alabama) said on social media, "The Biden Administration knowingly released Iranian illegal aliens into the interior of our country for four years. Open border policies don't just threaten our communities, they put our national security at risk. Grateful @POTUS continues to

secure our border and our nation."

ICE has arrested 11 Iranian nationals across eight states, because they pose a potential security threat. One of those was arrested on Tuesday in Locust Fork in Blount County. He reportedly was still carrying his Islamic Republic of Iran Army identification card in his possession.

FOX10 News is reporting that federal agents have conducted an illegal immigration raid at the new Gulf Shores High School construction site on the Foley Beach expressway. The FBI confirms that 37 suspected illegal immigrants have been taken into federal custody.

The Birmingham Times, the detentions occurred at the Intensive Supervision Appearance Program (ISAP) office in Birmingham's Southside, where undocumented immigrants regularly report as part of an alternative-todetention program. Multiple individuals were taken into custody during these



The man arrested in Locust Fork, Alabama on June 22, 2025, was identified as Ribvar Karimi, a former Iranian Army sniper who served from 2018 to 2021. According to U.S. Immigration and Customs Enforcement (ICE), Karimi entered the United States legally in October 2024 on a K-1 visa, which is issued to foreign nationals engaged to be married to American citizens.

Karimi married his American fiancée, Morgan Gardner, in January 2025, but failed to adjust his immigration status as required by law. He is currently being held in ICE custody pending removal proceedings. His wife, who is seven months pregnant, has publicly defended him, stating that he is a proud immigrant who "loves America" and had no malicious intent.

Federal officials have not publicly linked Karimi to any specific terrorist activity, but the Department of Homeland Security has emphasized a renewed focus on

identifying and removing individuals with potential ties to hostile foreign governments.

In Gulf Shores the FBI, in coordination with Gulf Shores Police, Orange Beach Police, and the Baldwin County Sheriff's Office, detained 37 individuals during the raid. The operation was described as a federal immigration inspection, and those arrested were transported to a federal facility for processing.

The City of Gulf Shores and Gulf Shores City Schools issued a joint statement clarifying that the construction site is under the control of a private general contractor, distancing themselves from the enforcement action.

ICE confirmed the arrests in Birmingham, stating that those detained had final orders of removal issued by immigration judges and had failed to comply.

"If you are in the country illegally and a judge has ordered you to be removed, that is precisely what will happen," ICE said in a statement. The agency emphasized that the ISAP program is designed to ensure compliance with immigration court rulings and that enforcement actions are now being carried out under stricter guidelines reinstated by the Trump administration.

Senator Tommy Tuberville (R-Alabama) acknowledged the operations, saying they are not limited to Birmingham but are occurring across the state. "If you're here undocumented, you do need to check in at your local office. If you don't, you're breaking the law by not showing up," Tuberville said.

The raids have drawn sharp criticism from immigrant advocacy groups.

Lisa Moyer of Bham Migra Watch told reporters the detentions "a betrayal of trust," noting that those detained were already participating in supervised release programs.

Allison Hamilton is with the Alabama Coalition for Immigrant Justice.

Hamilton said, "The message is very clear that immigrants are not welcome or wanted in this country".

The raids come amid a broader national crackdown on undocumented immigration. Over the weekend

ICE has recently conducted high-profile enforcement actions at construction sites in other parts of the country—including Tallahassee, Florida, where over 100 undocumented workers were detained in late May 2025. These operations are part of a broader federal initiative targeting unauthorized employment in the construction industry, particularly under the renewed immigration enforcement priorities

The U.S. Immigration and Customs Enforcement agency—ICE—was created in 2003 when the Department of Homeland Security (DHS) was created after the 9/11 terrorist attacks. It combined the old Immigration and Naturalization Service (INS) with borders and customs enforcement into one agency.



#### Senior Master Sergeant Jeremiah Daniel Bybee: Age 43





Senior Master Sergeant Jeremiah Daniel Bybee served 23 years in the U.S. Air Force. His Air Force Service Code included: (1) Aircraft Armament Systems Craftsman and (2) First Sergeant in which he supplied his commander with a mission ready force. He received the following medals, badges, citations, and campaign ribbons: Meritorious Service Medal with one Oak Leaf Cluster, Air and Space Commendation Medal with two Oak Leaf Clusters, Air and Space Achievement Medal with one Oak Leaf Cluster, Meritorious Achievement Medal with one Oak Leaf Cluster, Meritorious Unit Award one Oak Leaf Cluster, Air and Space Outstanding Unit Award with one

Oak Leaf Cluster, Air Force Good Conduct Medal with six Oak Leaf Clusters, National Defense Service Medal, Armed Forces Expeditionary Medal, Afghanistan Campaign Medal, Global War on Terrorism Expeditionary Medal, Global War on Terrorism Service Medal, Korean Defense Service Medal, Armed Forces Service Medal with one Service Star, Humanitarian Service Medal, Military Outstanding Volunteer Service Medal, Nuclear Deterrence Operations Service Medal with one "N" Device and one Oak Leaf Cluster, Air and Space Overseas Service Ribbon Short, Air and Space Overseas Ribbon Long with two Oak Leaf Clusters, Air and Space Expeditionary Service Ribbon with Gold Border, Air and Space Longevity Service Award with four Oak Leaf Clusters, USAF NCO PME Graduate Ribbon with one Oak Leaf Cluster, Small Arms Marksmanship Ribbon with one Service Star, Air and Space Training Ribbon, Air Force Basic Training Ribbon and NATO ISAF Medal.

SMSgt Bybee was born October 11, 1981 to his parents, Eric and Carolyn Bybee, in Great Falls, Montana. Both of his parents served in the Air Force with his father serving 10 years on active duty and his mother serving three years on active duty and four years on Reserve duty. He is the third generation of his family who has served in the U.S. Air Force. Because of his parents' service in the Air Force, the family often moved to various assignments during his childhood, and even after his family returned to civilian life, his family moved often. Finally, the family settled in Jonesboro, GA, where he reached the rank of Life Scout in Boy Scouts and participated in drama, swimming and literary competitions at Mount Zion High School graduating in 2000.

SMSgt Bybee's military service began with his volunteering to serve in the U.S. Air Force beginning October 10, 2000. He completed six weeks of Basic Training at Lackland Air Force Base, TX, and he was assigned to work in Aircraft Maintenance. He was sent to Sheppard AFB, TX, for training in maintenance of aircraft weapons systems for 16 weeks. After completion of training, he was given a permanent assignment to the Weapons Section at the 79th Aircraft Maintenance Unit during April 2001-March 2011. He began this type of service at Shaw AFB, South Carolina. While there, he experienced six deployments. During February 2002 to May 2002, he served as a Weapons Load Crew Member with the 379th Air Expeditionary Wing, Prince Sultan Air Base, Saudi Arabia. During August 2004 to March 2005, he served as a Force Protection Specialist with the 469th Air Expeditionary Wing, at Alt AL Salem, Kuwait. During November 2006 to January 2007, he served as the Maintenance Debrief Element Chief with the 379th Expeditionary Fighter Squadron, at Al Dahlfra, United Arab Emirates. During November 2007 to April 2008, he served

as the Weapons Load Crew Team Chief with the 379th Expeditionary Aircraft Maintenance Unit at Kunsan Air Base, Republic of Korea, and during August 2009 to March 2010, he served with the 455th Air Expeditionary Wing at Bagram Air Base in Afghanistan.

SMSgt Bybee then had three permanent changes of assignment, followed by one deployment and one more permanent change of assignment before retirement. During March 2011 to March 2013, he served as weapons expediter in aircraft maintenance at Kusan Air Base, Korea. During March 2012 to March 2015, he served as Load Monitor Element Noncommissioned Officer in Charge as nuclear surety specialist with the 703d Munitions Support Squadron at Volkel Air Base, the Netherlands. During March 2015 to February 2019, he served a permanent assignment as the Weapons Section Chief 31st Aircraft Maintenance Squadron in Aviano Air Base, Italy. During August 2016 to February 2017, he deployed to Camp Lemonnier, Djibouti, Africa as the Senior Enlisted Leader, 510th Expeditionary Fighter Squadron. He then served with the 100th Air Refueling Wing, Royal Air Force Mildenhall, United Kingdom during February 2019 to October 2019 serving as First Sergeant. He then served as a member of the 488th Intel Support Squadron out of Offutt Air Force Base, NE, during October 2019 to May 2020 as a First Sergeant located in England. Next, he served at Royal Air Force Mildenhall, United Kingdom during May 2020 to July 2021 serving as First Sergeant, and his last assignment was at Maxwell Air Force Base, AL, as First Sergeant Academy Instructor during July 2021 to Oct 1 2023. SMSgt Bybee retired from military service October 1, 2023.

SMSgt Bybee used the Air Force Tuition Assistance Program and received a Bachelor of Arts Degree in Military History from the American Military University of West Virginia in 2017. He is currently enrolled in the Veterans Readiness and Employment Program, a program for disabled veterans to go to school to be trained for a job to get back into the work force. Since 2023, he has been the Chief Operations Officer for GameDay for Heroes, an organization that hosts events for veterans such as the Mike McKeen Veterans Memorial Golf Tournament and Birmingham Bowl Veterans Experience. The goal of GameDay for Heroes is to "make veterans better civilians." He is a member of the American Legion Post 2019. He is also a volunteer with Troop Eight of the Boy Scouts of America serving as Committee Chair. SMSgt Bybee and his wife, Christi, have been married 23 years, and they have three sons.

SMSgt Bybee's conclusions about what serving in the U.S. Air Force has meant to him are: "Military service was not just a job or a career; it was an amazing opportunity to better myself, my family, and everyone around me all while being able to provide service to my country as a way to say 'thank you' to everyone who came before me." He is not worried about how people will remember him, but he is concerned about people with whom he has interacted. He believes that he should leave things better than he has found them. He doesn't want people to remember him for him, but he wants people to remember the people that he has touched.





#### Chief Master Sergeant Robert E. Dinsmore: Age 55





CMSgt Robert E. Dinsmore served 30 years in the U.S. Air Force. His Air Force Service Code (AFSC) was Bomb Loader, Aerial Gunner-Helicopter and Special Missions Aviator. He received the following medals, decorations, awards, ribbons and citations: Meritorious Service Medal with four oak leaf clusters, Air Medal with three oak leaf clusters, Aerial Achievement Medal with three oak leaf clusters, Air Force Commendation Medal with five oak leaf clusters, Air Force Achievement Medal with three oak leaf clusters, Kosovo Campaign Medal with two service stars, Afghanistan Campaign Medal with two service stars, Iraq Campaign Medal with service star, Military

Outstanding Volunteer Service Medal and NATO Medal for Yugoslavia.

CMSgt Dinsmore was born September 5, 1969 to his parents, John and Eleanor Dinsmore, in Dayton, Ohio, and he was reared there. He graduated from Bethel Local High School in Tipp City, Ohio, in 1988. He volunteered for military service and entered service in

the U.S. Air Force November 10, 1988.

CMSgt Dinsmore's military service began with his completion of six weeks of Basic Military Training at Lackland Air Force Base (AFB). After completion of the Aircraft Armament Systems Specialist Technical Training Course at Lowry AFB, CO, in March 1989, he then began working as an aircraft armament systems specialist and retrained as an MH-53J/M aerial gunner in 1994. He worked as a bomb loader on the F-15, a twin-engine all weather fighter airplane, the F-4 Phantom II, a two-seater twin engine all-weather long-range suppressor jet interceptor and ighter-bomber, and the B-52 Boeing Stratofortress, a longrange sub-sonic jet-powered strategic bomber.

He served at Kadina Air Base, Japan, for two years during April 1989 to April 1991. Then he served at Loring A.F.B., Maine, with the 44th Munitions Maintenance Squadron for one year during April 1991 to June 1992 as a load crew member loading the B-52. He returned for a second deployment to Kadina Air Base, Japan for two years loading the F-15 for two years during June 1992-June 1994.

CMSgt Dinsmore switched from loading bombs to working as an aerial gunner on the Sikorsky MH-53 J/M PAVE Low helicopter, a long-range special operations and combat search and rescue helicopter, with the 20th Special Operations Squadron at the Air Force installation, Herbert Field, FL, for two years during July 1994 to November 1996. This was followed by assignment to RAF Mildenhall, England, for four years during November 1996 to November 2000 with the 21st Special Operations Squadron RAF continuing to work on the MH-53 helicopter as an instructor. After extending his service in the U. S. Air Force, he served at Kirtland AFB, N.M., for four years. First, he worked during November 2000 to September 2003 with the 551st Special Operations Squadron as the MH-53J Evaluator Aerial Gunner. Second, he served there during September 2003 to July 2004 as the MH-53J Aerial Gunner Aircrew Training Device Manager and Instructor Aerial Gunner with the 58th Training Squadron. Third, he served during July 2004 to November 2004 as the HH-60G Instructor Aerial Gunner with the 512th Rescue Squadron. He then served at Nellis A.F.B, NV, during December 2004 to December 2007 working as the Flight Superintendent and HH-60G Evaluator Aerial Gunner on the HH-60G Pave Hawk helicopter, a four-blade, twin engine medium-lift utility military helicopter used in combat rescue operations. He then returned to serve five more years at Kirkland AFB, NM. First, he served during December 2007 to September 2009 as Operations/Squadron Superintendent and HH-60G Evaluator Aerial Gunner with the 512st Rescue Squadron. Second, he served during September 2009 to February 2012 as the Superintendent of Staff and HH-60G Evaluator Aerial Gunner with the 58th Special Operations Wing. Third, he served during February 2012 to March 2013 as the Squadron Superintendent/Chief Enlisted Manager and HH-60G Evaluator Special Missions Aviator. He continued serving as the Chief Enlisted Manager and AC-130W Aerial Gunner the 73rd Special Operations at Cannon A.F.B., N.M. for 18 months during March 2013 to October 2014. His last place of service was at Barksdale AFB, LA, with the Headquarters Air Force Global Strike Command for four years during October 2014 to December 2018 as the AFGSC Career Enlisted Aviator Major-Command Functional Manager on the Bell UH-1 Twin Huey, a twin-engine medium sized helicopter performing Intercontinental Ballistic Missile support and security

missions. CMSgt Dinsmore retired there December 1, 2018.

CMSgt Dinsmore's conclusions about what serving in the U.S. Military means to him are: "Serving in the military definitely gave me a sense of pride of defending our country and a sense of purpose. My jobs in helicopters, special operations, search and rescue and nuclear defense were all critical to someone's life at some point. The feeling that I was doing something that was bigger than myself was amazing. That is why I kept going to work every day and stayed 30 years. My whole life has been spent in service in the military, as a voluntary fire-fighter and an EMT for a while. After I got out of military service, I wanted to continue serving, and that is why I started Operation Combat Bikesaver, now reimagined as ETS (Veteran Education Training & Support). I wanted to give back and to make a difference in someone else's life." He would like people to remember him as caring and as being a provider.

While in the military, CMSgt Dinsmore used the G.I. Bill and received a B.A. Degree in Business Management from Santa Fe College of Art and Design in 2003, and he received a Master's Degree in Public Administration from the University of Oklahoma in 2008. When CMSgt Dinsmore retired from military service, he again used the G.I. Bill and received an Associate Degree in Machine Shop from Central AL Community College in 2022. Since then, he has worked as a machinist at All Phases and Industries, a trusted solution for North American buyers of fabricated, cast and machined metal products, at Mt. Megs, AL.

In 2019. CMSgt Dinsmore started Operation Bikesaver. This then became VETS (Veteran Education, Training & Support, and its mission is to provide support programs for veterans that decrease suicide rates and improve mental health while enhancing their well-being with education and engaged training in the trade arts. Veterans lose something when they leave military service. VETS has created programs to regain some of what the veterans have lost. The focus is on camaraderie, teamwork, friendship and reclaiming that incredible sense of purpose. A hands-on approach is taken by using motors, metals, minds and music to get veterans off of the couch and into a caring environment where they can learn, be involved and take charge of their own lives again. The VETS programs are offered in an alcohol and drug-free space.



The programs include:

- (1) **Shop Day** where veterans work on cars, motorcycles and anything mechanical to repair or customize them into a unique one-of-a-kind vehicle.
- (2) Metal Night focusing on welding, machining and bending metal to create tools, works of art or to repair broken things.
- (3) **Peer Support Group** with a safe veteran-only environment to heal and move forward in life.
- (4) Music Night making and istening to music which is healing so a musical jam session is offered where veterans can hang out, learn to play a chord or two or simply explore music and fun.


Veterans can come and learn how to work on motorcycles without paying anything because funds are provided by donations and grants. When a veteran earns a motorcycle build, he is provided with a \$2000.00 budget which can be used to do anything the veteran wants to a motorcycle or his desired vehicle. Metal Night is on Thursday 6:00-8:00. On Sunday 8:00-5:00, veterans can be involved in maintenance and customization of motorcycles and cars, and a free lunch is served to veterans.

Command Sergeant Major Barbara Anne Meek served 22 years in the U. S. military including active duty in the U.S. Army and duty in the Army Reserve and National Guard. She received the following medals, decorations, citations and ribbons: Army Commendation Medal, National Defense Service Medal, Army Reserve Achievement Medal, Georgia National Guard Distinguished Service Medal and Guard/Reserve Readiness Medal.

CSM Meek was born January 23, 1941 in Prattville, AL, to her parents, Raymond and Ella Mae Meek. Her father served as a Sergeant in the U.S. Army in Europe at the

Battle of the Bulge during WWII. Her brother, Col Donald Meek, served 34 years in the U.S. Army including two combat tours in Vietnam. She was reared in Prattville and graduated from Prattville High School in 1959 and then attended the University of AL for two years. She then was employed with the Center for Disease Control in Atlanta, GA, where she rose through the ranks to a GS-14 the senior civilian grade in Civil Service. She received a BS Degree in Biological Sciences and Secondary Education from Auburn University in 1977.

CSM Meek at age of 31 volunteered for duty in the U.S. Army beginning November 7, 1972 and served on active duty for 1.5 years until she transferred to serve in the Army Reserve in April 1975. The rest of her miliary service was in the National Guard. She began as a basic solider then as a combat medic and on to a clinical specialist. She retired from military service in 1988. CSM Meek retired from employment with the CDC in 1995. At age 55, she served as an EMS paramedic in Dekalb County, Georgia. She then worked with Atlanta's Caldwell Bank as a realtor. Following the September 11, 2001 attack, she volunteered to serve with the Georgia Department of Defense known as the Georgia State Defense Force where she worked with the Training and Doctrine Command. She was promoted to the rank of Command Sergeant Major. Then

the CDC recalled her for employment as a contractor. She retired from this and all employment in 2017. Since employment, CSM Meek has been a member of the American Legion, the VFW and the Catholic church.





balloons floating, all of this red, white, and blue screams the Fourth of July. And next year we will be celebrating the 250th Anniversary of the birth of our nation. So we can start this year and cheer for our

country's birthday for a whole year. In honor of this celebration, I have a pot garden in my backyard with red, white and blue flowers. Several of the pots have bright red geraniums, others with blue salvia, and white vinca. Now that all of these flowers have matured, they are a stunning sight. And they will be the show case for the outdoor July 4th barbecue.

#### PLANT OF THE MONTH--TRUMPET VINE



Campsis radicans, trumpet vine, is also known as trumpet creeper, hummingbird vine, is a species of flowering vines native to Eastern North America. Known as a fast growing climber prized for its profusely red, pink, orange or yellow tubular flowers. It is well suited for zone 8 and is found in zones 5-9. Its popularity is found in its ability to cover trellises, garden gates, fences, and even trees QUICKLY. They are

easy to grow and attract hummingbirds and other pollinators. Another attribute is that they drop their dead heads. In my wanderings through the plants at the Big


With flags flying, festive bunting hanging, and Box stores, I have not run across trumpet vine. However nurseries such as Green Thumb and Little Mountain Growers may be a resource. One caution is that trumpet vines are mildly toxic for humans and animals, so if you are handling the stems or flowers of this vine, wash your hands afterwards.

> I am a big fan of planting trees, shrubs and other flowers that I term in "a sequence of bloom". This technique ensures that there is something blooming in your yard at all times. Now it is not rocket science to keep annuals and perennials blooming in spring and summer and into the fall. But many times, that is it until next spring. I went through my yard recently and wrote down by the month what I have blooming all year.

- 1. December-January.....Camellias and Sasanquas
- 2. February.....Kiss- me- at -the -Gate
- 3. March.....Forsythia, Dogwood, Redbud, Japanese Magnolia
- 4. April.....Spiraea, Cherry Trees
- 5. May......Magnolia grandiflora, Catalpa, roses 6. June.through frost.....Crepe Myrtle, Vitex

And then there are a variety of vines, bulbs, and corms blooming through most of

So, there I was trying to act like I knew what I was talking about at places like Bass Pro Shops and trade shows. Now don't get me wrong, I never lied about my adventures or exaggerated my accomplishments, but I did stand

in a place where real pros stand and have to talk about things that real pros talk about. But I had to do it with surface level knowledge and experience. And without the presence and power of the Holy Spirit, their normal, simple, and even sinful lives would be exposed as having words with no transformational power. So, they waited, and then the Holy Spirit was given. And when the Holy Spirit came, it first showed up in the form of language. Each foreigner there heard the gospel in their own language, from people who otherwise couldn't speak that language. There's no doubt the first command to believers and the first purpose of the Holy Spirit was to give witness. Solitude and silence was and is not an option. I know you feel inadequate. I know your life is not the best example. I know you're not a pro. But you have the Spirit. And the Spirit takes your story and transforms it in the ears of the listeners. Jesus said, "You will be my witnesses." Not His pros. Because there are none.



We are now into the hot summer days of summer so time to ensure your pets safety if they stay outside during the day while you are away. Shade, moving air if possible and plenty of clean, cool water are critical. Ensure your outside pet's water is not only in shade but that there is a LOT of water available to your pet. Plastic children's wading pools can work great as some dogs will also lay in the water to cool off. Inexpensive box fans can greatly help as well with moving shaded air but please make sure your dog(s) cannot chew on the power cord and make sure to routinely clean the fan to reduce any fire hazard from accumulated dust and hair.

Dog houses MUST be well shaded elsewise they are just mini-ovens that no pet will want to go into. If you think an unshaded doghouse is adequate shelter for your pet, just crawl in one this summer and see how you like it. Our wish, of course,

is for dogs and cats to be inside your home so they can enjoy the air conditioning or fans with their human family. For those with 'short-nosed' dogs like Bulldogs, Pugs, Frenchies, Boston Terriers and more, keeping them in air-conditioning is critical! These snub-nose breeds are HOUSE DOGS IN SUMMER as they can easily suffer heatstroke or death if left out in the high heat, even if they have shade.

"She's got the best little mean mug we've ever seen, and while she's not always thrilled with mom's over-preening, the bond between them is heartwarming. Greta Lynn has been an incredible mother—attentive, patient and still one of the most beloved members of our herd."

Guests visiting the Park can spot Gertie alongside Greta in the giraffe habitat. Giraffe calves nurse for up to a year and grow quickly in their first months. The park's animal care team quickly ensured both mom and calf had everything they needed. Now thriving and full of energy, Gertie is beginning to explore and interact with her surroundings under Greta's watchful eye.

Reticulated giraffes are among the most iconic yet vulnerable animals in Africa. Listed as "Vulnerable" by the International Union for Conservation of Nature (IUCN), populations have suffered a decline of nearly 40% during the past 30 years, largely due to habitat loss and poaching. With wild populations estimated between 4,500 and 4,700, each birth is a hopeful step in the effort to protect the species.

The Alabama Safari Park is home to a growing herd of giraffes and more than 700 animals from around the world. Guests can enjoy three miles of drive-through safari from the comfort of their own vehicle and watch animals roam freely in large, natural habitats.






